

El Segundo Public Works Director Elias Sassoon Keeps the Water Flowing


Elias Sassoon has dedicated himself to public service for more than forty years. His experiences and successes along the way are why the City of El Segundo administrators selected Sassoon in the summer of 2020 to take over as Public Works Director. He has attacked his new post with the same fervor that marked his tenure of more than four decades, expertly filling similar positions in the Dallas-Fort Worth area, and most recently, as the Public Works Department Director in Rancho Palos Verdes.

Sassoon, who hails from Iran, once known as Persia (he prefers Persia), left his home country when he was 17 to traverse to America. After a pit-stop at JFK Airport in New York City, he soon jetted to the North Texas environs, where he settled in and attended college, scoring multiple degrees from the University of Texas at Arlington, culminating with a master's degree in Public Administration. He nabbed a job as a project manager for the City of Fort Worth in 1980, where one of his duties was to make sure people efficiently and expediently got from point A to point B, working closely with the Transportation and Public Works Director. Sassoon later would draw his paycheck from the City of Dallas, where he spent some 25 years and oversaw the construction of one of Dallas's municipal jewels. Sassoon said that his work spearheading the construction of and overseeing all the facets of Dallas' American Airlines Center, a nearly 1/2 billion-dollar project that was christened twenty years ago and is the home base for the NBA's Maverick's as well as the NHL Stars, is a piece of work that he is truly proud of. "A fantastic project," he said. While El Segundo does not have the available turf to house a construction project on the scale of the

American Airlines Center, Sassoon has been keeping himself busy, since August of 2020, tirelessly working on what some would say are mundane endeavors, like making sure the water flows when you turn on your faucet at home, or diving into sprucing-up the long-neglected El Segundo downtown flower poles. More about the poles later.

Said Sassoon, speaking about something we all take for granted: "You really don't think about water through the faucet until you turn on the faucet, and there is no water." Sassoon greets each challenge and task that he and his department face with a positive outlook, saying he considers himself a "servant to the people. I have always tried to put a smile on

LAX CEO Justin Erbacci Discusses **Airport Plans Ahead of the 2028 Olympics**

Tired of LAX traffic congestion? CEO of Los Angeles World Airports (LAWA) Justin Erbacci shares plans for a streamlined LAX ahead of the 2028 Olympics, as well as his experience managing an airport during a global pandemic.

Erbacci's days are long and filled with everything from Covid related upkeep to ground communication with flights to construction projects underway and in development.

"[The day] starts early and goes long," he laughs, trying to explain his day-to-day work. Erbacci was appointed interim CEO of LAWA in January of 2020, just before California went into lockdown because of the virus. Before that, he worked as the Chief Operations Officer, and he was officially appointed full-time CEO status in June of last year.

LAWA encompasses LAX, Van Nuys airport, and an aviation-related property in Palmdale. In order to operate a major airport, there are three major entities involved: the airport operator (in this case, LAWA), commercial air carriers and aviation businesses, and federal agencies like the Department of Homeland Security and the Department of Transportation.

With one of the largest metropolitan hubs in the world, including travel from around the globe, stepping into this leadership role would prove a challenge at any time for anyone. But for Erbacci, he took See Justin Erbacci, page 10

Barbara's cremains will be taken to Providence Baptist Church Cemetery located in Lawrence County, Mississippi and buried next to her beloved Frank.



Eagle Swimmers Have a Bright Future

The next time you're in the high school main gymnasium, look up on the side walls, and you'll see the league championship and CIF championship banners hanging proudly. Nearly every sport the school has supported over the decades is represented. El Segundo high school can boast several CIF Southern Section championship titles in baseball, softball, basketball, boys volleyball, boys soccer and girls soccer, boys water polo, and girls water polo, and, of course, swim titles.

The first CIF-SS title El Segundo won was a team title in swimming in 1948 and led by Jack Spargo, Bob Hughes, and George Allen. The most recent swim team titles were won in 2008 when Chelsea Kemp and Mattea Perotta led the girl's squad to a title.

The boy's team won the Division II title in 2011. This year's team didn't win a team title, but the boy's team did well enough to finish fourth overall while the girls placed 14th out of 44 teams. Both teams are loaded with underclassmen, so the future looks bright for the swim program.

This season the boys won the Pioneer League team title and had three who won individual titles. Sophomore sensation Alexander Cole's 1:40.46 in the 200-yard freestyle and 500-yard freestyle in 4:34.39 and earned his SoCal Swimming Futures cut in both events. Taisei Saito won the 200-yard Individual Medley in 1:56.22. Four-year standout Hirota Inoki, blistered the 100-yard freestyle in 46.96 to win that sprint event.



Council Talks Finances, Covid and Future

It was a heavy agenda for the El Segundo City Council at its most recent regularly scheduled meeting last Tuesday night. Discussions on the city's financial state and moving forward toward securing a possible AAA rating from Standard & Poor's, accomplishing much-needed facility upgrades at parks and pools, with a sense of urgency and a commitment to getting things done for residents, while also spending taxpayer dollars well.

City Council members were charged with looking at and approving a proposed operating budget for the fiscal year 2021-2022, a Capital Improvement Program budget, and reviewing staffing, and adding a part-time special projects administrator to help shore up city operations.

The meeting, which spanned nearly 5-1/2 hours, began with a special acknowledgment and presentation to the El Segundo High School girls' soccer team for winning the CIF Southern Section Division 4 championship, the school's first for its girls' team. The Cinderella season for the team saw them overcome a third-place finish in league competition, soaring in CIF playoffs with four wins that advanced them to face undefeated San Dimas for the CIF division championship. They then lost to San Dimas in CIF regional competition shortly thereafter.

The council's discussion of finances took an interesting turn when council member Scot Nicol wanted to learn more about why the newly renovated fire station 1 needed new carpet at a projected cost of \$85,000 after just four years.

Council also honed in on asking city staff to come back with a \$1 million reduction in the proposed budget after a lengthy conversation and settled on the city operating with a 20% reserve level. According to a staff report, the lowest reserve level allowed for a city is slightly over 16%, said city staff, and 20% is considered a "Best Management Practice" by municipal financial advisory firms and bond rating agencies. Reserves can be used in case of natural disasters like fires, floods, and earthquakes, as well as economic recessions. Mayor Drew Boyles was not "bullish" on the post-COVID-19 recovery, especially given El Segundo's reliance on people occupying office spaces and hotels being booked to capacity.

City Council entertained the idea of asking the El Segundo Unified School District to help pay for crossing guard services (the cost is \$130,950) but, for now, decided to approve the funding from city coffers. Council member Carol Pirztuk said, "... the safety of our children should be our focus," and urged the council to bear that in mind. Mayor Pro Tem Chris Pimentel believed there was room for discussion and negotiation with ESUSD and noted that they probably have "an understanding that we are in this together," saying he didn't think the city and school district were in an "acrimonious position."

Da Vinci Schools CEO/Superintendent Matt Wunder, a founder of Da Vinci, which opened in 2017, thanked the city for its All-Hazards Incident Management Team's efforts during COVID-19 and for vaccinating Da Vinci staff. He called out the team's "professionalism, service, and quality."

The city's Director of Information Technology Services, Charles Mallory, told the council the South Bay Fiber Ring Network, a regional broadband, fiber-optic network designed to keep South Bay cities on the leading edge of luring companies to the area as a technology-savvy community, had been completed last November and that El Segundo was the first city to connect to the network, which cost the city "zero" and saved the city approximately the \$20,000 it was spending to provide wi fi at the city library.

Mayor Drew Boyles read a proclamation for Juneteenth, an acknowledgment of Jun. 19, 1865, when the last slaves in Galveston, Texas, became aware of their freedom, a freedom the US had recorded as law on Jan. 1, 1863, after an official proclamation was made in September of 1862.

Shad McFadden, the city's Diversity, Equity, and Inclusion committee chairperson, came forward to tell the council in person at the microphone (city council meetings are currently still being held on Zoom) his thoughts about Juneteenth. He noted that growing up, he'd interpreted Juneteenth as a sad day because the time lapse between the issuance of the US proclamation versus when the last slaves heard about it contained such a gap. He urged all "to celebrate our diversity" and said that having sometimes See City Council, page 6

everyone's face who has crossed my path. I love this beautiful city!"

Most managers develop an organizational, pyramid-shaped chart, with the boss man or lady perched at the top of said chart. Sassoon said he does have a chart, but he has flipped the script on that management tool.

He places himself at the bottom of the pyramid, a "servant leader," he said, whose goal is to maximize the talents of his assembled team, and calling on his engineering background, solve the challenge at hand in the most efficient manner. "When I resolve an issue, it energizes me," Sassoon said, who, it has been noted by past and current employers, is often the first to arrive at work, the last to leave, and has been known to venture out and visit projects on the weekend to keep tabs on their progress. Too much time on the job?

"I try to be the best at anything that I do," the Pacific Palisades resident said, noting that sometimes work has "interfered with my personal life" and that he is striving to "keep a balance" in his work and personal life.

Sassoon relishes his post working for the citizens and the City of El Segundo. Upon his hiring, City Manager Scott Mitnick noted Sassoon's "passion for public service, his high level of customer service, and his depth of experience." Mitnick touted Sassoon's prior experience, reiterating that the hiring of Sassoon was a "tremendous asset to the city."

Speak with folks who have worked with Sassoon over the years, a constant theme emerges. A caring man, who pays attention to detail, works tirelessly, and, said Greg Porter, who worked with Sassoon in Texas for eight years, "one of the most remarkable human beings that I have ever had the pleasure to work with."

Continued Porter: "He is exceptionally giving, with the knowledge of people, culture, and his ability to listen, which makes him the absolute perfect fit for municipal government."

Porter related that Sassoon was effective not only in dealing with and shepherding multimillion-dollar municipal projects in the Dallas area, but could seamlessly pivot to giving his full attention to a local resident who may have an issue relating to her crumbling driveway concrete.

Porter lamented the day Sassoon decided to relocate to California. "It broke my heart," he said.

Jill Jordan has been associated with Sassoon for more than three decades. The two rose through the municipal management ranks in Dallas. "El Segundo is lucky to have him," Jordan said. "He is always dedicated, sees the job through, and is creative in coming up with solutions. Y'all are lucky to have him; his heart is in public service," she said. "He is going to watch out for his community."

Gabriella Yap was a colleague of Sassoon's during his three-year stint in Rancho Palos Verdes. She called Sassoon a "deeply knowledgeable engineer, with his heart in public service. He is generous in every sense of the word, very authentic, really wants to

with the city," Mitnick said. "He maintains a tremendous "can do" attitude. He is always upbeat and positive. He is a problem-solver who seeks to understand a challenging issue and works toward coming up with a resolution. I like how he comes to me with "solutions" and not "problems."

Regarding those flower poles, Mitnick shared: "A small sample of how he finds solutions and implements them in short order involves the Downtown decorative flower poles. There are over 55 of these that sat unused in disrepair for years and had become a visual eyesore. I had asked previous staff why we let these poles deteriorate and go unmaintained and unused. I was provided with several excuses, including The water lines are broken, cannot obtain the necessary parts to fix, too expensive, no one likes them, not a priority, etc.

"When Elias was hired, I told him that one of his first priorities had to be to fix these flower poles. He immediately set out to research each pole, worked with his new staff, developed a plan within his existing budget, and within a short period had every single pole refurbished to look like new, fixed the water lines, planted each pot with beautiful flowers, and the Downtown merchants and community love the result.

"On a bigger scale," Mitnick continued, "Elias is working on developing a multi-year Capital Improvement Program (CIP). This is coming along nicely. He is also working with the City of LA to improve the drainage and landscaping within the medians on Imperial Highway just north of El Segundo and adjacent to LAX. He is awfully close to obtaining a positive outcome. "Elias is a true team player. He puts the needs of the city ahead of his own. He is an effective member of the City's Executive Team (Department Heads).

"He leads by example. He works as hard as any of his department employees. He is often the first one into the office early in the morning and the last one to leave in the evening. He is frequently in the office or out in the field on weekends to make sure the facilities that his department are responsible for are working. He has an incredible work ethic and commitment to all things El Segundo.

"He will not ask any of his employees to do something that he would not do himself. He has a strong depth of experience and knowledge of the Public Works profession. He does not complain, and he figures out a way to gets things done without seeking credit for the result. He loves public service and to make the community better."

When he is not putting in the extra hours at work, Sassoon said he enjoys playing racquetball (he even invited this old scribe, who probably has not played racquetball in 30 years, to join him as his guest at his racquetball club), swimming, pondering movements on the chessboard, and reading, specifically history and biographies. Sassoon said he had not regretted his intrepid American venture that he undertook when he was a teenager, which, he said, was inspired by watching John Wayne movies that extolled the

Film Review 'Censor' is Vintage Horror Fun For the VHS Era

Before going into the fun new horror film *Censor*, you should know what a "video nasty" is. A colloquial term coined in the United Kingdom in the 1980s "video nasties" were films distributed on video cassettes that were criticized for their violent content by the press and various religious organizations. In her directorial debut, Prano Bailey-Bond puts these graphic films at the center of the story about a film censor (Niamh Algar) who, after viewing a strangely familiar video nasty, sets out to solve the past mystery of her sister's disappearance and embarks on a quest that dissolves the line between fiction and reality.

relatability. It's telling that after her sister goes missing during childhood, Enid grows up to become a film censor, choosing to submerge herself in such gruesome and violent content, striving to single-handedly extricate the most horrific moments from the public's (and specifically children's) consumption. But when a particular video nasty becomes the center of a national headline for an inspired real-life murder, Enid is left shaken, and the trauma of her horrific past haunts her again. Bailey-Bond shows the unconscious ways that we try to stave off events that are too hard to make sense of in a disturbing moment and what worlds we then create for

While operating within the familiarities of the horror genre that fans will hope for, Prano Bailey-Bond also flexes her deeper knowledge and appreciation of the genre with the plot's central connection to video nasties. The fun that Bailey-Bond brings to the screen with the video nasties' campy kills, titles, and even videocassette jackets are going to be some of the film's most memorable moments. And on a more personal level, it's clear that Bailey-Bond is expressing her voice through the central character Enid (Niamh Algar), a young and beautiful woman who is more interested in losing herself in her career of grisly fantasy than following a more traditional life path. Censor has a strong and empowering female perspective about being a woman both in the workplace and in danger, which Algar is as equally game for the whole time.

For a film that is so knowledgable about video nasties and the fun that's had in staging violence in film, though, *Censor*'s disturbances are aimed at the more heady paranoia of mental instability rather than blood-spurting horror sequences. There are only one or two jump scares and a few moments of grisly slasher fun, all handled rather mildly. I wonder if *Censor* had allowed itself to indulge in the genre's more bloody mayhem what further fun could have been had within this set-up. *Censor* actually ends up hitting on the softer side in terms of an all-out gorefest. However, the deeper human truth that Bailey-Bond expresses here is even more terrifying in its ourselves to cope. In asking the audience what fears are we running from, and what actions we take in an attempt to push those unendurable memories out of our minds, *Censor* is a film that will stick around and stir inside our minds.

At 84 minutes, *Censor* is perfect for casual mature audiences looking for a fun time with a horror movie, as well as for the more seasoned horror fans looking to indulge their appetites with the throwback to "video nasties." If you were wondering what a video store clerk's re-imagining of *Midsommar* and *Mandy* might look like, you might want to queue up *Censor* quickly.

City staff updated the council on COVID-19, noting the city had had nine new cases since the last briefing two weeks ago at the previous council meeting. He also said that the city had successfully conducted 18 vaccination sites and facilitated 2,606 vaccinations, among other notable recognitions. He said that as of Jun. 15, the state had now removed its "blueprint guidance" of color tiers but that individuals not vaccinated are still required to wear masks in all public indoor settings such as, but not limited to, grocery stores and movie theaters. Fully vaccinated people could go maskless everywhere except for public transportation, indoors in K-12 schools, childcare and other youth settings, healthcare settings, homeless shelters, cooling shelters and emergency shelters, and state and local correctional facilities. Staff also said that in settings where masks are required only for unvaccinated individuals, businesses, venue operators, or hosts may choose to allow individuals to self-attest to having been vaccinated, implement vaccine verification,



The boys did well in the 200-yard freestyle relay. Rainer Reczer, Taisei Saito, Hirota Inoki, and Alexander Cole combined to win the event in 1:29.46. This same relay team won the 400-yard freestyle in 3:12.46, and qualified for the CIF Prelims meet in both events.

On the girls' side, they finished an impressive second overall in the Pioneer League. Only freshman Molly Beetner won an individual league title when her strong surge at the end was good enough to win the 100-yard breaststroke in 1:08.62. The girls also won the 200-yard freestyle relay that consisted of Gabriela Crother-Collado, Molly Beetner, Maya Viramontes, and Emery Arnold.

Others who fared well at the league finals were freshmen Lucas Crother-Collado and Emery Arnold, who finished second and third respectfully in the 50-yard freestyle. Arnold finished second and Luke Pohlman third in the 100 fly, while Rainer Reczer was third in the 100-yard freestyle. Taisei Saito swam to a second-place finish with a 54.33 in the 100-yard backstroke. Kai Albertson was nudged out of winning the 100-yard breast and finished second in a time of 1:01.77. On the girls' side, Gabriella Crother-Collado finished second in the 200-yard freestyle and Molly Beetner's 59. 92 was good enough for a third-place finish in the 100-yard fly.

Both boys and girls JV teams finished third overall at the Pioneer League finals. Andrew Felix's 1:06.07 in the 100-yard backstroke, and Tyler Thomas won the 100-yard freestyle in 56.37. Victor Ayaay, Patrick Wang, Andrew Felix, and Julian Raymond took home the 200-yard freestyle relay crown In a year where only the top 16 earned the right to compete at CIF Prelims, due to COVID restrictions, El Segundo was well represented among the over 50 schools that had qualifiers for CIF Southern Section Division 2. This year the Eagles were moved into Division 2 up from Division 3, which made the competition a little more daunting. The girls finished a respectable 18th out of 47 teams while the boys' team finished fourth overall.

The girls were seeded eleventh in the 200-yard freestyle relay and finished strong and placed sixth, good enough for a medal. Three freshmen led the Eagles, starting with Emery Arnold, who got off to a good start, followed by Molly Beetner, who swam a team's best 24.61. Maya Viramontes swam a strong third leg while senior Gabriella

Crother-Collado anchored for the Eagles and held off Trabuco Hills' Taylor Lowe to give El Segundo a medal.

Alexander Cole had a great meet by winning the 200 free in a sizzling 1:39.25 and third in the 500 free (4:34.41). Taisei Saito made it to the podium twice, including one for finishing fifth in the 200IM in 1:54.18 and a sixth-place finish in the 100 backstroke (52.83. Hirota Inoki took home a sixth-place medal in the 50-yard freestyle. The Eagles (Inoki, Reczer, Saito, and Cole) won the 400 freestyle relay by nosing out Notre Dame of Sherman Oaks by six-tenths of a second thanks to Cole's anchor time of 44.98.

With so many talented swimmers returning next season, the Eagles have a bright future and continued success ahead. •

over leadership with all that entails in the wake of travel and airports becoming a significant point of focus associated with medical risks.

With the threat of Covid looming large, Erbacci didn't miss a beat. Taking federal guidance and safety precautions into consideration, he created a Covid task force to handle everything from implementing new touchless technologies all over the facility to implementing new cleaning standards and training to keep every employee up to date and on the same page. This includes things like new UV light sterilized handrails on escalators and buttons on elevators. Many normal airport functions moved over to a format usable on a mobile phone. Erbacci worked in his office every day of the pandemic to ensure the safety of all essential workers still required to go to the airport and begin working on a health and recovery plan for the future.

As for what's going on as we begin to exit the pandemic, some exciting new projects are underway. Erbacci explains some of the new travelers to and from the airport and all terminals, effectively mitigating the need for cars to be in the center of the airport.

The new people mover train will have three stations within the airport: a west stop near the Bradley International Terminal, a Central Terminal stop, and the third stop between terminals 1 and 7. From here, the train will continue eastward to a stop at an intermodal transportation facility. This will be a remote parking lot with about 4,300 spaces that will allow for parking, as well as ride pickups and drop-offs.

Continuing east, the people mover train will intersect with the Crenshaw metro line, allowing access by metro to the airport. Finally, the last station will be at the largest consolidated rental car facility in the United States.

"It will be the second-largest cement structure in the United States, second only to the Pentagon," says Erbacci. The idea with all of this is that all rental car transactions will happen at this final station, residents will have an easier time accessing the airport sans car via the metro, and all cars and hotel shuttles can mostly use the remote parking lot, where guests can then enter the airport by train. With all of these measures, the flow of travel through LAX will be much more ergonomic for a city of this size.

In addition to the train, Erbacci is working on the renovation of terminals, improvements to the airfield to alleviate congestion experienced on the ground, and adding more gates and a new concourse. A new elevated roadway system is also underway to replace the current system of how cars enter the central terminal, easing traffic on nearby streets and improving circulation in and out of the airport. 2023. Though he says these changes would have happened regardless of the upcoming Olympics, he says that he does want to make a good impression as athletes from all over the globe enter our city, which these new airport modifications will help provide.
