The Plunge Moves Forward and City Council Adds 10 Sworn Officers to Budget

Instructors holding private classes in two city parks may soon be required to pay \$15 per hour to the City of El Segundo to secure a permit, per a new Private Instructor Permit Fee process the city council moved forward during its Tuesday night regularly scheduled meeting. The two parks the six-month pilot program will be instituted at are Library Park and Recreation Park. In addition, Tuesday night, the council approved growing its police department from the currently approved 62 sworn personnel headcount to 72. A move officials say will take months to achieve given its current headcount of 57 officers, with five of that number not able to presently work solo in the field while they are fulfilling the requirements of either attending a five- to six-month police academy and subsequent field training for entry-level officers or, for officers making lateral moves, lateral field training with another officer.

City Council also heard about the progress being made on the Urho Saari Swim Stadium ("The Plunge") renovation project, about how the project will be financed, and when it will go out to bid. With a cost estimate of slightly over \$11 million, the project falls approximately \$4 million short. However, as noted by Public Works Director Elias Sassoon, by law, the city must have the funding before awarding the project to a vendor. As was explained at the meeting, city staff is working on a private sector/corporate fundraising campaign that is expected to be presented to the city council in August. Sassoon also noted the city's plan to accelerate funding by moving \$2.5 million from its July 2024 budget to the project sooner. The city also expects

\$1 million of funding from the El Segundo Unified School District once the project is completed. Council member Carol Pirsztuk implored council and city staff, "Please don't let the funding stop the process," and was assured that funding details would not stop the project from moving forward. She asked city staff to prepare a one-sheet document to easily and quickly see where the funds are coming from and the associated timeline.

Mayor Pro Tem Chris Pimentel, attending the meeting remotely, noted that once the design is complete, staff will bring the design back to the council for plan approval and advertisement to potential vendors wishing to bid on the project. Sassoon said that would happen "probably Octoberish" and would "hopefully be awarded" in the first quarter of 2024.

The project update Tuesday night provided more details and covered the extra steps being taken to ensure the project is as sound as possible. As council member and former planning commissioner Ryan Baldino explained, taking a pool stadium building built in the 1940s is akin to renovating a house built in the 1940s, noting that there would be unforeseen issues that would arise during the design and that such issues are "much easier to fix in the design stage."

The new pool building and pool will use a Pulsar chlorination system, and a condensing boiler system will replace the "typical atmospheric heaters" used in the past. Those heaters were 82 percent thermal with an 18 percent energy loss that "goes up the stack." While, the condensing boiler has 97 percent efficiency, a greater life expectancy, and is more reliable, according to the design firm the

city contracted with for the project. Pool leak testing has been done and to resolve all of the leaks, all of the wall tiles in both pools will be replaced. However, most all of the pool floor tile will be kept, except where trenches need to be dug to install new main drains compliant with regulations. Close matching tile is expected to be used in those areas, and the tile will align with seams, making it difficult to discern that it is any different. A geotechnical ultrasound was conducted on the soil underneath the building and returned a report that the soil is reliable and sustainable. The roof will receive a seismic retrofit upgrade with the entire roof coming off (half would need to be removed at a minimum) so that a "single-ply PVC" material with a lifetime guarantee and no maintenance could be installed. Borings were made inside the yard between the adjacent school and pool, and there was no evidence of any settlement. Interior leaking has been noted at the southeast corner, with a projected \$150,000 cost requiring excavation to remedy the issue. It was also noted the city might need to do a new main drain to the street drain. A fire suppression system will be installed using fire risers. And the men's and women's locker rooms have been modified to include family changing rooms whereby a father could take his daughters into a private entry and area in the men's locker room to help them change and vice versa. Offices will be on the ground level, with one there for the manager/supervisor of the pool and two more upstairs.

Police Chief Jaime Bermudez delivered an overview presentation on the police department,

Since we moved back to El Segundo, we have had a serious SKUNK invasion. We have relocated 21 skunks on West Walnut over the past few months & there are many more aggressive skunks on our camera. My neighbor had one in a cage & called the Police Department. They came & got the cage but never returned it so now she cannot catch them. I called the police about 6 months later to report this. I received a call back stating that they'd call back but never did. I have distributed Skunk Prevention flyers in our neighborhood as they carry Rabies & there are only 3 of us catching them. We have small children & have seen the skunks appear as early as 6:30 PM when the kids are in the yard. This is Public Health Crisis when a City allows an invasion and does nothing about it.

SKUNK Prevention: Sprinkle gardens

w/Cayenne or Epsom Salt. Keep food sources out of reach, cat food, bird food. Place rags soaked in ammonia, pine-sol, vinegar, moth balls, citrus, peppermint oil, bleach under all entry areas as they burrow deep. Cut tall grass, trim bushes. Place chicken wire under fences, motion lights scare them off, reduce access to water, fallen fruit from trees. Large traps are \$30-50 at Harbor Freight & peanut butter is great bait. Ashe Animal Control is the most inexpensive 562-414-9523. My neighbor paid over \$700 last year & has caught two. Ashe is \$50 a skunk! The neighbor above is awaiting her cage return. Another neighbor caught 4. We have caught 15 and are now taking a break to see if our prevention can keep them at bay while the City sleeps.




Film Review

Asteroid City is Wes Anderson's Most Spiritual Film to Date

Wes Anderson's latest film, *Asteroid City*, may be missing the auteur's most repeatedly cast actor–Bill Murray–but his absence doesn't leave too big a dent in this otherwise riotous affair. Jason Schwartzman–and to some degree, Bryan Cranston–anchor this

meta-tale of a science field trip gone wrong and the controlled chaos that occurs after a small town's unexpected meet-and-greet takes place with an extraterrestrial.

Wes's quintessential quirks and styling shine in this dry desert landscape. Combined with the film's use of a once-again perfectly-curated soundtrack, *Asteroid City* is one of Anderson's more commercially accessible feature films.

Asteroid City is a nostalgic take on America's nuclear-era obsession with aliens. Set in 1955, the town of Asteroid City (population: 87) is set to hold a convention for families to congregate and celebrate their children being named Junior Stargazers. Augie Steenbeck (Schwartzman) arrives with his son Woodrow (Jake Ryan) and three daughters and quickly meets the other families attending the literal star-studded affair.

Midge Campbell (Scarlett Johansson), her daughter Dinah (Grace Edwards), and three other Space Cadet award winners and their families are also amongst the group. Their cumulative IQ is highly concentrated in this remote city, but despite being some of the smartest people in the American Southwest, no one could have guessed that what they

were about to collectively witness would change their lives forever.

Of course, this being a Wes Anderson film, there is more to the story than this surface-level synopsis. The unexpected narrative choices and plot delivery throughout the film allow the audience to go inward and explore the themes that resonate with them personally. Watching the movie and mining for themes myself-both subtle and loud & clear-it is obvious to me how Anderson intentionally creates scenes with characters that have juxtaposing outlooks on love and loneliness, grief and hope, and life and death

It should come as no surprise to hear that the acting is superb. As mentioned earlier, Bill Murray is missing from the typical all-star lineup, but like a classic SNL skit, nearly all returning cast members are represented (even if it's just for a cameo). That includes Edward Norton, Jeffrey Wright, Tilda Swinton, Adrien Brody, and Tony Revolori. While not meaty enough for any one person to be a frontrunner in the awards conversation, as an ensemble, the synergy fits like a glove.

The deadpan dialogue between the characters is delightfully funny but the real humor comes from what isn't said. A subtle look, a lack of acknowledgment, a simple sign indicating that road construction has stopped indefinitely. In addition to expectedly brilliant soundtrack curation by music supervisor Randall Poster, Alexandre Desplat's score, and costumes by Milena Canonero, special attention should be paid to the puppeteers, specifically Andy Gent (please stay through the credits to see why he deserved a shoutout).



The Bill of Obligations: The Ten Habits of Good Citizens by Richard Haass

As we look forward to July 4th, our celebration of our country's Independence, let me recommend *The Bill of Obligations: The Ten Habits of Good Citizens* by diplomat and policymaker Richard Haass. I'm sure you are familiar with news articles discuss-

ing democracy and its fragility in today's world – this book addresses that issue and provides ideas to strengthen and reenvision citizenship.

According to Britannica.com, citizenship is the "relationship between an individual and a state to which the individual owes allegiance and in turn is entitled to its protection. Citizenship implies the status of freedom with accompanying responsibilities. Citizens have certain rights, duties, and responsibilities that are denied or only partially extended to aliens and other noncitizens residing in a country. In general, full political rights, including the right to vote and to hold public office, are predicated upon citizenship. The usual responsibilities of citizenship are allegiance, taxation, and military service."

Author Haass states that he is non-partisan, explaining that he has worked for Democrats and Republicans, both liberal and conservative. He states, "Party was never as important to me as individual candidates and issues." Mr. Haass is the president of the Council on Foreign Relations, which is an "institution dedicated to being a nonpartisan resource for Americans across the political spectrum ..."

Why does the author think our democracy is in peril? His perspective includes an important part of the relationship we as citizens have with our country. Not only should we be concerned with individual rights but also obligations that we have to the United States. Think of John F. Kennedy's important words on the occasion of his presidential inauguration, "And so, my fellow Americans: Ask not what your country can do for you - ask what you can do for your country." Become an *active* and *involved* citizen!

Some points of the suggested "Bill of Obligations" include: Be informed, get involved, stay open to compromise, and remain civil.

As a benefit of being informed, citizens can more wisely cast their votes and importantly, hold officials accountable. An uninformed citizenry is much more vulnerable to being misled or manipulated. Voting is also the most basic part of being an active citizen. The author gives examples of close outcomes of elections which illustrate how much voting matters. People can join or create organizations that can have direct influence in politics. Parents can influence their children to learn about and become involved in the political process.

Compromise should not be a sign of weakness. Again, John F. Kennedy: "Compromise need not mean cowardice. Indeed it is frequently the compromisers and conciliators who are faced with the severest tests of political courage as they oppose the extremist views of their constituents."

Civility can build bridges over differences. It allows for dialogue and relationships to grow and continue. Civility greatly decreases the chances that disagreements may end up in violent acts.



American Legion Team Looking Good



noting the three patrol areas the city is divided into and how they have not changed since at least 1992 and probably since the 1970s. In the presentation, Bermudez noted a 3 percent crime drop from 2021 to 2022, calling 2021 "a bad year for crime" and noting that auto theft, catalytic converter theft, and retail store theft are the biggest crimes in the city and nearby cities as well as statewide. He said the business expansion east of Pacific Coast Highway had brought an uptick in crime in what is Patrol Area 3. Year-to-date, he noted

Ralph's, primarily because of liquor, has had 253 incidents, with TopGolf logging 221. Nordstrom Rack has had 67 incidents, with Dick's Sporting Goods logging 65. After that, the Nike Store has 12, and Ulta Beauty has 11, according to Bermudez's presentation. He said the businesses east of PCH tax police patrol resources "pretty heavily." He also noted the 14 hotels in the city create "a big tax on our resources" due to calls about parties in multiple hotel rooms and the number of patrol cars and officers required, plus the

time it takes to evict hotel guests, which, for officers, includes remaining in the parking lot until everyone leaves to ensure there isn't any property damage. The city has 2,463 hotel rooms, according to the presentation, with Bermudez saying many guests stay in these hotels while attending events at Sofi Stadium in Inglewood. Bermudez noted that incidents included in his report include calls and self-initiated actions by officers who stop to look into something based on what they've seen or heard. He said Ralphs incidents in-

clude people out front bothering customers, homeless individuals asking for money, and/ or an officer seeing something suspicious and getting out of the car to initiate contact, and while there, an officer self-initiates looking into something. When asked about Topgolf incidents, Bermudez said the facility in El Segundo is "obligated to staff our officers at the fully burdened rate" and that the incident numbers in the report included times when El Segundo police officers were staffing the facility at the fully burdened rate.•
