Amber Meshack Connects the El Segundo Community to LAX

Los Angeles International Airport (LAX) is the fourth busiest airport in the world. Second only to Hartsfield-Jackson Atlanta International Airport, LAX is the busiest airport in the United States. Since its inception in 1928, LAX has evolved and grown to become California's travel hub, a gateway into Los Angeles.

All of this growth and innovation in the runways, terminals, and renovations can only happen with a strong and robust team to keep the wheels turning. Keeping the hiring process evolving as the airport does is Amber Meshack, Director of Business, Jobs, and Social Responsibility. Amber heads up a division that aims to be a model for other airports around the world, leading new programs aimed at diversity, equity, and inclusion.

"We take our commitment to our neighbors seriously with respect to the social responsibility side," she says, "The consideration of power and how our operations economically impact those around us is really what my job entails."

This means ensuring fair hiring processes, developing training programs, and writing contracts that encourage the employment of small local businesses. In addition, Meshack has created a program called BuildLAX, which helps train smaller contractors around the area on the specifics of what it takes to be successful working on construction projects for larger corporations.

Most remarkable about her department is a nationally recognized apprenticeship-ready program called HireLAX. This program is directly targeted at helping local workers create new careers. Meshack relays the shortage of construction workers right now due to high demand and an aging construction workforce. What HireLAX aims to do is to offer a training program to people from all walks of life in the Los Angeles and South Bay area. This could be high school students looking for an alternative to a four-year college, people looking for new careers, or even those with a past who are looking to begin a new venture.

"These jobs pay very well, and they provide a benefits package," says Meshack, "It's also something where you could put yourself through college working as a construction worker." As four-year colleges become more of a prerequisite for the workforce, less emphasis has been put on skilled trade jobs like construction work. Meshack tells of a female friend of hers who used

Elizabeth Tobias Will Not Let Local War Veterans Be Forgotten

Hopefully, whatever side of the currently fractious political divide that you frequent, whether you get your sometimes dubious information from the Fox News Channel or MSNBC, we can all come together and agree that the treatment of many returning United States war veterans is sometimes shoddy, at best?

Well, someone who does not just talk a good game, but gets in the game, is El Segundo resident Elizabeth Tobias, who grew up in a military family, with her father proudly serving a 26-year stint in the Air Force, a brother who served his country in the Navy, as well as other relatives who drew their pay in service to the Armed Forces of the United States of America.

Tobias, a Missouri native who moved to El Segundo in 2003, is the driving force behind a group of residents who are doing their best to not only remember the returning veterans, but to make a difference in their day-to-day lives. She and her cadre of volunteers have adopted veterans who reside in low-income housing in an apartment building on the cusp of Inglewood. She and her crew started last winter delivering donated items, what she termed "the basic necessities of life," such as canned goods and hygiene products on Veteran's Day, 2020, and thanking the

SMC and Its Mission Partners Successfully Launch Fifth GPS III Satellite

The U.S. Space Force's Space and Missile Systems Center and its mission partners successfully launched the fifth Global Positioning Systems (GPS) III Space Vehicle at 12:09 p.m. EDT (9:09 am. PDT) June 17 from Space Launch Complex-40 at Cape Canaveral Space Force Station.

The Lockheed Martin-built satellite was carried to orbit aboard a Space Exploration Technologies Corporation (SpaceX) Falcon 9 launch vehicle, previously used in a GPS launch last November, marking the first National Security Space Launch to use a reusable booster. The GPSIII reuse/recovery missions are saving the government a total of \$64.5 million.

"The launch of GPS III SV05 is a testament to SMC's ability to rapidly and safely deliver new capabilities on orbit. This successful launch occurred just seven months after SV04 and the team worked concurrent operations between both SVs during the dynamic situation presented by COVID-19," said Mr. Cordell DeLaPena, Jr., USSF program executive officer for SMC's Space Production Corps. "At SMC, we are proud to deliver our fifth GPS III satellite and will continue to operate at an accelerated pace to meet the demands of our users."

GPS III SV05 is the 24th Military Code (M-Code) satellite to join the current GPS constellation comprised of 31-operational spacecraft, the last required for M-Code Full Operational Capability.

M-Code in the newest generation of GPS satellites, brings new capabilities to users, delivering positioning, navigation and timing (PNT) information with three times the accuracy

and up to eight times the anti-jamming capability than its predecessor. SV05 augments a GPS III constellation that broadcasts a new civilian signal called L1C, which is easier to acquire, allows for ionospheric corrections, and improves reception in cities and remote areas.

GPS III SV05 separated from its upper stage approximately 90 minutes after launch. Engineers and operators at Lockheed Martin's Waterton Facility will now begin on-orbit checkout and tests, which are estimated to complete in approximately two weeks. Operational use is expected to begin in a few months.

"Today's launch culminated our work to use previously-flown hardware for NSSL missions," said Dr. Walter Lauderdale, Launch Enterprise's Falcon division chief. "Our partnership with SpaceX enabled us to complete this huge milestone well in advance of our first Phase 2 NSSL launch, enhancing flexibility and resiliency for National Security Space missions."

The U.S. Space Force's Space and Missile Systems Center, located at Los Angeles Air Force Base in El Segundo, California, is the center of excellence for acquiring and developing military space systems. SMC's portfolio includes space launch, global positioning systems, military satellite communications, a defense meteorological satellite control network, range systems, space-based infrared systems and space situational awareness capabilities.



Film Review

'The Sparks Brothers' is a Music Documentary About the Best Band You've Never Heard

Spanning every bit of two hours and twenty minutes, it's clear that director Edgar Wright feels indebted to both educate, as well as attempt to make audiences appreciate the art-pop duo Sparks—the most influential band that you've never heard of—in the highly entertaining music documentary, *The Sparks Brothers*.

An unabashed pop music fan himself, Edgar Wright (*Baby Driver*) makes it his mission to not only tell the story of the Mael brothers–Ron and Russell, whose band "Sparks" not only spans over five decades in which the pair made 25 studio albums and 500 songs–but capture their undefinable creative identity, and show how real commercial success would evade them over their entire career while they refused to compromise their vision.

But Wright the established filmmaker is up for the job, telling Sparks' story with an inspired assortment of zany and diverse animation styles whose tongue in cheek humor mix in some small part motivated by a desire to break into the mainstream, to be more famous than they were, or to a more simple degree, "be understood."

One of the most surprising and telling reveals is when, after the album of their first band, "Halfnelson," didn't sell well, it was their manager at the time who advised them to change their name to what would become Sparks (as they were told they looked like the Marx Brothers). While Sparks would (and should) be the last band in the world to be accused of having motivations to work to fulfill audiences reactions (which they never did, to be clear), it is telling that a constant need to work against rejection fueled them to achieve pinnacles of creative accomplishments that, who knows, might not have happened otherwise.

Sparks' prolific output would be for our collective cultural benefit, as Ron (the songwriter) and Russell (the voice) would create some of the most genre-defining music of the '60s.

with the band's own ironical detachments. By intercutting these animations with an array of interviews from the music and entertainment world–including Beck, Mike Meyers, Jason Schwartzman and Flea (as well as Wright himself), who all profess their love for Sparks–it's a wealth of riches to tell Sparks' story.

To understand Sparks is to understand the Mael brothers: born in Santa Monica, California (already confusing, as most everyone thought they were a British band), there's Ron (the "older" one) and Russell (the "cute" one), who were raised on a diet of Hollywood and cinema by their late father (who passed away before the boys were teens). It was this level of theatricality and cinema that would inspire the band aesthetically, and would later influence them philosophically through the appreciation of French new wave film, in which the brothers' self-awareness would rally them to churn against the mainstream of pop music that they'd would eventually operate in.

Of course, Ron and Russell themselves are present in this doc, too. So too do they want a part in constructing this (their) story, as their authorship has always been integral to their presentation. What I found interesting about *The Sparks Brothers* is that, while the Mael brothers were clearly all-too gleeful playing pop-provocateurs throughout their career (Ron famously sported a sort-of Hitler moustache, which he would say curiously never got mistaken for Chaplin), it's clear that they were

'70s and '80s, which would go on to predate electronic synth music like New Order and Pet Shop Boys. So even if you're not aware of Sparks' music (which you likely aren't), or don't entirely "get" their music (which mass audiences clearly didn't—hence this doc), *The Sparks Brothers* is a fantastically abounding story about creative artists who were unafraid to chart forward, to re-define themselves, to change up the formula and evolve to new places, which is a rare but necessary thing for artists to do today. Sparks wanted to stay true to their selves and never compromise on their unique vision. So they chose to be the best band that you've never heard of—until now.

construction work to put herself through Berkeley Law School.

The idea behind this initiative is to make sure that this career opportunity is available across the board, providing a chance to build a lucrative career, whether in construction or working in another capacity at the airport.

Meshack oversees business connections in every facet of the airport, from construction to food and stores inside the terminals to IT. She strives to hire local businesses to help in the airport's operation and works to make sure that locals are hired by these businesses and the airport. LAX goes as far as to contract a local photographer or graphic artist on a project-by-project basis. She encourages local businesses and entrepreneurs to present their ideas and get involved.

Monthly, Meshack meets with what she calls their Innovation Lab. Each month, her team invites vendors to present ideas for goods and services. "We've gotten some really innovative ideas and partnerships in that way." Meshack lists things like apps, environmental upgrades, services, and designs.

Meshack herself comes from a background of working for the city. When this department was created, she was working as a chief of staff for the new people mover train project. Meshack was sourced to get her current division up and running. Using her knowledge of the city and management experience, she set

to work developing strategies for the airport to be more inclusive.

"When we say diversity from all walks of life, we do have an emphasis on...heavy recruitment in the communities that are closest to the airport," says Meshack. In addition, when she draws up a contract with a vendor for the airport, a clause almost always exists that ensures fair, diverse, and local hiring. For the businesses she strives to include, she says that the airport provides in-house recruitment teams, which lessens the effort on the business to go through the time and labor-intensive process of hiring.

Meshack's future goals for the airport and her division revolve around the continuation of her team's efforts to increase inclusivity and expand diversity. "We [want to] continue to apply best practices for increasing diversity and equity in everything we do as an airport. Our CEO Justin Erbacci always says, 'it's not just what we do, it's how we do it," she says.

On June 23rd, Meshack's team will be holding a webinar intended to inform vendors about how to implement diversity and inclusion, as well as what the diverse LAX customer and workforce is looking for right now. 
Bob and Kathy Motta to be Honored

veterans for their stellar service.

Because of an outpouring of support from El Segundo residents in the past eight months, many of whom Tobias was able to meet through the El Segundo Parents Network webpage, Tobias and her volunteers have been able to provide home-cooked meals at Thanksgiving, sundry clothes, and gifts at Christmas, chocolates on Valentine's Day, and meals from local restaurants. "People from the community help deliver the items," she said. "With the caseworkers, we go door-to-door and thank the vets for their service; they are very appreciative."

Tobias said that once she started reaching out to El Segundo residents to participate in her endeavor, the "response has been incredible." She gave special thanks to El Segundo resident Dione Dierks, who works at Bishop Montgomery High School. Tobias said that the Torrance high schoolers donated "three truck and three carloads full of food, paper products, toiletries, and other items to the vets in May. It was incredible!"

Not to be left on the sidelines, Tobias said that the El Segundo Rotary Club handled the 2021 May donation, ponying up "BBQ bags," which included hot dogs, buns, chips, and cookies, while also donating a grill for the apartment complex to prepare the food.

El Segundo resident Jane Belton has worked with Tobias. "I so admire her, for not only her willingness to do this, but her creativity and ability to work with people. She is outstanding." Belton said she saw a post on Facebook and responded to help in any way that she could. "She is very sensitive to the veterans," Belton said of Tobias, relating that when donations are brought to their residence, some veterans open the doors, some are "a little more reticent," not opening their door to the initial knock, and some are not even home. "Can't say enough good things about her and this program," Belton said. "Both my dad and my brother were in the military," Bolton offered, which piqued her interest in lending a helping hand. "The amazing response from El Segundo citizens has been overwhelming," she said, noting how people "not only donated stuff that they had in their home, but people went out and bought brand new stuff."

I emailed Michelle Leach, who has worked with Tobias at tech start-up Mobilize Solutions since 2015. "I've been friends with Elizabeth for ten years and have worked with her for six years. I met Elizabeth volunteering at a women and children's home through St. Michael's church ten years ago. She has not let up her volunteer efforts since.

"She generously donates her time and talents to so many meaningful causes for our community and schools," Leach said, "but the one closest to her heart right now is working with vets. She comes from a long line of service members, so when she learned from a caseworker about the desperate needs vets have when moving off the streets and into apartments, she rolled up her sleeves and got to work organizing monthly care packages to the apartment complex. What makes her efforts so amazing," continued Leach, "is the support she gets from our friends and neighbors in El Segundo. The El Segundo Parents Network can sometimes be a bit of a drag, but then you scroll to a post from Elizabeth asking for donations, and the whole community jumps in to help. And gosh, if you do not see the post within the first 10 minutes of being up, forget about it; you are out of luck, every spot will be taken. And that is what is so wonderful. You cannot help but feel good knowing that we all come together to support a good cause. It is easy to rally behind Elizabeth and her cause because we all feel the same gratitude and compassion for those who have given so much to our country. I have been lucky enough to help with of few of the monthly deliveries. The caseworkers' mouths drop open when they see our carloads upon carloads of donations, and the vets come out of their apartments to help unload and deliver, to chat and tell a joke or two, or just to say thank you. I hope everyone that donates or even follows Elizabeth's posts on Facebook knows how much joy and



love our community is spreading with these

monthly donations. We should all be walking

around with a little more pep because we are

changing people's lives, and we have Elizabeth

glad you are writing about her and the work she is doing."

Diana Luna, Tobias's boss at Loyola Marymount University in the school's Vet2Peer program, added: "It has been a pleasure to have Ms. Tobias as part of our team at LMU Extension. For the past two years, she has been committed to the implementation and success of our peer counseling program for veterans, Vet2Peer. She has been supporting

the recruitment efforts, outreach, and delivery of the program. Last year, she was able to fully adapt the program to an online format while creating a sense of community among the students and instructors. Her commitment to the Veteran's community was shown when she highlighted to LMU Extension that the student population required extra support to manage the program during the pandemic. Due to her request, we were able to provide the necessary technology tools, materials, and training to the students resulting in 154 students graduating in 2020 with lively and emotional zoom graduations with the graduates' families and friends.

"The caring and thoughtful approach to the Peer Counseling for Veteran's Program," concluded Luna, "and her charitable venture are a consequence of her understanding and commitment to a community that needs our support."

Wade Austin is an El Segundo resident and Vietnam veteran. He chimed in that Tobias recruited him to take part in her veterans' program. "She is very persuasive and professional and kind," he said. "I don't do enough to support the vets," he continued, but he grasped the opportunity to get involved with Tobias and her goodwill project. "They love her at the veterans' structure that she supports."

When not working at her LMU job, parttiming it at Mobilize Solutions, or selflessly helping- out vets, Tobias said she likes to entertain, cook, walk her dog, and travel. Pre-COVID, she said she was the organizer for trips to Italy, France, and Croatia and that a year-long sabbatical to New Zealand not too long ago was "the most phenomenal year of my life."

At the end of our phone interview with Tobias, she said that she did not want the story to be focused on her, but on the El Segundo community members who have rallied to support the vets. She said that we have received "amazing community support," noting how some veterans returning to the States may have "lost their sense of purpose and belonging" when they return to civilian life and attempt to merge back into society.

"When I decided to start organizing the donations," Tobias said, "I knew that I wanted it to be an ongoing program and not just a onetime event. "I think to have a real impact; you have to keep showing up. And the El Segundo community keeps showing up."

from the federal government. The most well-known one is the Pell Grant, which offers subsidies that help students with significant financial need help pay for college.

With Pell Grants, the amount is dependent on a student's expected family contribution, the cost of attendance, the student's enrollment status and whether the student attends for a full academic year or less.

A lot of students work part-time jobs to support themselves while attending college. Many schools will offer on-campus jobs as a work-study option, which is financed by government aid and connected to your FAFSA.

If you've accomplished the above and you're still looking for additional funds, federal student loans can be a viable option. If you qualify, you should receive a letter from your school that details how much money and the types of loans you can get from the federal government.

per minute, to cybercriminals.

To protect your loved ones from financial cybercrime, the first step is awareness. What are the scams?

While fraud can come in many forms, some criminal schemes are targeted at the senior population, including:

- Romance scam: Fraudsters present themselves as potential romantic partners online to exploit their targets' desire for companionship a desire that has grown for many who have felt isolated through the coronavirus pandemic and eventually get access to their money.
- Person in need scam: Criminals pretend to be a loved one (e.g., a grandchild) in immediate trouble and need of money right away.
- Investment scam: Outreach with phony investment opportunities.

- Listen. Pay attention to what your loved ones are saying and listen for worrying key phrases, such as "people are asking me for money," "my bills are confusing to me" and "I don't understand financial decisions that someone else is making for me."
- Watch. Look out for red-flag behaviors, including unusual or unexplained financial activity, abrupt changes to documents, unpaid bills or mail piling up, new friends or sweethearts or confused behavior.


