New Police Chief Looks Towards Department Growth, Increased Community Involvement

In selecting its new police chief, the City of El Segundo brought in a seasoned law enforcement veteran with nearly 30 years of extensive experience encompassing virtually every facet of the field. But for Southern California native Saul Rodriguez, it was a career that almost never materialized. Raised in Culver City and the son of Mexican immigrants with a tireless work ethic, Rodriguez never gave a moment's thought to becoming a cop during his youth. "It wasn't until I was 19 or 20 and had a job at a retail store in Inglewood as a salesperson when my friend who was the store manager was testing with the LA County Sheriff's Department and he looked at me and said maybe I should try this out too," he recalled. "I went on a ride-along with the Sheriff's Department in Lawndale and from there I got the bug to get into police work."

At first, it looked to be a wise decision. Rodriquez excelled at the police academy and was set to be hired at a North Los Angeles County jail. Then, about two weeks before graduation, a mysterious health scare threatened to derail his plans. "I had a seizure while I was off-duty, and the doctor said I had to resign for medical reasons," he said. "I didn't think I was going to ever get back to law enforcement and so I went to

Cal State Northridge to get a degree in business management."

Yet Rodriquez couldn't shake his desire to become a cop and did find his way back after a full medical clearance. "They had no idea what caused the seizure, and it never happened again," he said. Rodriguez officially launched his police career in 1995, three days after the birth of his daughter. "I know exactly how long I've been in the business based on how old she is," he said. Two years later, he joined the Santa Monica Police Department, where he remained until taking the El Segundo position in April.

Among the highlights over 27 years in Santa Monica, Rodriquez was especially proud of the inroads made to curb gang-related violence in Hispanic and Black neighborhoods. "I was asked to help in those areas for several years, and we did a lot of great, proactive police work," he said of the stint that effectively eliminated the prior spate of tragic homicides in the sector. He also spent over a decade as a plainclothes undercover narcotics officer—an assignment he found especially fulfilling. "It was my team that would be called out to try to find the bad guys," he said, adding that he served as the group's supervisor for five years and built a level of camaraderie that paved a proven path for success In future leadership roles.

By the end of his tenure in Santa Monica, Rodriquez ran the criminal investigations division, which included the detective bureau, forensics and records, and was responsible for roughly 100 employees. As a captain, he oversaw the SWAT team and motorcycle officers. He noted that the breadth of experience as an executive there was an ideal lead-in for El Segundo. "El Segundo was a position I found very attractive because it was closer to my home [Rancho Palos Verdes] and it's a city with a great reputation... and it was

City Council Hears Talks on Water Tower Color and Police Homelessness Reduction Efforts

The El Segundo City Council heard about a new pilot program to address homelessness in the city, approved staffing the NFL Los Angeles Chargers practices with El Segundo fire department staff, and heard about the city's water tower bearing a rainbow pattern of colorful lights in honor of Pride Month, which is June, and that same water tower being turned red, white, and blue in observance of Flag Day on June 14.

The city's PATCHES (Proactive Approach To Combatting Homelessness in El Segundo) pilot program will engage all city departments, including the city manager's office, the city attorney's office, code enforcement, and the police and fire departments. Its goals and objectives will be to reduce homelessness in El Segundo, partner with service providers to assist in housing individuals experiencing homelessness, implement diversion practices that discourage individuals from committing criminal acts and constructing encampments, and provide a cleaner, safer community for residents, businesses, and visitors. Key performance indicators for the six-month pilot will be the number of homeless-related calls for service; the number of homeless outreach or referrals; the number of individuals transported to temporary shelters; the number of individuals placed in longterm housing; the number of monthly joint operation efforts for outreach; the number of enforcement incidents (citations, arrests) when necessary, and the number of mental health evaluations/mental health holds, said Lt. Luke Muir of the El Segundo police department, who delivered the presentation and who has been supervising the city's Homeless Outreach Team.

Muir noted that when he moved to El Segundo in 2007, the city had two homeless individuals. "We knew them by name, and they knew us," he told the council. Now, in 2024, the latest data from an annual January homeless count in Los Angeles County, Muir said city staff and volunteers "observed and counted" 13 homeless individuals and 42 dwellings, which can be tents, RVs, campers, cars, or any type of makeshift shelter. Muir also said that the 2024 LA County count was 75,312, down slightly from 75,518 in 2023. In 2022, the count was 69,144 homeless individuals in LA County.

Muir said that homelessness "is not just a police issue," and that is why the pilot program includes a "collaborative effort by all city departments." He explained that leaders from each department would meet monthly, police would be "boots on the ground," and said that LA County case workers follow up and "build relationships" with homeless individuals, many of whom need mental health services in addition to housing. He noted that the LA County Department of Mental Health would be involved (the department already is) to provide resources and guidance and to assist with mental health crises. "I know we can reduce homelessness in El Segundo," he said.

Council member Ryan Baldino asked for all city staff time spent on PATCHES to be tracked since homelessness is "very much a county issue" and "they have the resources" to put forward. He said being able to inform the county of how much time was being spent on homelessness would bode well for the city.

Muir said that some "50 percent or more" of all El Segundo police service calls "have something to do with an individual experienc-See City Council, page 11

<u>Film Review</u>

Kinds of Kindness is a Twisted Anthology of Artful Mayhem

Despite its weird and oftentimes headscratching moments, one thing is clear: Kinds of Kindness is made by a man who absolutely loves cinema. Yorgos Lanthimos, director of Academy Award-winning Poor Things, cooks up a smorgasbord of eccentricity and kookiness in his latest work, Kinds of Kindness. It does have a lengthy runtime of 2 hours and 45 minutes but the film surprisingly breezes by with uncompromising energy. Kinds of Kindness is a film you may not completely understand, but it's surely one you will not forget.

Kinds of Kindness is a very different movie for Lanthimos. Instead of following a traditional narrative structure, the film is broken up into three distinct short films that seem to have no correlation to each other. The cast includes Emma Stone, Jesse Plemons, Willem Dafoe, Margaret Qualley, Hong Chau, Mamoudou Athie, and Joe Alwyn (with a brief appearance by Hunter Schafer). The actors appear in each film but play different characters, completely unrelated to each other. It's quite engaging and often hilarious, much like how the cast of SNL fluidly jumps in and out of different scenes and personas.

The first in the anthology, "The Death of R.M.F.," tells the story of a wayward man (Plemons) who struggles to regain control of his life, ultimately facing the mercy of his unsympathetic boss (DaFoe). In the second film, "R.M.F. is Flying", a police officer (Plemons) is reunited with his wife (Stone)

but questions whether the woman really is who she claims to be. The third film, "R.M.F. Eats a Sandwich", stars Plemons and Stone again, this time as brainwashed cult followers

who are on a mission to find the next spiritual prodigy. Of all three films, the second one stands out as most in line with Lanthimos' earlier Greek "weird wave" classics. Emma Stone's physical comedy shines here, proving that her partnership with Yorgos Lanthimos continues to strike gold.

Lanthimos and co-screenwriter Efthimis Filippou re-team with many familiar faces from their recent Oscar-winning *Poor Things* (I can't imagine how everyone had time to make this movie in between production and awards campaigning!). In addition to Emma Stone and Willem Dafoe, he notably enlists cinematographer Robbie Ryan, editor Yorgos Mavropsaridis, composer Jerskin Fendrix, and sound designer Johnnie Burn to help bring Kinds of Kindness to aesthetic perfection. It's worth pointing out that, unlike the sonically flamboyant score in Poor Things, Jerskin Fendrix takes a much more restrained approach here. All three films embody the same off-key, eerie piano melody, akin to if your cat started walking across a keyboard.

Yorgos Lanthimos' love affair with the craft is on full display, enough to make every cinephile giddy with excitement. There is enough of his classic styling, like signature angular framing and intense closeups, to allow fans to find comfort in the familiarity and just enough disruption to push boundaries. All that to say, Kinds of Kindness isn't exactly an "enjoyable" movie to watch, rather, it's wholly fascinating. The distinction here is specific; it's not a film I'm rushing to rewatch soon but that might be because I still can't


Our Pool by Lucy Ruth Cummins

not difficult to transition here due to its size not being too large."

Though previously familiar with El Segundo, Rodriguez did not realize the extent of the community's unique charm until he had the opportunity to spend time amongst the local populace. "I always heard about the small-town feel before I came here, and then I found out that it's a real thing," he said. "I enjoy being out and part of the community. Community policing is extremely important in getting to know them and what they expect from us and them getting to know me."

For Rodriguez, building relationships with the residents, businesses, City staff, and department heads is a top priority in order to position for long-term success. He also pointed to the importance of maintaining a happy police department. "I have to make sure my personnel are content in what they're doing, that they feel supported and have the ability to speak their minds," he said. "Communication across all ranks is critical that way. If I take care of my people internally, then they will also be better persons outside the community. They'll be more open-minded and willing to express themselves. No idea is a bad idea. We need to listen to our people."

For Rodriguez, the philosophy of openness and transparency also applies to staff development. Though he just started in April and has no intention of leaving town anytime soon, Rodriguez already has a succession plan in mind. "I believe the next chief should come from in-house," he said. "Any promotions from all ranks should be internal. We are building an environment where everyone should feel they have the opportunity to promote up. If I develop and train my people appropriately, you're going to get a great quality officer out in the field every day, and the expectation is to be treated with nothing but respect and dignity and the highest level of integrity you can imagine. I think it's important to continually strive and look for the best. If you don't, it will pay bad dividends in the long run."

With that in mind, one of Rodriguez's goals is department growth, provided the fit is right. El Segundo currently has 57 sworn personnel, is budgeted for 62, but it has the City Council's blessing to increase the total count to 72. "We're looking to bring on not just entry-level officers, but also lateral officers already working for other agencies," Rodriguez said. "We provide a \$40,000 bonus incentive for laterals. At the same time, we want to make sure they understand what they're getting in El Segundo. It's a family environment where we treat each other with respect, answer every call, and go the extra mile for our constituency and community." The incentive has proven effective, with recent lateral hires from Cypress, Chino, LA Sheriff's Department and San Bernardino. "We are open to any and everyone to apply and if they offer what we need, we are going to hire them."

Looking at the importance of remaining at the forefront of new technology, Rodriguez was pleased to announce the implementation of drones as a first responder program. Already in place in nearby Hawthorne as well as in Santa Monica and Beverly Hills, the drones launch from the police station and fly overhead at potential crime scenes, oftentimes well before an officer arrives. "It gives us an overhead perspective on what's occurring," Rodriguez said. "It's recorded at all times and gets integrated with the live call. This provides a lead time that can make a tremendous difference in how we approach crime, and it can be used as evidence in prosecution as well." Rodriguez added that the drones are a vital tool in promoting officer safety to identify in advance if a perpetrator has a weapon.

The department also hopes to install surveillance cameras that can be integrated with

existing cameras through a software system to help solve crimes and create more efficiencies. "This will make our detectives' jobs a lot easier and reduce the amount of time they spend reviewing videos to find a suspect or vehicle," Rodriquez explained.

Keeping criminals off the streets has been a particular challenge for all agencies in the wake of legislation in the past decade that moved droves of offenders out of jails. Then last fall, the County's new zero-bail policy eliminating cash bail payments for all but the most serious crimes put further pressure on law enforcement. Rodriguez reported that local violent crimes, already at a low rate, are down in town, and vehicle-related catalytic converter thefts that were a major issue a year ago. However, property crimes and, especially, thefts at retail establishments are up. The majority of those take place on the east side of town in shopping complexes. "We are working with the retailers to monitor their cameras and whatever surveillance systems they have so they feel safe and confident we're doing our best to catch any suspects who have committed crimes in their area," Rodriguez said.

Another area Rodriguez continues to monitor is El Segundo's homeless population, which is relatively low in number but still an ongoing concern. The police and fire departments work with the City Manager's office on an outreach program to explain to those living on the streets what services are available. The situation is complicated, the chief noted. "The homeless population is the most vulnerable population that's out here right now,' he said. "It's unfortunate as they have no home and nowhere to go. Many are dealing with mental health issues. We have to make sure we deal with it appropriately and with integrity... and to treat them fairly because homelessness in itself is not a crime."

Though he clearly has plenty on his plate

as he gets up to speed with the new job, Rodriquez manages to find time for a life outside the department. He enjoys visiting his parents, who still reside in the same home where he grew up in Culver City. He has two grown children plus a five-year-old who keeps him on his toes. A workout buff, he stresses the importance of maintaining wellness by going to the gym and bicycling. However, basketball is no longer an option. "I'm not at the age where I can play hoops anymore," Rodriguez lamented. "I used to love it, but don't want to hurt myself."

A movie fanatic, he admitted to being addicted to romantic comedies and watches them regularly with his fiancee (who has two daughters of her own). "I don't know why—they're just cheesy and an easy watch to keep your mind off of everything."

Since his arrival, Rodriquez has been extremely active in attending community events and meetings. He also encouraged residents to contact him if they wanted to set up a neighborhood watch. The department also looks forward to its own programs, such as the annual National Night Out coming in August and the periodic Coffee with a Cop gatherings.

"In the last few years, there was a different feeling about law enforcement, and we want to break that sense of negativity," Rodriquez said. "We hope people understand that we're human and that they can see the human side of police work. We may not be right 100 percent of the time, but if we do make a mistake, we are going to work to get better. I am proud to be part of a great organization, and my job is to make it better and even greater than it is now. We are not just employees, but part of the community. El Segundo is a beautiful city and I am doing everything I can to make sure that we are recognized as not just one of the best organizations in Southern California, but in the entire country." •



ing homelessness" and noted that tracking will be improved for the pilot program. A past example of something homeless-related but not tracked to the "homeless" category was an incident in which an individual stole a tent from Dick's Sporting Goods. The new data tracking will capture a situation such as that and report it as a homeless-related incident. He said the city is close to having a new platform with an app ready for public use to report homeless-related issues and that the pilot program will be reevaluated in six months.

Mayor Pro Tem Chris Pimentel said, "WE pay a lot of money into the (LA) county..." and asked for coordination with other police departments city and county, and mentioned that a family reunification system costs \$7,000 per individual while a government-supported rehousing costs about \$70,000 per individual. He said money should be made available for family reunification efforts. The city council will receive a 90-day update on the pilot program. Muir said he anticipated having all department leaders Ready for their first monthly meeting by the end of July. The presentation was a receive and file.

In fire department news, the city council voted 4-0 (council member Carol Pirsztuk was absent) to authorize a request from the NFL Los Angeles Chargers football team for

coverage by El Segundo firefighters/paramedics during specific practices of the team on its new El Segundo practice field. The NFL requires each team to have mandatory and non-mandatory standby coverage at each of their practices to reduce response times if an injury occurs. "Hard coverage" (full gear practices) will involve two off-duty El Segundo firefighters/paramedics in the reserve rescue ambulance, and "soft coverage" will involve on-duty firefighters standing by on the scene with the ability to respond to any 911 call in the community.

With its approval, the first practice El Segundo will staff is set for July 23. The regular NFL season begins in September and lasts through the end of January. In preseason, there are 14 mandatory hard coverage practices and 14 soft coverage days. During the season, there will be one mandatory hard coverage practice each week.

The agreement stipulates that the Chargers will reimburse the city at the fully burdened rate of fire personnel at a time and a half and that the cost for a daily fire apparatus will be invoiced at the Cal OES rate presently set at \$260 per day. If any patients from the Chargers are transported, the team will "incur the standard Paramedic Service and Transport fees."

The city can revoke the contract with a 90-day written notice. The contract is for five years and broken into three and two years. It is set through June 30, 2027. The fire department currently has five firefighter/paramedic openings; however, the fire chief noted those were expected to be filled in mid-August.

Notably, the conversation about the water tower and its recent color changes was brought forward during the Public Comment portion of the meeting by El Segundo residents John Pickhaver and Anya Goldstein, who addressed the council separately. The city frequently places lights on the iconic water tower in observance of holidays, traditions, and other situations deemed notable. He said that City Council member Carol Pirsztuk had "greatly misled the community" via a comment she'd made on a June 15 El Segundo Parents Network Facebook page post by an El Segundo resident who asked for the water tower colors to be returned to rainbow colors for the remainder of June in honor of LGBTQ+ Pride Month. The rainbow colors on the water tower had been changed to red, white, and blue on Friday, June 14, which Pirsztuk indicated in her comment was in honor of Flag Day, and she said that those colors would remain until from page 2

President Joe Biden's arrival at Los Angeles International Airport, after which the colors would return to rainbow. Pickhaver took issue with Pirsztuk's words and disclosed how he found out via a Public Records request that she had texted Public Works Director Elias Sassoon on June 14 asking for the tower to become red, white, and blue and remain that way through July 5. He related what he'd written on the post feed and provided details, including a timeline, about what had happened and the email and influence of a resident who is notably anti-LGBTQ+, whose email to city council Pirsztuk then forwarded to Sassoon. Pickhaver calmly stated that he wasn't sure one person should be directing what colors the water tower should be and said that on her Facebook comments on the post, Pirsztuk "implied" that a "we" had made the changes when the edict to change the colors to red, white, and blue actually only came from Pirsztuk herself. Goldstein asked for clarification from the city attorney as to why one council member was instructing what the public works director should do. In his remarks addressing public comment, City Manager Darrell George said, "We tried to do the best thing in the lighting of the water tower. I think it's best to come back with a schedule." •




