# **El Segundo's Natalie Strong Attempts to "Create Gold out of Every Day."**

Communicate with El Segundo resident Natalie Strong, who serves as the cities Arts and Cultural Advisory Council vicechairperson, and her return email features the motivating tagline "create gold out of every day."

So, what does that mean? Strong is a child of the evil empire a tad bit south, Manhattan Beach (just kidding, Plank spent his formative years in MB, which at one-time was a quaint little beach town), an attendee of the Chadwick School up in the Peninsula, and a USC collegiate grad who spent some schooling time in Kent, England, a year she said was "amazing."

## **Donna Taylor Praises El Segundo for its Donations to Animal Shelters**

From July of last year through May of this year, Los Angeles processed over 9,000 dogs in its shelters. This was in addition to over 6,000 cats and over 5,000 other animals, like birds and other pets. Some are found, some are surrendered, but all are collected and kept at animal shelters throughout the county. During this time, shelters struggle to find enough resources to care for all of these animals at any given time. Enter Donna Taylor and the generous community of El Segundo.

Every so often, Donna Taylor, a longtime resident, and neighbor of El Segundo, runs her donation drive for local animal shelters. She asks her communities of Playa Del Rey, Playa Vista, El Segundo, and the surrounding neighborhoods to donate towels, food, blankets, and other necessities for the sake of rescued animals. El Segundo, she says, never disappoints.

"El Segundo continuously steps up to the plate and overfills my SUV with whatever it is that I'm asking for," says Taylor. El Segundo specifically has fueled the majority of her donation runs, making sure the animals have towels for surgeries, beds for comfort, and enough food to keep them healthy.

#### School District Not Being Truthful

I am writing in response to the El Segundo School District full page ad regarding the proposed gym at the middle school. The residents on Center Street and the north side of the middle school are the most affected by the gym addition and it's location. I am telling you, we were only made aware of the gym project recently by chance. At no time did we receive any communication from the school district or school board. When we made our concerns known to the school board, they gave us drawings of 5 construction proposals which we studied and responded to. We learned, however, that the construction layout they had already approved was NOT among the 5 proposals given us. We have given our views by way of letters and comments at several zoom meetings. We have a neighbor who has offered to sit down with the board as a representative of the neighborhood and the board has ignored the offer. The school district is not being truthful in conveying that they considered input from residents who live around the school. It's clear by their minimum required approach and dismissive actions and comments towards us that the neighbors really don't matter.

Middle School Construction Many wondered why three jurisdictions of school Bond oversight would take out a full-page advertisement after a deceitful force-feeding of community STEMM bond scope on the neighborhood? The ad targets neighborhood resident's objections to advancing ESUSD's agenda and aesthetics. All for another hostile, anti-community, public school facility hardening. Meanwhile residents (now bond victims) must accept the loss of another ESUSD open campus and wildlife habitat; with associated heat island generated by parking lots, paving, and a Gym-at the only one of three alternative locations they opposed; to enhance a STEMM learning facility. ## **Oaks Crowned Champions**




The Beavers' Jaime Owen is tagged out trying to steal second base by Dylan Immel in the semi-final game the Oaks won 5-

chips fall in the right direction, will resume this year in late August.

Murphy has known Strong for eight or so years, with their friendship starting when the mom's shepherded their kids to-and-from school. Murphy said that their paths have crossed in many ways. "We are both artists, in different media," Murphy said, noting that her artistic design specialties include fabric and tile and paint and appliances and lumber, while Strong specializes in "fiber arts," but she also "paints and draws, and does all sorts of other things."

Murphy said that their shared interest in artistic projects had led her to commission Strong to design not only "a beautiful custom quilt for my own house," but also pieces for Murphy's clients, including embroidered and painted items. Murphy has also hosted Strong's work during prior Art Walks.

"We are kindred spirits," Murphy said. "Natalie cares so much," noting her work for the El Segundo library and the arts and cultural committee. "She does it with her whole heart, with a passion for promoting art in all of its forms. She is definitely a voice of art in town."

As previously noted, Strong was a Manhattan Beach gal who attended Chadwick, moved for an awhile to Hermosa Beach, and settled in El Segundo with husband Richard. He just happened to be recently profiled in the Herald. Why land in El Segundo?

Strong cited the strength of the El Segundo Unified School District, as well as El Segundo being touted as a good place to raise her children. And when she is not working for pay, volunteering her time, or supporting her husband and kids, Strong said she likes to quilt and knit. When asked why she is so passionate about participating in art-related projects, Strong said she sees a vital need for "everyone to express themselves. Some people do it with gardening, some with computer coding. Arts are an important way to enrich the community, make the world more beautiful."

Strong has been working on the Arts and Culture Council for three years. She sees the council's mandate as one that tries to continue bringing culture to our city, "lending a hand to existing projects," as well as developing new endeavors. She is eagerly looking forward to, now that the COVID scourge has decreased, the resumption of the Art Walk program, and other similar El Segundo cultural outreach activities.

As for her post with the Parks and Recreation department, which Strong said that she has manned for about five years, she is looking forward to working again with the youths of El Segundo. "I can't wait for it to all come back," she said while noting a tentative resumption date of programs this Fall. "I never stop being inspired by the things kids think of," she said. "Their brains work definitely different than ours," she said.

types of pain management techniques," said Hasan Abed, MD, Anesthesiologist and Pain Management Specialist, Advanced Pain Management located in Timonium, Maryland.

If you take NSAIDs, it is important to talk to your healthcare professional because as many as one in four regular NSAID users are at risk to develop stomach ulcers - sores on the lining of the stomach caused by stomach acid.7 In addition to taking high doses of NSAIDs, other risk factors include taking NSAIDs with aspirin, or while taking corticosteroids or blood thinners, having had a stomach ulcer in the past and being older than 65 years of age. needed. So she began taking it upon herself to make sure no animal in her care was neglected in any way.

One day, a dog named Teddy crossed her path. At just four months old, Teddy was bitten by a much bigger dog, necessitating wheels for mobility. Taylor fostered Teddy, got him his wheels, rebuilt his strength through hydrotherapy, and fell in love with fostering in the process.

From there, Taylor began operating her rescue. In her time, she rescued and found homes for 90 dogs. The dogs she chose to foster were the ones that might have been receiving less attention and were less likely candidates for adoption—all of this she paid for out of her pocket.

The most common type of dog that gets adopted are the ones that are considered "cuter." This includes pugs, French bulldogs, and fluffy-looking dogs. Typically, says Taylor, she sees breeds like chihuahuas and pit bulls stay in shelters much longer, as well as dogs that are shy or haven't been

"I have a dog that I [rescued]..." she says, "she had foxtails in her eyes, and she couldn't see. You absolutely couldn't see her with all that matting." After some time of being overlooked for adoption, Taylor took her in, got her cleaned and shaved, and was surprised to see an adorable white Shih Tzu. Unhealthy and shy before, now she was fluffy, confident, and ready for a new home. Taylor got over fifty applicants to take her in.

Through her time rehoming dogs, Taylor describes her process of vetting applicants before releasing the dog. For her, the whole process was about making sure the dog was the most comfortable and cared for that it could be. This included checking applicants' spaces and making sure they knew all the responsibilities that come with dog ownership. This is meant to ensure the dog's safety and decrease the likelihood of a returned adoption. Often, dogs coming from shelters will have kennel cough, leading new owners to believe they are seriously sick. According to Taylor, there is no need to panic if a new adoption has a cough.

"Oftentimes, the adopter gets scared and returns the dog. It's nothing to be scared about. It's a cold, and it will go away in about ten days," Taylor says. Dogs coming from shelters have been exposed to more than they would in a home, so having some illnesses or infections isn't unlikely.

Another reason adoptions might not work out is that the dog may not get along with current pets. This, says Taylor, is partly due to the adopter not bringing their dog to the adoption to find out their reaction ahead of time and partly due to the way the dog is introduced.

"Take them outside on a leash, let them sniff," she says. Keeping a new dog out

introduce a new pet without the danger of aggression.

Though she no longer runs her rescue, Taylor is now a professional dog sitter and walker, using her years of experience to help busy families take care of their pets while keeping them in the loop at all times.

Having been working with dogs directly since 2010, Taylor wants to encourage adopting, not shopping. She says you can even adopt purebred dogs with serious searching and some patience, as many are surrendered and lost.

Taylor posts on local Facebook pages when she is doing a drive and adds that the most common need from shelters is towels, blankets, and food. Toys are not usually accepted, and bowls typically have to be metal, as ceramic may break and hurt the animal.

"Adopting an animal is unconditional love. You don't realize how much that animal adds to your life until you've had an opportunity to get one of your own." •
