## The Community Says Goodbye to Coach Steve "Shev" Shevlin

When July first came, El Segundo High School said goodbye to a legend. This treasured rarity had walked the hallways as a teacher or Athletic Director and the gridiron sidelines for the past thirty-five years. There aren't enough superlatives to accurately describe what Steve Shevlin has meant to the high school and our community. If there were a Mount Rushmore of El Segundo High School coaches chiseled on a mountaintop, there you would find Urho Saari, Henry Stuart, John Stevenson, Rick Sabosky, and Steve Shevlin smiling down upon you. After a career that has spanned over four decades, it was the right time for Steve Shevlin to say goodbye.

Steve Shevlin, affectionately called 'Shev' by fellow teachers, students, and his players, started his career in December 1989, replacing the legendary English teacher Kathy Peterson. For nine years he split his time between his English classroom and PE class assignment while spending time as an assistant football coach and then as head coach.

In 1999, Shev moved from the classroom to the Athletic Director's office, replacing another legend. When John Stevenson retired after an illustrious career as a teacher and ended with over 15 years as Athletic Director, it created a vacancy for the right person. "How do you replace a legend?" Shev said. "I felt it was my responsibility to carry on what has been a very successful athletic program. I had been privileged to work with John Stevenson, Craig Cousins, Steve Newell, and Rick Sabosky. Our school administration of Dr. Bill Watkins, Jim Garza


and Dr. Newton Hart were all very supportive."

For the past 25 years, Shev has been the Athletic Director, a demanding position, to say the least. His responsibilities were numerous and, at times, complex. He was in charge of preparing budgets for athletic programs, providing leadership and guidance for sports activities and programs and providing an equitable field time frame for various sports teams. He oversaw purchases of athletic equipment and ensured the facilities were maintained. He was also in charge of ensuring compliance with rules and league policies, as well as student/athletes and their residency. He says he was mentored by John Stevenson, one of the most organized and

well respected Athletic Directors according to the CIF Southern Section, California's governing body of high school sports.

During his tenure as AD, the El Segundo High School athletic department enjoyed its best success over a twenty-five-year span, perhaps in school history. It included 23 CIF Finals appearances, 16 CIF championships, and 96 league championships. As head football coach, he won a school-record 155 games. He led the Eagles to several league championships and the program's only CIF Finals appearance.

Shev says his motivation as AD was to carry the 'torch" forward that John Stevenson,


### What Remains Tells The Harrowing Story of Sweden's Most Notorious Serial Killer

Inspired by true events, What Remains tells the harrowing story of a mentally ill Scandinavian man who confessed to, and was convicted of, more than 30 murders. Based on the life of Sweden's most notorious serial killer Thomas Quick, filmmaker Ran Huang avoids turning this emotionally fraught story into a showy spectacle. It can be argued that the true crime genre, as a whole, has become "Netflix-ified," catering to audiences who crave easily digestible, pop culture content over the more mundane reality of police investigations. What Remains is not an easy watch in any sense. It is dark, voyeuristic, and devastating. It is also an interesting meditative study of the effect trauma has on memory.

Mads Lake (Gustaf Skarsgård) has been held in a Scandinavian psychiatric hospital for years after being convicted of abuse. Recently, though, his chance to start over and rejoin society is actually within reach. The thought both excites and terrifies him. Mads currently exists in the world as a shell of a human. He has hollow eyes and a shaky voice that barely registers above a whisper. His long, stringy hair and unkempt appearance show obvious signs of depression and defeat. His look is the epitome of a guilty man.

This is also the impression he gives his therapist Anna Rudebeck (Academy Awardnominated Andrea Riseborough) upon their first meeting. However, she can see through Mads' physical appearance as she gently digs into his past in search of the canon event

that altered his life. It's not long before she discovers that Mads' horrific upbringing and realizes that history is repeating itself. However, Anna stays neutral and non-judgmental, offering patience and grace. Officer Soren Rank (Stellan Skarsgård), on the other hand, has a less lenient approach. His only goal is to get to the truth of the unsolved disappearance of a young child that Mads may have been involved in.

Anna and Soren's opposing viewpoints sometimes lead to tense conversations, which only makes Mads' memory murky. Did he kill this child, and the others? At first, Mads is adamant he had nothing to do with the child's disappearance. But as evidence is produced that seems to claim otherwise, Mads begins to question everything he thought he knew about himself.

What Remains is a bold directorial debut for Ran Huang, whose only previous credit includes the 2014 short The Administration of Glory. Most notable is the deliberately slow pacing, almost leaning into director Apichatpong Weerasethakul's territory. For a high-intensity, high-stakes thriller, Ran Huang unfolds the narrative beats in What Remains with almost too much restraint. Running two hours and six minutes, a tighter edit could have offered a stronger thrill component to the story. As it currently plays, the abundance of silence dilutes the tension.

The darkness of the subject matter equally matches the film's visual aesthetic. The score, composed by Ben Frost, includes limited cues. But when the intensity of the music starts to creep in, it effectively shifts the whole mood. It's also worth pointing out that What Remains is a family affair for Sweden's royal family, the Skarsgårds. Not only does Stellan and his son Gustaf star in the film but Megan Everett-Skarsgard (Stellan's



### The Smoke in Our Eyes by James Grady

The Smoke in Our Eyes is a coming-of-age novel seen through the eyes of Lucas Ross, a ten-year-old living in Montana in 1959. It was a time of upheaval with segregation and racial tension, the Space Race, and the precursor to the '60s. When a fatal accident shatters the small town, Lucas finds his family in the middle of the storm. The automobile crash that takes the life of a high school boy and leaves another alive affects everybody in the small rural town.

Lucas is an observer, and adults provide endless opportunities for learning. Lucas's father has worked for the same employer his whole life but now feels threatened by the new son-in-law of the owner with his big ideas. Lucas's mother is one of four sisters from a tight knit family notorious in the small town. His sister Laura is in line for a scholarship that is now in question because of one small act of rebelliousness. The summer of '59 will prove a turning point in Lucas's short life, propelling him headfirst into young adulthood.

When Laura confesses she was at the party where the boys were drinking, everything she has worked for is in peril. She saw the two boys take off in the car, but they changed drivers more than once so she can't be sure



## Tips for Sticking to a Healthy Lifestyle Plan

(BPT) - How can you make healthy lifestyle changes that will stick? Dana Ryan, Ph.D., MA, MBA, director of sports performance, nutrition and education and Chair of the Herbalife Fitness Advisory Board at Herbalife, says it's all about enjoyment, community and confidence.

"In my opinion, the magic ingredient that helps boost the motivation is making friends and becoming part of a community," Ryan says. "The added accountability that friendships or fitness mates can provide can help to create long-lasting healthy active habits."

The Ohio State research study found the same thing. Accountability is a key factor in sticking with positive changes. But, it's about more than dutifully reporting in. Much more. Here are Ryan's tips for making healthy changes in your lifestyle that stick, supported by research from the National Library of Medicine.


Choose an activity you enjoy while you're doing it. It's crucial to pick an activity you enjoy and that feels good to your body. This is a huge predictor of success, and it's a typical area that people get wrong. When embarking on a fitness journey, many people focus on how they feel after the workout is over. A sense of accomplishment, that buzz of electricity, a rush of endorphins. But if you're slogging through a workout - running on a treadmill as you watch the distance tick off, ever so slowly - to feel good after it's over, it's likely you won't stick to it for long. Burnout will kick in quickly and you'll be making excuses to skip the gym. Instead, find an activity that makes you feel good while you're doing it.

Not sure what that is? Try different things. Take a yoga class, experiment with Pilates, book a few sessions with a personal trainer at the gym, join the rowing club on a nearby lake or river, rent a kayak for a few hours. Dust off your bike and get it tuned up, and take it for a spin. Find a pickleball club near you. Get those 10,000 steps in with a neighbor each morning. You'll find something you like to do, guaranteed.

Stick with it past the learning curve. The secret is to give it a little time for your body to get used to those new movements. You'll get better at it. Yoga will get easier, you'll be able to bike farther, Pilates will feel more natural. It is at that point you'll start to feel body confidence. And then you're hooked.

Find a community where you feel recognized and supported. Here's where accountability comes into play. But remember, it's not about dutifully reporting in. It's about finding a community to support your fitness goals. It could be a yoga class that you take at the same time each week, or a fitness club you frequent every day after work. It could be a workout buddy you meet up with at the park, a group of neighbors who walk together, a wellness coach who motivates you through your nutrition and fitness routine, or even your dog, who waits at the door each morning with his leash. Numerous studies show how finding community, even if it's a community of just one other person, helps people achieve their fitness goals.

Each of these tips builds on and supports the others. If you pick an activity that you enjoy, you'll experience a heightened emotional response and a greater release of the exercise-induced happy hormones dopamine and serotonin. This induced feeling of joy may encourage you to keep at it. If you keep at it beyond the learning curve, you'll master body movement and feel confident, and that will keep you coming back for more. And if you do it with a buddy, it will elevate your social connections and encourage you further. •

You sign up for a great deal on wireless service, but when it's time to pay, the numbers just don't add up. That \$70 service shows up on your bill as \$80 or more, leaving you confused about how your costs have gone up without any warning.

Some are mandated by government regulations, but others are fees applied strictly at the carrier's discretion. One of the main challenges in understanding your bill is deciphering the language used to itemize these charges.

Some carriers now roll all of their fees into a single monthly charge rather than listing them separately. While this may make it appear that they have eliminated extra fees altogether, this is not the case. Chances are, regardless of how the numbers are presented, you're paying for more than just your monthly service.

Obviously, certain taxes and fees are unavoidable, and even necessary. State and local taxes, the 911 fee used to fund access to emergency services, and payment into the Universal Service Fund to help underwrite rural and low-income telecommunications services, are all required by law.

But it's those pesky, less obvious fees that you have to be especially wary of, as they drive your costs up in unexpected ways. Most major carriers have an a la carte menu of items that trigger additional charges, and you probably don't know they exist until they show up on your bill. Beware of things like:

• Overage fees: If you use more minutes,

text messages or data than your monthly plan allows, many carriers tack on an additional charge for every bit of extra usage. Ask your carrier how they handle this, and be sure to take advantage of free usage alerts, by text or email, to help keep you on track.

• Activation and device upgrade fees: You may be excited about getting a new phone or upgrading to a new one. But, be aware that your carrier may charge you \$30 or more to connect it to their service. With premium smartphones already costing in the \$650-\$1,000 range, this extra charge can be an especially bitter pill for many cellphone users to swallow.

• Administrative charge: These are similar to regulatory charges, but more nebulous. They're usually billed as fees to cover the costs paid to other carriers when talking to someone on a different network, but they can also be applied for a host of general reasons. For instance, some carriers apply them for costs associated with cellular site rental and maintenance. Also, these fees can, and do, change from time to time, so watch them carefully.

You've already started here, just by learning what to watch for. If your carrier's fees are too high, switch to one that offers greater value by charging fewer fees. Ask about this up front. Consumer Cellular, for instance, is a no-contract provider which, on top of low-cost monthly service, provides free activation, free SIM cards, and charges no fees for changing plans or for overages.

Every little extra fee adds up to a great big phone bill. Choose wisely, and you'll avoid being a victim of "bill shock." •










### **Coach Shevlin** from front page


What made Steve Shevlin one of the most recognizable people on campus, in the community, and around the CIF? He says there is no secret to his success. There were lots and lots of canceled plans, sacrifices, and missed vacations." He added, "Everything was always a family decision, and without their support, I could not have stayed on as AD for 25 years."

On the school front, Shev says his biggest supporter was athletic secretary Patricia Guzman; they worked together for 22 years. "Her commitment to the students and success of the school is unparalleled, and she has been the linchpin my entire career as AD." Shev gets emotional when he says, "Patricia has made a tremendous amount of sacrifices to help keep the athletic department running smoothly for such a long time. She has always gone way beyond the call of duty and made me look great in doing so."

Other great supporters during his time as AD were the Activities Directors, Tim Harrison, Robin Espinoza, and Ashley Richmond. "They are amazing at inspiring the student body to support all activities at school and encouraging the kids to have fun. They did a phenomenal job rallying student my job easier."

When Shev passes the torch to Fotis Davlantis, the next AD, what's his advice? "We're a small school so participation by as many students is key. Promote the athletes to play and participate in as many sports as possible to find their interests. And then, let them decide on their athletic path."

He stressed, "Always strive to do what's best for the student-athletes and the school, and as best as you can, make personal time for your family. Last thing - hold on tight it's a wild ride!!"


Quotes from some coaches he worked with and former players he coached offered a glimpse of what Steve Shevlin meant to them and to the school:

To his core, Shev believed that his players could compete with anybody on a Friday night, and that was instilled in me on the field and now in life. I still think about this today and how important it is to take pride in everything I do throughout my career and in my life."

Mike Bundy: Coach Shev was the ultimate role model and mentor for me and so many others as we were young men and women growing up. Not only on the football field but everyone that he interacted with has learned a life lesson or many from Shev. He molded football players but also was teaching us lessons about how to be great teammates, brothers, fathers and contributing members of society. Thanks for everything, Coach Shev, and enjoy retirement!

Lars Nootbaar: Shev has meant the world to me, from being an assistant coach on my Little League Dodgers team to being my high school football and baseball coach. He has helped me out throughout my entire life and I know for a fact I would not be where I am today without Shev in my life. He had an impact on me as an athlete, but his biggest impact on me, and so many others, were the life lessons he taught us. I am forever indebted to Coach Shev.

Matt Engle: "Keep the Faith." This was a common slogan for Coach Shev. It captures Coach Shev's relentless belief in his players and their ability to be the best version of themselves. His affection and deep love for his players motivated all of us to become the kind of football players that we dreamed of becoming and the type of men he knew we needed to be. Coach Shev, I am forever grateful for you, for your unwavering support and your belief in me. You are every kid's desired head coach and I am so grateful to call you my coach!

In retirement, Shev says he won't be idle or bored and will be active. Before saying a final goodbye, he wanted to thank El Segundo High School and our community. "It has been the honor of a lifetime to have been a part of this community for 30-plus years. I am blessed to have played a small part in carrying the rich traditions of El Segundo High School athletics forward to the next generation. Thank you to all the players in all the sports. You have made El Segundo the special place it is and thank you for allowing me to play a small part; GO Eagles."

Move over Urho Saari, Henry Stuart, John Stevenson, and Rick Sabosky, and welcome Steve Shevlin to the mountaintop. •






