# Gilda Dyckman Cracks Down on Catalytic Converter Theft

During the pandemic, Los Angeles County reported a 400% increase in the theft of catalytic converters. All across Facebook, Next-door, the Citizen app, and local reports, stories of catalytic converter theft remain one of the top stories. So what is a catalytic converter exactly, why is it stolen, and how do they steal it? Gilda Dyckman explains what is happening and how you can prevent it.

To protect your vehicle from catalytic converter theft, Dyckman and her shop, Cars Automotive & Muffler, work with the El Segundo Police Department and other police departments in the South Bay to etch identifiers onto converters, as well as place protective cages and shields to deter thieves.

Every gas-powered car since 1975 has a catalytic converter. Located in the exhaust system, the catalytic converter serves to filter out the worst pollutants from the car before they enter into the air out the tailpipe. It looks like a little metal box on the bottom of the car, with two pipes coming out of it. In one pipe, harmful gases like nitrogen oxide and carbon monoxide from the engine get oxygen added or removed so that safer gases like nitrogen, oxygen, and carbon dioxide come out into the air.

"It's the metal that's in the catalytic converter," she explains, "the rhodium and the palladium. Rhodium is like \$22,000 an ounce." As cars become more environmentally friendly and sustainable, the search for nonreactive metals to filter out pollutants has reached an all-time high. Rhodium and palladium do the job very well.

As we recover from the pandemic, the market for cars has started to pick up again,

which means the demand for these metals has skyrocketed, driving up their price and value. One catalytic converter can cost around \$2000 to replace and can be sold for scrap on the black market for a few hundred dollars, depending on the converter and the metal inside.

Hybrid cars like Priuses are targeted most frequently, because they contain higher levels of metal and because these cars also run on electricity, meaning the converter is used less.

Because there are so many drivers in California, and especially in LA County, the state requires correct catalytic converters on

## Your Neighborhood Therapist

Dear Neighborhood Therapist,

I am happily engaged, but as the wedding date gets closer I find myself thinking about a relationship from a few years ago. It was a very good relationship for a long time (we were together longer than my fiancee and I have been), and we had discussed getting married. I was close to buying a ring. It was very different from my current relationship. Now I find myself thinking about all of the ways that my former relationship was satisfying that my current one is not, and while I am definitely happy to be marrying my fiancee, I worry. How can I stop my past relationship from affecting my marriage?

#### Dear Worried,

Your relationships with your parents, relatives, friends, and the place you grew up affect who you are, and who you are affects your marriage. It doesn't make sense that past romantic relationships would somehow play no role, either. This is the good news! In many ways, your "baggage" is baked in already: your past relationships are already affecting the current one. (The same goes for your fiancee and her life, of course.)

But I suspect that you'd like to know if it is possible not to feel the very thing you happen to be feeling. I wish I could fix that. The pang of regret, the path not taken, the things you miss about another person that you will never have again... these are things that most reflective people think about.

What you can do is try to figure out - as best you can, nobody gets it perfect - how your past relationships have affected you, and thus how they affect your marriage. The reason for doing this is so that you can account for these effects and act accordingly.

Just as an example, you may discover that it's harder for you to give affection than you want it to be. Now that you know that, what do you do?

No, that's not so easy to figure out. You might need some help. But it's a good start if you take a look specifically at what you are giving up by getting married, and then think specifically about why you hope that marriage will make giving up those things worth it. What are the trade-offs?

Next, give yourself a break: we all think about what might have been, and the lives we might have led under different circumstances. Of course you may wonder what your life would have been like if you had married someone else. You may even wish you had sometimes, especially when things that you used to enjoy may not be as accessible as they once were.

You know you will have to make sacrifices, and yet you have still decided to give marriage a try. This suggests to me that you have a sense that you can do this, and that you think it's worth it. And that's the key. What I am about to say doesn't mean you should never work to make your relationship better, and it's not very romantic, but I think it's helpful to consider on those days when we think the grass is greener: a marriage doesn't have to be perfect, or even great. It just has to be, for you, better than the alternative on more days than not.

## Summer Baseball Still Alive in El Segundo

It's been two years since baseball in El Segundo extended into the summer months. Little League All-Stars, Babe Ruth League All-Stars, and American Legion teams were each in action playing in District and State tournaments.

## 15s Advance to Regional Tournament with a Pair of Wins

El Segundo faced Heartwell in a best of three series, with the winner advancing to the Pacific Southwest Regional Tournament in Bakersfield. El Segundo swept both games 5-0 and 9-2 to punch their ticket to the Regional for the first time since hosting the 2012 Pacific Southwest Regional Tournament.

In the first game, Dominick Kopecky singled, stole second base, and scored on a fielder's choice to give El Segundo a 1-0 lead in the third inning. Max Martinez's solo home run extended the lead to 2-0 in the fourth inning. In the fifth inning, Lucas Bonham's RBI single scored Aiden Corral, and El Segundo would tag on two more runs in the sixth inning for the 5-0 win.

In the second game, El Segundo combined three pitchers to hold off Heartwell in their 9-2 win. It was a game of opportunities that El Segundo took advantage of. Trailing 2-0 in the third inning, El Segundo tied the game when they walked three times and were the victim of two hit batters. In the fourth inning, Kopecky singled and stole second base; he would score on an error. In the fifth inning, Nik Kvitek was hit by a pitch and scored on a double-steal, while Corral scored on an RBI single by Kopecky to make it 7-2. El Segundo would tag on two more runs in the sixth inning to make it a 9-2 final. Dominick Kopecky, Dylan Alcala, and Max Martinez combined to limit Heartwell to two runs on five hits, and Martinez struck out six in three innings.

El Segundo advances to the Pacific Southwest Regional Tournament in Bakersfield starting July 25. The winner of the Regional Tournament advances to the World Series beginning August 10 in Eagle Pass, Texas.

## 14s Win in a Walk-Off

El Segundo won its first game in the state tournament in thrilling fashion when they spotted Heartwell a 3-0 lead. In the third inning, Grady Lubs singled and later scored on an RBI single by Ethan Ayler to close the gap. With El Segundo trailing 3-1 in the bottom of the seventh inning Reed Abrams, Shane Huber, and Mays Borgmeyer each drew a walk. Lubs' sacrifice fly ball scored Abrams to make it 3-2. Gavin McKinnon had an RBI double scoring Robert Cantu who pinch ran

# Visual Poetry Lights up Los Angeles in *Summertime*

When Amanda Gorman took the stage in January at the 2021 Presidential Inauguration, two things happened. One, she sparked a meteoric rise of her own accord, landing nationwide notoriety, book deals, and an IMG modeling contract. She also-maybe more importantly-normalized and encouraged younger generations to explore spoken word poetry for themselves, proving that age is not a factor when it comes to self-expression.

In his latest film, director Carlos López Estrada (Blindspotting, Raya and the Last Dragon) shows how the streets of Los Angeles are filled with inspirational youth who are ready to speak their truth in the spoken-word musical, Summertime. Like an indie version of In the Heights for millennials (complete with mixed races and various skin tones!), most heart-wrenching scene comes in the form of a formally insecure woman finally standing up for herself to a manipulative ex-boyfriend.

I believe the success of Summertime comes from untraditional factors. The overall narrative and acting is fairly good, not outstanding, but what makes this film unforgettable is the outpouring of pure visual poetry (which outweighs any nitpicky criticism). The story of how Summertime came to be is just as impressive as the film itself. Together with López Estrada and Executive Producer Kelly Marie Tran, twenty seven youth poets workshopped their material over the course of one Summer in Los Angeles. The result is this feature film, a loose narrative structure comprised of intersecting stories from the poets themselves, all of whom make their feature film debut as co-writers and stars.

Depending on the scene (and therefore the dialogue), Summertime is a mix of emotional, comedic, and nostalgic instances that reflect the authenticity of the poets. One scene humorously calls out the prices at trendy Los Angeles eateries, and how a piece of avocado toast costs the same as basic livelihood necessities for lower income communities. Another scene shows an empowered queer woman giving a fierce monologue as she stands up for another same sex couple on a metro bus. Perhaps the Lane: job well done. Thank you for sharing your stories with us.



## Stillness is the Key by Ryan Holiday

Ryan Holiday is one of my favorite present day thinkers. He is the author of bestsellers The Obstacle is the Way and Ego is the Enemy, each pulling from the writings of stoic philosophers Seneca, Marcus Aurelius, Epictetus, and others. Now with his latest, Stillness is the Key, he once again presents a variety of stoic philosopher's notions and

connects the wisdom of these philosopher's, through the pursuit of reason, to today's times. Ryan Holiday suggests that when we are able to live in stillness and find inner peace, then we can find happiness and be our best selves.

Ryan separates the book into three parts; Mind, Spirit and Body. For mind, Ryan makes suggestions such as "Limiting our Inputs." He suggests asking ourselves if the information we are taking in is necessary. At times our brains get overloaded with so much information coming at us on a daily basis, that we may feel as if we are drowning, which brings unneeded stress. By limiting the information we take in it can help reduce brain overload.

Next, the Spirit, he suggests getting to the point of "Enough." He feels that to experience stillness it is important to feel that you are good with where you are in life and with what you have. As individuals we tend to want more and are never satisfied. He feels that when we reach the point of being content and feeling that it is enough we will have peace and feel secure in ourselves.

Lastly, the Body, he suggests we "Take a Walk." He finds that walking is cleansing. We tend to think when we walk, and some of the greatest thinkers came up with their greatest insights and ideas when they went for a stroll. Men like Martin Luther King Jr., Ernest Hemingway and Ulysses S. Grant all walked to think; they experienced clarity when they walked. Ryan suggests that when we walk we do so in a "repetitive, ritualized motion"; we walk for exercise and often meditate during, which brings a stillness within.

Ryan Holiday offers many more ideas to achieve stillness which are a good guide if you are looking to find peace in your life. You will find this book in the philosophy section in of our library. 

every car to pass smog check inspections. In some states, any aftermarket catalytic converter can be used for any engine in case of a replacement, but in states with high driving populations like California and New York, the converter must match the executive order number or engine family of the car. If a replaced catalytic converter does not match or is not on a list of acceptable aftermarket options, the car will not pass a smog test, filed under "emissions tamper."

This means, for some cars like the Prius, the converter must be replaced by the manufacturer in the absence of an aftermarket option. Dyckman cites an example of Hondas from 2005-2007, from which converters were being stolen faster than the manufacturer could replace them, so California had to grant an extension on cars that were on a waiting list for their new part.

El Segundo holds events like the recent "Etch and Catch," where residents can get their catalytic converters engraved for free. This can also be done any time, free of cost, at Dyckman's shop. As she explains, if someone is pulled over and found to have a catalytic converter in their trunk, there is currently no way for police to track if it belongs to the driver or not. However, if the converter has a VIN number or other identification tag etched into it, the police can more easily track the part.

For a price, shields, and cages can also

be placed over converters to make it more difficult to steal. According to Dyckman, it takes about sixty seconds to steal a catalytic converter, and more and more thefts are happening in broad daylight. Because of this, it's also important to know what catalytic converter theft looks like, so it can be caught more easily by neighbors and witnesses.

"What you're probably going to see is one or a few people, and they're usually going to be in an unmarked car with no license plate," she explains. She also says to watch out for sounds of a saw cutting metal, as typically portable saws are used to get the part out quickly. Often, she says, the process is tag teamed, with one member jacking up the car or waiting in the getaway car while the other works underneath the car to get the stolen part. Knowing what to look for, listen for, and report, neighbors, can help each other stop a crime in progress.

Manufacturers have recognized the black market boom of rhodium and palladium from their parts and have begun to attach catalytic converters to the engine, making it nearly impossible to steal without taking the entire car apart. However, with over two million automobiles currently registered in LA County, the risk remains high. If you want to get your converter etched, reach out to ESPD for more resources, or visit Dyckman's shop in Redondo Beach to get a free engraving. •





His stay in St. Louis was rewarding, Booth said. He sharpened his musical chops, attended school, and developed myriad entertainmentoriented side-hustles, including polishing his skills as an accomplished and contest-winning rapper, but he realized that he needed to move West to further his chosen career. On the way to Los Angeles, Booth, who said he arrived in California with a tad bit more than \$20 in his wallet, stopped off in Boulder, Colorado, and played some street music for the locals. Called "busking," which is defined as the "activity of playing music on the street or other public places for voluntary donations." Music for money. Or as the band, Dire Straits sang oh so many years ago, "Money for nothing, chicks for free."

His Boulder busking success added some greenbacks to his wallet and lifted his spirits. "The universe," he said, "got me to California and gave me the confidence to build my career."

Alas, breaking into the ultra-competitive music scene in the Los Angeles environs does not happen overnight, at least not for most performers. Booth said that he spent nights couch surfing with acquaintances, sleeping on a floor in Glendale, and calling it an evening as he positioned himself in his car to end the evening. But Booth did score a gig as a personal assistant to actor Val Kilmer, who had vacated his Bel Air residence for a month-or-so, and Booth was asked to house-sit, probably not having to sleep on the couch floor or in one of Kilmer's cars.

Booth had a family friend who lived in Redondo Beach, so Booth said he moved there, living down by the Pacific Ocean. He was plying his musical trade, working local Farmer's Markets, including El Segundo's Thursday gathering on Main Street. "I was grinding to make it," he said, "working six days a week, five hours a day" in search of tips from passers-by who enjoyed his musical talents.

But busking can only take one so far in life. Booth said he came to the sad conclusion that he might have to get the dreaded "real job" to pay the bills. As we all know, living in the South Bay is not cheap. So, Booth found a job in the hospitality industry, but while he was still in the training stage with his employer, he had an epiphany. "I was so miserable," he related. He went to his boss and thanked him for the opportunity but said, "music is what I need to do as my profession." Not all that supportive of Booth's performing aspirations, Booth said his dismissive boss said that what Booth wanted to do was "not a profession, that is a hobby." Booth said a quick adios to his short-term manager and set out to prove that maybe his narrow-minded boss had misjudged

Booth's talents.

Booth returned to busking and related activities. But how could he make his artistic endeavors pay his bills and more? He said that he found a website, Thumbtack.com, that "completely revolutionized my independent music booking service." Thumbtack's website claims that "When you need to hire someone – a landscaper, a DJ, anyone – Thumbtack finds them for free."

It worked for Booth, and it was a gamechanger. Soon he was fielding requests to perform at children's parties, singing, strumming the guitar, DJ'ing. In 2017, he started working with Erin Fagerlind, the founder and owner of El Segundo business "happy baby." What started as a one-day-a-week appearance blossomed into a four-day-a-week opportunity, allowing Booth to network with "happy baby" parents and offer his entertainment talents for off-site birthday gatherings.

But like most endeavors, the devastating COVID-19 pandemic put the kibosh on most of Booth's bookings starting in March of 2020. Booth said that his business dropped off dramatically with people masked up and cloistering at home with their families. His wife, Charlotte, suggested that Booth take a car ride to clear his mind. A long ride. Back to his hometown of Portland. Booth heeded his wife's sage advice, and while motoring north to Portland, began working on the book that he had always wanted to pursue.

Booth developed a 500-page autobiography, which is currently in the "edit" stage. And he is also again utilizing his pen-and-paper talents, co-authoring another book with former NBC and Golf Channel anchor and reporter Lisa Cornwell.

He has also cut 14 albums, including "Tot Rock," a compilation of Booth original compositions and classic children's favorite tunes that he perfected while performing at "happy baby." He likens his style of working with his young pupils as a mash-up of "Mr. Rogers meets Bob Dylan."

When he is not performing, Booth, who lives in Redondo Beach with his wife and 11-year-old son Max, likes to recreate by playing golf and volunteering his time as a Little League coach.

Megan Close Zavala has seen the magic that Booth weaves when he is entertaining and educating local youngsters "Mr. Tucker (as we know him) is obviously a talented musician," she said, "but his energy and sense of humor always shine through when he is performing with the kids in his classes. He treats them more like little people, as opposed to babies, and always makes sure everybody is having a fun time. We were lucky enough to have him play at our daughter's 2nd birthday party, and everyone loved it!"

Here is what "happy baby" owner Fagerlind said about Booth's talents: "Tucker's passion for music + love for sharing that with youth is palpable. My son was just four months old when he was introduced to Tucker's music classes — which we coined "Tot Rock with Mr. Tucker" for his happy baby classes and he was instantly captivated," she emailed. "He has been drawn to the guitar + would mirror Tucker's performance since before he could walk. Tucker has a gift for instilling an early appreciation for music in young children, while also keeping the attention of adults, through his playful, interactive classes that combine classic rock renditions with popular children's songs, too."

El Segundo Child Care owner Stephany Rassweiler said that Booth has performed for her charges for 3 ½ years. She said that Booth's entertainment allows the children to "dance and be themselves, and develop skills like balance and spatial awareness while socializing with the other kids." Added Rassweiler: "He has chemistry (with) the kids to make them feel comfortable in his presence. He adjusts to the kids; not the kids adjusting to him."

Tucker is grateful for the opportunities afforded to him in the South Bay and our city of El Segundo. "I never wanted to 'work' to begin with," he said. "And that is why it is great that I am in the profession that I am. We are always playing, playing music all the time. The kids should (always) feel like they are playing when they have a lesson. The only person who should feel like they are working is me because I get paid!"

Paid to create lifetime memories for his young students every day. •
