# **Marine Mammal Care Center Rescues Sea Lion**

It's a frigid and overcast day on King Harbor in Redondo Beach. The harbor is rife with excessive motorboats, tall sail boats, and the occasional marine mammal may grace the docks. The sea lions can be heard from hundreds of yards away- often howling to other animals or aimlessly at the sky.

The Redondo fire department aids the Marine Mammal Care Center to patrol the harbor, checking out common marine mammal spots like a barge full of 50-100 California Sea Lions, buoys out at sea, and the rocks where the tide breaks.

From the boat, Julian 'Jules' Léon, the marine mammal rescuer, can see an emaciated, almost year-old California sea lion pup laid out on the dock. The pup's ribs and hip bones are visible, and he is swarmed by flies, circling his face and landing on his small body. Jules wears a long sleeve shirt, a vest and pants tucked into his squeaky XTRATUF rainboots. He has several pairs of gloves but opts for the light blue Kevlar pair that are bite proof. He brought two net sizes and grabs the smaller one. Jules tiptoes slowly behind the pup, then tosses the net over his head. The sea lion squeals momentarily but doesn't fight back, another sign of exhaustion and malnourishment. Jules successfully gets the little guy into the net and twists it at the base, so the pup can't jump out. Jules takes the small mammal in the net and hoists him onto the boat, where he nervously releases an awfully pungent excrement.

Once the pup is in the sea lion-sized crate, it is time to take him back to the Marine Mammal Care Center for evaluation. This time of year, the center is nearly at capacity.

Each day at MMCC starts with cleaning the pens for the animals. Staff and volunteers alike take on this task- hosing down the fishy-smelling concrete and pools. There are currently over 100 patients at the center, 90% of which are just a few months to a year old. The adult animals are often taken in after fishing line entanglements or various injuries. The mammals are fed and rehabilitated until they are well enough to be released back into the ocean.

"We try to keep the wild animals wild.

Jules notices a tag on the left flipper, indicating that the pup is male. "He looks like a nearling," which is a term that Jules coined meaning not quite a yearling (a yearold), but close.

The goal is to get all of these animals back into their ocean home," Jules says. While he is speaking, elephant seals can be heard wailing in the distance. Their unique screams, which sound almost human or ape-like, have been used to create fantastical characters like those in Lord of the Rings.

Occasionally, there might be an animal that cannot go back to the wild. So, they'll go to aquariums or reserves. There was a harbor seal named Elmer who had cataracts. Some animals can do okay in the wild with cataracts, because their whiskers can sense and detect their environments, but Elmer had cataracts in both eyes, rendering him nearly blind. He now lives in a facility in San Diego with other harbor seals and gets to live the rest of his life as an advocate for his species.

For the healthy animals, they're often released at Cabrillo Beach or at White Point, which are the closest spots to the center. The animals know the ocean well enough to get back to where they belong and can travel up to 70 miles per day. MMCC will sporadically and witness, often in honor of a donor or group of donors.

Education is an integral part of MMCC's mission. The visitor center is filled with animal skulls and pelts as well as helpful infographics that were designed by Jules himself. School groups visit the center to learn about animal rehabilitation and ocean conservation.

Many of the calls the center receives are from concerned locals who've stumbled upon a seal or sea lion that is on land. Many people are unaware that because seals and sea lions are semiaquatic, they don't need to always be in the water and will often rest on the beach to warm up. Anyone who comes across a beached mammal should not approach it. Not only is touching a seal on land a federal offense that can accrue up to a \$10,000 fine, but a bite from one of these animals could result in what is colloquially known as 'seal finger' in which the wound becomes inflamed with pus. #### **Update from Ed!**

In her update, El Segundo Education Foundation Chair Christa Caban shared that the foundation has recently completed its \$1.8 million donation to the district and has begun working on fundraising for its next \$2 million donation. As a result of the increased donation goal, they are asking families to consider contributing \$800 per child. The goal of the donation is to keep the class size reduction for 4th and 5th grade students, as well as 6th-12th grade math. More information about Ed! is available at www.esedf.org

#### **Additional Board Actions**

The board approved a master contract with The HELP Group, a CDE certified non-public school. The HELP Group provides special education placement in a non-public school setting as required by students' individualized education plans.

The board approved the Proposition 28 Annual Report.

# **Catching Up on the Diamond**

With summer in full swing, it's time to visit the diamond and check on how the all-star teams and the Legion team did. In addition to the all-star teams, a few other players were recognized for their outstanding high school seasons and played in an all-star game.

There's nothing like attending an all-star Little League game, whether you're watching the 11-12-year-olds, the 11-year-olds, or the 9-to-10s. The atmosphere in the stands, as parents lean on each pitch, play, or call, is priceless. Teams on the field are dressed in new uniforms that reflect a colorful image.

Each team's goal is to reach the pinnacle for their age group. For the 11-12s, it's a trip to Williamsport to play in the World Series, while the other two age groups can play for a state title. Teams at each level participate in the District, Section, and state tournaments while the 11-12-year-olds continue their all-star play at the Western Regional, with the winner advancing to the Little League World Series. When an all-star team wins one of those tournaments, the team wins a banner depicting the tournament they have won. ESLL came away with five banners in 2023.

#### **El Segundo Little League Advances One Team to Section Tournament**

The ESLL, which has won forty-three banners over the years, sent two of the three teams to the District 36 finals. Only the 9-10s will advance to the Section tournament after coming through the loser's bracket and defeating Palos Verdes twice.

The 11-12s played host to the District 36 tournament and faced Redondo Little League

in the opening round and came away with a 6-0 win. Brando Diaz hit a two-run home run, and Griffin Goshi had two RBI singles to pace the offense. In the win over Manhattan Beach Little League in the second round, El Segundo came up with a five-run third inning to essentially put the game away. Mason Metcalf and Jude Hansen had two RBIs each, while Mikey Pennel had an RBI single.

ESLL faced Palos Verdes in the finals of the winner's bracket and trailed 5-4 before PVLL put together a late-inning rally that See Sports, page 6

# <u>Film Review</u>

## Horror Film Longlegs is a Living Nightmare

You know the feeling of walking into a spiderweb? The invisible strings that stick to your body immediately cause you to tense up and leave you feeling unsettled. This is the same sensation I had when watching writer/director Osgood Perkins's eerie horror film Longlegs. It's a film that is easy to get wrapped up in, offering little solace from the absolute mayhem that descends into chaos on screen. Backed by an unforgettable performance by Nicolas Cage, Longlegs is now playing in theaters.

Maika Monroe plays Lee Harker, a young FBI agent who has just been assigned the case of the century. It's one that has been unsolved for decades: the Satanic Longlegs murders. Lee may be new to this position but her instincts rival that of a seasoned professional. Assigned to investigate the ongoing serial killer case along with her is veteran Agent Carter (Blair Underwood). His protectiveness and trust only encourage Lee to double down on her unique investigative methods.

In every Longlegs crime scene, a note is left, written in an abstract code that the FBI has been attempting and failing to crack. Lee notices there is a bizarre lack of additional evidence that should be left behind, including fingerprints, DNA, and entry and exit points. There is no physical evidence at all. Using this as a launching point, Lee pivots her search less toward the predictable and more toward the surreal. This is when she starts to sense the presence of the killer, who is both everywhere and nowhere. Like the aforementioned spiderweb, she becomes entangled in Longlegs'

web which leads to a disturbing realization that changes the trajectory of the case.

The less you know about *Longlegs* before going into it, the better. What sets this film apart from other horror films are the subconscious ways Osgood Perkins injects suspense into every scene. The frenetic score incorporates minor string notes in conjunction with more organic sounds, like mic feedback and heartbeat pulses. The diegetic sounds crafted by the sound design team include eerie footsteps and environmental cues. Combined, they expertly build intensity throughout the film. The untraditional way in which the film was shot leans toward more arthouse horror. Jumping between aspect ratios and unconventional framing feels fresh and gives Longlegs a memorable visual aesthetic.

Now, a movie is only as good as the lead performances. In the case of Longlegs, Maika Monroe and Nicolas Cage sensationally embody the characters to make the film truly haunting. Maika's cool and calm demeanor offers a perfect juxtaposition to Nic's unhinged and unrecognizable character. Not one to shy away from a challenging or weird role, Nicolas Cage reaches a new achievement in his career as Longlegs. It is exaggerated and creepy all at once. Don't be surprised if Longlegs appears in your nightmares following the film, it's practically unavoidable.

Drawing inspiration from some of the greatest thrillers of modern times like Silence of the Lambs and Zodiac, Longlegs offers audiences a fresh perspective on the genre. NEON's marketing campaign-while impressive-may slightly oversell the scare factor and overhypes the film in general but Longlegs is still a solid movie worth watching in theaters over a VOD experience. Whether or not it has the legs to be named the scariest film of the year has yet to be seen. •

How to Keep House While Drowning: a gentle approach to cleaning and organizing by KC Davis



This slim volume is packed with compassionate, practical advice for busy adults drowning in to-do lists and guilt of what they "should" do. Davis is a licensed professional therapist and draws from her personal and professional experience for this book and the mental health platform Struggle Care.

gently reframing thoughts about work and our relationship to it. Davis also includes helpful advice about equity not equal in communicating and relationships such as partners focusing on each getting the rest they need instead of attempting to equally divide up work. One of my favorite quotes of the book that describes this shift is "this isn't a business deal where you need to protect your interests against an adversary; it's a partnership where you care about the well-being of each other. This goal is less like the bar graph comparing work and more like a line graph where both work together to ensure rest and enjoyment of life remains fair even as seasons change."





# **Braised Artichokes**

• How to Trim & Quarter Artichokes: Cut artichokes brown quickly, so have a fresh lemon half on hand to rub on freshly cut surfaces and squeeze the remaining lemon into a bowl of water. Snap off the dark green outer leaves, leaving the pale greenish-yellow inner leaves only. Cut off the top 1/3 of the artichoke. Cut off all but 1-inch of the stem and cut off the tough outer layer from the stem and anything remaining from the outer leaves. Cut the artichoke into quarters, and remove the prickly leaves and fuzzy choke. Place the artichoke quarters into the lemon water until ready to cook.

away from wildlife as they could contract and spread zoonotic diseases.

Jules has been a rescuer at MMCC for 3 years, but he has been in the field of marine biology for 14 years- studying marine behavior at University of Hawaii and going on to work at aquariums, to study salmon in Alaska, tag hammerhead sharks, and become a dive instructor. He has always loved marine life, but he recalls becoming fascinated after his grandmother gave him sea critter beanie babies. He also loved to watch shows like Crocodile Hunter and hopes to one day create his own show- a sketch comedy about marine life that is both entertaining and educational. Jules has never met a pun he didn't like. A Post-it note on his desktop computer reads 'SEAS the day' and his motto is 'keep it real like a seal.' He's even designed t-shirts and merch emblazoned with this saying. Jules runs an Instagram account called 'Jules of the Sea' where he posts his creations. He brings a magnetic positivity to his job, which he admits is his true passion.

Last year, there was an overwhelming number of animals at the center. Pens were built in the parking lot to accommodate all the animals in need. Education was temporarily shut down to have all-hands-on-deck for the overflow of mammals. During this time, the center went through roughly 1000 pounds of pacific herring a day to feed the mammals.

The surrounding community aids the Marine Mammal Care Center in many ways- through volunteer work, and through donations small and large. Volunteers can donate their talents-like education instruction, photography, animal care and cleaning of pens and dishes. Funding helps the center continue to protect wildlife along the southern California coast

and hopefully the center will be able to grow their facility. Along with volunteering and donations, there is an "Adopt a Pup" program where enthusiastic supporters can symbolically adopt a mammal at the center.

Research is another important aspect of the Marine Mammal Care Center's mission. Although the center is not primarily in charge of removing deceased animals from where they are found, they will occasionally bring in a body to conduct research. Recently, there was a strange phenomenon of stillborn sea lion pups in the breeding colonies of Channel Islands. Researchers have considered possible diseases that could be affecting the sea lions, or domoic acid poisoning, which can cause seizures, lesions in the brain, and can give animals cancer. Domoic acid is a naturally occurring toxin produced by certain types of algae, but high amounts of the acid can be attributed to climate change and human impact. MMCC works to understand these occurrences to prevent them in the future.

As we head back to the center with the sickly pup, we're approached by multiple locals who are fascinated by the rescue work and want to know what creature is in the back of the truck. People are fascinated by these large beings who flop and wobble and wail.

The pup we rescued is doing well, he had a few lesions and was quite emaciated, but after a few days at the center he is eating well, gaining weight and his immune system is improving with the help of medication. The center was kind enough to allow me to name the pup, since I witnessed his rescue. Honored by this, I named him Pat, after my dad. I hope to see him galumphing on the beach and flapping his fins in the ocean someday soon. •
