






# Check It Out

# Birnam Wood by Eleanor Catton

Written by the Booker Prize winning novelist of The Luminaries and screenwriter for the recent movie iteration of Austen's Emma, Eleanor Catton has produced another winner in Birnam Wood. Catton was raised in New Zealand and has based this novel on the country's South Island. She knows the political, social, and economic terrain of New Zealand and uses it to great effect here.

Birnam Wood is a guerilla gardening collective that plants gardens along roadways and on abandoned or unused plots of land, sometimes legal, sometimes not. Mira is a trained horticulturist and an arrogant, insecure renegade. Her best friend Shelley has tired of Mira's condescension and the unremitting cloud of financial insecurity, moral outrage and legal threat that hangs over the co-op. Birnam Wood is on the edge of collapse, as is the relationship between Mira and Shelley. Shelley wants out but knows the collective would not withstand her loss. Her feelings of resentment, guilt, and frustration have narrowed to focus on Mira.

A recent earthquake on undeveloped land has provided an unprecedented opportunity for Birnam Wood. The road is impassible and has walled off hundreds of acres of land, perfect for establishing a large, self-sustaining garden. By the time the infrastructure is repaired, Birnam Wood will have proven themselves as an environmental and ecological success, producing enough output to keep them solvent. Banking on the assumption that no one will notice, Birnam Wood moves in and begins their clandestine operation.

When Mira stumbles onto a private jet, she meets Robert Lemoine, an enigmatic American billionaire. Lemoine claims to be building an underground bunker on the land both he and Mira are trespassing upon. Mira wonders why are there armed guards and surveillance drones? Why all the secrecy? As they explore the inexplicable attraction between polar opposites, Mira realizes she is no match for the powerful, narcissistic Lemoine. Both Mira and Lemoine are skilled at keeping secrets and they will do whatever it takes to protect their interests, despite the devastation left in their wake.

# The Deepest Breath Tells a Bittersweet Story of Two Sea-Bound Soulmates

Every decision we make on this earth, whether on land or sea, is left to some degree of chance. Even with years of experience, we can never truly predict with full certainty the outcome of a situation. Yet in some ways, this unpredictability is part of the beauty of life.

Happenstance is what brought Alessia Zecchini and Stephen Keenan together, and fate is why their story is so painstakingly tragic. To bring this story to life, director Laura McGann takes audiences on an emotionally-stirring and reflective journey throughout the lives of these two sea-bound soulmates in the documentary The Deepest Breath, now streaming on Netflix.

On the surface, The Deepest Breath can be described as a tragic love story between a world-champion Italian freediver, Alessia Zecchini, and her Irish safety expert coach, Stephen Keenan. But dive a little deeper, and you'll soon discover that it's so much more than that. This film tells a poignant story about pushing the limits of the human body – mentally and physically – and the vulnerability that it takes to surrender everything in the name of love.

From the very first frame, audiences are submerged into the little-known world of freediving. Don't be surprised if you catch yourself attempting to hold your breath simultaneously with the divers on screen, as I subconsciously did. My pathetic 45 seconds compared to their nearly four minutes is laughable, and really puts into perspective why freediving is highly considered by many athletes to be the most dangerous sport in the world.

Alessia Zecchini meets this challenge head-on as she competes for the title of world champion freediver. Her dedication to the sport is admirable, if not foolish at times. Throughout the film, we witness her compete in different exotic tropical locations, whose beauty is often overshadowed by the deadly activity happening underneath the water. Plunging hundreds of feet downward with a single breath leads to occasional blackouts, where bodies are pulled to the surface by expert divers and given lifesaving treatments like CPR. Given the circumstances, there is no doubt that the bond between a diver and their safety expert is a precious one. Alessia and Stephen prove this ten times over throughout the film and their intimate moments are such a privilege to witness.

The crux of *The Deepest Breath* takes place in the moments between an inhale and an exhale. A mere matter of seconds can feel like a lifetime when one is submerged hundreds of feet in the ocean. Director Laura McGann has complete control of the emotional power of the story, which is complemented by the beautifully layered score by Nainita Desai. Produced by John Battsek of Ventureland, in association with A24, Motive Films, and RAW, The Deepest Breath is a full-bodied viewing experience and an incredible homage to those who are willing to risk it all for their dream. •



# **Summer Baseball Continues at State Level**

El Segundo has long been a hotbed for successful baseball teams. The high school team has won seven CIF championships, including the 1971 team that was crowned the mythical national champions. The American Legion team has been to the World Series, played in two Western Regional Tournaments, and has advanced to the state tournament 14 times. The Little League program has won nearly forty banners for winning a District, Sectional, or State tournament. And the Babe Ruth League program has won five World Series titles to its credit.

This year the El Segundo American Legion Blues advanced to the American Legion Baseball State Championship tournament. The games, once played at the Veteran's Home in Yountville, are now being hosted at Division 1 collegiate baseball stadiums that are adjacent to Veteran's facilities i.e. Veteran retirement homes or hospitals. The past two seasons were in Fresno, and this season and next will be hosted at UCLA's Jackie Robinson Stadium. The eight teams competing from around the state include teams from El Segundo, Long Beach, Antioch, Clovis, San Diego, Santee, Yuba City, and Petaluma. Returning from the 2022 state tournament included El Segundo,

East Bay (Antioch), Clovis, San Diego Hoover, and Petaluma, the defending state champion.

El Segundo faced East Bay (Antioch) in the opening round and won 11-4. Trailing 2-0 in the second inning El Segundo sent 13 batters to the plate and scored eight runs on five hits, three hit batters. The inning was highlighted by a 400-foot two-run homerun by Anthony Temesvary.

With the score 8-2 in the third inning, El Segundo took advantage of some wildness to score three runs on just two hits but took advantage of three walks and a hit batter to take an 11-2 lead. East Bay would score single runs in the fourth and fifth innings to make it 11-4.

Dylan Alcala went the distance for El Segundo, giving up four runs (three earned), six hits, and struck out seven. On offense, Ethan Ayler was 2-for-3 and scored twice, while Hudson Comer had one hit, was hit by a pitch twice, and scored two runs.

In the second round, the Blues faced West Hills (Santee) and came from behind to win 7-5. It was a game that saw West Hills look impressive but didn't intimidate El Segundo. West Hills scored three first-inning runs on one hit but took advantage of two walks and

two hit batters. Blues starter, Jake Collins, looked shaky to start, but after the first inning, jitters settled down. Blues pitching coach Ricky Clark thought his young pitcher may have been intimidated by the setting (pitching at Jackie Robinson Stadium) at first and said, "Once he settled in, he did everything we asked of him."

El Segundo responded with a first-inning run when Kyle Whalen was hit by a pitch and later scored on a ground ball by Anthony Temesvary to cut their deficit to 3-1. In the second inning, Ethan Ayler worked a ten-pitch walk and scored on a triple by Reed Abrams. The Blues tied the game in the third inning Mateo Heredia tripled and scored on Ayler's RBI single.

Trailing 4-3 in the fifth inning, the Blues came up with four runs. They were gifted three walks in the inning, two of which scored, and one three-base error that allowed a run. Abrams' RBI single gave the Blues a 5-4 lead, and Kyle Whalen's two-run single gave the Blues a 7-4 lead. West Hills' seventh-inning rally was cut short, with the Blues giving up one run on two hits and the walk that led off the inning.

The Blues faced the Petaluma Leghorns, the other undefeated team in the tournament. The Leghorns are the four-time defending state champions. They thrive on their hitting and play solid defense with an emphasis on strong pitching. But apparently, El Segundo didn't get that memo and put together a 12-10 win.

After a scoreless first inning, the Blues put together their most offensive productive inning this summer by scoring nine runs. They sent 13 batters to the plate and had eight base hits, including RBI doubles by Mays Borgmeyer and Anthony Temesvary. Hudson Comer had a double to lead off the inning and then had an RBI single to make

it 7-0 later on in the inning.
