

Pickleball Still Hot in El Segundo

On a Saturday morning at El Segundo's Rec Park, you'll see troves of people wearing athletic gear with their racquets slung around their shoulders. People of all ages, too-teenagers, senior citizens, young adults. Initially, you may think tennis is their game of choice, but you're wrong. It's a much more inclusive game that, frankly, doesn't take as much skill. All you need is a paddle and a positive attitude, and as soon as you arrive at the courts, you're ready to play pickleball.

Before COVID-19, Pickleball was a game relegated to retirement homes. It's essentially the same as ping pong, but played on a tennis-size court with four people. It would be normal to see a foursome play this next to a shuffleboard court in Florida, but once the pandemic hit, pickleball emerged as a great way to get outdoors and remain socially distant.

"The biggest evolution in pickleball has been the shift from the older communities to the younger communities," says Brandon Mackie, Co-founder of Pickleheads. "Back in the day, it was big in the retirement communities, but now it's for everyone. The pandemic helped grow the movement, and that forced the age group down even lower. In fact, 18-34 is the fastest growing age group for the sport, twice the rate of 55+."

Pickleheads is a national organization dedicated to the sport of pickleball and creating a network for players to tap into. Its online database of pickleball courts allows anyone to find a court in their area and even post games on the site to invite other players to

join their community. "Let's say you're in Michigan for the week and want to get out on some courts. You can visit Pickleheads. com to do that!"

According to research from Pickleheads, El Segundo is a hotspot for pickleball players in Southern California. "The biggest draw that El Segundo has is the presence of dedicated pickleball courts. In all of LA, there are only a handful of dedicated courts for players, and some of the best are Rec Park."

Mackie explains that temporary courts are no fun. They require extra supplies and take over spaces other people want for different sports. "El Segundo has the only dedicated courts in a huge radius—it is a privileged area to have fun and play. I think that's among the biggest driver alongside its small-town feel."

It's no surprise that El Segundo has emerged as the unofficial pickleball capital of California.

It's a game that's best played outdoors, but the two magical components of pickleball are its ease of play and camaraderie.

"I think what makes it a community sport is that anyone can learn, and anyone can win games," says Mackie. "There's no other sport in the world where 50-100 people come out and are so open to play with total strangers. You can come alone, and within minutes you're meeting ten people who become your friends. It becomes a big part of your social construct."

Making friends is easy, and playing the game is even easier. According to Mackie. "There are two players on each side of the net. To start the game, one player serves the ball cross-court to put it in play, and you just volley back and forth until someone hits it out, misses, or hits the net. You can only

What is being proposed? Franklin Avenue (Site). The draft IRAW describes the environmental investigation conducted at the Site, evaluates removal action alternatives, and proposes a removal action to address soil impacted with contaminants such as petroleum hydrocarbons, benzene, and metals. The IRAW objective is to eliminate/minimize potential risk to human health and the environment and presents the following:

Results of the soil and soil vapor investigations at the Site;

Conceptual site model (CSM) for the Site;

 Evaluation of alternatives and identification of a final recommendation for a removal action at the Site that is protective of human health and the environment; and

El Segundo Battles in Little League West Region

The El Segundo community has a rich baseball history. Eight players from El Segundo have played at the Major League Baseball level, and more than fifty others have signed to play professionally. What these players have in common is each of them played Little League baseball, other than George Myatt who was a youngster before Little League started.

This year's El Segundo Little League all-star team has won the District 36, Section 4, and Southern California tournaments to advance to the West Regional for the first time in the own when Brody Brooks and Louis Lappe each singled to start off the inning. Lucas Keldorf's RBI single scored Brooks to tie the game at 1-1. El Segundo had problems solving Bollinger Canyon starter Jay Murai. The hard-throwing right-hander, at one point, struck out six consecutive batters.

In the fourth inning, Bollinger Canyon scored two runs on no hits but took advantage of a couple of hit batters and two walks. In the bottom of the fourth inning and trailing 3-1, El Segundo combined three consecutive singles to start their half of the fourth inning. Lennon

league's history. The winner of the West Region tournament advances to the 2023 Little League World Series.

El Segundo players participated in the Opening Ceremonies of the four-team tournament. Other teams represented were Hilo, Hawaii; Canyon View, Arizona, and Bollinger Canyon, representing Northern California. The games were played at Al Houghton Stadium in San Bernardino. It takes three wins to win the tournament. El Segundo opened up the tournament with a 4-3 win over Bollinger Canyon and then delivered a 6-0 win over Hilo to advance to Friday's winner take all championship game.

El Segundo 4 Bollinger Canyon 3

El Segundo's successful summer continued with their assault on a historic run. They took advantage of a key error that led to three unearned runs and then held on for a 4-3 win over the Northern California champion, Bollinger Canyon (San Ramon).

In the first game, Bollinger Canyon opened their half of the first inning with a solo home run hit by Brandon Manivong off El Segundo starter Ollie Parks. After Jay Murai's single, Parks induced a ground ball to end the inning. El Segundo countered with a run of their Salazar, Brody Brooks, and Louis Lappe each singled to load the bases. The next two batters, Jaxon Kalish and Lucas Keldorf, struck out. With two outs, Max Baker followed with a sharp ground ball he hit to sure-handed shortstop Brandon Manivong. He muffed the ground ball allowing Salazar to score and make it 3-2. Crew O'Connor then followed with a two-run single, and El Segundo took a 4-3 advantage.

Jaxon Kalish replaced Parks on the mound and was dealing by closing out the fourth and fifth innings. The sixth inning belonged to Louis Lappe, who struck out the first two batters he faced. Then Mikey Wong sent a long fly ball to right field, which would've been out at most Little League ballparks, but was caught on the warning track by Lennon Salazar to end the game and give El Segundo the win.

El Segundo played brilliant defense behind starter Ollie Parks who gave up three runs on three hits. Second baseman Colby Lee took away two would-be singles with his diving plays. Brody Brooks, at shortstop, was in the middle of a key double-play and made a miraculous tag of Ghazi Hussain attempting to take second base on a wild pitch.



Set Sail for Pancakes by Tim Kleyn



Talk To Me is the Year's Best Horror Film


A24's latest horror film Talk To Me is a litmus test of physical restraint. How long can you go without clenching your fists, squirming in your seat, or covering your eyes is determined by your tolerance for intense gore, and-to be frank-sheer insanity. Supernatural forces conjure chaos in Australian filmmakers Danny and Michael Philippou's directorial debut, making for a whiplash of thrills that will no doubt delight any masochistic horror fan.

Written by Danny Philippou and Bill Hinzman (and based on a concept by an additional ten people), Talk To Me tells a story of a group of high schoolers who get caught up in conjuring spirits. The film also comments on the natural coming-of-age tendencies to experiment with boundaries and the enticing element of danger.

A couple of years after the unexpected death of her mother, Mia (Sophie Wilde) is beginning to have some semblance of a normal life again. Growing accustomed to not having her mom by her side, Mia finds comfort and stability with her best friend's family, Jade (Alexandra Jensen), her younger brother Riley (Joe Bird), and their mother Sue (Miranda Otto).

One night, Mia and Jade invite a small group over to their house to try out a bizarre ritual that has been sweeping social media. Lighting a candle, holding the hand of an embalmed paranormal body part, and whispering the words "Talk to me, I'll let you in," is all it takes for demonic spirits to cross over from

the other side and inhabit the body of the victim. Or, that's what the group of friends are led to believe. A time limit of about 90 seconds is discussed beforehand - anything longer than that and the spirits could take over your body forever. Of course, things don't go as planned during the group's night of conjuring as they accidentally unleash





The Philippou brothers push maximalist extremes in every direction. From the scratchy



These Little Leaguers Playing on the Big Stage

It's August 2, 2021, and the El Segundo Little League 10-year-old All-Stars have just defeated Sherman Oaks Little League 2-1 to win their first Little League state championship at any age level. Oh, the El Segundo Little League has played in state tournaments before, but this was the first championship. Fast forward to the present, and El Segundo is playing Sherman Oaks for the 2023 Southern California Little League 11-12-year-old State championship. The tournament winner advances to the Little League Western Regional and the last stop before advancing to the World Series played in Williamsport, Pennsylvania.

Ten of the 14 members on that 2021 10-year-old state championship team return to this year's team. This same group of players played for a state title last summer, placing third. So for the third time in as many years, this team and their coaching staff have competed for a state title.

For three consecutive summers, our community, filled with baseball history, has followed these players and their accomplishments at the All-Star level. I have been fortunate to have been on their three-year ride, covering them at each stop along the way and reporting on their successes. Let's take a peek at the team that has taken us on this thrilling ride that isn't over yet.

With all good teams, it takes a good coaching staff to make it successful. For three seasons, the coaching staff has molded a group of players into a team set on one common goal. Manager Danny Boehle, who is related to the Lennon sisters of the popular Lawrence Welk show, has a deep knowledge of baseball and is well respected amongst his peers. He picked up his knowledge in

high school and played for and coached with Benny Lefebvre at St Bernards high school. His athleticism led him to play on the AVP pro volleyball circuit in the early 90s. His managing skills may have come from owning the popular Fonz's restaurant in Manhattan Beach. Danny is married to his biggest supporter and best friend, Nikki.

Tim Abrams is a twenty-year El Segundo resident but grew up in Manhattan Beach. Tim's baseball talents at Mira Costa led him to play at the colligate level at Azusa Pacific. He coaches third base on the all-star team, works with the infielders, and hitting pre-game. Tim and his wife, Sondra, have a son Reed who plays baseball at ESHS, and two daughters, Addylynn and Riley.

Ed Lee is a long-time resident who has coached at the Little League level for 15 years. He helped coach his sons Alex, Ben, and Colby through their Little League careers. Ed oversees the pitching staff and is a source of composure when adversity arises. His wife Sam and he are enormous baseball enthusiasts and big Angels fans.

#1 Max Baker: Centerfielder, SS, Pitcher (nickname Chef Baker)

Max hits fifth in the lineup, hitting .456 with two home runs and three doubles. His play in the outfield starts with his speed in the gaps running down fly balls. His arm strength is another tool that sets him apart from other outfielders. His favorite food is fried chicken, and he takes pride in saying he is a state champion. Max's favorite team is the Red Sox, and his favorite player is all-star outfielder Masataka Yoshida.

#3 Lennon Salazar: Outfielder (nickname Tootie)

Lennon is a speedy athlete who has a magic touch when asked to bunt for a sacrifice

or hit. He says his favorite song is 'Viva La Vida' by Cold Play, and when he's not practicing or playing baseball, you can find him surfing. After a day of playing baseball or at the beach, you can find him refueling on his favorite sandwich; a hamburger. He is a San Francisco Giants fan, and his favorite player was All-Star catcher Buster Posey.

#5 Colby Lee: Second base (nickname Colbs)

Colby is a slick-fielding second baseman on defense. On offense, his bat control to bunt runners over is impressive. Colby would have AC/DC's 'Thunder Struck' as his walk-up song, and his favorite meal includes a great steak. Colby is a big Angels fan because Mike Trout is his favorite player to follow and watch.

#9 Brody Brooks: Shortstop, Pitcher (nickname Brodz)

team doing phenomenal things with the bat or the glove, but he said, "This team understands that "we" is greater than 'I." He said the team understands the next-man-up mentality and believes they are part of a special family.

El Segundo 6 Hilo, Hawaii 0

The Little League World Series has been dominated by a team representing Hawaii for two of the last three years. So when El Segundo faced Hilo in the winner's bracket semi-final, with the winner advancing to the West Region championship game, the locals were not mesmerized by their opponent's success; instead, they scored six runs on nine hits and won 6-0.

In the first inning, El Segundo loaded the bases when Brody Brooks walked, followed by singles by Louis Lappe and Jaxon Kalish. A run-scoring walk to Max Baker gave his team a 1-0. With Declan McRoberts on the mound, the crafty right-hander struck out four in the first two innings. In the third inning, El Segundo opened up the scoring with a four-run inning.

Brooks walked, and Lappe doubled to center field. Jaxon Kalish was intentionally walked to load the bases. Lucas Keldorf RBI singled to score Brooks. Max Baker and Crew O'Connor followed with consecutive RBI singles to make it 4-0, and Quinn Boehle had an RBI ground ball to give El Segundo a 5-0 advantage. In the fourth inning, El Segundo took advantage of a couple of errors to score another run. Lennon Salazar singled and later scored on an infield error to make it 6-0 and close out the scoring.

Hilo never really put together a rally. They could only muster up three hits and advanced runners to third base twice against El Segundo's dominating pitching.

With the win, El Segundo finds itself just one win away from playing in the Little League World Series. This team, which has virtually been together for three consecutive all-star seasons, will be spoken of in terms of legendary. If not already known, the players on this team will become community household names. To put it into perspective on how challenging it is to advance to the Little League World Series. According to Little League International, there are some 6500 leagues throughout the United States and in more than 80 countries. To whittle it down to ten teams representing the United States and ten from foreign countries to meet at

the World Series takes a lot of luck, dedication, and the right chemistry of talent to compete for a true World Series title.

Manager Danny Boehle kept his ecstatic composure in check after the win. "We knew Hawaii was a grinder and not to be overlooked. But I felt we had the game under control with our pitching, and then having the big third inning really helped." He says the game Friday night can't come soon enough, but with the days off, he is sending the team home to have some quality time with their families. "We're a family here, but they need to be with their families at home, so they'll be away until Wednesday to get a breather." He says he's confident the time away won't be a distraction but will be an asset so when they return; they can refocus on what is at stake.

The game between Hilo and Bollinger Canyon, in the loser's bracket finale, should go Bollinger Canyon's way. If that happens, the pitching matchup in the West Region final could match two of the top 12-year-old pitchers in the nation against each other. Both Louis Lappe of El Segundo and Bollinger Canyon's Brandon Manivong throw in the low to mid-70s or equivalent to an MLB 95-mile-per-hour fastball. Hitters will be challenged for a reaction

pitch and determine if it is a strike and swing or take the pitch. If that match-up comes to fruition, look for a low-scoring game.

The championship game is slated for Friday at 6 p.m. at Al Houghton Stadium, 6707 Little League Drive, San Bernardino. If you can't

El Segundo Little League has been a staple of the community for almost 70 years, and all of the volunteers, which speaks to the passion and heart of this league. We're so proud of the 12U All-Stars advancing to the Championship Game of the West Region Tournament. We'll all be cheering them on this Friday!"

One win away, and then it's on to Williamsport, Pennsylvania, and the Little League World Series. •

However, Korean food today has largely become recognized as Korean BBQ, and Rice Cups embraces the shift to provide customers with a contemporary spin on the phenomenon.

It's important to know that these meals are meant to be eaten on the go. Each order is thoughtfully packed into a compact cup, offering layers of delicious rice alongside salad, lotus root chips, goji berries, and macaroni salad. For your main protein, you can choose either beef, chicken, or pork dishes, and each one offers a different flavor with easy sauces and glazes. For example, the Beef Bulgogi is a tender, thinly-sliced marinated beef with a sweet

Think of it like Mexican Elote—the Korean Style Hot Dog is usually made on the street by various food vendors in popular shopping districts of Seoul and other cities. These hot dogs resemble the American Corn Dog; however, rather than a soft breading, the outside is fried in a crispy panko batter, rolled in sugar, and then glazed with a variety of sweet and savory sauces. Inside the breading, customers can choose from a traditional hotdog, a cheese dog (filled with a gooey, cheesy inside), or a combination of the two (half hotdog and half cheese). In South Korea, all are popular choices, but

the cheese dog is a true representation of delicious Korean street food, and Rice Cups does a tremendous job of capturing that essence. They even offer a Potato Hot Dog, which comes fried with crispy potato bits on the outside.

There aren't too many to-go options in town that deliver an experience like Rice Cups. Bowls are conveniently packed for easy storage on the move, and collectively, each meal provides well-balanced portions of leafy greens, proteins, and carbohydrates—a great way to fuel up and have the energy to burn for the long summer nights.

Local El Segundo resident Alex Roberts, who routinely bikes around Grand Ave with his son Reagan, shares that when "cruising the neighborhood," he and Reagan "love to pick up a street dog and eat it on [our] way back home." They stop and watch the sunset at Rec Park, enjoy the crispy, melted cheese as it stretches from each bite, and they always laugh as they finish up and ride their bikes back home.

"It's a fun routine for us," says Roberts.

"And bringing new businesses and new cultures into the fold is something I love to do with my family. It makes El Segundo fun to explore."•
