Meet Aly Mancini, the City's New Recreation, Parks, and Library Director

Did you ever watch the TV sitcom entitled Parks and Recreation? It debuted in 2009 and lasted for seven years, racking up 125 episodes. It took place in a fictional town in Indiana and starred actor Amy Poehler as a woman spearheading a fledgling Parks and Recreation department in an all-American town.

In the real world, Aly Mancini has been selected to lead the El Segundo version of Parks and Recreation. Mancini began her new gig on June 27, officially bestowed with the job title of Recreation, Parks, and Library Director.

Mancini said she had peered in on "a

profit like the YMCA. She had quite the role model in pursuing a recreation career; her mother, Stacia, had served the City of El Segundo as the Recreation and Parks Director, retiring in 2006.

Mancini took a job as the recreation supervisor in the Northern California town of San Leandro, which she called her "first foray into municipal recreation, and I loved it." But there was a downside ... " I did not like living in the Bay area."

Mancini was fond of the San Diego area, so she took a position as a recreation supervisor with the City of Carlsbad. This small, beachy community is "very similar to El Segundo,"

couple of episodes" of the NBC sitcom. "The show put a comical spin on what we do in Parks and Recreation," she said, a job that entails "constantly negotiating the needs and interests of the community, while also managing the reality of available resources."

Mancini grew up in Long Beach, then journeyed to San Diego to start her college career. That career began at San Diego State, but she "did not do well there" and ended up attending a satellite offshoot of Chapman University, achieving a Bachelor of Arts degree in Organizational Leadership.

She took a full-time gig with the City of San Diego, working as a program director for the East County Family YMCA. At that point, Mancini said, she realized that working in the recreation field "was my passion" and knew that, if she was to be serious about her passion, she also needed to get serious about her schooling, ergo the time spent at Chapman University.

Mancini focused on municipal recreation opportunities instead of working for a non-

Citizen-led Cannabis Initiative is Pulled From November 2022 Ballot

At its first regularly scheduled meeting since its annual summer break, the El Segundo City Council on Tuesday night covered the financial situation of the Park Vista senior housing complex; a new joint use agreement with the El Segundo Unified School District for public recreation facilities, and media studio and equipment; adopting universal standards for its Committees, Commissions, and Boards (CCBs), and how to handle a new state law (Assembly Bill 1276) regarding single-use food ware and condiments offered by food providers in the city.

Council also listened to City Attorney Mark Hensley weigh in on whether City Council could withdraw its three cannabisrelated ordinances from the November ballot. The conversation arose because the original citizen-led cannabis initiative submitted to the council for placement on the November ballot was withdrawn by its sole proponent in a letter received by the city clerk on Thursday, August 9. That initiative launched many conversations by the council on how the city should respond. That response ultimately is the three ballot initiatives approved by the council. Sandra Spiker asked to have the initiative withdrawn since she no longer lives in El Segundo. Once the city clerk received the letter, said Hensley, it was See City Council, page 11





2002 Babe Ruth World Series Champions Remembered

There are a plethora of reunions held each year, including class reunions, college reunions, military branch reunions, and family reunions among others. They are all very special gatherings, but it seems athletic teams getting together for a reunion is, in a way, more unique. When the 2002 El Segundo Babe Ruth 13-15 All-Star team held a reunion to commemorate their World Series championship, it was a special moment.

The El Segundo Babe Ruth League's All-Star resume is dotted with historical significance. The league has won five World Series titles and been to the World Series seven times. The league has been to the Pacific Southwest Regional tournament, a precursor to the World the players was off the charts," said Haaker.

The fifteen players included Sean Begley, Ryan Burke, Matt Cano, Tom Cook, John DeCarlo, Jered Drascovich, Chris Escalante, Nick Giovati, Tyson Hawley, Sean McNally, Austin Meick, Jeff Nisen, Pat Rooney, Ryan Wixom and Luis Zetino.

Larry Robinson, the manager and who has been a coach or manager on four World Series teams, said, "These guys were doing incredible things that can't be taught." He added, "They were intense competitors, they trusted the coaches and each other, and they were a very unselfish team."

During El Segundo's World Series title run, they went 14-0 that included four wins in the state tournament hosted at home, four wins at

Series, 12 times, including hosting the 1967, 1996, 2001, 2004, 2008, and 2012 tournaments. In 2021 El Segundo was represented at the 13-year-old, 14-year-old, and 13-15-year-old Pacific Southwest Tournaments.

Between 2001-2004 the league may have had some of the best four years of all-star success in any four-year period during its 64 years as a Babe Ruth League. In '01, the team lost in the Pacific Southwest finals with three fourteens and one thirteen-year-old on the team. In '02, they were World Series champions. In '03, they fell in the Pacific Southwest finals, and in 2004 took second at the World Series.

The 2002 team was a team filled with 15 talented players who would have started on any all-star team in the nation. Assistant coach Charlie Haaker, who has been a part of three World Series teams, said, "We had some high expectations of the team. Many of the all-stars were on the ESHS freshman team that year that went 23-4, and the overall baseball IQ of the Pacific Southwest Regional in Fresno, and six wins at the World Series in Connersville, Indiana. According to assistant coach Bob Motta, who has been a coach or manager on three World Series teams, thought their most challenging games were at the state tournament. "The games against Torrance were our most competitive."

El Segundo dominated La Crescenta 17-3, shutout El Centro 9-0 and got by Torrance 3-2 in the winner's bracket final and 2-1 in the final. In the first game against Torrance, the two teams were tied 2-2 in the seventh inning. Matt Cano led off the bottom of the seventh inning with a walk. Ryan Burke's sacrifice bunt allowed Cano to reach second base. With two outs, Jeff Nisen's ground ball to the first baseman went through his legs, and Cano came around to score the game-winner to give El Segundo a 3-2 win. In the State tournament final, Torrance took a 1-0 lead







service," he explained. Samaan also started an Instagram account for the store, which he continues to update occasionally with new drinks, product sales, and delivery options. Village Liquor also delivers on Grubhub, Drizzly, and Ubereats, to name a few, which he claims has helped revenue sales.

But his crowning achievement to date is the relationships he forms with customers, new and old. "They're like family to me," he explained, "Customers walk in and leave with a smile on their faces. That really matters to me, making everyone happy."

After working at Village Liquor for over six years, Samaan understands that the process of building and maintaining connections with his customers does not happen overnight. "At first, I didn't get to know the customers that much," he said. However, once he began having conversations with the people who came into the store, those conversations turned Beach, and they were ready to sell," he said. Samaan purchased the property in 2020, towards the beginning of the pandemic. And while that was a difficult time for businesses of all kinds, Samaan said that his Redondo Beach location is doing well, similar to his business in El Segundo.

He credits much of his success not only to the customers, but also to his dad, who has been with him since the beginning. "At first, when I was working, I couldn't handle everything by myself, and my dad helped through it all," he explained. Especially when business was struggling, and Samaan was trying to figure out how to get into a groove with the business; his dad was there to support him. "Even today, he still helps me. Of course, without him, I wouldn't be here. I'm very proud of him," he reflected.

And while Samaan continues to achieve

Stunning Eco-Thriller *The Territory* **Shows A Devastating Global Reality**

Where to watch: 'The Territory' opens in select theaters Friday, August 19th.

Director Alex Pritz is a name you should familiarize yourself with because his film, *The Territory*, is one that you'll be hearing about throughout the year (it is, hands down, the strongest entry I saw at this year's Sundance Film Festival). Equal parts heart-wrenching and poignant, *The Territory* uncovers the horrible reality and unjust hardships faced by the indigenous Uru-eu-wau-wau tribe as they fight to save their livelihood deep within the territory divide, other men brazenly encroach into Uru-eu-wau-wau territory, setting fire to the wildlife without care or concern.

Co-produced by the Uru-eu-wau-wau community (and Darren Aronofsky, among others), *The Territory* is a masterful output from all involved. Staying true to Alex Pritz's participatory filmmaking model, he literally gives cameras to members in the tribe to document their experience on the frontlines, which he edits into his own footage. It's this unique, otherwise unattainable, point of view that gives the film its power, never

The level of access that Pritz has within the tribe is paramount to telling their story. The bond of trust between the Western film crew and indigenous people is deeply felt, as evidenced by how emotionally invested we become throughout the film.

When we first meet the Uru-eu-wau-wau community, they are desperate for help. The recent public support of land-grabbing by rightwing politician President Jair Bolsonaro puts their land, their homes, and their livelihood at risk of complete collapse. Deforestation at the hands of non-Native Brazilians, who equally feel as if they have a right to claim the land for their own endeavors, is proving to have environmentally and politically devastating results.

Helping represent the Uru-eu-wau-wau community in their fight for protection is environmental activist Neidinha. Her strength is unwavering, even when faced with death threats targeted at her and her daughter. Neidinha acts as a team of one serving one once feeling exploitive or overdramatized.

The most powerful weapon here is the camera. Both Pritz and the Uru-eu-wau-wau community agree that the government's failure to intervene early on has caused irrevocable damage, and it is up to them to get their story told. The media attention from this story has already started to create a buzz in their native Brazil–as seen in the film–but the struggle is far from over.

The Territory, which was acquired by National Geographic during the festival, is an urgent call to action and the least we can do to raise awareness about this ongoing, deadly conflict is to talk about it, recommend it, and watch it. The future of the Uru-euwau-wau community, and the natural world, depends on it.

Are You at Risk for Bladder Cancer?

(BPT) - As you get older, your body and health change, but this doesn't mean every change you experience is a normal part of aging. Consider your visits to the bathroom, for example. If you or a loved one is over the age of 70 and has been experiencing changes in urination, it might be time to speak with your doctor.

Changes in urination may include1:

- More frequent need to urinate
- Pain or burning during urination

• Feeling as if you need to go right away, even when your bladder isn't full

• Having trouble urinating or having a weak urine stream

• Having to get up to urinate many times during the night

Blood in urine

While many of these symptoms may be signs of common, treatable conditions such as urinary tract infections (UTIs), bladder stones, an overactive bladder, or, in men, an enlarged prostate, they may also be signs of bladder cancer, according to the American Cancer Society.1

It is an important time to consider proper urological health and associated risk factors. If you or a loved one are experiencing any of these symptoms, you should see your doctor.

"Bladder cancer becomes more common as we age," said Dr. Sandip Prasad, a urologist in community practice with Atlantic Medical Group and the Morristown Medical Center, New Jersey. "Due to its prevalence, it's important for older Americans to be vigilant about any changes in their urinary health and behaviors, as it may help to detect - and, more importantly, treat - bladder cancer in living with NMIBC face a future of recurrence and additional surgeries.4

While there is a low risk of mortality, chronically relapsing NMIBC remains a problem.5 There are currently no drugs approved by the U.S. Food and Drug Administration for primary treatment of NMIBC.

Transurethral resection of bladder tumor (TURBT) is the standard first-line treatment option for NMIBC patients. TURBT is a surgical procedure to remove the bladder tumor through the urethra, the thin tube that carries urine from the bladder.

Recent scientific evidence shows that repeated TURBTs may lead to significant post-operative comorbidities (development of other health conditions) and even an increased risk of mortality. Patients who undergo repeated procedures may be facing serious health and other burdens that can impact various aspects of their life.6

There is a growing need for nonsurgical and minimally invasive approaches to treatment. While TURBT is the standard treatment used by medical experts for NMIBC, urologists believe TURBT may pose burdens and risks that include:

• Susceptible patient population: People in their 70s and 80s tend to live with multiple health concerns or conditions.7 Repeated, invasive surgeries impose greater overall health risk, both during procedures and postprocedure recovery.

• Access: Getting to and from outpatient facilities may be challenging for older patients who may not drive or have access to alternative transportation options.8

Convenience and safety: Lengthy hospital



its early stages."

While anyone can develop bladder cancer, some factors increase the risk. These include smoking, exposure to certain carcinogenic chemicals, having a family history of the disease, chronic bladder problems and urinary tract infections, previous chemotherapy, certain diabetes medications and age.2 Research has found that bladder cancer most often occurs in those aged 75-84 and is three times more likely to occur in males than females.3 Of the estimated 80,000 new cases of bladder cancer diagnosed each year, 70-75% are diagnosed as NMIBC.3 Those stays during recovery pose risks, not only due to the patient's increased susceptibilities post-procedure, but also because crowded hospitals can increase the spread of infectious diseases.9

For a variety of reasons, a minimally invasive outpatient procedure could be another treatment option for those living with NMIBC. There is an investigational, nonsurgical treatment approach for low-grade intermediate-risk NMIBC currently in Phase 3 clinical development.





in the second inning on a solo home run. El Segundo was scoreless through the first five innings when Cano drew a walk and scored on an RBI single by Nisen in the sixth inning. In the bottom of the seventh, Tyson Hawley singled and later scored the decisive run on an RBI single by Cano for the 2-1 win. The win sent El Segundo to their second consecutive Pacific Southwest tournament.

The Pacific Southwest tournament in Fresno was an eye-opener for the team since the players would stay with Host Families. With a quirk in the scheduling, El Segundo received a bye before facing Arizona in their first game. In named to the all-tournament team, while Tom Cook was named Most Inspirational and Austin Meick was named the MVP. With El Segundo's win, they advanced to the World Series in Connersville, Indiana.

The team packed their bags for the league's first trip to a World Series in six years. According to Coach Motta it was a long day getting to their destination at Connersville, Indiana. "Our flight was canceled, so we ended up taking an alternate flight that delayed us getting into the Indianapolis airport before 9:30 p.m. Then we boarded a really nice bus for the hour and a half drive to Connersville."

stay for El Segundo. "We were treated like celebrities, and the players were very respectful and treated their celebrity status with class, signing autographs and answering reporter's questions," said Motta. "Everywhere we went, they went out of their way to treat us special. I remember being with Kathy (his wife) at a grocery store, stocking up on things for the hotel room. We were about fifth in line when someone in the front of the line said, 'we don't want you to wait; please go ahead of us .'It was that way the entire week," Motta said.

In the opener, El Segundo crushed Mifflin County 18-0. The Pennsylvania team had no rainy weather. When the game resumed the next morning, El Segundo went on to score a 6-1 victory, propelling them into the World Series final against Beaverton, Oregon.

The final was a classic between two of the nation's top 13-15-year-old teams. Beaverton's bats came alive in the first inning with a threerun inning. El Segundo countered by sending 14 batters to the plate with a 10-run second inning that was highlighted by home runs by Sean McNally and Luis Zetino. Trailing 10-3, Beaverton got going again, scoring five runs on six hits, and trailed 10-8. In the fourth inning, El Segundo put together a three-run

extreme heat, El Segundo surrendered a 4-1 lead in the sixth inning by giving up three runs. El Segundo answered with a six-run bottom of the sixth highlighted by Jered Drascovich's two-run single, and El Segundo went on to win 10-4.

El Segundo shutout the host team Bullard 10-0 in the second game and moved into the winner's bracket final against Atascadero. El Segundo fell behind 4-1 early but didn't panic. Ryan Burke came in relief and shut down Atascadero's offense. With the game tied at 4-4 in the sixth inning, El Segundo scored five runs to take a 9-4 lead into the seventh inning. Atascadero would make the game tight and score four runs before Luis Zetino got the last two outs.

Atascadero eliminated the defending World Series champions from Hawaii to reach the final against El Segundo. During the 2001 Pacific Southwest Regional, Hawaii defeated El Segundo to advance to the World Series, but there would be no rematch. In the second game against Atascadero, the game went El Segundo's way, and it started early by scoring three first-inning runs on their way to a 6-3 win. Austin Meick, the only 14-year-old on the team, started and gave up three runs on three hits, walked three, and struck out ten, including the last three outs, all looking.



According to Motta, the bus was pulled over outside of Connersville by the State Police. "One of the troopers boarded the bus and asked, 'Is this the team from El Segundo, California?' Motta says he was surprised but informed the trooper it was. The trooper smiled and said they were there to give the bus a police escort into Connersville.

Motta said that when the bus entered Connersville and drove down their downtown main street, they were met and greeted with sidewalks filled with cheering people who had come out to welcome each of the teams. El Segundo was the final team rolling in after 11 p.m. "It was a special moment for all of us and just the start to an incredible week."

The Opening Ceremony was an epic event with Hall of Fame manager George Lee 'Sparky' Anderson making a speech that left the players on the field and the 6000 fans in the stands in awe. One of the highlights of the World Series is attending the team banquet. The host team will have a retired Major League player as a guest speaker who will speak to the players on a variety of things related to his past. The 1969 National League Rookie of the Year, Ted Sizemore, was the featured speaker, and he addressed the players, coaches, family, and fans at the banquet.

It was a tremendous way to start the weeklong

chance. El Segundo came out swinging and scored 11 runs in the third inning, including an eight-run rally with two outs. In the second game, El Segundo got clutch three three-run home runs to defeat Millard West (Nebraska) 10-0; Austin Meick, Jeff Nisen, and Tyson Hawley each hit three-run home runs.

In the third game of pool play, Arkansas took a 5-4 lead after four innings. El Segundo rallied six runs in the fifth inning to take a 10-5 lead. Ryan Burke came in relief and threw three scoreless innings on the way to a 14-5 El Segundo win.

The final pool play game against the host team, Connersville drew 6500 people. Prior to the game, it was an opportunity to pay tribute to the 9-11 Memorial, which was built with a waterfall in the outfield. Connersville had built a monument to memorialize the 9-11 event that occurred the year before. Daniel Rodriquez, the singing New York police officer famous for singing the national anthem, gave an emotional rendition that left players and fans in tears. El Segundo started Chris Escalante, and he shutdown the host team by throwing a one-hitter in El Segundo's 17-1 win. Escalante helped his cause by going 3-for-3.

El Segundo faced Tallahassee, Florida, in the semi-final round. After leading 2-1 through four innings, the game was suspended due to rally highlighted by Matt Cano's homerun to give El Segundo a 14-9 lead.

In the fifth inning, Sean Begley doubled and ended up scoring on an error to make it 15-9. In the sixth inning, McNally drew a walk, and Nisen hit his third home run of the World Series to extend the lead to 17-10. Beaverton's seventh-inning rally was cut short. They scored one run on two hits, but Zetino struck out two, and El Segundo won their fourth Babe Ruth 13-15 World Series title.

For the World Series, as a team, El Segundo hit .455, had 17 doubles, hit ten home runs, and dominated the All World Series Teams. Honored were Austin Meick, Luis Zetino, Jeff Nisen, Nick Giovati, Tyson Hawley, and Ryan Burke; Sean McNally was named Most Outstanding Player.

At the reunion, ten of the fifteen members attended. Two had passed away, two had prior commitments, and one was nursing a sick baby. Each of them in attendance had a special memory, but all of them said it was the best summer they've ever had. Austin Meick said, "It was an awesome time. With all the distractions, the team stayed focused, and the coaches made sure of that."

Jeff Nisen summed it up succinctly, "It was a once-in-a-lifetime experience. We were a close-knit team that refused to lose." •





While in Signal Hill, Mancini worked on several high-profile projects, including the city's first Dog Park, Community Garden,

City Council

and the new Signal Hill Public Library. "I am passionate about working to build communities where residents can come together to create and make memories," she said. "I look forward to working with the City of El Segundo to bring innovative programs and events to the community."

Mancini recently moved to Redondo Beach. Like most of us who have had the pleasure of relocating one's life, she loved the experience. "It was terrible," she laughingly said.

Tina Hansen, the vice-mayor of Signal Hill, had this to say about Mancini: "I have been a member of the Signal Hill City Council since 1994. Aly has always impressed me with her passion for her chosen profession. She believes in the slogan "Parks Make Life Better," Hansen emailed, "and she is always trying to find ways to improve community services. She can organize large communitystyle events that feel personal and unique. She and I worked side by side planning and creating a vision for a new library which is really a showpiece in our city and area. "She is someone I call a servant leader - not afraid to get into the trenches and work alongside her staff. She is always excited to grow her skills and continues to learn. During the worst of the pandemic, she found ways to keep

services available and created new programs like Gus the Ghost, which was a hunt for homes and businesses with a Gus poster. As a colleague, I consider Aly, a friend, and I am excited to see what she does in El Segundo."

While Hansen has known Mancini for 15 years, El Segundo Fire Chief Deena Lee met Mancini less than two months ago but is duly impressed by her talents and experience. "I met Aly when she started in El Segundo on June 27," Lee emailed. "We have gone to lunch to get to know each other. We share a lot of the same passions. We love engaging with the community and providing activities that empower young people and women. I shared with Aly the video from the "Fired Up" Girls Empowerment Camp that we held in March. She said that it brought tears to her eyes. We are looking forward to many collaborations between Fire and Recreation, Parks, and Library.

"Aly has a positive attitude, tons of experience, and a desire to bring great programs to El Segundo. She is also smart, innovative, and fiscally responsible. Aly is a great addition to our Executive Team."

Recreational pursuits, as we [hopefully] adapt to the COVID scourge, are particularly important to a city and its citizens, especially a smaller town like El Segundo, which has as its fulcrum, the acreage of Recreation Park.

Mancini said that because people were working from home, and "cooped-up" for the better parts of two years, when they grasped the opportunity to breathe the [mostly] clean air and smell the freshly cut grass, they gravitated to the terra-firma of our numerous local parks.

One of the key projects that have greeted Mancini in her new job is completing a "needs assessment" of the parks' facilities. Mancini said that she and her team would assess how to spend recreation and parks funding. And how does that new-fangled sport of pickleball fit into the recreational mix? "We are taking a look," Mancini said, "at what do we still have a need for, and what do we have to re-evaluate?"

Mancini said she is "really looking forward" to working with new city manager George and the City Council members, who she said has been "very responsive" to the needs of her departments. •

sent to Los Angeles County. The county said they would withdraw the measure from the ballot, "but technically," said Hensley, "just to make sure that we've tied the loop on it completely, the thing before you tonight is just a resolution that clarifies the county or restates to them that this is no longer on the election ballot. It's not on discussion tonight whether to pull one of the city's measures or not. It's just a ministerial action to inform the county that the measure by the citizen

out. And sometimes, they're wrong. And I think they're wrong. You had until Friday last week to do this (in Hensley's opinion). You could have attempted it at a meeting today, but it would have been interesting whether a court thought that was OK or not, which would have been risky."

The council recognized resident Mark Bloom who, in July, was part of the USA Padel (a racquet game played on a reduced size tennis court with four surrounding walls on which players can hit the ball in addition to on the court surface) team that won a Gold Medal at the 2022 Maccabiah Games for Padel. During the presentation of a commendation, Bloom explained that his team of mostly 20-year-olds (he is 40) "all brought the thunder... It was an epic trip," he said. The Games were held in Israel, which meant Bloom, a former Hebrew school student, got to travel to Israel for the first time. Padel is played in 78 countries (the U.S. only has 40-50 courts nationwide, said Bloom). The Maccabiah Games are the third largest international event in the world, following the Olympics and FIFA World Cup. In 2022, some 10,000 athletes participated in a variety of sports and games. During the "Public Comment" portion of the meeting, El Segundo Unified School District Superintendent Melissa Moore told the council she supported the proposed new amended 10year joint use agreements, saying the school district and city have a "longstanding tradition of joint use agreements, stemming back to 1990." She noted that discussions for the proposed new agreements with amendments began in March with then-interim City Manager Darrell George. School Board President Tracey Miller-Zarneke spoke about the amount of time school district staff had spent on the new proposal and two other subjects. Resident Ryan Baldino was the lone speaker who addressed the cannabis initiatives, noting, "I'm here to talk about the special meeting agenda item of possibly pulling the citizen ballot initiative. relationship (with ESUSD), why would we do ten years?" and that he didn't want to handcuff future city councils nor did he want to "rubber stamp" the proposed agreement without more detailed information. City Manager Darrell George asked to bring the item back to a future meeting so he could discuss their concerns with the school district and bring the item back with a deeper "analysis" and "thorough staff reports," said Giroux.

"But I do want, I think it's important to state that we can't pull ours even if we wanted to," said council member Lance Giroux. "Am I correct on that?"

"Yes, legally, there are differences of opinion about this, but even if you were to believe that you could still pull it, it would be by 5 o'clock tomorrow, so there's no time to notice a meeting by then," Hensley said. "And I don't believe, and by the way the code is written, your time expired on Friday."

Giroux noted that his understanding was that council had until 3 p.m. "yesterday" (Monday, August 15). "If you wanted to put it on the agenda, yes," said Hensley, "according to the county," noting that the county assessment that made the deadline August 15 was relying on information related to a "special election" and the November election is not a special election. "So, I think the county's put out information I don't agree with. This is not a special election. They're not a judge. They don't enforce the laws; they just put things they most likely should all be pulled."

Mayor Drew Boyles and council member Giroux wanted to better examine the new proposed amended agreements between ESUSD and the city than was presented Tuesday night. "I'd like to see what the school provides," said Boyles, saying he wanted to "understand the total financial contribution on both sides" and that the information he wanted to see was "not in the staff report." He also noted that the school district is making capital improvements that involve recreational facilities, another factor to consider in any agreement because "there's so much in play in terms of what they're going to offer the city in the future." He did not like "putting a 10-year agreement in place when so many things are in flux." Giroux said that it was "important to be as transparent as possible" and that he wanted to know the benefits of the agreement, the cost, and where the funds come from, among other financial considerations. He also said he did not see "the rationale for" a new 10-year agreement, saying, "With such a good working

situation at Park Vista senior housing complex during an agenda item entitled, "El Segundo Senior Citizens Housing Corporation Board's State of the Union Presentation on Park Vista and Associated Proposed Actions." Some of the considerations put forth were whether or not Park Vista is supposed to be self-sufficient or supported by the city; where the deficits in the complex's financial situation arise when its rent revenues exceed \$800,000 annually and expenses are about \$700,000; how capital improvement expenses such as an unexpected \$50,000 for mandatory earthquake insurance and expected items such as a plumbing study and design should be handled. Rent increases, resident turnover and a waiting list, a potential increase in the age needed to qualify for living in Park Vista, the history of Park Vista and the intent of its originators, and the current intentions and thoughts of the community and city council came up as topics. "We need to give them the tools to be a self-sustaining community," if that's the direction the city takes, said Giroux. •
