Residents Once Again Call Out Council Member’s ‘Lies’ and ‘Deception’ Regarding Water Tower Lighting for Pride Month

After taking a summer break and not holding two consecutive city council meetings, the El Segundo City Council returned last Tuesday night to its regular schedule of council meetings and heard requests from residents for council member Carol Pirsztuk to apologize for what these residents called “lies,” “a deliberate act of deception,” and “an elected official lying to constituents.” One resident also questioned “the silence from the rest of the council” about the claims that were brought to the council’s attention during the Public Comment portion of the July 2 meeting. Council member Pirsztuk did not attend the July 2 meeting.

Tuesday night, the council also heard, during Public Comment, from three representatives of a construction company that took issue with how a contractor was selected for a job with the city as well as from a 35+-year resident of McCarthy Court who told council she has seen a “series of pretty bad actions” on the street, including hit-and-run accidents that destroyed a neighbor’s vehicle. She asked the council to take action by perhaps installing speed bumps, signage, and more lighting. She also told them catalytic converters had been stolen from vehicles in the area.

Other city business addressed Tuesday night included updates from the Library and Recreation and Parks commissions, wage and classification changes to some part-time and full-time engineering and recreation and

parks positions, the new Enterprise Resource Planning System city staff is recommending, and implementation of Measure C sales tax. Longtime El Segundo Planning Commission member Brenda Newman was feted for her 15 years of service on the commission.

Resident Anya Goldstein, who addressed the city council at its July 2 meeting, once again took to the podium to address the council during Public Comment, noting she is a 10+-year resident and member of the Sweat Equity Alliance, an El Segundo organization whose mission states: “We seek peace and justice, equality and equity, along with liberty and safety for all who live, work, study in, or visit El Segundo, CA. We know specific communities are disproportionately disadvantaged by systemic racism, sexism, elitism, ableism, homophobia, transphobia, and gender discrimination, and we seek to remedy those wrongs. We know anti-Black and Brown racism is baked into the DNA of El Segundo and continues to negatively impact the city to this day. We are committed to rooting out the problem and repairing the damage. We are demanding change, creating awareness, and building a truly united El Segundo.”

Goldstein noted that Pirsztuk “hasn’t said a peep about this (situation) since it came to light” and said that it “took an uproar on social media” and “a public records request” to bring Pirsztuk’s actions to the surface. Those actions, as described by the residents who

spoke Tuesday night, include a digital trail that they say shows how Pirsztuk reached out to Public Works Director Elias Sassoon and directed him to change the color of the lights on the city’s iconic water tower from rainbow colors celebrating June as Pride Month after receiving an email from a community member known to publicly post anti-gay and racist “vitriol,” according to at least one of the speakers Tuesday night. This change took place on June 14, in honor of Flag Day, Pirsztuk posted on a Facebook page known as the El Segundo Parents Network. Pirsztuk also noted in her posts that the red, white, and blue colors would remain on the water tower until President Joe Biden’s arrival at Los Angeles International Airport, after which the colors would return to rainbow. Resident John Pickhaver subsequently found out via a public records request that Pirsztuk had texted Sassoon on June 14 asking for the tower to become red, white, and blue and remain that way through July 5.

The city frequently places lights on the iconic water tower to observe holidays, traditions, and other notable situations. Resident Susan Bowling, the author of the original June 15 Facebook post that Pirsztuk was responding to, said, “Obviously, everybody here knows what happened. This is not about a flag anymore. It’s not about the lights on the water tower. This is about an elected official lying to her constituents...”

Film Review

Cuckoo Is A Shriek-Filled, Ear-Splitting Ride Into Bird-Themed Horror

I saw the world premiere of the new horror film *Cuckoo* at this year's South By Southwest Festival in Austin, and it's an experience that's going to stick with me for a while. It wasn't just because it was my first time at the stunningly ornate Paramount Theatre—though that was definitely a treat. No, it's mostly because the film itself was so wildly bizarre and ear-splittingly loud that it burrowed its way deep into my brain.

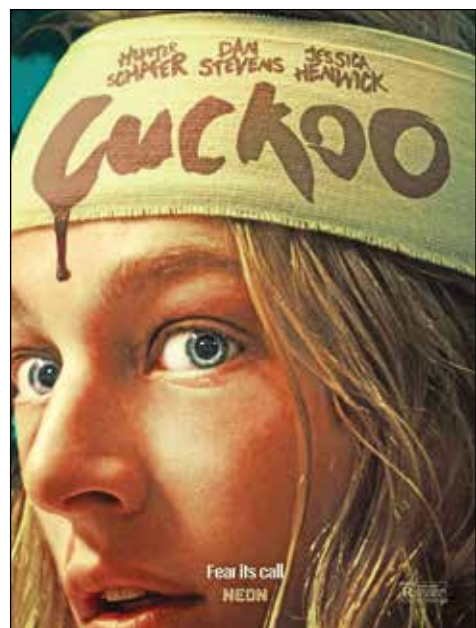
The movie features Hunter Schafer (from HBO's *Euphoria* and Yorgos Lanthimos's *Kinds of Kindness* by) as Gretchen, a seventeen-year-old girl who's dragged by her remarried dad to a remote resort in the German Alps. Things get even weirder when her dad's creepy boss, Mr. König (Dan Stevens), takes an unsettling interest in Gretchen's mute half-sister. As the strange noises at night hint at a darker truth, Gretchen starts

to uncover a menacing secret.

Cuckoo is a blast if you're in the mood for a blend of unsettling thrills with a campy, offbeat twist. It's definitely a midnight movie, leaning into its eccentricities rather than trying to be a serious horror film. During the post-screening Q&A, Dan Stevens admitted he was as baffled as the audience by the film's deranged, off-kilter nature. It's clear that Tilman Singer, the film's quirky writer and director, enjoys blurring these lines.

Hunter Schafer leads the film with impressive grit, battling the film's creepy bird antagonist right up until the end. If you're up for a midnight flick that leaves you with a mix of unease and amusement, *Cuckoo* is worth a watch. I'll definitely remember the film's piercing shrieks every time I think of it. Whether it was genuine fear or just the over-the-top sound design, I'm not sure, and honestly, I'm not going to overthink it—after all, that's probably what the film would want.

Artist Bios

Rob Bonfiglio is a Los Angeles based critically acclaimed solo artist as well as touring guitarist with the Brian Wilson Band, the Lovin' Spoonful, Peter Asher and others. Rob was a member of the band Wanderlust who made a splash in the mid 1990's with the chart-topping single "I Walked." They opened for The Who, Collective Soul, etc. and were lauded by the London Sunday Times, declaring their debut album, "Prize," "one of the greatest rock records of all time." He is also guitarist/musical director for the multi-platinum selling pop group Wilson Phillips and produced their most recent album "Dedicated." When not on the road, Rob frequently lends his sideman talents to a multitude of L.A. based artists. Rob has recorded five solo albums and his power pop sound and arrangements exemplify his professional musical abilities. A prolific songwriter, Rob's original songs have scored high profile placements in TV, commercials and film.

Paula Fong is an Americana/Folk singer/songwriter from Los Angeles who grew up harmonizing in choirs and small acapella groups. She continued to explore singing various genres from classical to Chinese opera and eventually joined an Americana church band where the main musical focus was acoustic country and folk. During that time she fell deeply in love with folk and roots music and became enamored with the classic voices and songwriting of Joni Mitchell and Patty Griffin, but was also inspired by indie folk groups like Nickel Creek and Iron and Wine. She is currently co-directing an Americana music service, singing back up vocals and touring with Abby Posner's band - Abby Posner and the Big Fall, as well as recording her first solo EP which is due for release at the end of summer, 2024.

Sean Lane is a unique blues artist originally from Louisiana, who plays solo-acoustic Delta Blues, solo-electric Hill Country Blues, and also fronts a four piece Blues-Rock band, Sean Lane & The Hellhounds. Writing original songs with an "old-time" sound is his hallmark, specializing in slide guitar and exciting rhythms. For the last 25 years he has traveled all across the U.S. performing and recording, and most recently lecturing with his newly created themed show, "A Musical History of the Blues." Sean's music is steeped in tradition but always innovative, raw and distinctive.

Johnny Cash once said this about **Evie Sands**: "She's got the stardust in her eyes, she's got silver bells in her voice and you'd think she's got electricity in her fingers the way she plays that guitar left-handed and upside down." Evie Sands is a legend in her own time. She's a multi-faceted talent who possesses a one-of-a-kind voice, enduring sampled catalog, is a tastefully succinct instrumentalist, and that rare anomaly: female arranger/producer in a male-centric industry. Evie's renowned song-craft, like her signature vocals, benefit from a rare blend of keen intelligence and genuine emotion with lyrics

The calendar says it's nearing the end of August. What it doesn't mention is that during the summer heat, the fall sport of football is just beginning. The El Segundo Eagles' high school football schedule begins tomorrow. The Eagles have a new head coach, a new offense, and a new attitude defense.

Head coach Rory Schoonmaker is highly optimistic about his team and says they should be fun to watch. The Eagles have a wealth of talent with a mix of returners and the addition of some talented sophomores up from last season's frosh/soph team. The Eagles also enter into a new revamped Ocean League that should benefit them come playoff time. So let's look at the team and preview the 2024 Eagles.

The offense looks stronger than last season, with some key returnees leading the way. 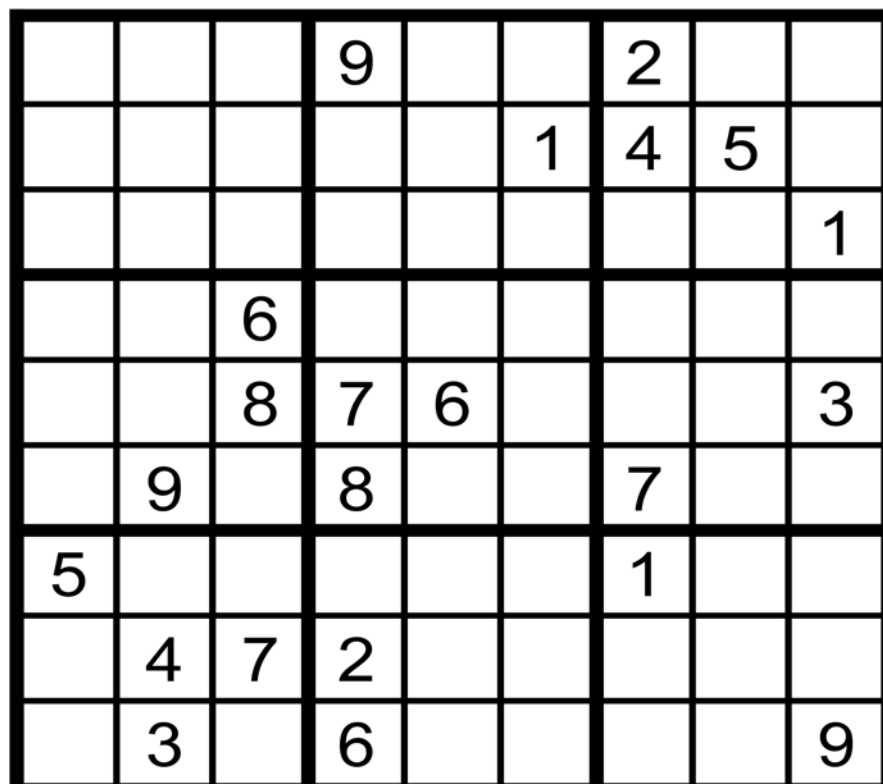

groups, according to Coach Schoonmaker. "We plan on using a good deal of rotation, but seniors Ethan Ayler and Ruben Gomez should receive a number of the team looks early on as they have developed good chemistry and rapport with Ryan and are grasping our pass concepts well."

The running game will help balance out the offense. Senior running back Cole Castillo, has been extremely impressive through the spring and summer workouts. His balance of strength, speed, and intelligence is something the offense will lean on. If there's a downside to Cole's approach, Coach Schoonmaker says it might be his over-the-top vision, which isn't a bad thing. "The only issue I have had with Cole is trying to get him to slow down!" Additionally, junior linebacker Isaiah Rodriguez has come on as of late carrying the ball and is earning more and more looks at the G-back position on offense.

Every good offense is predicated on a strong offensive line and Coach Schoonmaker has been impressed. "We have a strong core of returning starting offensive linemen. Starting with our center and anchor of our line is Preston Greaser." Coach Schoonmaker likes his intelligence and command of the line schemes. "He has helped us move through our installation process at a faster pace than anticipated." Seniors Isaac Beas and Xavier Ramos are returning starters and have grasped their leadership roles well thus far. "We will also be transitioning a former defensive line starter to the offensive line this season in junior Samiuela Vaikona, whose toughness and physicality will help give us that extra push at level 1."

The Eagles struggled defensively last season. That looks to be in the past with a change in philosophy that they will be focusing on

this season. The focus will be on keeping things in front of them and really trying to make opposing teams earn their scores. Coach Schoonmaker says, "We might not create as many negative plays as last season's group, but the goal for us will be to limit the number of big plays (+20 yards) for opposing offenses and try to keep the tide and momentum of the games in our favor."

The line play of returnees Reese Biggerstaff, Jake Danford and Jason Juarez has looked outstanding in their roles in the defensive front. Coach Schoonmaker said, "We are trying to utilize the versatility of all three to create a strong presence at the line of scrimmage." They also have other contributors in this area, but they will be leaning on those players to carry a bulk of the workload on Friday nights.

The linebackers are usually the heart and soul of the defensive unit. Isaiah Rodriguez has been doing a phenomenal job taking command of the defensive scheme. Coach Schoonmaker says, "We will be shifting him to a new interior position this season and he is taking to it well." After Rodriguez they are looking at multiple individuals who may be able to contribute at the linebacker position but have yet to settle on a starting group. It has been highly competitive in practice, and the coaching staff is seeing some very encouraging execution, particularly from the underclassman.

The secondary has been great through the short spring and summer. The change in philosophy has served this group particularly well thus far. They did have some struggles from time to time last season. In that context a lot of the success they have been having this offseason, in the new scheme, was because they were bred in fire to an extent last season. Errors they made in the

past have motivated them to improve their execution and understanding of the schemes and it has really shown in their coverage execution this summer.

Coach Schoonmaker said, "Obviously, as we have gotten into gear, we are working on their contributions more so in the running game. I have been very happy with the way they have performed and progressed against the past this summer." The primary group will be returning starters Grady Lubs, Axel Thiess, and Sean and Shane Mossman. "This is one of our deeper groups in terms of depth, and it is very competitive. There will certainly be a great deal of rotation and could potentially be a change in the line-up before week one."

Special teams look to be a strong point of the team, and they are exploring different

options. Coach Schoonmaker said, "We are having a few different players work on our kicking game, including senior starter Ethan Ayler and sophomore Chase Mattoon. Return duties will fall primarily on a rotation of our backs and receivers."

Coach Schoonmaker has surrounded himself with top-notch assistant coaches with plenty of experience. In the past the program had welcome back former players who wanted to stay close to the program. This season only Dolph Adomian (offensive line coach) and Jared McKenna (running backs coach) are former Eagles. The other assistants are Peter Sibbison - Special Teams Coordinator; Saul Sierra - Defensive Line coach; Eric Bertholf - Linebackers coach; and Brian Everitt - Wide Receivers coach.

With the Eagles transitioning into a reshuffled Ocean League they have a legitimate opportunity to win their first league title in eight years. The nonleague schedule should prepare them for a run at a league title. The Eagles open their 2024 season on the road at Sierra Vista (Baldwin Park) at 7 p.m., where they'll take on the Dons on Friday night. The Eagles return for their home opener next Friday night August 30, at 7 p.m. when they host the Peninsula Panthers. The rest of the nonleague schedule includes @ Don Lugo on Friday, September 6, home against South Torrance on September 13, and Torrance on September 20. The Ocean League schedule starts with Hawthorne on October 4 at home. Then they go on the road for two straight, including at Beverly Hills on October 10, Centennial on October 18, and at home against Morningside on October 25. The Eagles wrap up their regular season on November 1, playing on the road at West Torrance. All games are slated for a 7 p.m. kickoff. •

Nutrition Tips to Power Your Next Workout

(BPT) - With the kickoff of summer, and #GlobalRunningDay, many of us are motivated to slip into our sneakers and head outside for a run. A good run enhances strength, contributes to cardiovascular fitness, builds muscle endurance and is a great way to shed pounds. It's also a boost for your mental health. A recent study in Neuroscience News found aerobic exercise like running leads to an increase in levels of serotonin, dopamine and norepinephrine - chemicals that regulate your mood. It also helps promote better sleep, relaxes stress hormones and increases brain function.

So, take this as your sign to get out there! But, in addition to the right footwear, a killer playlist and an interesting route for your workout, it's vital to focus on nutrition. Regardless of the distance or duration of your run, sports nutrition is an important key to your performance.

Most runners know they should get some carbs, protein, and stay hydrated. But how much, and when? Before, during or after your run? Dana Ryan, Ph.D., MA, MBA, director of Sports Performance, Nutrition and Education and Chair of the Fitness Advisory Board at Herbalife, offers these tips to get moving with good nutrition.

Start with the basics. Whether you're a distance runner or a new jogger working up to your first mile, a good basic diet is the building block for great performance. Fruits, veggies, lean protein, healthy fats and good carbohydrates are a must.

Pre-workout boost. As you near your run, you want to focus on liquids. One to two hours before your workout, drink a protein shake that includes carbohydrates. Protein helps your brain and body function and gives you an energy boost, and those carbs keep you going. you want to avoid pre workout are fiber and fat as they are hard for the body to digest.

Hydrate! This is vital before, during and after your workout. Proper hydration is essential not only for general body functions, but also boosts performance and mitigates dehydration during running. Runners need to maintain body water balance, because water provides nourishment that the body needs for almost every single function. It also helps limit changes in body temperature. For hydration, water alone is great. Water with electrolytes kicks it up a notch. Herbalife24 CR7 Drive was designed to support athletes. Carb it up. For many dieters, carbs are taboo. But for runners, or people who do other high-intensity workouts, carbs are key to performance. And for those longer runs, add in some carbohydrates to be closer to a 3:1 carbohydrate-to-protein ratio. Why? Protein after a run helps your muscles repair and recover. The amino acids in protein help build lean muscle, which is exactly what you want. No matter your fitness level, nutrition is an important part of getting the most out of your workout. Now, get out there and move! •

Are You Confident in Your Investment Strategy?

(BPT) - More than 60% of Americans feel they are in a better place to achieve their goals than generations that came before them, according to Schwab's eighth annual Modern Wealth Survey, an examination of how Americans think about saving, spending, investing and wealth. Boomers lead the charge, with 66% believing they are more or as likely as older generations to reach their goals, followed by Gen X (63%), Millennials (62%) and Gen Z (60%).

One factor likely driving the positivity across generations is the rise in the number of Americans investing in the stock market. Schwab's survey data shows that almost three in five Americans (58%) are investing today. This is in line with recent Federal Reserve data, which is up from 53% in 2019 and is the highest on record.

When asked specifically why they are in better financial shape than previous generations, Schwab's survey reveals that Americans believe they now have more ways to build wealth (50%), increased accessibility to investing (46%) and additional investment options available to them (46%). Gen Z, which starts with those born in the late 1990s, notes that a top reason for their financial confidence is improved access to investing.

"There has never been a better time to be an investor, and it's encouraging to see that a majority of Americans are engaged with their personal finances and building long-term wealth, particularly younger generations who are beginning to save and invest earlier in their lives," said Jonathan Craig, Head of Investor Services at Charles Schwab. "During the pandemic, we saw an increase in the number of Americans investing, but there are a lot of factors driving this trend that were in place before that and continue to drive investment activity now. Industry changes

such as lower costs and minimums to invest and get advice, broader access to sophisticated platforms and tools, and a proliferation of investing information have all contributed to making investing more accessible than ever before. Increasing access to investing has been Schwab's core mission from day one, and it's still at the heart of everything we do today."

Schwab's survey shows nearly 70% of Americans are confident in their investment strategy and point to the availability of financial advice and knowledge (51%) and the ability to easily research companies and investments (37%) as top reasons. Gen Z, the most confident of the generations, says that learning about investing at an early age is the biggest factor for their confidence. Additionally, more than a quarter of Gen Z respondents report that they were taught about investing in school, significantly more than older generations.

Despite increased levels of investing, survey respondents admit there's more they can do, with only 18% saying they are currently on top of their finances. Nearly one-third (32%) feel they are on track to being on top of their finances and another one-third (34%) note that they need to make changes to feel more in control. One key area for improvement among Americans is financial planning. Schwab's survey finds that only 36% of Americans have a written financial plan. Among those who do, 76% say it makes them feel more in control of their finances and nearly all (96%) say they feel confident that they will reach their financial goals. And it's a lot of trouble. When you knew the day before, you had told them to light it (red, white, and blue) for the whole month."

At the July 2 city council meeting, City Manager Darrell George said, "We tried to do the best thing in the lighting of the water

tower. I think it's best to come back with a schedule (of what colors appear on the water tower when)." He reiterated Tuesday night that the staff is working on a policy. Council member Lance Giroux took the time to explain that a policy will be coming out for review at the council's September 3 meeting, adding, "My feeling in a situation like this is that I need to allow the person to defend themselves or make a decision how they want to address it." He mentioned that Pirsztuk was not at the July 2 council meeting and that the council had not held a meeting since that time.

At the end of the meeting, when council members were given the opportunity to give "reports," Giroux asked to bring back the pilot parking program in Zone 3 for some tweaking on Pine and for overnight resident parking on the "north side of the park" and mentioned that El Segundo's Rock & Brews on Main Street is holding a fundraiser this Friday, August 23 all day with 20 percent of all food and beverage going to the male bicyclist who was hit on August 4 and "is lucky to be alive," according to Giroux. •
