Wagner Deabreu: Living the El Segundo Version of the Endless Summer

It is not a coincidence that El Segundo's Wagner Deabreu makes his living teaching his charges how to surf, not only in the ocean, but on the pavement, while also imparting life lessons that can be cultivated in the water and on land.

Said Deabreu: "Surfing is above all transformative and healing; I am enjoying the benefits of devoting my whole life to it and hope to inspire others to do the same."

It was some 40-or-so years ago when he started diving into the magic of surfing, scouring surf magazines. "Within three years, I was getting tubed and punting airs when other kids started asking me how I was doing that. Most people answer that by saying, 'I don't know, I just did it,' but I dove inside my brain, [and] searched for detailed information on how I was accomplishing those moves."

As Deabreu tells it, he was "almost born in the ocean" in a Brazilian waterway. His mother was nine months pregnant, but was not content to sit around the house and wait for her water to break. So, Deabreu's parents decided to go deep-sea fishing. Which was when Deabreu's mother's water *did* break. Dad steered the boat to the nearest island, beached the boat, and found the nearest hospital where Wagner was born.

He was raised in Brazil with an older brother and younger sister. He touted [most of] his Brazilian upbringing while noting that there are definitely sketchy patches of his home country. He said his father was keenly aware of the proclivities of some of the local knuckleheads and steered Wagner into martial arts courses. "My Dad knew the roughness of the place," Deabreu said, "and wanted me to know how to defend myself."

The discipline gleaned from studying and participating in the martial arts, Deabreu said, has helped to shape his approach and philosophies that he utilizes as a surfing coach/consultant.

About growing up in a "rough" neighborhood, Deabreu said, "The first time that I got robbed, I was like eight-years-old." He also detailed having his wallet and watch heisted by hooligans when he was nine. And he related a story about how, when he was "twelve-or-thirteen," some older, disgruntled surfer took umbrage to getting sprayed by water while in the ocean and, once back on the beach, attacked Deabreu's surfboard with a sneak salvo, smashing the youngster's

board with a two-by-four.

Then there was the time Deabreu was held hostage during an armed robbery. He was twenty at the time, he remembers, working at a tech support job. Armed hombres entered Deabreu's workplace and kicked and assaulted Deabreu, using him as a shield as they attempted to ransack the business.

"That was a very traumatic experience," he said, "with the cold metal of a gun in your ear." He and his co-workers were herded into a small room as the criminals made the hostages remove their shoes, busted up anything they did not steal, and spread shards of glass on the floor, making it exceedingly

El Segundo School District Found Liable in Lawsuit

The El Segundo Unified School District was ordered to pay a million for failing to stop bullying of a student at the El Segundo Middle School. The student was 13 at the time and the school was accused of failing to supervise and protect her from bullying, torment and verbal assault.

The school has addressed the issue by adding two student safety assistant positions at the two elementary schools, implementing a safety plan, adding a phone app for students to report safety concerns and training of staff in behavioral threat assessment protocols.

El Segundo Unified School District Superintendent Dr. Melissa Moore has released the following statement in response to an August 25 judgment in a lawsuit involving the district.

"As a school district, we respect the ruling of the court and acknowledge the findings of the lawsuit. The next steps are up to our legal counsel. As we move forward, we are committed to self-improvement and doing everything we can to prevent bullying in our schools.

We have taken a number of actions to make this happen. These include adding two Student Safety Assistant positions at Center Street and Richmond Street elementary schools, the adoption of a tailored security assessment for all schools, and the implementation of a comprehensive school district safety plan.

Additionally, we have implemented a series of recommendations from a third-party comprehensive safety assessment that was conducted in 2018. These include behavioral threat assessment protocol training for staff, the use of We Tip website to anonymously report concerns related to bullying, physical safety enhancements at our middle and high schools, and two new safety staff members. As an extra layer of protection, our Gaggle alert system flags any potential bullying occurring online.

The safety and wellbeing of our students is our top priority. We will continue to take the steps necessary to ensure a safe, welcoming, and inclusive learning environment for all." •

Previewing 2022 Boys Water Polo, Girls Volleyball, Tennis and Golf

With the new school year beginning and the first football game in the books, it's time to preview some other sports. This will be the first season for a girl's golf team in the school's history. The girls' volleyball team is on everybody's radar, and the girl's tennis team looks strong. The boy's water polo team looks to defend their Pioneer League championship while going deep into the playoffs.

Girl's Golf Team Making History

For the first time in over four decades, the Eagles will field a golf team. The Eagles will have a girls' team for the first time in school history. Head coach David March is excited about the school's newest team and is looking forward to the challenge of leading a new program. He said, "I have previous high school golf coaching experience at St. Monica HS. When the job opened up, I applied." He says the leadership team believed in his vision and gave him the opportunity to build the program from the beginning.

To prepare for the season, they held a three-week free summer camp at TopGolf for all current ESHS students to help bring awareness to the upcoming golf program. The camp included range time, short game work, and simulated match sessions. At the end of the summer camp tryout was held at The Lakes.

Coach March expects the team to show up every day and work to improve individually and collectively as a group. "The league has some of the best teams and toughest courses in Southern California. Our motto is to play the course with the goal of improving each day." From what he's seen already, this summer could be a good barometer of what he expects to be a successful inaugural season. "The team has had a great attitude and enjoys being around each other, which is a good start."

The Eagles' home course will be Westchester GC, and practices are held at TopGolf and The Lakes. The team will play two matches a week, practice twice a week and have a weekly weight room session. El Segundo's league schedule includes Palos Verdes, Peninsula, North Torrance and Torrance high schools. Their home courses are Palos Verdes GC, Rolling Hills CC, Los Verdes GC and

Victoria GC.

The Eagles have 17 golfers on their roster, but experience will be their Achilles heel. With only a handful of girls who have played, it could be a challenge in their inaugural year. Incoming 9th grader Ashley Perkins will lead the Eagles. She is a multi-sport athlete that has valuable experience playing junior golf. Her ability to lead the program over the next four years could be key to the growth of golf at ESHS. Others who will be counted on could be senior Elli Vincent and junior Ashley Davis, who both have experience.

Coach March says each of the players on the roster is a multi-sport athlete, which will help their development. "They are eager to learn and improve and being athletes playing other sports, so they know how to compete."

Girls Volleyball Looks to Compete for League Title

The Eagles had a successful 2021 season in which they went 16-6 and reached the CIF Southern Section Division 4 playoffs before dropping to the Alemany Warriors, the eventual CIF champions, in five games. This season looks promising, with the returning players looking to make a statement.

Returning starters include seniors Marly Smith (last season First Team All-Pioneer League and All-CIF, committed to Villanova), Summer Breneman (who will be taking the lead in the setter position), Tala McGill (opposite/libero), and Kira Cullinan (middle blocker). The Eagles have one returning junior Lauren Neely (middle blocker, 2021 2nd team All-Pioneer League).

New players include freshman Macy Ludwig, senior Sara Allen (hitter/defensive specialist), junior Riley McAndrews (middle blocker), and sophomores Allie Stevenson and Ava Adlam both multi-sport athletes.

According to head coach Natasha Nguyen and assistant coach Jacob Richmond the team has prepared for this season with two weeks of summer practice with some light lifting and track workouts and competed in the Lakewood tournament (2-2). Coach Nguyen said, "The expectations this season are to build strong team chemistry to support our standout seniors and develop our up-and-coming underclassmen. If we can do that, we will

Does My Loved One Know They Have Dementia or Alzheimer's?

I have spent many years working with individuals affected by dementia and Alzheimer's, as well as their families. As the disease advances, often I get asked if I believe that the person with dementia knows they have a disease; and I believe that the question is asked for a couple of reasons.

It is our hope and desire to believe that our loved ones do not suffer through a disease. Though the affliction may be present, it might bring us comfort to know that they are not really aware and thus, not suffering through it. So families often ask in an attempt to find comfort.

A second reason this question is asked is to try to come to terms with the motivations of combative behavior that abounds in patients with dementia or Alzheimer's. If they don't have the understanding of the disease, they may also not realize they are often being hurtful in their responses or reactions. Believing that the new behaviors stem from the disease make us more sympathetic and understanding.

And a third is to understand their impaired judgement. A common example is the "battle for the keys" and driving. We often question their judgement by wondering 1) do they think they are still good drivers, 2) if they are aware of their "close calls" or that they can easily get disoriented, and 3) if there is selfishness and irresponsibility in disregarding the dangers of their

Early on in the disease, the person afflicted may say things like "my brain is just not right lately," or "I just don't remember things and I feel a little slow." They are clearly acknowledging a problem. When these comments stop, it is easy to wonder if they simply no longer want to indulge the subject, or if the case has advanced such to reach a level of lack of acknowledgement.

Brain trauma and cognitive disease do not reverse or get better; and the disease affects and progresses differently for different people. The cause, trauma, and/or injury will also be a factor. Cognitive decline can affect memory,

language, thought association, reason, emotions, etc. Someone may be able to bake a pan of cookies but not remember they require a walker to walk down the room.

But as the disease advances and decline progresses, there is also a possibility of entering a stage of "anosognosia," meaning "without knowledge of disease."

When anosognosia occurs there is reduced or limited ability to understand one's true condition. It can be selective or complete. As such, the person may truly not recognize the symptoms of their dementia.

How do we cope with their anosognosia?

- Anosognosia can cause the person with dementia to speak or behave in hurtful or bizarre ways. Remember that this is not the person of the past but their disease talking.

- Don't take it personally and try not to argue.

- Connect with their emotions, not their words or actions

- Validate, Defuse and Re-direct: When an argument arises, such as wanting to continue driving, *validate* that not being able to drive is difficult. *Defuse* by telling them that you will drive or that the drive is not necessary, and *re-direct* the conversation to another subject

- Keep this interaction very short since the attention span is probably short

- Don't rehash it later

So, does my loved one know they have dementia?

Maybe, maybe not. In the earlier stages, it is more likely that they understand the decline. Later, the stage they are at and/or the type of cognitive disorder may not allow them to know they have a disease. And as the disease progresses and they become less aware of their surroundings, they could further reduce their awareness of their disease.

As we care for a loved one with dementia, we hope to provide the proper care, affection, comfort, and dignity they deserve. Beyond that, it is probably best to not try to speculate too much. Instead, attempt to live and enjoy as much as you can with them in the present moment. •

Film Review

In *Breaking*, A Desperate John Boyega Holds a Bank Hostage

Based on the true story of when former U.S. war veteran Brian Brown-Easley held a bank hostage after being denied his disability pay from the VA, *Breaking* (formerly *892*) is a suspenseful thriller that also shines a poignant light on the injustices that veterans still suffer in our country today.

Directed by Abi Damaris Corbin from a script she wrote with Kwame Kwei-Armah, *Breaking* combines the best of big-screen movie-making with more emotional, human storytelling. I've seen and enjoyed Hollywood's exciting hostage standoffs before, but knowing that this story was based on a real event makes the film resonate a little differently while watching.

In the lead role, John Boyega plays the aforementioned Brian, a former U.S. Marine who now collects disability payments just to get by—which he's barely doing. He makes long walks to his low-income motel where he stays, and his only relief is talking with his daughter on the phone every night (but even that gets cut off). When a processing error from the VA denies Brian's latest disability payment, he's threatened with becoming homeless, and he's finally pushed to the brink.

The next day, Brian calmly walks into a local Wells Fargo bank in Atlanta and, after politely interacting with the bank teller, calmly informs her that he has a bomb in his backpack. Here, the story is set on its suspenseful course. But something's different about this holdup. Brian lets most of the people in the bank go right away, and calmly requests his demands: to speak to a hostage

negotiator and have his story televised by the local news outlets.

We find that Brian is a man who, although incredibly conflicted, still has a good heart. It's clear he doesn't intend to do harm to anyone, including his two hostages, Estel Valerie (Nicole Beharie) and Rosa Diaz (Selenis Leyva). He apologizes repeatedly to them for the situa-

tion he's put them in, and at one point even answers one of the bank's phone calls from someone asking questions about her 401k—who he attempts to help. When the bank offers to credit his account, he denies the offer. It needs to come from the VA, and the events that he's creating are the only way that they, and the rest of the world, will finally listen.

It's exciting to see Boyega in this role, playing a real-life character from this world, and not a galaxy far, far away. Boyega's baggy



Dear Neighborhood Therapist,

I am in my fifties and I've recently gone back to graduate school. Some of the people - definitely not everyone - in my cohort are very different from me. This is great, but there is one person who takes everything I say in the worst possible way, and I find myself feeling defensive about things that I never dreamed of. It is really uncomfortable and I am considering quitting. It would be devastating to me: I love the new career and I want to make it work, but I've begun to dread going to some of my classes because of this, and I worry that my work life afterwards may be like this as well. It's gotten to the point where I don't say anything in class anymore, even when I feel like I have something to contribute. I spoke to some of the professors, and they have assured me that I haven't done or said anything wrong, but they have been very careful not to criticize the other students. I feel like I'm going crazy. Is there something wrong with me? Should I try to stick it out?

— *Under Attack, El Segundo*

Dear Under Attack,

I'm really sorry this is happening to you. It's a terrible way to start a new chapter in life. There's good news and bad news. First the good news: even though the experience stinks, that doesn't mean it actually has any meaning other than the fact that this particular situation and combination of people isn't working for you. It's not evidence indicating you've made a bad career choice, or that there is anything at all wrong with you. And even though nobody else may have spoken up publicly about it, you're likely not alone in your reaction to them.

The bad news is that just as there are "toxic" people in the workplace, there are "toxic" people in any setting, and it seems like you have come into contact with a few of them. It doesn't matter if others think they are toxic;

the thing that matters is that you think they are. Here are a few questions to consider:

As you think about the other students you have interacted with, how have your experiences been? You don't have to like everyone in your future field or profession. You don't even have to like most people. But you probably need to like enough people so that you have colleagues you can turn to in the future.

Based on what you've seen so far, are there enough people who you feel comfortable with? Do you think that if you had been placed with a different group of people randomly that things would be better? If your answer to either of these last two questions is yes, that seems to argue in favor of sticking it out.

Some people undermine and attack in ways that cause us to lose confidence in our own abilities. Bosses and professors are often reluctant to shut them down, or they fail to notice. It's hard to interact with such a person without feeling drained, or worse. If you are able to avoid them altogether - perhaps by changing to another group or class - it will be worth the effort. If you're stuck together, the sad thing is that it may make most sense to avoid them completely, or confront them directly.

In either case, it stinks that it's happening, but I think you should stick it out based on what you've said. This toxic person will be around through your grad school, but then you have the rest of your career away from this person.

- Talk to your doctor about clinical trials

Patients who volunteer in clinical trials can access treatments unavailable elsewhere, but it's important to know as much as possible about the potential risks and benefits before deciding to participate.

Plus Therapeutics is evaluating an innovative, targeted radiotherapeutic, 186RNL, in the U.S. National Institutes of Health-supported ReSPECT-GBM Phase 1/2a clinical trial. This 186RNL drug candidate features high radiation doses delivered directly to the GBM tumor (sparing surrounding healthy tissue and cells) via a single, minimally invasive surgical procedure performed during a short hospital visit. Data collected to date from the trial have shown that 186RNL has potential to be a safe, effective and convenient treatment option for GBM patients and clinicians.



difficult for the hostages to maneuver once the looters vacated the premises.

As a parting warning, the banditos made it clear that if any of the hostages were obstinate, the robbers would circle back and shoot two folks...and one of them would be Deabreu.

"A crazy scenario," he said, ending with no hostages being hurt. So how did Deabreu get to El Segundo after being a hostage in a Brazilian armed robbery? He met a gal from California while living in Brazil, "did

Deabreu said that while he was developing his surfing talents in Costa Rica, he started thinking about becoming a surfing consultant/coach. Once he settled in El Segundo, his company "Wagsurf" was later established.

The Wagsurf method involves a studied progression: First, the student develops their chops on the ground, a process labeled "surf skate." Next is "wake surfing." The instructor pilots the boat, and the wake surfers trail behind the boat, riding the boat's wake without

Wag teaches them to respect the hugeness of the ocean and the strength of the waves and to be safe. Finn was lucky enough to go with him to Mexico for the third time this summer. Mike and Maggie also credit their interest in the business to their dog, Oreo. "He's always our inspiration, our mascot, our greeter, and our tester," Mike explained, "Sometimes I can tell people that treats are Oreo-approved, which means he likes it a lot."

But Mike has other ways of getting treats to the community. "Almost daily, you can find me out on my scooter, riding around just looking for people who are walking dogs," he said. On their daily walks, Mike and Maggie even take treats with the Wags and Whiskers business card attached. "Feed-back was pretty positive from the get-go," he reflected, "People like it."

Interestingly enough, the idea to take their business on the go was not planned; it was a last-minute decision in response to a delayed permit. "When we started the business, there was a two-month period where the store was set up; we had everything we needed, we just didn't have a sign," Mike explained. Thus, delivering treats around town was—and continues to be—a way to increase awareness and generate interest in the store.

Nowadays, Mike sees the immediate response to passing out treats. He estimates that for every ten treats he gives away, at least two people will come into the store to check it out. "Most people are pretty receptive," he said, "but some are more hesitant. For the most part, though, everybody seems to like it, and it's worked out well for us." Always conscious of pet allergies and dietary restrictions, the treat he usually carries is a vegetarian-base breath cleaner called "Whimsy," also sold in-store.

The couple also makes strides to contribute to the community through their business in other ways. They currently co-sponsor a dog event at Brewport, which occurs every

Sunday in August. With around twenty dogs (and their owners) usually coming each week, Wags and Whiskers supplies treat bags for

those who come. "There are pools and toys," Mike explained, "and the dogs play while the parents mingle. It's a fun time."

Reflecting on what it means to be a resident and a small business owner in town, Mike says that Wags and Whiskers only make the couple feel more connected. clothes, raspy voice, and simple speech convey a different side of his acting that we haven’t seen before, and extends his range greatly. The journey that Brian goes on is a demanding one, requiring everything that Boyega’s got.

As the situation escalates, he talks with a news producer (Connie Britton) and eventually, the hostage negotiator (Michael K. Williams). A former veteran himself, his conversation with Brian creates a connection between them, and a bond forms. He sees Brian’s plight, and his safety becomes his own concern as well. In his final film role, Williams commands the screen every time we see him. His presence alone gives unparalleled gravitas to this, as well as every film he’s been on. And while he will sorely be missed, this is a worthy final performance to remember the late actor by.

Corbin balances the rising suspense of the hostage standoff along with the more intimate scenes of Brian and his tight circle of confidantes. Scenes with Rosa and Estel make us empathize with him more and more. As the suspense grows—from a quiet sunny day to, at its highest point, a barrage of

helicopters, tanks, pop-up command centers, and reporters—*Breaking* also keeps Brian and his mission front and center. When we finally learn how much money he was denied and that he’s asking for now, it stops the movie in its tracks with impact. Considering the dangerous situation he’s put himself in (and how he knows he may not make it out alive), you realize that it’s not the amount of money he’s asking for that he’s truly after, but simply raising awareness of the injustice that he, and many others, have been denied.

Without giving away the ending, Brian would likely be pleased to know that his story is now being told, and shared with the world. I hadn’t heard this story before seeing this film, but now that I have, I’m saddened to think about the desperation that some people are met with, and the lengths they’ll go to make amends. Brian Brown-Easley shined a light on a deep problem in our country, and *Breaking* furthers that story. It’s an issue that needs to be corrected at the federal level in order to ensure that those who serve our country need to be served back. •
