City Council Address Preferential Parking and Water Tower Lighting Schedule as Policy

The El Segundo City Council moved forward with a new policy, the first regarding when and with what colors its iconic water tower will be lit Tuesday night during its regularly scheduled meeting. The policy comes on the heels of some controversy surrounding one council member's directions to city staff regarding what colors should illuminate the water tower this past June. The city has been lighting the water tower in honor of and to commemorate special occasions, accomplishments, and holidays without a set policy.

Council also moved to add new parking details to the pilot Preferential Parking program in Zone 3, including East Pine Avenue from Kansas Street to Washington Street, and allowing overnight parking with a permit (from 6 p.m. to 6 a.m.) along the west side of Illinois Street from East Mariposa Avenue to East Holly Avenue.

Council member Carol Pirsztuk, who found herself embroiled in that controversy, with residents calling for her to apologize amongst requests for accountability and transparency after she commented on a Facebook post about the water tower's lights being switched from rainbow colors for LGBTQ+ Pride Month to red, white, and blue on Friday, June 14th for Flag Day and remaining that color for a few days on an El Segundo centric page. Residents claimed that through a public records

request they had learned some truths previously unexposed about the lineage and motivations behind the changes.

Pirsztuk, whose written "statement" on the matter was published in the El Segundo Herald's August 29th edition, addressed the situation publicly at a council meeting for the first time Tuesday night, saying that the reason she had not yet spoken about the water tower incident was because she had used her personal Facebook account when she made her comments on the Facebook page and not "my council account, it was just me as Carol Pirsztuk." She then explained that when she first was elected to city council, she began asking the public works director to light the water tower in colors relevant to a holiday or celebration, calling doing so a "reflection of celebration, inclusivity of everything." In previous years, changing the color of the lights required screwing in light bulbs to change out colors but now colors can be changed much more quickly.

She noted that when she said "instructing" the public works director to change the lights, she was actually "requesting", and so, for June 2024, the rainbow lights went on for Pride Month and then were changed to blue and gold to honor El Segundo graduates during graduation weekend after a conversation sparked the idea. She'd also requested that the lights return to rainbow colors after

graduation weekend. Pirsztuk also noted that she'd "cc'd the city manager on all my emails and exchanges."

In her account, Pirsztuk reported receiving an email from a resident she does not "personally" know requesting a color change for Flag Day on June 14th. In reaction to that email, she asked that the public works director change the colors to red, white, and blue and then leave them that way until July 5th because the council member was going on vacation to judge the national championships of Irish dancing, a "tough competition where you're sequestered for a week." Then, when she saw a [Facebook] post [asking why the water tower was not longer lit in rainbow colors] on Saturday [the day after Flag Day], she said, "Oh my gosh, people are very upset about this. So, I posted an explanation, and I said in that post, under my name, it will go back to rainbow colors. So, I waited over the weekend because our director of public works works crazy hours, and I did not want to upset him over the weekend." Then, on "Monday morning at 8:40 in the morning, I texted him and cc'd the city manager," requesting the lights go back to rainbow colors for the rest of the month.

"So, this perception that there's a lie out there or intention. Never the intention. The intention was always to bring celebration, to

She was raised in the Disciples of Christ Christian Church and after her dad died when she was 16, Adonna set out to get her first job to help she and her mom make ends meet. Years later, after a successful career at Mattel Toys, she answered the call to ministry.

The Night in Question by Susan Fletcher

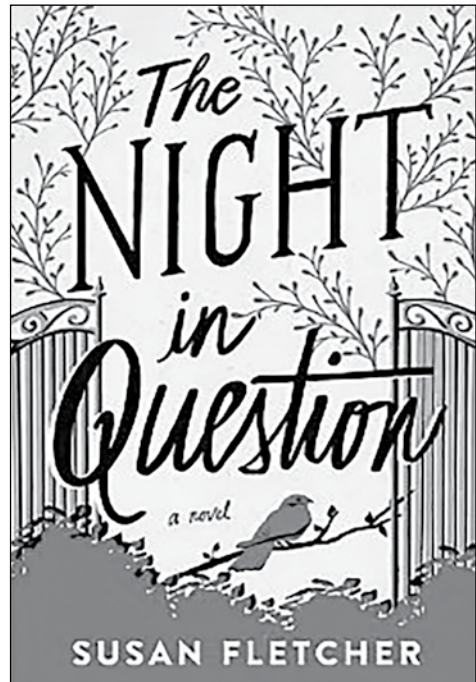

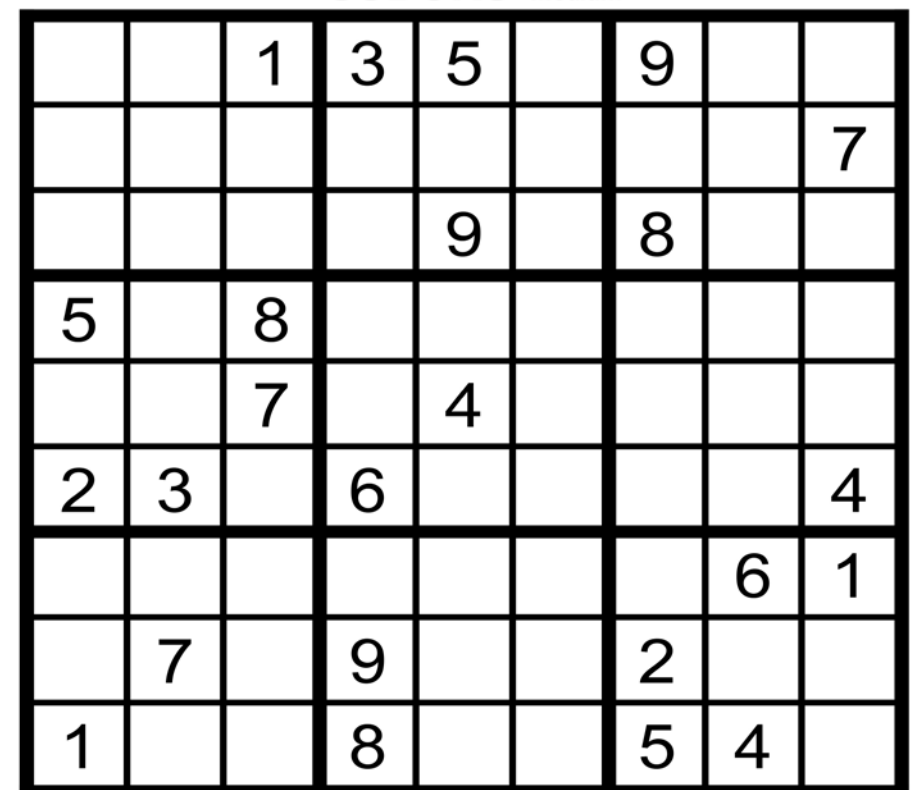

Girl's Flag Football Starts Inaugural Season

The Eagles start their first season of Flag Football with the administration's full support.

As first-year head coach Megan McCann says, "We were lucky to have the support of Principal Gebhart and ADs Steve Shevlin and Fotis Davlantis last spring to start working on getting a program up and running."

The Q.B. can only run once per set of downs, and you cannot run if within five yards of the line to gain. There is no kicking or punting and any fumble is considered a dead ball. Additionally, everyone on offense is an eligible receiver.

The first-year offense is loaded with talented two-sport stars. Senior quarterback Allie Stevenson is a standout softball player and volleyball too. Olivia McPherson plays both ways and is also an elite soccer player. Jazz Ramos will be a receiver and is the starting second baseman on the softball team. Charli Pages will be playing tight end and full back and is also a standout centerfielder softball player. Other offensive threats look to be Shelby Jackson, Nyla Cho and Lexi Heredia.

On defense, the safeties look to be Olivia McPherson, Sara Farah (sophomore), Nyla Cho, and Maggie Green. The linebackers of Nicole Fitzpatrick (sophomore), Victoria Rodriguez, Destiny Castellanos (junior), and Shelby Jackson have shown they will be tough in the middle.

There’s quite a cast of characters, both in Florrie’s present and in her past. Even the most minor of persons are given detail and nuance. Florrie’s family comes alive as she remembers her childhood, some unbelievably true adventures in far-flung locales and some heart-tugging interactions with past loves that will make you sob a bit.

How do these two literary threads come together? That is the sheer pleasure of this book. Past and present intermingle at times and Florrie reveals herself to be much more

than what people at first see. The author explained in an interview that she wanted to create “...a significantly older protagonist ... I’m constantly interested in characters who are, in some way, marginalized or underestimated by society. I wanted, too, to give her an extraordinary adventure in these later years – as well as the opportunity to emphasize how being *older* does not mean that one is *less*.”

There is much more to Florrie than what one may think, especially on *The Night in Question*. •

bring awareness (voice drops off), to celebrate diversity, to celebrate inclusion, to celebrate everything,” said Pirsztuk, “so that’s why it’s very disturbing. I didn’t want to publicly make the statement because it wasn’t about me as a council member; it was always about me when I posted on social media as a person. So that’s the explanation, and that’s the end of the story.”

During public comment, which is when the water tower lights were spoken about by residents previously attending a July and August council meeting (the council was on hiatus for summer in between the two meetings, an annual ritual), on Tuesday evening, some seven residents raised the issue of Pirsztuk’s actions and lack of transparency. The resident who wrote the email requesting colors be changed to honor Flag Day also spoke, noting that the discourse “became really colorful” on the Parents Network Facebook page and social media once people became aware of the controversy over the water tower colors. She read her original email that prompted the change for Flag Day, which contains

zero hate speech toward anyone, and noted that she became the object of hate speech. “My brother is gay,” she said, noting that she is not a hater. She suggested that all special groups no longer have lights on the water tower and that the lights be used just for federal holidays and school purposes.

Tuesday night, city staff presented council with three options for lighting the water tower. In a 5-0 vote, the council approved the first option, which maintains the existing lighting schedule of Valentine’s Day (Red/Pink Theme); Saint Patrick’s Day (Green/Gold Theme); Fall (Orange/Yellow Theme); Independence Day (Red/White/Blue Theme); Halloween (Purple/Yellow Theme); Hanukkah (Light Blue/White Theme); Christmas (Green/Red Theme); El Segundo HS Colors (Blue/Gold Theme); Lakers Colors (Purple/Gold Theme); Dodgers Colors (Blue Theme); Chargers Colors (Blue/Gold Theme); Party Time (Various Flickering Color Theme); Pride (Rainbow Theme); Juneteenth (Red/Black/Green Theme) and Unforeseen Special Occasion as Determined by City Manager. •

on with her. She speaks in hindsight, as most of the film takes place 15 years earlier. Vita recounts having to beg, borrow, and steal to get \$5,000 to make her semi-autobiographical first feature. Nothing was going to get in her way of making this movie. Well, almost nothing.

Fifteen years earlier: Energetic and brimming with passion, Vita assembles a group of friends to help her shoot the semi-autobiographical film, “Always All Ways, Anne Marie”, a story about a young woman from a small town who gets pregnant and decides to leave home. A novice director in every sense of the word, Vita’s eagerness can’t compensate for her inexperience. Through no fault of anyone in particular, except for maybe the stoner crew members, the indie production quickly descends into chaos. On-set tension with her friend and lead actress Dina (Devon Ross) makes their relationship uncomfortable. Her well-meaning but distraction-prone boyfriend causes many derailments, which only increases Vita’s resentment toward him. And when a near-fatal accident threatens one of the key cast members, Vita knows her dream project has

officially unraveled and appears lost forever.

Anyone who has spent time on a film set, professionally or in college, will feel nostalgic watching *My First Film*. Zia Anger captures those small but essential moments, when you’re low on sleep, short on money, and spending hours a day hanging with friends. It’s a magical time that doesn’t come without its complications, including relationship dynamics. Perfume Genius lends his whimsical artistry to the score as the film’s composer. The breathiness and light vocals further contribute to the film’s overall sense of intimacy.

Zia Anger touches on a deeply personal and sensitive moment in her life in *My First Film*. It feels cathartic to watch, and I can only imagine how therapeutic it was to make. Much like how Dina expresses herself in ways that Vita is afraid to, Vita acts as a vessel for Anger to explore deep, unearthed emotions. *My First Film* is a reflective critique of artistic truth. Through intricate and fearless storytelling, this labor of love stands as a powerful statement from an exciting director we should keep on our radar. •

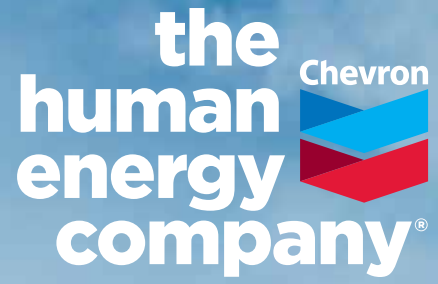
