Council Discusses Little League World Series Champions Parade/Ceremony and New AAA Rating

The El Segundo City Council paved the way for its World Series Little League All-Stars Champions celebratory parade and ceremony by appropriating up to \$200,000 to be spent on the city-sponsored Sunday, September 10 event. The 12-player roster of boys ages 10-12 from El Segundo Little League did what no El Segundo team has ever done before, battling its way from the loser's bracket last month in Williamsport, PA, to soundly defeat a Texas team to win the U.S. Little League championship and then turning around the next day to beat a Curacao team 6-5 in a game that will go down as one of the best and closest games in Little League World Series history. That feat has catapulted both the team and the city to new heights, bringing worldwide attention and acclaim to the 12 12-year-olds who comprise the team and their coaching staff.

At its regularly scheduled City Council meeting on Tuesday night, city staff presented the anticipated parade and Stevenson Park celebration ceremony plans, calling for \$75,000-\$100,000 to cover the costs. However, the council weighed in and increased the appropriation to \$200,000 to cover the cost of allowing each ballplayer and coach to ride solo in a vehicle in the parade rather than sharing a vehicle with another player as city staff and police had initially planned for. City staff is soliciting sponsorships to offset the costs, with Mayor Pro Tem Chris Pimentel making it clear any advertising or labeling for a sponsor should be tastefully done and not the "Tostitos Fiesta Bowl" but rather just "Fiesta Bowl" with sponsor billing downplayed so as

not to overtake the actual event.

This Sunday's parade will start at noon at Imperial Highway and Main Street, traveling Main Street to Grand Avenue, two blocks beyond the typical parade route on Main Street. The boys will then be taken to Stevenson Park for a ceremony with a 1 p.m. starting time. While the parade is a free public event, the Player Recognition Ceremony at Stevenson Park will have limited capacity, with wristbands required for entry. Wristbands are limited to four per person. Two wristbands are free with a valid city-issued Rec ID, and \$5 each for additional

wristbands. A valid Rec ID is required for all wristband purchases. Rec IDs are available to El Segundo residents. According to the city website, wristbands became available on Tuesday, September 5, for purchase at the "Checkout Building, Clubhouse and Joslyn Center" in a limited quantity.

El Segundo Police Chief Jaime Bermudez and Recreation, Parks, and Library Director Aly Mancini addressed the council, bringing them up to date on details from meetings with El Segundo Little League representatives. Chief

Eagles Run to First Victory

The El Segundo football team was riding a six-game losing streak that stretched back to last season. After falling to an impressive Santa Monica team in the 2023 opener, the Eagles had their way with Mary Star in their 34-8 win over the Stars.

The Eagles used a powerful running game led by junior running back Cole Castillo, who had the bulk of the carries for 152 yards and two touchdowns. Castillo had limited carries as a sophomore, but with the way he sliced through Mary Star's defensive line, he looks to be the main running back this season.

The Eagle's offense started slowly, with Castillo carrying four times for 37 yards on the team's opening drive. During the nine-play drive, first-year quarterback Anthony Temesvary completed a 22-yard pass and looked comfortable at the position. The senior started on defense and was the backup to Leo Menendez at quarterback as a sophomore. Temesvary sat out his junior year before returning as the team's leader and one of the captains.

With an excellent starting position on their second possession, the Eagles leaned on the running game. Castillo rushed five times for 48 yards, including an 11-yard burst for a touchdown. Alex Reis converted the first of his four of his five PATs for a 7-0 lead.

El Segundo's defense had a stranglehold on Mary Stars' offense, which provided great field position for the Eagles extending

Recognizing Malnutrition with Dementia

Malnutrition is a lack of proper nutrition. It can result from several factors, including low income, insufficient food, and not eating nutritious foods. Many people associate malnutrition with impoverished populations and are surprised to learn that people with dementia are also at significant risk.

For people with dementia, malnutrition can result from many reasons, including a lack of appetite and forgetting to eat. As changes in the brain progress, many people living with dementia also experiences changes in metabolism and the brain's ability to regulate appetite. Unlike most of us, they may not feel hungry and fail to eat or eat enough nutritious food. Malnourishment may also result due to challenges with shopping, illness, cooking, or eating that become more challenging with time. Even loose-fitting dentures or other oral problems may contribute to losing the desire to eat.

Malnourishment significantly compromises health among those with dementia. They are at greater risk of infection or sickness and may become lethargic. Strength and stamina are also compromised, increasing the risk of slips and falls.

Families caring for someone with dementia should know the risk of malnutrition and the warning signs. It's not enough to note a steady decline in weight, especially if the person with dementia lives at home because daily changes in appearance are difficult to notice early. These warning signs include changes in mood, dizziness, chronic fatigue, or even feeling cold constantly. Food going uneaten is another warning sign, whether the delicious leftovers in the fridge or items aging more than usual in the pantry. In the longer term, take note of looser clothing, rings slipping or becoming looser, or cinching belts tighter than in the past.

If you are concerned that your loved one is becoming malnourished, your first move should be to contact your loved one's physician and arrange a checkup. Doctors chart weight and height and are well-qualified to flag other changes in health you may not have noticed. If they note unhealthy weight loss, they will also explore other potential underlying causes to eliminate or address them.

If the physician confirms your concerns, they will likely recommend a diet designed to add weight, including nutrient-dense or high-calorie foods. Typical items on these diets include full-fat dairy products, starchy vegetables with butter like mashed potatoes, avocado, thick soups, and nuts. They may also recommend various vitamins and minerals or suggest high-calorie shakes to increase weight.

Protein is essential for life, and its usual source is meat. If chewing or swallowing is an issue, protein that doesn't require much chewing may help, such as in soups or meat pies. Shepherd's Pie is a dish we serve in our memory care homes for those with advanced dementia. Scrambled eggs and tofu (a vegetarian option) are excellent protein sources that are easy to swallow. Pureed foods may also help in many cases.

Malnutrition is a serious matter for persons with dementia. Family caregivers should stay alert to the possibility and take early action. As always, I recommend joining support groups to share challenges and learn successful approaches used by others, and professional help from dementia care specialists is just a phone call away. •




<u>Film Review</u>

Fremont is a Magical Tale About a Refugee Looking For Connection

Portraying the mundanities of everyday life in a humorous, smartly observed, and profoundly moving way is what makes the film Fremont

A mostly slice-of-life film told through a series of funny and touching vignettes, the modestly made Fremont follows the life of a young Afghani immigrant in the US. Photographed in fabulous black and white, Fremont draws comparisons to the work of John Cassavetes and personally made me think of Frances Ha. Premiering at this year's Sundance Film Festival, it was the most endearing and enjoyable film I saw.

Donya (Anaita Wali Zada) is a young Afghani woman living in the quiet town of Fremont, California. She lives alone but among a strongly concentrated Afghani community. She takes the bus into San Francisco where she works a low-thrills job packaging cookies at a fortune cookie factory, passing the time listening to small talk from her quirky friend and the encouragement from her good-hearted Chinese immigrant boss.

A largely quiet presence, Donya listens to the thoughts and opinions of a revolving cast of characters. It's a wonderful storytelling device, allowing us to see this unique slice of Americana through her eyes.

Donya's quietness should not be mistaken for passiveness-and certainly, not for weakness. With piercing eyes, she has a fixed, almost steely gaze-something almost challenging. But as the camera captures, there's an enduring warmness and intelligence that lies underneath. Donya watches the world with both curiosity and caution as if constantly on guard.

To this end, we see that Donya has trouble sleeping and wants to get sleeping pills. Before she can receive the prescription, she must sit through weekly sessions with a psychiatrist (Gregg Turkington). These repeating sessions allow us to learn more about the closed-off Donya. And it's here where the film makes its reveal: Donya fled from the threat of the Taliban after working as a translator for the US Army.

Instantly, Fremont explodes into a global story, widening out beyond just the sleepy American city where she lives. Immediately, the film's slow, quiet rhythms of humdrum life stand in stark contrast to what we can imagine was her previous life—a war-torn country filled with constant danger and chaos.

All of the simple, pleasant joys that we then see her live-nightly talks about Indian soap operas with a small restaurant owner, a job promotion to begin writing her company's fortunes, and the possibility of a budding romance (Jeremy Allen White)-feel even more special and magical.

Directed by Babak Jalali (from a script he wrote with Carolina Cavalli), Fremont is a small, but incredibly heartfelt and enjoyable film. The story's many vignettes feel like chapters in a personal diary. I found myself either laughing at its droll jokes, touched by the heartfelt moments, or amazed by its profound observations.

Of course, the thing that makes the movie work is its star. First-time actress Anaita Wali Zada as Donya is perfectly cast. This makes sense when you learn that she is in fact, a real-life refugee. Her performance is natural, raw, and one of pure observation. Slowly, Donya starts to open up, and the tiniest hint of a smile starts to sneak through. You can feel that a whole world of color and wonder lies waiting ahead.


Milo's Monster by Tom Percival







into the second quarter. Starting near midfield, the Eagles went 11 plays to get into the end zone. Once again, the Eagle's offense consisted of ten running plays. The running game was led by Castillo, who picked up 45 yards on five rushing attempts. Temesvary found his tight end, Lucas Sun, open for a 14-yard touchdown pass for a 14-0 lead.

On their next possession, the Eagles went 90 yards to score and go up 21-0. After a penalty backed the Eagles down on their 10-yard line, Temesvary found Lucas Sun open in stride in the right flat. Sun weaved his way past the defense and rambled 85 yards before being brought down near the goal line. Castillo ran it in on the next play on a short run, and just like that, El Segundo was up three touchdowns.

On the first play from scrimmage, after El Segundo's score, Mary Star quarterback Santiago Martinez threw an interception to Grady Lubs at the El Segundo 45-yard line. Joe Bolder gave Castillo a breather at running back, and Michael Wilson ended the sevenplay drive by catching a 17-yard pass for a touchdown with two minutes remaining in the first half.

With the score 28-0, the Eagles had dominated the first half offensively. Defensively, they limited the Stars' offense to 18 plays for a total of 42 yards.

The second half saw the same lopsided game. The Eagles went with their backups for most of the third and all of the fourth quarters. Temesvary, who has completed eight passes for 191 yards, including one to Alex Reis on a 28-yard pass play for a 34-0 lead with just over two minutes remaining in the third quarter.

In the fourth quarter, the defense came up with a turnover when Isaiah Rodriguez

came up with a fumble recovery on a punt return. That extended the opportunity for Joaquin Wagner-Bagues to get more carries and show the Eagles' depth. The only bright spot for Mary Star came in the closing minute. Sophomore quarterback Tanner Rollins found Aubrey Hunter open on a 31-yard touchdown pass play.

It was an impressive win for the Eagles, who improved to 1-1 on the young season. The Eagles travel to South Orange County to face Capistrano Valley Christian (1-1) tonight at 7 p.m. They'll return home next Friday night, September 15, at 7 p.m.

Water Polo Teams Begin Season with Tournament Championship

The boy's water polo program is arguably the most decorated of all the sports at El Segundo high school. With 38 league titles and numerous CIF championships, the Eagles are one of the top programs in the South Bay of not the Southern Section.

This season should continue their success with eleven seniors on a deep team that includes six returning starters. Anchoring the defense is last year's team and Pioneer League MVP, senior captain Luc Giroux in goal. He has put up some big numbers for the Eagles in the past three years, and they are looking forward to his leadership and defensive abilities.

Senior standouts Max Hale, Nolan Barnett, Patrick Wang and Logan Fastman have been huge contributors to the program since their freshman year and bring a plethora of experience to this year's squad. Max Hale has been a leading scorer, garnering all-league recognition since his first year with the Eagles. Barnett and Wang made huge strides in their level of play, and Fastman will help lead the defensive efforts guarding the center.

Coach Ward said, "We are looking forward to the return of the team's workhorse, last year's point leader Carter Williamson. He is recovering from injuries sustained in an accident last month, but we are hopeful he will only miss the first few games of the season and will be back in the pool sooner than later."

Junior Stefan Lazarevic will provide solid backup between the posts at the goalie position, joined by big contributions in the field from juniors Hayden Abbott, Vinny Baldino, and Sutton Fisk.

Sophomores Cooper Albano and Tristan Foster will provide significant energy and power to our offense at the lefty position and center spot, and we are excited to add even more depth to our roster with the talented incoming freshman center Austin Miller.

The Eagles faced stiff competition in the Corona Invitational Tournament and scored 4-0 to claim the tournament championship. In the first game against Redlands, nine different scorers chipped in goals in the Eagle's 14-3 win. Freshman Austin Miller and Sophomore

Seth Davis notched their first varsity goals. In the 9-8 win over University (Irvine), a tight back-and-forth game featured seven different scorers for the Eagles, highlighted by sophomore Cooper Albano's game-winner as time expired. It was another close game against Crean Lutheran, but the Eagles outlasted the Saints 12-10.

In another physically draining game, the offense was led by sophomore Tristan Fosters with four goals and senior Max Hale's three goals. Luc Giroux had another stellar game with ten blocks and three steals.

In the championship game against Roosevelt HS the Eagles came away with a 14-12 victory. The Eagles sealed first place with a balanced effort. Cooper Albano and Max Hale had three goals each to pace the offense. On defense, Luc Giroux, with 14 blocks, and Nolan Barnett, with three steals, including two in the fourth quarter, helped close out the win.

For the tournament, Max Hale led the offense with ten goals, followed by Tristan Foster with nine, Nolan Barnett with eight, and Cooper Albano with seven. The Eagles played host to Crespi on Tuesday and return home next Thursday, September 14, at 3:30 p.m.

Bermudez said the city will be bringing in additional resources via mutual aid to properly plan for the parade and event. He noted that during a recent Homecoming Parade, lots of people approached the kids participating in the parade and said that motor officers would be riding between the parade vehicles and parade watchers on the sidelines for safety purposes. Council member Lance Giroux pointedly asked if Little League was getting everything they'd requested, to which it was noted that a Little League representative had said the Little League would follow whatever the police department recommends. Chief Bermudez told the council, "We were trying to make everything happen." as the groups met and planned the events and that the initial plan of seven vehicles with two players or coaches riding per vehicle was "easier to protect" than 15-16 cars. However, when council member Ryan Baldino said, "Every kid wants a car." Chief Bermudez said, "We

can do that," adding that the department would figure out who else we can tap for resources for it." Moments later, Baldino said, "If you can add cars to the parade, great. If not, that's OK."

Having the El Segundo High School band and cheerleaders in the parade was also discussed. However, for safety purposes, the council agreed to have the band and cheerleaders at the Stevenson Park ceremony and not in the parade. Mayor Drew Boyles noted that it is "more important to have each kid in a car" over including the band and cheerleaders in the parade. Several council members noted how the parade and ceremony are "a oncein-a-lifetime event."


