# Gate 14 Fitness: Reimagining Fitness and Exercise in 2022

I became aware of Gate 14 Fitness in the Spring of 2020. My golf course had shuttered because of COVID. To pass the time in the afternoons, I would venture to a patch of grass on Franklin and Maryland Streets and shank a few pitching wedges.

An exercise class was taking place on and around the concrete squares in the southwest corner of the grass. Weights were being lifted, and folks were running up and down the hills of El Segundo.

With the withering of COVID, Gate 14 Fitness has now relocated inside to a wedge area between Domino's Pizza and Cold Stone Creamery on Grand Avenue.

Here is co-owner Alfred Brown's take on the genesis of his business: "Gate 14 Fitness started in my garage over on Whiting Street," he said. "I moved back to the area after having grown up in Manhattan Beach to be closer to my nieces while I was finishing a Ph.D. at USC.

"I have always been known for doing 'crazy workouts,' many of which originated from my time playing rugby at Princeton University," he said. "Circumstances in 2017 birthed the gym in a more formal manner, [when] a few friends reached out to see if they could train with me more regularly, and Ediz moved back to Southern California.

"By word of mouth, attendance at [my] garage 'gym' started expanding," he said. "We lifted weights and then ran up the steep hill on Franklin to Chevron's Gate 14, over and over. It became apparent that this was more than a passing phase. At Ediz's insistence, we began looking for a more permanent location.

"With the help of a few close friends, we built Gate 14 Fitness by hand. As the longtime varsity coach of Mira Costa's boys' soccer team," Brown shared, "I knew how to run workouts and how to challenge people. We expanded the principles of the

gym and created a format we think is truly second to none."

Brown and Basol chose the moniker of "Composite Training" to encapsulate their workout regimen.

Dina Kinkaid is a Gate 14 coach: "Everyone on the team has different strengths and brings something different to the job," she emailed. "I am known for being the one who can find something great in every session, and it does not matter if the outcome was good or bad.

"When you first meet [the owners], you think they are just hard-core fitness junkies, but when you listen to a workout debrief, chat with them, or read an email, you quickly get a sense of how much they have to offer.

"The programming emphasizes building mental strength and expanding your limits more than I have ever experienced before. Each workout is designed to create a personal

challenge for the client; each day, Gate 14 helps people look at themselves and appreciate something they learned and apply it to their whole life."

"The real secret is that we do not really see ourselves as a gym," Brown said. "We see ourselves as the focal point for a community of like-minded individuals who are seeking more out of life. We base workouts on books and music and genuinely try and thread the physical work we all do in the studio back into the daily lives we lead."

Realtor Gina Hoffman has been a member of Gate 14 for three years. "The attention to detail of every workout is completely different," she said, noting how the trainers "focus on the entire body and mind.

"The biggest and best part is the community they have built within," Hoffman continued.

# The Mailbox: A Family-Run Business

What does it mean to say a business is family-run? It could mean that it has been passed down over many generations, from great-great-grandparents to great-grandchildren. Or, it could mean something else entirely. To The Mailbox owner Robin Fosselman, owning and operating a 'family-run' business is about building strong, lasting relationships with the people you see each day, bringing a unique sense of care and comfort to the store.

The Mailbox was first opened over 43 years ago. Fosselman is the store's fourth owner. She started at the business working for a friend who owned it at the time. When she heard, they were going to sell, she and her boyfriend at the time decided to buy it.

This was a new line of work for Fosselman, who had previously worked as a law assistant for 30 years. While she enjoyed that line of work, she wanted to be closer to home. Fosselman is originally from Culver City, but has lived in El Segundo for the past 14 years. "It wasn't anything I thought I'd ever be doing," she reflected.

But the career change wasn't the only adjustment she would find herself dealing with. A few years into owning the store, her boyfriend passed away. Fosselman has since run The Mailbox by herself for the last 12 years. "After my business partner died, I was lost, and I didn't think I could do it by myself," she explained, "I realized I had no choice; I had to still go to work every day and do it on my own to make him proud."

# Hyperion Lawsuit, Homeless Update, Financial Report, DEI Presentation, and More

On the heels of a South Coast Air Quality Management District hearing earlier that day on the City of Los Angeles' Hyperion Plant and its ongoing air quality issues in the year plus since a plant emergency occurred in July 2021, 13 residents expressed their outrage to the El Segundo City Council Tuesday night about the lack of action to stop the foul and potentially harmful odors coming from the plant. In response, City Council has called a Special Meeting on Thursday, September 8, beginning at 7 a.m. via Zoom, to discuss possible litigation against the plant and its operators/owners and to examine declaring a State of Emergency. Council chambers will not be open for the meeting.

In other action from the council's regularly scheduled meeting Tuesday night, council members and attendees heard from their new Los Angeles County Supervisor, Holly Mitchell. She introduced herself remotely and presented information about her, her staff, and their work now that El Segundo is in her newly formed district, District 2, after the county completed some redistricting. Current Board Supervisor Janice Hahn previously served El Segundo and continues in her role in a newly drawn district. The El Segundo Police Department provided

an update on the city's Homeless Outreach Program, with Chief Jaime Bermudez and Officer Alex Leavitt, one of two officers and a sergeant dedicated to homeless outreach, providing the context and details of their work. Officer Leavitt said that almost all of the homeless individuals they encounter "are dealing with mental illness in some way" and that homelessness, in and of itself, is not a crime. He noted that overnight camping is not allowed on El Segundo Beach, noting that a citation had been issued recently for that offense. He explained the boundaries under which El Segundo's jurisdiction falls, notably from the north side of Grand Avenue to the north end of Manhattan Beach around 45th Street. He said Los Angeles Police handle everything north of Grand Avenue on the beach. Officer Leavitt also outlined the many services his department can connect homeless individuals with, including free groceries, meals, showers, laundry, and substance abuse programs. These services, he said, are provided by about 20 organizations. he also explained that police officers cannot force anyone to use any of the services available to them and that frequently, it takes numerous contacts with an individual before they will accept a service.

Basol recognized that Brown had developed an exercise program that "clearly worked" and encouraged his friend to pursue a permanent workout facility.

"We think of the workouts as an experience," Brown said, "challenging the mind,

are out of shape, it can be embarrassing to walk into a gym," he said, "and be surrounded by a bunch of fit people. I never felt that way at Gate 14. Everyone there is pushing themselves in their own personal way, and to be part of the team, all you need to do is show up and work hard."

Brown, 39 years young, hails from Redondo Beach, moved to Manhattan Beach in grade school, and became acquainted with Basol, who was a couple of grade levels below Brown. He graduated from Mira Costa in 2001, a couple of years before Basol.

Brown was a child of the punk-rock era, "always into books and music," mentioning seminal bands like Black Flag and the C-Jerks.

Brown has always been a devoted workout guy, and when he moved to the southwestern corner of El Segundo, he began training in his garage. Basol had moved back to the area after a stint in the corporate world, and the duo decided to craft a workout facility, Brown said, that followed the motto "if there is not something out there that fits you exactly, make it yourself."

Brown was a soccer player at Mira Costa and played rugby when he moved on to Princeton. He continued refining his workouts while in college, developing techniques that he now teaches.

He has a teaching job at Cal State Fullerton and a coaching gig at Mira Costa. He said that he and Basol are "curious" folk, who want to broaden their knowledge outside of the walls of a gym.

Basol, 37, matriculated to UC Berkeley, where he studied political science. Post-college, he returned to Manhattan Beach to pursue a career as a professional gamer; he and his teammates toured the world to participate in gaming competitions.

He later worked on the marketing side for video game publishers, returning to the San Francisco area. But when his wife Heba got accepted into nursing school, he left the gaming company to return to Southern California.

He rekindled his friendship with Brown, joining him for those high-powered workouts that often started in the garage. In a few months, Basol said he lost thirty pounds and "four-or-five waist sizes."

as well as challenging the body. I have never belonged to a gym," mentioning that "I do not stare into the mirror, and all that [stuff]. Not my thing."

When COVID hit, the gents had to rearrange their plans. They soldiered on, conducted classes whenever and wherever possible, and made sure that their members were still engaged.

"We pride ourselves in extinguishing the machismo end of things," Brown said. "I am not interested in comparing my biceps to somebody else's biceps. Every day, we try to give people the opportunity to try something that they do not know, create a thought-provoking experience."

"We train people's minds," he said, "and show them that they are capable of so much more. I just love owning a business that is doing good for the community," said El Segundo's Basol.

# Honk For Jesus. Save Your Soul is a Flashy Satire of Organized Religion

One of the more light-hearted films to come out of this year's Sundance Film Festival has finally made its way into theaters. Writer-director Adamma Ebo and her producing partner and twin, Adanne, make their feature film debut with *Honk For Jesus. Save Your Soul*, a sharp comedy that pokes fun at the extravagant facade of organized religion and celebrity within a Southern Baptist megachurch.

Pastor Lee-Curtis Childs (Sterling K. Brown) is an outgoing man who leads a congregation of thousands at his megachurch, "Wander To Greater Paths." Or rather, *used* to lead. As the film opens, it's revealed that his not-so-angelic past has come back to

haunt him and has put his position of power in jeopardy. In order to regain the trust of his community, Pastor Childs has enlisted the help of a documentary crew to chronicle his redemption journey; one that he calls his "ultimate comeback."

Not thrilled with the situation she finds herself in is his wife—the first lady of the church—Trinitie Childs (Regina Hall). Her willingness to participate in the documentary is comically dense at first, stating to the camera crew, "I have been blessed with some beautiful Prada!," completely unaware of how gaudy a statement that is.



# Cross Country Preview and Football, Water Polo Win Thrillers

The long-awaited fall seasons have started. The cross country programs are highly anticipated with their pre-season rankings. The football team got their first win of the young season, while the boys' water polo team opened with an overtime win.

# **Cross Country Teams Reload for Success**

The El Segundo high school's cross country teams have been highly successful under the tutelage of head coach Marcos Bolanos. This season both girls' and boys' teams are on the radar of the CIF Southern Section, as both are ranked in the top 10 of their respective Division 4 polls.

Coach Bolanos says the teams have prepared for this season much like in past seasons by working out since the middle of June. They held their weeklong camp at school and made their annual high-altitude camp to Big Bear, where they ran daily for a week. Bolanos said, "We had several runners also attend a high-altitude camp in Colorado for several weeks. Luca Romero and Luke Harrell attend the prestigious Team Prep Running Camp in Crested Butte, CO. The athletes also worked with strength coach Justin Sydney in the weight room three times a week.

The expectations are high for both teams, and according to Coach Bolanos are primed to be in the thick of it when it matters. "We are returning six of our top eight boys from last year and five of our top eight girls from last year's teams." He added that both teams were the fastest Mt. SAC teams in school history. "We have a great opportunity for a league title for both groups as well as a very deep run in CIF." Each year's goal is to get to the California State Meet, and Coach Bolanos believes they have the talent for each team.

On the boys' side, the Eagles look to Luca Romero to have another huge season. Last season he was able to qualify for CA State CIF meet on his own. During last season's track schedule, he set school records for the 5k, 3200, and 1600. Right behind him is Owen Frank, who ranks second all-time in the 3200 and is pushing Romero in workouts. Behind the top two are Luke Harrell, Mo Izaan, Jackson Chartier, Adam Neulander,

Ryan Butcher, and Vicken Semerdjian, all returners. New to the team is a junior, Esteban Esparza, who, according to Bolanos, is a really gifted runner and could challenge for one of the top seven spots.

On the girls' side, the Eagles return four of their top seven. Captain Iliana Montenegro was a CIF track qualifier in the 3200 and has all the makings of a top-tier competitor. She is joined by sophomore sensation Yuvia Bernauer who had an incredible freshman year. Senior Katy Durand is going to take a major leap this season. "She had one of the best summer camps I have seen in recent memory," said Bolanos and added, "Katy was an All-Pioneer league finisher."

Seniors Angela Schoenbaum and Makaela Fujimoto have been mainstays on the varsity squad and will be key scoring contributors for the Eagles this season. Lana Kincaid, Kate Elward, and Sunny Gales will be a few of the younger returners who should take a big jump this year. Natalie Christenson, just a freshman, could have an impact on the team. She had a stellar few years in the middle school cross country program and looks strong early in the season.

The schedule for the Eagles will be an arduous one. They start with some fast courses with the Southern California XC opener at Cal State Long Beach. Then they'll compete in the Woodbridge Invitational, the largest high school XC race in the country. The top runners in the program will travel to Arizona for the Nike Desert Twilight to race against some of the best runners in the Southwest. This season they'll host a race on campus on October 13th. They will host the second Pioneer League race at the school and the first one to be held at night, starting at 6 p.m. The Pioneer League will be a brutal reminder of how competitive the league will be. Besides El Segundo being ranked, West Torrance, South Torrance, and Torrance are also ranked in the early CIF polls. The Pioneer League finals will be held at Columbia Park in Torrance.

forced smiles of pageant contestants. They're committed to making their redemption story as emotionally seductive as possible, but their faith in the documentary-as well as their own marriage-gets put to the test many times along the way.

Adamma and Adanne use humor to portray the ugly truth that not all who preach from the pulpit are free from sin. The creative decision to shoot partially in faux-documentary style contributes to its overarching comedic tone. Watching Sterling K. Brown ham it up to the cameras in one moment and then drop the facade the next draws a chuckle every time. His character is the epitome of how Michael Scott from The Office would look running a Southern Baptist megachurch.

Honk For Jesus. Save Your Soul gives Sterling K. Brown and Regina Hall the freedom to play and explore. Their performances are unobstructed by the fluff that films with bigger production budgets can easily distract from. The strength of the humble yet ambitious script was inspired by Ebo's own experience growing up in megachurch culture in Atlanta, Georgia. Using this personal insight, the film captures a complex issue at the heart of organized religion but tells it in a way that makes it unique and enjoyable for everyone, even atheists! •

From January to March of this year, he noted that the department was able to help eight homeless individuals find permanent housing, also a goal of the city's homeless outreach program. He advised the public to call 9-1-1 for an emergency situation, ESPD dispatch at 310-524-2769 for an immediate situation not defined as an emergency, and to call him at 310-524-2295 for any other discussions. He called homelessness "a very complex problem that's always evolving"

Council also heard about changing how vehicular traffic is measured and reacted to when assessed for the California Environmental Quality Act. CEQA is intended to inform government decision-makers and the public about the potential environmental effects of proposed activities and to prevent significant, avoidable environmental damage, according to a website for the California Governor's Office. The new method, called Vehicle Miles Travelled, replaces the 1950-originated method of Level of Service and should result in shortening or

reducing the number of trips a vehicle takes while the Level of Service Method simply expanded lanes, etc. to accommodate traffic, according to city staff.

In financial news, the council heard the Investment Portfolio Report for June and how the city is adapting to current financial situations and looking toward the future with an eye to inflation and the impacts of a declining commercial office occupancy rate in the city.

Diversity, Equity, and Inclusion Committee Chair Avery Smith delivered a presentation on the best practices of DEI in the local community. The city's Human Resources director presented two department reorganizations that essentially changed the name of Community Services to Recreation, Parks, and Library and changed development Services to Community Development.

Council was also presented with two options for a city monument/gateway sign for the corner of Imperial Highway and Main Street. They asked for redesigns to return at a future meeting after discussing the sign options and their \$450,000 cost per sign. Council member Lance Giroux was uncomfortable with having such a costly sign at that specific location, saying, "It's going to get damaged right away." Other concerns raised for the corner were weeds, having no greenery whatsoever, and no irrigation. Mayor Pro Tem Chris Pimentel opined that the committee behind the sign had been formed in 2016.

During the close of the meeting, City Attorney Mark Hensley announced that the city had prevailed in a case brought by ESPD Officer Scott O'Connor, who sued the city, alleging retaliation based on his union activities resulting in the loss of his school resource officer position. Hensley noted the jury took "less than one hour" to render the verdict and that the city had spent "just more than half a million dollars" to defend itself. He said the city would be "able to recover a portion" of its costs and that the city attorney's budget for an "unprecedented" \$3.5 million is intended to deal with the eight remaining legal cases on tap from police and fire department staff. It was not indicated if any of these staff members remained on staff. Hensley did state that the city has faced 11 cases in the last two years approximately and only had one such type of lawsuit in its previous 25 years that he was aware of.

City Manager Darrell George announced that E Segundo is among the top five cities named as a finalist for the Most Business-Friendly award, which will be presented in November. The city has taken the top spot two times and was in the top five last year for cities of its size.

Mayor Drew Boyles announced that the State of the City luncheon on September 14 is a "major fundraising event for the (city's) chamber of commerce." That is why there is a fee to attend. The meeting will be recorded and available online after the event. However, Boyles noted that anyone interested in attending could contact him to see what arrangements could be made.

# The Mailbox

Fosselman's day-to-day tasks include picking up the mail for the over 500 box holders, sorting it accordingly, and, most importantly, customer service. This includes helping people with packing or shipping questions, notary, faxing or copying information, and even simple tasks like buying stamps.

She believes customer service is what really makes The Mailbox stand out. "When I first bought the place, my friend told me: You're not offering people something they can't get anywhere else. The only thing you're in control of is the customer service," she explained.

Fosselman is proud to have connected with so many customers in El Segundo, many of which she now knows on a much more personal level. "So many of the customers have become personal friends," she explained. When she first moved to El Segundo, Fosselman didn't know a lot of people. However, now people sometimes will even stop her on the street. "I don't think a day goes by that someone doesn't compliment me or tell me how great of customer service I have," she observed, "Everybody is just so nice and encouraging."

Her favorite part of owning the store? Helping people send a letter or ship a package. It's the simple things, she explained, that makes it all worth it. This also means being able to help people who have questions, but don't have a computer or phone. "Sometimes customers will come in and ask me a question that's not even related to my business at all," she said, "So many times I try to lift up the customer, but oftentimes, they lift me up too," she said.

It is these small, but meaningful interactions that make Fosselman proud to be a small business owner in El Segundo.

Now, she is excited to pass on The Mailbox to new owners, but the store will remain a family business. The new owners, AJ Pulver and Shiela McEntee, are a family from El Segundo, both attending El Segundo High School as teenagers.

Finding them, Fosselman said, was practically kismet. She had originally hired two local brokers to find someone as a new owner. They both found a few people who were interested in purchasing the store, but as she explained, it wouldn't remain a family business. She rejected their offers. However, one of the brokers was interested himself; he went home, talked to his wife about it, and they decided to buy it. After finding AJ and Shiela, the rest is history.

"That was my fantasy," Fosselman said, "They remind me of me when [my boyfriend and I]

first got the place-how excited and hopeful. They are just so excited to run the place."
