### **Kiwanis Club Supports Our Youth**

They may be over a half-century apart in age and are at very different places in their lives, but when it comes to being members of the El Segundo Kiwanis Club, Bill Watkins and Zack Cosby are on the same page. It's all about the kids.

The long-time local service organization, established in the late 1920s, continues to prioritize community youth through various ongoing (and new) projects, events and programs. Watkins officially joined in 1981 when he was an administrator at El Segundo High School, but his involvement with Kiwanis harkens back to 1963 when he was the KEY (Kiwanis Educates Youth) Club advisor on the campus and also taught English classes. The objective remains the same no matter the year, Watkins, 84, noted. "Throughout all this time, the goal of the El Segundo Kiwanis Club has always been to support the youth in our community through the city's many youth programs and El Segundo Unified School District's sports, arts, career day programs, and scholarships," he said. "I am proud to be a member of this organization that supports our youth activities and our high school students through KEY clubs at El Segundo and Da Vinci high schools."

Cosby, 31, pointed to his "wonderful childhood" growing up in town where he was "privileged" to enjoy "incredible opportunities" that local service organizations such as Kiwanis helped to foster. "Now, as an adult, I can appreciate how truly special this community is, and I'm proud to be able to give back to the town that has given me so much my entire life," he said. "Kiwanis is more than just a club—it is a family. The ability to raise money that all goes back to the kids here brings me so much joy. Being the youngest board member of the organization, I view my contributions as paying it forward

so that future generations will have the same experiences I had."

One of Cosby's fondest childhood experiences was attending the annual fall street fair that he now gets to help organize. Originally held on Richmond Street but moved to Main Street after the pandemic, the event is more popular than ever and serves as one of the Kiwanis' most prolific fundraisers. The 2024 Main Street Fair festivities are set for Saturday, September 28, and will feature arts and crafts booths, merchandise vendors, kids games, a food court, a beer garden, live music on two stages, and more over eight city blocks.

Coming up in October is the Kiwanis Costume Contest in conjunction with the annual Halloween Frolic. A staple for over 20 years, this program highlights age categories from infant through adult as well as group costumes. "When my children were young, we competed every year with our homemade costumes and we took home several prizes over the years, including a 'Transformer' that actually transformed, a 'shark who ate my sister,' a box of crayons, and a 'Slinky Dog' with one of my daughters at each end," Kiwanian Kelly Watson recalled. Contest emcee since joining the club in 2019 (this was also her first volunteer activity for the group), Watson is pleased to see the event thriving once again as an in-person experience after a Covid hiatus. "In 2020, we had to move online using the Padlet app, where we judged costumes and decorated homes."

Wrapping up 2024, Kiwanis will co-sponsor (with the El Segundo Police Officers Association) the construction of Santa's Sleigh to ready the vehicle for the Holiday Parade and to prep See Kiwanis, page 8

#### The Jewelry Source Celebrates 40 Years

#### Check It Out

#### Lilith by Eric Rickstad

This is not an easy read, but it should be read by everyone. The first four pages are filled with foreboding. The reader is immediately invested in the story. We know something terrible is coming. And of course, it does. An elementary school shooting.

When teacher Elizabeth Ross realizes what is happening, she foregoes protocol and tells her students to run, run as fast as they can, out of the classroom, out of the school. She should be with them, but she can't leave her son in another classroom facing certain death. It is horrifying to read this from a first-person viewpoint. It is horrifying to read it at all, but school shootings are now so commonplace that we must. Eric Rickstad captures the fear, the dread, the anger, and anguish pumping through Elizabeth Ross as she searches for her son. This is how the novel begins.


Stuck in the hospital, Elizabeth and her son

Lyden recover from the injuries they have suffered. Elizabeth stays at Lyden's bedside, sleeping in a chair. As she wakes one morning, she listens to one of the country's largest gun suppliers announce his bid for president in the wake of the shooting to protect the second amendment rights of all citizens to bear arms whenever and wherever they wish. Gleefully, he suggests that it may all have been a hoax, an excuse to increase gun control. Next, she is frantically called into a meeting with the school superintendent and principal and her union representative to discuss disciplinary action for her breach of procedure, despite being hailed as a hero for having saved those children. Elizabeth seethes with anger at the men in power. If they won't do something, she will. Thus, Lilith is born.

This is a gut-wrenching novel. Every page is filled with mounting tension, an exercise in perseverance. I reiterate this is not an easy read, but this thriller is a masterpiece in addictive prose. One simply cannot turn away. Gripping in its reflection of the real world tragedy of gun violence, it stays with the reader long after it has been read. Retaliatory justice is morally ambiguous at best, but the concept of an "eye for an eye" is provocatively seductive here. •

Newman's career opened her to a new world and her desire to deepen her knowledge led her to the Gemological Institute of America (GIA). Alongside her friend and tennis partner, Roanne Mahony, who also graduated from GIA, Newman explored the world of gems. Their shared enthusiasm and a spur-of-the-moment visit to a gem show in San Diego resulted in their first jewelry creations. The positive feedback and requests for custom pieces inspired them to start The Jewelry Source.

Their venture began modestly with a small rented space at 116 W. Grand. As their reputation for appraisals, repairs, and custom designs grew, they moved to a larger location at 413 Main Street. In 1999, they settled into their current location at 337 Main Street, a time when downtown El Segundo had fewer dining and retail options. Over the past 25 years, Newman has witnessed the transformation of Main Street into a vibrant hub of activity.

In June, The Jewelry Source hosted a special event to benefit Children's Hospital Los Angeles in memory of Roanne Mahony, who passed away in 2020. The event featured

a party tent with carnival-style games, food, and drinks, and was a resounding success. Twenty percent of sales from the event were donated to the hospital, and a stunning gold ring with a marquise-shaped diamond and custom-cut ruby halo was raffled off to a delighted winner.



#### **Catching Up on the Eagles**

With the fall season sports in full swing, it's time to catch up on how the Eagles are doing. The football team looks solid, while the boy's water polo team is off to a strong start. The girl's flag football team is showing their potential and the girls' volleyball team is building the program in the right direction.

#### Football Team Has Potential

The Eagles have started their season with wins over Sierra Vista and Don Lugo, sandwiched in between by a loss to South Bay powerhouse Peninsula. During their first three games, it is apparent that the Eagles are improving and have the potential to have their first winning season in six seasons.

Sophomore quarterback Ryan Wiacek has passed for over 550 yards in the first three games. Cole Castillo has been the running back workhorse rushing for nearly300 yards to open the season.

Against Sierra Vista, the Eagles amassed 497 yards of offense in their 56-12 win. Wiacek completed 71% of his passes for 218 yards and three touchdowns. Castillo averaged 7.8 yards per carry, while Chase Mattoon had three receptions for over 100 yards and a touchdown.

The 28-14 loss against Peninsula was dominated by referee flags that were perplexing at best. Still, the Eagles showed their potential against a Peninsula team that might be their best in years. The stat line was close, but the game came down to questionable calls at crucial times. Castillo picked up 92 yards on the ground, while the defense was led by Isaiah Rodriguez and Axel Thiess.

The Eagles traveled to the Chino area to face Don Lugo in the 85-plus-degree sweltering heat. The heat didn't take the Eagles out of their game in their 34-27 win over the Conquistadors. The balanced El Segundo offense picked up 282 total yards with Wiacek throwing for 218 yards and three touchdowns. Chase Mattoon caught a touchdown pass for the third consecutive game and also had an interception.

The Eagles travel to South Torrance on Friday at 7 p.m. They return home next Friday night to host Torrance at 7 p.m.

#### **Boy's Water Polo Continues to Impress**

The Eagles, fresh off a 32-0 and CIF Championship season, are off to another impressive start. They defeated Orange County powerhouse Orange Lutheran 8-7 to begin the season. Carter Williamson led the team with three goals and an assist. CIF Player of the Year Tristan Foster took a knee to the side of the head and was placed in concussion protocol.

Without Foster in the lineup, the Eagles went on to win the Long Beach Tournament with wins over Francis Parker (San Diego) 17-9, Redwood (Visalia) 7-5, Downey 13-12, and Redondo 8-7 in the championship game.

it for two weeks of roaming the local streets as St. Nick alerts residents of his impending whereabouts. Scot Nicol chairs this event as well as the Kiwanis annual golf tournament that welcomes about 100 participants and raises an average of \$15,000 a year.

Nicol also chairs a brand-new venture that raises funds for high school sports: the Kiwanis Athletic Foundation. "Kiwanis already supports a ton of local sports, but sees an opportunity and a void in need of filling in that area," he said. Kristie Sherrill also played a major role in the foundation's creation, adding, "We felt there was a need for this in our community since most sports teams require additional money to run their programs, so we will work closely with the schools to help support where it helps the most."

Sherrill additionally serves as the Kiwanis liaison for College and Career Day at El Segundo High. The club funds the event at which each student signs up to hear three speakers representing different vocations. "We have over 150 volunteers come in to speak with the students about a large variety of career options," she said.

College and Career Day takes place in the spring when the Kiwanians truly roll into high gear. For instance, Link Crew's annual Freshman Orientation debuted over a decade

Zack Cosby, Kiwanis' youngest member and board member. ago as a way to ease the transition period for incoming first-year high school students. "It pairs ninth graders with upper-level students who act as mentors, guiding them through their first year," program co-coordinator Gerardo Barajas explained. "The orientation includes activities like icebreakers, campus tours and team-building exercises, all aimed at fostering connections and building confidence. At the end of orientation, leaders and ninth graders participate in a group theme costume contest. Another memorable activity is the gingerengineering contest, where the participants work together to build gingerbread structures." Other notable supporters include the Parent Teacher Student Association (PTSA) and the El Segundo Education Foundation.

Meanwhile, the third annual Chilipalooza will take place at Library Park in April 2025; this event features amateur chili (including plant-based) chefs competing for the top apron. Cornhole, live music, and a beer and spirits tent are also part of the proceedings. "This event is 100 percent volunteer-based, so all the operating profits go to the Kiwanis Club of El Segundo to invest in the youth of El Segundo and the South Bay," coordinator Shannon O'Toole said. "They fund school sports, scouts, city improvements, and scholarships for high school seniors. Kiwanis member

Barry Gribbon suggested a chili cook-off event after Covid when he realized people wanted to get out and enjoy the parks again. A successful Chilipalooza would include mild weather, smiling faces and full tummies."

A year-round program that helps both businesses and residents, the El Segundo Community Discount Card provides price reductions of at least 15 percent at over three dozen local merchants. Participating companies benefit through free advertising and community support, while cardholders save money on purchases. "Kiwanis was able to raise money through the card purchases during the pandemic when all our events got canceled," program chairperson Jeff Wilson said. "The \$20 card is good for the entire calendar year and can be used over and over at each business." Sales start for 2025 in December and can be purchased online or at select businesses in town.

Last but not least, the newest Kiwanis event is set for October 7, when the group hosts the second of two El Segundo City Council candidate forums. "We are partnering with the El Segundo Woman's Club to coordinate the two events that will both be open to the public," co-coordinator Kara Baldino said. The first forum will take place at the Woman's Club building on October 2 from 6-8 pm, with the second at the El Segundo High

School Performing Arts Center five nights later during the same time window. "We are really enjoying working with the Woman's Club and excited to provide this opportunity for the public to have their questions asked of all six candidates in one place," Baldino added. "It is Kiwanis' goal to host a City Council candidate forum for every election going forward and to have our El Segundo High School Key Club help us in the process as well. Kiwanis centers around community service and helping children, so involving the students in the process of putting on a forum for the community is a perfect fit!"

The El Segundo Kiwanis Club supports dozens of additional events, programs and groups too numerous to mention on top of the list of items covered above. As its website (elsegundokiwanis.org) emphasizes, "We believe our neighborhoods and our world are best served when people of all ages and different backgrounds work together to share their time and talents." Recognizing the contributions of the aforementioned Watkins and Cosby in this regard, Kiwanian Eric Kari concluded, "The fact that we have over five decades of age difference within our club is a pretty phenomenal statistic. I guarantee most other clubs don't have that." But when it's all about the kids, age is just a number... •
