# Camping in Public Banned Citywide

El Segundo will follow the lead of 14 California cities and ban camping and sleeping in public areas. The Council on Tuesday implemented stricter measures to balance public safety and coax homeless residents and transients to use shelter beds and social services instead of living on the street.

Now, camping in public, including sleeping in a vehicle or camper parked on a street, is forbidden within the city limits. The broader ban is modeled after one in Grants Pass, Oregon, which won a legal challenge this summer at the U.S. Supreme Court. The cities of Long Beach, Hemet in Riverside County, and Vista in San Diego have also enacted camping bans since the Grants Pass decision.

The council voted 4-0 to expand a narrower nuisance ordinance that restricted overnight camping in public parks, parking lots, and the beach. Under the new camping ban, anyone caught sleeping in a public area between 10 p.m. and 6 a.m. will be cited and could face fines and possible jail time for a third offense in one year. Penalties range from a \$1,000 fine to six months in jail or a 30-day ban from the property.

That includes sleeping in vehicles and campers parked on city streets, though public driveways are exempt from the restriction. Examples of camping include tents, sleeping bags, and storing belongings on public property. It's now illegal to block a sidewalk or public right-of-way in El Segundo. Personal belongings can be removed with a 24-hour notice and held in storage. The ordinance gives a person whose

belongings are moved 30 days to provide proof of ownership and claim them.

Justices ruled on June 28 that outlawing camping in public parks and other spaces was legal and that the approach taken by the southern Oregon city had merit. The court noted that Grants Pass tried to persuade people living in tents at public parks to move into shelters and take advantage of social service programs.

The Supreme Court also ended a requirement that shelter beds must be available for a city or county to enforce a camping ban. Based

on a January census, South Bay's homeless population sits at 5,428 people. Volunteers who went out over three nights in January counted fewer unsheltered people than in 2023. El Segundo's permanent homeless population is small compared to its neighbors though it fluctuates with transients, according to the city attorney's office that drafted the revision to the nuisance ordinance.



#### Four considerations as you save for college

There are several savings options as you and your future college student prepare for the costs of college.

WHEN YOU ADD UP THE COSTS of raising a child, education looms large. "Four years at a public in-state college is projected to cost \$47,152 today," says Richard Polimeni, head of Education Savings Programs at Merrill. At a private college, that total could hit nearly \$169,0001, and at the most elite schools you could spend far more. "You can expect tuition costs to rise by about five percent each year," he adds. That's why it's important to start saving as early as you can. "Ideally, you want your savings to pay for a larger portion of the costs, so you or your child can borrow less."

"Start by setting up automatic monthly contributions to an account earmarked for college," Polimeni suggests. Then, as freshman year approaches, you can look for ways to fill in the gaps. Contribution limits, tax benefits, and other factors differ across the four major college savings options, including a 529 savings plan, a 529 prepaid tuition plan, a Coverdell Education Savings Account, and UTMA/UGMA custodial accounts created under the Uniform Gifts to Minors Act/ Uniform Transfers to Minors Act. Consider a conversation with your advisor about which options best align to your family's overall financial plan.

#### Make the most of tax benefits

"There are various federal income tax provisions that not only encourage people to set aside funds to pay for higher education costs but could also help offset some of those expenses," says the Chief Investment Office ("CIO") National Wealth Strategies Team for Merrill and Bank of America Private Bank. Those include tax credits for higher education expenses and a deduction for student loan interest. What's more, you can withdraw funds from individual retirement accounts to cover eligible college costs without incurring additional taxes for early withdrawals, but it's better to leave those funds invested for your long-term goals, the CIO notes. For more on these tax rules, ask your advisor for the CIO's Wealth Strategy Report: Tax Provisions Related to Higher Education Expenses, June 2023.

#### Final stretch? Fill in the gaps ...

On average, families cover only 54% of college costs with savings and the parents' and student's income.<sup>2</sup> Another 26% comes from scholarships and grants, with loans covering 18% (friends and relatives kick in the rest).<sup>2</sup> That means that in the final run-up to college, you may want to look into one or more of these options:

**Apply for federal student aid:** Start by filling out the Free Application for Federal Student Aid (FAFSA), which you can do beginning October 1 of your child's senior year in high school. "Everyone should apply for federal student loans and grants, even if you think you won't qualify," says Polimeni. Your aid eligibility doesn't hinge on your income alone, although it is a significant factor. Financial aid awards, which often take the form of student loans, take into account the

#### The Substance: Vanity Fares Poorly in this Multi-Sensory Stunner

Youth is a hot commodity in Hollywood. Once you lose it, you can never get it back. Everyone ages, of course, but if you're a fading A-List celebrity, one forehead wrinkle can be the difference between bankable and broke. In the new body horror film, The Substance, French filmmaker Coralie Fargeat explores the toxic repercussions of ageism and body image. Bordering on fetishism when it comes to the film industry's obsession with beauty, Fargeat's film takes a stand against this demoralizing, anti-feminist treatment of women's bodies. In the ultimate power move, The Substance is a graphic and gory cinematic rallying cry that aims to upend the effects of toxic beauty culture. In theaters nationwide on Friday, September 20th.

Demi Moore plays Elizabeth Sparkle, a Jane Fonda-type who has made a career for herself as an actor-turned-fitness personality. Despite having a star on the Hollywood Walk of Fame and her own aerobic morning show, Elizabeth knows her time in the spotlight is running out. She sees her life begin to play out in the past tense, picking up on the notso-subtle cues from her boss, Harvey (Dennis Quaid), with phrases like "you were great". Despite her legendary status in the industry, she can't avoid the inevitable. She will be aged out of Hollywood. If becoming old makes one invisible, regaining youth is the only way to feel desired. Luckily, there's a drug for that.

A chance encounter leads Elizabeth to discover a miracle drug that claims to be the fountain of youth. One injection of "the substance" is all it takes for her to become reborn as the gorgeous, twenty-something Sue (Margaret Qualley). Blinded by this promise of a younger self, Elizabeth acquires and injects the neon-green liquid into her body. After a demonic exorcism-like process, Sue

is born and she is beautiful. Her long limbs, silky hair, and clear porcelain skin stand in stark contrast to Elizabeth's aging body.

Taking the substance comes with a nonnegotiable rule: Remember, you are one. Therefore, the time between Elizabeth and Sue needs to be split equally. For one week, the world gets Elizabeth, the next week they get Sue. While the women take turns as sentient beings, their counterpart lays unconscious on the bathroom floor, being fed through a tube until it's time to wake up. Things go according to plan, in the beginning at least. Both Elizabeth and Sue are respectful of the schedule and Sue quickly becomes Hollywood's budding darling. The divide between Elizabeth's hopelessness and resentment and Sue's optimism and success escalates, eventually reaching a breaking point. What follows is a multi-sensory monstrosity as both women battle to break free from their repression and regain control of their womanhood.

Behind the riotous visual elements of *The* Substance, director Coralie Fargeat crafts a deeply personal message that resonates. Portraying Elizabeth Sparkle is Demi Moore's latest crowning achievement. Her theatrical skills and comedic timing are on full display and are especially mesmerizing toward the film's second half. Margaret Qualley as Sue is another perfect casting choice. Her shift from a Bambi-like demeanor to a greedy itgirl is methodical and devilishly fun to watch.

Amplifying the onscreen visuals are a pitch-perfect score and sound design. What starts as slightly campy in tone, the sound eventually morphs into a hypnotic and brutal sonic experience. ASMR tingles, especially at the very beginning of the film, add another layer of full-body chills.

As the credits rolled after nearly two and a half hours, my jaw was practically on the floor. What had I just witnessed?! With *The* Substance, Coralie Fargeat cements herself as a new visionary and bold voice in modern cinema. The Substance is defiant, deranged, and demonic... and I loved every bloody second of it. •





system. The defense had four sacks and an interception.

After a scoreless first quarter, the Eagles took advantage of a fumble recovery at the South Torrance 13-yard line by Isaiah Rodriquez. Three plays later, Cole Castillo followed his line into the end zone for a 3-yard T.D. On the touchdown run the Spartans were assessed a major penalty that was assessed on the ensuing kickoff. Eagle's kicker Chase Mattoon executed a perfectly placed on-sides kick that went the required ten-yard distance. Mattoon was the first to jump on the ball and the Eagles took over at the Spartan's 37-yard line.

The offense went back to work on a short field. The South Torrance defense held the Eagles out of the end zone and Mattoon kicked the first of three field goals; this one from 25-yards away.

With time winding down in the second quarter sophomore quarterback Ryan Wiacek was faced with third and eight. He saw an opening to rush for the first down. Once through the line, he raced down the right sideline 60 yards for a first down. On fourth and six, Mattoon connected on a 42-yard field goal with forty-two seconds remaining in the half to make it 13-0. The half ended on a sack of Spartan QB Chase Spahr by Eagle defensive end Jake Danford.

The Eagles took their 13-0 lead into halftime realizing they had had their way with the Spartans. The offense rolled up over 160 yards on the ground, while the defense limited the Spartans to 90 total yards of offense.

Near the end of the third quarter, the Spartans were driving deep into El Segundo territory with a 12-play drive; the drive leaked into the fourth quarter. On third and ten from the El Segundo 12-yard line, the Spartans Q.B. threw an interception. Shane Mossman stepped in front of Braden McCormick, the intended Spartan receiver, near the goal line and returned it to the El Segundo 12-yard line.

On the next Spartans possession, they went 52 yards in seven plays to score a touchdown on Seth Blevins' 3-yard run. This narrowed the score to 13-7. With 2:08 to play, Mattoon kicked his third field goal from 33 yards away for a final 16-7 score.

Cole Castillo had a big night rushing the ball for 133 yards and a T.D. The lanes were opened thanks to the line play of seniors Isaac Beas and Xavier Ramos, juniors Preston Greaser and Samiuela Vaikona, and freshman Gio Blanco.

The Eagles celebrate their Homecoming game Friday night at 7 p.m. against the

Torrance Tartars. The Homecoming Parade down Main Street is slated to start at 5 p.m. This year's theme is "Ancient Empires and Wonders of Gundo." The Eagles played the Irvine Vaqueros in a non-league matchup at home and came away with a hotly contested 9-8 win. It may not have been the Eagles' best-played game because of all the unforced errors and difficulty with their passing, but when they needed a steal or a goal down the stretch, the Eagles stepped it up.

The Eagles forced the Vaqueros into low-percentage shot attempts in the opening period. On several attempts, their shots clanked off the side and top of the goalposts. On the other hand, the Eagles had clear shot attempts blocked or saved by goalie Neil Maddox. With two minutes gone, Cooper Albano found an opening inside and fired it in for a goal. Austin Miller took a pass and weaved his way inside for a goal to make it 2-0. The second period revealed plenty of miscues by

Kate Summers' dig started a long rally, and the Eagles won the point. Her ace knotted the game at 8-8. Macy Ludwig, Catherine Reed, Sarina Waite, and Sydney Neely played well for the Eagles.

The schedule doesn't get any easier with a home match with Torrance and Redondo this past Tuesday and Wednesday, respectfully, and host the twelfth ranked (nationally) Mira Costa Mustangs next Tuesday at 3:30 p.m.

The Eagles traveled to Culver City to take on the Centaurs in a non-league game. The Centaurs are in their second season and have experience, but the start-up Eagles showed that their first-year experience was enough. The result was a 38-6 win for the Eagles, who improved to 3-2 on the season.

Allie Stevenson led the Eagles' offense by passing for four touchdowns, including a 40-yarder to Olivia McPherson, who also had a rushing touchdown. Ava Gutierrez led the Eagles with six receptions, including one for a T.D. Nyla Cho and Sage Guy each caught touchdown passes, too.

As good as the offense was clicking, the defense was stellar under the tutelage of defensive coordinators Jessica Davis and Randall Moss. The Eagles had four interceptions, including one by Maggie Green, who returned one twenty yards for a touchdown. Nyla Cho used her speed and hounded the Centaur quarterback to make several sacks.

# Thai Ginger Chicken with Yellow Jasmine Rice

Add the garlic and ginger and cook and stir for 1 minute. Add the coconut milk and cayenne pepper and heat to a boil. Reduce the heat to medium-low. Cook for 2 minutes, stirring occasionally.
- Step 4: Place the broth, jalapeño peppers and cilantro into a blender. Cover and blend until the mixture is smooth.
- Step 5: Stir the broth mixture in the skillet. Return the chicken to the skillet. Cook until
  the chicken is cooked through. Stir in the lemon zest. Season to taste. Serve the
  chicken mixture with the rice.

Angeles County Supervisor Janice Hahn said. The focus on shelters has convinced people who are homeless by choice or displaced to get inside, she added.

Following the Supreme Court decision, Gov. Gavin Newson made \$3.3 billion available to cities from Proposition 1 for more behavioral health outreach and care to individuals experiencing mental health conditions and substance use disorders. The governor's executive order issued in July focused in particular on residents who are most seriously ill, vulnerable, or homeless. Voters narrowly approved Prop. 1 in the March primary election.

People experience homelessness for different reasons, not all of which are mental health or substance abuse, according to El Segundo's five-year plan for homelessness from 2018. There are chronically homeless defined as without permanent shelter for a year or more, and often with a disability condition.

People classified as recently homeless have lost their housing within the past year because of a change in employment, health, or a breakup or divorce. In some cases, their rental is sold or owner-occupied.

The report said transients include young people who are drawn to living at the beach for the summer and can be persuaded to return if housing and other resources are available elsewhere.

The last category includes individuals and families at imminent risk of becoming homeless. According to the five-year plan, providing meals, laundry, and groceries from a food pantry can sustain these people and prevent others from falling into homelessness.

El Segundo police officers are trained to respond to calls involving homeless residents and transient visitors. City staff working in code enforcement, parks and recreation, public works, and legal services act as eyes and ears in the homeless community for police follow-up and referral to caseworkers with PATH.

In a related action, the council decided that El Segundo Public Library needs a code of conduct that the police can enforce. The El Segundo Board of Library Trustees will adopt a set of rules which will be added to the city's municipal code. Recent instances of misbehavior and violations of the library's rules, some by members of the homeless population, prompted the city to take this action.

#### In other council action:

The city commended El Segundo High School alum Allison Reaser-Halverson for winning the Women's Decathlon World Championship.

The Council agreed to allow alcohol sales on a city-owned parking lot for the Sept. 28 Kiwanis Main Street Fair.

The School Board will meet in the City Council chambers while the school district offices are remodeled. Work is expected to be completed in August 2025. The school district will reimburse the city for staff time to produce and record the school board meetings at an estimated rate of \$484 for a two-hour meeting.

Crews repairing a sinkhole on Grand Avenue discovered additional damage, which will raise the cost of the project by \$100,000. The city will use general fund reserves to make the necessary repairs to a dislodged sewer pipe that wasn't part of the original bid.

The designs for the Teen Center were reviewed, and the council favored Option 2. It would slightly change the size of the basketball and multi-use courts and add courtside seating. The project cost, including a remodel inside the Teen Center, is estimated at \$5 million. The Parks & Recreation Commission, a Parks Renovation Subcommittee, and a Teen Advisory Committee all liked Option 2. •


