# Council Sends Joint Agreement with School District Back for More Work

An amendment to the joint use agreement for fields and facilities between the City of El Segundo and the El Segundo Unified School District engaged the five-member City Council for about an hour Tuesday night, with the item as originally presented by city staff not securing approval even though the school district board had approved of the agreement as written at its meeting on September 12. Instead, after a lengthy dialogue, the City Council voted 3-2 to extend the current agreement for 30 days until staff talks with school district officials and delivers more information on specific issues that kept the item from passing.

In other news, the council voted unanimously not to take city staff's recommendation to keep the intersection of Main Street and Oak Avenue as a two-way stop signed intersection and asked staff to implement a four-way stop signed intersection and look into other safety possibilities, including a lighted crosswalk and/or a signaled intersection after hearing from four residents who spoke in favor of a four-way stop sign. One of the four speakers was an El Segundo student who was hit in the crosswalk in April, thrown into the air, and rendered unconscious. Her mother also spoke, telling the council of countless nearmisses of pedestrians in the crosswalk and some "horrible almost crashes."

The council also heard a presentation on the Downtown Specific Plan and recommendations for Phase One of the Recreation Park renovation. It increased the salary range for the chief of police by seven percent and increased by \$1,000 per month, the stipend the city pays the city clerk. The city's Human Resources director noted that the city clerk stipend had remained the same for six years, and the assistant city clerk's position has been vacant for more than a year with staff unable to fill the position with quality personnel

Council members Carol Pirsztuk and Ryan Baldino were clearly not pleased with the council not passing the amendment to the joint use agreement. Pirsztuk repeatedly said council members were getting "in the weeds" when asking for specific information and that the amendment as presented was good policy that would then allow city staff and school district staff ("the professionals," as she called them) to actually manage the fields and facilities. Council member Lance Giroux insisted that Richmond Field, which is owned by the school district, not continue to be maintained and scheduled by the city.

### The Other Epidemic

Here in the United States, a new type of war on drugs has begun. Never before, even with the lethality of the substances already on the market, has there been something as deadly as fentanyl. According to the CDC, between 2019 and 2021, opioid overdose deaths have doubled, and fentanyl accounted for 83%. In the same study, in 2021, the most recent full year of data available, nearly 6000 Californians died from a fentanyl overdose - a tragedy each and every one of them. There is, however, a newly affected group of people whose deaths from the matter have begun to climb since 2019: children.

In a recent California State Assembly Joint information hearing meeting, Fentanyl

deaths were marked at 81 tragic deaths in 2019. However, those numbers have skyrocketed to 230 adolescents and young adults ages 15-19 in just three short years. And perhaps, in a more tragic vein, they did not even know they had ingested it before they perished. These statistics are everywhere. According to the California Department of Public Health, non-fatal opioid overdoses have tripled in recent years, from 2018 to 2020, rising from 379 to 1,222. This sample group ranged from ages 10-19; in this same age range, opioid overdose fatalities rose 625%.

How is this happening? Within the last year, according to the Drug Enforcement Agency, there have been large swaths of

### **Chief Oversteps Politically**

On 9/13/23, El Segundo Police Chief Jaime Bermudez issued a press release regarding L.A. County's limit on cash bail. The press release was more of the same fear-mongering that Chief Bermudez spouted at the September 5th City Council meeting. Not only were the non-agendized comments made at the 9/5/23 Council meeting inappropriate and in potential violation of the Brown Act, the follow-up with a press release to the public essentially vilifying the County-wide policy change was an overreach of his authority as Police Chief. The press release contained misleading information, could only be interpreted as intended to conjure fear in the hearts of residents, and was a blatant political maneuver. Included in the press release was information for the public to use to contact L.A. County with "concerns related to the Zero Bail protocols". Chief Bermudez has improperly used his position as Police Chief to air his political views and attempt to rally support of the public he serves by using intentionally vague and inflammatory statements. LA County Superior Court instituted a zero-bail policy for many offenses during the pandemic. While some police officials argued those policies led to increases in crime, a report to the County Board of Supervisors last year showed re-arrest and failure to appear rates stayed relatively static during the period the policy was in place. Chief Bermudez is walking a fine line between ethical and unethical dissemination of information. City officials would be wise to reign him in.

### **Bail Reform Myths**

Police Chief Bermudez gave an unagendized (and therefore inappropriate) presentation on "zero bail" policies at the 9/5/23 City Council meeting. The public had no notice this important topic would be discussed. Troublingly, Bermudez and Councilmember Giroux asserted that zero bail means zero punishment for crime. This is incorrect. Bail is about pretrial detention – that is, incarceration while you're presumed innocent. Pretrial detention is not supposed to be punishment for crime; the punishment is the sentence you receive if convicted. That these two high-ranking officials don't understand this basic tenet of our system is highly concerning. LA County Superior Court's bail schedules reflect the empirical evidence that individualized risk determinations and tailored release conditions are more effective at reducing the risk to public safety than uniform cash bail schedules, which impose pretrial detention based on financial resources. No one wants their catalytic converter stolen and no one wants to see a local business robbed. But the data shows no correlation between these crimes and a no-cash-bail policy. Beyond promoting public safety, bail reform promotes our constitutional principles of liberty and the presumption of innocence, while recognizing that the failed policies of the last few decades have led to the overincarceration of people not convicted of crime (who make up over 51% of LA County's jail population). These pretrial detainees are disproportionately low-income and Black and Brown. Bail reform is complicated. The last thing we need is fearmongering and misinformation coming from the top as we try to figure out.

### Water Polo Gets Defensive



The items to be treated include: one 1-liter container of tetrahydrofuran, one 1-liter container of diethylene glycol dimethyl ether, and one 50-gram container of benzoyl peroxide.

The Clean Harbors Environmental Services (Clean Harbors) has been contracted to conduct the treatment. The chemicals are potentially reactive and unsafe for transport in their present state. The treatment involves the addition of liquid solutions to the containers to stabilize the chemicals. Once the chemicals are treated, they will be transported offsite for proper management. DTSC has determined that these chemicals pose an imminent and substantial endangerment to human health and the environment if not properly managed. Therefore, an Emergency Permit should be issued. This Emergency Permit is effective from May 24, 2023, through July 24, 2023. The Emergency Permit includes measures to minimize any adverse impact to the community and the environment.

**CALIFORNIA ENVIRONMENTAL QUALITY ACT** (CEQA): DTSC has determined that the issuance of this permit is exempt from the requirements of CEQA and has filed a Notice of Exemption (NOE) with the State Clearinghouse. 



### <u>Film Review</u>

### Shiva Baby is a Cringe-Worthy Comedy **About Millenial Anxiety**

In Judaism, "sitting shiva" is the week-long mourning period that is observed following the passing of a first-degree relative. In Shiva Baby (streaming on Max and Apple TV+), a millennial undergrad feels the same sort of deep mourning, albeit over the current state of her young life. When Danielle (Rachel Sennott) returns home from NYU to attend a funeral, she knows that she's also entering the lion's den of an overbearing family. The equal parts eager and concerned "How are you?" triggers her anxieties of her uncertain future.

Shiva Baby is such a refreshing and enjoyable new comedy due to how totally authentic

This hilarious suffocating experience n is controlled by the entire filmmaking team: Hanna A. Park's measured and then energetic editing controls each new wave of discomfort wonderfully. Maria Rusche's cinematography captures the jam-packed nature of this house (building to a near-hallucinatory climax that reminded me of Rosemary's Baby). And of singular note, composer Ariel Marx's score is quite actually the thing that stands out that gives Shiva Baby its anxiety-inducing identity, an off-beat tension that reminded me of Jonny Greenwood's score for Punch Drunk Love. All elements swirl to make for a cringe-worthy setting, which is pretty fun to see this all-

the characters and situations all feel. It's not altogether surprising, given that the film is based on the experiences and observations from writer and director Emma Seligman's own life, here making her directorial debut. Seligman's shrewd observations of the Jewish culture along with a new millennial identity make for a wonderfully cringe-worthy but very real culture clash. From the specificity of detail in the shiva setting and the hilarious characters who attend it, down to its stark portrayal of young people owning their newfound sexualities, Shiva Baby is the type of equal-parts defiant and personal filmmaking that make for the best kind of directorial debuts.

Shiva Baby smartly uses its single setting location to bring many elements of filmmaking together to control its tone-that being a cringeworthy one every truth that Danielle skirts only raise the stakes to becoming a pressure cooker of discomfort (halfway through the film when she bursts out of the house to get air, we are desperately grateful for it as well).



### The Best Cook in the World by Rick Bragg

Looking for a new audiobook to listen to during my commute to the library, I browsed our collection of books on CD. My eye landed on The Best Cook in the World. I had previously listened to several books by food writer Ruth Reichl ... I decided to take a chance on it. I am so glad that I did!

I listened to Rick Bragg's easy Southern drawl recalling his mother's exceptional ability to build satisfying meals despite their poor circumstances during his childhood. Subtitled 'Tales from My Momma's Table' gives the

listener an idea, but recipes are not the main event here. Author Bragg delves into his family history, intertwining Southern lore and home cooking, making the listener alternately laugh uproariously, wonder about the authenticity of those anecdotes and then, suddenly become tearful during an especially heart-tugging moment. Using colorful language that enhances mood, much of his recreations of long-ago stories are nothing less than poetic.

First conceived as a means to preserve his mother's recipes (she never read a cookbook nor did she ever write anything down herself), this project transformed into a collection of urban legends and possibly true reminiscences passed down since before the Civil War. Beginning with the legend of The Mean Old Man (Bragg's own great grandfather "Jimmy Jim"), who was on the lam when his son Charlie begged him to come home to teach his new bride Ava how to cook before he "starved to death."

Bragg details what life was like for plain folks in dire straits before, during and after the Depression in the wilds of northeastern Alabama and northwestern Georgia, in particular. People grew their own food and raised animals for slaughter. During harder times, they fished and hunted what they could find and added to their meager meals by foraging in the woods. There's a memorable account of Bragg's mother reciting her preparations for "poke salet" a wild (and toxic!) plant that proliferates in the South, especially along country roads and ditches. This "delicacy" should only be harvested at a certain time of the year, washed many times, cooked several more times... well, it's quite an undertaking.

Larger than life characters like "Aunt Sis" are memorialized, as in the tale of her chicken dressing recipe that's somehow tied to that time when she shot her husband in the teeth! There's the tale of government "commodities" (free cheese and such for the poor) being distributed that were celebratory events. On another occasion, Bragg's mother (as a child) was taken to a hobo dinner with her father and brothers. Oh, and there was the time Ava (Bragg's grandmother) actually turned a tornado away from their home!

Bragg's mother (Margaret) never paid attention to the measurements of ingredients. When he asks, she usually replies "Enough" or "a pinch" or "a smidgen ..." In the recipe for collard greens, 'what you will need' is "a mess" of greens. "How much is that?" he asks. "You'll know," she states.

When he recited the recipes at the end of each chapter, I was instantly brought back to memories of my own family. My parents were raised in Alabama and we traveled every summer to visit. Listening to his voice describing the Bundrum family's adventures and travails I realized that he and I have a shared history, which has moved me beyond words. •



### **City Council**

When Baldino told him that in "two-by-two" meetings, the only new items brought up for discussion between the city and school district was amending the length of time an agreement was good for, Giroux said, "Then that's sad because I've been making my feelings known on this topic for a very, very long time. And the fact that that wasn't discussed at your two-by-two is problematic for me." A short time later, he said, "The idea is to get it done and get it done right. There are very few pain points here. Like very, very few. It should never have gotten to this."

Pirsztuk wanted city staff to ask school district personnel if it's "viable" for the school district to take over the maintenance and scheduling of Richmond Field. She had noted earlier in conversation that Richmond Field has lights and Center Field, which the school district handles, does not, and that perhaps staffing by the district is related to that. However, it was also pointed out that Club sports teams play on high school fields with lights, and school district staff handles that.

City Manager Darrell George told the council the Richmond Field issue had been discussed with school district personnel. "I don't recall it being an affordability question," he said. Recreation, Parks and Library Director Aly Mancini told the council she thought it was brought up that keeping the Richmond Field under the city was a benefit to the community because it maintained "centralized scheduling," to which Giroux said, "But it's not centralized scheduling because we all cross beams when we're running these organizations (i.e., Little League, AYSO). It literally does not change anything for the user groups. It's just a matter of who they write the check to."

After the 3-2 vote to extend the existing agreement, Mayor Drew Boyles said, "It's good to see so much passion. Everyone cares a lot about this town. It's really good." Pirsztuk said, "But you know what, the history of the partnership, we've just now put cracks in that partnership. And I just want to make sure that we understand there are

part of the agreement, that's somehow our bad. There are a lot of threats up here about how the school district reacts to us when we question things. It's interesting."

Said Boyles, "I think it was a healthy discussion. I'm certainly glad we had it. It was well overdue in terms of both sides."

During Public Comment earlier in the council meeting Tuesday night, El Segundo High School student tennis players and residents told the council they did not want the use of the city's tennis courts taken away from the high school students. After hearing from close to half a dozen people speaking on this topic, Boyles told everyone nothing was being changed as it related to the use of the tennis courts. City Manager George concurred.

Also, during Public Comment, resident David Holop took issue with El Segundo Police Chief Jaime Bermudez's comments about bail in Los Angeles County and the upcoming changes taking place in October. Bermudez and council member Giroux had indicated there are "zero repercussions" to committing crimes given the way bail is being handled. Holop said there is data that demonstrates that there is no tie between the amount of crimes being committed in an area and its bail policies.

City Manager George delivered a report on progress at the Hyperion Water Reclamation Plant. He said that California Assembly Bill 1216 had passed the California Senate 26-7 on September 6 and now awaits Governor Gavin Newsom's consideration and signature. He noted that work on tank covers will last through the end of December and that this type of work could bring odors. Work will take place on weekdays from 7 a.m. to 5 p.m. and will be done on one section of a tank at a time.

The council also looked at possibilities for Rec Park, including making decisions on the three ball fields, Teen Center with a Teen Plaza, and the skatepark. They also heard more about specifics of the Downtown Specific Plan related to outdoor dining, parking, street closures, and building add-ons designed to entice business owners and visitors to spend time and money in downtown El Segundo.•






