# **State of the City: Business Vital to Residential Services, Quality of Life**

With a strong turnout of some 500+ people, the El Segundo Chamber of Commerce presented the 2022 El Segundo State of the City on Wednesday, Sept. 14, on the 7th floor of the Pacific Corporate Towers (PCT), 100 North Pacific Coast Highway. Mayor Drew Boyles set the stage for the State of the City presentation, providing live narration that accompanied prerecorded videos of the mayor pro tem and each city council member commenting on each goal of the city's Strategic Plan. As the videos played or the mayor spoke, audience members could get a closer view of the live mayor and the videos shown on larger screens throughout the venue. Chamber President Marsha Hansen welcomed guests to the chamber fundraiser, which included a buffet lunch by Blue Butterfly PCT. The event's best moment was an update on the city's ongoing dilemma with the City of Los Angeles' Hyperion Water Reclamation Plant and came from "Special Guest" and El Segundo resident Kelsey Chittick, who recounted firsthand how the community had supported her when her 42-year-old husband died suddenly, leaving her with their two young children, while also aiming for the city's neighbor to the west, Hyperion, and the ongoing odors emanating from it ever since a major plant emergency in July 2021. In recent action, the El Segundo City Council, now 14 months after the plant emergency, has declared a State of Emergency and will file a lawsuit to bring relief to residents impacted by the plant.

like (she and other residents aren't sure), Chittick, a comedian, inspirational speaker, and author, said, "There are people on it now. We appreciate it. Those who live here are very grateful that we are moving toward fixing this. So, leave on a note of hopefulness when it comes to Hyperion."

Following Chittick, Mayor Drew Boyles began the State of the City presentation on the city's five Strategic Plan goals. He called out and thanked those who had worked to save the city "over \$120 million over 20 years for this city by way of a pension obligation bond. Pension trust fund and other taxes

being taken to improve pensions, including having our employees help pay-in the past, they weren't paying-for pensions, at least several groups." he noted that the city treasury has grown from \$90 million to \$120 million since 2016. He highlighted the new Top Golf facility, the Los Angeles Chargers NFL team headquarters, and L'Oreal's new West Coast Headquarters in the city, noting that the El Segundo Top Golf is "neck and neck with Las Vegas Top Golf, and it "only took a decade to get it done and we're so happy it's there." He noted that the Chargers

# **El Segundo City Council Addresses Hyperion, Smoky Hollow Pilot Parking** Program, Senior Housing, New City Sign

Hyperion, a man who evaded police, parking in Smoky Hollow, the new city gateway sign, facilities and equipment joint use agreement with the El Segundo Unified School District, a new residential soundproofing program, senior housing funds, and the upcoming year-long upgrading of El Segundo Boulevard were all topics presented to the El Segundo City Council during its regularly scheduled meeting last Tuesday night.

El Segundo Police Chief Jaime Bermudez delivered a public safety update in which he said a man who had eluded police in a May incident on Center Street

near Walnut Avenue has been located and identified by detectives and is currently in jail. The case will be presented to the District Attorney, said Bermudez, who noted the man is facing multiple charges. He also said the police department is authorized to have 62 officers and currently has 60, with three in field training, three in the police academy, and three in "injured on duty status." He noted that the department currently has 15 officers who could potentially qualify for retirement in the near future. When asked by Mayor Pro Tem Chris Pimentel if there was anything he needed, as in council See City Council, page 6





# Luc Giroux Leads Eagles to Water Polo OT Win



Palisades had one last possession after an El Segundo turnover, and David Hazany's last-second shot found the net for a Dolphins 7-4 halftime lead.

The second half would be a different game on both ends. El Segundo's defense continued to pressure the Dolphins' attack, and Eagle goalie Luc Giroux had three of his 12 saves in the third quarter. Max Hale closed the gap with a score inside. With 4:48 left, Eastman found Hale open on top, who capitalized and scored to make it an 8-7 deficit.

The Eagles forced Palisades into seven

Ward said her team's slow starts are due to their experience. "They are prepared; they just don't realize how good they are yet, and that seems to lead to our slow starts." Palisades took an early 4-0 first quarter before the Eagles rallied for a 13-12 overtime win.

Trailing 4-0 to start the game, El Segundo scored their first goal with a shot by Tristan Foster to cut their first quarter deficit to 4-1. El Segundo's offense came alive in the second quarter and cut the Palisades lead in half. Carter Williamson passed to Logan Eastman inside, who fired it past Dolphin goalie John consecutive empty possessions in the fourth quarter, with El Segundo trailing 9-7. Giroux continued his stalwart effort with three saves and shut out the Dolphins in the final quarter. The Eagles had a number of shots but couldn't find the net, and turnovers hampered their attack. With time running down, Palisades had one final possession. David See Sports, page 15



perhaps authorizing an excess of officers so that the department would not be deficient in staffing at any time, Bermudez said that was not necessary and that a detective had been temporarily reassigned to help the personnel sergeant with hiring. He noted the department is actively recruiting and mentioned recruitment signs posted on Main Street and Pacific Coast Highway.

Also, before moving into the meeting agenda's consent calendar and other items, City Manager Darrell George provided an update on the city's actions on the City of Los Angeles' Hyperion Water Reclamation Plant, which abuts the city on the northwest and sits between the Pacific Ocean and El Segundo. The city has fielded 1,100 odor complaints since Hyperion's emergency in July 2021 that sent sewage into the ocean and caused major flooding and damage throughout the plant. Earlier this month, City Council declared a State of Emergency related to public health. It okayed the pursuit of a lawsuit against the City of Los Angeles due to the ongoing impacts residents are experiencing due to issues with the plant. George noted that the declared emergency gives the city manager certain authority to act immediately and provides the city access to state and federal funds. He and City Attorney Mark Hensley said they anticipate dialogue with the City of LA's attorneys before filing a lawsuit. Hensley noted the city had previously filed a lawsuit against Hyperion 27-28 years ago. He did not elaborate on the outcome of that lawsuit. George was set to meet with the Vice Chair of the South Coast Air Quality District on Wednesday and said city staff is reaching out to media, mayoral candidates for Los Angeles, and District 11 candidates since Hyperion is in their district. He said staff had "really ramped things up" since the council's decision to declare the emergency and pursue a lawsuit. It was noted that SCAQMD does not have "specific authority" to force Hyperion to install air quality monitors but that SCAQMD is monitoring the plant's compliance with a recent abatement order that has been published with more hearings "to come about violations at the plant" by SCAQMD. Council member Carol Pirsztuk noted Hyperion is "hard to shut down" because it is a public facility. Responded Hensley, "I know, part of the other issue is, people made this statement that it's, I don't want to say it's too big to fail, it's too big to close down, and this is part of what I see the board wrestle with, okay? They would shut down if it was a smaller enterprise. Even if it were a public agency doing something wrong, it would be forced to shut down. They don't know what to do because they can't force it to shut down. I really feel that that's a huge, um, that their hands are really tied because of that. And they know the fines, to the extent they get fined, that Hyperion will just pass those along to the ratepayers, so they feel like they are just punishing the people paying for the service. And they've said that during these meetings. This is a real problem for them."

In related news, the council also discussed the Imperial Sewer Flume and Sand Hill Sewer Flume Rehabilitation Project after it was pulled from the consent calendar by Pimentel. He called out how the "numbers did not make sense" and "defied comprehension to us" when the city first saw the numbers indicating the level of sewage the city was generating for the plant. In response, the city had replaced meters in sewer lines, and city staff said the issue is, for the last few years, what we can do. See if there is room to negotiate and talk to Hyperion. These meters, which are now accurate after a year of reading, are intended to compare the two sets of numbers from before and after the

Another item pulled from the consent calendar for discussion was the El Segundo Boulevard Improvement Project. Pirsztuk asked when work would begin, and in answer, the city's Public Works Director Elias Sasson calculated that construction would begin "maybe spring 2023" with 160 working days for completion, resulting in about a year of work. Pirsztuk asked him to notify the Chevron Refinery and Continental Development staff, which are located on or have an interest in the main city thoroughfare that runs from the 405 freeway to downtown El Segundo. Pimental noted that the project had been "cost neutralized" due to funds secured from Prop C and Measure M "almost exclusively," said Sassoon, adding that some "other reserve funds" would be used in addition to the \$4.5 million grant. Mayor Drew Boyles explained that participation by himself and the mayor pro tem on the South Bay City Council of Governments had contributed to the city securing the funding, adding that it's "very competitive to get these funds." He encouraged the city council to continue its involvement on the SBCG's board.

The suggested pilot parking program for Smoky Hollow drew many council comments between the three council members who did not recuse themselves. Boyles recused himself. He owns property in Smoky Hollow and Pimentel because his employer has a property interest in the area. The first pilot parking program addressed El Segundo Blvd. and added parallel parking. The pilot did not go well, with the council directing it to be discontinued in May 2021. The new and second pilot program before council calls for changing two-way traffic on Nevada Street and Oregon Street in Smoky Hollow from El Segundo Blvd. to Grand Avenue to one-way traffic with 45-degree angled parking in a former traffic lane. Council member Lance Giroux said he didn't see what problem the proposed pilot parking program solved and that it put a "band-aid over it." Council member Scot Nicol called it "a step in the direction to the future vision of the Smoky Hollow plan," which was developed in 2017, and called it "a step in the right direction." He advocated for adding California Street to the pilot program. Giroux said, "Again, all I'm seeing is we're building, we're spending x amount of money to put angled parking on areas where businesses are at, and by the way, this was before the pandemic, before COVID, before all this, so the number of people coming into the office, all that has changed, so we know that. So, if the idea

is to help get more parking within the city for people to utilize, I'm just not seeing how this current plan for this pilot program gets us there," noting "it's taken five plus years to get us here." Nicol then explained how current residents (on Kansas and Washington streets and Franklin) are impacted in the area due to longtime businesses that do not have space to park employees on site. Giroux then said that because the council was not allocating money yet, he was okay with moving forward. The three council members then added California Street to the pilot program.

The council gave discussion and unanimous approval, 5-0, to extend the current joint use agreements, which expire this month, with the ESUSD to allow time for more discussion for a new agreement.

Council also approved a two percent parking fee increase for Park Vista, the city's senior housing facility, and heard more about how the city's 504 funds can be used. Their historical intent was related by residents at the time the fund was established, and its use was voted on by residents who elected it to go to senior housing in the city. The council stopped short of Park Vista's request for formally dedicating the 504 funds solely for the use of Park Vista, though it is the only senior housing in the city. The city's Chief Financial Officer Joe Lillio recommended that the city keep the funding in the "Senior Housing Fund" to give future councils flexibility, adding that he doesn't foresee another senior housing facility being built in the city so for "all intents and purposes" the money is used for Park Vista upon approval from city council. Council also approved upgrading new tenants from January 2023 to a charge of 65 percent of the rental market rate. Boyles said he would like to see Park Vista's projected \$3.5 million in capital improvements accelerated.

As for a new city sign to greet people at the corner of Imperial Highway and Main Street, the council voted 3-2 to have the landscape architecture firm, currently under a \$103,000 contract, move forward by supplying the council with some iterations on the sign design. Pirztuk and Nicol dissented. Pirztuk said, "It just seems like we're paying a lot of money for something that just doesn't seem attractive." The sign cost is roughly \$422,000 with funds from the Arts and Culture Committee. The City council agreed with Sassoon that the committee should receive a briefing before city staff returned to the council to request advertising for the project's construction. Pimentel asked for a timeline.

At the conclusion of the meeting, Boyles announced that Nicol's father Scot S. Nicol had passed on September 6 at the age of 67.







had broken ground on their \$100 million headquarters and that L'Oreal has 18 brands.

The biggest reveal of the event came toward the end when Boyles explained that "98 percent of this town's revenue comes from business. So it's incumbent upon us to continue to grow our economic base." He said residents "would not have our independent police, independent fire, independent public works, libraries, you name it, without our business community."

Said Boyles, "Stimulating business growth in town is essential to long-term fiscal stability for El Segundo," noting that the city council is determined to maintain a balanced budget "while prudently building strong reserves for the future so that the community will continue to receive the very best in services and programs."

The State of the City presentation honed in on the city's "Five key goals of the city's strategic plan, which focuses on providing the highest level of service to our city's residents and businesses."

Goal One: Enhance customer service, diversity, equity, inclusion, and communication.

Goal Two: Support community safety and preparedness.

Goal Three: Promote a quality workforce through teamwork and organizational efficiencies.

Goal Four: Develop and maintain quality infrastructure and technology.

Goal Five: Champion economic development and fiscal sustainability.

Mayor Pro Tem Chris Pimentel filmed his video at the UCLA Health Training Facility, home of the Los Angeles Lakers NBA team, and noted that "whether you're a worldchampion organization like the Lakers, a small business, a student, a retiree, a veteran or just the backbone of this community that our involved members are, we want to make sure that you are valued and understand how critical you are to the success of this city." He addressed Goal One.

He noted that the city council had "listened" in 2020 and created a nine-member Diversity, Equity and Inclusion committee. He pointed out that the city is committed to timely communication via its websites, social media platforms, community cable programming, emergency alerts direct to your phones, and public service announcements, saying, "Community engagement, proactive transparent communications are critical to serve the community and increase overall awareness and understanding."

Boyles then remarked about the schools in El Segundo and their top quality, saying he is "Excited about everything coming out of our schools." He also noted that the city has been working to enhance communications across multiple channels and that "Since May of 2020, we've seen over 1.6 million page views to our website," in addition to growing "our email database to over 21,000 people" and that the city's social media platforms have received "over 100,000 impressions in the last year." He also called out the city's Net Promoter Score of 55 for business, noting that Apple's score is generally 65. Boyles said the city also uses the qualitative comments from the NPS survey to help guide its strategic plan every year. He noted that the city has a Poet Laureate (the city's first-ever), Hope Anita Smith, an experienced and award-winning poet, writer, collage artist, and educator who that recently promoted Police Chief Jaime Bermudez has been with the city's police department since 1992. He said that "17 percent of sworn police officers have been promoted since 2020" and that they had "367 applications for police officers in 2022. Clearly, people want to work with the city of El Segundo."

He noted that El Segundo PD Officer Kristoffer Eszlinger recently had been awarded the South Bay Medal of Valor for

will serve through December 2023. It held its first Festival of Holidays last December, which included Indian dancing, Japanese drumming, music from and stories about Kwanzaa, Christmas, winter, Hanukkah, an African drum circle, traditional Mexican folk dances, and participation in dance and music from the El Segundo High School Symphony Orchestra and other local youths. The city plans to hold the event again this December. And in other news, Boyles noted that the Los Angeles Kings NHL team donated \$75,000 to rebuild the city's roller hockey rink.

Council member Carol Pirsztuk, who addressed Goal Two, filmed her clip at the Toyota Sports Performance Center, home of the LA Kings for over 20 years, noting that worldclass athletes train in El Segundo, making it important for all visitors to feel welcome and safe. She cited the city's "continued investment in hiring, training, technology, coupled with the hard work of our men and women in uniform," as being "what attracts families and businesses seeking a safe place to grow." she said, "The safety and well-being of the El Segundo community is the city council's top priority, as well as "treating all people with dignity and respect. El Segundo is proud to be a place where residents, businesses, and visitors feel safe and protected."

Boyles then addressed the attendees, noting

his life-saving efforts. That the city has the first female fire chief in the South Bay in its recently promoted Fire Chief Dena Lee, who also put on a "Fired Up Girls Empowerment Camp" so girls and female teens could see the possibilities of a firefighting career. The girls at the camp worked hoses and climbed ladders, among other tasks related to being a firefighter. Boyles noted that 23% of the city's sworn firefighters have been promoted since 2020 and that the city capped fire department applications at 150 (otherwise, they would have had a huge number to sort through) recently when they hired two new firefighters.

Council member Scot Nicol dubbed a "homegrown El Segundo leader by Boyles during the intro to Nicol's video clip, was stationed at Brett Field (formerly Pine Field) for Goal Three. He reviewed recent activities and improvements the city is making to ensure staff is a teamwork training and commitment model. To that end, the city recently asked city employees, "How do you feel about working here and what do we need to do better?" said Boyles.

Council member Lance Giroux addressed Goal Four at the construction site of the new LA Chargers headquarters and practice facility. He noted that this is the "type of world-class investment happening in El Segundo right now" and that the city continues to invest in streets, parks, landscaping, and recreation facilities to ensure its reputation as a city with a high quality of life for its residents as well as a safe and welcoming city for its businesses and visitors.

Boyles noted that the city council has approved \$5 million toward a "new Teen Center, a much-needed revamp of our skatepark, basketball courts, ball fields, irrigation, lighting, sports courts." He said the city works with an \$80 million annual budget in its general fund but has \$60 million in capital improvement projects left to do. He said the city's historic swimming facility dubbed "The Plunge" was first built as part of the New Deal after the Great Depression, calling it "one of our beautiful heritage properties." He promised the facility would be brought back and made functional while keeping its historic design elements and that the city has received \$1 million from the El Segundo School District and \$500,000 from Chevron for the \$4.5 million Plunge renovation project. He also noted that in a year, the city has resurfaced 2.4 miles of road, constructed 600 linear feet of new sidewalk, and repaired 77 sidewalk locations.

Boyles also addressed the Hyperion debacle, saying, "The reality is we had a pretty terrible spill 14 months ago." The city has received 1,100 odor-related complaints in 14 months, the water board issued a notice of violations to Hyperion, and the South Coast Air Quality Management District has issued 13 notices of violation and three abatement orders, but "still the odor problem exists." He said the city opted to file a lawsuit because "We have to protect our residents and our businesses." He also thanked resident Corrie Zupo, a trained environmental engineer who used to work with AQMD, for all of her assistance. He noted that the city had joined the California Green Business Network, passed a single-use plastic ordinance, and improved the city's recycling program with Cal Recycle. He said, "Maintaining quality infrastructure is critical to attracting top employers."

Boyles calls El Segundo the "Most important five square miles economically in Southern California" and said that new developments are constantly underway. The city's vibrant economic base includes startups, biotech giants, media, and professional sports organizations.

He also offered one of the reasons why El Segundo might be so attractive to employers, telling the story of a new startup in the city. When asked why he selected El Segundo, he told Boyles, "I built an algorithm to scrape LinkedIn and look for the highest density of highly trained engineers per square mile on the West Coast." Boyles asked the crowd, "Do you think Silicon Valley came up first? Nope. El Segundo. There are over 800 Phds at Aerospace Corp alone, right there," adding, "We have the intellectual capital." •



John Pickhaver: I'm a millennial renter who lives in an apartment with his boyfriend and two cats that we rescued on the street from the innards of a 2007 Toyota Corolla. Not certain, but I don't think we've had such a combination on our Council in the past. Aside from these highly-specific items, what makes me stand out is the fact I've been speaking regularly at City Council meetings over the last few years in an effort to bring about meaningful change and greater representation in town. In June 2021, I successfully called on the City to proclaim June Pride Month in El Segundo and to illuminate our iconic water tower in rainbow lights in support of the LGBTQ+ community. It's now an annual tradition. As a City Councilmember, I will carry these values of inclusion and belonging with me in every decision to help bring out the best in El Segundo.

Chris Pimentel: We are fortunate to have very smart, involved, candidates for the council. While serving on the City Council I've been involved in numerous, complex, decisions. From negotiating the Top Golf lease, to managing the pandemic, responding to Hyperion and shepherding the reconfiguration of Nash St and Park Place, it has been a blistering four years. Elected officials in the region selected me to chair the Coalition of Governments' Transportation Committee as well as lead our delegation to LA County Sanitation. What I believe sets me apart amongst the candidates is my proved track record of accomplishing tasks in a thoughtful manner for the city.

#### What important issue affecting El Segundo has fallen under the radar, and what would you do to address it?

Ryan Baldino: Falling under the radar is a conflict with Sacramento around housing. We don't talk about it much because it doesn't affect us now but certainly will without push back. State legislators continue to pass laws that take control away from local towns, like the recently passed Senate Bill 9 which allows the division of a single-family lot into two separate lots, and then permits two houses to be built on each lot. This means a property intended for one dwelling could have 4, dramatically changing our neighborhoods and their charm, density, and ease of day-today living. I am motivated to carefully work towards an answer that preserves our small town character, while figuring out residentdriven, home-grown solutions to address the lack of affordable housing for current and future citizens. I look forward to talking with you more about this and other issues impacting El Segundo.

Michelle Keldorf: From updates to the Teen Center, the Joslyn Center and the sports courts at Recreation Park to aging public infrastructure, we have many capital projects to address. Maintaining our public amenities, updating our water and sewage systems and ensuring our roadways are safe is essential to the continued enjoyment and livability of our community. Deploying the funds allocated to projects efficiently and in real-time is key. Without timely action, the scope and cost of these projects can increase exponentially. Similarly, rather than relying on consultants to chart our course, I support a return to the expertise of residents volunteering their time on Commissions and Committees. These appointees often have direct experience whether it be in environmental science,

facility management or human capital. City staff and city leadership can use them as a cost-effective resource.

**Robin Patch:** No answer was provided by Robin Patch.

John Pickhaver: From the Hyperion Disaster to Affordable Housing to Property Crime, El Segundo faces many challenges. But an important issue that falls under the radar is Pedestrian Safety. We regularly hear about accidents or close calls in town due to inattentive or careless drivers or electric bike riders, but there's never enough done to fix the problem. Having been hit by a car while running on Franklin Ave - you know the street where there may or may NOT be a stop sign at the next block - this issue resonates with me. Fortunately, it's a problem we can solve by taking swift, deliberate action. We need more four-way stops and more crosswalk illuminators, along with a public education campaign laying out safety guidelines for e-bikes. Further, I would seek input from the community and our public safety departments to find even more ways to ensure a safer pedestrian-friendly environment here in town.

Chris Pimentel: With so many critical issues affecting El Segundo - particularly air quality and public safety - it seems odd to say that LAX has fallen under the radar, but it has. The insatiable desire to grow that airport, accommodate larger aircraft, and unwillingness to distribute cargo flights throughout the region, all have enormous impacts on our quality of life. It is critical that the city stays engaged with Los Angeles World Airports and holds them to the terms of our settlement and continues to press for cargo relocation. We cannot sit idly by while their growth plan chokes our roads and their workers park on our streets. I led this effort previously and if re-elected I will continue to do so. •
