She Wants to Support You in Your Learning

I had one regret the day after interviewing Rose Ahrens and walking with her at Center Street Elementary School, where she is the Principal. I should have asked how she got her first name. After all, a rose is often memorable, impressive, and a force of nature. A rose is a symbol, a topic of art, a very sturdy plant, which comes in various shapes and sizes but is often unique, if not incomparable.

Rose, as noted, is the Principal of Center Street Elementary School in El Segundo. She started there a year ago. There are two very apt handwritten expressions on the front door of the school: *“In A World Where You Can Be Anything, Be Kind,”* and *“Be The Change You Wish To See In The World!”*

Rose had an outstanding background to become the principal -- 25 years with the Manhattan Beach Unified School District. She began as a teacher’s aide, earned her teaching credential, taught elementary school at Robinson, job shared at Pacific, took a two-year hiatus to work in the family business, but had “that itch,” wanted to come back, and went on special assignment for literacy. She would obtain her administrative credential, then become Assistant Principal at Manhattan Beach Middle School and ultimately its Principal. Phew! She stays very busy indeed.

“I love teaching, and I always knew I would be a teacher, but what drives me is my passion for learning. Not just my own learning, but learning for all. My greatest impact on the classroom is through teachers, and I do all I can to support them and push them to continually refine their craft. When teachers feel confident about what they’re implementing in the classroom, students are

the ultimate beneficiaries of that hard work, collaboration, and professional development.”

Given that Rose was in the Manhattan Beach Unified School District for over two decades, my reaction is that it may not have been the smoothest transition for her to become Principal of a school in the El Segundo District. True, Manhattan Beach is adjacent to El Segundo, but these are different and distinct Districts.

I can indicate here that Rose Ahrens has risen to the challenge. Sitting and talking with her, then walking the very nice Center Street campus with her, is comfortable and enjoyable. As we walked, several kids stopped, smiled, laughed, and showed Rose what they

The Future of California’s Voice on Capitol Hill

On September 29th of this year, Diane Feinstein passed away after serving 31 years in the Senate of the United States. With the news of her death, the role to fill her vacated seat was left to Governor Gavin Newsom. There was little deliberation concerning the shortlists and after three days, he tapped Laphonza Butler. Even with her taking the long-held seat of Dianne Feinstein, there are a lot of questions circulating the political sphere as now a new challenger has entered the fray for such a hotly contested seat. Currently polling at the top of the race, and even before Butler was tapped for the interim role of Senator for the state

of California, are Representatives Adam Schiff of Burbank and Katie Porter of Irvine. With these massive changes to the upper echelon of representation for California, the state looks north to Sacramento as an already vigorous competition had even more life bestowed upon it.

Even before Senator Feinstein had passed, there was an embittered race between leaders Representative Katie Porter from Irvine and Representative Adam Schiff from Burbank. Rep. Schiff is currently polling at around 20% support from likely voters and Porter at 17%, according to a study survey conducted by UC Berkeley, co-sponsored by The Los Angeles Times.

14U Girls Claim NSA Western National Championship

El Segundo is well known for its baseball success. It was magnified with the recent Little League World Series title the El Segundo Little League All Stars won. But not lost in all of the hoopla surrounding the World Series champs is a group of thirteen softball players. The 14U girls' softball team had an incredible run to win the NSA Western National Championship.

Like the Little Leaguers, who played for three years together, these girls rose out of the pandemic. Since the pandemic hit, they have played over 270 games together, traveled over 14,000 miles, and won 170 games. Together, they crossed 10,000 miles in 2020/2021, including trips to Utah, Nevada and Iowa. In 2022, they represented El Segundo Girls Softball all-stars in the 12U division. They placed sixth at the SoCal State Championships, then qualified and placed ninth at the NSA Western Nationals. This season, they moved up into the 14U division and played in many different tournaments, winning several.

The NSA, which stands for National Softball Association, is the governing body that runs national region tournaments, including ones that are played in Southeast Region-Florida; North Region - Indiana; Central Region- Kentucky; and the Western Region that was played in Modesto/Stockton. No current tournaments would bring together all four National Region winners to play for a true National title.

El Segundo advanced to the Western National Region tournament by winning several local tournaments, including one in Bakersfield, to advance to the state tournament. At the California State championship tournament in Palmdale, the team went 6-1 overall and scored an 11-3 win in the finals. Head coach Steve Cleland said the defense showed how strong they were. He said he knew they could score, but it was the defense that was impressive. They outscored their opponents 55-12 in the seven games they played.

To prepare for the Western Region National championship, the team played in one of the country's biggest tournaments in Colorado. The team competed well, did some fun things like white water rafting, and walked on the infield at Coors Field the home of the Colorado Rockies.

El Segundo traveled to the Western Region National tournament in Stockton in a 15-passenger van they decorated as the Eagle Mobil. The team stayed at the Marriott and was treated like royalty. Playing in the sweltering

90-degree weather was not a deterrent, and the team showed they were there to win it all. Coach Cleland made sure his team stayed focused, and the team responded.

El Segundo maneuvered through the double-elimination tournament undefeated to reach the finals. The team they faced, the Firecrackers, was on a roll. They had battled back from a loss in the first round of the double-elimination tournament and were now in the finals. The Firecrackers scored three first-inning runs on a walk, a single, and homerun, and they grabbed an early 3-0 lead. Coach Cleland and his coaching staff calmed everybody down and reminded them they had been down before. "We just needed to play our game and chip away at being down so early."

In the second inning, Ell Sabosky singled with one out. With two outs, Dani Benjamin singled, and Jazzy Sigaran drew a walk. The stage was set for the youngest player on the team, Maddie Ferrier, to step up to the plate. She clobbered a fastball for a triple to right center that cleared the bases and tied the game at 3-3.

The teams went scoreless until the fifth inning. Dani Benjamin drew a walk to start the inning, and Jazzy Sigaran bunted her over to second base. Ferrier followed with an infield single, and Kathleen Lane drew a seven-pitch walk to load the bases. With two outs, Ava Waters hit a two-run triple. El Segundo scored on a passed ball to increase their lead to 6-3 heading to the sixth inning.

The Firecrackers mounted a three-run rally on the strength of four singles and an untimely El Segundo error to tie the game. Jazzy Siagaran stopped the rally by getting a strikeout with the go-ahead run on third base. El Segundo went in order in their half of the sixth inning, forcing extra innings.

In extra innings, the team batting starts with a runner on second base. The Firecrackers took advantage immediately with a run-scoring single. But Siagaran got out of the inning by striking out the next batters and induced a routine fly ball.

Trailing 7-6 in the bottom of the seventh inning and Sadie Gramajo, the runner at second base, Siagaran's RBI single tied the game, scoring Gramajo. Then Maddie Ferrier singled, and with runners on first and third base, Maya Bonner hit the first pitch for an RBI walk-off single, giving El Segundo an 8-7 win and the NSA Western Nationals Championship.

In winning the NSA Western Nationals Championship, El Segundo went 5-0 and

Steve Shevlin: The Community's Coach

Coach Shevlin was selected to be the Grand Marshall at this year's Homecoming Game. Here is a brief overview of this amazing career in El Segundo.

After graduating from Culver City HS in 1981, Steve Shevlin began coaching at his alma mater in 1983 as a WR/DB coach for the Centaurs and coached there until 1989, when he was hired as an English Teacher/assistant coach at El Segundo HS.

Coach Shevlin took over the head coaching reins at El Segundo in 1994 and embarked on his career-long path for the Eagles. And while the program struggled in his initial years (where he went 1-9, 2-8 his first two seasons), he was instilling pride and excitement in the program that was infectious with the athletes he coached.

With the help and guidance of great mentors like John Stevenson (ES's legendary Baseball Coach), Steve Newell, Craig Cousins, Gene Engle, Dan Heck, and Rick Sabosky, the Eagles began to turn the corner in 2000. From that year to 2019 (when Coach Shevlin resigned from Football), The Eagles posted .500 or better overall seasons in 17 of those 19 years and reached the CIF Playoffs 15 times.

As the Eagles built momentum, great players helped steer the program to unprecedented heights. Matt Engle QB (2002) was named the State Player of the Year for Medium Schools, Jamie Stewart (2013) was named the CIF Scholar-Athlete of the Year, Lars Nootbaar QB (2014 and currently in Major League Baseball) led the Eagles to their 1st ever CIF Finals appearance in 2013. Seven players earned Cal-Hi All-State Honors - Matt Engle QB, Gage Mortesen RB/LB, Nigel Nootbaar TE, Austin Brasher LB, Jamie Stewart WR, Lars Nootbaar QB /Taz Tauaese RB.

Forty-six players earned All-CIF honors during Coach Shevlin's tenure, and countless more All-South Bay and All-League honorees.

During his tenure, Coach Shevlin set school records for Wins (157), Playoff appearances (15), League Championships (6), CIF Semi-Final Appearances (2), and CIF Final Appearances(1). Coach Shevlin was named the 2013 South Bay Coach of the Year and Coached the "Blue" Team 4 times in the South Bay All-Star Game (winning three times).

In 2023, Coach Shevlin was honored by the Southern California Football Coaches Association with the Clare Van Hoorebeke Award for defining excellence and making

significant contributions to high school football in Southern California.

Also in 2023, Coach Shevlin was honored with the CIF Southern Section-Champions for Character Award- exemplifying the CIF Southern Section Pillars of Character, Sportsmanship, Integrity, Positive Relations, Respect,

and commitment to the rules of the game.

Coach Shevlin has also served as Athletic Director from 1999-present, helping direct the Eagles to 17 CIF Finals appearances and 14 CIF Championships. He served on the CIF Football Advisory Committee for ten years (2008-2019), was an assistant baseball coach for 14 years, and served as interim Head Baseball Coach in 2013.

This moment is shared by many people who supported Coach Shevlin in this lifelong endeavor. Robin Espinoza, Patricia Guzman, Rainy Smith, Dana Lund, Billy Traber, Shawn Green, Megan McCann, Gregg McMullin, Steve Eno, Tiffany Pinier, Darin Glotz, Tiffany Masisonet, Lori Mendoza, Gianna Summers, Gigi Thompson, Casey Gardener, Tim Duerr, Tyler Murray, Chris Doukakakis, Jeramie Stewart, Nick Kessler, Jason Parker, Chuck Shaffer, Bobby Brackman along with a supportive Administration led by Jim Garza, Newton Hart, Tomas Romo, Ali Rabiei. These people were the backbone of the behind-the-scenes successes, and this continues today with Principal, Steve Gebhart, Alyssa Reyes, Julia Straszewski and Ashley Richmond.

Foremost and most importantly, none of this would have been possible without the unwavering support of Coach Shevlin's Family - his wife, April, and children, Cassidy and CJ. "I thank God every day for my family and their willingness to support me in such a great endeavor. Positively impacting young men's lives and representing our school and community has been the honor of a lifetime."

Film Review

The Mission Explores an Evangelical Christian's Fatal Sermon

The Broadway musical "The Book of Mormon" is highly praised for its tongue-in-cheek mockery of well-meaning but ignorant religious zealots. As the story goes, a young and naive Mormon missionary enters into unwelcome territory with his Godly paraphernalia in hand, determined to convert an entire Ugandan tribal community into followers of the Church of Jesus Christ of Latter-day Saints. The musical is outrageous, flamboyantly exaggerated, and makes for the perfect date night activity. However, after American missionary John Chau died during an attempt to proselytize his beliefs to the isolated and highly unpredictable Sentinelese tribe, the plot of the silly musical that felt so farfetched suddenly feels

Emmy-winning directors Jesse Moss and Amanda McBaine (Boys State) bring the tragic story of John Chau's fatal sermon to the screen in The Mission, opening in select on Friday, October 13. In 2018, John's death made headlines around the world when he was killed with bows and arrows at the hands of the Indigenous people who live on the remote North Sentinel Island. The Sentinelese are widely considered to be among the most vulnerable and dangerous in the world, and history has shown that they don't take kindly to foreigners entering their territory. John saw these obstacles as all the more reason to venture, illegally, to the remote island. He viewed the Sentinelese as victims of Satan's last stronghold, and he was determined to be the one who could convince them to follow God and was willing to die trying.

The backbone of the documentary relies on John's posthumous diary, which was turned over to his family after his death. Journal entries are read aloud by a voice actor who captures John's wide-eyed optimism and free spirit mentality. "If God is for you, who can be against you," he writes—an eerie foreshadowing of how his false sense of security put him in a deadly situation. Interviews with his family and friends tell a similar story of a young man who was adventurous, self-sufficient, and deeply committed to his church. Limited archival footage also means that the dependency on video archives is crucial, and animation is used to depict scenes that could otherwise not have been shown.

What makes John's story all the more heartbreaking is his unintentional arrogance and assumption that he was invincible under God's eye, which turned his final sermon into a self-inflicted suicide mission. Experts and religious leaders comment on the fact that "people who exist out of time"—much like the Sentinelese—is a seductive narrative to Westerners who feel compelled to push their beliefs and societal structure onto them. But not everybody needs or wants "saving."

On one hand, John's Evangelical Christian faith gave him purpose. On the other, his dedication was responsible for his death. The filmmakers bring up both sides of this conundrum, making it difficult to confidently place blame on any one person. Was he brainwashed into thinking he could actually save these people? Did he literally believe he was a messiah? And if so, did the church encourage these delusions? John's story is harrowing because of how unavoidable the outcome could have been, making The Mission a fascinating albeit heartbreaking watch.

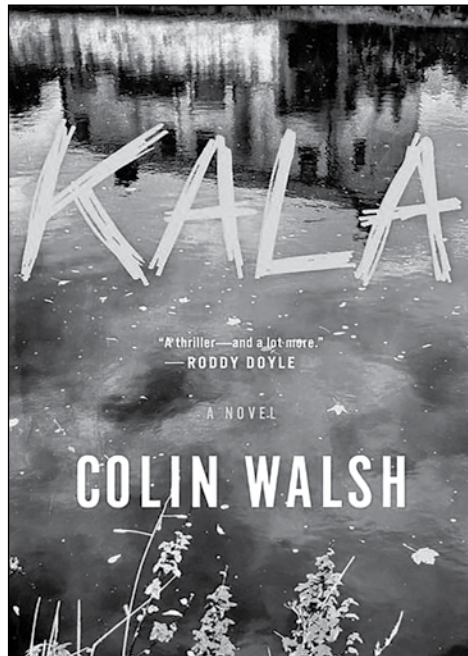

Set in a small tourist town on the west coast of Ireland, this sprawling tale of friendship, family, greed, and vengeance is also a sort of coming of age cautionary. Toggling

between the years of 2003 and 2018, we witness the bonding of six fifteen-year-olds from four established local families - the Brennans, Lanaans, Laughlins, and Lyons. Joe, Mush, Aiden, Aoife, and Katherine, called Kala, grew up in Kinlough while Helen has only just returned to her father's birthplace with her father and sister after the death of her mother.

In 2003, Helen is a bright, rebellious teenager, unmoored by the death of her mother. Kala and Aoife are fast friends who befriend Helen. When they all attend the Disco, the three boys and three girls become an inseparable group. Navigating through their teens, they drink, smoke, skip school, and chase trouble. Although they are devoted to each

other, factions form and resentments arise. Mush is the silent, loyal friend who enjoys hanging out with the girls. Joe and Kala are enthralled with each other. Aiden becomes increasingly distant and troubled. Aoife is jealous of the growing closeness between Kala and Helen. The summer of their sixteenth year ends in the tragic disappearance of Kala.

It is now 2018 and Mush has never left Kinlough, still working at his mother's shop while living at home. He has lived a quiet, reclusive life on the perimeter. Joe is the hometown boy made good, a worldwide superstar and famous musician. He has come home to open a bar on his old stomping grounds. Helen has returned for the wedding of her father Rossie to Pauline, Aiden's mother, and Mush's aunt. Kala's loss has embittered Helen, who is a freelance investigative journalist in Canada. Her insistence on discovering what happened to Kala draws them all into a spider's web of lies, corruption, violence, and murder.

were doing. Various people waved, nodded, and smiled. Teachers welcomed us, even as we suddenly just peered into their classroom.

Bottom line: You can tell when people are glad to see someone when they have a comfort about that person, a rapport. I could tell that Rose Ahrens, Principal of Center Elementary School, is, well, a rose.

The campus itself is sizeable, and every corner is used by the 800+ students there. There is a music classroom, Project Lead the Way classroom, literacy classroom, library, and garden, each with a teacher/librarian dedicated to that topic.

Of course, there are teachers at different grade levels and a physical education instructor, special education aides, and math and

reading specialists. I am not covering all the good facts about Center Street Elementary School here, but it would be great to be about six years young and attend Center Street as a young boy. My elementary school was all asphalt and maybe one-fourth the size of Center Street.

Rose continues: "I get to the school by 7ish in the morning. There are some late nights, but I also try and make sure to get home in time to make dinner two times a week. We have three kids of our own! But, being a principal invariably is 24/7. There are weekends and holidays, but if something is important or urgent, I will be involved. Earlier today, I met with about 100 parents with our Coffee with the Principal. The love

that the interest is high and the positive energy is so welcomed. Ultimately, it's all about the students, and as long as we keep them at the center of our decision-making, it will be okay and, honestly, better than okay because they deserve all the tools, inspiration, and support to be their best selves. That takes all of us working together, parents, faculty, and the community to ensure it's all there for them. It does take a village, and I'm so proud to be part of the work that is happening... together."

Rose talks enthusiastically about the school partnering with, among others, the South Bay Lakers. You can see improvements at the basketball courts and playground.

When you come into Ahern's office, the

first thing you may notice is a big table in the middle of the room, surrounded by chairs. Her desk is off to the right. There are school-related items on the wall. It just is very inviting. You feel like sitting down and talking. You do not feel rushed, and you want to learn more about learning itself. When I left, I dictated into my cell phone to remind myself how comfortable I felt in the principal's office. The principal's office? Isn't that a place you never want to be? Don't you wind up there if you are in some sort of trouble?

In Rose Ahrens' office, you are welcome. The two quotations above on the front door to the school are an indication of what you are walking into: An excellent environment. •

While Schiff is in a slight lead, there is a lot of race left to run, and anything can change by November next year.

The interesting wrench in the gears that constituents rarely see is the fact that there will be a sitting, yet new, Senator on the ballot—if she chooses to run. Granted, her experience, of only a little over a year at the time of the election, will pale in comparison to the late Feinstein's 31. She will technically be the only person on the ballot with experience in the Senate. There is a lot of fear that Butler will have a sort of lame-duck appointment to the seat, but there is so much time for her to do something effective and make a name for herself on the Senate floor—and she already has.

Butler was brought about to her seat with some controversy due to Governor Gavin Newsom's old statement that he would ensure Feinstein's seat was passed to a black woman nearly three years ago. This caused some anger from voices in the black community, stating that black women do not need to be the keeper of Feinstein's seat while it awaits a new person to sit on it. A lot of this anger comes from a sharp overlooking of the qualifications that Butler has and the fact that she will not be able to hold the seat for a considerable amount of time.

The race for California's senate seat is sizing up to be interesting and combative, with new and exciting events at play that only come very seldom in the political world. These kinds of situations have rarely been brought to constituents to sort out. Still, the electorate of California is beginning to weigh in on the tumultuous handling of the death of an incumbent senator. The race was already shaping up to be a close match among leaders Porter and Schiff, but with the extra layer of an untested new incumbent, there are sure to be some shake-ups.

Schiff and Porter are not alone in their race to be the face of change after 31 years of Dianne Feinstein being a loud and proud voice for Californians in Washington DC, but they currently are the two leading the pack of contestants. Down below them, there is

Barbara Lee of Oakland, a prominent Democrat on the ballot polling at 7%. Joining her below Schiff and Porter are a couple of GOP candidates, James Bradley and Eric Early, polling at around 7% and 5%, respectively.

With the death of Dianne Feinstein, a crowded field got even more crowded. People have been eyeing the spot of the late Senator for over 30 years now, and since she was elected, she has never lost her power. But now, following the appointment of her replacement, there is chaos in finding who will be the elected replacement for the long-time Senator. Although a race from behind for Butler, the interim replacement, would be tough, it is not out of the realm of possibility. With the amount of time that she has on the floor of the Senate to participate in votes and penning new bills, she could make a serious name for herself that could help lead to—not a reelection—but a proper first election. With all of that, there is a wonderful sales pitch of walk-on experience as a senator that Butler can give that no other candidate vying for the seat can say.

The world of politics is, at its very nature, chaotic. People bustling and speaking, and moving for votes and bills and prominence. But here in California, it is now especially chaotic. Very rarely do these kinds of affairs happen concerning alleged "lame duck" appointees, especially not in a state that has, for a very long time, been consistent with who represents it on Capitol Hill. The sun has set on the long-reigning, undisputed Queen of California politics who rose to fame from her time as mayor of San Francisco and became a well-known face and voice in the hallowed halls of the capitol building for over 30 years. The electorate is faced with a complex choice in the coming election season, and a new player in the vicious game of the American Senate is trying her hand at making the changes she wants to see in the world. There is no telling, except by way of counting ballots, who the late Senator's seat will hold following the 2024 election, but as the days go by, one sun sets and a new one will rise. •

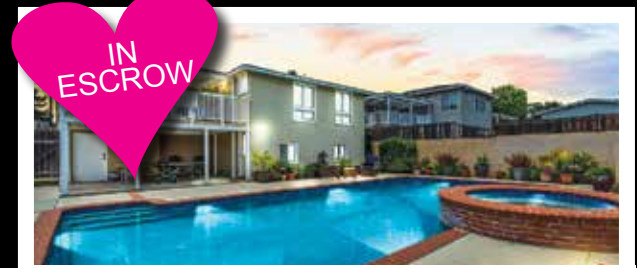
