City Council Responds Quickly to Smoky Hollow Business Owner's Plight

In a show of support for a longtime El Segundo business owner and resident, the El Segundo City Council took swift action at its regularly scheduled meeting last Tuesday night, adding language to the Smoky Hollow Specific Plan that will enable Tony Barraza, owner of Hi Tek Automotive in El Segundo to move his business to a new Smoky Hollow location at 115 Nevada Street. City Council's action was waged after a strong showing of support for Barraza during the public comment portion of a public hearing on the Smoky Hollow Specific Plan Update and Community Benefits Plan Policy, in which 16 residents came forward in support of keeping Barraza in business in El Segundo. Barraza, who has been in business since 1988 and a resident for more than 20 years, asked the council to find a way to keep his business open in the city where his family's "dream started."

For its part, neither the city council nor city staff had anticipated the outpouring of support for Barazza, nor was Barraza's plight on the agenda. But after the 16 residents spoke, the council made a point to find a way to help Barraza by adding language to the amendment. Though council member Lance Giroux wanted to find a way for Barazza to open his business doors basically right away, city staff and the city attorney reminded the council that the amendment requires a second reading at a regularly scheduled city council meeting, and the next one is November 7.

Said Giroux, "First of all, thank you. To have 16 people come in on behalf of one person is pretty much what this city is about. So kudos to you, Tony, to have that kind of support. So, thank you for coming in. I think when we always look at all these projects we do, whether it be the Downtown Specific program or this one, we're always trying to evolve, OK, but we don't want to evolve to the point where we lose the legacy of who

we are as a community. So, I think really what happened here is this kind of got caught in the crossfire here. And, to my knowledge, this is the only issue that's come up. So if there were other issues like this, wouldn't we have heard about them already?" he queried Community Development Director Michael Allen, whose department was presenting the first reading of its amendment to the

Woman's Club Receives Historic Recognition

On September 18, 2023, The El Segundo Woman's Club and the City of El Segundo celebrated the unveiling of a plaque commemorating the listing of the Woman's Club Clubhouse in the National Register of Historic Places by the United States Department of the Interior. The event was attended by members of the Woman's Club, El Segundo City Council, El Segundo Unified School District, El Segundo Unified School District's Board, the California Federation of Women's Club's Marina District, the great grandson of John C. Austin, Michael Spaulding RLA, and members of the community.

The Woman's Club Clubhouse is the first El Segundo schoolhouse built in 1912 and purchased by the Woman's Club in 1936. Assisted by noted Los Angeles architect, John C. Austin, Club members renovated the building and have used it continuously since that time for meetings, as well as opening it to the public for community and civic events. Rentals of the clubhouse help to fund the maintenance of the historic building.

Celebrating the event were: Mayor Boyles, acknowledging the City's appreciation that members of the Woman's Club in 1936 had the foresight to acquire and



ESUSD Board Meeting Report

The following information covers the September 26, 2023 ESUSD board meeting and was taken from ESUSD website:

Board Recognizes ESHS Student Daniel Tritasavit El Segundo Unified School **District Board of Education**

Daniel Tritasavit, ESHS senior, was named a 2024 National Merit Scholarship semi-finalist. Daniel is one of only 16,000 students nationwide to receive this honor. This honor places Daniel in the top 1 percent of U.S. high school seniors! The National Merit Scholarship Program is a nonprofit organization that awards scholarships to high school seniors annually, with semifinalists chosen based on their preliminary SAT scores. As Daniel moves into the next round of competition for a National Merit Scholarship, he will be asked to submit a detailed scholarship application that includes a personal essay, letter of recommendation, and grades and SAT scores that align with his PSAT score. By advancing to the National Merit Scholarship finals, he is eligible to become one of the 7,140 national finalists who will be chosen to earn a share of nearly \$28 million in scholarships set to be distributed in 2024. The ESUSD Board of Education was pleased to recognize Daniel for this outstanding achievement and wishes him the best of luck as he moves to the next phase of competition!

Board Hears Presentation on CAASPP

Marisa Janicek, Assistant Superintendent of Educational Services, shared results of the ESUSD California Assessment of Student Performance and Progress (CAASPP) from 2022. CAASPP tests are administered in ELA (reading, writing, listening, and research and inquiry) and mathematics (concepts/procedures, problem solving, communicating reasoning, and data analysis) to all students in grades 3-8, and Science Test (CAST) is also administered to students in grades 5, 8, 11 and 12.

ELA Results

At the elementary level, the district saw mixed results: 4th grade improved significantly, 5th grade remained consistent, and 3rd grade dipped slightly. While there are several factors that played into the dip at the 3rd grade level, administration expects those numbers to trend upward this year. Schools are identifying needs and interventions, and reading specialists within the elementary schools are working with those students needing additional support.

At the middle school, the district again saw a small dip in the results from last year. However, the group as a whole is still above 70% for meets or exceeds standards, and middle school administrators are looking at additional interventions to support students within the middle school age groups. Additionally, the percentage of students who did not meet standards at the 6th grade level went down from nearly 10% to only 8%, a significant improvement.

For ESHS 11th grade students, the percentage of students not meeting grade-level standards was cut in half from two years ago, thanks to the targeted interventions in place at the high school. Additionally, these students are almost back to the 80% threshold desired for students meeting or exceeding standards.

Within subgroup levels, the district's two targeted groups, ELL and Special Education, increased the percentage of students meeting or exceeding standards significantly. The district has individual plans in place for each of these students.

Homecoming's Historic Win Story and Photos by Gregg McMullin

The El Segundo Eagles football team was unaware of the worst Homecoming game loss in school history 55 years ago. The fact that this year's game was played on one of the most superstitious days of the year, Friday the 13th, never came to mind. What was going through the team's mindset was playing with pride and not allowing the game to get too big for them. In front of an overflowing Homecoming game crowd, the Eagles gave their head coach, Shawn Green, his first Pioneer League win. The 28-7 victory over the West Torrance Warriors gave his coach a sigh of relief. "It's been a long time coming, and they played well; I'm proud of each one of them," said Coach Green.

The win over West Torrance broke a sixgame losing streak against the Warriors. It was the first victory over the Warriors since 2010, when Grant Palmer threw three touchdown passes, leading the Eagles to a 36-10 win. It also gave Shawn Green his first Pioneer League victory since taking over as head coach three seasons ago.

The Eagles have had their challenges this season with their defensive secondary. The pass defense was at its best, limiting the Warriors to 198 yards on 15 of 43 completed passes. The secondary of senior Michael Wilson, juniors Shane, Sean Mossman, and Grady Lubs played their best game thus far in terms of coverage and physical play.

El Segundo survived a long West Torrance opening game 11-play drive that the Warriors came away without points. The Eagles took advantage of great field position on their second possession. Anthony Temesvary connected with Michael Wilson on an 18-yard touchdown pass play. The Warriors responded on their ensuing possession with a 66-yard touchdown pass play from Eli Brandt to Reef Sharman, giving West Torrance a 7-6 lead. There was a mix-up in defensive coverage that allowed Sharman to get wide-open. Coach Green said it was a miscommunication that was fixed throughout the rest of the game.

The Eagles showed their resilience with their next possession. Temesvary marched the offense 65 yards for a go-ahead touchdown that started with a 45-yard pass completion to Michael Wilson. Six plays later, junior running back Cole Castillo rushed for an eight-yard touchdown and a 13-7 lead on the final play of the first quarter. The second quarter went





Film Review

The Trial of *Reality Winner*: Hero or Traitor?

Former Air Force veteran and NSA contractor Reality Winner was just 25 years old when she was charged under the Espionage Act, facing a decade in prison for leaking a classified document that seemed to prove Russia's interference in the 2016 Presidential

election. At the time, then-President Trump vehemently denied any wrongdoing in his quest for the ultimate power position, claiming that any talk of Russia's collusion was just a distraction from his victory. It was a tense time in America, made even more unbearable for Reality as she stared at a document that contradicted everything Trump was saying publicly. Taking matters into her own hands, she made a rushed decision to leak the document. Just as quickly, she was faced with the consequences.

The politically-charged documentarian Sonia Kennebeck (Enemies of the State, National Bird) brings the story of the now 31-year-old Reality Winner back into the public's consciousness in the self-titled documentary, Reality Winner. Executive produced by Wim Wenders, the film is the first official statement from Reality since her release from prison on June 2, 2021. Using intimate, never-before-heard conversations between Reality and her family, Kennebeck crafts a thought-provoking exposé about the risks of whistleblowing, even if acting in good faith on behalf of the country, and begs the question if her actions constitute that of a traitor or a hero.

Throughout the swift 94-minute runtime, Reality recounts the morning of her initial confrontation with FBI agents, her struggle to adjust to prison, and her eventual release and acclimation back into the world post-Covid. Soft-spoken yet unabashedly confident, Reality conducts the sit-down interview in the yard of her parent's home (and who can blame her for wanting to be outside after spending years in a jail cell). Assisting in the storytelling is Reality's mother, Billie Winner-Davis, whose own emotional rollercoaster is a painstaking watch. Through their own words and corresponding verité footage, Reality and Billie's individual experiences over the last five years show an unwavering strength in the midst of a radioactive political climate.

The story of Reality Winner is a fascinating one but we must remember that at the center of it all is a young woman who still struggles to navigate through these uncharted territories. She says as much toward the end of the film by professing she is still battling an uphill fight. She has joined the ranks of previous whistleblowers Chelsea Manning, Thomas Drake, and Edward Snowden, a group she never intended to be part of. While there isn't any "new" information shed on Reality that isn't already accessible on Google, the documentary is still an engaging story and recounts a historic moment in American politics.

Ironically, in June of 2023, Donald Trump was also indicted under the Espionage Act for his possession of classified documents, just like Reality five years prior.

growth in math scores as well, with special credit given to the schools' math interventionists and new curriculum. At the middle school level, 8th grade students saw a 7% increase, and upon further examination, cohort growth can be seen from year to year as well. At the high school level, it is important to note that these students had not taken a state assessment since 7th grade, and yet they still saw growth.

Science Results

ESUSD has identified science instruction as an area for improvement moving forward. While data is limited due to this test only being reinstated in 2022, the district considers science to be a potential growth area, leveraging the implementation of a new biology curriculum last year. The district has incredible teachers in place who are building a love for science within our students, and with time and the dedication of our teachers, these results will soon improve.

The district will continue the conversation about ways to ensure the students of ESUSD are receiving the best education possible, achieving growth, and finding success.

have trickled all the way down to the earlier levels of primary education, and with that, the emphasis on productivity began.

It cannot be argued that everyone must be productive in their daily lives, financially, in relationships, in personal pursuits, the list goes on. However, it has been observed that there is a significant benefit to something like a gap year. Writing for the Harvard Graduate School of Education's Magazine, Brenden Pelsule writes, "Media debate around gap years typically revolves around economics. Does what's good for the few, the questioning usually goes, come at the exclusion of the many? According to this line of thinking, there are gap-year advocates, like Bob Claggett, Ed. M.'91, who has done studies showing that gap-year alumni outperform their peers in college..." The advocates against something like a gap year would have entirely financial complaints and apprehensions on the subject. The naysayers warn against something as frivolous as time off in this fashion, a foreign concept to many minds. The worries sprouting from this idea cry that it could lead to a lifetime of laziness and being financially behind. And worse yet, something as "detrimental" as the rest of a gap year could throw someone off of their rhythm for an entire lifetime. This, however, is not the case.

The issue with a gap year is the financial cost of it. How does one justify the cost of nothing? To that question, the answer is another question. What is the price tag of memories drifting through the consciousness of a head covered with gray hair? One cannot put a price on them because they are priceless. They are infinitely valuable, especially when they are spent living life to the fullest. Grabbing it by the reins and leaving nothing left unseen or no stone unturned. And that is not to say a practice such as a gap year could prevent that.

A soul-searching journey needs to be conducted in the dusk of adolescence, and an unabridged life is the way to do it. There is a particular glow that some have when they walk into a room. A shine on their cheeks, a glint in their eyes that can scream, "I lived," that not many carry around the world with them. It could be the importance of a break between the mundane and often dreary days of high school and the exciting, intricate world of higher education. There is more to see and discuss, and there will be greener trees in the campus foyer and a respect for the gray-haired professor spinning a yarn about their youth that would not otherwise be there if not for something such as a gap year. That is not to say that it wouldn't be there otherwise, but you can increase the chances of such a joy spawning if one takes a moment to live the life they aim to study.

Everyone has a different journey ahead of them. Every individual will make their own trails on the path of life. Kick over different rocks, get lost in different sets of weeds, and find their own wondrous pasture to rest in and watch the simple beauty of life passing around them. The gap year, while something that has been proven to be beneficial, is only for some. However, it is essential to recognize the use of such a thing and allow young people to explore their life and decide with an educated and mature mind what is next for them. •

Community Benefits Plan Policy and Smoky Hollow Specific Plan Update.

Said Allen, "I mean, a good example is the gyms. Over the last few years, examples have come up that have informed tonight's text amendment or specific plan amendment. This just happened to come up while we are in the midst of already taking this to the public..." Responded Giroux, "Right. I get it. So, one of the things is this gentleman's been in business a very long time, and he's not currently able to operate. ...

"OK, so the man's been out of business for six months," said Giroux. "I think if nothing else we have to come up with a solution tonight to allow him to be able to get back to work even if it's going to take us another six months to come up with a policy. There has to be a way to be able to do this because you can't put the man out of business. So, if you want to know what we're asking for, that's what I'm asking for. There has to be a way to be able to word this, to do this, whether it's a legacy business provision in the agreement or whatever it is, but the man has to be able to get back to work."

"Council member Giroux, not looking to put anybody out of business," responded Allen. "What we're here tonight to do is to come up with some language..." Asked Giroux, "I'm not saying we are. I'm just saying that we have an issue. So how do we fix that issue tonight so the man can open up his doors tomorrow morning?"

Allen mentioned deferring to the city attorney, stating he wasn't sure language could be come up with "tonight." Giroux said, "I think we can." Mayor Pro Tem Chris Pimentel was one of three city council members in the room who could vote on the Smoky Hollow Specific Plan Update and Community Benefits Plan Policy amendments being proposed Tuesday night (Mayor Drew Boyles and council member Ryan Baldino recused themselves before the agenda item being discussed because Boyles owns property and Baldino rents property in Smoky Hollow), then weighed in as he attempted to direct and add to the dialogue: "If there are other limitations on environmental effects on neighbors, because right now, we have auto body shops with existing noise parameters, so I assume that that language is sort of already in there somewhere or?"

Said Allen, "So the idea with legal nonconforming (which is how Hi Tek was classified at its previous location) is that they're eventually phased out, they're amortized, right? In this case, it's happening a bit sooner than what we're comfortable with. And it's happening to a business that we'd like to keep and find a path forward. If we were to look for a permanent path in the specific plan, we'd want to look at those things because they're currently not spelled out in the specific plan. It's not a use that was contemplated in the specific plan. There could be some shortcuts. There could be some other light manufacturing... but off the cuff, I'm not looking at that at the moment."

Said Pimentel, "If we, in the nature of capricious city councils, said, 'Let's add an amendment that says legal nonconforming can move within the zone if they're the same footprint or smaller, and accept a little bit of risk with not having those items, could we come back and amend it again so he can keep his doors open?"

City attorney Joaquin Vazquez noted the "novelty of staff's awareness of this" (issue with Hi Tek), adding that Allen wanted to be prudent and be able to "double-check carve-outs" and discover any potential "blind spots" and "what might be the other side of that coin?" all in the spirit of "what can we do for the public good?"

To that end, Allen said he could "Throw out some language tonight," make a" quick assessment on our own based on any site implications, other uses," etc., before the second reading and that the amendment, if approved with the language addition that allows Barraza to re-open his legal nonconforming business in a new Smoky Hollow location, could be revised if necessary, council could include the language and vote to approve it as part of Smoky Hollow Specific Plan Update and Community Benefits Plan Policy.

Council voted 3-0 to approve the language and added it to the Smoky Hollow Specific Plan Update and Community Benefits Plan Policy, with city staff then making its assessment, followed by a second reading on November 7 or possibly a new first reading at City Council's special meeting that will be held later this month if necessary, so that the second reading could remain on track for November 7. The new first reading would be needed "if there's anything material that changes between the first and second reading..." noted Allen.

In other news, the city council watched city staff present the FY 2023-24 Economic Development Strategy and took action related to the Land Acknowledgement Statement on the City's Arts and Culture Advisory Committee Meeting Agendas" item, asking for more detailed information from staff.•




