Council Candidates Weigh in on the Issues

Each week leading up to the November 5 election, the Herald will publish El Segundo City Council candidate responses to questions covering various matters of local concern.

1. Should we look at any zoning or other changes in residential, commercial and industrial areas of town? If so, what and why?

Drew Boyles: Over the next few years, we will update El Segundo's General Plan—a comprehensive process involving public input and thorough analysis of market trends, demographics, land use, traffic, environmental factors, and infrastructure needs. This may lead to land use changes and will include multiple public hearings. While previous efforts focused on the Smoky Hollow Specific Plan, Downtown Specific Plan, and Housing Element, this update will prioritize areas east of PCH where significant opportunities exist for optimal land use development. The plan will align with environmental regulations, state mandates, and community needs, promoting sustainable growth and enhancing residents' quality of life while balancing economic and environmental goals.

Chris Eidem: I miss the days when Smoky Hollow was primarily a light industrial area, with a few artists and creative spaces mixed in. We should take a closer look at our city's different zones to see how we can promote growth within the existing zoning framework. It's important for the city to continually assess these areas, ensuring that any development aligns with our limits and has minimal impact on our schools and neighborhoods.

Lance Giroux: Focusing on residential zoning east of PCH is essential for our city's future. This effort goes beyond just meeting regional housing needs assessment numbers; it aims to address our community's specific needs. Welcoming developers

to build, for example, senior retirement communities or accommodations for Air Force Base personnel could directly tackle local needs and ease housing demand. Park Vista, our current senior housing option, is fully occupied with a long waiting list. Additional housing could help our retirees downsize and remain in our community. Another example is working with the LAAFB. Currently, many base personnel must commute into El Segundo from far distances. Offering a viable housing solution closer to work could mean less time on the freeway and better work-life balance. By embracing innovative ideas, we can better serve our community and ensure a prosperous future for El Segundo.

Michelle Keldorf: I support land use initiatives east of PCH that attract businesses to strengthen our vital tax base. As we update the General Plan Land Use Element, we should focus on commercial office areas currently experiencing high vacancies. There is an opportunity to re-zone and/or overlay additional commercial uses that further position El Segundo as a

desirable hospitality destination, leveraging our proximity to sports franchises and Southern California's attractions. Regarding residential, I'm proud of our work to achieve a state-certified Housing Element that identifies opportunity sites west of PCH, particularly along PCH and Imperial, without increasing density in our R1 and R2 zones. I would support a live/work overlay in the Smoky Hollow Specific Plan, allowing shared residential and business units. This would encourage additional housing options for young professionals, small business owners, creatives, and remote workers while activating the area, enhancing pedestrian mobility, and fostering a vibrant workforce environment.

John Pickhaver: We should consider zoning adjustments, particularly in areas east of PCH. Our current "put density where density is" plan risks overpopulating certain parts of town, leading to less parking, more traffic and congestion. In the next state-mandated housing allocation cycle, we'll face increased requirements

Three Write-In Candidates for Upcoming City Clerk Spot

Though no one filed paperwork to run for El Segundo City Clerk by the initial August 14 deadline, three individuals threw their hats in the ring as write-in candidates in advance of the November 5 election. Eric Kenas, Alissa Kovall and Susan Truax will vie for the open slot after each secured the required minimum of 20 signatures from local registered voters to obtain the nomination. Each

also successfully completed the Statement of Write-in Candidacy, with those filed with the County Registrar as the only candidates qualified to be written on ballots for the position. Long-time City Clerk Tracy Weaver opted not to seek reelection after three terms. October 22 was the write-in deadline. No additional candidates emerged for the City Council or School Board offices. •

Eagles Have a Winning Week

The El Segundo Eagles had a winning week. The water polo team swept their way to a Bay League championship appearance this past Monday. The girl's flag football team earned a CIF playoff spot, and the football team dominated once again.

Water Polo Team Advances to Bay League Championship Game

The Eagles had a busy week leading up to the Bay League Tournament. They started by defeating the Millikan Rams 10-7 in a non-league matchup on the road. Then, they defeated the Palos Verdes Sea Kings 12-8 on Senior Appreciation Day. They ended their week by sweeping Palos Verdes and Redondo in the Bay League preliminary tournament.

Against Millikan the Eagles started slow on offense by scoring two goals but their defense held the Rams in check in the first period. In the second period the Rams turned the tide by scoring three goals and the game was tied 3-3 at halftime.

El Segundo used its center position to its advantage in the second half, and Austin Miller obliged by scoring three of his four goals. Leading 5-4 going into the fourth period, the Eagles scored five goals and held the Rams off down the stretch to win it 10-7.

Before their final Bay League game against the Palos Verdes Sea Kings, the Eagles celebrated their seniors during Senior Appreciation Day. Stefan Lazarevic, Sutton Fisk, Hayden Abbott, Vinny Baldino, Carter Williamson, Shayne Hopkins, Nathan Morales, Chase Davidson, Jayden Stephens, and Jacob Noda were introduced to the crowd by current

teammates who shared memories of the player they were introducing.

As for the game, the Eagles were in total control against the Sea Kings. Hayden Abbott got the scoring going for the Eagles with a goal early in the first period. Then Abbott assisted on Tristan Foster's goal a short time later. Carter Williamson's goal from the five-meter area extended the score to 3-0. Sutton Fisk scored the first of his three goals with under a minute to play in the quarter to give El Segundo a 4-0 lead.

In the second quarter, the Eagles used a strong counterattack to score four more goals. Williamson's assist to Austin Miller made it 5-1, and later, Miller's side-arm shot skipped in for a 6-2 lead. Hayden Abbott

found Sutton Fisk open, who tossed in another score. Williamson found an open shot on a counterattack with twenty-four seconds remaining for an 8-2 halftime lead.

Miller opened the scoring in the third period with a vicious overhead shot. Then, after a steal by Sutton Fisk, the talented senior received a pass and worked it inside for a shot attempt. The attempt caromed off the post back to Fisk, who punched it back into the net for a 10-3 lead. The Sea Kings pulled to within 10-5 to close out the third period.

In the fourth period Seth Davis had a key block and Carter Williamson had an important steal to help hold off the Sea Kings and the Eagles won 12-8 to wrap

up second-place seed for the Bay League preliminary tournament.

The tournament's format, to determine the Bay League champion, is that the six teams are seeded based on the five games they played during the league schedule. Since the Eagles' only loss was a 6-5 decision to undefeated Mira Costa, the Eagles were seeded second. They faced Palos Verdes in the opening round and won 10-9. Then, they faced Redondo in the semi-final round and overcame a two-goal deficit to force overtime and win it 12-10.

Against Palos Verdes, the Eagles struggled against a spirited Sea Kings team looking for revenge. El Segundo gathered its composure, made defensive stops, and ultimately held off the Sea Kings.

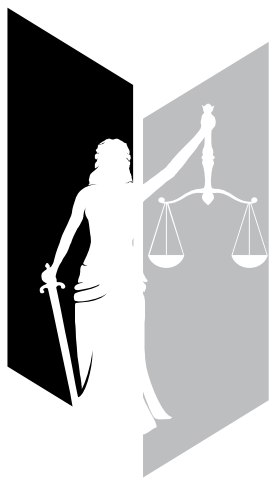
The battle against the Redondo Sea Hawks was close throughout, with the Sea Hawks taking a 6-4 halftime lead. The Eagles kept playing catch-up in the second half when, at one point, trailed by three goals. But the Eagles got superb defensive efforts from Carter Williamson, Hayden Abbott, and goalie Stefan Lazarevic in the fourth quarter, and the offense came alive to tie the game at 10-10 to force overtime. In the second overtime period, Sutton Fisk's late goal held up, and the Eagles won 12-11.

El Segundo faced Mira Costa on Monday to play for the Bay League championship. The Eagles fell to the Mustangs 6-5 during the regular league schedule. EL Segundo's defense held the Mustangs' potent offense to their lowest score of the season. The winner would be the league champion and get



Film Review

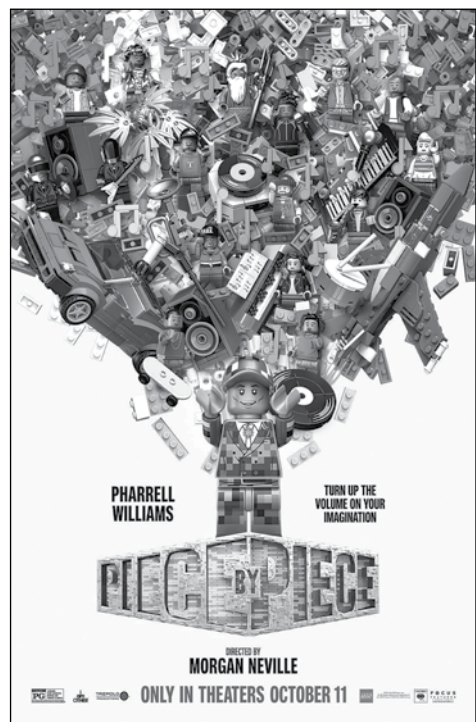
Piece by Piece: An Animated Biopic that Redefines the Bounds of Conventional Storytelling

I'll admit, I was apprehensive about watching Morgan Neville's Pharrell Williams biopic *Piece by Piece*. I've been a fan of Morgan's work since he blew me away with *20 Feet From Stardom*, so I did not doubt his capability to construct an emotionally charged music doc. My hesitation came from questioning how Pharrell wanted his story told; doing so exclusively through GCI Legos seemed nuts. Was this going to be a piece of branded entertainment disguised as a music biopic? My thoughts continued to swirl as the lights dimmed and the movie started. Within two minutes, any shred of uncertainty was transformed into full-blown captivation. I was officially hooked.

Stunning images feel like they're tangibly leaping off the screen, despite the film not being in 3D. Combined with nonstop musical numbers, *Piece by Piece* is a contagiously joyful cinematic experience. It will have you toe-tapping and head-bopping for the entire runtime. Now playing in select theaters.

Pharrell, in Lego form, sits across from Morgan Neville, also in Lego form. They are sitting on a soundstage made entirely of, you guessed it, Legos. For as unconventional as the visual is, *Piece by Piece* follows familiar documentary pacing and formats. Starting with childhood ambition, Pharrell linearly reminisces through his young adulthood in The Neptunes, his rise to fame and eventual big break, and his subsequent existential crisis.

This all culminates in a humble realization and gratitude for his talents and life.

If you're already familiar with the multi-hyphenate artistic wunderkind, Pharrell Williams, or have paid close attention to his career, you'll get a lot out of the intimate stories he shares about his early days in the music industry. On the off chance you've never heard Pharrell's name, I can guarantee you've heard his music. At one point in the film, a musical montage medley breaks out with all of the songs Pharrell has imprinted on. I found myself thinking "Oh yeah, Pharrell made that!". Familiar tunes include Britney Spears' "I'm a Slave 4 U", Snoop Dogg's "Drop It Like It's Hot", No Doubt's "Hella Good", and Kendrick Lamar's "Alright", plus so many more.

From playing a high school talent show with his Neptunes bandmate Chad Hugo to creating the world's biggest earworm "Happy" (from *Despicable Me 2*), Pharrell's talent is bar none. Music mesmerizes him and, quite literally, embodies a fantastic visual form. Pharrell experiences synesthesia and watching this play out on screen in *Piece by Piece* is a creative explosion of sound, color, and life.

Director Morgan Neville's calm demeanor during their interview helps Pharrell feel at ease. This is important as they touch upon the more uncomfortable themes of imposter syndrome and uncontrollable ego. Pharrell breaks down the barrier of his celebrity as he talks candidly about The Neptunes disbanding, his insecurity masking itself as cockiness, and spreading himself too thin trying to be the best. Toward the film's end, he returns to his hometown in the projects of Virginia Beach to regain perspective. This

All the Colors of the Dark by Chris Whitaker

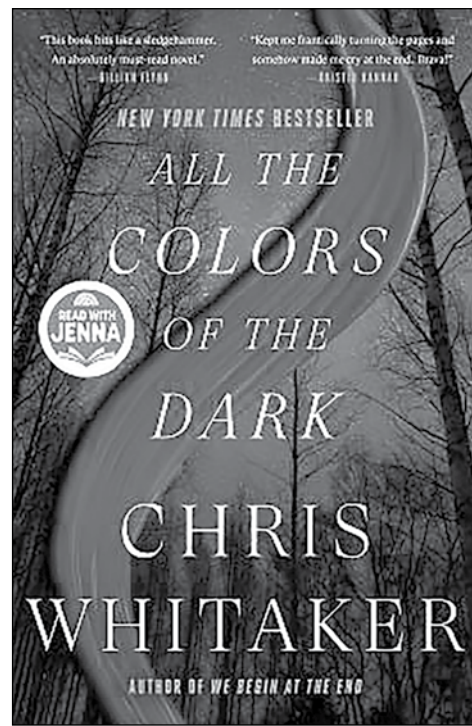

Unputdownable is defined in the Merriam-Webster Dictionary as "unable to be set aside; riveting." The adjective's earliest known use is in the 1830's, not a word contrived by publishers to sell books like I had always thought. At any rate, unputdownable best describes Chris Whitaker's latest novel *All the Colors of the Dark*. A hybrid coming of age, crime novel, and heartbreaking love story, the author of the best selling *We Begin at the End* has delivered another blockbuster.

Set in the small town of Monta Clare, MO, the story opens in 1975. Joseph McCauley, known as "Patch," for the patches he wears over his missing eye, is a thirteen-year-old trying to survive extreme poverty and his

single mother's alcoholism. New to Monta Clare, Saint lives with her grandmother, having lost both parents at a very young age. The Pirate and the Beekeeper. The two outcasts become inseparable until the unthinkable happens. Tragedy hits small towns especially hard; all the residents are intertwined in each other's lives. What happens to one has an effect on all.

This story depicts an epic quest driven by obsession, love, and loyalty. Characters are fully realized, brimming with life and emotion. Even peripheral characters become known. The landscape of the Ozark Mountains proves a mesmerizing backdrop and hunting ground. Whitaker's writing style may be unconventional, but it is impeccable. Spanning decades, the book is taut and suspenseful, never predictable. It is heartbreaking and hopeful in equal measure. In the end Saint comes to realize, "To love and be loved was more than could ever be expected, more than enough for a thousand ordinary lifetimes." •

Board Of Education Meeting Showcases Halloween Spirit, Impressive District Renovations

The October 22 Board of Education meeting came at a unique time of year, with Halloween just around the corner and Election Day less than two weeks away. Fittingly, each board member wore an impressive Halloween costume and shared words of encouragement to the community about the importance of casting their votes.

"If you don't vote, you don't get to complain," said Meredith Beachly, president of the Board. "There are too many important things on the ballot not to vote."

Board Clerk Tracey Miller-Zarneke echoed her sentiments, wishing local politicians good luck in the upcoming election. She congratulated them for their "confidence and integrity" throughout the election cycle, and for running community-oriented campaigns.

Key updates on district-wide renovations and construction projects dominated the meeting proceedings. Measure ES, an ongoing investment in our community's schools, outlined several recently completed projects, including modernizing the El Segundo High School library, window replacement in the engineering building, gym modernizations, and more. According to the presentation led by Chief Business Official Kim Linz, all major work via Measure ES is complete except for the Eagles' Nest, Arena, and District Office.

Initially passed in 2018, Measure ES has drawn from an initial budget of \$92,000,000 to improve each of the district's schools. El Segundo Middle School also received a new gymnasium, in addition to the modernization of science classrooms, the band classroom, and Bulldog Hall, plus multiple safety and efficiency upgrades. For example, there is no longer a lake in the middle of the school's field whenever it rains.

The district's elementary schools have also benefitted from Measure ES, with Center Street receiving drop-off and drive-through modernization and a new play structure, courtesy of Center Street PTA. Richmond Street has an equally long list of improvements, including a new classroom building, a kindergarten shade structure, restroom modernization, and a safe and welcoming entry vestibule, among others.

The remaining \$13,312,004 on the budget will go toward renovating the District Office to include air conditioning, higher ceilings, ADA-accessible restrooms, and a general makeover of the space to "create a building that reflects the district's philosophy" of open arms, according to Linz. She also shared that El Segundo has applied for state matching dollars to be eligible for additional modernization funds if Proposition 2 passes.

On the topic of El Segundo's elementary schools, Richmond Street delivered a presentation on the social-emotional learning and wellness efforts they are making. Principal Carie Olausian outlined the RULER framework the school employs, which stands for recognizing,

understanding, labeling, expressing, and regulating. To meet staff and students where they are, Richmond Street is applying this framework in new ways through staff retreats, classroom charters so every student's voice is heard, the awarding of best-self slips when students exemplify exceptional social-emotional behavior, and utilizing sensory rooms whenever necessary.

Richmond Street's sensory rooms are specifically designed to help students relax, self-regulate, or recharge, complete with items such as therapy balls, mini-trampolines, weighted blankets, and more. Taken together, each of these measures helps staff and students foster a habitat where they can truly thrive.

Other board updates touched on the success of recent community events. The Skechers Walk brought out 1,144 walkers, exceeding its goal of 950 and surpassing last year's tally of 758. Additionally, Center Street School's Jog-a-thon raised over \$100,000, according to Miller-Zarneke.

High school senior Caleb Tsai was honored at the meeting for being named a National Merit Scholarship Semifinalist by the College Board. The award distinguishes him as one of 16,000 students nationwide—out of more than 1.3 million—who took the PSAT and qualified for over \$27 million in scholarships.

Meanwhile, ESHS football continues to rack up big wins, improving to 5-3 and going undefeated in league play thus far. In October they have been particularly dominant, with the team outscoring its opponents 160-13. Their spirited play has coincided with the school's Spirit Week, which featured a "Pink Out" on October 23 for Breast Cancer Awareness Month. The school recently held a powerful assembly organized by the Jewish Student Union, which touched on themes of antisemitism.

Several action items were discussed and subsequently passed by the Board, including Superintendent Jason Johnson's hiring request for a new Assistant Superintendent of Human Resources, offering a \$260,000 annual contract from November 4, 2024, through November 3, 2027. A tentative agreement between El Segundo Unified School District and non-represented employees – such as playground supervisors, classified management, confidential employees, superintendent, etc. – was also approved, pending ESTA ratification.

For those readers who are just dying to know, District Superintendent Jason Johnson dressed as Robin Hood, Beachly showed her crowd spirit as an LA Chargers superfan, Board Member Dieema Wheaton appeared as a flight attendant for "Education Airlines," Michael Wagner complained of jersey tightness after dressing up in full football uniform and Miller-Zarneke positively stole the show with her Blue Butterfly costume and "I Voted!" sticker to match. Vice President Frank Glynn was not in attendance, possibly due to his ongoing search for a suitable Halloween costume. •

Do You or a Loved One Have Advanced Multiple Myeloma?

(BPT) - Two clinical trials are seeking adults for research on an investigational medicine for relapsed and/or refractory multiple myeloma. Multiple myeloma is a rare bone marrow cancer, and about 35,000 people in the United States will be diagnosed this year. Most people will be diagnosed over the age of 65, and African Americans are more than twice as likely to be diagnosed compared to Caucasian patients. Multiple myeloma can cause a range of difficult symptoms, from bone pain and infections, to weakness, nerve damage, or impaired kidney function.

While there are treatments approved for multiple myeloma, most people will have their cancer return after treatment (what doctors call "relapse") or they may no longer respond to a certain medicine (called "refractory" disease). Doctors may determine suitable treatments for each patient based on a range of factors, including the stage of the disease and previous therapies, as different treatments may be combined or used one after another.

Bristol Myers Squibb is currently investigating the potential of an investigational therapy for patients living with relapsed or refractory multiple myeloma. Medical research built on existing scientific knowledge and proven mechanisms of disease have the potential to improve anti-myeloma activity and overcome treatment resistance.

Clinical trials are controlled studies of potential new medicines, procedures or other treatments, and doctors use information they learn from these studies to help figure out new or improved ways to treat diseases like multiple myeloma. While clinical trials offer the possibility of accessing cutting-edge treatments and contributing to medical advancements, they also come with potential risks, including side effects and uncertainties about the effectiveness of the treatment being studied.

Two clinical trials are underway evaluating an oral therapy called mezigdomide, which is part of a group of novel therapies known as CELMoDs™. CELMoDs, like mezigdomide, have been designed to help remove harmful proteins from cells, potentially killing cancerous myeloma cells and helping the body's immune system to attack these cells as well.

"Despite continued scientific progress, multiple myeloma is still incurable, and many people have periods of remission followed by relapse, making the long-term management of this cancer incredibly important," said

Anne Kerber, M.D., Senior Vice President and Head of Late Clinical Development, Hematology, Oncology and Cell Therapy for Bristol Myers Squibb. "Having many different medicines available for people as they live with this cancer is necessary for the future of myeloma therapy and clinical trials are critical in helping us find the next wave of potential treatment approaches. People who take part in clinical trials play a vital role in how we advance research for this disease and, ultimately, improve outcomes."

About the SUCCESSOR-1 and SUCCESSOR-2 studies:

The SUCCESSOR-1 and SUCCESSOR-2 studies are studying the safety, tolerability, and effectiveness of mezigdomide in combination with other myeloma treatments, compared to standard medicines for multiple myeloma without mezigdomide in adults with relapsed and/or refractory multiple myeloma.

Before joining a SUCCESSOR trial, patients sign their consent, then take part in a screening period, during which a doctor performs several tests and assessments to see if they are eligible to participate in the study. For both SUCCESSOR studies, eligible participants must be at least 18 years of age, have a diagnosis of progressive multiple myeloma, and have received prior treatment for multiple myeloma with certain medicines. After all necessary tests and assessments have been completed, and if patients are eligible to take part, they may enter the study assigned and will be randomized to receive standard multiple myeloma treatment or standard multiple myeloma treatment with mezigdomide. Participation in a clinical trial is voluntary. Once study treatment begins, it will continue until the disease returns or the treatment is stopped for another reason, such as issues with tolerability. There are also follow-up visits to assess the long-term effectiveness and safety of the therapy.

During the study, patients would not be responsible for study-related costs, such as doctor visits, lab tests and procedures. Those costs are all covered by Bristol Myers Squibb. Patients and caregivers may also be able to receive reimbursement for some costs like time, travel, or transportation. 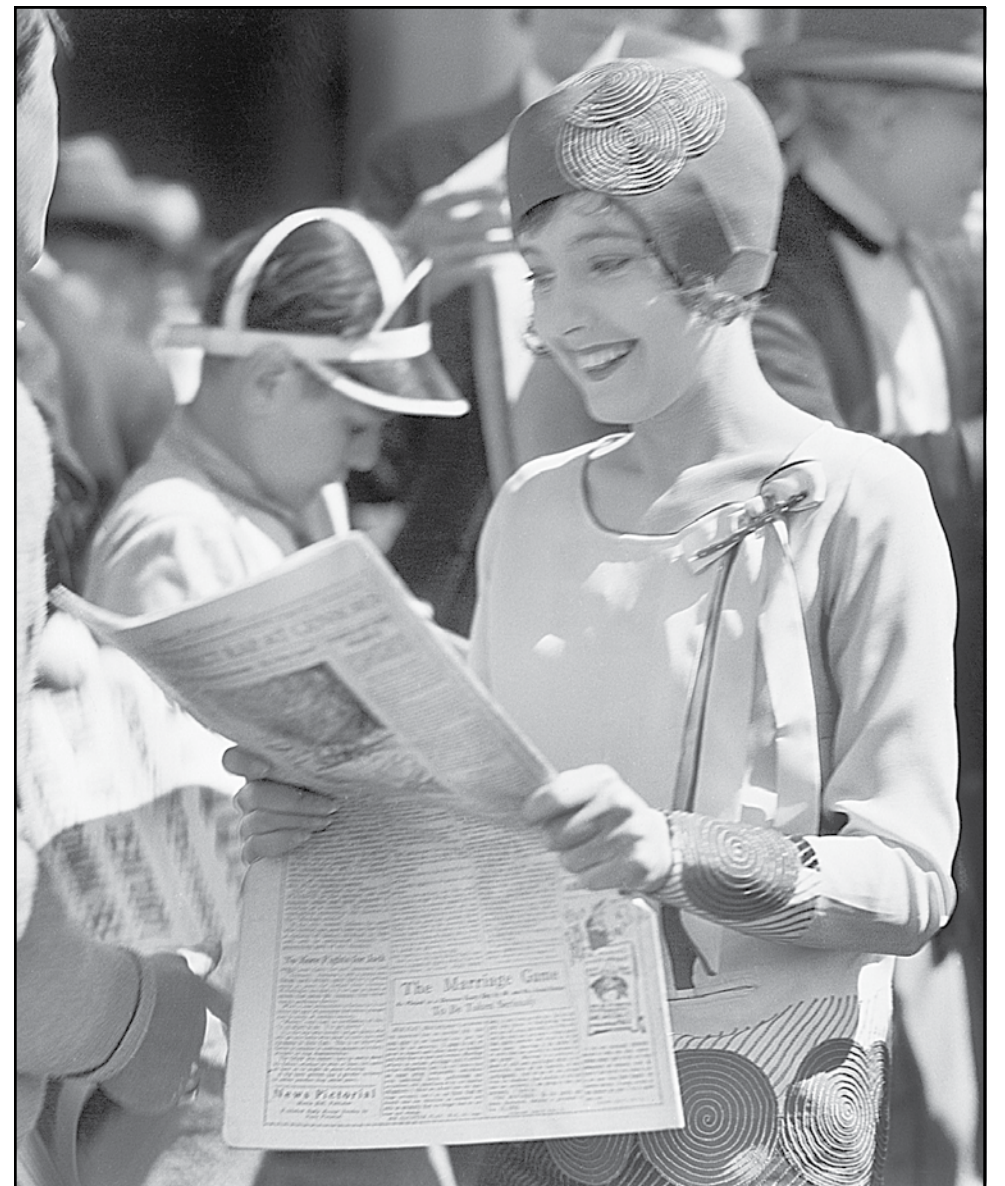

HELLO NEIGHBOR,

El Segundo is a close-knit community of wonderful people. We see each other at concerts in the park and at the local restaurants, bars, and breweries we all love. Our kids play in the same leagues and attend the same schools. So, when elections for local office come around, the yard signs aren't just names; they're people we know personally. Often, we vote for them, assuming they represent our values. But the politics of politeness may actually be holding back those values.
