Three-Year Capital Improvement Program Keeping Public Works Busy

Though it seems like only yesterday when he started here, El Segundo Public Works Director Ken Berkman will celebrate his three-year anniversary on the job on November 1. Asked what he feels is his most important accomplishment so far during his tenure, he did not hesitate in his response: “I pushed for a Citywide facilities condition assessment,” he said. The analysis of the City of El Segundo’s various buildings was one of the key components in shaping the first-ever three-year capital improvement program (CIP). The first batch of such projects approved in the summer by the El Segundo City Council will get going over the next few months. Berkman referred to the initial campaign of the multi-year CIP as a “big step forward” and added that the condition assessment will be pivotal in pinpointing future work to be done at City Hall, the library, Recreation Park, Park Vista and other City buildings. “Before this, we were running blind,” Berkman noted.

The CIP for 2019/20 includes 35 projects with a total price tag of \$9.98 million, of which nearly two-thirds will come out of the general fund. The rest will pull from a mix of water and sewer enterprise funds, gas tax monies, state ballot measure allocations, grants and special funds. Among the big-ticket items: the Indiana Street water main replacement, lifeguard pump station construction, annual roadway rehabilitation, and yearly sidewalk improvement and construction. Work on water mains, sewers, streets, pavement and sidewalks remain the cornerstones of Public Works, Berkman was

quick to point out. “This is the boring stuff in the background that is nonetheless critical to what folks use every day,” he said. “I am proud of the effort to rehabilitate our roads and we have made a great deal of progress the last four years.” Berkman added that the City hopes to reach or exceed its prescribed five-year Pavement Condition Index goal of 73 in 2020. It rated at 65 in 2015, which was also the average statewide.

Key general fund projects for the current fiscal year include construction of Acacia Park (minus a previously planned new pool and restrooms because the Council opted to redirect those monies elsewhere), Teen Center upgrades, Richmond Field renovation, City Hall windows replacement, community cameras and fixed license plate readers, Main and Imperial entryway beautification, and hockey rink rehabilitation. Berkman emphasized that the Teen Center project will first require a needs assessment to determine desired changes to the basketball court, skate park and building. He described the window work at City Hall as vital to bolster security and energy efficiency and said the hockey rink is “a really cool project in partnership with the LA Kings.”

The 2019/20 CIP list allocates \$100,000 for The Plunge replacement scope assessment. A Request for Proposal (RFP) will go out to aquatic center architects, engineers and maintenance experts to assist with the needs assessment and get a sense of the cost to revitalize the community’s iconic pool that has been in frequent disrepair for many years. The Council moved \$1 million

into a Plunge rehabilitation reserve fund both this year and in 2020/21, with \$1.5 million slotted for 2021/22. Rising construction and materials costs will no doubt swell the price for this project well beyond earlier estimates in the \$4 million range, Berkman indicated. Meanwhile, the City can use monies remaining in its aquatic fund towards this project and also look for grants and outside stakeholder contributions.

Next year’s biggest project by far entails improvements to El Segundo Boulevard from PCH to the city’s eastern border. Berkman confirmed that Metro recently approved a \$4 million Measure M package to help cover more than half of the \$7.5 million estimated construction cost (with the remainder from non-general fund sources). “The El Segundo Boulevard project includes pavement rehabilitation, installation of curb ramps and bike lanes, traffic signal poles, video detection, and pedestrian countdown signal heads,” he said. On a related note, a section of El Segundo Boulevard near Main Street now boasts 15 new (though temporary) parking spaces as part of a pilot program approved in the prior fiscal year. The long-term goal is to find much-needed additional parking for the growing Smoky Hollow area.

The CIP also provides more than \$1.3 million over the three years to finally repair and upgrade the plumbing at Park Vista. The \$60,000 this year will cover design costs, with the rest of the money allocated over two phases in 2020/21 and 2021/22 to complete the work.

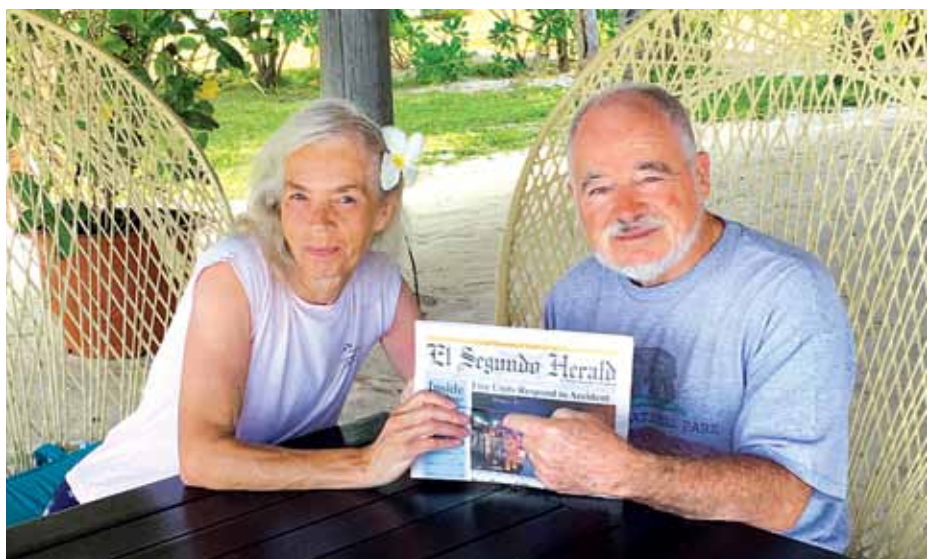

The Latest News on Grand Avenue and Richmond Street

For those wondering on the status of the center on Grand and Richmond that was home to several longtime businesses, a commercial real estate tenant held a long-term ground lease on the property at 210-220 E. Grand Ave. that expires at end of December 2019. The property owners are not renewing the lease and the lease allows the property to be returned in its original condition (vacant lot). In

September, the tenant obtained a demolition permit and recently completed the demolition of the building that contained a laundromat, two restaurants and a bar. An interested company that would like to develop the property with a similar commercial structure is in contact with City of El Segundo staff. The City will share updates and information as it becomes available.

El Camino College to Celebrate Grand Opening of New Student Services Building

El Camino College will celebrate the grand opening of its new Student Services Building with a ribbon cutting, live music, and self-guided tours on Friday, Nov. 1 at 3 p.m. The ribbon cutting will be at 3:10 p.m. with self-guided tours from 3:30-5 p.m.

Strategically located to create a “front door” on the north side of campus, this modern facility features an open, two-story atrium lobby with space for students to meet and study. A new “Warrior Welcome Center” on the first floor is dedicated to student equity and achievement, offering new and continuing students a one-stop location to receive application and registration assistance,

access financial aid information, and speak to a counselor, among other resources. A reorganization of services allows students to receive immediate help in a central location.

The project cost for the 81,000-square foot facility was \$35 million, with funding from voter-approved Measure E facilities bond monies. Features included energy-efficient windows that provide natural light on all sides; drought-tolerant landscaping maintained with reclaimed water; and housing for offices including Financial Aid, Counseling, Special Resource Center, Veterans Services, and First Year Experience.

EIR Released for Proposed Desalination Plant

West Basin Municipal Water District (West Basin) has released the Final Environmental Impact Report (EIR) for a potential ocean water desalination facility in El Segundo. The Final EIR was released following the conclusion of four supplementary ocean water desalination studies and drafting written responses to over 200 questions submitted during an extended 91-day draft EIR review and public comment period that ended on June 25, 2018.

To help ensure water supply reliability for West Basin customers and communities within its service area, the agency developed a goal of achieving a diverse water supply portfolio, as detailed in its 2015 Urban Water Management Plan. For West Basin, water supply reliability can be achieved by: reducing dependence on imported water; increasing water conservation; expanding recycled water production; and developing a locally-controlled, drought-proof

water supply.

The potential Ocean Water Desalination Project addressed in the Final EIR would produce approximately 20 million gallons per day (MGD) of drinking water. This would provide a reliable and consistent West Basin water supply during periods of drought, limited water allocations, or water scarcity due to natural disaster.

Now, as a coastal water agency, West Basin has undertaken its obligation to explore and evaluate a potential new reliable water source. The District is completing the California Environmental Quality Act (CEQA) process to examine the conversion of ocean water into drinking water with technologies that are environmentally responsible, energy-efficient and cost effective.

Since its formation in 1947, West Basin has undertaken a scientific and research-based

Census Workers With Local Knowledge Needed for Jobs That Really Count

The U.S. Census Bureau is looking for a few good men and women – hundreds locally to help conduct the 2020 Census that is critical to South Bay cities and Los Angeles County securing funding for federal programs and protecting seats in Congress. Recent high school graduates, veterans, retirees, military spouses, seasonal workers and applicants who are bilingual are highly encouraged to apply. People 50 and older are considered excellent job candidates. They tend to be reliable, dependable and they know their communities firsthand. “They bring with them years of experience and get the job done,” said Dana Marie Kennedy, the Arizona state director for

AARP. Historically, 50 percent of census takers are over the age of 50 and many are retirees.

“This census, the emphasis will be on an online response,” Andrew Soto, partner specialist with the U.S. Census Bureau of the Los Angeles Regional Office told the Hawthorne City Council earlier this year. “There will still be paper forms if requested.” The importance of an accurate Census count can’t be over-emphasized, federal and local officials stress. Federal funding for Community Development and Building Grants, homelessness and schools is doled out using a formula that is population-based. The once-every-decade census also determines which areas gain or lose seats in

Wisburn School Board Views Cali Dashboard Special Presentation

Last Thursday evening's Wisburn School Board meeting featured special presentations updating compliance with the state-mandated California Dashboard analytics educational tally, and implementation of the Ni Hao Mandarin after-school program at Juan de Anza Elementary.

The Ni Hao Mandarin presentation, helmed by Wisburn Unified School District parents Zalina Visentin and Jenna Boller, included information regarding the current after-school program, videos that portrayed the joy of students who attend the program, parental testimonials, plus next steps as they try to grow the nascent offering.

There are currently 12 students enrolled in the program. Nine were listed as "full-time." Two well-credentialed teachers, Zoe Lao shi and Joy Lao shi, are working with the students, whose after-school activities begin at 12:30 p.m. and can conclude for some at 6 p.m. Their daily activities include "Circle-time," where the focus is on music and movement with Mandarin songs; group learning that includes a theme book in Mandarin; and an enrichment timeframe featuring arts and crafts, with the emphasis on Chinese characters. Then there is a block for "story-time in Mandarin." Also on the daily agenda: Outside playtime and the probably necessary "bathroom break."

Anza Principal Alberto Paredes gives high marks to the program. "Ni Hao gives our students an opportunity to learn a language in a fun, collaborative way," he said. "We are happy to be able to partner with them."

Parental testimonials rounded out the presentation, with a couple of the young program participants being coaxed to sing a Mandarin tune to the appreciative Board.

Da Vinci Charter School administrator Gloria White, who appeared on the boardroom big screen from Sacramento, spearheaded the next presentation remotely. Wisburn Assistant Superintendent, Educational Services Dr. Aileen Harbeck was deeply involved in the gathering and reporting of the state-required data.

The Dashboard is a fairly recent mandate asking educators to help identify strides made by school districts trying to button-down analytic data that does not just reflect the results of a single test score -- but also focuses on perceived disparities among student groups, with more information culled to support the local school strategic planning process.

Harbeck said that the Dashboard allows

educators to provide "self-reflection." White noted that while implementing the Dashboard metrics is "a little scary, with a lot of hard work," she added that the process is "super-fun and super-exciting." The goal of the Dashboard implementers is to improve the outcomes for all District students in a transparent way.

Summing up the Dashboard analysis in Wisburn: All necessary indicators have been "met," including basic services, parental engagement, school climate, and access to a broad course of study. The next steps for the Dashboard regimen include the Nov. 1 end-of-submission date, and the public release of accumulated data in the second week of December.

Wisburn Superintendent Dr. Blake Silvers said he is a fan of the Dashboard. "It gives us the data," he said. "It allows us to look at the data and see how we can match our metrics with what the State considers to be a high performing [district]. We are using the Dashboard quite a lot."

Board member reports then followed, with many looking forward to upcoming events. Board President JoAnne Kaneda noted how things must be humming along because she hasn't received too many stakeholder mis-sives recently.

District CBO Dave Wilson answered questions on the R.H Dana Middle School gym financials. President Kaneda asked about the fact the local fields are "absolutely packed with soccer." She queried, "I would really like to know who is using the fields? There is a lot of stuff going on." She mentioned she wanted to make sure that all users of Wisburn facilities were paying their fair share.

During his report, Silvers thanked White for her diligence in helping compile the Dashboard data and reporting remotely, noting that gathering required data "is not the most fun." He also spoke of his attendance at Peter Burnett Elementary School's Native American artifacts exhibit, giving props to teacher Dorothy Sweeney and adding that it is nice to see how students respond to what he termed "old technology." He also pointed out the continuing District efforts to address perceived safety concerns and continue to ramp up communications to stakeholders.

In other District news, Burnett fifth graders culminated a unit of study with the Native American exhibit on campus that featured students making an artifact at home, which would be displayed at the school. Students were

Legendary Football Coach Steve Shevlin Stepping Down

El Segundo High School has been fortunate to have some great head coaches. If there was a Mount Rushmore of El Segundo High head coaches and it was narrowed down to four, you'd find for the first three Urho Saari (water polo and swimming), John Stevenson (baseball) and Rick Sabosky (basketball) proudly displayed. Each was a legendary coach who brought out the best in their players both on and off their respected field of play for decades. You can add and chisel Steve Shevlin onto that special monument.

Friday night will be Shevlin's final regular season football game as head coach of the Eagles. After 26 years, Coach Shevlin is stepping down. He's adamant that he is not retiring from his athletic director position at the high

and 1980. He became an assistant coach at the lower levels for his alma mater for five seasons before being hired as a teacher at El Segundo High in the winter of 1990. He spent four years as an assistant coach for the Eagles before being named head coach in 1994.

Shevlin's first several seasons were challenging when El Segundo moved into a league with such powers as Mira Costa, Redondo and Rolling Hills (Peninsula). When El Segundo was moved into the Santa Fe League in 2001 it was the start of an incredible run that saw the Eagles win six league championships, advance to the CIF playoffs 15 times in 18 years, make five quarterfinal appearances, reach one semifinal and play in one final. Since 2001, the Eagles have had just one losing season and won 139 games. In that time, the team has

school he has held since 1999. "I'm not going anywhere -- I'll still be the AD. It is just time," he said. He added that the timing was right to pass the program over to a highly motivated, experienced and qualified person.

Coach Shevlin was a standout defensive back for Culver City High School in 1979

a 64 percent winning percentage. With 158 wins overall, Shevlin is the second winningest South Bay football coach in the area behind Don Morrow of Mira Costa.

With Shevlin at the helm the program has established school records for consecutive

Two Problems for Sophia is a sequel to *One Word from Sophia* in The Sophia Books series written by Jim Averbeck and illustrated by Yasmeen Ismail. In this book, Sophia has her One True Desire, her very own pet giraffe named Noodle! Sophia is surprised that having a pet giraffe is a little more complicated than she anticipated. She defines Noodle's two main problem areas:

Sophia's grandma, known as Grand-mamá, happens to be one of Noodle's favorite people. However the feeling is not mutual. Grand-mamá, does not enjoy receiving sloppy kisses from Noodle's long, wet tongue. The biggest problem in the family, though, seems to be Noodle's snoring. It is difficult for anyone to get any sleep when Noodle sleeps because of his incredibly loud snoring. One morning, Sophia's mother orders her to find a perdurable solution to Noodle's problems. Sophia must do everything she can to stop Noodle from being sent back to where he came from, as Grand- mamá suggests.

Sophia then begins her journey to design a snoring solution for Noodle. She begins with research and consults with Ms. Canticle, an

acoustical engineer, who offers an explanation and potential solution to improve his condition. Sophia is unsuccessful in her first attempt to eliminate Noodle's snoring, so she calls Ms. Canticle once more. She works on prototypes, draws up a blueprint, and gathers the right supplies from her family to come up with a new sleeping mask for Noodle. You'll have to check out this book from the library yourself to see if Sophia's creation ends up being the permanent solution her parents ordered!

I thought this book did a wonderful job of introducing new vocabulary to children, especially those interested in science. I also appreciated the inclusive nature of this book, which includes Sophia's multigenerational and diverse family. Film Review

The Irishman: Scorsese Contemplates a Life of Crime in Decades' Time

At 3 hours and 29 minutes long, with an estimated \$159 million budget, and boasting a legendary cast led by one of the greatest living directors of all time, the epic nature of Martin Scorsese's latest film, *The Irishman*, is nearly unfathomable. Quite literally, it's a film with the scope and ambition of being a masterpiece. Scorsese's mob saga is a tour-de-force that leaps through decades to tell a story that is cinematically brilliant and, surprisingly, one of his most emotionally introspective films.

period-piece imagery and superb direction that audiences have come to love and expect from Scorsese, *The Irishman* is also surprisingly introspective, as he examines death and isolation in a closer way than ever before. Of course, plenty of humor is incorporated into the script – which is fantastically acted through further performances by Harvey Keitel and Ray Romano – but it's the film's quieter moments that make it so unique. De Niro's performance – or performances, plural, as he plays Frank through many years of his life with the help

The Irishman, inspired by true events, is told through the point of view of the film's protagonist, Frank Sheeran (Robert De Niro). Confined to a nursing home and facing his mortality, Frank begins to recount his life's story, which Scorsese shows through an expertly intercut series of flashbacks. Starting with Frank's earliest days, we see him driving trucks as a typical blue-collar worker. After unexpectedly linking up with crime lord Russell Bufalino (Joe Pesci) and delivering on personal "jobs" for the mobster, Frank finds himself in his inner circle, quickly climbing the ranks from family man to hitman.

Loyalty and discretion – the traits Bufalino admires so dearly in Frank – are also precisely the traits that union boss Jimmy Hoffa (Al Pacino), President of the International Brotherhood of Teamsters, is looking for in a right-hand man. The hot-tempered and theatrical Hoffa and the cool and collected Frank are on opposite sides of the "composure" spectrum, yet they take to each other instantly and build trust as the years go by. However, good times in the world of organized crime don't last long, and the organization's corrupt inner workings, shady political connections and dangerous rivalries continue to keep Frank and Hoffa on edge, all leading to the infamously unsolved mystery of Hoffa's disappearance.

While the film evokes all of the incredible

of CGI facial mapping – is sublime.

For Netflix, *The Irishman* is last year's *Roma*: a big-budget picture helmed by one of the most respected artists of our time, and at the moment an obvious frontrunner for nominations across the board come awards season. If you're able to see *The Irishman* in theaters this weekend, I highly recommend it. On the big screen, it's much easier to immerse yourself into the film for its entire duration (I fear an at-home Netflix watch, which will be available Nov. 27, will lead many to pause the film and interrupt the experience). But either way, Scorsese's latest is undoubtedly among his best and deserves to be seen in any way possible. •

CIF-Southern Section playoff appearances (7), league championships under one coach (6), quarterfinal appearances (7), one semifinal (tied with Steve Newell) and finals appearance (1).

Shevlin coached some great athletes over the years and he's proud of each and every one of the 537 football players he estimates he helped mentor. Since 2002 the Eagles have had seven different players named to the All-State team, including two who were CIF State Players of the Year. Quarterbacks Matt Engle (2002) and Lars Nootbaar (2013) were both State Player of the Year. Others who were named to the All-State teams in the past 17 years were running backs Gage Mortesen (2008) and Taz Tauaese (2016), linebacker Austin Brasher (2012) and receivers Nigel Nootbaar (2010) and Jamie Stewart (2013). Stewart was also named to the All-Academic State team and Lars Nootbaar was named to the All State team his senior year (2014).

A plethora of his players went on to play at the collegiate level from local junior colleges to Division I programs. One of Shev's former players, Jack Hawley, played briefly with the Buffalo Bills of the NFL. Many former players have come back to assist Shevlin with the football program and there are four others who have made their imprint at a major college or professional level. Jeff Fucci (2002) is the assistant athletic director at USC, Steve Urrutia (2002) is a scout for the Cincinnati Bengals, Wil Reinmann (2011) is an assistant coach at Mississippi State and Austin Brasher (2013) is the strength coach at LMU.

In his own words Coach Shevlin wanted to thank the community in a very special message: "I want to let everyone know I will be retiring as the head football coach at El Segundo High School at the end of this season. It has been my biggest honor to coach all the young men

for the last 26 years who have played for us. Now it is time to let younger coaches take the reins and carry on the great traditions that we have created. I have been privileged to coach and teach young men about the great game of football as the head coach at El Segundo High School. It has been an honor to carry on a great tradition of athletic success that goes back to some great mentors with John Stevenson, Steve Newell, Craig Cousins and Rick Sabosky. These men were a guiding influence on me as we strived to build a program this school and community would be proud of. Without their influence, I don't know if I would have survived the early years of coaching the ES Football program."

Shevlin continued: "Thank you to all of those who have supported me and our coaching staffs during my tenure. Our success is a reflection of all who work to support the greatness El Segundo offers all of us. There are so many people to thank and I may miss some, but not purposely. The program's success can be traced to those doing their part to help put a team out on a Friday night. Thank you to my office soulmates Patricia Guzman and Robin Espinoza. Sincere thank yous go to Bill Watkins, Newton Hart, Ali Rabiei, Jim Garza, Logan Fox and Melissa Gooden for believing in me and our program. Thank you Tomas Romo, Gigi Thompson Rainy Smith, Penny Laster, Gregg McMullin, Gary Summers, Gary and Janet Truesdale, Marcy Dugan, Lee McCullough, Bob Lowe, Craig Cousins, Ray Motta, Bob Motta, Jim Gardener, Louise Davidson, Maxine Walsleben, Gail Stevenson, George Stevens, Tim Harrison and Bennett Rogers for your support over the years. I want to express my gratitude to family supporters Andy and Jo Orens, who have traveled to so many games from their home in

Camarillo. I want to thank Suzanne Rogers, Karyn Ross, Audrey Melton, Keani and Enrique Romero, Rebecca Abbott and George Poppe, Lisa and Joe Caravello and all the families who've hosted team meals. Your help and guidance in all things related to our football program has been instrumental in our success."

Shevlin went on to single out coaches who supported him over the years: "I also want to thank some very special coaches whose love of football and coaching young men has been a privilege for me to work alongside during my tenure: Craig Cousins, Chuck Shaffer, Jason Parker, Jeramie Stewart, Chris Doukakis, Jun Masuda, Shawn Green, Jeff Puffer, Casey Gardener, Tim Duerr, Sean Post, Joey Bolder, Tyler Murray, Nick Kessler, Mike Wagner, Shaun Kemp, Bobby Brackman, Paul Keiser, Dave Watson, and Darin Glotz. Many of these coaches were former players and have come back to share and give back to the kids today. Two coaches in particular I want to give special thanks to are Gene Engle and Dan Heck. Coach Engle's offensive scheme, mindset, patience and humbleness allowed me the time to nurture and grow as a head coach. Coach Engle's faith and belief in the greatness we all have is a testament to what we can achieve when we 'keep the faith.' Coach Heck who served as our defensive coordinator, instilled a toughness and seriousness about playing defense with a purpose, without exception and without excuse, and to win each play -- which was a recipe for success. These two men, without a doubt, are the reasons we are where we are today as a football program."

Shevlin reflected on what he will miss the most about coaching: "To all the players we have coached, I want to say thank you for the privilege to work with each one of you. To have had the

honor to have an impact on so many young men and teach life's lessons through the lens of football has been an inspiring and cherished moment in my life. There are unbelievable life-long memories for all of us that we will never forget. It is true what will be missed most of all is the camaraderie of players, coaches and our community striving together for a common goal. I will miss the day-to-day grind of what it takes to keep a successful program running efficiently. I will miss those kids' smiles and sweat, and tears of joy and sorrow. I will miss the wonderful ES community who has supported us so enthusiastically over the years. I will miss it all. At the same time, I feel it is now time to step back and let others steer the ship. Now is the time to pass the reins on to a new coach, to assistant head coach Shawn Green. He will continue to encourage, build and mentor young men this community will be proud of for years to come."

Last but not least, Shevlin added: "The most important thank you goes to my wife April and my two kids Cassidy and CJ. Football is demanding and takes a lot of energy and time. This meant years of sacrifices for my family each year, including vacations without me. Many weekends April did all the traveling to games, events and lots of nights alone helping with our kids' homework. Through it all, April and my kids were so supportive. Undoubtedly, without April's support, I would not have had the opportunity to coach so many of the young men I have been privileged to help mentor. Thank you again; it's been the honor of a lifetime..."

On behalf of a grateful high school and community as well as the hundreds of athletes you made sure were also students, thank you, Coach Shev! •

the Congress.

Hawthorne officials estimate that every resident in their city who returns a census form or speaks with a field representative brings in \$2,000 per year for community programs.

The positions are temporary and could last between one and three months, starting next year. Job inquiries can be directed to the Census Bureau's Los Angeles Regional Office at 1-800-992-3529 or at Los.Angelos.Jobs@census.govplace.

"We need people to apply now so they can be considered for part-time census-taker positions next spring," said Timothy Olson, the Census Bureau's associate director for Field Operations. "It's important we hire people in every community in order to have a complete and accurate census."

Census Bureau officials have recruited national and regional partners, including AARP and the Boys & Girls Clubs of America to reach as many people living in the South Bay as possible when the counting begins next June. "As a trusted voice in communities around the country, Boys & Girls Clubs can help reach hard-to-count communities, ensuring an accurate census and snapshot of our population," said Julie Teer, the chief development and public affairs officer for Boys & Girls Clubs of America.

Census-takers will be hired to work in their communities and go door-to-door to collect responses from those who do not reply to the 2020 Census online, by phone or by mail. A follow-up head count of urban dwellers can be

done with a short drive out to a home address or apartment building and a knock on the door.

These temporary, part-time positions offer competitive pay, flexible hours, paid training and weekly paychecks, according to a Census Bureau announcement mailed out Oct. 22. Job duties and the amount of travel required vary by positions, which are listed at www.census.gov/about/regions/los-angeles/jobs/all.html. The page (at the bottom) includes tips for filling out a census employment form and special considerations for veterans.

Pay rates vary depending on where the job is located, from \$13.50 to \$30 per hour. The selection process for census-taker positions begins in January, with paid training occurring in March and April. Household that don't respond online or by mail to the Census will be identified beginning in May. That's when teams will be out canvassing South Bay neighborhoods -- and the work will continue at least into June.

Most households in the nation will receive invitations in the mail to respond (online, by phone or by mail) in March 2020. The Census Bureau will begin advertising nationwide in January to increase awareness about the importance and benefits of participating in the 2020 Census.

The 2020 Census officially starts counting people in January 2020 in remote Toksook Bay, Alaska. The U.S. Constitution mandates that a census of the population be conducted once every 10 years. •

approach to evaluating water management needs for the service area and implementing innovative water reliability solutions. During the multiple year drought of the 1980s, West Basin became a pioneer in water treatment technology by inaugurating a water recycling facility in 1995 which now purifies 40 MGD of treated sewage and is world renowned for producing five unique types of customer-tailored water.

West Basin continues this innovative water solutions legacy through its partnerships in groundwater replenishment by expanding recycled water production, evaluating new purification technologies, and by building funding partnerships to increase access to water conservation programs for local residents and businesses.

The potential desalination project site would be an 8 to 13 acre footprint within an existing 33-acre industrially zoned location within the El Segundo Generating Station site (301 Vista del Mar in the City of El Segundo). Today, the site houses a heavy industrial power generation facility, while the proposed desalination water plant is considered a light industrial facility. The potential desalination facility would include a low velocity, screened intake system to deliver ocean water to the facility, reverse osmosis membrane technology, a brine discharge diffuser system to return concentrated seawater back to the ocean, and a drink-

ing water delivery system to distribute potable water to the local and regional supply systems.

A Draft EIR, published in the spring of 2018, evaluated the possible impacts of constructing and operating the proposed project. The report also identified mitigation strategies to avoid, minimize, or compensate for environmental impacts. During the extended 91 day public comment period, West Basin received 213 comments. The Final EIR which has been released provides detailed responses to each of these comments, in accordance with the California Environmental Quality Act (CEQA).

The funds derived from the in-lieu fee may be used by the City to design, acquire and install public artwork in the City, and to support

The proposed ordinance also exempts certain projects, such as certain rehabilitation work or reconstruction of structures that have been damaged, and outlines the proposed process for submitting a Public Art Plan and having artwork approved by the City. On October 10, 2019, the Planning Commission formally considered the ordinance and recommended the City Council adopt the ordinance. The City Council is the final decision-making authority for the proposed ordinance. The project is exempt from the

California Environmental Quality Act (CEQA) pursuant to 14 CCR § 15061(b)(3) of the CEQA Guidelines because it can be seen with certainty that there is no possibility that the proposed ordinance will have a significant effect on the environment. 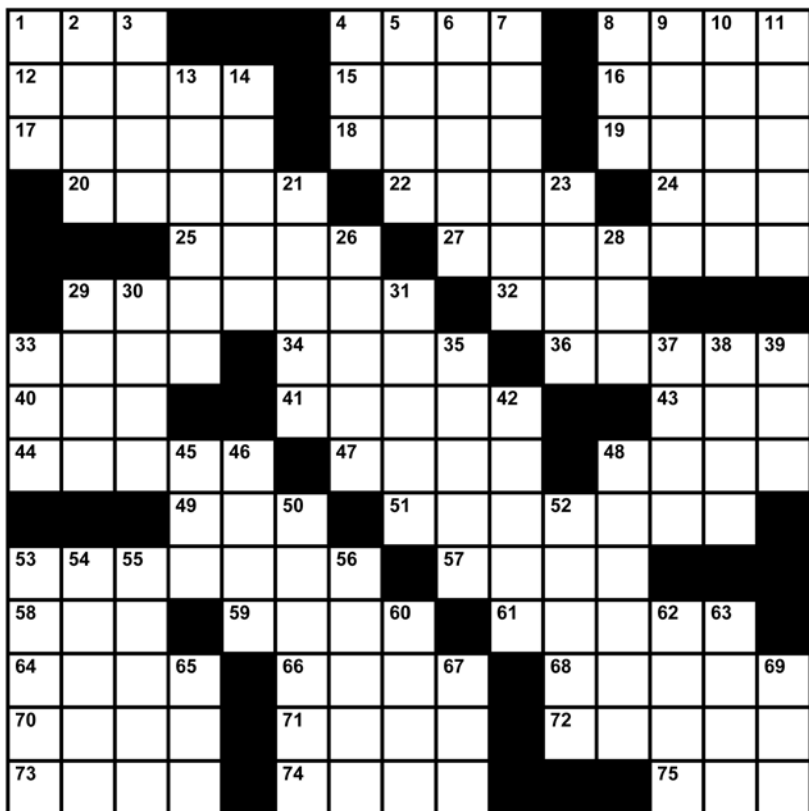

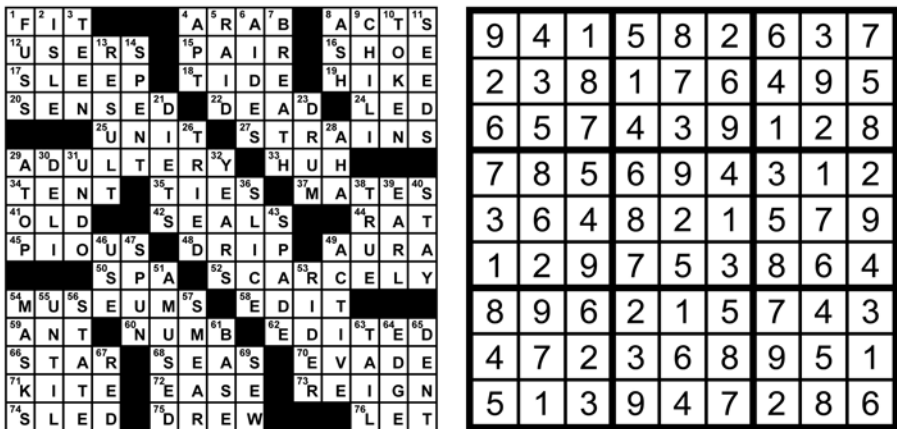

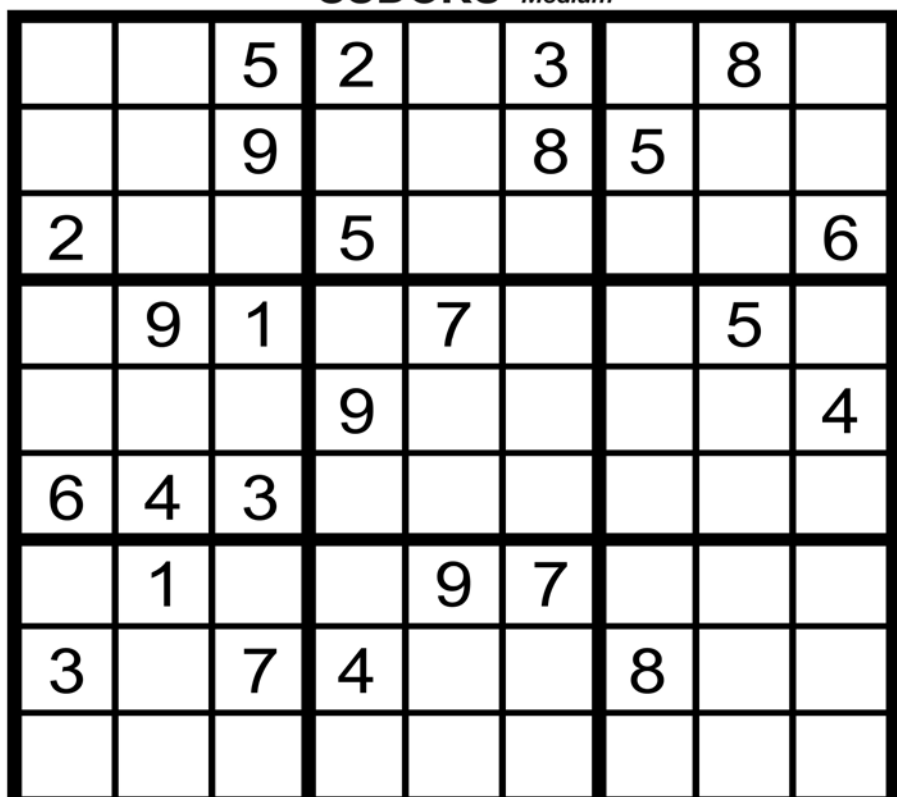

Meanwhile, Berkman and staff hope to garner Measure R transportation funding for one of the largest projects in El Segundo history – the Park Place gap closure and grade separation. The Council agreed to budget \$300,000 each of the next two years towards design, with construction estimated in 2017 at \$55 million (not including potential right-of-way acquisition costs). The construction period could take three to four years. The approval process requires the South Bay Council of Governments to submit the request to Metro. “This is a great regional project and one of the top ones in the South Bay COG

program,” Berkman said. “It will be a great help to not only alleviate traffic on PCH, but also Rosecrans. It will also provide access to the Metro Green Line and Douglas Street Station and enhance access to the Crenshaw/LAX line and the airport’s future automated people mover.”

Starting this month Public Works will get management in place to kick off this year’s projects, followed by RFPs going out for potential consultant work, Council approvals of the plans, and advertising for construction to identify the lowest responsive and responsible bidders for the eventual contract awards. It will

be a busy few years for Berkman and company, with just over \$30 million funded for the CIP over that time. “Our annual delivery capacity is about \$10 million in projects, so we are doing

as much as we can physically do to continue to improve our local infrastructure and provide the services our residents and businesses have come to expect,” he said. •



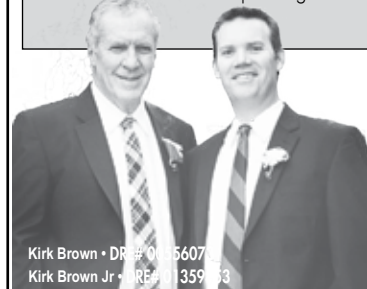
