## Woman With Local Ties Helps Hurricane Survivors Move Forward

The recent hurricanes that battered the southeastern coast of the country were among the worst in our nation's history--devastating communities, destroying homes and businesses, and taking lives. Yet amidst all the tragedy are stories of hope, of people banding together to support one another in this time of crisis, of amazing acts of sacrifice and kindness, and a reminder that there can still be unity despite America's political divide. Then there are the unsung heroes you don't hear much about—those deployed to the ravaged regions and toil around the clock as part of an ongoing, arduous relief effort. One such individual is Jennifer Fogg, whose company Valiant Resources specializes in providing critical support services in disaster-ridden areas. On October 3, she arrived in Hendersonville, North Carolina (just outside of Asheville), where she had a day earlier dispatched a 53-foot trailer carrying 30 washers and dryers to serve the nearby population left without water. Crews wash and dry laundry dropped off for pick-up the next day. The facilities, set up behind a hospital, operate 24/7. Fogg also partnered with another firm providing restroom and shower facilities,

with over 500 assets on the ground utilized by the state to maintain operations and to help those impacted by the storms. "So many communities were without water since the main water lines from treatment plants were taken out by the floods," she said.

Fogg emphasized that she makes it a point to hire local labor as part of her team. "One

employee lost a family member in this event, but needs to work," she said. "It's part of the resiliency the North Carolinians have. They want to be useful and stay busy. We take care of them and help them out with whatever they need."

Fogg managed to save one man's livelihood before even arriving. Desperately looking for

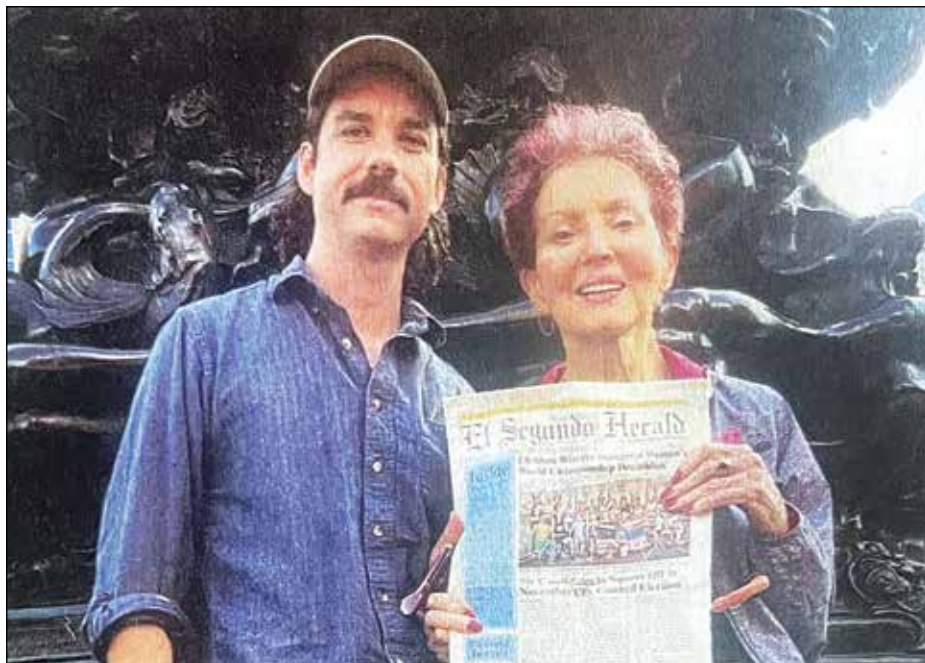

## Cross Country Team Gets New Coach with Same Goal

The El Segundo High School's cross country team is in a new coach transition. Their new coach, Meghan Lukan, has the running and education background to lead the cross-country program. She grew up in the Midwest, Cedar Rapids, Iowa. She says she ran cross country in middle and high school and pursued Exercise Science and Kinesiology while attending Iowa State University. Upon graduating from college, she found herself flying out to California, specifically El Segundo, to start her personal training career. "I interned at a local private training gym in El Segundo." She says she trained at Equinox for two years, and for the past ten years, she has been an independent contractor running her own personal training business. She runs 'Lukan Fit' out of a private gym in El Segundo.

Meghan started her passion as a runner in middle school. "I had a teammate that I looked up to because she was an incredible runner. That sparked my interest in running, and ever since, I have kept that alive." She says she was fortunate enough in college to have the opportunity to train and work with most Division 1 sports, including cross country and track teams. With her experience working with elite runners, she has learned running can be a challenge. "It's not easy but when you equip yourself with the proper diet and guidance, you can achieve results you never thought were possible."

As with any new coach, Meghan's first priority was meeting all of her athletes. She believes that building a team is equally if not more important than the running talent itself. She says, "In order to be successful

we needed to learn and implement the proper steps to work successfully as a team." She said that once she met with the athletes and learned what their individual goals were, she set a plan to achieve them.

Behind the scenes she went to work in creating the workouts for her runners. "We practice Monday through Friday with most of our meets being held on the weekends." Workouts during the week would consist of two tempo or interval training days with the other three days being a long run day. She says the runners could build their mile base and endurance with this type of training. Coach Lukan also likes to incorporate strength training and stretching in their training program. "Their workouts would also incorporate some type of upper/ lower or abdominal exercise so they continue to get stronger."

Helping to keep traditions alive Meghan says is having team dinners the night before each meet. "It gives our runners a chance to have team bonding while enjoying a meal of spaghetti and meatballs dinner with salads, fruits and desserts."

The cross country season is winding down but the team has had eight meets already this season. The team is preparing for the Pioneer League finals on November 7 by competing in the Mt SAC Invitational. The boy's team qualified for the elite sweepstakes heat.

Leading the Eagles this season have been Vicken Semerdjian, Tanner Wilson, Eli Pohlman, Jonah Smigelski, Preston Castro, Ben Mason and Preston Milne-Castro on the boy's side. On the girl's side and Zoe Pollard, Myla Hillman, Sunny Gales, Cynthia Johnson

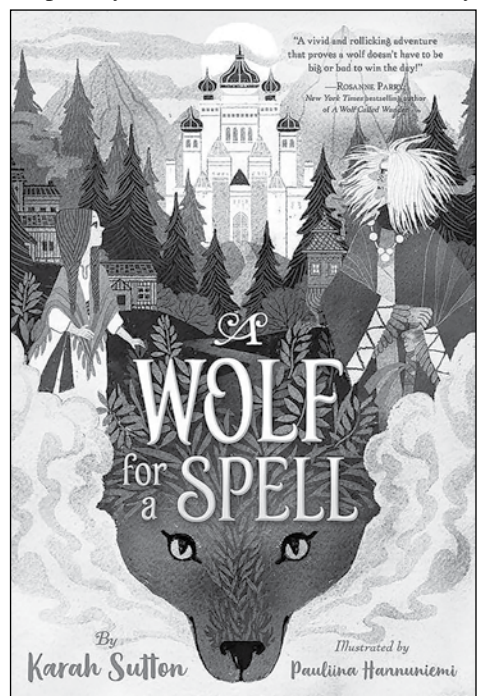
With the cooler temperatures and darker days my taste in books tends to gravitate towards cozy fairytales and this book was a perfect fit.

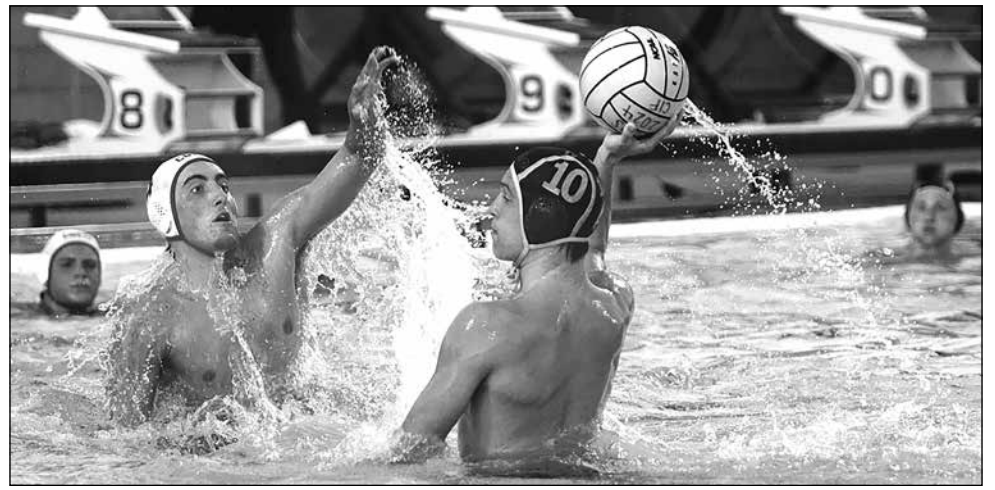

**Water Polo Team Falls in Bay League Final**

For the first time in five years the Eagles won't be league champions. Their streak was snapped when they fell to the Mira Costa Mustangs 7-5 in the finals of the Bay League Championship Tournament.

Mira Costa played tough defense in the opening period that prevented the Eagles from taking better percentage shot attempts. The Mustangs used a strong counterattack to score three first-quarter scores and take a 3-0 lead. The Eagles switched to a different defense to start the second period. Cooper Albano stole a pass inside, and the Eagles countered with a goal from Tristan Foster to Sutton Fisk for a goal. The Mustangs responded with Flynn Guenther's goal a minute later to make it 4-1. Hayden Abbott

worked a pass into Foster, who side-armed a clean shot into the net for a 4-2 score.

Trailing 5-2 in the third period, the Eagles found themselves chasing goals. A minute into the period, Cooper Albano worked a pass to an open Hayden Abbott, who scored from the two-meter area. After the Eagles forced the Mustangs into a shot clock violation turnover, Carter Williamson fired a strike into the net to close the deficit to 6-4.

In the fourth quarter both teams ramped up their defenses. Eagle goalie Stefan Lazarevic made two saves, Tristan Foster had a couple of steals, Vinny Baldino prevented high percentage shots and Carter Williamson's defensive presence was a help inside. Trailing 7-4 with under a minute Williamson scored from the right side to make the final score 7-5.

It will be the first time in five seasons the Eagles will not enter the CIF Southern Section playoffs as a league champion. They will, however, enter the CIF-SS Division 1 playoffs and host La Habra (23-3), the Freeway League champions, today, October 31, at 5 p.m. A win would send the Eagles into the quarter-finals next Wednesday.

**Girls Flag Football Team Drops CIF Playoff Game**

The first CIF Flag Football playoffs were instituted this season. This is the second year of CIF Flag Football, and it was so popular that the El Segundo Eagles formed a program for this season. After a late start the Eagles played a brief schedule of ten games when most other programs had played twice that many.

The Eagles still managed to finish second in the Pioneer League and drew the Highland Bulldogs in the first round of the CIF Southern Section Division 3 playoffs. The

Eagles took the long bus ride to Palmdale to play an experienced team that has won 30 games in their two years, including a 19-5 record this season. The Eagles put up a valiant effort but came up short 38-32 in the historic playoff game.

The Bulldogs employ a team filled with track athletes. Their speed and multi-option offense created problems for the Eagles. With miss-direction laterals and speed on the edges, the Bulldogs used six plays on their opening possession to take a 6-0 lead on a three-yard TD lateral play. The Eagles countered with a three-play and out series. The Bulldogs needed four plays to score and make it 14-0 with their second possession.

El Segundo's nervousness may have led to consecutive uncharacteristic dropped passes. Those jitters changed when Eagle quarterback Allie Stevenson connected with Jaz Ramos and Charli Pages for big gains. Then Stevenson found Pages open in the end zone for a score. The Bulldogs scored their third TD after an interception set up a 5-yard TD pass and increased their lead to 22-6.

The Eagles chewed up much of the first half's final minutes with their seven-play drive. On fourth and long, Stevenson hooked up with Pages over the middle for a first down. Three plays later, Stevenson's 4-yard TD pass to Ava Gutierrez scored with seven seconds remaining; Pages caught the two-point conversion to make it 22-14.

To open the second half, the Eagles struck quickly. Allie Stevenson found Jaz Ramos on the edge for a 55-yard gain. One play later, the Eagles got into the end zone and trailed 22-20 with 21:54 remaining in the game. The Bulldogs scored on back-to-back possessions and led 38-20 with 10:25 in the game.

The Eagles went the distance capped by Charli Pages' four-yard TD pass reception to make it 38-26. After forcing the Bulldogs to turn the ball over on downs, the Eagles scored on Pages' 55-yard touchdown pass reception and made the final score 38-32.

El Segundo matched Highlands' touch-for-touchdown. The difference was the Bulldogs scoring three more two-point conversions and holding the Eagles to one. The 32 points the Eagles scored are the most scored on the Highland Bulldogs in two seasons.

It was an incredible first season for the Eagles. Most of the roster plays another sport so their competitive edge was tested throughout the season. With the popularity of the sport growing, it is hoped that more two-sport athletes will be playing next season.

**Football Team Awarded Forfeit and Prepares for West Torrance Showdown**

The Eagles were supposed to face the Morningside Monarchs, but the Monarchs canceled their game and the rest of their season due to a lack of available players. Morningside High will close its doors in June 2025, citing declining enrollment and other issues.

With the week off, the Eagles prepared for their final Ocean League game of the season when they travel to West Torrance on Friday night to take on the Warriors. The Eagles and Warriors sport a 4-0 league record so the winner would be Ocean League champions. The Eagles are looking for their first league championship outright since 2014 when Lars Nootbaar led the Eagles to the Ocean League title. In 2016, El Segundo was in a three-way tie with Lawndale and Culver City. West Torrance is looking for their first league title since 2014. •

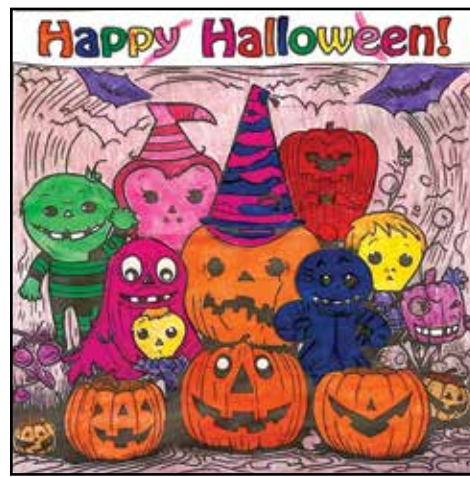

housing in hopes of not having to sleep in her car (which she previously did for weeks at a time during other disasters), she found an owner of cottages 27 miles away who was facing the prospect of a completely vacant property after every reservation canceled due to the storm. She promptly booked all the rooms. "He literally started crying on the phone and said he had been afraid he couldn't make his mortgage," she said.

Yet even with lodging in place, Fogg only averages about two hours of daily sleep during the initial phase of her stints. "And I've lost 11 pounds in two weeks from what we call the 'hurricane diet.'"

Despite what she described as "extraordinary damage," Fogg pointed out that this particular storm (Hurricane Helene that brutalized the region in late September) was unusual. "When I go to a disaster site, it's typical to have no water or power 100 miles in any direction for up to a month... but the weirdest thing with this location is water goes where it wants to go," she said. "Gravity is part of that, and it's a very mountainous community along with the way the infrastructure was designed. So, the damage is extensive but also sporadic. You can go to an area with debris piles 30 feet high with no roads or access at all and then go 10 miles away and order a McDonald's cheeseburger. It's so different." Still, as of the time of the interview, a curfew was still in place, and many roads were completely washed out.

Through all the harrowing destruction, the people still push forward. "Resilience is a big deal, and these North Carolinians have been through so much," Fogg said. "We have seen some horrific things, but they want to take care of themselves. They don't want to be taken care of, so we are sensitive to that." The North Carolinians also step up to support each other. "We've seen so many acts of kindness. There was a guy with his credit card at a gas station going to every machine and filling up gas tanks for people. Staying positive is one of the most important things you can do in this kind of work."

With all the conflicting media reports, Fogg was quick to confirm that FEMA (Federal

Emergency Management Agency) has a "very visible" presence in the area. "I've supported FEMA for 20 years, and I only see them doing the best they can, putting the right resources in place and truly caring about the communities they serve," she said. She reported that shelters in the area are "well-organized" and offer a variety of services with hot meals, baby supplies and other essentials readily available for those who need them.

Other than her work with Valiant, Fogg has a substantial entrepreneurial background. She has been a CEO five times. Her first business was a window washing company she launched at the age of 12. She sold it for \$2,000 to a high school senior. "My first real job was with an advertising agency," she added. "I had my own agency within two years." Among other resume highlights, she also ran a financial services company and is an executive business coach.

When she wraps up her contract in North Carolina (it will likely take many months), Fogg will return to her home in Oklahoma City. She recently retired, although she remains available when there is a disaster. She also hopes to eventually visit her stepmother, Joan Parker, who resides in El Segundo. Her father, Craig Parker, sadly passed away two years ago. The

couple originally moved here in the late 1980s and became beloved fixtures in town known for their community involvement and support of various groups and causes. "I love El Segundo, and it is so dear to my heart," Fogg said. "My kids have their prints in Handprint Alley, and we have stepping stones on the walk."

As a teenager, Fogg could often be found hanging out in the popular local eatery Wendy's Place Cafe (where she was allegedly the only person given a copy of the secret coconut cream pie recipe by the late owner) and later on helped facilitate the first Leadership El Segundo class. Among other notable achievements, she became an Explorer with the Irvine Police Department when she was 18; was hired by law enforcement to research child drownings at the age of 20; and was featured with her stay-at-home husband in a *People Magazine* article entitled "Daddy Day Care"—eventually appearing on the *Montel Williams Show*. The couple raised four daughters—all successful in their fields.

Meanwhile, Joan Parker expressed her pride in her daughter's accomplishments. "Jennifer loves to make life a little easier for people in difficult situations," she said. "Her positive attitude and cheery disposition show them that somebody cares."

Fogg launched Valiant Resources 20 years ago initially as a general contracting firm for military and federal projects. When a "friendly competitor" pleaded for her help in the wake of Hurricane Katrina in 2005, her business model changed. "I was very busy raising my daughters and running my business, so I didn't have time to watch the news," she said. "I didn't know what Katrina was. I initially said no, but she kept calling and finally offered me \$25,000 to come for the weekend to help manage operations. So I flew from Sacramento to Baton Rouge. That was in September of that year. I didn't get home until February." Since then, she has responded to almost every major disaster in the United States.

One of those disasters was the infamous Hurricane Sandy, which tore through New York and New Jersey in late October 2012. As it happened, a federal agency official contacted Fogg on Halloween that year asking for her assistance. "They wanted a solution, as the country had never faced anything like it before," she explained. All at once, Long Island was completely without power, storms and fires raged, and the forecast was for five to seven feet of snow the next day. Meanwhile, the presidential election was less than a week away. While she can't get into the details, Fogg devised a plan that ultimately enabled New Yorkers to vote and, in the process, secured her role in political history by averting potential electoral college mayhem. In the aftermath, she earned Small Business of the Year honors from the US Department of Homeland Security. "It was one of the most rewarding experiences of my career," she said. She went on to laud the efforts of others in the disaster response industry. "There is a robust network of companies that do this type of work. We're all in a support role for those agencies doing the best job we can to get people the resources that they need..."

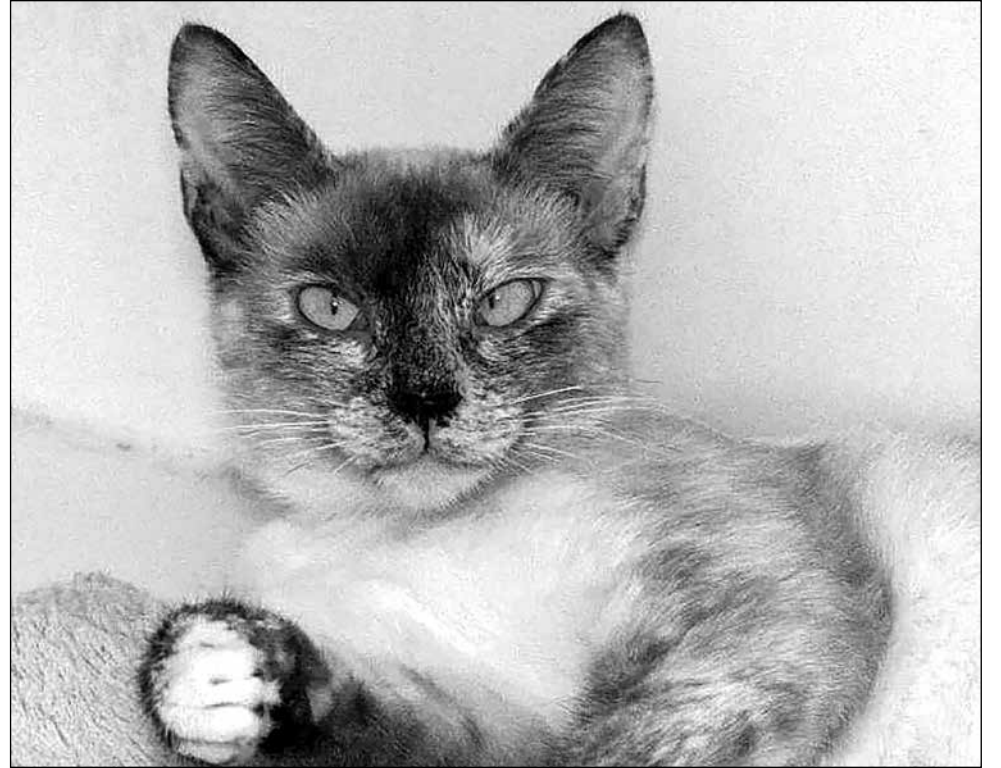

## Film Review

Cardinal Lawrence, although a strong candidate for the position, insists that he has no desire to be Pope. This opens up the election to members, with a few frontrunners quickly gaining traction. Cardinal Bellini (Stanley Tucci) of the Vatican, Trembley of Montreal (John Lithgow), Tedesco of Venice (Sergio Castellitto), and Adeyemi of Nigeria (Lucian Msamati) attempt to convince the majority of members why they deserve the holy position. Each hopeful brings with them a different agenda. Cardinal Bellini is more forward-thinking and progressive while Cardinal Tedesco romanticizes more conservative propaganda. Not surprisingly, the conclave is politically charged and fraught with conflicting ideologies. However, once a dark horse is introduced into the fold, Cardinal Benítez of Kabul (Carlos Diehz), the energy inside the Vatican undeniably changes.

Cardinal Benítez is a soft-spoken man who goes nearly unrecognized at first. At first,

his presence concerns Cardinal Lawrence because his arrival is unannounced. Once the wayward Cardinal declares his interest in assuming the role of Pope, a few members of the congregation begin to suspect something is awry. Behind the locked doors of the Sistine Chapel, Cardinal Lawrence suddenly finds himself at the center of a conspiracy that could not only disrupt the conclave but dismantle the very foundation of the Catholic Church.

*Conclave* is not only a staggering political thriller, it is also a stunning visual achievement. The moment the Cardinals descend onto the Vatican wearing their blood-red robes is the moment my eyes grew wide just trying to take it all in. It's easy to feel the weight of the film's richness and depth. Every frame could be a painting. The script is equally as strong. For as sharp and cunning as it plays, *Conclave* is unexpectedly funny in certain moments. As the Cardinals ponder over elect-

ing a leader, one member proclaims that the candidates may not be ideal so they need to vote for the "least worst option". This line hit harder given the political climate right now, and had the audience in stitches. It can be hard to toe the line between serious grounded drama and dark comedy but screenwriter Peter Straughan does so with finesse.

From the esteemed casting to the perfect

score by Volker Bertelmann, *Conclave* is absolutely not to be missed. Filmmaker Edward Berger is no stranger to bringing stories of epic proportions to life. His last film, *All Quiet on the Western Front*, was nominated for Best Adapted Screenplay at the 2023 Academy Awards. Given its gravity and impressiveness, *Conclave* should earn him another trip to the Oscars. •

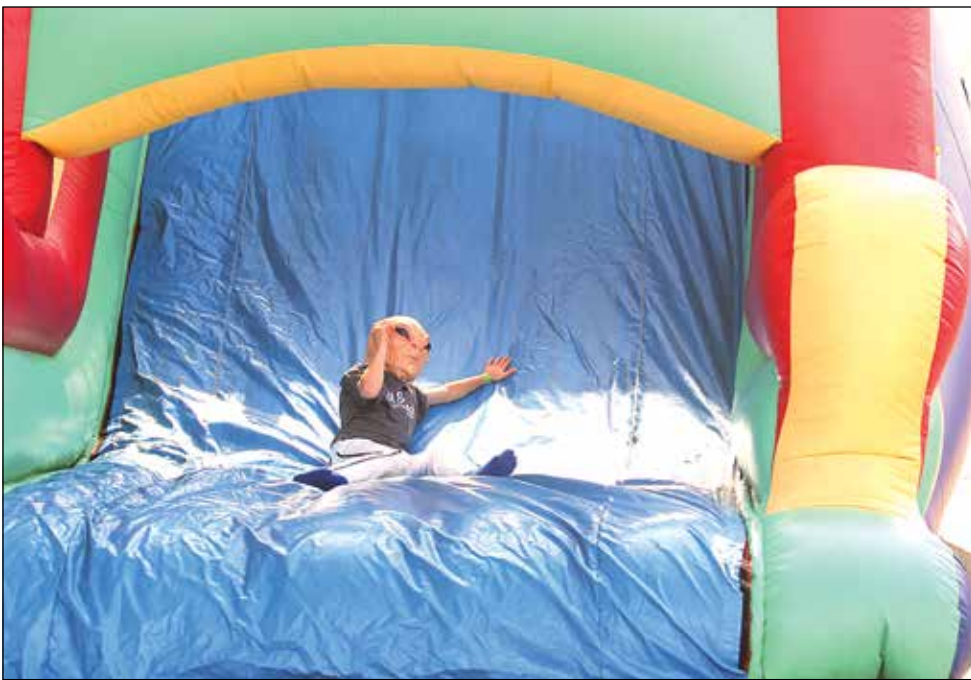
