Sandy's Rotary Striders Walk for a Cause

The Michael J Fox Foundation Walk/Run Series promotes awareness and is a fundraiser for fighting Parkinson's disease. The goal has always been to bring a unified Parkinson's disease community together around a shared goal: to cure Parkinson's. Since its inception in 1994, the event has dramatically scaled — from 200 participants in its first year to 11,000 around the United States and more than 30 countries by 2019. The 2023 goal of \$1.1 has nearly been met, especially with communities coming together to host their own walk/run events.

What is Parkinson's disease, and how does one come down with it? Parkinson's disease is a brain disorder that causes unintended or uncontrollable movements, such as shaking, stiffness, and difficulty with balance and coordination. Symptoms usually begin gradually and worsen over time. As the disease progresses, people may have difficulty walking, talking, and, in some cases, difficulty eating. Symptoms start slowly. The first symptom may be a barely noticeable tremor in just one hand. Tremors are typical, but the disorder may also cause stiffness or slowing of movement. Symptoms often begin on one side of the body and usually remain worse on that side, even after symptoms begin to affect the limbs on both sides.

Research and studies of Parkinson's disease suggest that a combination of genetic and environmental factors, such as exposure to toxins, may be a factor in getting the disease. In Parkinson's disease, certain nerve cells called neurons in the brain gradually break down or die. Many of the symptoms of Parkinson's are due to a loss of neurons that produce a chemical messenger in your brain called dopamine. The biggest risk factor for developing Parkinson's is advancing age. The average age of onset is 60, and

men are more likely to develop Parkinson's disease than women. Genetics is thought to play a role in Parkinson's, but in most cases, the disease does not seem to run in families.

This incredibly unselfish and giving group of individuals called themselves 'Sandy's Rotary Striders.'

In this diverse group of community members are architects, business owners, realtors, educators, and Eagle scouts, as well as others. These compassionate people came together for a common goal: to raise funds for studying a cure for Parkinson's disease while creating awareness of the disease and honor a true friend and fellow Rotarian.

As far as tracking miles, each team member was responsible for tracking their mileage, whether it was a Fitbit, iPhone, iWatch, etc. Then, each night, team members would log into their team member page and log their miles for the day. The group only came together as a group to walk one time. The rest

Field Use Priority a Sticking Point for City Council

A Joint Use Agreement between the City of El Segundo and the El Segundo Unified School District moved one step closer to approval last Monday night during a Special Meeting when the El Segundo City Council voted 5-0 to approve what city staff presented with a few additions. The current joint use agreement, which expired on September 1 of this year, according to city staff, had previously been extended for a year in 2022 to allow time for both parties to discuss, add, eliminate, understand, and approve a new Joint Use Agreement for Public Recreation Facilities and Media and Studio Equipment. The Council's unanimous approval Monday

night provides 45 days in which the school board can look at the agreement and approve it. It directed city staff to meet with school district staff to go over each entity's field use policy and to develop an outline of what groups are using what facilities and fields when.

After an exchange between Council member Lance Giroux and Council member Ryan Baldino during Monday night's meeting, Mayor Pro Tem Chris Pimentel stepped in. "Can I restate 'cos I feel like we're losing a little bit of the (unintelligible). So the purpose last time of asking that these additional facilities be included in this sort of total community

Board Hears Update on FLIGHT Program

Dr. Jack Plotkin, Executive Director of Innovation and Student Support, presented to the ESUSD Board of Education on the establishment of FLIGHT. This is the district's first community-based instruction program to meet the needs of special education students ages 18-22 and Wellness Centers at both secondary schools. Participating students have completed high school and are continuing their education by learning additional skills. Currently, ESUSD has five students participating in the program.

FLIGHT is an acronym for Foundational, Living Skills, Independence, Growth, Health and Wellness, Transferable Living Skills, which are key components of the program. During FLIGHT, students participate in volunteer, non-paid work experience arranged through community-based instruction outings and are taught and guided by a special

education adult transition teacher.

FLIGHT works collaboratively with service providers in the area, including psychologists, behavior interventionists, speech and language pathologists, and occupational therapists. The program aligns with the Individuals with Disabilities Education Act (IDEA) and available opportunities within the community.

The board approved a tentative agreement with the California School Employees Association Chapter 71 (CSEA) for the 2022-23 Fiscal Year.

Eagles Finish Off Regular Season 28-0

The El Segundo high school's water polo team finished their 2023 regular season with a couple of wins against the Beverly Hills Normans and the Downey Vikings. The 18-4 win over Beverly Hills was preceded by Senior Appreciation Day, giving them their third consecutive undefeated league championship. The win over Downey was a good test for the Eagles before entering the CIF Southern Section Division 3 playoffs.

Seniors Honored Before Beverly Hills Matchup

Before playing the game against the Normans, the Eagle's water polo program honored their eleven seniors. Each of them was introduced by an underclassman, including Luc Giroux, Patrick Wang, Caedon Buhr, Max Hale, Nolan Barnett, Dane Mackerer, Logan Fastman, Will Kerker, Patrick Ezo, Andrew Felix and Brayden Ward.

The lopsided win over Beverly Hills wasn't unexpected. The Eagles had outscored their Pioneer League opponents 191-31 in the first nine games and had defeated the Normans 18-5 the first time they faced off against

each other. The Eagles got off to a quick start when Logan Fastman took a pass inside and backhanded his shot into the net. The Normans' aggressive defense caused numerous penalty shots during the contest. Caedon Buhr obliged by firing a shot on the Eagle's next possession to make it 2-0. The Eagles increased their lead when Max Hale waited for an opening and made a shot from the 5-meter area. Tristan Foster closed out the first period by scoring with his shot from the top to make it 4-0.

Head coach Nila Ward kept her roster active when she continued changing the lineup throughout the game. There wasn't much of a drop-off between the shifts. The offensive and defensive ends were in step with each other, showing just how deep the Eagles are.

In the second period, Logan Fastman worked himself inside and scored off a rebound attempt by Nolan Barnett. Junior left-winger Carter Williamson was active with his passing. It resulted in an assist to Tristan Foster, who was set up inside to make it 6-0. On the next possession, Williamson fed Cooper

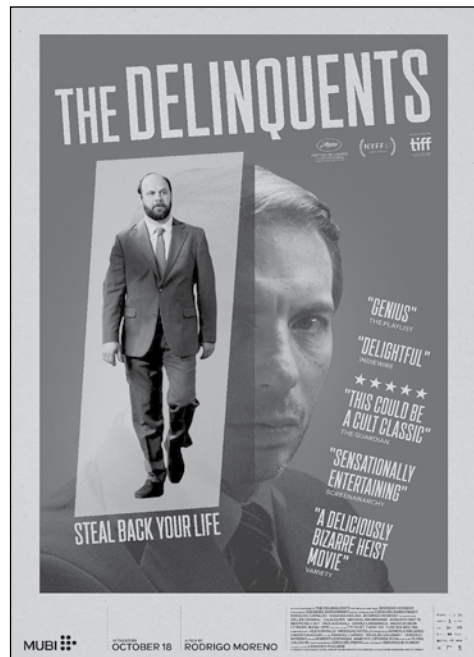
Film Review

The Delinquents Will Make You Want To Finally Live Your Life

A “delinquent” can be either of these things: someone who violates the law, or someone who is overdue in an action. In Rodrigo Moreno’s film *The Delinquents*, the meaning applies to both. In this case, those who break the law in order to rectify something they are crucially overdue in doing: finally living their lives. What starts out as a dryly funny bank heist comedy, *The Delinquents* ends as a poignant meditation on the sacredness of life that will inspire those who seek out this special film.

The film opens with a hilariously drab shot of a colorless suit laid over a chair. It’s the

sad uniform of Morán (Daniel Elías), a lifeless bank teller who handles large amounts of money each day for a living, without the faintest trace of joy on his face. One day, Morán nonchalantly enters the main bank vault alone. Staring into the security cameras, he casually proceeds to put over \$650,000 in cash into his bag and walks out of the building.

Morán then meets up with an unsuspecting colleague, Román (Esteban Bigliardi), informing him of the illegal act he performed earlier that day. Román also learns of Morán’s grand plan: that if he looks after the stolen money while Morán serves out his sentence (which he’s calculated to be just over three years; less with good behavior), he’ll receive half of the money—which Morán reasons would equal five years’ worth of salaries working at their soul-crushing bank job. Initially reluctant, Román agrees, and takes the money to hide. After all, what could possibly go wrong?

What begins as an impulsive agreement to accept a sizable fortune turns into full-on anxiety for Román—especially after a strong-willed detective enters the picture and signs start to point to his involvement. Román decides it’s not worth it, visiting Morán in prison to inform him he can no longer keep the

money. Morán—who himself is experiencing the unexpected roughness of prison life—tells him of a hidden nature reserve where the cash can be stashed. Román buries their fortune, but not before meeting a group of friendly strangers at the lake: Norma (Margarita Molino), Morna (Cecilia Rainero), and Ramón (Javier Zoro) (yes, they are all anagrams, signaling a cosmically fated connection that we all share with one another).

It’s here where the first act ends, and where the film takes on an entirely new tone in its second act: one that’s less comical, and more observant about life’s beauty when you’re finally outside of the system. Ramón embarks on a new passionate life path with Norma, avoiding the stresses of his job as well as the family he left behind. The film moves from the busy city into the wide expanse of nature, where Ramón, Norma, and his new friends live (and where Morán may still be connected to this new group of strangers).

Rodrigo Moreno’s film is an incredible work of art, ultimately revealing how people can let their jobs become their life’s meaning and forget the source of true happiness. Moreno’s ways of slowing the movie down to reflect this, such as dancing to a long song, hearing a full-length poem read aloud, and simply witnessing beautiful shots of rolling mountains, are flourishes that remind us as viewers to slow down and experience these “unproductive” but beautiful moments without a “productive” value.

The Delinquents is a long movie. At 3 hours and 9 minutes—complete with two chaptered parts—it’s something of an odyssey to endure. Ironically, the film (Argentina’s official entry to the 2024 Academy Awards) is about the preciousness of passing time, and how we shouldn’t waste a single minute of it. To that end, you might think that watching a three-plus hour movie might go against its own message, but I’m here to say that you’d be wrong. *The Delinquents* accomplishes its mission in the final scene, proving it has the impressive and magnificent power to make you reconsider how you live your life. •

Death of a Bookseller by Alice Slater

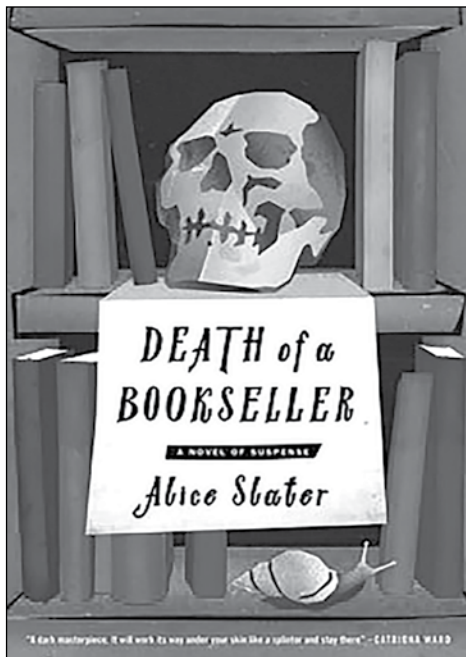

In Alice Slater’s debut novel, the protagonist Roach, as she calls herself, works for a chain bookstore in a branch that is plagued by low sales. She is obsessed with true crime, especially serial killers. She has worked for the bookstore her entire adult life, but does very little work, doesn’t like the customers, and uses phony customer names to order titles that she keeps for herself. Her life is contained in the black bubble of death, revolving around her passion for the genre, scoffing and hating on “wannabes” who jumped on the bandwagon when true

crime became trendy.

When employees from the main branch arrive for an overhaul of the failing branch, Roach cannot keep her eyes off of Laura. Roach senses something in the golden girl aura of Laura and is convinced they could be best friends. Despite repeated attempts, Laura has no interest in a friendship with Roach. She rebuffs her entreaties and is dismissive and disdainful. Roach is not about to let this rest. Her burgeoning obsession with Laura tangles up in her obsession with serial killers. As she delves deeper into Laura’s past, she begins to realize they have something in common. The journey to discover Laura’s secret takes her on some very twisted turns. Roach doesn’t like no for an answer.

This is a creepy, dark thriller with a slow burn. Keep the light on when you read this and be sure you have plenty of time because it is a hard one to put down. •

The Eagles have worked hard all season long, and they know what is at stake. If you have the opportunity to watch history unfold, they play today at home at 5 p.m.



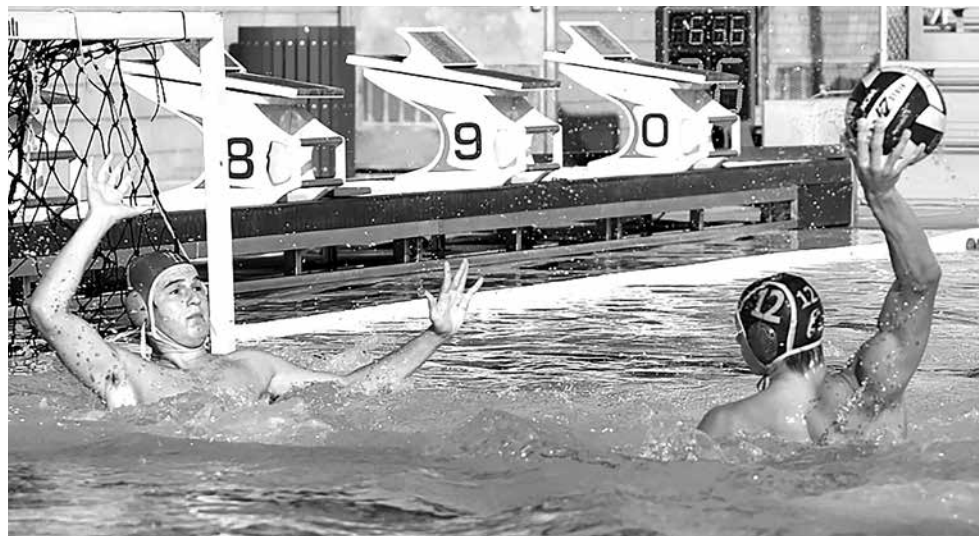

pool of fields was to make sure that the 7,000 user groups that we get beat up about having field space have field space. And I think to council member Giroux, let me try and restate this, but I'm going to butcher it, is it doesn't help us if we add capacity but because the algorithm they use doesn't let those teams on it because their algorithm doesn't prioritize 501(c)(3)s (i.e., AYSO). So I think the case is that if we add this capacity, these look great on paper, but if no one can get access to them because they use a different scheduling priority list, then we've sort of gone in a circle... But it would, to Councilman Giroux's point, be worth knowing, and if we have a system where yeah, they've got a practice field we could use, but it's been rented already for the next ten years, ya know, it doesn't help us any. And then this agreement, it would have given us sort of nothing on it. So, I think it's a valid concern. I don't know what to do with that. I mean, do we have the moral courage to blow something up in a year if we're not getting on there? I'm not sure we need to walk the dog on that one."

Just before the exchange mentioned above between Giroux and Baldino, City Attorney Mark Hensley said, "Again, I think the reason the word 'district' was substituted into paragraph three rather than 'school' was to get at the point that..." Mayor Drew Boyles then asked him to speak up a bit. "I think the reason that in paragraph three, the word 'district' is substituted instead of 'school' is to get at the point that council member Giroux is making. And so, you know, we can take this if the council approves it and make it clear to the district that the intent is

that if it's not a district program, meaning high school sports, whatever is part of the school district as opposed to Pop Warner football, that the expectation is the city has the next level of priority. If that wasn't the intent of changing this word, then I don't understand why it was changed, but that was my understanding. But if that turns out to be incorrect, we can bring this back to the council."

During the meeting earlier, Giroux stated that if the city is entering into a joint use agreement with the school district, shouldn't both parties have the same field/facility allocation policy? He noted that he has seen club sports use school district fields five days a week, for which he guessed the district might receive \$180 per day. He noted that the city priority policy for field/facility use is the city first, then the school district, then 501(c)(3) organizations, and then club sports groups. He later said he didn't know why the school district was being "so secretive" when it came to stating their field usage policy, noting that if the school district isn't using a field, then the city should have the next priority. "We talked about prioritizing the kids in town, so I just want to make sure we're doing the same thing," said Giroux. Recreation, Parks and Library Director told the council that in her meetings with school district representatives and staff, they did not go into the level of detail as to who uses each other's fields and how many hours each group uses them for, but that they did discuss "how many hours we use of each other's facilities."

Baldino held firm with his intention to get the Joint Use Agreement approved and moving forward at this Special Meeting and

noted areas of agreement with the school district in meetings he'd been involved in. "How do we get these field spaces that the district has and aren't being used? How do we get them into our scheduling system so that our user groups can use them? And the idea is, 'OK, if we're not using them for district purposes, then they'll be opened up to you, the city...'"

Said Baldino, "This can come back to us in six months. We can approve this now and see how it is working. And if we need to make changes, we can. But we've already been a year into this about a joint use agreement. And I think we spent a lot of time, a lot of staff time has gone into it, so why don't we set this thing up and see how it goes? And if we need to come back and make an adjustment, we have the ability to do that." Giroux pushed for transparency from the district as to what the fields are being used for now.

Said Hensley, "Because I think that's what the issue is council man Giroux is asking, 'Are we getting equal, is this being treated equally? That is, when we have city purposes, are we giving the district the next line of availability? And is the same thing working here? If the district's not using it for its purpose, is the city getting the next line of availability?'"

Said Baldino, "Yeah, I'm not sure that was the intent in our meetings. The idea was if you have district field space that's not being used, how do we capture that into our scheduling system? How do we get that so that the city, instead of it just being vacant and not used for any purpose, how do we make sure that kids are out there using that field? And I think what you're trying to get

at is how do we use this agreement to try to change or modify the district's field-setting policies. I think that's two totally different conversations."

Said Giroux, "Well, if you're saying that we're looking at whatever the leftover space is on the fields, I'm quite certain there isn't any. Look, I can; we can all go out there five days a week. I've been there. I know, we all know what's there. My daughter plays lacrosse for the high school team, and she's been practicing at times on Campus El Segundo. Why? In season. So, all I'm saying is that let's just be transparent in the process. We would ask the same thing of anybody."

Council member Carol Pirsztuk noted that she's heard outside groups negotiate field use months in advance with the school district, and then when AYSO attempts to book the fields, they're already booked. She suggested someone could work with AYSO so they can book field use in advance and not at the 11th hour.

The joint use agreement, as approved Monday night, also changes the term from ten to seven years with a "re-opener at four years," the district agrees to share the pro-rata cost share of one-time equipment upgrades that benefit the school district and an agreement for the city and district to meet twice annually to schedule fields and facilities with the city's Director of Recreation, Parks and Library and District's Chief Business Officer in attendance. Both agencies will come back to the city council with use policies and intended uses for the next 12 months or so. The city council expects to review the agreement at its first regularly scheduled December council meeting. •

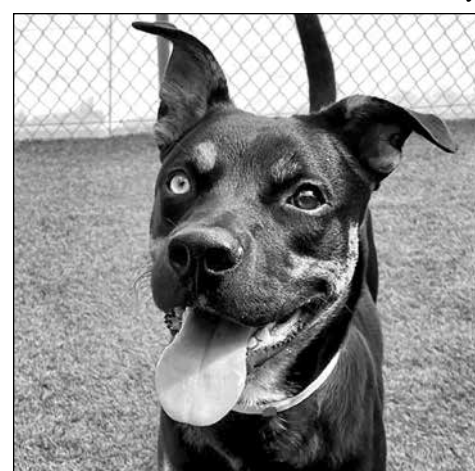
