El Segundo Council Rubbish Discussion Keeps City 'Business-Friendly'

In just under two hours, on a night in which the voters of the United States would decide their next President and El Segundo residents would elect three residents to the council, the El Segundo City Council tackled a recommendation from city staff to allow only four trash haulers to be granted commercial solid waste non-exclusive franchise agreements, turning away at least eight other trash haulers currently doing business in the city, preventing them from working in El Segundo.

In other news, on two 5-0 votes, the city council granted the "existence of an emergency" that authorized the "Award of a contract without competitive bidding for the permanent repair of the City of El Segundo Wiseburn Aquatics Center pool heaters. Installation of the new pool heating system will close the Aquatics Center pools in July and August of 2025, according to Public Works Director Elias Sassoon.

At least five people weighed in on the commercial trash hauling proposal during Public Comment, two expressed their appreciation of the proposal and the selection process. Those two voices were from American Reclamation and Waste Management. The other three voiced their opposition to the proposal. One speaker, resident Shari Metcalf, advocated for the small "Mom & Pops" trash haulers, saying she had run her own commercial trash hauling company, A and A Waste and Roll-Off Services, Inc., with her husband and a partner from 2000 to 2016 and then sold it to another small company, Patriot Services. She said that when customers deal with smaller companies, they tend to receive better service and not feel like a number and less important. They don't get repeatedly transferred when calling by phone, which is annoying. She said the city was selecting larger commercial trash haulers in its four recommended choices: Waste

Management, Athens, EDCO, and American Reclamation. She told the council that she had called one of the four for a quote for service on a commercial property she owns in El Segundo and that the quote was three times more expensive than what she currently pays.

"Why would you want to remove a company that provides great service to its customers and at a better cost?" asked Metcalfe, referring to Patriot Services, noting that under city staff's recommendations, Patriot would no longer allowed to operate in El Segundo. She also cited the city's statement on one of its websites that El Segundo "is a great place to grow your business or your family..." when denying small businesses the opportunity to do business in the city.

The two brothers who own Patriot Services. John and Barton Keuroghlian, were also present Tuesday night, with John addressing the council, saying they service more than 25 percent of the commercial and multi-family customers in El Segundo. He noted that they have been serving the city for 14 years and that their growth has been organic due to their "commitment to personalized service and our dedication to exceeding customer expectations." He also said, "We are consistently reinvesting in our business and the community by acquiring state-of-the-art equipment, including metal containers, carts, and a brand-new collection vehicle that cost us over \$400,000." He noted that the company has the "ability and resources to assist the city to meet compliance thresholds set by the State of California."

Mori Bellicoff, co-owner and president of Haul Away Rubbish, said his company's business has always been about recycling. His father started the company in November of 1949, and second, third, and fourth generations are now working at the company. He noted that his father had achieved 90 percent diversion


with Rold Gold Pretzels around 1960 before "diversion was even known" and that the company began when the word for "recycling" was "salvaging." He then said, "What bothers me is I turned in an RFP, and your staff and your consultant did not even offer us an interview, which absolutely makes no sense to me." He said he thinks city staff does not understand the trash industry. "This is, again, a little disturbing that your staff would not even consider a 75-year-old company and our experience."

After the council handled other items on the agenda, the city's Environmental Programs Manager, Daniel Pankau, gave a presentation on the selection process, noting that the city council has jurisdiction over trash hauling in the city and that currently, companies apply for a permit and have "minimal vehicle standards" to meet and "no substantive qualifications" to acquire a permit. He noted that with the passage of SB 1383, the state's most significant waste reduction mandate in 30 years, which also has specific requirements for jurisdictions and haulers, the city's current process needed to be updated to avoid the city's exposure to significant fines. Mayor Drew Boyes recused himself from the matter because he works in the industry.

Pankau told the council that currently, the city has permitted nine companies to perform commercial trash services in the city and that the multi-step process of notifying trash haulers of the city's intent to transition to an exclusive non-franchise model started in 2019 with notice for a Request for Qualifications sent to 12 trash haulers in November 2023. He noted that currently, the city has nine permitted trash vendors. Of the 12 who responded to the RFC, all were deemed qualified and provided with a Request For Proposal in April 2024. Staff then and a consultant reviewed the RFPs and set interviews with the top nine that took


Check It Out

The Raft by S.A. Boden is a plane survival story about 15-year-old Robie, who is in a plane wreck while going home to Midway Island from Hawaii. Robie decides to go visit her aunt in Hawaii because she misses her and is a little bored on Midway. When Robie gets to Hawaii, her aunt had to leave on a business trip and leaves Robie with her neighbor. The neighbor, however, calls Robie's aunt to tell her she can't check on Robie after the aunt leaves. Robie experiences freedom for the first time and goes out to explore Hawaii. place in June 2024. "We feel that the top four recommended haulers offer the greatest value to customers along with assurance to the applicable laws and regulations," said Pankau.

SB1383 requires the state to reduce organic waste (food waste, green waste, paper products, etc.) disposal by 75 percent by 2025. It also requires that 20 percent of currently disposed edible food be recovered for human consumption by 2025.

"We do have to respect our RPF process," said council member Lance Giroux, after asking about the process and likening it to a job vetting interview process in which you may start with 50 applicants, calling the cutting process "normal." "That being said, I think we also have to look at the fact that, actually Republic (one of the four vendors city staff was recommending) didn't show up tonight, right? There was nobody from Republic. My understanding is Patriot has about 25 percent, Republic about 23 percent and Athens has about 18 percent of the current business. Is that accurate? he asked Sassoon and Pankau, who stood at the presentation podium. Before they could answer completely, he said, "Just more or less, right. Okay, so that's two-thirds of the business. Am

I also understanding Athens is the only one who made the top four. So my concern here is that we are gifting 50 percent of the business to four people who haven't done business in the town before or have done a little bit of business in town before..." He then added, "I believe we do have a responsibility here to not force businesses that have been established with someone here for a long time to just say no, I can't choose that anymore."

Council member Ryan Baldino said it was "great" with the city moving from a permit process to the non-exclusive franchise model for protection but that he did have a problem with the city trying to pick "winners and losers" and saying who is qualified to do business in town and who isn't. "We like to tout ourselves as a business-friendly city, and I want to see as much competition as we can." He called for letting "the market decide" and to open the non-exclusive franchise model to be offered to all 12 applicants.

City Council voted 4-0 to allow the 12 permitted companies in the city to be granted the solid waste non-exclusive franchise agreement. The proposed term was changed from seven years to two years.

Eagles Have a Future in Playoffs

This time of year means post season implications for some teams while others have begun their playoff schedule. It is an exciting time of the season where minor miscues could mean a league title, or it could mean their playoff run has ended. The El Segundo football team played for a league title but came up short; they will go to the playoffs as a second-place finisher. The water polo team opened up their CIF Southern Section Division 1 playoff with a spectacular win.

Eagles Get Their Wings Clipped Against West Torrance

It's been a long time since the Eagles won a league football championship. The last time they won a share of a league title was in 2016. They won an Ocean League title outright in 2014. So, when the Eagles faced the West Torrance Warriors on the road in the final Ocean League contest it meant the Ocean League title was at stake. Both teams entered the game 4-0 in Ocean League play. There was enough incentive for each team, but the Warriors had the weight of their last league title, of any measure since 2014, on their minds.

El Segundo didn't play a game in week nine due to a forfeit by Morningside. So, the lack of game time action may have contributed to their frustrating night and why West Torrance prevailed in their 38-21 win over the Eagles.

On a cool, blistery evening, the Eagle's offense was silenced by the West Torrance defense. The Eagles were missing a key component of their offense when Cole Castillo was held out due to a freak injury in practice. Castillo is El Segundo's leading rusher averaging 5.9 yards per carry and 13 touchdowns on the season.

In the first half, the Eagle's high-powered offense was held in check by a swarming West Torrance defense. In the first quarter El Segundo had no answer and had a minus eight yards of total offense. The second quarter wouldn't be much better; El Segundo had seven offensive plays. West Torrance dominated the time of possession, ran 51 total plays in the first half, and took a 24-0 lead into halftime.

The Eagle's offensive line had their hands full with the quickness of the Warriors defensive unit most of the game. Eagle quarterback Ryan Wiacek was constantly hurried and was

sacked three times. The bright side to the offense was Isaiah Rodriguez and Merrick Boyles, who filled in at running back.

Trailing 31-0 in the third quarter the El Segundo running game got into gear. Rodriguez picked up 15 yards on one play. Boyles' rushing attempt deep in Warriors territory set up an eight-yard rushing touchdown by Rodriguez. The Warriors responded with a nine-play drive that extended into the fourth quarter and, scored a six-yard touchdown and extended their lead to 38-7.

The Eagles would not go quietly, and their perseverance was evident. After Sean Mossman returned the ensuing kickoff 47 yards to the Warrior's 45-yard line, the Eagles needed five plays to score. Rodriguez picked up 17 yards on the first play, and then Boyles rushed four consecutive times, including one into the end zone from the four-yard line, and made it 38-14.

The Warriors coughed up their next possession thanks to Eagle defensive end Hunter Sprick, who forced and recovered the fumble in West Torrance territory. With time winding down, Wiacek found Ethan Ayler open for a 12-yard touchdown pass. The Warriors took their turn and attempted to run out the clock. They were stopped on fourth and short with under a minute to play. The Eagles' courageous play didn't go unnoticed in that final 58 seconds. After an incomplete pass, Axel Thiess caught a 15-yard pass, setting up one last exciting play.

On the final play of the game, Wiacek showed his scrambling skills. After taking the snap, the sophomore quarterback eluded two Warrior defenders with a juke move to escape their grasp. He retreated 15 yards, faked out another defender, and got away from two more West players. Wiacek got free from the pressure momentarily when a West defender had him in his sights. Wiacek got his pass off and was drilled afterward. The pass fell incomplete, but no flag was called for roughing the passer. It was a fitting ending to a game of frustrations.

The loss means the Eagles will enter the CIF Southern Section Division 10 playoffs as the second-place team. The CIF came out with their pairings and were not kind to the Eagles. El Segundo (6-4) faces the Shadow Hills Knights (6-4) Friday night at 7 p.m. on the road; Shadow Hills is located in Indio.




