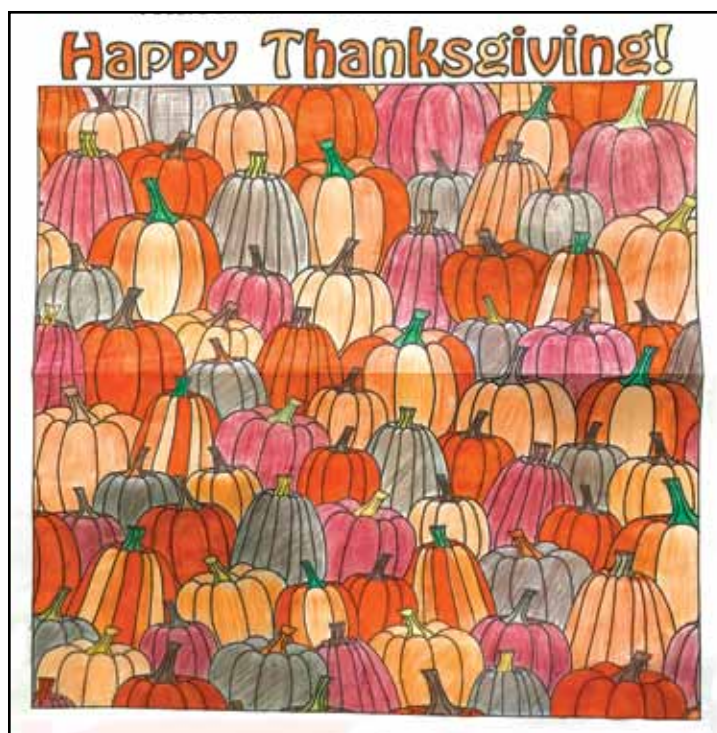
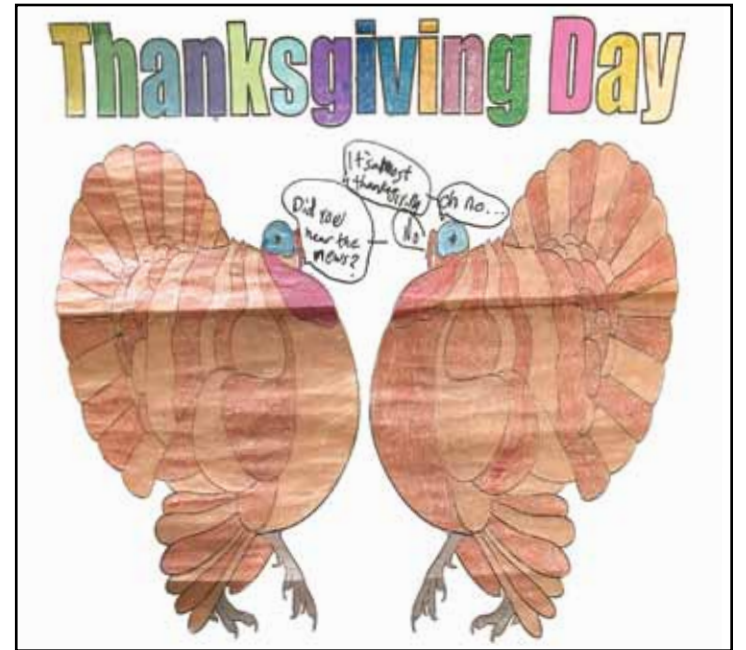

El Segundo Family Touts the Boy Scouts of America Program

We will start today with a pop quiz, framed in the *Jeopardy* tradition, with a nod to the late, great host Alex Trebek. The category: Current celebrities who participated in a community service program in their youth. The answer: Jack Black, Michael Jordan, Harrison Ford, Bill Gates, Jimmy Buffett, Jay Leno, Mike Rowe, Richard Gere, and Hank Aaron, amongst others. The question, answered correctly by the winning reader, would be: "Which celebrities were part of the Boy Scouts of America program (BSA)?"

Sorry, no points or cash awards to those who came up with the correct answer.

Speaking of scouting, El Segundo resident Kerri Arroyo and her husband Jesus are the proud parents of three boys who have traversed through the scouting program in El Segundo, which currently boasts three Boy Scout Troops, two Cub Scout Packs, and one Girls' BSA Troop, as well as the parents of daughter Amanda, who while not participating in the scout program, "lived the scouting world for

10 years," Kerri said.

Discerning readers may take note that the Arroyo children's first names, Alexander, 24, Amanda, 22, Andrew, 22, and Anthony, 15, all happen to start with the same letter, and are "accidentally alphabetical, by birth," Kerri said.

The Arroyo family moved to El Segundo in 2006 from Hawthorne. As longtime parishioners at St. Anthony Church, where all the children were baptized, and with Jesus working for more than decades for the Boeing Corporation, they were familiar with the family opportunities available in El Segundo. They were also impressed with the strength of the El Segundo Unified School District.

Kerri said Andrew was the first to show interest in scouting, and became a Cub Scout, which is set-up for youth kindergarten age through fifth grade. That inspired Alexander to join the Boy Scouts program, which comes into play after the scout's 10th birthday. If one continues the scouting progression, the next step, if you complete the requirements,

is to become an Eagle scout. All three of the Arroyo boys have "Eagled-out", which means that they have earned at least the 21 merit badges to become Eagle scouts. There are 13 required badges a scout must earn to become an Eagle scout, in fields like cooking, citizenship, first aid, and emergency preparedness. Then they can choose pursuing a list of more than 100 optional merit badges to reach 21. Blackjack!

Kerri said that, with computers, cellphones and other 2020 gadgets occupying a "significant amount" of a youth's time, the BSA program offers its members "opportunities to take a break from technology and experience learning moments."

Julio Catzalco, Scoutmaster of Troop 762, who has known the Arroyo family for nearly a decade, agrees, citing the fact that participating in the scouting program "is where the boys start seeing the world of many outside activities," mentioning "learning about citizenship, our flag, our country, as well as our

countryside." He related that these activities, including building pinewood, soap-box derby cars, small boats, and rockets, shooting bows and arrows, BB guns (all in a supervised, safe environment) helps to mold young men, and since 2019, young women. The BSA program, which started 110 years ago, began welcoming young ladies into the fold last year.

Mike Rotolo, who is the President of the El Segundo Scout House Association, located on Grand Avenue, emailed that "My son Anthony was in scouting during the time Alex Arroyo was. Both earned their Eagle rank, and during that time I learned what a fine young man Alex was. His mother and Anthony followed in Alex's footsteps. The Eagle rank is not an easy achievement, and for all three brothers to achieve it speaks well of the family and of each of the young men. Kerri got involved and volunteered to help the Scouts earn merit badges and continued to help throughout the years her three sons were in scouting."

Rotolo has a long history of participating in scouting. "As an Eagle Scout myself," he wrote, "I made sure my son had the opportunity to become a scout. He thrived in scouting and I got the opportunity to help with the scouting community here in El Segundo. Kerri is the

in the nation to name a few. Anthony earned 71 merit badges on his path to Eagle, which is remarkable considering that 21 merit badges are required to earn the Eagle rank and fewer than 6% of Scouts earned Eagle over the last 10 years according to Scouting magazine."

Continued Stoker: "Eight scouts in Troop 762 earned Eagle in the last 14 months, which is a fantastic reflection on our Scout Master, Julio Catzalco, and all the adult volunteers that have help the scouts along the way. Kerri and Jesus Arroyo are both active as merit badge counselors and Kerri recently led several boys to earn the Pope Pius XII Catholic religious emblem, so the whole family is involved in the success of the Troop."

Catzalco emailed that "Alexander was one of the older boys in the Troop and I could see that the younger scouts knew him as one of the youth leaders of the troop, and he was well on his way of earning his Eagle Scout Award. I believe that my son Marc's first Eagle Project exposure was Alexander's Eagle Project at Center Street School. My son was very impressed with the way that Alexander ran his project, and it gave him a goal to reach."

"The Arroyo's are very active in our troop," Catzalco said, "they attend many of our troops

secretary of the Association. ESSHA maintains and operates the Scout House which is the meeting place for Cub Scout Packs and Scout Troops. Scouting provides a wealth of opportunity," Rotolo said, "for our young people. Not only with opportunities for advancement in rank but also in the education and experience of outdoor adventures."

Another scouting supporter is Eric Stoker, Advancement Chair for BSA Troop 762: "The Arroyo family has been a cornerstone of Boy Scouts of America in El Segundo for well over a decade. All three boys have earned scouting's highest rank."

"The boys were also very adept at earning merit badges," he added, "which are BSA's awards for demonstrating knowledge and skills in diverse fields of interest, including swimming, hiking, cooking, and citizenship

Eagle Projects, Community Service projects, help the scouts earn their Merit Badges, assist our troop plan events (and) fundraising, way too many activities to count. They are a great family and a joy to have them as a part of our troop family."

Catzalco said that when Cub Scouts "cross over to Boy Scouts, they start becoming more independent, carrying backpacks over several miles to their campsites, set up their own tents in the woods, cook, clean, gather, learn about filtering water to drink, and especially how to treat the outdoors. The outdoor activities are bigger, at summer camp, (where) they shoot .22 rifles and shot guns, climb walls, learn to sail and canoe and tons of other great things. Our troop canoes two days and 11 miles down the Colorado River from the Hoover Dam to Willow Beach, backpack 6 days over 40 miles over in New Mexico, and more, lots more."

"The scouts learn so much about themselves, their world, the people and how to lead," Catzalco said. "In every activity that Boy Scouts do, the youth are in charge. The Senior Patrol Leader, the Assistant Patrol Leader, the Patrol Leaders, Troop Guides, Instructors are all youth leaders who guide their younger scouts in all of this. The Scoutmaster and Assistant Scoutmasters guide the youth leaders, but the youth leaders guide the scouts. It's great to see the young scouts marvel at the older scouts who seem to know so much, and it's even better when they grow up into that older scout themselves and feel so proud of all they have accomplished. I have seen it with my own two boys and many of the boys that have gone through our troop. The Arroyo's have been a big part of our troop's success in elevating 28 Eagle Scouts."

The BSA motto is "be prepared." Their slogan: "do a good turn daily." Prescient thoughts as we all face the challenges of day-to-day living in the COVID-19 era. •

Serving Up “Good Stuff” in El Segundo

As the weather in the South Bay shifts to rolling fog and gray, misty breezes, restaurants in town find themselves dealing with another major challenge to serving customers throughout a global pandemic: outdoor dining.

Good Stuff, a local breakfast restaurant and favorite among townfolk, is certainly feeling the pressure. On the corner of Grand Ave. and Richmond St. (131 W Grand Ave.), you can see couples and families sitting outside on

the weekends—seemingly normal in the early morning hours. But as the weekend passes, the sidewalk gets emptier. By mid-week, only a few outdoor tables host workers on a lunch break, and every hour or so, a customer walks inside to pick up a to-go order, then rushes back to their car and drives off. The slower pace is a big challenge for Chase Bennett—the newly appointed general manager of Good Stuff’s El Segundo location.

“We’ve definitely noticed a slow-down in business,” says Bennett. “On the weekends,

although there may not seem like much to celebrate, he feels that it’s important to honor their history—especially their customers.

To ring in their 40 years of good food and good service to the community, Good Stuff is hosting a range of new promotions to not only benefit customers but to also drum up new business. For instance, one of their most popular promotions is their gift card kick-back that they’re offering from Black Friday throughout the rest of the year. Plus, starting in December until the New Year, Good Stuff is hosting a mimosa special that features four different types of mimosas. It’s a perfect pairing for their pumpkin spice pancakes that’s new on the menu for the rest of the fall season, too. “We want to give our customers a fun, beneficial reason to get them coming back. Obviously, the chilly months ahead make that tough to do with indoor restrictions, but hopefully, we can make things festive and enjoyable for everyone.”

And much like every other restaurant in town, Good Stuff has noticed a huge focus on to-go orders. Traditionally, the chain has always been a sit-down venue and still is for loyal customers in the morning, but Bennett has noticed a major trend in ordering habits and revenue for the restaurant as a whole. “I’d say that roughly 40% of our revenue, at the moment, comes from to-go orders. We don’t make it a huge priority because it’s never been our main model, but we definitely recognize the shift and have been more accommodating for those customers who want to stay at home.”

For delivery options, Good Stuff partners with DoorDash to bring their classic breakfast items to those who’d rather eat out without going out.

“There’s no right answer in a situation like this,” says Bennett. “But I hope the community here knows that we’re thinking of them and

at all of our locations, it gets pretty busy with local customers, but during the week, it’s pretty light. It’s something we’ve never seen before, and we opened in 1979.”

Owned and founded by Chris Bennett, Chase’s father, Good Stuff originally kicked off in Hermosa Beach. As a South Bay native, Chris dreamed of one day owning a restaurant where he grew up, and when an opportunity arrived for him to do so, he quickly cemented his dream as a staple of the surrounding communities.

Growing up as the son of a restaurateur, Chase found himself working at the Hermosa location throughout high school. He’s an alumni of Bishop Montgomery in Torrance, and unlike his five other siblings, working in hospitality just made sense for him. “I tried a lot of other things in my life, but working in the restaurant has always been something I love. I love the business side of it, working with people, supporting the community, and right now, we’re facing some of our hardest challenges. We actually lost the previous general manager here in El Segundo right when COVID hit, so it’s been tough, overall, for me to adjust to a normal life. Nothing about running a business right now is normal.”

Bennett also shares that Good Stuff is celebrating its 40th anniversary this year, and

doing everything we can to serve them.”

Good Stuff is open Monday through Sunday from 7 AM to 2 PM. They offer ample seating on the sidewalk, as well as a patio area for customers to enjoy. •

‘My Octopus Teacher’ Shows the Connection That We’ve Lost and Long For With Our Natural World

For some of us, the dizziness of these times has us feeling disconnected from our natural world. Perhaps that’s why, in a need to escape from life on land, audiences are diving into the new documentary *My Octopus Teacher* (now streaming on Netflix).

My Octopus Teacher follows South African documentarian Craig Foster. After spending a career photographing wildlife and seemingly

technologically-advanced time in history, we’re turning for answers from silent ocean-dwellers (although its intelligence may rival our own—octopi have a brain in each of its eight tentacles!). *My Octopus Teacher* rings so powerfully at a time when some of our highest elected officials reveal a remorseless hypocrisy in the human spirit, that we re-direct our efforts to find answers to life’s questions with one of life’s most prehistoric creatures.

losing touch with the modern world, he leaves it all behind and takes up a new hobby: diving off of the South African coast. In the process, he discovers the presence of a female octopus—who he pursues and documents each day. Over time, she encourages him to think of life’s bigger questions and lessons.

Comprised of just one character (well, two, if you count a certain tentacled co-star), we follow Craig singularly, which makes for an incredibly personal, diary-like experience. His solemnly spoken interviews are intercut with footage of him swimming alongside an ever-growing octopus (footage that he shot himself). All things combined, it’s a very soothing watch: his peaceful and easily meditative speech makes for a calming narration of his underwater adventures.

Through Craig’s journey, I was certainly able to feel a reconnection to nature (and I work on computers all day long). Even though the experience is a second-hand one, seeing Craig’s footage is really quite transporting. Although he dives with a snorkel (meaning he’s without an air tank, and therefore is unable to explore the ocean’s deepest depths), his coastal dives capture a brilliantly colorful aquatic world that is amazing to behold. You won’t need a scuba suit or diving license in order to be taken away to a whole other world.

I find it quite funny that during the most


But, be warned: like any nature documentary, you should prepare to see nature showing its less heartwarming side, in which the circle of life should be experienced without attachment.

I’m actually not sure what *My Octopus Teacher* left behind, in terms of the greatest lesson that Craig—or I—learned. But perhaps that’s something that can only be answered by each one of us that watches it, as long as we look to take the plunge for the chance at finding peace with an eight-legged friend.
