Council to Put Transient Occupancy Tax Increase on April Ballot

In a move that could potentially add close to \$5 million in annual revenues to the general fund once five new hotel properties are up and running, the El Segundo City Council on Tuesday night voted to place a proposition on the ballot for the April 12 municipal election to increase the transient occupancy tax (TOT, assessed on hotel and motel patrons) from eight to 12 percent. As a general tax item, a simple majority of El Segundo voters must approve the measure. To go to ballot, four Council members had to give their blessing. Mayor Pro Tem Carl Jacobson was the lone dissenting vote, stating that he was only willing to up the TOT to 10 percent.

At today's occupancy levels, each one percent TOT increase would yield an estimated \$800,000 in new general fund dollars annually. But that number could eventually increase to \$1.2 million per annum as local room count swells over the next three years with the various hotel openings.

Discussed during the summer strategic planning sessions as a way to provide a more stable revenue stream, the additional monies from the tax increase could be used to fund important City projects (long-term facility and infrastructure needs), help balance the budget, offset costs of services, enhance reserves, and bolster tourism marketing. Staff met with El Segundo Chamber of Commerce and hotel representatives and received support to raise the TOT in order to help the City, according to Planning and Building Safety Director Sam Lee. However, the group reportedly expressed a

preference to set the new rate at 10.5 percent, with 0.5 percent of the total to be used towards travel and tourism marketing. While the Council can adopt a resolution indicating its intent to allocate a portion of the proceeds to tourism, it cannot officially earmark the monies on the ballot measure—or else the item would be classified as a special tax and require two-thirds voter approval.

El Segundo has the lowest TOT when compared to competitive market areas including Manhattan Beach, Hermosa Beach, Torrance, Hawthorne, Redondo Beach, Los Angeles County, Culver City, Santa Monica, Long Beach and Los Angeles. The average rate for these areas is 12.9 percent, with only Manhattan

ESUSD Superintendent Moore Gives State of the Schools Address

Second-year El Segundo Unified School District Superintendent Melissa Moore made her "State of the Schools" address Monday night at the High School's Performing Arts Center. The nearly 50-minute presentation was viewed by District administrators, teachers, School Board members, parents, and interested members of the community, and concluded with an uplifting video presentation, dubbed "ESHS Pride Video" that included the participation of nearly the entire High School student body.

Moore, who came to the District after serving as Assistant Superintendent of Human Resources in the Yucaipa-Calimesa school district, began her service to the ESUSD on July 1, 2014, replacing Geoff Yantz, who had accepted the Superintendent's position with the South Pasadena School District in March of 2014.

Her Power-Point presentation kicked-off

with the mention that the Eagles' Nest Preschool had successfully earned a state preschool license.

Next, she lauded Center Street and Richmond Street Elementary schools implementation of the Project Lead the Way program, focusing on kindergarten thru fifth grade students at the elementary level, noting the "ongoing cycle of improvement" in the District.

Center Street Principal Martha Monahan, who attended the address, emailed that "I am proud to be part of a District that values and seeks out input from teachers, administrators and parents to continue to improve student outcomes."

The Middle School and the High School successes were next mentioned in the presentation, highlighting the positive launch of the one-to-one iPad initiative for students in sixth through twelfth grade.

Address attendee and Middle School Principal Jack Plotkin emailed that "Dr. Moore celebrated the unique achievements of each school in the ESUSD while articulating a coherent vision for K-12. We will certainly face challenges, but as Dr. Moore noted, we have a dedicated, well-trained staff to see us through."

Moore then pointed out that the Middle School had successfully achieved California Gold Medal recognition for its International Baccalaureate Programme (IBP).

She commended the High School, mentioning that they had earned a six-year accreditation from the Western Association of Schools and Colleges (WASC). The length-of-term is the highest ranking possible. ESHS was recently recognized as an Apple Distinguished School for its innovation, leadership and educational excellence, a two-year term feting the school's successful implementation of the one-to-one iPad initiative.

The California School Boards Association

will honor the Middle School later this week (Dec.5) with their Golden Bell Award, recognizing the school's IBP.

High School Mathematics instructor Kathy Clemmer was given kudos by Moore. Clemmer is one of only five mathematics teachers in the state to be selected to receive a Presidential Award for Excellence in Teaching Mathematics and Science in California.

Moore then spoke of what she termed the "vision for the future," focusing on student learning as the top District priority, with access and equity for all students, coupled with "high expectations." She noted that "relationships are the foundation, with respect, trust and understanding" as cornerstones of the District's mandate. She noted the need for a "learning organizational cycle of improvement, with collaborative decision making, teamwork, recognition of efforts, and partnerships to

Film Review

Peggy Guggenheim: Art Addict Tells of One of Modern Art's Biggest Influencers

Spending time surrounded by art in Los Angeles has been an increasingly popular cultural activity lately. With the opening of the new contemporary art museum, The Broad, in Downtown LA, the millennial generation is seeming to put a bigger significance on experiencing art in person (but whether or not this is just for social media purposes is a topic for another day). The El Segundo Museum of

the film was based off of. Director Lisa Immordino Vreeland uncovered the recordings between Peggy and Jacqueline in Weld's basement and upon hearing the tapes, knew Peggy's story had to be visually told. The interview with Weld would also be the last Peggy ever gave before her death and Vreeland treats the significance of these tapes with the utmost respect and care when executing the film. The combination of old photographs and video footage mixed with archived recordings

Art, appropriately called an "Art Laboratory", is another example of the community's demand for a creative outlet. From Submarine Deluxe comes the documentary *Peggy Guggenheim: Art Addict*, a colorful biography about one of the biggest influencers in art history, the notoriously unconventional grande dame, Peggy Guggenheim.

Everyone who knew Peggy loved her for her eccentricity and uniqueness. An heiress to the Guggenheim family fortune, Peggy often called herself the "black sheep" of her upper-class family. She loved being the center of attention and even shaved off her eyebrows as a teenager in rebellion to her perception of society's pressure on young women at the time. Peggy reveals her tragic upbringing, which included the death of her father when he drowned aboard the Titanic, to her biographer Jacqueline B. Weld in audio tapes that were long thought of as lost, but thankfully have been found, for audiences to enjoy. These tapes went on to become the subject of Weld's 1986 biography, "The Wayward Guggenheim," and from which

transports the viewer back to bohemian Paris in the '20s and into the fast-paced lifestyle of a young Guggenheim.

The "who's who" of the avant-garde world, including Marina Abramovic and Larry Gagosian, the art dealer who owns the Gagosian Gallery chain of art galleries, reminisce about Peggy and the life-changing contributions she made to the art world. From giving Jackson Pollock his first break to being credited as one of the first galleries to mix European and American art, Peggy's candor and vulnerability while talking to Weld are both inspiring and heartbreaking.

Peggy Guggenheim: Art Addict is just as abstract, colorful, and spectacular as Ms. Guggenheim herself was. The film will leave viewers with a sense of wanderlust and admiration for a woman who helped define the art world as we know it today. A nonstop ride with constant surprises, *Guggenheim* premiered at the Tribeca Film Festival earlier this year and is now playing at the Laemmle Playhouse 7 and the Sundance Sunset in West Hollywood. •

Apple, Gouda and Farro Salad

Makes 6 servings as a side dish, or 4 servings as a meal

Ingredients

FOR THE SALAD

- 1/2 cup roughly chopped walnuts
- 6 cups mixed greens
- 1 large apple, core removed and thinly sliced
- 6 ounces Arla Dofino(R) Gouda cheese, cut into cubes
- 1 cup cooked farro
- 1/3 cup dried cranberries

FOR THE APPLE CIDER VINAIGRETTE:

- 1/4 cup olive oil
- 1 1/2 tablespoons apple cider vinegar
- 2 Teaspoons honey
- 1 Teaspoon Dijon mustard
- 1 Teaspoon minced shallot
- Salt and freshly ground black pepper, to taste

Preparation

1. First, toast the walnuts in a small skillet over medium heat, stirring frequently. Cook until the walnuts turn brown and smell toasted. This will take about 5 minutes. Transfer to a small bowl to cool.
2. Place the greens in a large bowl. Top with sliced apples, Gouda cheese cubes, farro, dried cranberries and toasted walnuts.
3. To make the vinaigrette, whisk together the olive oil, apple cider vinegar, honey, mustard and shallot. Season with salt and black pepper, to taste. Drizzle the salad with the vinaigrette and gently toss. Serve!

Note: Honeycrisp or Granny Smith apples are great options, but any apple variety will work.

Trojans Take Back Victory Bell

Things didn't look so good for USC after the first quarter of play. They were slipping right into UCLA's hands after their first drive ended in a field goal. One of the many keys to the game was to hold your opponent to a field goal once they got into the red zone. The Bruins looked like they were doing just that. After a quarter

of play, the score was 7-3 in favor of UCLA. The Bruins wouldn't score a field goal all game long. Little did we know it, that fact would favor the Trojans. 20 unanswered second-half points was the key to the day as USC put together identical first and second halves on their way to routing UCLA and taking back the Victory Bell and the reigns to the rivalry between the two schools steeped in hatred towards one another.

Cody Kessler almost began to cry as he stepped up the ladder for the last time with his sword in hand and led the USC band in song in his final game as a Trojan. The senior, celebrating senior day at Los Angeles Memorial Coliseum, couldn't have ended his USC career in a better way. It's not over yet, though. By beating UCLA 40-21 last Saturday afternoon in L.A., the Trojans earned themselves a spot in this year's Pac-12 championship game against Stanford. The Trojans lost to Stanford 41-31 earlier in the year, but will be out to avenge that loss and not only end their season on a high note, but also put this tumultuous year behind themselves with an encouraging and strong finish to the season.

There's no telling how the Trojans will do against Stanford, but there's also no doubting the fact that they've been a different team as of late under interim coach, Clay Helton. With the victory, USC improved to 5-2 under his watch, winners of their last five of six games. "This was the goal and the plan all along," linebacker Su'a Cravens explained. "I don't like the way we got here, but we'll still take it." Anytime USC's season ends in a victory over UCLA, the players will take it. This is, after all, the first time in four years that it's done so. When you add a Pac-12 title shot to the mix, however, things get even that much better.

For what seemed to be the first time all year to fans, the Trojans played as a complete team for the entirety of the game. The offense held the ball for a total of 40 minutes while the defense and special teams did damage as well.

Just before the half, Adoree Jackson returned

offseason in the NFL. "It's a new feeling for us here," Mora explained. "The game turned, obviously, on the punt return there right before the half and the turnovers in the second half. We couldn't get any, and they did, and they capitalized." The Bruins didn't capitalize on anything in the second half. Aside from an 11-play, 78 yard drive with just over three minutes remaining in the third quarter, UCLA was quiet. They simply watched as the Trojans dominated the second half of play and notched a much needed victory into the record books.

"This was a great opportunity for our seniors to leave their legacy," coach Helton said. "A legacy that will now not be remembered for former coach Steve Sarkisian, but for the Trojans gritty play under their new interim head coach. "They're leaving their mark not only for now in the immediate moment, but for years to come." Anytime these two teams get together and play each other, the result is remembered for all-time. The fact that it was USC's first win in four years, however, adds just a bit to the legacy of it all. "This was a great day for four seniors," wide receiver JuJu Smith-Schuster said. "Especially because we run L.A." You couldn't necessarily get the Lakers to argue that. A win against the Bruins means precisely that for this proud Trojans bunch.

Schuster tallied six catches for 85 yards while Kessler, in his last game as a Trojan, put up three total touchdowns and 175 yards passing. Both teams have been inconsistent this year, but UCLA's injuries and unpredictable play finally caught up to them. "I just felt like we made that defense look a lot better than they necessarily were," Bruins quarterback Josh Rosen said. "No shots at them at all, we just didn't execute like we should have." An excuse from the quarterback, but UCLA fans could argue that the Bruins haven't executed like they should have all season long. Now, the Bruins are destined for the Las Vegas Bowl while the Trojans will compete in the conference title game for the first time since 2011. - Asixlion@earthlink.net

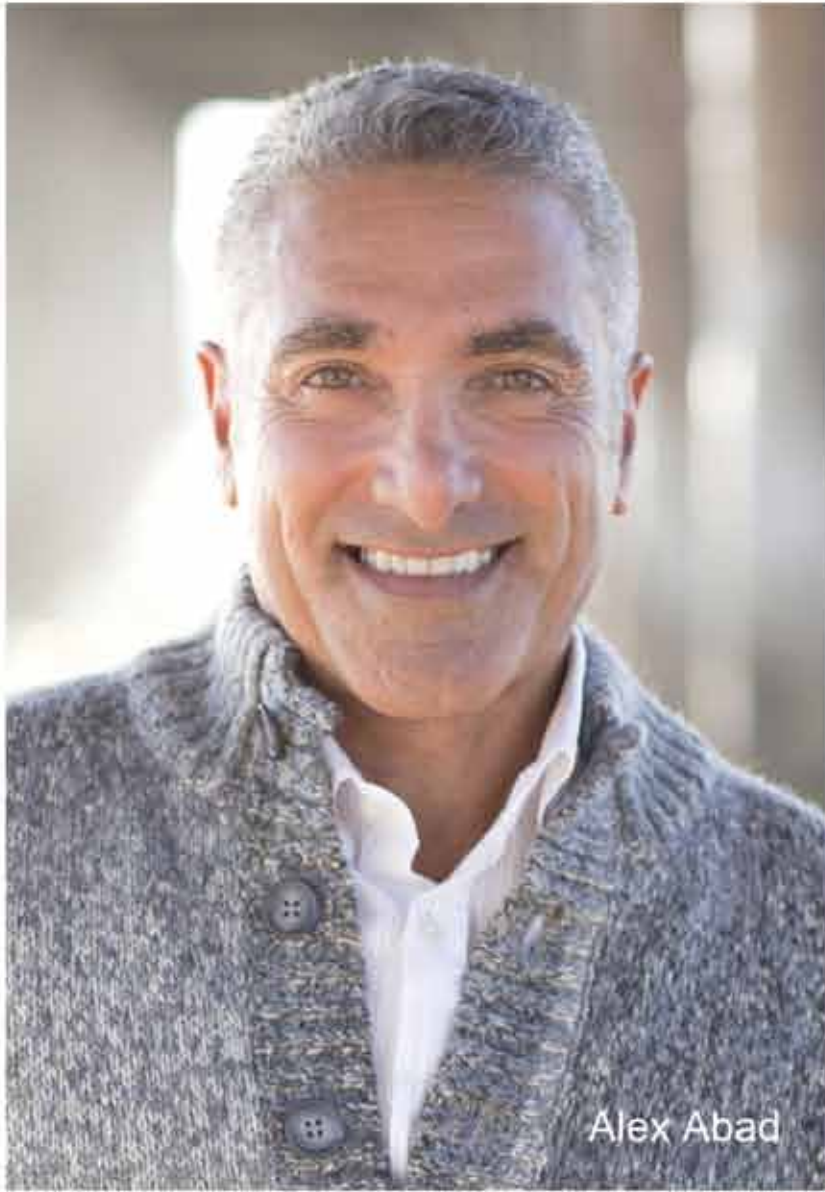

Beach below the 12 percent level (at 10, but reportedly considering a two percent hike) other than El Segundo. Meanwhile, the statewide median for TOT is 9.7 percent. El Segundo previously assessed a 10 percent TOT until 1996 when the Council of that time lowered it to eight.

Mayor Suzanne Fuentes noted that local hotel operators balked at a potential TOT increase a few years ago when the hospitality industry was struggling. She said now they are “beyond that” and would support the City. City Manager Greg Carpenter further elaborated that while hotels thrive during the week, they need some help to bring in patrons during weekends—hence the desire to allocate some of the TOT monies to bolster tourism. Councilmember Marie Fellhauer was reluctant to commit the half-percent amount towards tourism, but liked the idea of a separate assessment on top of that in which the City would oversee the effort with hotels grouping together to kick in funds.

Councilmember Dave Atkinson pointed to the importance of informing voters that the tax increase won't come out of their pockets and that it only affects hotel customers. He added that every dollar collected from the TOT goes to El Segundo and can be used to help improve local quality of life. He also lamented the fact that the City lowered the rate back in '96. “You know how many things we could have fixed over that 19, 20-year time?” he wondered. Jacobson explained that the Council back then reduced the rate because the City had a large influx of business license tax monies coming in and too much going into reserves.

All five Council members will collaborate to write the ballot argument, which is due by December 15. The City Attorney will also provide an impartial analysis of the measure.

Also on Tuesday, the Council made additional revisions to its water conservation ordinance in order to mirror the model adopted by the State of California. The latest actions center on any new projects (commercial buildings, multi and single-family homes) as well as major remodels where landscaping comes into play. Provisions including reducing the threshold for new projects subject to water conservation regulations from 2,500 to 500 square feet—and making the 500 mark applicable to all residential projects. Additionally, residential and nonresidential projects must reduce the total landscaping area containing “high water use plants” and also decrease the maximum amount of water that can be applied to a landscaped area for such projects. Irrigation design requirements include dedicated water meters for non-residential projects with a new threshold of 1,000 square feet as opposed to 5,000 previously. Irrigation systems will now have to include pressure regulators, master shut-off valves, and high-efficiency sprinklers—as well as flow sensors for leaks. Those embarking on new projects will also have to provide a water budget that indicates usage per square foot.

To ensure compliance, customers will have to go through a plan check process that will also entail inspections—and they will have to hire a water auditor. To help navigate through the potential complexities, the City will provide handouts and informational materials, conduct public outreach, and collaborate with other municipalities/agencies to develop best practices.

Another notable change will allow residents to install artificial turf and synthetic grass at their homes (previously prohibited)—provided the material is not toxic and water can pass through it. New definitions for softscape, hardscape and xeriscaping will also broaden the types of materials available for landscaping.

The Council nixed a request by the Community Cable Advisory Committee to approve the use of El Segundo TV facilities to produce and broadcast candidate video statements for future municipal elections. Under the suggested arrangement, each participating candidates would have had to comply with set guidelines, receive the same amount of time, and choose between two takes with no cutting or editing. Councilmember Fellhauer questioned if it is a conflict to use City funds (estimated at \$1,100

per election and absorbed within the adopted budget) for this purpose. City Attorney Mark Hensley opined that it is fine as long as it is done in a “neutral way” and found to be in the public interest. Mayor Fuentes felt the video statements would be “a way for us to have another outreach.” Fellhauer agreed in that respect, but still strongly felt it shouldn't cost the City anything. Councilmember Mike Dugan thought the candidates should pay for the videos themselves. Ultimately, the item failed for lack of a motion.

Presentations on Tuesday included the annual proclamations for Candy Cane Lane and the El Segundo Holiday Parade. The former will as always take place on the 1200 block of East Acacia Street. This year's festivities will kick off on December 12 at 7 p.m. and run through December 23. Started by local resident Ken Bailey in 1949, Candy Cane Lane attracts thousands of visitors each year to see how homeowners decorate and light up their properties to showcase a winter wonderland. Other highlights include Santa Claus arriving on top of a horn-blowing fire truck, a snow-covered Christmas village at the end of the cul-de-sac, and music from the El Segundo Community Band.

The 52nd annual Holiday Parade is set for Sunday, December 13 from 1 to 3 p.m., with the

theme of “Be a Gift to the World.” Proceedings begin on Main Street at Imperial Avenue and continue down to El Segundo Boulevard. Prior holiday events include today's (December 3) Santa's Village at City Hall Plaza at 3 p.m.,

the Farmer's Market and Holiday Craft Fair, the annual Tree Lighting Celebration at the Civic Plaza at 5:30 p.m. and the El Segundo Chamber of Commerce Holiday Mixer at Citizens Business Bank from 5:30 to 7:30. •

expand opportunities” for all.

She then said that one of the School Board goals for this school year was to “increase achievement for all students,” and that all students will hopefully progress academically through each grade level, ensuring college and career readiness by the end of the 12th grade.

Jeanie Nishime, School Board President, who attended the address, emailed that “Dr. Moore’s address once again reminded me that student learning is out top priority. Our faculty and staff are committed to ensuring that every child is given the tools and support necessary to learn.”

Other bullet points elucidated by the Superintendent included the need to provide a safe, emotionally supportive and healthy learning environment that engages students through academics, athletics, activities, the arts, and/or a relationship with a caring adult, with the District striving to ensure the safety and well-being of students and staff; the ability to retain high-

quality employees and build the capacity of personnel; and to offer staff the opportunity to receive professional development to enhance collaboration, share best instructional practices and programs, and implement effective 21st century instruction based upon quality data analysis.

Moore also talked of the need to continue to increase parent and community engagement, as well as inform and educate all stakeholders, including staff, teachers, parents and administrators, and the community-at-large.

She also mentioned the quest to maintain appropriate resources and services, with the students continuing to learn from skilled classified personnel, administrators, and properly credentialed teachers, in their authorized areas of instruction, utilizing standards-aligned instructional materials in school facilities that are in good repair.

She then delineated the District’s “Roadmap for the Future,” speaking of state standards in

English Language Arts, as well as in Mathematics, and District statistical data portraying students who have exceeded the state standard, those who are meeting, nearly meeting, and not yet meeting the established standards.

She mentioned the District’s need to embrace technology, citing the success of the iPad initiative, effectively deepening the District’s integration of technology towards “transformative practice.” Increasing awareness and taking risks, are important, she said, in developing the capacity of elementary students to achieve success as they matriculate in this technological age, citing statistics that “more than 50% of today’s jobs require some degree of technology skills, and experts say that percentage will increase to 77% in the next decade.”

Other areas that Moore highlighted: Targeting intervention for students in need; developing and implementing site interventions; continuing attendance recovery interventions; increasing

select instructional aide programs; and providing all teachers multiple-levels of support.

Moore talked of the need to explore expanded enrichment opportunities, define art pathways, and to develop future course pathways for District students. She also noted the District’s implementation of “instructional coaches,” who provide peer-to- peer support in technology, mathematics, and special education.

Carol Pirsztuk, CEO of the Ed! Foundation, then ascended the stairs to the presentation podium, and talked for a few minutes about the Ed! Foundation support that the ESUSD has received, noting that, because of the way that funding is allocated, that California ranks 42nd in the nation when it comes to per-pupil expenditures, and that local donations to the Ed! Foundation help fund most, if not all, of the District’s Arts program, Librarian support, Counseling and Advocacy programs, as well the Middle Schools IBP. •

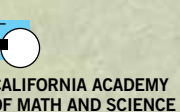
