Tracy Weaver Concludes Long Run as City Clerk, Considers Her Next Agenda

When it came time to file paperwork to run for local offices a few months back, Tracy Weaver had a big decision to make. Should she seek a fourth term as City Clerk or call it a wrap after 12 and a half years in the position? She weighed her options and the answer became clear. It was time to call it a day. December 17 was her last City Council meeting as she swore in her successor, Susan Truax, that evening. "I always felt three terms was a good run," she said. "The first term you are learning, training and assessing the office... and understanding what it means to be a city clerk. In the second term, you will be able to pinpoint the changes and technology needed to streamline the workflow and can begin acquiring and implementing change and tools that will make a difference. In the third term, you are able to fine-tune the changes and workflow."

It seems like yesterday when Weaver outlasted two other candidates in April 2012 to succeed longtime City Clerk Cindy Mortensen (who was at the helm for an unprecedented 20 years). "She said I would be a good fit for City Clerk, and I would like the job... she was spot on," Weaver noted. Of course, there was a learning curve back then. Between her patient and helpful staff, plus her own strong work ethic, the then-new Clerk was able to hit the ground running and never looked back.

An El Segundo native and daughter of well-known local mainstays Lee and Chris Sherrill, Weaver's family history harkens back to the town's Standard Oil beginnings. A 1981 El Segundo High School graduate who then earned a degree at Cal State Long Beach, Weaver worked in restaurant management early in her career before moving into the banking industry as a branch manager for World Savings. In 1998, she left her job to become a stay-at-home mom. Married for 33 years to Kirby Weaver, the couple have three children who attended and graduated from El Segundo Unified campuses. But by 2012, the kids were older and their mother was ready for a new challenge.

As she acclimated herself to the routine of the Clerk's office, Weaver immediately had to learn how to put together complicated City Council agendas and also attended seminars to earn her CMC (Certified Municipal Clerk program)—which she considers her top accomplishment. As a part-time clerk, accumulating the required hours and training takes a great deal of time. "But I stuck with it, continued to attend conferences and training courses, and was awarded my CMC this year," she said. Weaver was also proud to implement an agenda management system that led to the Council becoming paperless. It was a major improvement in efficiency. "There were no more agenda notebooks to copy and deliver to Council members," she said. "It saves the City money and staff time."

Weaver also instituted the Netfile system for filing FPPC (Fair Political Practices Commission) forms for yearly filing and election forms. She also supported staff in their continued education to complete Technical Training for

Clerks. Deputy City Clerk Lili Sandoval and Records Technician Patricia Harada are close to achieving their own CMCs, Weaver reported. She additionally assisted in implementing a City-wide Records Retention Program.

Looking back on her time as City Clerk, Weaver confirmed that elections—she oversaw

Looking Back at 2024 Sports

Looking back at twelve months of sports in our community can be a trip down memory lane. 2024 was another memorable year that started with the 2023 El Segundo Little League All-Stars, the Little League World Series champions in the Rose Parade. It ended with several high school teams competing in year-end tournaments. In between, we cheered on our teams, crowned league champions, won a CIF championship, welcomed a new sport at the high school, said goodbye to a legend, and welcomed a new football coach and Athletic Director. There were heartbreaks, close calls, and disappointments, but we comforted our athletes through it all. So let's stroll down memory lane as we revisit the first six months of 2024.

January Showing Promise

With the ushering in of a New Year the El Segundo Little League All Stars, the 2023 Little League World Series champions, were honored by riding on a float, on New Year's Day, in the Rose Parade.

The girl's water polo team was seeking their third consecutive league title. El Segundo got a rare shutout against Beverly Hills and defeated the Normans 11-0. The Eagles had their way against the South Torrance Spartans and won easily 16-2. The Eagles faced Mira Costa, the two-time defending Bay League champions, in a non-conference matchup. It wasn't close when the Eagles jumped out to a big lead and defeated the Mustangs 18-7.

The boys' basketball team's fun-time approach had the team in position to compete for the league title. The boys' soccer team defeated North Torrance 4-1 and Lawndale 7-0 to keep their Pioneer League championship hopes alive.

February is Playoffs Month

The El Segundo Eagle's boys' basketball, girls' water polo, and boys' soccer teams peeked at the right time and were rewarded for their

efforts heading into the CIF Southern Section playoffs. Each of these teams had been playing with the playoffs on their minds when they reached the pinnacle end of the season. The girls' soccer team got a much-needed win in their final game to sneak into the playoffs, while the girls' basketball team ended their season on a positive note but missed the postseason.

The Eagles overcame a ten-point fourth-quarter deficit to win an epic 54-53 victory over DaVinci. The winning margin came on two free throws with 2.7 seconds remaining in the game. This gave the program its eighth league title. The Eagles were rewarded with the top seed in their Division for the CIF-SS playoffs.

The Eagles boys' soccer team had a winning season by going 14-6-2 overall. In the first round of the CIF-SS Division 3 playoffs, they faced the El Rancho Dons and made Liam Moore's only goal stand up for a 1-0 victory. In the second round against Salesian the two teams battled for two 40-minute halves without a score. The game went into golden goal time, and three minutes into the extra period, the Mustangs caught a break and lofted a free kick into the net for a Salesian 1-0 win.

The girls' water polo team won a CIF championship in 2022 and was promoted to Division 1 the following year and this season. For the third consecutive season, they won at least 22 games; they finished 22-7. The Eagles hosted the Dos Pueblos Chargers in the first round and took a 2-0 first-quarter lead, but that lead withered away in their 13-5 loss.

The girls' soccer season ended in the first round of the CIF-SS Division 2 playoffs with a hard-fought 1-0 loss to fourth-seeded Woodbridge (Irvine). The Eagles displayed a great defensive effort, allowing the Warriors just three shots on goal.

The El Segundo high school boys' basketball team had an incredible season. They won 23

games, claimed their first league title in three years, and advanced to the CIF Southern Section Division 5AA finals for the first time in over twenty years. It marked the fourth time in 61 years the program had reached a final. But a historic win was not in the cards when they fell to the Castaic Coyotes 63-52.

March Means it's Baseball Time

The El Segundo Little League celebrated its Platinum Anniversary's Opening Day Parade and ceremony. On a cool morning, the El Segundo Little League's 70th annual parade, with more than 400 Little Leaguers marching, with their teammates, down Main Street.

The first pitch was ceremoniously delivered by Danny Boehle, the 2023 Little League World Series champion manager. Then, a permanent plaque commemorating the World Series Champions was unveiled. Finally, the unveiling of a unique sign that will be a permanent fixture on the Brett Field scoreboard honoring the 2023 World Champions was uncovered. Then the 2024 schedule got underway, with the Major Dodgers defeating the Royals 8-1.

The ESGS League celebrated its 58th year with an Opening Day Ceremony. The festive atmosphere the ESGS League put on for the nearly 220 girls in the league resembled a huge party. They have had many successful all-star teams do well in tournaments leading up to Nationals.

The high school's baseball team finished third in its own tournament. The Eagles had an impressive week, defeating Culver City 6-2, losing a heartbreaker to Palos Verdes 1-0, and defeating Carson 8-7. The games were part of the El Segundo-Stevenson Tournament, believed to be the longest-running high school baseball tournament in Southern California.

The high school's softball team strung together wins to reach the semi-finals of the prestigious Torrance National Tournament. In the first round the Eagles took care of the

La Serna Knights 12-2 and squeaked by the Redondo Sea Hawks 2-1 in the quarterfinals before falling to the West Torrance Warriors 2-1 in the semi-finals.

The boys' golf team improved their record to 7-1 with their pair of wins over the South Torrance Spartans. The first was played at Los Verdes GC 188-211 and the second one was a score of 165-190 on their home course at Chester L. Washington GC.

The El Segundo AYSO Region 92 girls U14 All-Star team made an epic run that culminated in a Western States Championship. This team had endured heartbreaking losses in the past three years. They had overcome the adversity to conquer their goal of winning a Western States title. It was a fairytale ending to what has been an incredible All-Star journey for these girls.

April Means Schedules Winding Down

With spring high school sports winding down, the Eagles had a crucial week leading up to their regular-season finale. The baseball team split an essential series with South Torrance. The softball team lost a heartbreaker to West Torrance and then rallied to defeat South Torrance. The boys' volleyball team swept Torrance and Lawndale to secure third place and most likely a spot in the CIF Southern Section Division 2 playoffs. The golf team prevailed to win their first league title, and the girl's beach volleyball team made history by advancing to the CIF playoffs.

May is CIF Playoff Time

The baseball team fell in the quarterfinals, while the softball team lost to Redondo in the first round. The boy's lacrosse team lost a heartbreaker 9-8 in their first CIF semi-final round. The girl's lacrosse team, the second-place team from the Ocean League, played host to the Trabuco Hills Mustangs in the

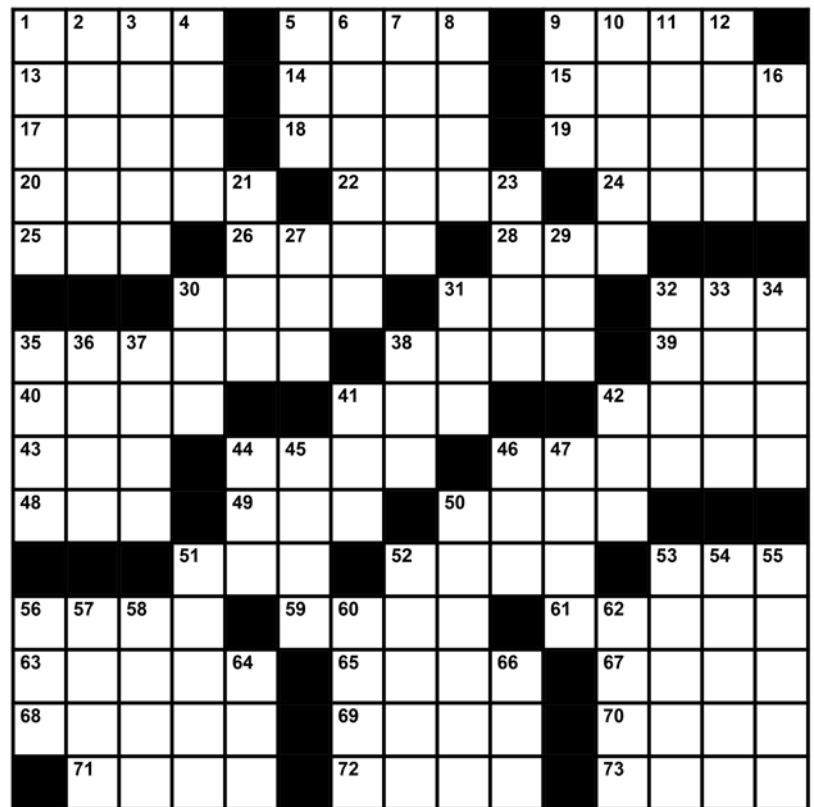

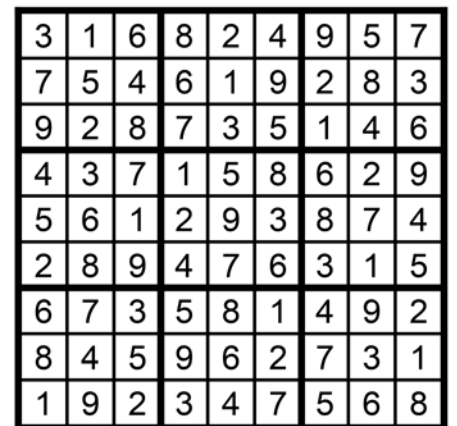

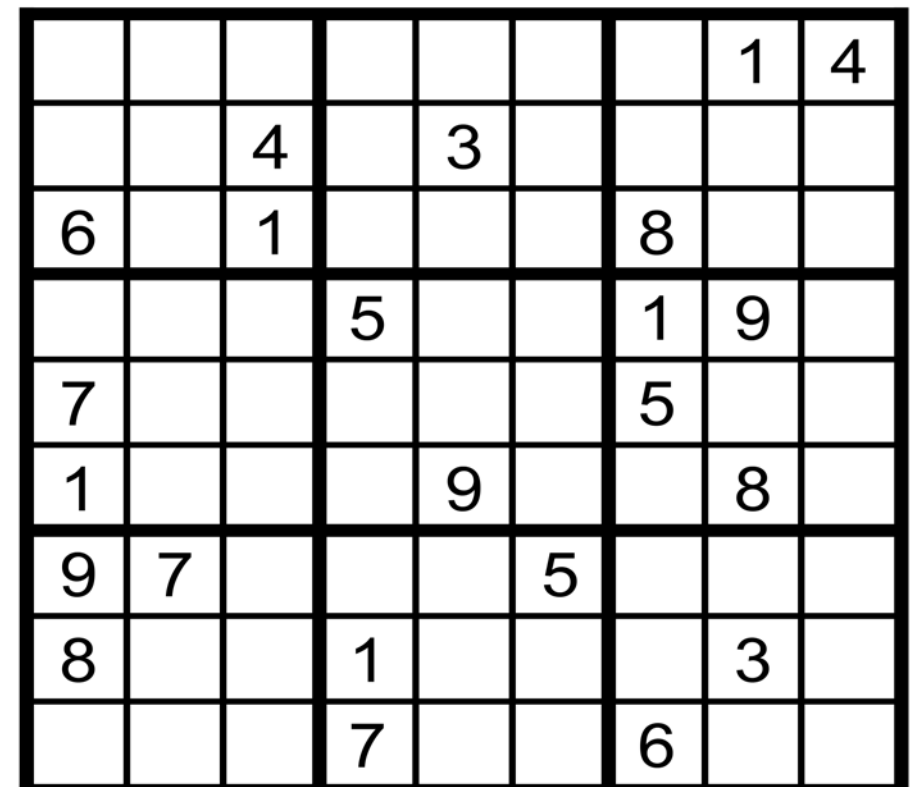

first round of the CIF-SS Division 2 playoffs but fell 12-8.

six of them—proved to be the biggest challenge. Though she still had much to monitor this past cycle, even though voting now goes through LA County, it was nothing compared to when El Segundo held its own standalone races. "The Clerk staff worked extremely hard to run a fair and transparent election," she said. "Deadlines were constant, and you must not miss a deadline, posting or filing. During elections, I had to check my calendar 10 times daily to ensure nothing was missed."

Moving to a Cloud-based agenda management system proved to be the most notable change since Weaver arrived at the Clerk's office. Eliminating the need to copy multiple agenda packets that previously had to be distributed to Council members saved both staff time and money in copy fees. "The system can be used from home or office and staff can write reports in advance," she said. "Agendas are placed in the system up to six months in advance, giving staff plenty of time to write their staff reports."

In addition to earning her CMC, Weaver never stopped learning throughout the three terms and had to continually stay on top of

changes, innovations, and new regulations. She completed Technical Training for City Clerks and attended two conferences annually (except during Covid). One conference centered on best practices and ideas, while the second focused on New Laws and Elections. "We discussed laws that affected the cities and clerks' duties as well as the ever-changing laws around elections," she said.

Weaver credits her success to "the best staff in the world" and the supportive City Attorneys. "Getting elected to a job you have absolutely no clue about can be daunting, but the Clerk's office staff and City Attorneys were very helpful in answering all my questions and pointing me in the right direction for conferences and outside training," she said. "Lili and Patricia are a great source of knowledge, as well, after [former Deputy City Clerk] Mona Shilling retired. I relied on them for the day-to-day office operations and was confident in their ability to maintain a high standard of service to both residents and staff." Weaver added that she worked closely with the City Manager's office, particularly Deputy City Manager Barbara Voss and Executive Assistant to City Council

Mishia Jennings. "I worked with Barbara on producing the agendas every two weeks, running questions and ideas past her and asking her advice on various topics over the years," she said. "I also found Mishia's knowledge and advice to be sage and welcoming. And I would be remiss if I didn't acknowledge all the City Managers and department heads I have worked with over the years. All of them, in their own way, made my time as City Clerk memorable. They are definitely a group of hard-working professionals who make the City a better place to live in and work."

Weaver also endorsed the election of Truax, feeling the office will be in good hands going forward. "Suz will be a fabulous city clerk," she said, "She has already started watching past Council meetings and has been attending recent meetings in person. We have signed her up to take her first class, Nuts and Bolts of Clerking. It was the first class I took, and it's very helpful in giving you insight as to what the Clerk's office is responsible for kind of a crash course in clerking. Suz will bring a fresh set of eyes and possibly see something she feels needs updating or changing. It's a

good thing—change..."

Speaking of change, Weaver's children still lived at home when she became City Clerk in 2012. The oldest, Meghan, was about to graduate from El Segundo High en route to the University of Oregon. Mady was a high school freshman and Jackson was still in fifth grade at Richmond Street School. They're now all adults living on their own. "Meg is engaged and is attending nursing school," she said, "Both Mady and Jackson work at Slice and Pint, Mady is an audio engineer looking for that perfect job. Jackson is deciding if college is for him or if trade school is a better fit. Now Kirby and I are empty nesters with dreams of retirement and traveling in the next few years."

Some of that traveling will come sooner than later. Weaver and her mom will shortly head to Budapest, Prague, and Bratislava for a two-week trip. "It's a little R&R, and we shall see where life takes me after that," she said.

Wherever life takes her, Weaver has zero regrets about what got her to this point. "I have loved being City Clerk for the community I grew up in," she said. "Now it's time for a new adventure..." •
