# Workforce Reduction Plan Approved By Inglewood Council

The Inglewood City Council this week unanimously approved the updated Workforce Reduction Plan for fiscal year 2013-2014. The Council also directed the City Manager to begin implementation of the workforce reduction plan.

"In October of 2013, you [City Council] asked us to produce a workforce reduction plan to take into account the shortfall that the City faced," Assistant City Manager Michael D. Falkow said. "At the time of budget adoption, the City was facing a \$7.1 million shortfall. We knew that the furloughs that all bargaining groups had agreed to was going to end in December of last year."

Predicting that bargaining groups would not accept a fourth year of 10 percent furloughs, which would end on December 2013, the City was left with having to eliminate positions to save money. The initial workforce reduction plan sought to eliminate 56 positions, which was projected to save the City \$2.94 million for year and help cut the budget gap.

However this initial agreement has changed because at the time that it was approved, some of the bargaining groups had no layoff clauses in their contracts. This meant that staff could not make cuts until January 1, 2014. In December the Council approved a workforce reduction to take place at the

end of January 2014, primarily to allow it to analyze the number of voluntary separations or retirements that occurred. In the initial workforce reduction plan there were 50 full-time positions, one permanent part-time position and five part-time positions being

looked at for savings.

"The updated workforce reduction plan reflects some changes--of the 37 positions, six of them were not general fund positions and were not utilized for cost savings," Falkow said. "Nine of them were separations, not retiring, which were already included in the workforce reduction so can't be counted twice. So that left 18 positions to be eliminated."

Due to the one-month delay in the implementation of the cuts, the City's savings will extend for eight months instead of nine. However, all employees who voluntarily retired on or before December 2013 will provide the City the full nine months of savings.

"Of those [positions eliminated] there are only seven bodies in those positions, meaning there are 11 positions vacant," Falkow said. "This provides savings to the City from the retirement, the nine that separated--don't want to count them twice--and the 11 vacant positions will provide the City \$2.57 million for the rest of this current fiscal year. The previous projection was \$2.94 million. This means the City was able to save virtually 50 people that would have been otherwise eliminated."

Some positions left vacant have been designated to remain unfilled while others have been left with the need to be filled, including core positions such as City Attorney. However, due to the City's fiscal situation, they too will remain vacant until the funds are available to fill them with qualified personnel. "Staff will issue rescission notices for employees being removed form workforce reduction, letting them know layoff is rescinded," Falkow said. "The rest of those employees will be notified of removal." •

Other interests included backpacking, GPS and his iPad. He is survived by his brother Tom Tyson, sister-in-law Matie (Crossley) Tyson, sister Ruby Sue Muffoletto, brother in law Gerald Muffoletto, nieces and nephews Gini Tyson, Michelle (Tyson) Cornwell, Todd Muffoletto, Robb Tyson, and Kimberley (Muffoletto) Wilkinson, four grand nieces and nephew, and special friends Glynda Bragg and Megan Baierski. # Hawthorne Kickers Keep in Contention by Topping Beverly Hills

Hawthorne High's boys' soccer team was knocked out of a first place tie in the Ocean League with Culver City in the Ocean League after a 2-1 overtime loss at Santa Monica on January 29, but bounced back with a 2-1 win at Beverly Hills last Friday to remain in contention for the league crown. Against the Normans, the Cougars (13-2-2 overall and 4-1-1 in Ocean play) had one goal each by forwards Jeremiah Egujie and Francisco Alvarado in their victory. Alvarez also had an assist.

At Santa Monica, it was a battle between two squads that were ranked in the CIF-Southern Section Division IV as Hawthorne was sixth and the Vikings were ninth. After a scoreless first half, Egujie got things going with a goal early in the second half. Hawthorne maintained its 1-0 lead until just one second before the whistle to end regulation sounded when returning all-CIF Southern Section Division IV forward Jason Bautista sent the match into overtime as he slipped the ball past Cougar goalkeeper Manuel Valencia. Bautista then won the match for Santa Monica as he scored with approximately five minutes into the second overtime period.

Hawthorne, which is still in third place behind first place Culver City (5-0-1) and second place Santa Monica (5-1), hosted Inglewood last night and will be at home against Morningside Friday at 6 p.m. The Cougars will then have another league showdown at Culver City next Tuesday at 6 p.m. and close league at home against the Vikings next Thursday at the same time.

### INGLEWOOD PULLS AWAY FROM SANTA MONICA

Inglewood High's boys' basketball team used a big second half to pull away from Santa Monica 59-39 in an Ocean League rivalry on January 29 at Inglewood. The Sentinels, who are 4-2 in league after a 58-48 home loss to Santa Monica last Friday, jumped out to a 23-12 second quarter lead before the Monarchs got within as little as three points. Leading 29-20 at halftime, Inglewood (12-10 overall) outscored Morningside (2-4 in league after a 68-62 home win over Culver City last Friday) 16-7 in the third period to lead by 18 (45-27) and finished off with the 20-point victory.

Against Santa Monica, which is 5-1 in league and in second place behind leader Beverly Hills, the Sents were tied at 11 with the Vikings after the first quarter and were

down by just two points (27-25) at halftime. After that, Santa Monica (13-9 overall) steadily pulled away.

Also in earlier league games, Inglewood had wins over Hawthorne 90-66 and Culver City 80-65. The Sentinels are in third place in league.

Coming off the win over Culver City, revenge from its 77-57 loss to the host Centaurs in the league opener on January 15, Morningside visited Beverly Hills last night and will be at Hawthorne for a 7:30 p.m. game on Friday. The Monarchs host Santa Monica next Tuesday and finish league at home against cross-town rival Inglewood next Thursday, with both games at 7:30 p.m. Morningside is currently tied for fourth place with Culver City in Ocean play.

#### LAWNDALE ROUTS EL SEGUNDO

Lawndale High's boys' basketball team remained tied for first place with North Torrance in the Pioneer League after routing host El Segundo 73-37 last Friday. In the last meeting between the Cardinals and the Saxons on January 22 at North, the Saxons downed Lawndale 95-77.



So has the tyranny begun? In August, 2011, S&P downgraded U.S. debt from AAA to AA+. Two days later, Barack Obama's Treasury Secretary, Tim Geithner, taught the Chairman of S&P's parent, Harold McGraw, about the Chicago way. In a sworn affidavit, McGraw stated Geithner told him his deed would not go unpunished. "You have done an enormous disservice to yourself and your country" and that S&P's conduct would be looked at very carefully."

Only S&P among the three credit rating agencies downgraded U.S. debt, and only S&P was sued in 2013 for \$5 billion by the Obama Administration for fraud. Chicago comes to Washington, D.C.

Dinish D'Souza, author of the anti-Obama book *Obama's America*, is now a Federal target, being charged with laundering \$10,000 in political campaign contributions. It turns out he loaned to his fiancée, who

made a campaign contribution to an old college classmate. Would the IRS have charged him if he were Michael Moore?

Reuters reported that The Privacy and Civil Liberties Oversight board, a governmental agency, on January 23 found that the daily spying on billions of Americans' phone calls, the 600,000 address books, the 500,000 electronic "buddy lists" and 200 million text messages collected daily by the NSA have had "minimal" impact on counterterrorism efforts and are illegal, but the Administration ignored the report.

A special review panel appointed by Obama last year to investigate NSA phone hacking recommended 46 actions to limit NSA's spying power and recommended court approval on a case-by-case basis, but few of the recommendations have been implemented.

In fact the spying has become more pervasive and sophisticated, extending to the spying on game apps on cell phones to build profiles of the game players. Now a person can not only be tracked by his cell phone, but also profiled by the games he plays on it.

In 2011, there were 266 applications for drones to be flying over the U.S., but by 2013 the projection is that within 10 years there could be 30,000 drones directed by the Pentagon, viewing any and every aspect of our physical life. Under Federal law, anything seen by the drones can be kept for 90 days, evidently without violating the Constitution's Fourth Amendment banning illegal search and seizure.

So Washington can roll over in his grave. Tyler can nod an "I told you so," and Obama can continue until 2016. •
