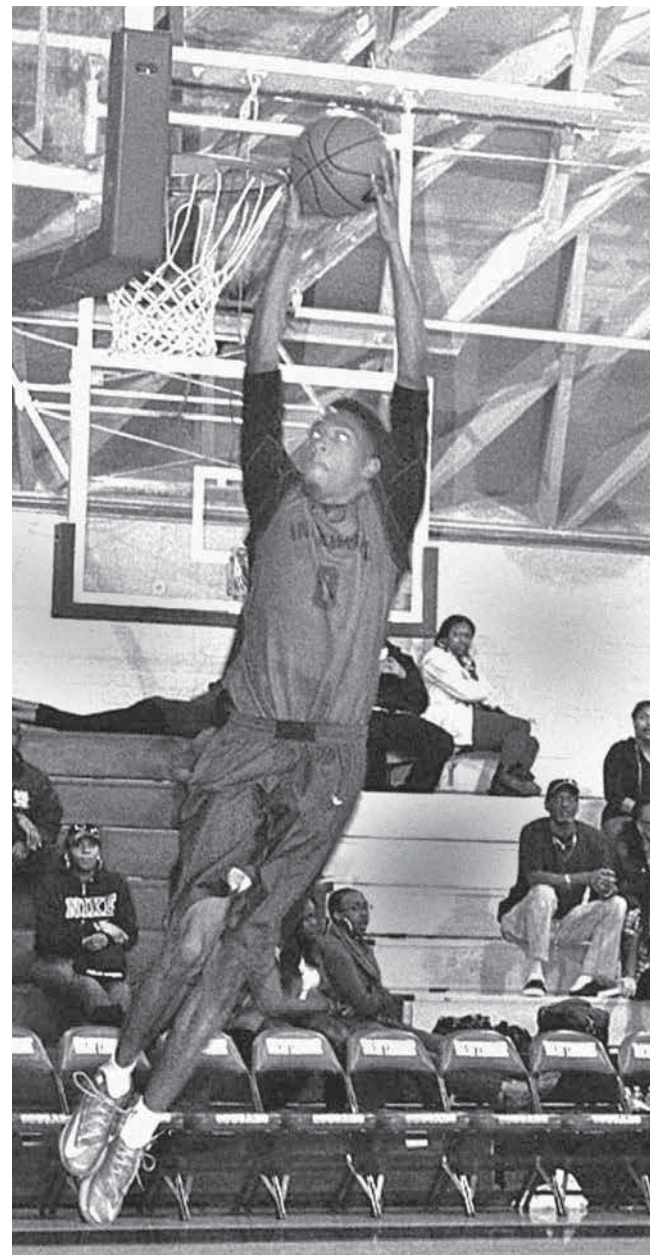

## Council Unanimously Approves General Plan Amendment to Housing Element

At its latest meeting, the Inglewood City Council unanimously approved an amendment to the local housing element to ensure proper affordable housing development in the community. A discussion on the issue hosted by the City's Planning Division in February 2013 addressed potential goals and objectives along with incentives that would lead to the development of quality affordable housing.

"This body has a legal responsibility and obligation to make sure that housing is available for all income categories," District No. 4 Councilman Ralph L. Franklin said. "So it is critical that land density is being accessed as well as population growth and that we handle the income levels of those that are coming and those that are staying and maintaining the quality."

In April 2013, the Planning Commission hosted two community workshops in order to obtain feedback on any unmet housing needs in the community in order to establish new housing element goals and objectives. The draft has been reviewed by the Planning Commission and by the California Department of Housing and Community Development, with the latter determining that the statutory requirements of the state housing element were met.

The housing element is representative of

the City's commitment to developing and improving housing with the following three purposes: to access current and future housing needs as well as resources and constraints that may impact the City's ability to meet those needs; to identify the City's goals, objectives and strategies for the development

of housing in order to meet those needs; to provide a timeline of actions that the City will have to take in order to implement said policies for the sake of achieving stated goals and objectives.

The Southern California Association of Governments (SCAG) develops a regional housing needs amendment before all housing element cycles to determine the need for a region and allocate a certain number of housing units that must be accommodated by each local region. The City of Inglewood was allocated 1,013 housing units for the 2012-2021 planning period within the categories

based on the Los Angeles County median family income. The categories include extremely low income, 125 units; very low income, 125 units; low income, 150 units; moderate income, 167 units; and above moderate income, 446 units.

The City is not obligated to develop that exact number of units, but it is required to make sure that there are enough sites available in the community to accommodate the project housing needs during the planning period.

### Council Approves Two-Year Agreement for City Employee Uniforms

The Council unanimously approved a two-year agreement with the option of extending for another year, with Aramark Uniform, Inc. in the amount of \$118,000 in exchange for uniforms for City employees. Since the money is to be provided by the general fund, the 2013-2014 fiscal year budget was also amended via a resolution to reflect the additional use of funds.

The City of Inglewood has a memorandum of understanding for its employees, which allows for the provision of uniforms for a wide range of employees. Inglewood has a history of providing uniform services for the rental and laundry services of uniforms every week at a price tag of \$118,00 a year. •

## One Man’s Opinion

Sinister Sam stood in a half-crouch in a New York City alley, furtively glancing from left to right to see if the cops had spotted him and ready to run if need be. His hat was pulled down low over his eyes and he twirled his waxed mustache, waiting for a target. Sure enough, a Rube came walking past the alley, gazing up at the giant buildings.

“Ppssstt,” said Sam, flipping open his coat. “Wanna buy a gen-u-wine Rolex for \$19.95?” The Rube walked by smiling, but the persistent Sam followed. “Okay, how about a health care plan where you don’t have to pay any premiums until you get sick?”

Skeptically, the Rube asked, “How’s your system work, Sam?”

“Okay, wise guys like you stay on the sidelines, not buying insurance until you need it. When you’re ill, you can’t be rejected and you can’t be charged an exorbitant premium when you do enroll. What’s more your penalty for not enrolling early is a small fraction of one month’s premium, so it’s insignificant.

“Like rounding up cattle, the government caused cancellation of 50 percent of all individual insurance plans and 60-75 percent of all employer-provided plans, forcing up to 100 million privately insured people into the government corral. The insurance companies then rope and brand the new enrollees with a 40 percent premium hike to make up for guys like you. Even those who have had their insurance cancelled and reinstated have their premiums jumped by 25 percent.

“To help new enrollees pay for these premium hikes, the government offers

subsidies based on a claimant’s declared income up to \$94,000. But since the IRS cannot audit every claim, the President says the government will provide subsidies on an ‘honor system.’ No one knows, therefore, what impact the subsidies will have on the enrollees’ net policy costs...or the national debt.”

Scratching his head, the Rube asked, “But what if the ‘un-sick’ can’t afford the new skyrocketing premiums even with government subsidies--what will happen to them?”

“The federal government has already thought of that,” replied Sam, “by increasing funding to state-run Medicaid programs for the poor.”

“And what about the insurance industry?” the Rube wondered. “If the un-sick don’t buy insurance early, won’t the industry go broke?”

“Nope,” said Sam. “The law includes a taxpayer bail-out for insurance companies if this mega-scheme collapses. The bottom line then is that the federal government will bear the ultimate responsibility as the payment source of all health care costs--first through unquantifiable taxpayer subsidies on skyrocketing premiums, or second through federal government grants to state-run Medicaid programs, or third, by promising to bail out insurance companies devastated by this Machiavellian scheme. In any of the three eventualities, the government will be the ultimate single payer health care underwriter, exactly as the President had planned from the beginning. Simply put, this is the greatest entitlement program of all time, so be the wise guy, Rube. Buy insurance when you need it...no sooner.”

“Okay Sam. Flip open that coat of yours and let me have one of those Rolexes.” •

### Career Full of Accomplishments Thrown Away by Lies

When Senator Roderick Wright was found guilty of perjury and voter fraud a few weeks ago, it was a good day for the American justice system. I won’t deny that the news did cause a bittersweet reaction in me. It was bitter because Wright has a well-deserved reputation for helping small businesses and advocating for low-income children. However, it was sweet because the Senator did break the law and we finally see an elected official being held accountable for his or her actions. In the end, despite the crime being committed and the reputation that he built being tarnished forever, it was a good day for the State’s legal system because it proved that we are capable of convicting a popular, well-liked person of a crime.

Wright is the first member of the State Legislature to be convicted of a felony since the Shrimpscam sting of the 1990s. With Wright scheduled for sentencing on March 12, he could face more than eight years in jail along with being banned from ever being an elected official for life. Not surprising, the Senator plans to appeal the verdict. Despite his plans to shake the verdict off, it was refreshing that a jury found Wright guilty of lying about where he lived during his run for State Senate in 2008. Much hoopla is made about voter fraud when it relates to the people casting a vote. Some states (mostly in the South) have worked toward passing laws to require a voter

identification card or making the process to register to vote a lot more complicated. All of this is to ensure that only legally qualified individuals cast a ballot. Someone who is not qualified to vote will go to jail upon casting a ballot. As rare an occurrence as this is, just as rare is a politician going to jail for voter fraud.

While there is still much to be determined in this case, it is encouraging that a guilty verdict came back considering the failure of other juries to do the same with elected officials accused of the same type of crime. Los Angeles’ Richard Alarcon has dealt with his own issues regarding the same type of voter fraud and not much happened with regards to consequences. If anything, Alarcon can file (if he hasn’t already) for his pension given his years of service.

Senator Wright has been found guilty and now I hope that he is punished for his crime. It would also be nice to see laws that make these residency requirements to run for office easier to verify. If millions of innocent Americans have been put at risk of disenfranchisement due to the very, very unlikely in-person voter fraud scenarios, then the possibility of politicians committing voter fraud via false residency should be treated no differently. What Wright did was wrong and it is great that he was caught and convicted. Unfortunately, everything he accomplished prior to this conviction will from now on be easily overlooked. •

## Police Briefs

**HAWTHORNE PD RECEIVES GRANT FOR SPECIAL TRAFFIC ENFORCEMENT AND CRASH PREVENTION**  
The Hawthorne Police Department has been awarded a \$130,000.00 grant from the California Office of Traffic Safety (OTS) for a year-long program aimed at preventing deaths and injuries on our roadways through special enforcement and public awareness efforts. The grant received by the Hawthorne Police Department will aid in the city’s ongoing effort to improve traffic safety and the quality of life. The Hawthorne Police Department will use the funding as part of an on-going commitment to keep our roadways safe through both enforcement and education. Chief of Police Robert Fager states, “The long-standing partnership and trust afforded to us by the Office of Traffic Safety is significant. Through these annual grant endeavors, we can focus targeted resources and efforts to equally educate our community as well as safeguard our motorists and pedestrians.” The grant will assist in efforts to deal with traffic safety problems and to reduce the number of persons killed and injured in traffic collisions. While traffic deaths from all causes declined by nearly 39 percent between 2006 and 2010 in California, state and federal officials anticipate that figures will show a

slight rise in 2011. DUI deaths remain the largest sector, at nearly 30 percent of traffic fatalities. Recent trends show increases in two new categories – distracted driving and drug-impaired driving.  
**‘D.U.I. / DRIVER LICENSE CHECKPOINT’ CONDUCTED ON FRIDAY, JAN. 31ST**  
The Hawthorne Police Department’s Traffic Bureau conducted a ‘DUI / Driver License Checkpoint’ on Friday, January 31st, 2014, from 8:00 PM to 2:00 AM, at the intersection of Rosecrans Avenue & Isis Avenue, City of Hawthorne. The California Highway Patrol’s West Los Angeles Division assisted in the checkpoint. The following is a summary of the results from the checkpoint. A total of 1,593 vehicles went through the checkpoint. Eight drivers were arrested for DUI, four drivers were cited for driving with a suspended license and 16 drivers were cited for driving unlicensed. A total of 11 vehicles were towed. Funding for this checkpoint was provided to the Hawthorne Police Department by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration, reminding everyone to continue to work together to bring an end to these tragedies. ### Motto Contest Won by High School Student

Linda McVeigh was only 16 and a junior at Hawthorne High in 1962 when she heard that the City of Hawthorne was conducting a contest to select a motto that would be used to promote the city. She thought long and hard to come up with something catchy. She thought that the reason she loved living in Hawthorne was the people she was going to school with. The early 60’s was a magical time in the bedroom community of Hawthorne. Rock and Roll was just taking off. A couple of her classmates were playing a few tunes in their family room over on Kornblum. Those were the days when neighbors knew each other. Everyone knew who lived on their block. Block parties were held on holidays. Neighbors looked out for each other and for their children. Linda thought the best phrase to describe her community was “City of Good Neighbors”. Some 50 years later we still use that as our motto. Ms. McVeigh still lives in Hawthorne and recently stopped by the Hawthorne Museum along with some of her Hawthorne High reunion group.

### Hawthorne’s Beatles Connection

Since the Beatles have been in the news lately, I thought I would share our connection with the famous group. The following information comes from Google’s Wikipedia website: “Olivia Harrison attended Hawthorne High School and graduated in 1965. Harrison worked as a secretary at A&M Records, where she met George Harrison. Harrison gave birth to the couple’s son, musician Dhani Harrison in August 1978. Olivia and George married in a private ceremony in September 1978 at the Henley-on-Thames Register Office in England. Harrison attended Ringo Starr and Barbara Bach’s wedding in 1981 without her wedding ring, giving rise to the mistaken speculation that her marriage to George was a hoax. In the early 1990s, Harrison founded the Romanian Angel Appeal to provide aid to children living in devastation in Romania. In 1999, George and Olivia were attacked by a deranged man who broke into their home. George went downstairs after hearing noises. Moments later, George came in, followed by his attacker and was stabbed multiple times.



Olivia attacked the assailant with a “heavy table lamp” and the assailant turned on her. Later, they were both treated for their wounds at a hospital. The man was quoted as saying he was on a “mission sent by God,” and that the Beatles were “witches.”

Neighbors and friends of Olivia would see a large, white Rolls Royce parked outside her house in the neighborhood

behind Hawthorne High School. Rumors have it that some of the Beatles showed up one Halloween and got dressed up and went trick or treating in our fair city. Who knows? The world’s most loved band members may have knocked on your door.

### DR. DON BRANN NAMED SUPERINTENDENT OF THE YEAR

Inglewood Unified School District State Trustee Dr. Don Brann was honored this week as the 2014 Superintendent of the Year by a Pepperdine University graduate school advisory panel.

The Superintendent Advisory Council at the Graduate School of Education and Psychology (GSEP) recognized Dr. Brann on Thursday, Jan. 30, during a dinner and reception in Monterey.

“More than four decades of experience in California public schools have culminated in a wealth of knowledge and expertise from which our students and schools benefit,” State Superintendent Tom Torlakson said in a letter congratulating Dr. Brann. “I appreciate your leadership and judgment as an educational leader, along with your work to strengthen ties with the school community.

“Please accept my most sincere gratitude for your service to the students of Inglewood,” he continued. “We are all fortunate to have you at the helm, and I look forward to our continued partnership as we move toward providing all California children with a world-class education.”

Torlakson appointed Dr. Brann last year to lead Inglewood Unified. He has more than 30 years of superintendent experience in six

California districts, including a 15-year stint with nearby Wiseburn schools, and has also worked as a principal, program coordinator and classroom teacher. Under Dr. Brann’s direction, the small K-8 Wiseburn School District saw significant enrollment gains and built new schools. He has similar goals for Inglewood, which has embarked on plans to boost enrollment, enhance academic performance, lower class sizes in primary grades and improve facilities, among other initiatives.

Dr. Brann is married with two grown daughters who followed his footsteps into education. He is the founder and vice president of the board of Da Vinci charter schools, and a former El Segundo councilman. He holds a doctorate degree in education and bachelor’s degree in business administration and marketing from the University of Southern California, as well as a master’s degree in education from California State University, Los Angeles.

The GSEP’s Superintendent Advisory Council is a consortium of state superintendents that meets for training, advocacy and discussion on education issues. Members advise Pepperdine students on credentialing, administrative training and master’s and doctoral programs. •

### Lawndale Takes Over First in Pioneer After Downing North

Earlier in Pioneer League play, North Torrance High's boys' basketball team had a very good shooting game in stunning defending league champion Lawndale 95-77. Last Friday, the Cardinals got to host the Saxons and they made it worthwhile in rolling to a 90-73 victory to avenge that defeat and take over first place in Pioneer action. With the win, Lawndale improved to 7-1 in league and 16-8 overall, while North fell to 19-5 overall and 6-2 in Pioneer action.

The Cardinals took advantage of their height, led by 6-foot-9 players Chimeze Metu and Brodricks Jones, but it was guards Quincy Pinkard and D'Lano Beckles who paved the way. Pinkard led all scorers with 29 points, while Beckles added 13. Metu contributed 16 points, nine rebounds and five blocked

shots. Jones had nine points, 13 rebounds and three blocks.

North, though, played without standout guard Koh Flippin, who is lost for the season with a broken wrist, and that could have hampered the Saxons. Flippin put in 18 points when the Saxons defeated Lawndale. Mo Nwodili led North with 22 points, 10 rebounds and three blocks.

The Cardinals led virtually the entire game. North was within three points (49-46) early in the third quarter behind a steal and layup by guard Chad Ashimine, but Lawndale responded with a 20-7 run culminated by a slam dunk by Metu on a pass from Beckles to up its lead to 16 (69-53) with 1:39 left in the third period.

The win puts the Cardinals in good position for their second consecutive league title. After

visiting lowly South Torrance (1-7 in league) last Tuesday, Lawndale closes Pioneer play at home against Torrance tonight at 7:30 p.m.

#### INGLEWOOD DEFEATS HAWTHORNE, CULVER CITY

Inglewood High's boys' basketball team is just one game behind leader Beverly Hills in Ocean League play after crushing Hawthorne 91-54 and overcoming Culver City 62-48 on the road last week. Against the hapless Cougars (6-19 overall and 0-8 in league) on February 5, Inglewood broke open an early close game. Leading 27-20 after the first quarter and by five (31-26) early in the second period, it was a slam dunk by Darae Elliott that ignited a first half closing 23-6 run that gave the Sentinels a 54-32 halftime advantage.

Inglewood (14-10, 6-2) was led by Terrell Gomez and Elliott with 17 points apiece. Corey Dollarhidi tallied 10 points. Hawthorne had a game-high 18 points from Ricky Bryant, but he went down with what appeared to be an ankle injury with 1:32 remaining in the game. Bryant did not play in the Cougars' 81-60 home loss to Morningside last Friday. Markell Gray totaled 10 points for Hawthorne.

At Culver last Friday, the Centaurs led throughout three quarters. They led 34-24 at halftime and still by three (45-42) after the third period before Inglewood's offense and defense took over and outscored Culver 20-3 in the fourth quarter to pull out a 14-point victory.

Hawthorne fell to 0-8 in league with an 81-60 home loss to Morningside last Friday. The Cougars were unable to stop the Monarchs' Gabe Solache, who scored a career best 41 points. Solache went 15 for 19 from the field, including making seven of nine three-point basket attempts, and made all four of his free throw attempts.

The Monarchs, who improved to 8-14 overall and 3-5 in league, also had a triple

double by Dakaria King with 11 points, 11 rebounds and 10 assists. James Brown finished with 12 points and nine rebounds. Marlon Towns led Hawthorne with 20 points.

After hosting Beverly Hills last Tuesday, Inglewood finishes league at cross-town rival Morningside tonight at 7:30 p.m. The Sentinels already clinched a spot in the CIF-Southern Section Division IA playoffs. The Cougars close league at home against Santa Monica tonight at 7:30 p.m.

#### LADY SENTS ROLL OVER HAWTHORNE

Inglewood High's girls' basketball team is in second place in the Ocean League after rolling over host Hawthorne 58-27 on February 5. Leading 14-7 after the first quarter, Inglewood turned the game into a rout by outscoring the Cougars 36-10 in the next two quarters for a 50-17 bulge.

The Sentinels (5-3 in league) had balanced scoring led by Dominique Godbolt with a game-high 13 points. Shanatha Bryant tallied 10 points and Nicole Lemberg put in eight.

Hawthorne, which is 4-4 in Ocean play after topping Morningside 47-37 last Friday at home, was led by Kristina Brown with eight points. Deanna Ray and Crishell Tebudio had five and four points respectively. Brown led the Cougars with 30 points in their win over the Monarchs.

Inglewood visits cross-town rival Morningside tonight at 6 p.m. Hawthorne hosts Santa Monica at the same time for hopes to advance to the CIF-Southern Section playoffs. Both are league finales.

On February 5, Inglewood High football standout linebacker Zaire Andre signed a letter of intent to play at PAC 12 college University of Washington. Andre was an all-CIF Southern Section Western Division player for the Sentinels. •

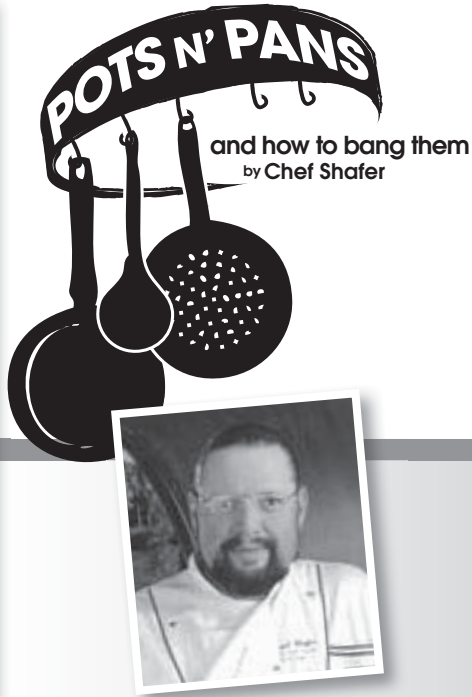

This week we are very crabby so we will have to make some crab cakes. I always hated the crab cakes that you would get in some restaurants. They usually were more breading than crab. I understand why they did it but it doesn't make up for the poor quality. The reasons for all the bread are two fold. One is that crab is expensive and two the bread helps keep it together and easier to fry off. Here is my way of making crab cakes that lets you taste the great crab, still get the crispy coating and they still remain light.

## Chef's Crab Cakes



1 can pasteurized crab, 1-pound size (you can get it at Costco or Whole Foods)  
1/2 cup finely diced celery  
1/4 cup finely chopped green onions  
1/2 cup mayonnaise  
1/2 cup panko breadcrumbs  
Pinch black pepper  
1/2 cup panko breadcrumbs  
Most markets sell this Japanese-style bread crumb

In a bowl mix together crab, celery, green onions and mayonnaise. Add 1/2 cup of panko and mix. Let sit for 20 minutes. Then form into round cakes with the use of a cookie cutter that is the size you want them to be. Lightly coat with the other 1/2 cup panko. In a medium heated pan, brown off the cakes in oil till golden brown and serve with dipping sauces or the melon salsa that you see in the photo. Look for the melon salsa recipe next week. •

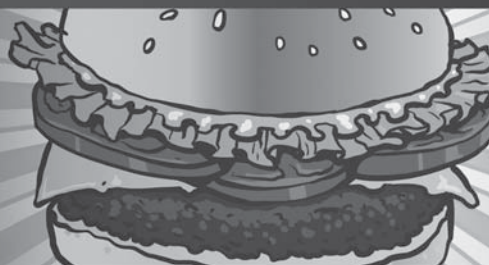
