Council Approves Use of HOME Funds for Rehabilitation Effort

In a 4-1 vote Tuesday, the Inglewood City Council approved the use of HOME Investment Partnership Act (HOME) funds to rehabilitate a City-owned property. Despite some opposition from some residents about the use of such funds to rehabilitate City-owned property, the Council approved action on the parcel located on 708 W. Beach Avenue after a public hearing.

"This is a home that is sitting in a blighted condition--the owner was deceased a number of years ago, so the City owns it and it cannot stand in the condition it is in. It is not good for the neighborhood and it is a CDBG [Community Development Block Grant] fund eligible area," Councilwoman Judy Dunlap said. "These are HOME funds and it cannot be used for any of the purposes that have been discussed here. It cannot be used for streets, alleys or sidewalks. It has to be used strictly for affordable housing and I want to make that clear. That is all we are voting on--one item. This particular project is simply for a blighted home owned by the City that we can use HOME funds on." City of Inglewood Grant Director Pamela Thigpen presented a staff report requesting direction from the Council with regard to the 708 W. Beach Avenue property and a separate property located on 101 N. Market Street that was acquired by the City's former redevelopment agency. It was recommended that the second floor of the Market Street property be rehabilitated to provide for affordable housing through the use of CDBG funds and some HOME funds. "During the last couple of years, in some cases the Community Development Block Grant program under-expends the funds during the course of that fiscal year and therefore those funds can be carried over to the next fiscal year and can be allocated for other eligible projects," Thigpen said. "Right now, the City owns two properties that can be rehabilitated to provide affordable housing opportunities within the city, which is in compliance with the consolidated plan."

the Market Street building would be visited at a later date and only acted on the property located on Beach Avenue. The City currently has \$640,000 in CDBG funds and \$80,000 in HOME funds that can be allocated to other eligible activities. The Project Summary Proposal for 708 W. Beach Avenue provided in the staff report project costs between \$35,000 to \$63,000 for the two-bedroom, one-bathroom, single-family residence, depending on the types of improvements to be approved and undertaken. Still, some residents expressed their doubts and opposition to the rehabilitation effort.

"I am concerned about what this housing and grant money is being spent on because you are not setting the priorities of what is needed in the city," Inglewood Resident Gil Mathieu said. "What is sorely needed is firsttime homebuyers programs. You saw the joy of these people that were able to purchase property under these programs."

Thigpen also asked the Council to consider that as of April 30, 2013, the grant manager for the CDBG program will be retiring, which will then allow for a salary and benefits savings on approximately \$78,000 each fiscal year. As a result, there is currently no money in the budget for the CDBG program given a 28 percent reduction in CDBG allocation from the federal government during this fiscal year. This reduction would affect the City's ability to use CDBG funds to pay for printing and mailings of the annual brochures and surveys sent out every year.

"We are recommending that the City amend the budget to allow you to take \$24,000 of that salary savings and allocate for printing, publication and postage in order for staff to be able to create the annual CDBG brochure and survey to be mailed out to the residents," Thigpen said. "If that is not allocated, those expenses would have to come out of the general fund."

While the disagreements over how and where to allocate funds were present all night, for Councilman Eloy Morales, Jr. public hearings allow citizens and the Council to obtain information that otherwise might not reach them. "It is important to get this type of presentation," Morales said. "It would be unfair not to represent areas that are eligible for these funds. These are funds that I can tell you in my area for which there is a specific need, in terms of getting some alleys redone, or getting some streets done immediately. These are things that we have been piecemealing every year. We have been arguing for CDBG funds every year, and every year we have been able to fix a certain number of streets or [get] an alley done. Here we have some additional funds. I hear that many areas in Inglewood have needs and I agree with that, but the truth is that these funds are designated to certain areas and we need to establish that here." •

Wiseburn Recognizes Exceptional Students

The Wiseburn School Board highlighted some of its brightest students during its meeting last Thursday. The members applauded the efforts of Anza Elementary's Wild Crew, a group of girls who are raising awareness about the plight of lions and tigers in the wild. They also recognized the winners of both the spelling and geography bees.

Superintendent Tom Johnstone introduced the Wild Crew, a group of about 20 girls who made it their mission to save wild lions and tigers. The group was formed after one of the students saw a documentary on these two kinds of big cats and together they looked into the plight of lions and tigers and how the Wild Crew could try to save them. "The Wild Crew did something very special---they researched and found that because of how mankind conducts themselves, it is driving lions and tigers to extinction," Johnstone.

What the group decided to do to confront the problem was write a letter to President Barack Obama explaining how endangered wild lions and tigers are and how the group worried that they might go extinct in the wild. Obama wrote back to the students, thanking them for the letter and praising them for their convictions. "They wrote him and conducted themselves very eloquently and the President of the United States responded and sent them a letter back," said Johnstone.

Anza Principal Sarah Nitsos said that these students are aiming to change the world for the better. By taking a stand for animals that can't defend themselves from poachers and encroachment, she thinks they are making the world a better place. "This group started determined to fix the world's problems starting with the lions and tigers," said Nitsos "They are working very hard at promoting social justice and righting the wrongs they see in the world. I am so proud of them."

Nitsos was far from only person showering the Wild Crew with praise. Johnstone commended the girls for taking action on issues important to them instead of waiting for someone else to step up and handle it. "We are very proud of them," said Johnstone. "First of all, for being committed to this issue and also for being ready to do something about it not just complaining. They did something constructive about it."

The Board also recognized the winners of the District spelling bee, especially overall winner Andrew Harrison. Johnstone said he was impressed with these students' spelling ability, especially since he admitted as a student he wasn't the strongest speller. "I very much admire these people," said Johnstone. "When I was in eighth grade, if the entire class got every single word right on the spelling test, we didn't have to take the test next week and I was always the person who messed it up for us."

The bee covered a wide variety of words, from commonly used (and misspelled) words to more obscure words. The test also had subsections of words from other cultures, such as Greek words like homogenous, android and megalopolis; Italian words like contraband, fortissimo and neutrino; and Native American words like chipmunk, Eskimo and toboggan. The winner was decided after three of these subsections, but Johnstone continued on, undaunted. "What ended up happening is we had a winner and then they had to keep going," said Johnstone

The contest continued for two more rounds. These last two rounds consisted of Old English words like bequeath and nightingale, and Japanese words like tsunami and origami. After these two categories, the bee was over and Johnstone joked that the students were happy to see the event concluded. "And then we were done and they said, 'Oh, thank you!"" said Johnstone.

The last group of students to be recognized consisted of geography bee winner Moses Estran and the runners up. The geography bee is more than just naming countries and filling in blank maps. Johnstone said that to be successful, these students had to utilize a complete knowledge of countries in the world--from natural features (such as lakes and mountains) to political and economic relationships as those relate to geography (such as identifying important ports and trade routes).

"It's very difficult--they give you a map with certain information...and you have to figure it out," said Johnstone. "It's not just memorizing facts. Geography is kind of a lost art."

Johnstone was excited to see many of the winners and runners up flanked by beaming parents. He said that part of the reason students like these geography and spelling bee winners can succeed is because of the guidance and encouragement of their parents. "It's a big deal." said Johnstone. "We love having so many parents here. These kids do so well because their parents super-support them." •


Correction

Bruins Clipped Going Into Tournament

March Madness may have just taken on a different meaning for the UCLA Bruins. All in all, their season has been a success so far this year, finishing 13-5 in the Pac-12 while winning its 31st conference championship by beating Washington in this year's regular season finale. The Bruins have had some rough stretches along the way also, though, like the three of four games that they lost in the month of January or the loss to a horrible Washington State team just three days before their big win against Washington to clinch their division. Despite all of the inconsistency, the Bruins may have just found themselves more maddened than ever after this month of March that had the team playing in the Pac-12 championship tournament at the MGM Grand hotel in Las Vegas, Nevada. Not only did the Bruins squander a chance to come away with the championship title, but they also added insult to injury by losing their second-leading scorer in the process as the team heads into the 2013 NCAA tournament.

Three games in three days isn't easy for any team, let alone the UCLA Bruins who were coming off of a hard-fought year to win the Pac-12 outright in the last game of the regular season. The momentum was all shifting in the Bruins' favor and it looked as if the team was really beginning to gain energy following its last-second victory over Arizona in the semifinals of the tournament to send UCLA to the conference championship game. Freshman Jordan Adams was the key to that game's victory, scoring 18 of his 24 points in the second half while leading his team to a 66-64 victory before breaking his foot on the final play of the game. "The very last play of the game when they were shooting, somehow he came down and tweaked his foot," UCLA head coach Ben Howland said. Later the team would find out that the tweak was in fact a break and that the Bruins would have to go on without their second-leading scorer for the rest of the conference tournament and the remainder of the year. "It's going to be tough to go without him," said freshman guard Kyle Anderson, "but it's all part of handling adversity, and that's something that we've shown we're pretty good at." Now, the Bruins will have to show that they are even better at it if they want to make a deep run into the NCAA tournament.

The day after Adam's broke his foot, the Bruins were hit with even more adversity, having to go up against a streaking Oregon

everything on the line. As Adams sat on the bench with a boot on his right foot, he could only look on as his team had a hard time keeping up with the Ducks all night long, surrendering a nine-point lead to Oregon at the half. Adams' absence meant that the Bruins wouldn't have the same ability to score that they have had all season long and in the beginning rounds of the tournament. "He's one of our best players," Howland said. "So I guess when you lose one of your best players, it's always something you've got to try to overcome." UCLA simply couldn't overcome this onslaught by the Ducks, despite how hard they tried. Larry Drew II had 14 points and six assists, Shabazz Muhammad tallied 14 points and in place of Adams, Norman Powell poured in 10 for the top-seeded Bruins. It was all for naught, though, as Oregon rallied to score six straight points to help stretch out a 71-62 lead with just under three minutes remaining in the game. As time on the clock dwindled, so too did the hopes of the Bruins as the final margin of victory for the Ducks remained at nine points, 78-69.

Now, UCLA's chances of making a deep tournament run seem slim to none. With all of the momentum now gone from the team, in addition to the absence of one of their leading scorers, reeling together six straight wins may be more difficult than not. There's no doubt that the absence of Adams will have an adverse effect on where UCLA goes from here. His injury, coupled together with the loss to Oregon, likely dropped UCLA in the tournament seeding. UCLA hoped to land a spot no worse than fifth and be closer to home in the West Regional, but ended up as the sixth seed in the South Regional, with a game against the 11th seed Minnesota Gophers Friday, March 22 in Austin, Texas. So the Bruins are playing a little bit farther away from home than originally planned. What's even worse is that now, Ben Howland's job may indeed be on the line. Without a deep run into the tournament or at least a Sweet 16 appearance, Howland could be looking for a new job come this summer. But don't count the Bruins out just yet. The team has proven resilient time and time again this season. "It's tough," Larry Drew II said. "But there's something about this team. We find ways to make things happen when it seems like all is lost." Perhaps not all is lost quite yet, but if players like Drew II, Muhammad and Anderson don't step up come tournament time, UCLA could be


While 14 CFR Part 150 of the Federal


