South Bay Workforce Investment **Board Hosts Youth Job Fair**

More than 700 youth and 60 companies attended the Blueprint for Workplace Success Youth Job Fair hosted at Rogers Park on April 10. The event was sponsored by the South Bay Workforce Investment Board and South Bay One-Stop Business & Career Center and has been an opportunity for young people in the area to engage with employers about job openings and adequate interviewing techniques as well as having proper resumes.

"Anything that has to do with the workforce, we will help. If it is matching laid-off workers with a job or helping employers in the South Bay by providing the workers that they need or putting people into training to make them more appealing and apt for a job, that is what the South Bay Workforce Investment Board does," Executive Director South Bay Workforce Investment Board (SBWIB) Jan Vogel said. "We have a special place in the hearts of the youths, as the economy is not as strong as we hope it would be. When the economy is weak, then you have a lot of different people vying for those jobs traditionally filled by youths. When you have parents and grandparents working for low wages, it pushes the youth to the bottom of the barrel and it makes it much more difficult for them to get a job. We have to be able to keep our youth occupied and hopefully in a productive manner in order to allow them to grow."

This job fair has been organized for more than 14 years and began when SBWIB, which in years past had a large summer youth program, had federal funds cut. In an attempt to provide an event to connect residents with jobs without the use of federal funds, the SBWIB has reached out to students in Inglewood, Lawndale, El Segundo, Hawthorne, Carson, Gardena and the Beach Cities.

"I did not know what to expect, but it was great. There are a lot of companies that I want to apply to and I had a good overall experience," Long Beach City College student

and homeschooled high school student Nephtiry Bailey said. "I think these events are very important. We are in a recession and people need to make money-especially students. It is basically on us to get the economy back up and running. I think job fairs like this should happen as much as possible."

Gardena High School junior Chris Hernandez has been a part of similar events in the past and believes that he is better prepared for an interview with a potential employer than people who have not gone through the programs that he has experienced. "I think it was good, but I think I need more opportunities to apply and engage in more thorough interviews," Hernandez said. "The interviewers I was with were more focused on job descriptions and I didn't get asked a whole lot, but overall it was great. They [companies] need to give out applications. They tell us to apply online and we already know that. It was good that they answered our questions and I think I am pretty prepared, but I will keep attending more job fairs. I am pretty confident about getting a job."


For students to attend, they had to be between the ages of 16 and 21 and were required to be Blueprint for Workplace Success-certified. They also had to complete a Blueprint for Workplace Success Job Fair Workshop or be enrolled in a STEM academy.

"It gives me more confidence to speak about myself and sell myself. It also gives me the opportunity to apply to more places because I would obtain information from the Internet or people, but that alone did not motivate me to follow through with the process of going online and applying," Angelica Ceja, senior at Gardena High School said. "My interview went well. The person in charge of my interview asked me a lot of questions and gave me information about what they do at their store. I am pretty confident I will get a call within the next three days."

The fair also helps people who are no longer in school but who have completed one of the

requirements in the past. For Mia Clark, a Gardena High School graduate and future El Camino College student, the SBWIB has been preparing her during the last three months via its Gardena One Stop Center. "They had me at their site and helped me with customer service, they helped me dress better and they helped me interact with other people," Clark said. "They also taught me other things like clerical work skills that can help me find a job. It was like pre-training. These resources are very important for me because I actually need a full-time job. Bills are not going to pay themselves and considering that I am not in school, I need a job to do the things I need to do to help myself and get back into school to get a better job."

Organizing the fair has never been easy, but the benefits have outweighed the challenges for more than 14 years now. "It is always a challenge, but we have a relationship with these employers-and as you saw at the job fair, there are many people there for us," Vogel said. "Plus, there are a number of young people that go through our training courses throughout the year on how to get a job and how to keep a job. These individuals were very well-prepared on how to go out and interview in order to obtain a job." •

Hawthorne Falls to 0-4 With Rugged Start

Hawthorne High's baseball team found Ocean League power Culver City too much to handle with two more league losses last week. At Culver on April 16, Hawthorne was shut out 5-0. At Hawthorne last Thursday, the Centaurs pulled away from the Cougars 8-2.

Last Thursday, Hawthorne and Culver were tied at two after three innings and the Cougars trailed 3-2 through four before the Centaurs let loose for five runs, behind a three-run home run by freshman Michael Netzel and a two-run shot from Darren Sylvester. The Cougars managed to have good pitching by senior Dominic Gutierrez through the first four innings before giving up the two homers in the fifth that put the game out of reach. Gutierrez pitched 5 2/3 innings, allowing six runs (four earned) on eight hits. He struck out six batters and walked one.

Sylvester, a junior, started the game with a solo homer, but Hawthorne came back to tie the game at one when Andrew Banuelos singled, scoring Gutierrez. Culver again took a 2-1 lead, but Chris Robles drove in a run with a base hit in the bottom of the third. Freshman Calvin Murrillo gave the Centaurs a 3-2 lead in the top of the fourth with a run-scoring single.

"Gutierrez pitched okay," Hawthorne head coach Greg Hines said. "We got to have the plays." The Cougars managed three hits in the game off Culver starting pitcher Nathan

On April 16, Hawthorne was not able to get much off sophomore pitcher Jay Sterner, who hurled a two-hit shutout. Sterner struck out eight batters and walked just one. Gutierrez and Steven Leyva had the only hits for the Cougars. Tim Stewart had a two-run homer for the Centaurs.

The Cougars (11-8-1 overall and 0-4 in league) hope to get back to winning form as they face Beverly Hills in two games this week. After visiting the Normans at La Cienega Park on Tuesday, Hawthorne hosts Beverly Hills today at 3:15 p.m. Hawthorne visits Inglewood next Tuesday at the same time.

Boston Strong

Almost two weeks ago now, the Boston Marathon was the site of one of America's greatest tragedies since the bombing of the World Trade Center in New York. Boylston Street, on that day, was supposed to be a place for celebration--a place that symbolized completion and achievement. Instead, what developed was utter chaos and disaster where because of two degenerate psychopaths, what should have been a feeling of fatigued fulfillment in an instant turned into utter terror leaving three people dead and more than 170 victims wounded. The events that took place that day can never be undone. People's lives will forever be changed from a rippling shockwave that touched every person's heart across the nation. The events that took place, though, will never be forgotten and America stands undefeated. A prevailing sentiment of resilience and the undying will to recover has now been born in the face of disaster--and once again, the United States stands strong. It has been learned that in the face of catastrophe, Americans band together and it is no different this time for Boston. Boston columnist Kevin Cullen put it ever so simply when he stated that the city of Boston only cares about three things in this life: "Politics, sports and revenge." Now in the aftermath, it is sports that will be the power to help get us through this tragedy.

The Boston Marathon has been around since 1897 and is considered to be the oldest continual marathon in existence. Attracting runners from all nations and all states in America, it is one of the, if not the most, popular marathon events in the world. It is important to not let this race nor any sporting event be diminished by the mindless attacks on last week's Patriots Day in Boston. Instead, the world, the nation and the city should come back stronger and fulfill what is an opportunity for renewal and accomplishment. "We don't want the evil people who did this to get the satisfaction of changing the symbol of Boston, which is freedom of movement, companionship, sportsmanship," said Mike Noori, a 52-year-old resident of Atlanta, Georgia who was at the race supporting his wife who ran in honor of her own breast cancer survival. Noori's wife Sina represents a microcosm of why Boston will remain strong and the marathon will go on and most likely be an emotional scene next year. People come from all walks of life to celebrate their own personal achievements or to run for a cause that means something in particular to them and those around them. It is the sport of marathon running that bonds those who participate and those who are affected around the world together. It's one sport for one cause with one thing in mind: Success.

Though the motivations of the attack remain uncertain, it is clear that they occurred at one of the world's largest and most patriotic athletic events in one of the world's most patriotic cities on an entirely patriotic day that commemorates the beginning of the American Revolution. What is great about the sport of the marathon is that it represents the ideal of freedom in and of itself. Anyone can enter of any age, any gender, any ethnicity or creed from elite runners to novices and those who share handicaps. There is no ticket that must be bought to watch and support those who are undertaking the feat. There is basically no barrier that separates the competitors from their fans. That same openness may in fact be what made the marathon such a target--but if the attack was meant to weaken the freedom that the race represents, it will fail miserably.

The 2014 Boston Marathon will indeed be one of the biggest marathons in the history of the sport. The amount of competitors entering the race will more than likely exceed the largest amount ever recorded. The amount of fans present to cheer on the competitors will pack and line the streets. Victims of this week's tragedy will undoubtedly return to finish that which they have started, once again instilling the feelings of jubilation, completion and success that were so effortlessly robbed from them this year.
