Council Approves Sponsorship of Relay for Life

In a unanimous vote on Tuesday, the Inglewood City Council approved the City's sponsorship of this year's Relay for Life, which takes place June 8-9 at Crozier Middle School. For the ninth consecutive year, the Relay for Life will be present in Inglewood thanks to the efforts of organizers and volunteers who devote their time to the 24-hour event in order to raise funds and awareness.

"It is about celebrating people who beat cancer and celebrating people that we have lost to cancer while remembering them and their fight," Regional Lead Volunteer with the Los Angeles Southwest Region Relay for Life American Cancer Society Michael Calzada said. "We also promote healthy lifestyles to combat cancer. Raising funds is what we aspire to do and we have been successful in the past--but not as successful as we need to be. Statewide our fundraising is down about 10 percent, so for Inglewood to come up with \$30,000 will be a big step for us because it means that the community is stepping up. In years past it has not been able to reach \$25,000, so it would be great if we could get large donors or if people simply came out and participated."

This year's goal for organizers is to reach 25 teams with 5-10 people per team. Hosting the event at Crozier Middle School provides a logistical advantage for organizers who can better coordinate and provide adequate facilities and communications.

"It [fundraising] has been up and down

during the nine years that the event has taken place, but community members and organizations always find a way to contribute," Calzada said. "Having it at Crozier Middle School is a big deal for us because it is close to the Police Department, close to City Hall and it allows us to use the facilities that City Hall offers. The City does not have a lot of open space, so it is critical for us to have the [Inglewood Unified] School District get involved. The School District also promotes the event at schools, which is great."

In the past nine years, the Inglewood community has been able to raise \$165,000 for the American Cancer Society through the Relay for Life. For organizers, educating the community about cancer is a crucial element of the Relay. "One of the amazing stats that I always tell people and it usually stops people in their tracks is that one in three Americans will get cancer in their lifetime... It is a statistic that I think of every day as I go to work doing this," Staff partner with the Inglewood Relay For Life Dana Waldrop said. "What we are trying to do is prevent those numbers and through Relay for Life, we are raising money to fund programs that have to be in the Inglewood community."

Some of the programs that exist to help people battling cancer include Road to Recovery, where cancer patients who do not have transportation are given rides to receive treatment. There is also a program for women called Look Good, Feel Better

in which women who are going through treatment can meet with a cosmetologist or beauty advisors to help them put makeup on, put on a wig or fix their eyebrows. There is even a 24-hour number to which people who have been diagnosed and who are struggling can reach out: 1-800-ACS-2345.

There are approximately 5,000 Relay for Life events nationwide and 400 in California alone. In the South Bay, there are 25 and the event has grown and allowed organizers to continue spreading information about cancer while providing support to those who have battled the disease.

"We not only honor cancer survivors who participate in the event for free--we give them a special t-shirt and honor them with a special lap as well, but we honor the caregivers," Waldrop said. "It is not just about the person that is fighting cancer, but it is about the entire family and their entire network. For every person that is fighting cancer that is going through treatment, there are caregivers fighting that battle with them day-by-day, side-by-side."

Calzada added, "It is really important that the message gets out that cancer never sleeps--and neither can we and raising funds while promoting awareness which allows the message to continue."

So far, there are 16 teams and 44 people registered. Cancer survivors register for free. For persons interested, more information about the event is available at: www.Relayforlife.org/inglewoodca. •

RESOLUTION NO. 7540

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HAWTHORNE, CALIFORNIA, DECLARING ITS INTENTION TO LEVY STREET LIGHTING ASSESSMENTS FOR FISCAL YEAR 2013-2014 AND SETTING TUESDAY, JUNE 11, 2013 AT 6:00 P.M. AS THE TIME AND DATE OF A PUBLIC HEARING.

WHEREAS, the City Council of the City of Hawthorne, California, has adopted Resolution No. 5178 on the 26th day of April 1982, forming the Street Lighting Maintenance District of Hawthorne, pursuant to the provisions of Section 22585, et. seq. of the Streets and Highways Code; and WHEREAS, on May 14, 2013 the City Council approved preparation of an engineering report setting forth estimated street lighting assessments for fiscal year 2013-2014; and

WHEREAS, the required engineering report and estimates have been completed and filed with

the City Clerk and approved by the City Council.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the City Council of the City of Hawthorne, California as follows:

Section 1. That it is the intent of the City Council to levy and collect assessments within the assessment district described in the City Engineer's Report, dated May 16, 2013 for the fiscal year 2013-2014, except that there shall be no assessment upon a Federal or State government agency, or another local agency.

Section 2. The improvements in the district consist of the public and traffic signal lighting facilities now or which may hereafter be constructed or installed, and the maintenance and servicing thereof.

Section 3. The district is designated as the Street Lighting Maintenance District of the City of Hawthorne and its general location is within the boundaries of the City of Hawthorne.

Section 4. A full and detailed description of the improvements, the boundaries of the assessment district, its zones and the proposed assessments upon assessable lots and parcels of land within the district are contained in the City Engineer's Report of May 16, 2013, which report is incorporated by reference hereby as though fully set forth herein.

Section 5. That, pursuant to Section 22625 of the Streets and Highways Code of the State of California, on Tuesday, June 11, 2013 at 6:00pm, a hearing will be held by the City Council of the City of Hawthorne, California, regarding the levy of the proposed assessment. The hearing will be held in the City Council Chambers, located at 4455 W. 126th Street, Hawthorne, CA 90250.

Section 6. That the City Clerk shall give notice of said hearing causing the Resolution of Intention to be published pursuant to Streets and Highways Code Section 22626.

Keeping Funeral Costs Affordable

Anyone who's put a loved one to rest knows that death is not cheap. According to the National Funeral Directors Association, the average adult funeral cost \$6,560 in 2009 (their most current data). That doesn't include such common additions as a cemetery plot, headstone, flowers, obituaries and limousine, which can add thousands to the bill.

Because death is a frequently avoided topic, many people aren't armed with information about the many variables – and costs – involved in planning a funeral. Thus, just when survivors are grieving and most vulnerable, they're bombarded by decisions that must be made quickly, often without even knowing what their loved one would have wanted.

The key message for the living is to decide on preferred funeral arrangements ahead of time and to convey those wishes to your family – ideally in your will.

Another important lesson: Know your legal rights and what funeral-related goods and services cost so you – or your survivors – don't feel pressured into buying things you don't want or need. The Federal Trade Commission (FTC) oversees "The Funeral Rule," which regulates how funeral providers must deal with consumers. Among its provisions:

Upon request, funeral homes must provide an itemized price list of all their goods and services, whether you call (even anonymously) or visit in person.

You have the right to choose among their offerings (with certain state-mandated exceptions) and are not required to purchase package deals containing unwanted items.

Prior to purchasing a casket or outer burial container from a funeral home, they must share descriptions and prices before showing you stock on hand.

Providers that offer cremations must make alternative containers (besides caskets)

available.

Note: The Funeral Rule does not apply to third-party sellers such as casket and monument dealers, or to cemeteries that lack an on-site funeral home.

If your beliefs don't require following specific funeral protocols, here are a few ways to reduce costs while still honoring the deceased and their survivors:

Veterans, immediate family members, members of the Commissioned Corps of the U.S. Public Health Service and certain civilians who've provided military-related service may be entitled to burial at a national cemetery with a grave marker. Burial is free, but families are responsible for funeral home expenses and transportation to the cemetery.

A \$255 lump-sum death benefit is available to surviving spouses or minor children of eligible workers who paid into Social Security.

For many, cremation is a viable, less expensive option to burial. If you plan to hold a viewing first before the cremation, ask whether you can rent an attractive casket for the ceremony.

Some families prefer not to hold a public viewing. For them, "direct cremation" or "immediate burial" may make sense. Because the body is promptly cremated or interred, embalming and cosmetology services are not necessary, which saves hundreds of dollars. Also, with direct cremation you can opt for an unfinished wood coffin or heavy cardboard enclosure for the journey to the crematorium.

You can purchase a casket or cremation urn from a source other than your funeral home. The funeral home cannot assess handling fees or require you to be there to take delivery.

The death of a loved one is always upsetting, but you may be able to ease your family's emotional and financial burdens by planning ahead. •

The top Belles' performer was the championship from triple jumper Rachel Toliver at 39 feet, 3.25 inches. Toliver jumped 40-0.5 inches in winning the Division IV title on May 18 at Mt. San Antonio College in Walnut. St. Mary's also advanced Kayla Phillips in the triple jump at 39-3.25.

Junior standout Sierra Peterson made the State meet after placing fifth with a time of 23.96. Peterson finished behind champion Arianna Washington from Long Beach Poly (23.18), second place Brittany Brown (Claremont, 23.95), third place La Troya Franklin (Long Beach Jordan, 23.9) and fourth place Eboni Sutherland (Corona Centennial, 23.92).

Peterson also ran in the second leg of the Belles' 400 relay, which was second in 46.12. Other runners included junior Allanah Hughes, sophomore Aliyah Hale and senior Toliver. Winning in a runaway was Long Beach Poly, timing 44.94—one of the top prep times in the United States this year.

All will compete in the California State Championships at Buchanan High's Memorial Stadium in Clovis (Fresno area) on Friday and Saturday. Friday's prelims will begin at 1 p.m. Top finishers advance to the championship with the field events starting at 4 p.m. and the running events beginning at 6 p.m.

Arts Takes Center Stage in Hawthorne

The Hawthorne School Board discussed their Arts Strategic Plan during the Board's May 22 meeting. Assistant Superintendent of Educational Services Brian Markarian provided an overview of what the district has accomplished and what challenges remain before meaningful art education can be found in every Hawthorne classroom.

Arts are in the core requirements for elementary school curriculum by law, but Markarian said that education in arts is valuable enough that even if the district wasn't required to teach the arts, the district would continue to do so.

"Arts are core . . . and we could swap out core with the word critical," said Markarian. "Even if it wasn't in legislation we know the arts or critical and making sure students are exposed to the arts is part of our mission."

To explain why the district needs an Arts Strategic Plan, Markarian had to explain why arts are important to students. He said the benefits of arts education are many. Markarian cited research that shows arts education leads to better engaged and ultimately more successful students. One major bonus of arts education is that studies show a correlation with a background in arts and success in college.

"We know the arts can motivate," said Markarian. "We see positive increases in every area connected to increased exposure to arts. There is more and more research coming out really defining that relationship between arts education and academic achievement."

As important as arts education is to a student's success, in a landscape of declining education budgets it is often the first program to be cut. However, instead of cutting in Hawthorne, the district looked to outside organizations to help keep arts education funded. In 2011 the district partnered with Arts for All, an LA County organization that brings creative arts lessons to classrooms throughout the county. Markarian said that Arts for All was a strong partner for the district.

"We had certain things we wanted to do in arts education but we needed to find a strong partner," said Markarian. "And Arts for All is that partner for us."

Becoming an Arts for All district involved training district leadership in introducing arts to the classroom through a series of profession development seminars. The district also hired arts coach Jennifer Zakkai to teach arts strategies to teachers in nearly every school in the district. The goal for the district is to provide some arts education to every student, even if it take wildly different forms.

"We need to provide quality arts education to all students," said Markarian. "It's going to look different in different places, but

certainly we want to increase access."

In his strategic plan, Markarian identified that securing funding would be a major challenge in expanding arts education. He mentioned making use of fund raising, partnerships with local businesses or non-profits and applying for arts grants.

"We need to secure resources to expand and sustain arts education," said Markarian. "We can have the greatest plan laid out, but if we can't find the resources to make it happen, we probably aren't going to have much success. We know we need to dedicate the time and effort."

Another goal Markarian identified for a successful arts program is to raise awareness of arts education. Reminding the public about how beneficial arts education is should help justify the expense of these programs.

"We [should be] constantly highlighting the positive attributes of arts education and showcasing student achievement in the arts," said Markarian.

While the district has made progress in improving their arts programs, there is still more work to be done.

"We have a lot of work ahead of us, but it's necessary work to provide our kids with a rich, well rounded educational experience," said Markarian.

The remaining work will have to be done without the help of the district's arts coach as Zakkai will no longer be working with the district. She sees a bright future for arts in Hawthorne School District and said she was honored to work with the district. During her work in teaching the district about arts education she saw how capable Hawthorne's leadership is.

"Making a difference in students' lives takes vision, courage, leadership, resourcefulness and sustained practice," said Zakkai. "All of which have been in evidence during the rich collaboration between the Hawthorne School District and Arts for All."

The presentation closed with a performance from the district's student band. The group of violinists and cellists received a standing ovation from the audience. Zakkai said performances like this one are an example of how arts education provides an avenue to increasing a student's self-confidence.

"This is what the work is all about," said Zakkai. "It's about you being able to put your skills and talents into practice."

For those wishing to see more student art work and performances, Prairie Vista principal Chris Fagnano shared that her students as well as other Hawthorne, Lawndale, Wiseburn, Lennox and Centinela Valley students would be involved in the Take Part In Art festival held on June 1 at Dana Middle School from 10 a.m. to 2 p.m. The festival will include hands-on art making booths, artist workshops, student artwork gallery and student performances.

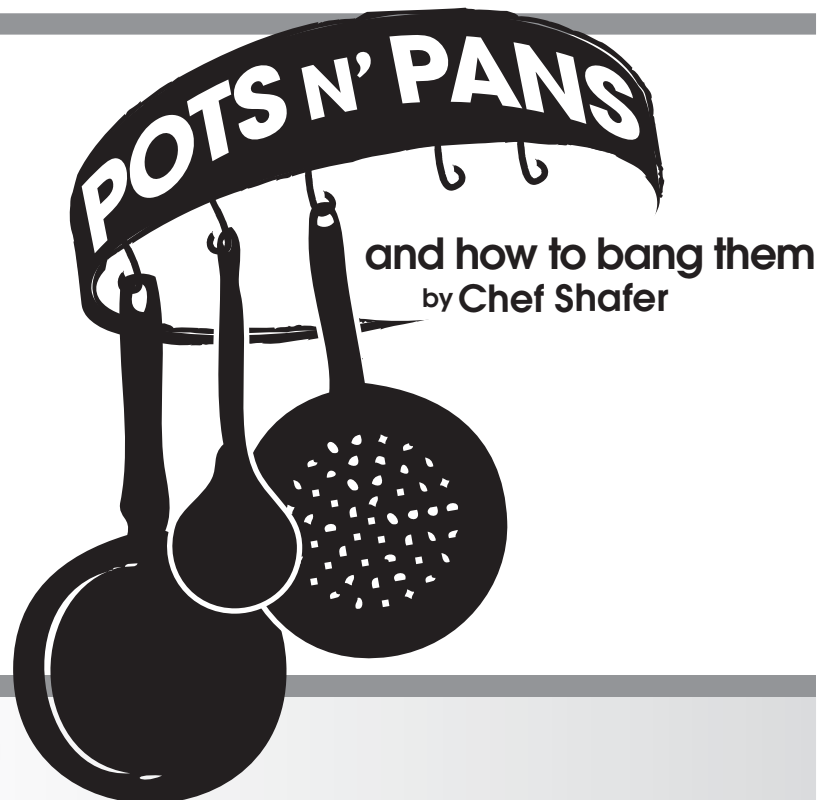

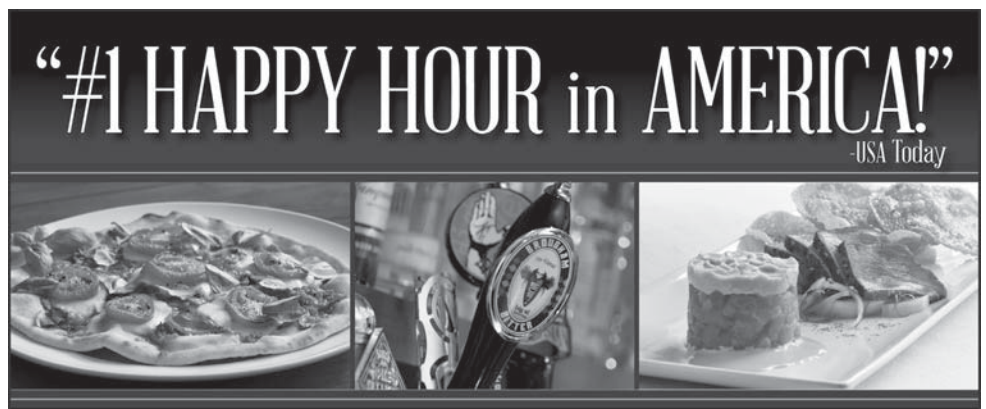

Getting Better at Preventing Animal Abuse

In September of last year Senate Bill 1500, introduced by State Senator Ted Lieu, was finally signed by Governor Jerry Brown. Unlike most laws that make the cruel and inhumane treatment of animals a crime, this bill focuses on issues such as overcrowded shelters and protecting the abused animal from being returned to abusive owners.

Prior to SB 1500, there was a loophole in the State's laws that forced animal control agencies to return abused animals to their abusive owners, regardless of evidence proving that the animal was mistreated. The law specifically indicated that mistreated animals must be returned to the owner if the animal is physically fit or the owner can and will provide the necessary care for the animal. Unfortunately in many cases, the abused/neglected animal would physically recover from its wounds having been in a shelter and hence would be deemed fit to return home.


SB 1500 is a more comprehensive approach to dealing with abused pets. The new law will allow animals to be removed from the custody of their owner prior to the resolution of their pending criminal case, so long as a judge rules that there was probable cause to seize the pet or pets. In addition, the law places cost liability of the shelter care on the owner if they refuse to surrender the animals.

The reason all of this is important is because our laws are taking a huge step when dealing with crimes. This law addresses animal abuse/neglect/cruelty in a more comprehensive way. Unfortunately our society is quick to impose punishments on criminals, which are very

necessary, without always providing the proper follow-up for the victim. This law is making sure that the animals recover in the long run. It ensures that an abused animal no longer has to be forced back into the environment that put its well-being at risk in the first place.

As humans, we can remove ourselves from negative environments to improve our living situation. Despite having such an advantage over the rest of the animal kingdom, we sometimes fail to do that for ourselves. Unfortunately, animals do not have such abilities. They are dependent on people and when the people they depend on the most fail them in the worst of ways, there must be laws in place to help these animals. The help must include more than being removed from the abusive environment. There has to be follow-up and SB 1500 establishes the initial follow-up needed to ensure that a rescued animal does not become a victim for a second time.

The safeguards established by this new law will allow for the development of more effective and comprehensive recovery plans when dealing with rescued animals. While it is a fact the animal shelters are overcrowded and rescued pets add to the burden, that does not mean the answer is releasing the animal back into the hands of an irresponsible owner. Animal rescue efforts are to be applauded and admired and to those organizations that spend every penny they raise and endless amounts of volunteer hours rescuing and caring for abused animals, I thank you. It is encouraging to see that a new law is in the books that seeks to act beyond prosecution and fines when dealing with the issue. •
