## Classified Employees Protest Outside Inglewood Unified School District Office

Car horns blared as classified employees picketed outside the Inglewood Unified School District office during the June 19 School Board meeting. With signs demanding that the State Superintendent of Public Instruction Tom Torlakson visit the area, protestors expressed their concerns and displeasure at the cuts being made ever since the State took over the District.

“They [State officials] do not understand Inglewood,” California Professional Employees, Local Union # 2345 representative Christopher Graeber said. “They try to apply this cookie-cutter format, but they are not here. Torlakson should be sitting right beside you [State Interim Superintendent La Tanya LaTonya Kirk-Carter]. He was elected. I am a voter. I am his boss.”

The classified employees gathered to protest against additional pay cuts proposed by Kirk-Carter. Approved that night were the elimination of 42 positions, including plant managers and campus supervisors, saving the District \$800,000.

“The impact would be big. There will be a lot of custodians not cleaning schools and safety will be a big issue,” campus supervisor Jose Celis said. “We all understand that the District is going through some tough times, but there should always be a plan A, a plan B and plan C and you should follow them. It’s not just about cutting.”

Since becoming State Interim Superintendent, Kirk-Carter has made budget adjustments by eliminating positions from the classified employees--and on May 28 during a community budget meeting, it was proposed that 171 classified employees, janitors, campus security and transportation employees be laid off to help shorten the \$17 million budget deficit. It was not clear if the 42 positions eliminated during the June 19 meeting were part of those 171 positions, but Kirk-Carter told employees present that the cuts are being ordered from the State and that she is only there to ensure that actions are followed through.

“My job is to come and balance the budget and make recommendations as much as possible and then get to the point where they are made for you. This process is real. It is not fun and my power is limited,” Kirk-Carter said. “It is no longer local control. There are no longer things we can look at and say we really need this. We can’t say we won’t have this in our school district. There are 1,500 school districts in California and of those, they try to make you fit into a box of what they are accustomed to looking at.”

Kirk-Carter indicated that the cuts are being made based on two reports written by a group of people sent by the State to study the areas of pupil achievement, facilities and technology, and human resources. However, she also said that the reports were not available

as of the meeting.

“We saw these people come and they were going to make the recommendations and this is not the end,” Kirk-Carter said. “It is too easy to make the cuts on the backs of the classified folks and I don’t like it as much as you don’t like it. If I was to follow the dictate, everybody would be unemployed as of June 30.”

The 42 positions eliminated during the June 19 meeting were followed by the approval of 19 custodial positions. For the classified employees, this was considered a move to demote plant managers.

“All I know is that these are our jobs and as a plant manager to be put back to custodian is not very nice. I am here to let you know that we work hard,” Julian Valdez, plant manager at Hudnall Elementary School, said. “I make sure that the school is secure. I am the only guy at the school, practically. The kids look up to me. I do not need to go ahead and speak about other schools, but I know that campus supervisors, myself as a plant manager, the bus drivers and everybody works together. We do our jobs and we don’t need another cut in pay. We are already having a hard time.”

Classified employees are also concerned with what they consider a lack of cooperation and transparency from the State Interim Superintendent and State administrators. “Since day one, she [Kirk-Carter] has not bargained--she will say one thing, but in writing it is different,” Celis said. “I would like a response. I want him [Torlakson] to figure out a plan and tell us the truth. If he tells us the truth, then we can work with him and figure things out. He needs to tell the public and let the parents know what is going on.” •

4. Use outdoors only: keep away from flammable materials
5. Light one at a time, then move away quickly
6. Keep others at a safe distance
7. Never point or throw fireworks at another person
8. Never alter or take apart a firework
9. Do not give fireworks to young children under any circumstances
10. Have a bucket of water handy for emergencies and for dousing misfired/spent fireworks
11. Never attempt to re-light or fix malfunctioning fireworks

Idiocy abounds, but among the many versions of *The Ship of Fools*, none could

"Okay," they acknowledge, "there are 30 million surveillance cameras in the U.S. and 80 government agencies have received FAA approval to launch as many as 30,000 domestic spying drones above the U.S. over 20 years, but what's that got to do with me?"

So the NSA has arranged to have all ATM and credit card transactions available to the government. Shouldn't the government know everyone's financial transactions?

The Transportation Security Administration can collect travelers' data on a daily basis and hold it for two years; and social media

### Political Q & A

Dear Friends,

Today, I voted for the 2013-2014 fiscal year budget that the California State Legislature passed and is now on its way to the Governor for review and final signature. Some of the reasons why I voted for this compromise budget:

- Overall, this is a balanced budget based on fiscally conservative revenue projections that restores funding for priorities like education while also setting aside over \$1 billion in reserves. This is the third year in a row that the Legislature has passed a budget on time by the constitutional deadline.

- As a former South Bay school board member, I have been fighting for more funding for our South Bay schools. Thanks to all the letters, e-mails, and phone calls from many of you, K-12 school districts will receive more funding this year than last year. Moreover, we achieved an increased base funding grant for all school districts, including suburban districts.

- The budget increases funding for the University of California, California State University, and community college systems. This is an important investment in our economy and our future workforce. Also,

families with incomes at or below \$150,000 will benefit from a cut in student fees by up to 40 percent beginning in 2014-2015.

- The budget provides a modest funding increase of \$63 million for the state's courts. As a former prosecutor, I will continue to fight to restore court funding to ensure access to justice for all.

- The budget provides \$6 million in additional resources for our military veterans to reduce the unacceptable backlog for filing veterans disability claims. As Chair of the Assembly Veterans Affairs Committee, this is a top priority for me.

While I am pleased that we passed an on-time balanced budget that restores funding for priorities like education, this is a compromise budget, and it is not perfect. There are parts of the \$96.3 billion budget that I am not happy with. However, I will continue to fight for the South Bay, and I will continue to fight for common sense priorities for California -- good jobs, good schools, safe neighborhoods, and a healthy environment.

As always, I welcome your thoughts, and I look forward to continuing to work with you.

### Tax Incentives that Benefit Landowners, Provide Healthy Food Options for Community

The State Assembly recently passed AB551, authored by Assemblyman Phillip Y. Ting from San Francisco, in which cities and counties are authorized to create urban agricultural incentive zones. The legislation would also allow reduced property assessments when a property owner allows any type of small-scale food production on said land. What does that mean? It breaks down to cities and counties being able to enter contracts with landowners in order to create small gardens while offering tax breaks/incentives to the owners.

In the past our legislators have been known for approving generous tax breaks for corporations and small businesses, which do provide a benefit to consumers. The impact of the tax incentives from AB551 are just as important and beneficial to consumers as the tax breaks given to other businesses. Giving property owners the ability and financial incentives to produce fresh produce will add to a city's sense of community while promoting healthy eating.

Most cities in the South Bay enjoy having their weekly farmers' markets. It is a chance for residents to purchase non-mass-produced fruits and vegetables from local growers and in turn help stimulate the local economy. Simultaneously, it is an opportunity for the people in the city to gather and build a stronger sense of community. Through Assemblyman Ting's legislation, which is now in Senate Committee, the unifying effects of a farmers' market in a city will be expanded as more and more community gardens are likely to get started.

With the recent push promoting healthy lifestyles through exercise and the consumption of fruits and vegetables, empowering residents to create community gardens is a very effective way to promote the well-being of the city's residents. Allowing people to witness the harvesting process of the goods sold at these farmers market is going to pique their interest in these products and has a high potential for people to consume these goods. Just like any business, if the products are good, people will come back. Having people return to purchase the foods that are grown in their own city creates a direct economic impact on the community.

Furthermore, if customers keep purchasing these fruits and vegetables, that means they are eating healthier--which leads to a healthier lifestyle and we can all appreciate the trickle effect that has on the rest of the community.

Just as important, the community is interacting face-to-face. In our digital era when emails and text messages are the preferred method of communication, it is refreshing to have opportunities where we can interact with old friends, neighbors and local business owners for a few hours one day a week. We continue to be amazed at how the world is at our fingertips because of technology and yet we engage less and less with the world outside our front door. AB551 will help our communities with healthy food options. It will help our communities by incentivizing the creation of local gardens, which will lead to a direct economic impact. # Looking Up

## Alive on a Pale Blue Dot

On July 19, NASA's Cassini spacecraft will be turned to image Saturn and its entire ring system during a total eclipse of the Sun, as it has done twice before during its nine years in orbit. But this time, the images that will be collected have been specifically designed for something very special. They will capture, in natural color, a glimpse of our own planet next to Saturn and its rings, taken from nearly a billion miles away. "It will be a day," says Cassini imaging team leader Carolyn Porco of the Space Science Institute in Boulder, Colorado, "for all the world to celebrate."

"Ever since we caught sight of the Earth among the rings of Saturn in September 2006 in a mosaic that has become one of Cassini's most beloved images, I have wanted to do it all over again, only better," says Porco. "And this time, I wanted to turn the entire event into an

planned trajectory for the remainder of its Saturn mission in search of the best time to image the Earth when it was unobstructed by Saturn or its rings, and when there weren't other pressing scientific observations that rendered the idea impossible. Imaging any planetary body close to the Sun necessitates doing so when the Sun is completely blocked, so that no undiluted sunlight can enter the cameras or other Cassini instruments and damage their sensitive detectors. Such opportunities during Cassini's orbital tour are rare.

When all was considered, the best time for this event was found on July 19, 2013. For several hours on that day, the spacecraft was once again going to be in Saturn's shadow.

Unlike previous images of Earth by NASA interplanetary spacecraft since the days of Voyager, this will be the first time the world's people will know ahead of time that their

opportunity for everyone around the globe, at the same time, to savor the uniqueness of our beautiful blue-ocean planet and the preciousness of the life on it." Porco was also involved in co-initiating and executing the famous "Pale Blue Dot" image of Earth taken by NASA's Voyager 1 from beyond the orbit of Neptune in 1990.

The intent for the upcoming mosaic is to capture the whole scene, Earth and Saturn's rings from one end to the other, in those particular camera filters—red, green and blue—that can be composited to form a natural color view, or what human eyes might see at Saturn. It also includes imaging the Earth and the Moon with the high-resolution camera—something not yet done by Cassini.

Three years ago, Porco and her staff members at CICLOPS began carefully examining Cassini's

picture is being taken. "My sincere wish is that people the world over stop what they're doing at the time the Earth picture is taken to revel in the sheer wonder of simply being alive on a pale blue dot of a planet, and to appreciate the ever-widening perspective of ourselves and our world that we have gained from our interplanetary explorations," says Porco.

## Share Your Money Before You Die

Now that the long-debated estate tax rules have finally been settled, let's get real: Despite all the hoopla raised, most people probably would never be impacted whether the lifetime estate tax threshold had stayed at \$5.12 million or reverted to \$1 million. In the end, it actually went up a bit to \$5.25 million for 2013.

Even if your estate will only be a fraction of that amount, it still pays to have a plan for

Any interest the account earns is not subject to federal (and in most cases, state) income tax; plus, many states offer tax deductions for contributions made to their own 529 Plans. distributing your assets. If your finances are in good shape, there's no reason not to start sharing the wealth while you're still around to enjoy helping others. It also doesn't hurt that you can reap significant tax advantages by distributing a portion of your assets now.

Before you start doling out cash, however, make sure you are on track to fund your own retirement, have adequate health insurance, can pay off your mortgage and are otherwise debt-free. You wouldn't want to deplete your resources and then become a financial burden on others.

If you can check all those boxes, consider these options:

**Avoid the gift tax.** You can give cash or property worth up to \$14,000 per year, per individual, before you'll trigger the federal gift tax. (Married couples filing jointly can give \$28,000 per recipient.) You'll probably never have to pay a gift tax, however, since you're allowed to bestow up to \$5.25 million in gifts during your lifetime above and beyond the annual \$14,000 excluded amounts before the gift tax kicks in — which for most of us means never. Read IRS Publication 950 (at [www.irs.gov](http://www.irs.gov)) for details.

**Pay for education.** If college is still far off for your children, grandchildren or others,

and gifts don't count), you may fund a Roth IRA on their behalf. You can contribute up to \$5,500 or the amount of their taxable earnings for the year, whichever is less. Your contributions are made on an after-tax basis but the earnings grow, tax-free, until the account is tapped at retirement.

**Fund someone's benefits.** Many people cannot afford health or other insurance and so forego coverage, putting themselves just one serious illness or accident away from financial disaster. Many also can't fund their 401(k) plan or IRA. Consider applying your tax-exempt gifts to help loved ones pay for these critical benefits. You'll not help protect them from catastrophe, but also greatly increase their long-term financial self-sufficiency.

**Charitable contributions.** If you're planning to leave money or property to charities in your will, consider beginning to share those assets now, if you can afford to. You'll be able to enjoy watching your contributions at work — and be able to deduct them from your income taxes. Read IRS Publication 526 for details.
