# **Space Shuttle Endeavour to Travel Through Streets of Inglewood**

After nearly two decades, 25 missions and nearly 123 million miles in space, the Space Shuttle Endeavour will soon make its way from LAX to its new and permanent home at the California Science Center in Exposition Park. The 170,000-pound shuttle's transportation effort through the City of Inglewood is being carefully coordinated by representatives from the California Science Center, the City's Public Works Department and the Parks, Recs and Library Services Department.

"We are going through two cities--the City of Inglewood and the City of L.A.--so we reached out to both cities as soon we were awarded the Endeavour," President and CEO of the California Science Center Jeffrey N. Rudolph said. "Everyone here, from the Mayor to all of the staff, has been fantastic

like we are doing it every week. I hope that Inglewood will put its best foot forward. I have marked the date and I have already applied for the day off from work. To me it represents truly a bygone era.

The unprecedented task will require the removal of 50 overhead power and communication lines, 19 traffic lights, 14 road signs, 75 small trees and 52 large trees, among other items. In addition, the CSC has committed to replace every tree removed at a rate of two-for-one.

"City inspectors will accompany the shuttle as it is moving down Manchester Avenue to ensure and to document any damages to the city's infrastructure," Executive Assistant to the City Manager Mawusi Watson said. "All costs associated with the day of the move will be covered by the CSC, including police which is the largest expense."

The shuttle is expected to arrive at LAX on September 20, depending on the weather condition, and is expected to begin its trek to the CSC on October 12 and actually make its way through Inglewood on October 13. These tentative plans began April 12, 2011--the day that NASA told CSC the latter would get the space shuttle. At that moment, planning for the space shuttle's transportation became the center of attention.

"There is a competitive process with

However, the overall sentiment prior to the presentation made by Rudolph was excitement in anticipation of the historic event. For one resident, the space shuttle is a reminder of his motivation as a child to move to Southern California back 1981.

"I had just moved from Northern California down here chasing a dream I had because I saw a picture on the wall of a restaurant in Vacaville of the First Flying Wings and I said to myself, 'I am going to work for that company one day." Inglewood Resident Bernard Davis said. "To go to Downey and see that actual shuttle being built was amazing and she is coming home, basically. ## **Think for Yourself**

Just like in high school, most centers of assembly are socially segregated into different groups with similar philosophies. Most members prefer to stay in their own cliques and justify their membership for a sense of belonging, a feeling of safety and approval. This leads members to think collectively and become more like each other by changing their own appearance, interests, or, in more drastic situations, their own morality. But the constant pressure to think as a group and "become one" pushes people to abandon their own individuality and replace it with a crowd mentality. This brings up the issue on whether an individual's thoughts is actually his own or those of the social hive-mind.

Ever since the existence of life, animals had to constantly adapt in order to survive. Although it is less gruesome than before, the "Adapt or Die" ideology is still shown today when individuals are pushed to adapt to different social factors in order to maintain a decent social life. This form of Social Darwinism is similar to what is seen in the wild where individuals form larger groups based on similar attributes for protection. This example is shown in its most primitive form through tribes, and in its more current form as clubs and cliques. Instead of using the group for protection from physical threats, such as a charging Bull Elephant, today's groups are usually created for another form of danger: ridicule and emotional harm. This concept of having power in numbers deters would-be bullies, or charging Bull Elephants, from harming members of the group. The parallel between humanity's tribal roots and its present social state is evident in these examples, as both rely on forming larger groups for protection. But another reason why groups are formed is the human desire for approval.

People desire approval and want to know their hard work is recognized by their superiors. As children, this form of recognition would be a "good job" and a pat on the back, while as adults, recognition would take into the form of a raise or a promotion. The same can be said in groups where people are driven to do even the most mundane and embarrassing tasks just to gain the favor of their superiors. New members of a club are usually looked down upon as "newbies" and are the first choice to do mundane tasks such as documenting activities and picking up trash. But over time, the boring tasks usually are compensated with respect from other members and the individual is entitled to more benefits.

Some of these benefits include being accepted into the group as a true member and gaining the privilege to accompany members into social gatherings. Yet again, the natural need for protection is shown in this example. But not only is the person gaining protection, he is also procuring benefits from being in a bigger group. This practice dates back to our formative years when our hunter-gatherer ancestors found it much easier to hunt prey in large groups. But with the benefits listed in the stated examples, why would any individual choose to remain independent? It is because of the potential troubles of following what others say.

Sometimes, the desperate need for belonging can lead to very life-altering mistakes. A solid example of this is in gangs. Just like in most groups, gangs are mainly made for the sake of protection and acceptance. Gangs function the same way as their more civilized counterparts, but tend to resort to more violent acts to gain respect. For example, instead of doing the mundane task of cleaning desks to gain acceptance, some gangs would instead push a recruit to do illegal acts to prove their self-worth. This includes stealing cars, robbing stores and even inflicting harm on civilians. But although gaining acceptance to the group is an accomplishment to some, the feeling is short-lived as a number of new members regrettably end up in prison cells. So with all the different personalities individuals have to be, when can one separate the thoughts of an individual from those of the social hive-mind? The answer is to single out the individual as a person and not generalize their views as those of the group.

There are many instances in people's lives when they find out that the person whom they believed to be ended up being the complete opposite of their expectations. This may have a positive or negative outcome, but usually surprises or humbles the person. There are a large number of smart and respectable people who unfortunately make the wrong decisions and join the wr ong group. Likewise there are also a number of sinister "wolves in sheep's clothing" who are members of reputable organizations. The only way to truly know the thoughts of an individual is to forget about what organizations they are in and focus on the person himself. Generalizing and stereotyping prevents someone from separating the individual from the group because it sets an unfair expectation of the person's beliefs. I have had many instances in my life when I was surprised to find out that the same people who act like gangbangers with their "homies" are the same people who knock at my door with the utmost respect and credibility. The main difference between the person I meet in school and the same respectable man in my neighborhood is the absence of the group, and presence of the individual in the purest and unadulterated form.

With the increasing pressure to join groups, it is ever more difficult to maintain one's individuality. Groups provide the protection and acceptance most people long for, but also can bring forth some unexpected consequences. Blindly following the orders to climb the social ladder causes these problems to occur and produces more harm than good. Unfortunately, people tend to base someone else's beliefs solely on the views of the group and set unfair expectations on the individual. With this, the only way to differentiate the views of the individual from the group is to view him as a person--not a member. •

Hard to believe we are more than half way through summer this election year which means mail boxes and answering machines will soon be overflowing with election campaign messages and literature from Federal, State, County and local elected officials and committees pushing various ballot measures.

So here are some dates to keep in mind prior to the November 6th Election Day.

If you have recently moved, changed your party affiliation or failed to vote in the last two general elections, you must register by October 22, 2012, to be eligible to vote. You may apply between October 8 to October 30 for a vote by mail ballot.

Voters who wish to vote by mail must submit a written request for a ballot no later than 7 days prior to election day. If you will be unable to vote in person on election day, promptly complete and sign the application for a vote by mail ballot and return it to:

**REGISTRAR-RECORDER/COUNTY** CLERK

Under state law, a voter may apply for permanent vote by mail status. As a permanent vote by mail voter, you will no longer have to apply for future elections. A ballot will automatically be mailed to you for each election in which you are eligible to vote. A spouse or other person who resides with you may also want to apply for permanent vote by mail status.

# Hawthorne P.D. Captures Home **Invasion Robbery Suspect**

On August 10, 2012 at approximately 4:00 am, Hawthorne Police Officers responded to the 4500 Block of 115th Street reference an inprogress armed robbery. Neighbors reported hearing loud voices next door and it appeared as though the neighbor was being robbed. When Officers arrived, they set up a containment around the victim's residence and after a few minutes they observed a subject exit the house holding grocery bags containing valuables. Officers on scene ordered the man to the ground at which point he alerted the officers that he was the victim, and that the armed suspect was still inside his residence.

Within moments, officers observed a second subject exit the residence and the victim immediately identified this second subject as the perpetrator. The suspect was ordered to the ground and upon doing so the suspect tossed a replica handgun on the ground near the entrance to the home. He was taken into custody without incident. He has been identified as 19 year old Devonte Austin of Los Angeles. Officers interviewed the victim who reported that he was going to work that morning and while getting into his vehicle, which was parked in the driveway to the home, Austin approached him from behind and struck him in the back of the head with the butt of a handgun. The victim fell to the ground and was robbed of his belongings. The victim was ordered to get into the car and then forced to drive to a nearby gas station where he was ordered at gunpoint to retrieve money from the ATM.

Austin followed her into the bedroom where he pointed the handgun at her. The victims were repeatedly threatened to cooperate or the husband would be killed, his wife raped and their baby killed. Austin also told the victims that he did not care anymore about them and that this was the 5th robbery that he had committed through-out the night. The victim was also ordered to take valuables out of the bedrooms and to place them in living room area near the front door.

As the victim was ordered to carry his own property to his car, officers on scene took Austin into custody.

Detectives following up on this investigation were able to canvass the neighborhood for evidence or witnesses to this crime and vielded evidence linking Austin to a residential burglary a few houses away that had occurred within half-hour of the robbery. Local home surveillance video captured images of Austin near both victims' homes just prior to the robbery and residential burglary. Theses images also show Austin acting alone, and it is not believed that there was a second suspect in either crime. Detectives believe that Austin may be responsible for other related crimes that may have occurred through-out the night. Austin is currently under arrest for kidnapping for robbery, home invasion robbery, carjacking and assault with a deadly weapon. Austin's bail is currently set at 2-million dollars. Detectives have also learned that Austin is currently out on bail for a similar burglary arrest that took place in the Lennox area in March of 2012. Anyone with information is encouraged to contact the Hawthorne Police Department, Detective The Vu, at (310) 349-2844. The case remains under investigation by Hawthorne Police detectives. •

## Ex-Leuzinger Hoop Star Wins Gold for U.S.

Former Leuzinger High and Hawthorne resident Russell Westbrook was denied with his Oklahoma City Thunder of winning the National Basketball League crown by the LeBron James-led Miami Heat in June, but he, along with James and the rest of the United States' men's basketball team, captured the gold medal as the Americans topped pesky Spain 107-100 last Sunday in the XXX Olympiad London. Westbrook's ankle injury limited him to play just nine minutes as he mustered only three points. He injured his ankle in the medal round semifinals on Friday as the American squad rolled over Argentina 119-86.

After the U.S. won all but one of its previous contests by blowout scores with margins ranging from 27 points (98-71 in its first game against France) to 83 (an Olympic record setting 156-73 thrashing of Nigeria in pool play), the Americans knew that they would be in for a challenge against Spain, led by Los Angeles Lakers' star Pau Gasol and his brother Marc, a member of the NBA Memphis Grizzlies. The only other team to play with the U.S. was Lithuania in pool play as the Americans were able to hang on for a 99-94 victory. Against the Spanish, the U.S. led by only one (59-58) at halftime and led by as many as 13 points late in the fourth period that all but clinched the game and the gold medal for the Americans. The U.S. coasted from there. Leading the Americans was Thunder standout Kevin Durant with a game-high 30 points and nine rebounds. Durant totaled an Olympic record 156 points during these 2012 Games. James added 19 points and Laker sensation Kobe Bryant chipped in 17. Pau Gasol sparked the Spanish with 24 points, followed by Juan Navarro with 21. Marc

Gasol contributed 17 points. Another Thunder star, Serge Ibaka, had 12 points for Spain. NO I.D. PULLS AWAY FROM LAKERS

We can begin the debate with last year's winner of the Pioneer League, the Torrance Tartars. 





## **Finance:** How to Stop Annoying Telemarketing Calls

When the Do-Not-Call Implementation Act of 2003 was passed, it was supposed to herald a new era of silence – as in, no more annoying dinner-time telemarketing calls. Based on the number of unsolicited calls our household still receives nearly a decade later, however, I'd say the law has been had only mixed success.

True, the sheer volume of calls did drop significantly after we registered our home and cell phone numbers with the Federal Trade Commission's National Do Not Call Registry. But because so many types of organizations are exempt from the legislation and so many shady companies flout the rules, everyone I know still gets pestered relentlessly.

There are steps you can take to curtail annoying calls; and just as important, ways to avoid falling for telemarketing scams: First, if you haven't already done so, register your phone numbers with the registry, either online at www.donotcall.gov or by calling 888-382-1222 from each phone you wish to enroll. Although it's illegal for telemarketers to call wireless phones, you may want to register them just in case.

Be aware that certain organizations are exempt from the Do Not Call regulations barring contact. Charities, political organizations, telephone surveyors and companies with which you've done business in the last 18 months (and their affiliates and business partners) are still allowed to contact you unless you specifically request to be removed from their lists.

Telemarketers have up to 31 days to update their lists, so if you're not currently registered it could take that long for calls to cease. After that, you can file complaints about unwanted calls at the Do Not Call website



or phone number. Remember, though: Debt collectors may continue to call you, whether or not your number is registered.

Here are a few additional tips for reducing call volume:

Use Caller ID to screen incoming calls. By law, telemarketers must use some iteration of their business name in their onscreen ID, but many unscrupulous organizations will attempt to "spoof" you by providing misleading identifying information.

If you don't recognize the name or number you can either take the call or let it go to voicemail. If the line goes dead, that usually means it was a robo-call and there was no live operator available. Either way, you'll likely continue to receive calls unless you take action.

If a message is left and you think the organization is legitimate, call them back to request being taken off their own internal

Do Not Call list, which they're required to maintain by law or face steep fines. If you suspect the call is a scam, go straight to filing a complaint.

You can also use your phone carrier's call-blocking function to prevent future calls from that number. However, this step won't do much good if someone is harvesting and selling your phone number to multiple telemarketers; plus, many carriers limit the number of callers you can block.

And finally: You can notify specific sellers in writing that you wish to continue receiving their calls. Just be aware that some marketers may attempt to obtain such consent surreptitiously via innocent-seeming solicitations or emails. This is one more reason why it's important to read every document and email carefully before signing or checking "I agree" to the fine print. •

"We are constantly arguing with the press about how our image is just not delivered in a positive light on a daily basis--and here we have a great opportunity where we are going to see not only coverage by the major papers, but I'm sure by the televisions stations where Inglewood will be seen as having been capable to work with a group such as yours [CSC] and to really accommodate this type of transportation."

Morales continued, "If you want to place some sort of value on it, you just can't buy that type of positive energy and that type of positive announcement to the entire country. It just happens to be in a year where a lot of big projects are happening in Inglewood." •
