Legal Marijuana Dos and Don'ts

A century of marijuana criminal law goes up in smoke in a few days, leaving in its place a patchwork of dos and don'ts for South Bay residents and their employers to follow.

On January 1, marijuana became legal for recreational adult use. Adults must be 21 and older to buy, carry and use marijuana. They can't smoke it in a public place though.

It has been a crime since 1913 to possess or grow marijuana in California. That changes, too when adults can grow six marijuana plants in their homes or outdoors as long as the plants are out of plain sight. The strong odor from mature marijuana plants attracts attention, and authorities want to deter minors from getting their hands on easy weed.

The Dos

Let's start here. Adults over 21 can grow their own marijuana or buy it from a statelicensed retailer. All licenses must be issued by the Bureau of Cannabis Control.

Adults can give away marijuana, but cannot sell or barter with it. The adult-use law also doesn't mean the end of medical marijuana. State-sponsored medicinal pot retailers will be open for business in early 2018.

Young adults, 18 to 21, can buy medicinal marijuana with a recommendation from a physician or a county-issued identification card.

The cannabis control bureau had issued approximately 150 temporary licenses statewide as of December 27. Unlike Colorado that was ready with retail stores

on the law's first day, California's rollout is much slower. The state released the rules for retailers and laboratories in November, including a requirement that applicants for licenses comply with local rules.

Now for the Don'ts

Make no mistake. There is a time and a place for lawful use of recreational pot. And there are places where under no circumstances will it be okay to smoke a joint.

Employers have the right to ban the use of marijuana and cannabis products by their employees. Getting stoned before or during the workday is not a protected activity.

Driving while under the influence remains illegal, the DMV reminded motorists in a pre-Christmas announcement. A stash of marijuana must be kept in a closed container in a vehicle or in the trunk.

The open-container restriction applies to passengers, too. "The DMV will assign negligent operator point counts for this violation," it warned on December 21.

The annually revised drivers' handbook for 2018 will explain the penalties for marijuanarelated violations.


Traveling across the state line with marijuana is forbidden, even to Nevada and Oregon that have legalized pot. It's not okay to carry marijuana or cannabis onto federal property, including national parks and military bases. That's because federal law continues to classify weed as a Schedule 1 drug, making it illegal to use as a medicine or to kick back and relax.

A Schedule 1 drug is considered extremely harmful and without any medical benefits. Other Schedule 1 drugs include LSD, heroin and the date-rape drug Ecstasy. Despite several studies done on marijuana's medical benefits, federal authorities haven't reclassified marijuana. Nonetheless. 23 states now allow medical marijuana. Landlords and private property owners can ban marijuana from the premises, too.

Despite the new freedoms, California's decriminalization of pot law isn't open season for state-licensed shops in the South Bay. Carson is the only city open to allowing marijuana businesses to operate locally. Voters approved taxing marijuana and cannabis products grown and sold in the city. There are no retail shops open yet.

The Bureau of Cannabis Control did not issue a single temporary license to operate a cannabis store, growing operation, testing lab or delivery service in the South Bay, as of last week. The nearest adult-use retailers of marijuana are found in West Hollywood, where four retailers had the green light to open for business on Jan. 1.

A Beguiling Romance with a Twist

Love can be quite intoxicating. So can Paul Thomas Anderson movies. Anderson's natural cinephile sensibilities have allowed him to make some of the very best films of all time. Seemingly drawing straight from the well of pure cinema, his films are dazzling masterpieces that seep deeply into the audiences' subconscious and only get better the more they are thought about over time.

Set in the high-fashion world of post-war London, *Phantom Thread* is the story of an obsessive dressmaker (Daniel Day-Lewis) and the woman he meets who tames him--until a rocky disruption ensues that forces each to see how essential they are to the other. An absolutely gorgeous work and a rich feast for the eyes, this period piece is one that deserves to be seen on the big screen.

One thing that separates *Phantom Thread* from Anderson's other films is that it's Anderson himself who's behind the camera for this movie. Here he assumes director of photography duties as well as directing. When you're able to operate the camera, pick the lenses and make your own lighting decisions, you are exacting full control to execute your vision, as he does here.

Reginald Woodcock (Day-Lewis) knows a thing or two about the necessity of control when it comes to creating his works of art. And with that comes his need for perfection, irritable if otherwise. Mercilessly meticulous in realizing his vision, it's his sister Cyril (Lesley Manville) who takes to tempering his frustrations while she helps him run the business. Woodcock may in fact be the character that most closely mirrors Anderson himself--the commentary on his own artistic sensibilities (and shortcomings) as a perfectionist auteur. He shows that creating such beautiful pieces

often comes from a joyless place.

This makes the introduction of Alma (Vicky Krieps) one that inspires Woodcock. He has had other muses before. One is seen before the arrival of Alma, but it's Alma whom we find is his match and whose presence in his life of consuming routine and ritual slowly frays at the seams. Woodcock tries to live his life of narcissistic vanity in his undisturbed artistry, but Alma disrupts this vision before the movie reveals its screwball story that forces Reginald and Alma to realize how much they need each other.

His most reduced story yet, *Phantom* Thread is carried by the beguiling performances of the two lovers. The performance that Day-Lewis exacts as Woodcock in control and restraint is as exacted as any craftsman. If we are to believe his statement that this is indeed his final screen performance, then it is a fantastic one to leave behind. Vicky Krieps as Alma is a presence that can suck the air right out of a room, her face communicating exactly what she's thinking.

The allure of a PTA film is that there is always more than meets the eye. Interestingly, this is a detail that is manifested in the film. Woodcock sews names and words into the linings of his pieces, blesses them or just a creates a sneaky secret that no one will ever know. These codes can leave any critic endlessly intrigued.

Phantom Thread turns out to be a phantom of a film itself, leaving a mysterious and lasting impression that will continue to occupy the mind long after its watch. Creeping darkness and growing tension make this love story one that will sit quite well next to its peers.

Intense Methane Rainstorms Hit Saturn's Largest Moon, Titan

Titan, the largest of Saturn's more than 60 moons, has surprisingly intense rainstorms, according to research by a team of UCLA planetary scientists and geologists. Although the storms are relatively rare—they occur less than once per Titan year, which is 29 and a half Earth years—they occur much more frequently than the scientists expected.

"I would have thought these would be once-a-millennium events, if even that," said Jonathan Mitchell, UCLA associate professor of planetary science and a senior author of the research, which was published in the journal Nature Geoscience. "So this is quite a surprise."

The storms create massive floods in terrain that are otherwise very cold deserts. Titan's surface is strikingly similar to Earth's, with flowing rivers that spill into great lakes and seas, and the moon has storm clouds that bring seasonal, monsoon-like downpours, Mitchell said. But Titan's precipitation is liquid methane, not water.

"The most intense methane storms in our climate model dump at least a foot of rain a day, which comes close to what we saw in Houston

Based on a Press Release from UCLA, from Hurricane Harvey this summer," said Mitchell, the principal investigator of UCLA's Titan climate modeling research group.

> Sean Faulk, a UCLA graduate student and the study's lead author, said the study also found that the extreme methane rainstorms may imprint that moon's icy surface in much the same way that extreme rainstorms shape Earth's rocky surface.

> On Earth, intense storms can trigger large flows of sediment that spread into lowlands and form cone-shaped features called alluvial fans. In the new study, the UCLA scientists found that regional patterns of extreme rainfall on Titan are correlated with recent detections of alluvial fans, suggesting that they were formed by intense rainstorms.

> The finding demonstrates the role of extreme precipitation in shaping Titan's surface, said Seulgi Moon, UCLA assistant professor of geomorphology and a co-senior author of the paper. Moon said the principle likely applies to Mars, which has large alluvial fans of its own, and to other planetary bodies. Greater understanding of the relationship between precipitation and the planetary surfaces could

lead to new insights about the impact of climate change on Earth and other planets.

Titan's alluvial fans were detected by a radar instrument on the Cassini spacecraft, which began orbiting Saturn in late 2004. The Cassini mission ended in September 2017, when NASA programmed it to plunge into the planet's atmosphere as a way to safely destroy the spacecraft.

Juan Lora, a UCLA postdoctoral scholar and a co-author of the paper, said Cassini has revolutionized scientists' understanding of Titan.

Although Titan's alluvial fans are a new discovery, scientists have had eyes on its surface for years. Shortly after Cassini reached Saturn.

radar and other instruments showed that vast sand dunes dominated Titan's lower latitudes, while lakes and seas dominated its higher latitudes. The UCLA scientists found that the alluvial fans are mostly located between 50 and 80 degrees latitude—close to the centers of Titan's northern and southern hemispheres, but generally slightly closer to the poles than to the equator.

Such variations in surface features suggest Titan has corresponding regional variations in precipitation, because rainfall and subsequent runoff play a key role in eroding land and filling lakes, while the absence of rainfall promotes the formation of dunes •

Trojans End 2017 with Bowl Loss

With a 24-7 loss in the Cotton Bowl last Friday night, the USC Trojans fell in their final game of the season and were defeated by the Ohio State Buckeyes for the first time since 1975. The Trojans may not have lost the game as much as Ohio State's defense won it, but quarterback Sam Darnold certainly had his share of mistakes that wound up costing the team. While the Trojans took to the field as this year's Pac-12 champions, the Buckeyes took the field looking to prove a point. After being snubbed from the College Football Playoff, their 17-point victory at AT&T Stadium in Texas proved that they at least belonged in the conversation. That same playoff snubbing is also perhaps what gave Ohio State the extra motivation it needed to send the Trojans back to Los Angeles with USC's third loss of the season.

Throwing for 365 yards wouldn't normally seem like such a bad way to end a college football season. When those 365 yards are accompanied by three turnovers and eight sacks in a 24-7 loss, though, that ending quickly begins to lose its fairytale luster. "Whenever you turn the ball over that much, it's hard to win games," Darnold said at his postgame press conference. "Just a lot of stuff where we shot ourselves in the foot."

That's exactly what the Trojans did last Friday night--shot themselves in the foot. USC had four turnovers that led to 21 Ohio State points, the first of which occurred on the third play from scrimmage as cornerback Kendall Sheffield stripped receiver Deontay Burnett, giving the Buckeyes a one-touchdown lead less than three minutes into the game. As if that weren't enough, Darnold and the Trojans would give up plenty more before the half. A second quarter pick-six by safety Damon Webb that was returned 23 yards put USC in an even deeper hole before Darnold lost a fumble just before the half that led to another two-play, 59-yard touchdown drive for Ohio State. The Buckeyes would take a 24-7 lead into the half.

It was a leaky offensive line that undoubtedly led to USC's season-ending loss and Darnold's struggles in the game. A monstrous total of eight sacks seemed to understate the amount of times that the Buckeyes' defensive front was immediately in the backfield, rushing Darnold's hand into making a decision. The Trojans were held scoreless in the second half of play. The only time the team did score on the night was after Ohio State muffed a punt, setting Ronald Jones II and the USC offense up in excellent field position for the

team's only score of the game in the second quarter of play.

All in all, Darnold's typical inconsistency was on display at the professional football stadium last week. It's obvious that the quarterback has the ability to make the most jaw-dropping passes in all of college football. Even some quarterbacks in the NFL seem incapable of making the throws that Darnold completes to his wide receivers at times. Just when the 6-foot-4 sophomore seems to get rolling, though, the inconsistency that has bothered him all season long rears its ugly head again. He misses wide open wide receivers and fails to take care of the football--both of which oftentimes lead the Trojans to having to come from behind or in some cases even lose the game.

Darnold's three turnovers in the game raise his personal total on the year to 22. That number alone is reportedly higher than 101 other FBS teams, according to *Sports Illustrated*. Playing behind an offensive line that is clearly in shambles certainly doesn't help his cause. Neither does taking that same offensive line to go up against the extremely elite pass rush of Ohio State. "Our defensive line won that game," Buckeyes head coach Urban Meyer explained. "That quarterback, we've got a lot of respect for him--but the best way to disrupt a quarterback is to get after him and we did. If you don't let him set his feet, you have a chance. You saw there at the end of the game that quarterback never set his feet."

All of the chatter now surrounding the Trojans, and more specifically Darnold, will turn to questioning whether or not he'll be back at USC for his junior season or take the journey into the NFL. Darnold will be forced to make up his mind by the deadline to declare on January 15, if he hasn't made up his mind already by the time this article is published. Cases can be made for him either staying or going, but in his own words, Darnold has stated, "I'm really just focused on just hanging out with my teammates for the next couple of days. But it's tough. I'll look at everything and make my decision after that."

On one hand, another year in college certainly won't hurt the maturation process of a quarterback who clearly still needs just a little bit more of it. On the other, an NFL coaching staff would certainly help Darnold in maximizing his potential. Oh, and the millions of dollars he'd receive by signing an NFL contract... There's always that too. •

How to Lower Your Monthly Mortgage Payment



(BPT) - Owning your own home comes with many advantages, including escaping rising rents and the personal and financial stability associated with homeownership. Fortunately, millions of Americans, with less than 20 percent down, have been able to buy a home sooner thanks to mortgage insurance (MI). If you don't put down 20 percent of the mortgage cost, you will likely be required to purchase MI, which enables low-down-payment borrowers to qualify for home financing from lenders.

While homeownership has many benefits and continues to be part of the American Dream, it is not without costs. Several surveys have found that the majority of first-time homebuyers - over 80 percent according to one study - put less than 20 percent down. For these borrowers, there is usually the added expense of MI, which may give some of these borrowers pause.

But there is good news: the monthly private mortgage insurance premiums do not last forever on most conventional loans. And when private MI (PMI) cancels, homeowners will have more cash in their pockets each month - money that is available for home improvements or other goals. It is important to understand, however, that not all MI is the same, and not all MI can be canceled.

There are numerous low-down-payment mortgage options available that include MI. The two most common are: (1) home loans backed 100 percent by the government through the Federal Housing Administration (FHA) that include both an upfront and annual mortgage insurance premium (MIP); and (2) conventional loans, which are typically backed at least in part by private sources of

capital, such as private MI. The key difference is that one form can be canceled (PMI) while the other (FHA) typically cannot be canceled.

An FHA loan can be obtained with a down payment as low as 3.5 percent. However, be aware that you will typically have to pay a mortgage insurance premium (MIP) of 1.75 percent of the total loan amount at closing or have it financed into the mortgage. In addition to your regular monthly mortgage payments on your FHA loan, you will also pay a fixed monthly MIP fee for the life of the loan. This means you could pay hundreds of dollars extra every month - thousands over the life of the loan - until you pay off the entirety of the loan.

If you obtain a conventional loan with PMI, you can put as little as 3 percent down. Like an FHA loan, PMI fees are generally factored into your monthly mortgage payment. However, PMI can often be canceled once you have established 20 percent equity in the home and/ or the principal balance of the mortgage is scheduled to reach 78 percent of the home's original value. This means that the rest of your mortgage payments will not include any extra fees, so that your payments go down in time, saving you money each month. What you save in the long run can then be put toward expenses like home renovations, which can further increase your home's value.

MI is a good thing because it bridges the divide between a low down payment and mortgage approval. But not all MI is created equal. If you want to buy a home but still save in the long run, PMI might be the right option for you. Check out lowdownpaymentfacts.org to learn more. •



- 2 Eggland's Best eggs (large)
- 1 large (or 2 small) sweet potatoes, washed and sliced into thin chips

- 1 teaspoon salt, divided

- **2.** Flip sweet potatoes and bake for another 10 minutes or until potatoes are crispy chips. Coat a nonstick skillet with cooking spray and bring to medium heat. Scramble the eggs with milk and remaining salt and pepper, and pour into skillet, stirring often until cooked through. Set
- 3. Remove sweet potatoes from oven and top with half of the cheese, followed by the eggs and beans. Top with remaining cheese. Place back in the oven until cheese is melted about 5-10 minutes.
- 4. Remove from oven and place on serving dish. Top with cabbage, cilantro, guacamole and salsa. Serve immediately.
