Police Department Expenditures To Include Emergency Vehicle, Inc. Purchase Order

Inglewood's Mayor and City Council approved the use of \$571,007 in expenditures for the city's Police Department, which included the authorization of a purchase order with Emergency Vehicles, Inc. in the amount of \$303,507 for the purchase of a new rescue vehicle.

The staff report signed by Inglewood Chief of Police Mark Fronterotta highlights that during the 2015 fiscal year the police department launched the process of replacing the older vehicles that were considered to have exceeded their life-cycle. Rather than continuing to repair these vehicles at an expensive rate, the council approved using asset forfeiture funds for new ones.

"The vehicles replaced were primarily used by the Patrol and Investigations Bureau," states the staff report. "In addition to thee small to mid-size vehicles, the Department uses a converted twenty (20) year old commercial vehicle to transport equipment required during critical incidents. Due to its age the equipment vehicle regularly requires repairs that are very costly and time consuming."

Asset forfeiture, also referred to as asset seizure, is any type of asset obtained through police confiscations resulting from police investigations and/or arrests. The assets can be in the form of cash or items of a high monetary value that were the result of, or involved with criminal activities; furthermore, some of these assets can be the result of civil offenses.

The approval of the EVI purchase order will enable the police department to purchase of the equipment vehicle. In 2013-2014 the County of Los Angeles awarded EVI a purchase order that would allow for the creation of similar equipment vehicle via a competitive biding process. Through those purchasing terms by the county, agencies throughout the county were able to complete similar purchases.

Other purchases and updates by the police department will include the acquisition of items needed for a camera system expansion; law enforcement systems and software updates at a price tag, \$40,000; and the purchase of less lethal and safety equipment in the amount of \$40,000.

"As part of the police department's on-going project to install security cameras at various locations within the City, a total of \$55,000 will be used to purchase necessary equipment and services related to the project," states the staff report. "Currently, camera installations are occurring along the Florence and Manchester corridors. Later in the year, cameras will be installed at additional City parks and other critical infrastructures."

The department will also purchase MDC and radio equipment services and repair in the amount of \$30,000. One aspect of the purchase will include the annual replacement of a variety of parts needed to perform in-house repairs of department issued MDCs, mobile radios and portable radios. Also approved were \$30,000 in annual uniform purchases.

"Pursuant to provisions within the

Memorandum of Understanding (MOU) for General Bi-Weekly Employees, Police Officers, and Civilian and Police Management, the City must provide employees with the uniforms and safety equipment required to perform their assignments upon hire," states the staff report. "A majority of the expense is covered by the General Fund; however, some of the uniforms for specialized units are not covered within the budget. These funds will be used for uniforms expenses in excess of the General Fund allocation."

For consultant services, the department will spend \$20,000, as well as \$20,000 for office equipment, furniture and miscellaneous supplies.

"The consultant will be hired to conduct the selection process and make recommendations to assist with the ranking of candidates," states the staff report. "Typically, these funds are used to purchase new items to replace items that are older and no longer suitable for use."

The department will also spend \$25,000 in non-POST training for sworn and civilian personnel that is not considered POSTreimbursable. The training includes focus on leadership, personnel management, personnel evaluations, incident management, less-lethal tactics, ethics and supervisory and managerial accountability. Lastly, there will be a \$7,500 investment in community affairs and public service announcements.

"In an effort to increase community awareness regarding various events taking place in the City, the Department will use Asset Forfeiture funds to procure promotional items" states the staff report. "Thee items will be primarily related to recruitment efforts, community activities, and crime watches."..

Cassini Closes in on Enceladus, One Last Time


A thrilling chapter in the exploration of the solar system will soon conclude, as NASA's Saturn-orbiting Cassini spacecraft makes its final close flyby of the ocean-bearing moon Enceladus. Cassini is scheduled to fly past Enceladus at a distance of 3,106 miles on Saturday, Dec. 19, at 9:49 a.m. PST.

Although the spacecraft will continue to observe Enceladus during the remainder of its mission (through September 2017), it will be from much greater distances -- at closest, more than four times farther away than the Dec. 19 encounter.

The upcoming flyby will focus on measuring how much heat is coming through the ice from the moon's interior -- an important consideration for understanding what is driving the plume of gas and icy particles that sprays continuously from an ocean below the surface.

"Understanding how much warmth Enceladus has in its heart provides insight into its remarkable geologic activity, and that makes this last close flyby a fantastic scientific opportunity," said Linda Spilker, Cassini project scientist at NASA's Jet Propulsion Laboratory, Pasadena, California.

By design, the encounter will not be Cassini's closest. The flyby was designed to allow

Cassini's Composite Infrared Spectrometer (CIRS) instrument to observe heat flow across Enceladus' south polar terrain.

"The distance of this flyby is in the sweet spot for us to map the heat coming from within Enceladus -- not too close, and not too far away. It allows us to map a good portion of the intriguing south polar region at good resolution," said Mike Flasar, CIRS team lead at NASA's Goddard Space Flight Center,

Greenbelt, Maryland.

The south polar region of Enceladus, while well lit for observing observations by Cassini's visible light cameras when the spacecraft arrived at Saturn in mid-2004, is presently in the darkness of the years-long Saturnian winter. The absence of heat from the Sun makes it easier for Cassini to observe the warmth from Enceladus itself. By the time the mission concludes, Cassini will have obtained observations over six years of winter darkness in the moon's southern hemisphere.

Cassini completed a daring dive through the moon's erupting plume on Oct. 28, passing just 30 miles (49 kilometers) above the surface. Scientists are still analyzing data collected during that encounter to better understand the nature of the plume, its particles and whether hydrogen gas is present -- the latter would be an independent line of evidence for active hydrothermal systems in the seafloor.

This moderately close flyby will be the 22nd of Cassini's long mission. The spacecraft's surprising discovery of geologic activity on Enceladus, not long after arriving at Saturn, prompted changes to the mission's flight plan in order to maximize the number and quality of encounters with the icy moon. Cassini made its closest Enceladus flyby on Oct. 9, 2008, at an altitude of 16 miles.

The unfolding story of Enceladus has been one of the great triumphs of Cassini's historic mission at Saturn. Scientists first detected signs of the moon's icy plume in early 2005, followed by a series of discoveries about the material gushing from warm fractures near its south pole. They announced strong evidence for a regional subsurface sea in 2014, revising their understanding in 2015 to confirm that the moon hosts a global ocean beneath its

Film Review

Michael Moore's *Where To Invade Next* Attempts to Reinvigorate the American Dream

Let's start with Michael Moore's divisive title: it's a complete bait and switch. There is an indication from this title and from the movie's opening that this is a movie about the US Military and their dominance worldwide. You'd never guess it, but this movie has almost

educated viewers will know about. Moore isn't focused on shaming America though: he's interested in showing how fantastic these other countries are when in action. Of course, any documentary has the tendency to be biased and with *Where To Invade Next* running at only 110 minutes, Moore must paint countries with broader strokes. However,

nothing to do with this, a breath of relief as you can imagine there are only so many times we can fathom all the negative elements of the trillion-dollar US war business.

Instead, Moore's latest film, Where To Invade Next, is actually an optimistic documentary, a bit of a paradox in the world of news related docs. The film is a series of vignettes showing Moore traveling to, or 'invading', different countries on a hunt for what they are doing well and for ideas to take back to the United States. While his choice of countries is unfortunately very Euro-centric, the results are surprisingly effective. In every country, Moore chooses a specific topic to dive into. In France, it's food in schools. In Italy, it's work vacations. With each country, Moore is trying to show how systematically horrible our current system is and what it has the potential to be. The food in our school cafeterias is what is nourishing young people but is treated as an afterthought and the results are pretty gross. In France, food is seen as part of their education, so eating lunch is given major a level of respect as a way to teach kids how they'll eat well for the rest of their lives. This is one of the many fantastic examples that Moore finds in each country.

Moore isn't focused on shaming America though: he's interested in showing how fantastic these other countries are when in action.

The root of all of these problems comes from the mismanagement of money, the greed of for-profit schools and public buildings such as prisons, and more that many moderatelyhe does a great job of making sure any skepticism is answered. For example, after highlighting one particular school or prison, he often will show a second more extreme example that confirms the point he is making. Moore is a polarizing character, but he's a master of the craft. He knows how to make his points, funny or serious, using the tools at his disposal.

It's been a fantastic year for documentary, in large part due to the number of working documentary filmmakers who have new material this year: Alex Gibney (Going Clear and Steve Jobs), Kirby Dick (The Hunting Ground), Davis Guggenheim (Malala) and Moore, among others. Each of these prolific directors has a signature style which they don't stray far from, but in every case it works to their personality and subject matter. All are in contention for the Best Documentary Oscar. While Michael Moore's latest isn't particularly topical compared to some of his other work, it invites Americans to recognize that perhaps we need to look at other countries as models for how to improve our current system. His final revelation not only is fascinating but ties the whole film together. For any American interested in the future of our country, look to this film as a guide to some positive possible directions.

Where To Invade Next opened at ArcLight Hollywood on December 23rd with a national release February 12, 2016. Rated R for language, some violent images, drug use and brief graphic nudity. •

Banana Mango Smoothie and Almond Twirl Bread

Ingredients

SMOOTHIE

- 1 cup Reduced Fat Lactaid Milk
- 1/2 cup sliced bananas, frozen
- 3/4 cup cubed mango, frozen
- 1/4 cup cooked white beans, rinsed
- 2 tablespoons chopped walnuts
- 1/8 teaspoon vanilla extract
- Dash cinnamon

ALMOND TWIRL BREAD

Bread:

- 4 1/4 cups all-purpose flour
- 1 package active dry yeast
- 1 cup Lactaid Reduced Fat Milk
- 1/3 cup granulated sugar
- 1/3 cup butter
- 1/2 teaspoon salt
- 2 eggs

Almond Filling:

- 1/3 cup granulated sugar
- 2 tablespoons butter, softened
- 1/4 teaspoon ground cardamom or cinnamon
- 1/2 cup ground almonds

Icing:

- 1 cup sifted powdered sugar
- 1 teaspoon vanilla extract
- 3 teaspoons Lactaid Reduced Fat Milk
- 2 tablespoons sliced almonds, toasted

Preparation

SMOOTHIE

Place all ingredients into a blender. Blend on high until smooth (about 1 minute).

BREAD

- 1. In a large mixing bowl combine 2 cups of the flour and the yeast. In a small saucepan heat and stir1 cup Lactaid Reduced Fat Milk, 1/3 cup granulated sugar, butter and salt just until warm (120 to 130 degrees F) and butter almost melts. Add to flour mixture; add eggs. Beat with an electric mixer on low speed for 30 seconds, scraping the side of the bowl constantly. Beat on high speed for three minutes. Using a wooden spoon, stir in as much of the remaining flour as you can. Turn the dough out onto a lightly floured surface. Knead in enough of the remaining flour to make a moderately soft dough that is smooth and elastic (three to five minutes total). Shape dough into a ball. Place dough in a lightly greased bowl, turning once to grease surface of dough. Cover; let rise in a warm place until double in size (about one hour).
- 2. Sprinkle with Almond Filling, spreading evenly. Roll up into a spiral, starting from a long side. Pinch seam to seal. Place seam side down, on prepared baking sheet. Shape into a ring; press ends together to seal. Using kitchen scissors, snip at 1-inch intervals, making each cut two-thirds of the way to center. Gently turn each section slightly to a side. Cover and let rise in warm place until nearly double in size (about 30 minutes).
- **3.** Bake in a 350-degree oven about 25 minutes or until bread sounds hollow when lightly tapped and top is golden brown. Transfer to a wire rack and let cool.

ALMOND FILLING

In a small bowl stir together 1/3 cup sugar, 2 tablespoons butter, softened, and 1/4 teaspoon ground cardamom or cinnamon with a wooden spoon until well combined. Stir in 1/2 cup ground almonds.

ICINO

In a small bowl combine the powdered sugar, vanilla, and enough of the 3 teaspoons Lactaid to make of drizzling consistency. Drizzle over bread. Top with sliced almonds. •

Morningside Outlasts Peninsula to Win San Pedro Shootout

Under first year head coach Daniel Campbell, who is a nephew of ex-Morningside High and the National Basketball Association Los Angeles Laker standout Eldon Campbell, the Monarch boys' basketball team was looking to make a comeback. Throughout the 1970's, 1980,s, 1990's and even into the first part of the 2000's decade, Morningside was one of Southern California's dynasties but during most of the past several seasons, the Monarchs have not enjoyed as much success.

Morningside, though, is looking to bring back its glory days with a 10-3 record after winning the San Pedro Pirate Shootout with a thrilling 60-57 overtime victory over Bay League foe Rolling Hills Estates Peninsula on December 30. The Monarchs' victory also avenged their 61-44 defeat to the Panthers in the 11th place game of the Westchester Tip-off Classic on December 5. The game started out with streaks as Morningside took a 9-5 lead before Peninsula, also under a first year head mentor in Ryan Quinlan, came back with 15 unanswered points and the Panthers appeared to be headed for another easy win over the Monarchs with a 20-9 advantage early in the second quarter. The Monarchs, however, came back with an 11-0 run behind two three-point baskets by Charles Wright and another threepointer from Patrick Jeune to tie the game at 20. Peninsula held a 25-24 halftime edge. The Panthers were still up by two (39-37) after three quarters but Morningside came back with a 14-12 fourth period to tie the game at 51. The Monarchs came back to outscore Peninsula 9-6 in the overtime period behind key baskets and free throws by Brandon Anyanwu and Charles Akanno, who ended up being named the tournament's Most Valuable Player. Anyanwu led the Monarchs with 20 points, followed by Jeune with 10 and Akanno with nine points and 16 rebounds.

"He's a physical basketball player," Campbell said of Akanno. "He gets in front very well. The team played real hard and we moved the ball well." The Panthers were led by returning all-Bay League forward Mickey Babek with a game-high 21 points. Evan Malone added 11

The Monarchs won their first two games of the tournament over South Torrance (78-59 on December 26) and host San Pedro (79-58 on December 28). Morningside also defeated Middle College 68-49 on Saturday. The Monarchs will host Hawthorne in non-

league action Friday at 7:30 p.m. Morningside, then, will, again, play Peninsula on the road in their Bay League opener next Tuesday at the same time. Campbell knows that the Bay will be very competitive, led by Redondo, which came off a second place finish in the prestigious Maxpreps Holiday Classic after losing to the United States' top ranked squad in Chino Hills 96-80 on December 30 at Rancho Mirage High in Palm Springs. Inglewood, which finished second in the Bay but defeated Redondo once last year, also figures to be well in the race, along with the

Monarchs, Panthers and Mira Costa.
