## Civil Service Rules Updated; Funds Allocated for Administrative Department Positions

A resolution recommended by the Human Resources Department to update the definitions to the Civil Service Rules was approved by the city council, as well as budget amendment in order to allocate enough money to create fulltime transitional positions within the Administrative Department.

Adopted by the city council on March 30, 1971 through Resolution No. 6295, the city's Civil Service Rules were established. On Oct. 22, 1974, Resolution No. 6850 amended the original resolution. In the 42 years since the last resolution, the rules have not been changed, modified or updated by any subsequent city council.

"In that time period, there have been numerous changes in labor and compensation laws, which require the City to update the Civil Service Rules so as to be in compliance with these current employment laws," States the staff report signed by Human Resources Director Jose O. Cortes. "At this time, the City has a need to hire transitional fulltime employees who will not have Civil Service status but will be eligible for fulltime benefits as other fulltime civil service employees."

The approved transitional positions are designed to allow a qualified employee to be eligible for appointment to a position within an existing or "new class that has been created for a specific purpose," or even a program and whose employment may end in the future as the result in of a change in elected officials. This also includes any employees who might be affected by a loss of non-city funded programs that may be part of grant-funded positions with the Public Works, Parks, Recreation and Library Services or

the Residential Sound Insulation Program.

"These positions are essential for the elected officials, as they require a confidential employee of their choosing that is well versed in their day to the day operation and agenda and it is someone they can trust with their City business transaction and communications," indicates the staff report. "Transitional appointments include but are not limited to grant funded positions as well as fulltime staff positions serving elected officials."

Currently employees who are designated Transitional Appointments do not fall under Civil Service status. Yet, transitional fulltime employees who are at the as of Dec. 31, 2015 were working with the city would be grandfathered into civil service status.

Under the new rules all transitional appointments will be "subject to the intent of the Civil Service Rules applying to regular fulltime, probationary and permanent status employee," but details having to do with recruitment, testing or the selection process, as well as handling grievances and disciplinary issues, promotions and terminations will be defined by the city manager. The rules also state that if a transitional status employee is terminated because of a lack of budget, the grant-funded program has ended or the

appointing official leaves office or is not reelected, "the transitional appointment of said employee will automatically terminate from the City services no later than when the appointing Councilmember successor assumes office." However, the council assistant can be reappointed by a different councilmember, or in any different transitional position within city service.

The allocation of funds by the council will create four fulltime transitional positions for each elected council member's assistant and will coincide with their time in office. Currently the positions of Assistant to City Council exist on the City's Salary Ordinance and are filled on a part-time basis.

"The Budget Amendment will better serve the needs of the elected officials and the citizens of Inglewood by being able to work forty (40) hours per week as opposed to only 28 hours that part-time employees are eligible to work," states the staff report.

Base salary for part-time Assistants to the City Council is set at \$70,843.20 per year, but two assistants will received a slightly higher salary due to bi-lingual pay. The District No. 1 assistant will receive a full-time salary and benefits of \$104,201; the District No. 2 assistant will receive a full-time salary and benefits of \$106,298; the District No. 3 assistant will receive a full-time salary and benefits of \$106,298; and the District No. 1 assistant will receive a full-time salary and benefits of \$104,201.

"The total impact for the remainder of the fiscal year to the Budget of the Administration Department, where these positions are paid from, is approximately \$84,665," concludes the staff report. •

# Looking Up

## Ceres: Celebrating 215 Years of Planetary Discovery

New Year's Day, 1801, the dawn of the 19th century, was a historic moment for astronomy, and for a space mission called Dawn more than 200 years later. That night, Giuseppe Piazzi pointed his telescope at the sky and observed a distant object that we now know as dwarf planet Ceres.

Today, NASA's Dawn mission allows us to see Ceres in exquisite detail. From the images Dawn has taken over the past year, we know Ceres is a heavily cratered body with diverse features on its surface that include a tall, cone-shaped mountain and more than 130 reflective patches of material that is likely salt. But on that fateful evening in 1801, Piazzi wasn't sure what he was seeing when he noticed a small, faint light through his telescope.

"When Piazzi discovered Ceres, exploring it was beyond imagination. More than two centuries later, NASA dispatched a machine on a cosmic journey of more than 3 billion miles to reach the distant, mysterious world he glimpsed," said Marc Rayman, mission director and chief engineer for Dawn at NASA's Jet Propulsion Laboratory, Pasadena, California.

Piazzi was the director of the Palermo Observatory in Sicily, Italy, which has collected documents and instruments from the astronomer's time, and published a booklet on the discovery of Ceres. According to the observatory, Piazzi had been working on a



catalog of star positions on January 1, 1801, when he noticed something whose "light was a little faint and colored as Jupiter." He looked for it again on subsequent nights and saw that its position changed slightly.

What was this object? Piazzi wrote to fellow astronomers Johann Elert Bode and Barnaba Oriani to tell them he had discovered a comet.

"I have presented this star as a comet, but owing to its lack of nebulosity, and to its motion

being so slow and rather uniform, I feel in the heart that it could be something better than a comet, perhaps. However, I should be very careful in passing this conjecture to the public," Piazzi wrote to Oriani.

By July 1801, Piazzi had calculating the object's orbit and made public his observations, announcing it as a planet, and naming it "Ceres"—after the Roman goddess of agriculture, was also the patron deity of

Sicily, where Piazzi then lived and worked.

The news was especially interesting to Bode because he had championed the Titius-Bode hypothesis: that the positions of planets in our solar system follow a specific pattern, which predicts each planet's distance from the Sun. The pattern demanded that there be a planet, yet undiscovered, between Mars and Jupiter—and this is exactly where Ceres orbited.

In March 1802, Heinrich Wilhelm Matthias Olbers discovered a second, similar object: Pallas. William Herschel, discoverer of Uranus, then wrote an essay proposing that both Ceres and Pallas represented an entirely new class of objects, which he named "asteroids."

The door had opened for many more asteroids to be observed. The discoveries of Juno in 1804 and Vesta in 1807 reinforced Herschel's notion that asteroids are a class of their own. Today, we know there are hundreds of thousands of asteroids in the main asteroid belt between Mars and Jupiter.

Now, as we commemorate the 215th anniversary of Ceres' discovery, Dawn is observing the dwarf planet from its lowest orbit ever: 240 miles from the surface. The many craters and other features that Piazzi could not see with his telescope are being named after agricultural deities or festivals, extending the theme that Piazzi began with the name "Ceres." •

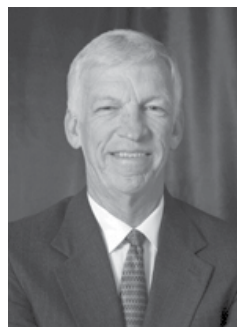

## Cardinals Fall Short of Santa Monica

Lawndale High's boys' basketball team gave highly regarded Santa Monica a scare but eventually ran out of gas in a 66-59 home loss in overtime to the Vikings on February 3. Santa Monica is the top ranked team in the CIF-Southern Section Division IA and is on the watch list for the prestigious Southern Section Open Division playoffs.

Behind the hot shooting of also football standouts Chris Murray and Bryant Perkinson, the Cardinals took a 13-6 first quarter lead. On defense, Lawndale, which is 11-13 overall and 3-5 in the Ocean League, was effective on the Vikings' standout Jonah Matthews, who will be joining former Cardinal standout center Chimeze Metu at University of Southern California in the fall, who was held to just three

first period points.

Lawndale, which lost its earlier game to host Santa Monica 76-47 on January 15, trailed 26-25 at halftime. Matthews, however, started to finally pick up as he added 10 second quarter points, including two three-point baskets. Matthews led all scorers with 25 points, including four three-pointers.

The Vikings led by three points (43-40) after three periods and were up 58-56 before Perkinson was fouled with five seconds left in regulation. Perkinson tied the game at 58 and sent it into overtime by making two free throws.

In the overtime period, though, Santa Monica stepped it up as Mikhail Brown scored all eight of its points to just one for the Cardinals. Brown finished with 18 points. Perkinson scored Lawndale's only point when he made one of two from the charity line. He led the Cardinals

with 16 points. A.J. Gipson added 13 points and Murray chipped in 12.

"I'm proud of my guys," Lawndale head coach Patrick Marks, who replaced recent head mentor Christopher Brownlee, who was dismissed by the school's administration due to an incident that occurred during a tournament it was involved in Sacramento shortly before Christmas, said. "Jonah's a great player. "When he's open, he can do anything. Our philosophy was to get him tired. He never does. Perkinson is a great athlete."

Earlier in the day, Perkinson, a wide receiver-defensive back on Lawndale's football squad that made it to the CIF-Southern Section Western Division quarterfinals before losing to eventual champion Calabasas, signed to play football at Sacramento State University. Perkinson was also Ocean League triple jump champion in track and field last spring.

The Cardinals had a very tough week having to face the top two teams in the Ocean. Lawndale traveled to Beverly Hills last Friday and was pinned with a 68-39 loss.

The Cardinals have a critical final week. After visiting El Segundo last Tuesday, Lawndale closes Ocean play at home against Hawthorne tonight at 7:30 p.m. The Cards will need to win both of those games for an automatic spot in the CIF-Southern Section Division IIA playoffs.

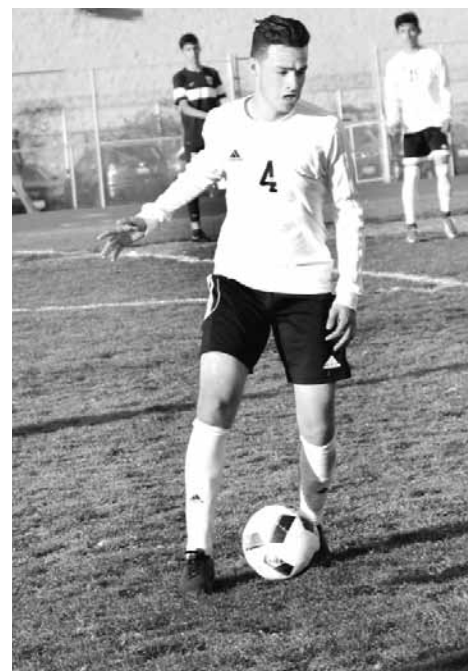

Dr. McJunkin recalls one particular patient who had struggled with chronic back pain for more than five years. According to McJunkin, trialing spinal cord stimulation was one key to the patient getting his life back.

"This patient felt like his life was wasting away before trying spinal cord stimulation," says McJunkin. "He didn't have the energy or strength to enjoy his grandkids, and even his wife was impacted as she watched her husband consistently deal with his pain. It wasn't until he tried spinal cord stimulation that he was able to get the relief he needed."

According to McJunkin many chronic pain patients spend years trying a number of different treatments. For some, back surgery will help for a while, but the pain may

Patients living with chronic pain should work with a doctor who is a pain treatment specialist to determine which option is best for them. Some patients may try multiple solutions before finding one that works for them and often exhaust all other possibilities before resorting to surgery.
