Mayor Authorized To Execute Agreement With State Board of Equalization

The council approved a report by the city's Finance Department recommending that the mayor have the authority to carry out an agreement with the State Board of Equalization to implement the Local Prepaid Mobile Telephony Act.

Also adopted was a resolution that will allow for the examination of prepaid mobile services surcharges and local charge records by the City of Inglewood and its consultants. The city manager has also been authorized to sign certification on the city's behalf with regards to prepaid mobile telephone services.

As of Jan. 16, 2016, Assembly Bill 1717 will take effect in an effort to solve the state's collection problem and require state retailers, as well as online retailers, to collect the city's utility user's tax [UUT]. The collection of UUT will be required to take place during the time that the retailer collects the sales tax on any item sold.

"Under this new law, all local jurisdictions have to contract with the State Board of Equalization [BOE] in order to receive UUT imposed on consumers of prepaid wireless phone services," indicates the department report signed by Assistant City Manager/CFO David L. Esparza. "It should be noted that AB 1717 has a sunset provision of 2020, but it is expected that the Legislature will permanently renew AB 1717 if the actual costs of collection proves to be reasonable and the level of collections are as anticipated."

The report presented to the council also states that the wireless service providers, via the monthly invoice charges sent to customers,

collect a city's UUT. However, individuals who rely on prepaid wireless services are able to bypass the UUT due to the lack of a collection method. The lack of any type of contract with prepaid wireless services means

there is no invoice through which the city can collect UUT, since the product is sold by retailers and not the service providers.

"It is estimated that 70 percent of all prepaid wireless services are sold by retailers," states the report. "Since these transactions bypass our local UUT collection channels, the City as experienced a significant loss of revenues as customers expand their use of prepaid wireless telephone services."

For the city to be able to collect the lost UUT revenues, it was mandatory that the Mayor "execute an agreement required by the State BOE" at the latest, Sept. 1, 2015. The agreement allows the state to collect the UUT, but if the City of Inglewood decided to not contract with BOE, it will not receive any of the UUT revenue.

"While the actual impact of this new source is unknown, the City's UUT revenue consultant [Muni Services] estimates it will range from 15-20 percent of the current UUT telecommunication revenues," states the

report. "This estimate is a statewide average, and individual cities will vary depending on their demographics and the number of large retail stores [located in the city] selling prepaid wireless services."

City staff estimates that the increase in revenue from UUT will be from \$464,000 to \$619,000 per year. Yet, the city will be required to reimburse the BOE in order to cover implementation costs and it is projected that the city's share will range from 5-6 percent [\$23,200-\$30,950]. Collection costs for the BOE will decline after the first year, as will the city's share in the expenditure.

Total revenues with the implementation and collection of UUT on prepaid wireless services are projected to range between \$220,000 and \$294,000 for the 2015/2016 fiscal year and will impact the general fund operating budget.

Film Review

Straight Outta Compton is an Impassioned Tour N.W.A.'s Rise to Fame

Arguably, the film of the moment is F. Gary Gray's *Straight Outta Compton*. Propelled by an excellent marketing campaign (because, y'know, Dr. Dre was involved) and reverence for the film's subject, the film has stood out in the August box office doldrums. There's always a lot of generalizing about American audiences being "simpleminded," but if a 2.5-hour music drama can be the biggest hit

It's also inevitably self-referential for not only its producers (Ice Cube, Dre, and Easy-E's widow Tomica Woods-Wright) but also for F. Gary Gray, since the production of *Friday* is included here – he directed that too. This is probably why the film feels incredibly detailed and honest; it offers insight rather than hagiography. There's a real love for hip-hop demonstrated, and Gray especially highlights the creativity and energy of the medium in

of late summer, then we're probably doing just fine. Especially when it's one as fiery, comprehensive, and entertaining as this one, millions of fans aren't wrong.

The film spans about a decade of time, from the latter days of the Reagan era right into the median of Clinton's, and chronicles the origins of hip hop group N.W.A. as well as the rise to stardom that follows. One appeal of the film is how it manages to convey the story from the perspectives of the collective's members. The ones most prevalently featured are Eric Wright, O'Shea Jackson, and Andre Young (a.k.a. Easy-E, Ice Cube, and Dr. Dre, respectively). The narrative admirably keeps up with the individuals as it moves along, which gives an intimate quality to the film.

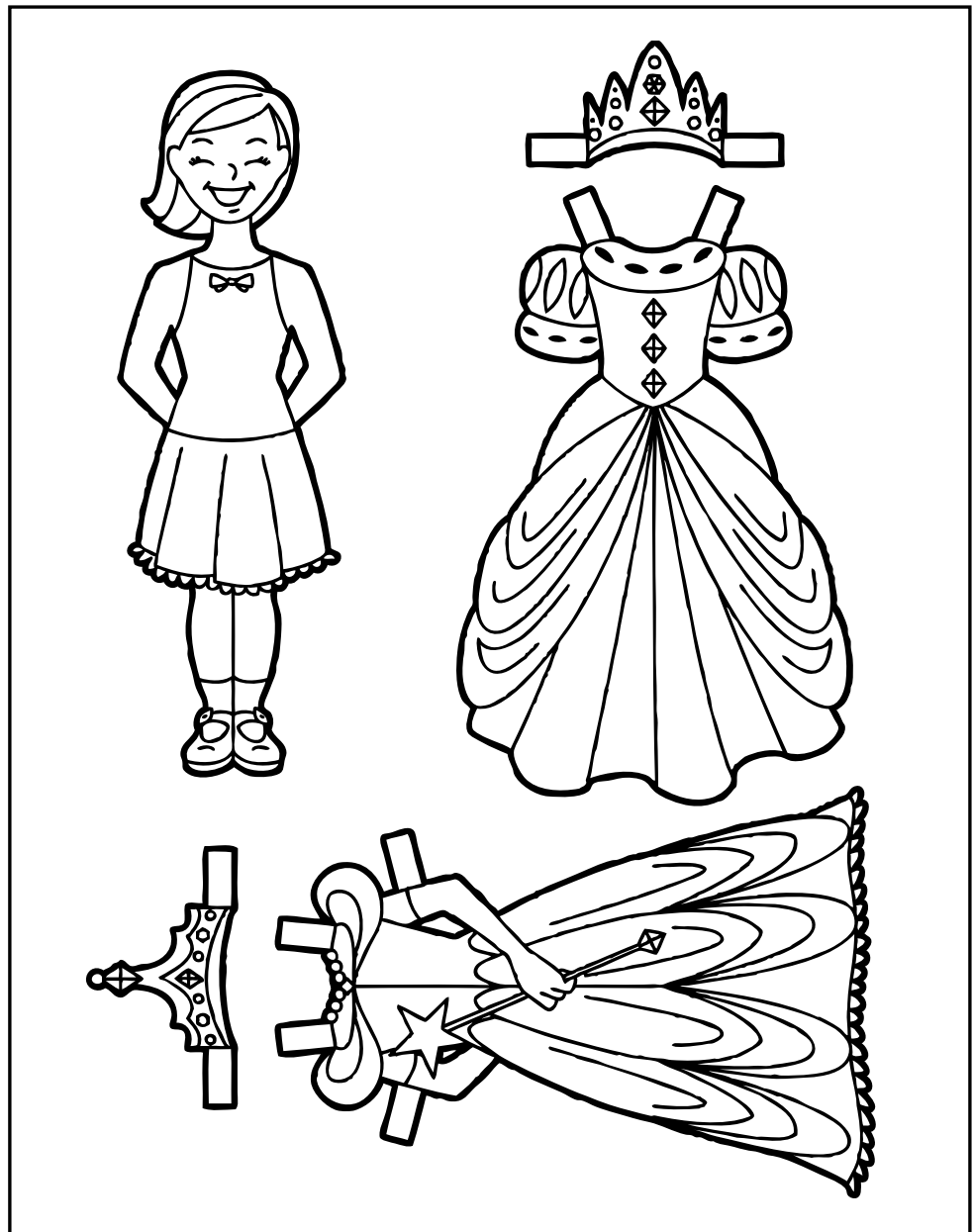
the recording sequences. Equally impressive are the N.W.A. concert scenes in the first half, which recapture a couple of the group's performances – including an infamous Detroit show that provoked a riot.

Straight Outta Compton is strongly acted across the board. Jason Mitchell and Corey Hawkins shine as E and Dre, as does O'Shea Jackson Jr. in portraying the ferocious talent of his father Ice Cube. Also excellent is the always-reliable Paul Giamatti as N.W.A. manager Jerry Heller (playing the snooty musician's manager for the second time this summer). And for the aforementioned run time, it zips along surprisingly well. It's absolutely one film that deserves the hype. *Straight Outta Compton* is now playing in theaters everywhere. •

LA County DPSS in Partnership with SBWIB Offers Transitional Subsidized Employment Program

The South Bay Workforce Investment Board (SBWIB) is reaching out to businesses, public agencies and nonprofit organizations throughout Los Angeles County to take advantage of the Transitional Subsidized Employment Program (TSE) that provides entry-level employees, whose wages in some cases can be fully subsidized for up to eight months. These employees' wages, taxes, and Workers Compensation costs are covered by the SBWIB, which serves as the employer of record.

The LA County DPSS GAIN Program recruits and screens job applicants who are then referred to participating career centers and eventually get interviewed by potential work sites which makes the final determination of hiring and training them. Entry-level employees

hired by nonprofit and public/governmental agencies receive the minimum wage and can work up to 40 hours/week for an eight-month period. The employer then has the option to retain the employee or not.

TSE employees selected by private for profit businesses are fully subsidized for the first two months while the employer provides them with job skills and other training to help them succeed. During the next four months the employer hires them for on the job training and can receive a monthly subsidy up to \$550 per employee. After the four months the business retains the worker on their staff. 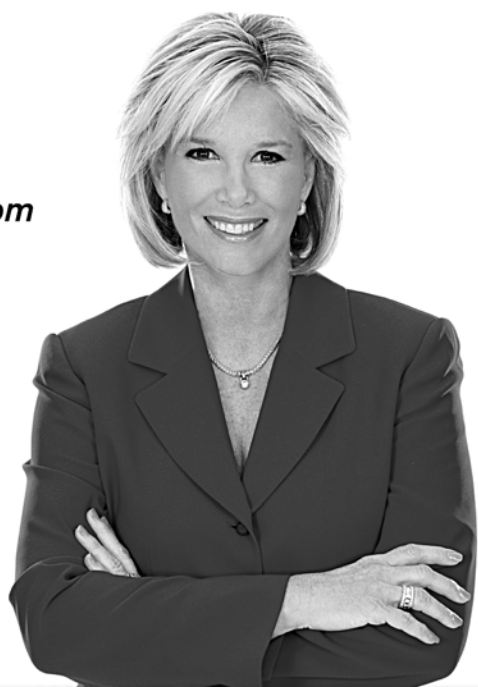

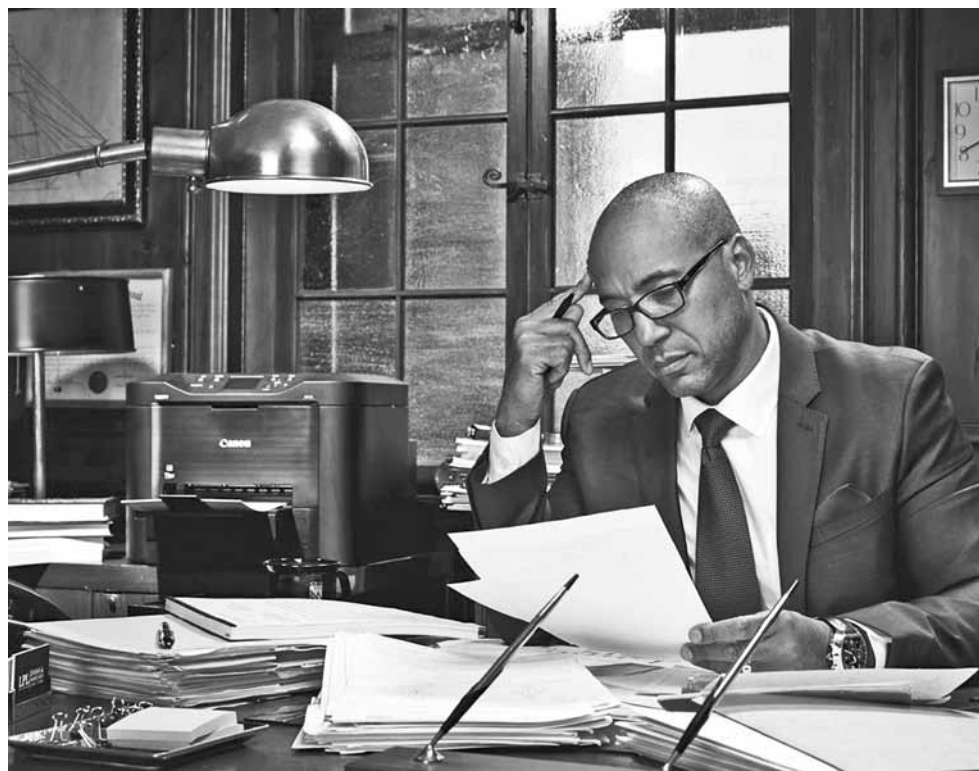

Morningside Outlasts Leuzinger in Season Opener

Morningside High's football team opened the season with a 48-36 win over Leuzinger High in a non-league game last Friday at Coleman Stadium in Inglewood. The Monarchs were led by Adarrus Wilson, who scored two touchdowns, including a game-clinching 50-yard interception return.

Morningside started fast with a 34-6 third quarter lead before seeing the Olympians rally to grab a 36-34 advantage midway in the fourth quarter when running back Lionel Smith scored on a 10-yard run. Charles Akanno came back and gave the Monarchs the lead for good on a three-yard touchdown run with about four minutes left. Wilson, then, sealed the game on his scoring interception.

Wilson, also a CIF-Southern Section sprint qualifier in track and field, added a 90-yard kickoff return. Smith scored three TD's on runs. The Monarchs visit CIF-Los Angeles City Section school University Friday at 7 p.m.

Things will not get much easier as the Olympians host defending Ocean League champion El Segundo at the same time. The Eagles lost most of their top players from last season, including premier quarterback Lars Nootbar, who is now at University of Southern California on a baseball scholarship, but El Segundo, under a very good head coach in Steve Shevlin, will continue to be very tough and a top contender for the league crown.

CARDINALS SEEK OCEAN CROWN

Last year, along with El Segundo, Lawndale High joined the Ocean League and the Cardinals had one of their best seasons in their second stint (2002-date) of the school by placing second in league behind the Eagles.

Lawndale advanced to the CIF-Southern Section Western Division playoffs against eventual champion Palos Verdes. The Cardinals pushed the Sea Kings to the limit before falling on the short end of a 35-28 score. P.V. won the crown by topping a very good Ventura team 32-24 on the road.

The Cardinals will be highlighted by fourth-year starting varsity quarterback Chris Murray. If he keeps his success, he should have an

outstanding season and hopes that he'll be heavily recruited by Major NCAA Division I colleges. Last year, Murray combined for more than 2,000 yards passing and rushing as he dominated several teams. When he passes, he will have two targets in all-around player Bryant Perkinson and Boise State University-commit wide receiver-defensive back Jaylen Walker. Both are also returning all-league seniors.

According to first year head coach Travis Clark, Perkinson will be used a running back, wide receiver and defensive back. Senior running back Zach Cooper will lead Lawndale's ground attack.

"At this part, things are working," Clark

said. "We're trying to change the culture."

Lawndale begins the season Friday at home against South Torrance, a team that the Cardinals played against in the Pioneer League up until moving to the Ocean last year. Last season, the Spartans placed fourth in the highly competitive Pioneer League before falling to Ventura in the first round of the Western Division playoffs.

South should continue to be very competitive in the Pioneer with 11 returning starters, led by a very experienced quarterback Gabe Zuniga.

"He's a good player," Clark said of Zuniga. "He's real dangerous."

It will definitely be a good match-up between Zuniga and Murray. Zuniga has

two very good receivers in returning starters Carl Richardson and Noa Harrison. South's defense is led by returning all-Pioneer League defensive back Tanner Thompson.

HAWTHORNE SEEKS TO MOVE UP

Over the past several seasons, Hawthorne High's football program has gone through a dark age but it hopes that it can finally pull through for a better season. The Cougars are getting some hope with key returning starters in senior running back-strong safety Benjamin Del Gado, senior wide receiver-free safety Jaylen Morgan, junior offensive lineman David Gonzalez and junior wide receiver-cornerback Marte Matu. Matu is also a candidate for the starting quarterback, along with junior Redondo transfer Andrew Kalenski.

"We're mostly junior dominated," Hawthorne head coach Donald Pysinger said. "We only have eight or nine seniors. We have some experience. We'll keep working. We're still learning."

Hawthorne opens its season at home against Lynwood Friday at 7 p.m.

SENTS BEGIN UNDER NEW COACH

Inglewood High's football team starts its season at home against Laguna Hills under new head coach James Sims Friday at 7 p.m. The Sentinels lost head coach Jason Miller and top assistant James Durk, who opted to move to Dominguez High in Compton. Along with them, Inglewood lost several players who transferred to other schools, including some who chose to follow Miller to Dominguez.

Inglewood has just four returning starters but some are good including junior Kevin Lucas, a returning all-Bay League junior. Others are senior linebacker-fullback Roderick Long, senior lineman Eric King and sophomore linebacker-tight end Jerome Cook.

Last year, the Sentinels finished 4-6 overall, including two forfeit losses caused by an early game ending scuffle in a non-league game against North Torrance where most players were ejected and were ineligible to play the next game against L.A. University. Inglewood ended up forfeiting that game to the Wildcats. •

Customized Knee Implants Offer Advantages To Patients

(BPT) - By 2030, the number of people turning to knee replacement surgery to end pain and regain mobility will likely increase to 3.5 million annually, according to the American Academy of Orthopaedic Surgeons. For many patients, recovery from knee replacement surgery is painful and slow, and the results are often not what people expect. Multiple clinical studies have found that on average one in five patients who have a knee replacement are dissatisfied with the result because of pain after surgery or because their new knee feels unnatural.

Seventy-two-year-old Ohio resident Tedd Boomershine went from running daily to having trouble walking and completing day to day tasks. When the pain became so severe it was debilitating, he decided to look into replacement surgery for both of his knees. His doctor told him about his options, including a customized implant from ConforMIS, Inc. called iTot(R) that is now available for total knee replacements. He liked the idea that the implant would be specifically designed to fit his anatomy based on a CT scan of his knees.

"I had no second thoughts about surgery at all. I wanted to get back to my active lifestyle and enjoy my evening walks with my dog, Stella, again," says Boomershine. "Two weeks



after my bilateral surgery with the ConforMIS customized knees, I was walking without the assistance of a cane or a walker and I was able to drive. Now after eight months, my knees are pain free and have total flexibility, my legs are straighter, my stride is better and

Seven weeks after surgery Boomershine was able to walk to his fitness center, ride the bike and do weight machines and then

Looking Up

Stunning New Images from Dwarf Planet Ceres

The crater takes its name from the Roman agriculture deity of harrowing, a method of pulverizing and smoothing soil.

In examining the way Occator's bright spots reflect light at different wavelengths, the Dawn science team has not found evidence that is consistent with ice. The spots' albedo—a measure of the amount of light reflected—is also lower than predictions for concentrations of ice at the surface.

"The science team is continuing to evaluate the data and discuss theories about these bright spots at Occator," said Chris Russell, Dawn's principal investigator at the University of California, Los Angeles. "We are now comparing the spots with the reflective properties of salt, but we are still puzzled by their source. We look forward to new, higher-resolution data from the mission's next orbital phase."

Ceres, with a diameter of 584 miles, is the largest object in the main asteroid belt between Mars and Jupiter. At its current orbital altitude of 915 miles, Dawn takes 11 days to capture and return images of Ceres' whole surface. Each 11-day cycle consists of 14 orbits. Over the next two months, the spacecraft will map the entirety of Ceres six times.

The spacecraft is using its framing camera to extensively map the surface, enabling 3-D modeling. Every image from this orbit has a resolution of 450 feet per pixel, and covers less than 1 percent of the surface of Ceres. At the same time, Dawn's visible and infrared mapping spectrometer is collecting data that will give scientists a better understanding of the minerals found on Ceres' surface.

Engineers and scientists will also refine their measurements of Ceres' gravity field, which will help mission planners in designing Dawn's next orbit as well as the journey to get there. In late October, Dawn will begin spiraling toward this final orbit, which will be at an altitude of 230 miles.

Dawn is the first mission to visit a dwarf planet, and the first to orbit two distinct solar system targets. It orbited protoplanet Vesta for 14 months in 2011 and 2012, and arrived at Ceres on March 6, 2015. •

Striking 3-D detail highlights a towering mountain, the brightest spots and other features on dwarf planet Ceres in a new video from NASA's Dawn mission. The video is available at: <http://www.jpl.nasa.gov/video/details.php?id=1392>

A prominent mountain with bright streaks on its steep slopes is especially fascinating to scientists. The peak's shape has been likened to a cone or a pyramid. It appears to be about 4 miles high, with respect to the surface around it, according to the latest estimates. This means the mountain has about the same elevation as Mount McKinley in Denali National Park, Alaska, the highest point in North America.

"This mountain is among the tallest features we've seen on Ceres to date," said Dawn science team member Paul Schenk, a geologist at the Lunar and Planetary Institute, Houston. "It's unusual that it's not associated with a crater. Why is it sitting in the middle of nowhere? We don't know yet, but we may find out with closer observations."

Also puzzling is the famous Occator (oh-KAH-tor) crater, home to Ceres' brightest spots. A new animation simulates the experience of a close flyover of this area.

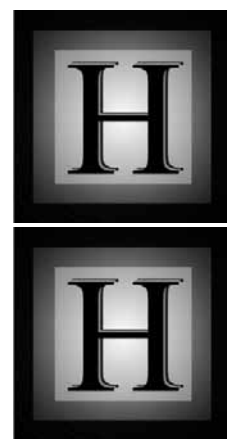

Walnut Stuffed Cherry Tomato Halves



“Who doesn’t love a stuffed cherry tomato?” Guarnaschelli says. “A mixture of cheese, peppery arugula and juicy tomatoes brings out the great richness of the nuts. Stuffed cherry tomatoes are satisfying without being filling, and make a great alternative to bread-based starters. You can assemble these appetizers ahead of time and refrigerate them until you’re ready to serve.”

Yield: 12 servings
Prep time: 15 minutes

Ingredients

- 3/4 cup fresh arugula leaves, coarsely chopped
- 1/2 cup (2 ounces) coarsely chopped Fisher Walnut Halves and Pieces, toasted
- 1/2 cup finely grated Parmesan cheese
- 2 tablespoons extra-virgin olive oil
- 1 teaspoon balsamic vinegar
- 1 teaspoon grated lemon zest
- 1/8 teaspoon salt
- 36 cherry tomatoes

Preparation

1. Toast the walnuts by placing them in a large non-stick skillet over medium heat. Stir frequently until the walnuts turn golden - about three to five minutes.
2. Combine the arugula with the walnuts, cheese, olive oil, vinegar and lemon zest; set aside.
3. Cut the tops off the tomatoes. Use a small spoon (such as an espresso spoon), the handle of a teaspoon or a melon baller to gently remove the majority of the seeds and pulp, taking care not to pierce the skin. Season the insides lightly with salt. Fill the tomatoes with the walnut and arugula mixture. Serve at room temperature.
4. “For a more Italian experience, use authentic Parmigiano Reggiano cheese in this recipe,” Guarnaschelli suggests. “It’s more expensive than domestic Parmesan, but it has a wonderfully rich and nutty flavor.”
