Protest Against Coast Guard Aims to Save Floating Classroom

Animo Leadership Charter High School students, along with students from inner cities across the Los Angeles area, will gather on Saturday, May 10 at 1001 S. Seaside Ave. #20 in San Pedro to protest the United States Coast Guard's attempts to shutdown City2Sea's free educational trips. Students from Animo Leadership Charter High School, like many others throughout Los Angeles, have enjoyed free scientific expeditions to sea for the last few years with the nonprofit organization, City2Sea. The trips were shut down in June 2013 by the Coast Guard, who has yet to prove the legality of its actions. Because of this, the students have lost a full year of learning marine science on their "Cruising Classroom." The trips were usually three hours long with a lesson plan on marine science aligned with the classroom work they needed to master in order to graduate high school. Animo students were the first students to help City2 Sea to develop this hands-on program. "We have been doing this for 10 years but mainly out of Redondo Beach," City2Sea co-founder and Executive Director John Sakacs said. "One of my priorities has always been to make these trips at no cost to the kids since we work with Title I, low-income students."

The dilemma was ignited when a former 52-foot commercial boat was donated to

City2Sea in July of 2012 to be used as a floating classroom. Members of the USCG met with Sakacs in June 2013 where they informed him that he was required to obtain a commercial license (COI) for the vessel,

Streamliner, as it carries "passengers for hire," or face severe penalties. Sakacs denies ever having charged a consideration ["fee" in USCG lingo] to go on a trip or asked anyone else to pay for the costs of a trip. "We asked right from the beginning that they please provide us any proof that shows that we charged anyone so we can solve this and they haven't because we haven't," Sakacs said. "They haven't produced any evidence of it because they can't."

Initially, the USCG sent two representatives to board the vessel and inspect to see if it

was used for commercial purpose. Sakacs was then invited to speak with USCG representatives during an informal meeting where he spoke about his organization and how it operates. "One guy mentioned that we take donations, which all nonprofits do," Sakacs said. "He went as far as saying that even if we take donations for off water expenses such as marketing or computers, that it is still considered a passenger for hire. That's the key word and I don't know how it is interpreted that way."

City2 Sea is a small 501 (c)(3) nonprofit organization based in Redondo Beach that is dedicated to introducing and educating inner-city kids to marine life. Since City2Sea began its efforts, it has introduced thousands of inner-city youth to the importance and beauty of the Pacific Ocean. Sakacs is unwavering in that City2Sea has never charged the inner-city teenagers or the Title I schools they work with, a fee to attend or participate. "We believe that all children should have access to a great education and the ocean," Sakacs said. "We were so excited to be able to offer this free, hands-on learning experience to the local children that can't afford to pay for a trip." 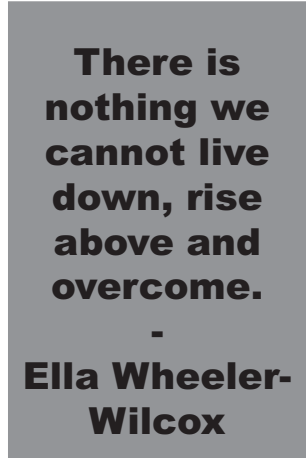

Highland Elementary Honored as California Distinguished School

Inglewood Unified's Highland Elementary has been named a California Distinguished School, a distinction given to top public elementary schools around the state that have made strides in narrowing the student achievement gap. Highland is IUSD's top performing school, with students and subgroups outperforming those at some local charter and private schools. It has received the Distinguished School honor before, most recently in 2008. And in 2010, Highland earned the prestigious National Blue Ribbon award. State Superintendent Tom Torlakson on Wednesday named Highland among 424

California Distinguished Schools for 2014. "I applaud these strong, thriving schools that are making such impressive strides in preparing their students for continued success," Torlakson said in a statement. "This award is well-deserved by these school communities for their enduring dedication to high standards, hard work, and unwavering support." To apply for the honor, schools must meet a variety of eligibility criteria, including federal and state accountability measures. Eligible schools must submit a written application that includes two signature practices, and undergo a county-led site validation review.

One Man's Opinion

An honorable man, the Prime Minister of South Korea resigned because the ferry disaster occurred on his watch and his government reacted too slowly. If that were the basis for national leadership's resignation, think of how many times he would have resigned if he had headed a government in which:

Government Benefits: The Census Bureau reported there are 167 million non-veteran Americans receiving some form of government benefits, but only 103 million full time workers. Therefore there are 64 million more people taking out than putting into the system.

Welfare: The government has spent \$3.7 trillion on welfare over the last 5 years, yet 46 million live below the poverty level.

Food Stamps: When Obama took office, there were 32 million on food stamps. Today, there are 49 million who cannot feed themselves.

Jobs: The Bureau of Labor Statistics disclosed that in 20% of the families in the country, no one . . . not one person . . . works . . . either full time or part time.

Income Taxes: The top 40% of income earners pay 106% of all income taxes. The other 60% are along for the ride. Who is paying their fair share?

Economic Growth: During the first quarter of this year, the economy stagnated, growing at 0.1% . . . that's right, not one percent, but one tenth of one percent.

Medicaid: There are 70 million on government-paid Medicaid, but as the country sinks into poverty, it is anticipated that Obamacare will add 16 million more to the

rolls, a 22% expansion.

Defense: The Federal and State governments spend over \$1 trillion per year on entitlements, excluding Social Security and Medicare: a sum nearly twice that of national defense. This spending equals \$50,000 per year for a low income family of three.

Bureaucracy: There are over 200 Federal and State welfare programs, including 27 low-income housing programs, 30 employment training programs, 34 social service programs, 13 food programs, and 24 child care programs . . . all run by bureaucrats.

Obamacare Update: As of April 28, the Obamacare back-end programs required to run the system are not functional. As a result, the Administration has no knowledge of the number of enrollees who have paid their premiums, the percentage of young people who have enrolled, and the financial subsidies to which enrollees are entitled. Some have blamed the administration for stonewalling information from the public, but the fact is that it doesn't know. Moreover, Accenture, which is charged with completing the back end programs, has no projection as to when its work will be done.

National Debt: Before Obama, the cumulative national debt stood at \$10.6 trillion, and he pledged to cut it in half before the end of his first term. Today, it stands at \$17.5 trillion, and the non-partisan Congressional Budget Office projects it will rise another \$7.6 trillion over the next decade.

If our government were headed by a man as honorable as Korea's Prime Minister, we would be headed in a different direction, but wishes and dreams don't constitute a plan for the future. •

Automobile Manufacturer Leaving State Showcases Economic Crisis

On April 28, Toyota dropped some pretty bad news for California, and in particular for the City of Torrance. The popular car company will be moving its North American headquarters from Torrance to Plano, Texas. Toyota opened its doors in Torrance back in 1982 and employs an estimated 5,200 workers. While the relocation will leave approximately 2,300 employees in California in locations such as Newport Beach and Long Beach, losing a business like Toyota is a big setback for a still struggling California economy.

While Toyota representatives stated that the move will consolidate its operations in Michigan,

Kentucky and California into a single facility in Plano, I can't help but wonder how much money Toyota will save due to the lower tax rates in Texas. It makes absolute sense for a company to have all of its operations in the same state or city if possible. However, <http://www.tax-rates.org/> indicates that Texas does not have a corporate tax rate while California has an 8.8 percent corporate tax rate. With a gap in the tax rate that big between both states, it is not difficult to believe that Toyota found some inspiration in these numbers to move.

Whatever the reason for Toyota's decisions to pick up and leave, the fact is that California's business climate is in crisis mode and seems to be getting worse. Granted, businesses come and go; it's the nature of the game. Yet, to lose a corporation as large, popular and profitable as Toyota is an

enormous black eye. Statements made by Toyota representatives indicated that the move was to better serve their customers and to position the company to enjoy sustainable and long-term growth.

If Toyota had to leave California in search of "sustainable and long-term growth," how dire is the business climate in our state? Are we really in a situation where a business that had called California home for more than 30 years can no longer envision a sustainable future if it stays? That is horrible. If a veteran business in our state is leaving to accomplish better growth, how can we expect to attract new corporate businesses?

How can we convince current corporations to stay? I wish I was an economist or business guru to provide the answer. Unfortunately, I am not and so I am left with these questions and the frustration that 4,000 Torrance-based Toyota employees will be impacted by the move: that includes 2,000 motor sales employees and an estimated 1,000 in the company's financial and manufacturing sectors, respectively.

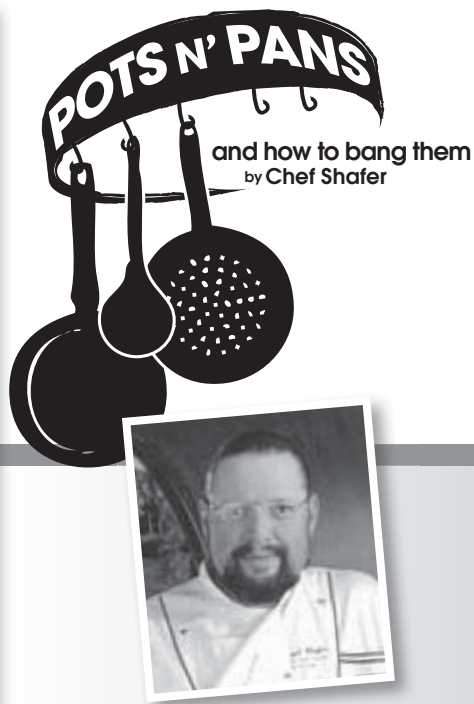
I hope that the displaced workers can find something fast that will allow them to continue providing for their families. Also, it would be great if another corporate giant would find the soon-to-be empty building in Torrance an ideal location for its operations. It's discouraging that Toyota is leaving and it is scary that more people will be soon find themselves unemployed. •

Stuffed Chicken Breast Bristol

Stuffing:
 6 chicken breasts 6-ounce each, skinless and boneless
 6 slices mozzarella cheese about 1.5 oz each
 12 fresh basil leaves
 2 large tomatoes, diced into 1/4 inch size
 1/2 a large red onion, diced fine
 3 cloves of garlic, chopped
 3 tablespoons olive oil
 1/2 cup white wine
 Salt and pepper
 2 cups vegetable oil for frying

- Take each breast of chicken and place it on a clean surface then using a meat mallet flatten the chicken breast out till it is thinner by 1/2 the original size. Do not over beat it or it will tear.
- Repeat for each breast.
- Season the breast with salt and pepper.
- In a hot sauté pan add the olive oil, onions and garlic. Brown off slightly 1 minute.
- Add the tomatoes and wine. Let it reduce till almost dry.
- Cool.
- Layer each breast with a slice of cheese, 2 basil leaves a tablespoon of the tomato mixture. Fold in half. Make sure the chicken is touching chicken and the stuffing is all in the center



Coating:
 1/2 cup flour
 2 eggs
 1.5 cups breadcrumbs

- Take the eggs and beat the slight in a bowl.
- Start by dredging the stuffed breasts in the flour then dipping in the eggs then coating thoroughly with the breadcrumbs to make sure the chicken breast is sealed at the folded edge. Set aside on a sheet pan with wax paper on it. Repeat.

Sauce:
 1 pound mushrooms, sliced
 1/2 red onion chopped fine
 3 tablespoons of olive oil
 1/4 cup white wine
 1 15 oz. canned dice tomatoes
 3 tablespoons unsalted butter
 6 to 8 basil leaves, chopped coarsely
 Salt and pepper to taste

- In a 2-quart sauce pan sauté the onions and mushrooms in the olive oil about 2 minutes.
- Add the wine and tomatoes and simmer for 10 minutes stir in the butter salt pepper to taste and basil leaves. Serve with your crispy chicken.

How to Cook the Chicken:

- Heat the 2 cups of vegetable oil in a high-sided fry pan or Dutch oven. The oil should be a medium heat. If too hot it will burn the chicken; if too cold it won't cook quickly. Check the oil by dropping a drop of sliced bread in the oil if it toasts slowly its ok. Place the chicken breasts in the oil and brown carefully. Repeat till the all the breasts are browned off on all sides. Be gentle as to not open the side of the fold. Place on the sheet pan again and finish cooking in a 350 oven for 15 to 20 min. or till the breast is firm and bubbly.
- Set cooked chicken on a platter and serve with the sauce. •

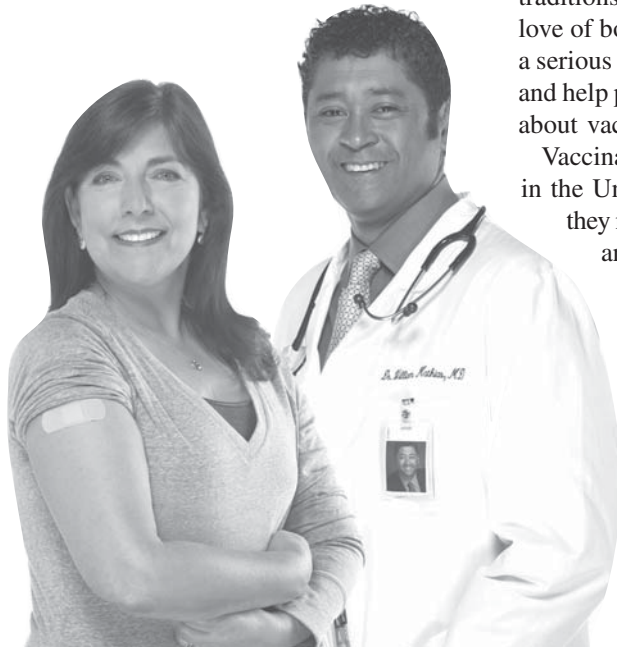

Not sure what vaccines you may need? The CDC offers a short quiz at www.cdc.gov/vaccines/adults to help you find out which vaccines are recommended for you. All adults should get an annual flu vaccine to protect against seasonal flu and Td/Tdap vaccine to protect against tetanus, diphtheria and pertussis. You may also need other vaccines based on your age, health conditions, occupation and other factors. If you are planning to travel outside of the U.S., check on any additional vaccines you may need. Astronomers Observe Corkscrew Nature of Light from a Distant Black Hole

For the first time an international team of astronomers has measured circular polarization in the bright flash of light from a dying star collapsing to a black hole, giving insight into an event that happened almost 11 billion years ago. Dr. Peter Curran from the Curtin University node of the International Centre for Radio Astronomy Research (ICRAR) was part of the team that observed gamma-ray burst 121024A—a bright flash of light emitted by a dying star collapsing to a black hole—and found a surprising detail in the light they collected. ICRAR is a joint venture between Curtin University and the University of Western Australia. The research was published May 1 in the journal *Nature*.

“Gamma-ray bursts are so powerful that we can see them clearly at extraordinary distances,” Dr. Curran said. “But this one was an unusual case, its light had a strange feature—it was circularly polarized.” If light is polarized it means the waves are moving in a uniform way as they travel—either bouncing up and down or left and right for linear polarization, or in the case of circular polarization, corkscrewing

around in a spiral motion.

Dr. Curran said 3D movies make use of circular polarization by feeding a different image to each eye through special glasses, giving the illusion of depth while watching a film. “Most light in the natural world is unpolarized, the waves are bouncing around

at random,” he said. “But the light from this gamma-ray burst looked like it was part of a 3D movie—it was about 1,000 times more polarized than we expected. This means that the assumptions we’ve been making about gamma-ray bursts need to be completely reconsidered—assumptions of how electrons

are accelerated to the incredible speeds we observe. Our results show that gamma-ray bursts are far more complex than we thought.”

Gamma-ray bursts are the brightest objects in the entire universe, only lasting a fraction of a second, but sending out as much energy in that time as the Sun will in its entire life. These bursts are emitted by dying stars collapsing to black holes that form jets of material traveling at over 99.995 percent of the speed of light. “These extreme objects are like super-powered versions of the world’s largest and most powerful particle accelerator, the Large Hadron Collider, except very far away in space,” Dr. Curran said. “We can use them to study microscopic electrons and how they behave in extreme environments, at a great distance—in this case, 18,500 million light-years away, at a time when the universe was just a fraction of its current age. This is the first time we’ve found circular polarization in the light from a gamma-ray burst, but we think we’ll find it in more bursts in the future, so we can start to pin down what’s actually happening when these bright flashes of energy are released.” •
