Hawthorne Council Splits Votes as Meeting Held Minus Mayor Brown

Mayor Chris Brown did not preside over the Tuesday meeting of the Hawthorne City Council; he was excused for personal reasons from the evening's activities. His absence meant that several votes failed, since the fourmember dais does not agree on many things for their city and split votes 2-2.

In the Consent Calendar, two items were called out of order for discussion, as their topics involved expenditures of city funds when the financials for the city indicate that spending needs to be closely monitored. An incentive package drafted for consideration would set up a program for new and/or existing businesses to have certain requirements waived, such as sales taxes or Utility Users Taxes for a short period of time to entice companies to open in Hawthorne. These incentives were written with a cap that would give authority to the City Manager to execute incentives with less than \$25,000 in total for all incentives being considered.

Mayor Pro-Tem Olivia Valentine requested that the cap be lowered to \$15,000, which is the maximum amount which the City Manager may use to make everyday operational purchases for the city. However, Council member Alex Vargas stated that he preferred the resolution not include any incentives that would give authority to the City Manager, but would all include approval by the City Council regardless of totals. After discussion, both options were considered. The first motion lowered the cap to \$15,000 for the authority of the City Manager. The vote was taken and was 2-2, with Vargas and Council member Nilo Michelin casting the dissenting votes. The second motion was made for Vargas's option of no incentives without City Council approval and the City Manager having no authority to make deals for any amount. When that vote was taken, it also failed with a 2-2 vote, this time Vargas and Michelin voted in the affirmative, with Valentine and Council member Angie Reyes-English voting with the dissenting ballots.

The second item pulled for discussion was a resolution written and seeking approval for a policy curtailing the use of cell phones and other electronic equipment during meetings, other than the equipment for the meetings and for exclusive use for city business of any equipment issued to the elected officials, restricting use for personal reasons of that equipment. The discussion included how much would the purchase of tablets or laptops for City Council use save in paper, staff time, or other ways. The City Manager explained that the purchase was in the approved budget for the current fiscal year, and cost savings and efficiency improvement would save a minimum of \$150,000 a year. Michelin stated that he didn't see a cost benefit in the purchase and he was not in favor of electronic equipment for the City Council. Reyes-English praised the purchase as bringing Hawthorne in line with the 21st century and with so many other jurisdictions that handle their city business in as many paperless ways as possible.

The vote was called and Michelin and Vargas voted "No" with Valentine and Reyes-English voting "Yes" for the purchase and use of electronic equipment for the City Council at meetings. However, the motion for the actual resolution on the table and on the agenda for the use of electronic equipment during meetings failed for lack of a second to the motion.

A resolution was approved in support of the more than 250 Nigerian kidnapped girls and condemning the actions of those involved in the kidnappings. The second reading of an ordinance was approved to set standards for apartment development in the city with amendments to the parking regulations within any apartment development, following a public hearing wherein one request by a citizen resulted in the wording of the ordinance including the elimination of any Recitals mentioned in Section 1 of the ordinance.

In the City Manager Consent Calendar approval for ACCO Engineered Systems was approved for the updating of all systems for HVAC in City Hall. This was the opened bid for \$298,111 held publicly at the last meeting. Also, the request for the Environmental Impact Report (EIR) for the Downtown Hawthorne Boulevard Specific Plan was approved, however, Michelin cast the only dissenting vote for this EIR despite the need for the report in order for the MIG Consultants plans to be considered.

The consideration for a pocket park at 129th Street and Hawthorne Boulevard was delayed by a vote of 3-1, with Reyes-English dissenting on the delay, while the others agreed that the design and installation of a park was not necessary until after the Hawthorne Boulevard construction is complete and should not be done in conjunction with the construction.

The request for an expansion of duties for the City Treasurer was postponed, as there is no job description that delineates the Treasurer duties. Valentine requested a legal confidential before the next meeting with a job description based on what surrounding cities do in this instance. Valentine called for a vote on this discussion item, with Reyes-English abstaining since she did not agree that a vote was necessary to give the staff direction on an item.

A request was made of the City Manager to report on how many code enforcement violations have been written in that last six and a half years and how much has been collected in fines. The report should also include the type of training staff receives and how they are kept informed on ordinances and resolutions that effect their enforcement for non-compliance.

The City Manager reported that a Finance Director has been hired and he will be introduced at the next Council meeting. The meeting was adjourned in memory of Beverly Robinson a citizen volunteer who was very active in city events and regular attendee of City Council meetings. The next meeting of the Hawthorne City Council will be on Tuesday, June 10 at 6 p.m. when the first draft of the budgets for fiscal years 2014-15 and 2015-16 will be presented. •

Citizens Stand Together for Peace and Social Justice

A diverse gathering of Carson and Lawndale nonprofit directors, student organizations and religious leaders addressed local issues of social justice and religious peace at the Carson Event Center on May 22 in light of April's Nigeria schoolgirl kidnapping, reaching a resolution with a cooperative peace agreement signing.

Hosting the event was Heavenly Culture, World Peace (HWPL), an international nonprofit with a branch in Los Angeles that promotes

peace initiatives through culture, arts, policy, and religion for the cessation of war. The Chairman of HWPL is Korean War veteran Mr. M.H. Lee. At 84 years old, Mr. Lee is traveling to meet ambassadors, religious officials and youth to dialogue about peacebuilding & nonviolence and to sign the "HWPL Peace Agreement," which has received over 500 signatures from dignitaries across 72 countries.

After a panel discussion addressing women's rights and religious tension, Mr. Lee delivered the keynote address speaking on the role of religion in achieving peace and the importance of understanding one's scriptures to create a culture of non-violence. At the forum's conclusion, the room of a thousand attendees signed the peace treaty together at one time, pledging to work together for peace.

Mr. Lee is currently on his 10th World Tour having visited Washington D.C., New York and Mexico to confer with political and religious leaders. While in Mexico, Mr. Lee was honored with the title of "Messenger of Peace" by the City of Veracruz. In September, Mr. Lee and HWPL will host the World Alliance of Religions for Peace Summit in South Korea, a large-scale international forum of influential leaders from the religious, political and non-profit spheres working for peace. Presidents and leaders that Mr. Lee has met in his 10th and previous tours have expressed their unanimous support and attendance at the summit. •

Warning: Job Scams Pack a Financial Punch for Employment Seekers

(BPT) - As the country emerges from the Great Recession, many people are still looking for employment. Whether it's a full-time job or a second job to earn a little extra money, hard-working folks across the nation are applying to job listings online. But beware: lurking among the real jobs are cleverly designed employment scams, and even the savviest of job hunters can fall victim.

"People looking to make an honest living are often preyed upon by sophisticated scammers luring them in with easy money offers," says Shelley Bernhardt, director of consumer protection at Western Union. "But there are warning signs that can help people steer clear of employment scams, like claims of guaranteed employment and having to pay upfront fees."

Western Union says job seekers should stay alert to three common job scams:

1. MYSTERY SHOPPING

Scenario: Scammers pose as a mystery shopping organization and hire "new employees" to evaluate a money transfer service. They send a check to be deposited, ask the person to take a certain percentage as commission, send back the remaining amount and then evaluate the service. The problem is a bank typically makes funds from the cashed check available before the check clears. The victim learns the check is fake after the money has been sent back to the scammer, meaning he or she is out that money.

Tips: While legitimate mystery shopping jobs are available, none will send you a payment prior to a job being completed. You should never send a money transfer to someone you have not met in person even for what seems to be a mystery shopping

2. PAY-PER-CLICK (PPC)

Scenario: Scammers develop websites that offer to pay consumers for clicking on ad links for their purported clients to generate Web traffic. Although there are some legitimate PPC companies, others may make unauthorized claims that Western Union is a form of payment for your services. Western Union does not operate as a payment mechanism for PPC companies. You should also be cautious when providing personal information to such companies prior to researching the company.

Tips: Always request a different form of payment besides Western Union, and never provide sensitive personal information. Remember a secure website starts with "https," an unsecured site is "http."

3. UPFRONT JOB COSTS

Scenario: Victims receive job offers, but are told they must send a money transfer for things like credit checks, applications, recruitment fees and office supplies for work-at-home positions. Victims send money and prepare to start their new job, but the scammers run with the money and are never heard from again. It's common for scammers to pose as recruiters, so always be aware when talking with people, even if they come across as very professional. Some scammers go so far as to send a check to cover the expenses and request any funds not used be sent back to them. The victim spends the money and sends back the remainder and then the check bounces.

Tips: A person should not have to send money up front in order to secure a legitimate job. You should never send a money transfer



to someone you have not met in person. Never spend money before a check officially clears, which can take weeks.

"Criminals get smarter every day so it pays to be alert when looking for employment," says Bernhardt. "These three common job scams are unfortunate; always be wary and practice caution when it comes to your personal finances and information." •

Hawthorne Falls Short in Wildcard Game

Hawthorne High's baseball team has been consistently getting into the CIF-Southern Section Division III playoffs out of the Ocean League but it keeps on failing to get through its first game. In a wildcard round playoff game at home against Palmdale, the Cougars, the third place team from the Ocean, fell short of the Falcons 7-6 on May 20. A pair of bad innings in the top of the second and fifth proved pivotal for Hawthorne. Palmdale, which tied for third place with Lancaster in the Golden League, scored four runs (three unearned) in the second and added two more in the fifth. The two-run fifth came after the Cougars, who finished their season at 16-9-1, cut the Falcons' lead to 4-3 with a pair of runs in the bottom of the fourth. Hawthorne ended the inning leaving the bases loaded. After the two runs, the Cougars had the bases loaded with one out. "We've done that on and off," Hawthorne head coach Jeff Hines said. "In these games, you got to execute."

In the top of the fifth, Palmdale scored twice behind back-to-back triples by Henry Cabajal and George Villalobos. The Falcons padded their lead to 7-3 in the top of the sixth when Joey Lastra drove in a run on a sacrifice fly. Down to the last out with Jonathan Juarez at first base on an error and Steve Leyva, who singled after one out, on at second, senior standout Andrew Banuelos slashed a three-run home run over the left field fence to cut Palmdale's lead to one.

The following batter, Mike Henderson, however, popped out to shortstop, ending the threat, as the Falcons moved on to play at top seeded Palm Desert in the first round and ended Hawthorne's season. Palm Desert went on to shut out Palmdale 8-0 to move to last Tuesday's second round game at home against Fullerton Loara, which opened with an 8-5 home win over defending Division III champion Gardena Serra in the first round on Friday

Freshman Chris Phelps sparked the Cougars by going two-for-four with one run batted in. Senior Steve Leyva was two-for-three, drove in one run and scored once. Villalobos was the biggest damage to Hawthorne pitching as he had a single, double and triple and drove in four runs. "Unfortunately, the top of the second inning began with a couple of errors and Palmdale scored four runs," Hines said. "That hurt. That three-run home run

late could have put us ahead."

ANIMO ROLLS IN FIRST ROUND

The Animo Leadership High baseball team began the CIF-Southern Section Division VII playoffs with a 10-0 win over University Prep from Victorville last Friday at Darby Park in Inglewood. The Aztec-Eagles, who improved to 13-4 overall after capturing the Harbor League and were ranked seventh in Division VII, scored three runs apiece in the bottom of the second and fourth innings, then added four in the sixth. Daniel Colmenero sparked Animo by going four-for-five with one run scored. Miguel Guerrero and Alex Munoz each went one-for-two with two RBIs and a run scored. Winning pitcher Fabian Vital went the distance, scattering seven hits, striking out seven batters and walking just one. The Aztec-Eagles played Cate School of Carpinteria in the second round last Tuesday.

ST. MARY'S FINISHES SECOND

The St. Mary's Academy girls' track and field team from Inglewood placed second in the CIF-Southern Section Division IV Championships last Saturday at Cerritos College. The Belles finished behind champion Oaks Christian from Westlake Village with 82 points. The Lions ran away with the team title at 123 and Gardena Serra was third with 61. St. Mary's had a pair of victories by senior Sierra Peterson in the 100-meter dash at 11.73 seconds and anchored the Belles' 4x100-meter relay team to a win clocking 46.66. Other members of the squad included Allanah Hughes, Aliyah Hale and Briana Shufford. Peterson also took second in the 200 in 24.14. St. Mary's 4x400 team of Alai Divinity, Hale, Morgan Pecanette and Peterson was third timing 3:48.9.

Kyre Anderson was involved in four events at the finals. Her best finish was second place in the long jump with a leap of 17 feet, three and three-fourths inches. Anderson also recorded two third places in the triple jump (37-5 ½) and 100 hurdles (14.54). Anderson was also seventh in the 300 hurdles in 46.04. Other top performers by the Belles came from Hale who was second in the 300 hurdles clocking 43.79, Divinity who finished third at the 300 hurdles at 44.97 and Hughes in the triple jump (37-5 1/4). The Wiseburn School Board honored nine staff members during the district's yearly Years of Service Recognition presentation. He has been a feature at every school in the district and maintenance and operations director Bill Denney said he is dependable, a hard worker and always willing to help out. He is retiring in the near future and Denney said he will miss him and the barbeque he cooks up.

The next teacher to receive accolades was Karen Kosenski-Arias, a first grade teacher at Anza Elementary who has worked in the district for 30 years. Anza principal Sarah Nitsos read some past performance reviews that in addition to complements on her flexibility and rapport with students, proclaimed her a "master teacher in every aspect." Said Nitsos, "Karen is an example of an excellent teacher and a professional."

Arias wasn't the only 30-year Anza teacher; fourth grade teacher Jeannette Sutton was also honored for her tenure in the district. Nitsos described her as a consummate professional and a wonderful teacher, as well as having the "the most impeccable handwriting of anyone I've ever seen in my entire life." Sutton has also been honored as Wiseburn Teacher of the Year in 2010 and her former principal current director of curriculum Chris Jones referred to her as a "highly valued member of the Anza family."

The next staff member to be honored for 30 years of service was Margaret Lawson, a classified aide at Cabrillo elementary. Cabrillo principal Margaret Lynch said she is a patient, caring teacher who appreciates students and teachers alike. "She's magical in the first grade classrooms she works in," said Lynch. "After time with [her] they are better readers, better mathematicians. They're just better people."

Lastly, Dana sixth grade math and science teacher Candy Gray was recognized for 30 years of working in the district. Silvers said she is an energetic and enthusiastic teacher and a valuable teacher leader. She has chaperoned many of Dana's sixth grade camping trips in addition to contributions to the community as a member of the site council and as a member of the leadership team. Silver said the thing that stands out about her the most is her bright and kind personality. "Part of what makes Candy so impressive as a teacher is her sense of humor and her wit that she brings to the classroom every day," said Silvers. •




Summer Melon and Beet Salad
