Police Officer Killed in Motorcycle Accident

The Hawthorne Police Department is saddened to confirm that Sgt. Leonard Luna passed away following a motorcycle accident

on Monday, July 8. The accident occurred on the 105 Freeway, near the Long Beach Boulevard off ramp, and is under investigation by the California Highway Patrol. Sgt. Luna is survived by his parents, a brother, extended family, and friends. The family has requested privacy at this time.

Sergeant Luna grew up in the South Bay, graduating from high school in the City of Torrance. He worked in the hotel industry while pursuing his wish to become a police officer. He was hired by the Hawthorne Police Department in April of 2003 as a police recruit, and graduated from the Los Angeles County Sheriff's Academy in August that same year.

Sergeant Luna worked as a police officer in the Department's Patrol Bureau until January of 2006. He tested for the position of detective, and based on his skill level and dedication to duty, earned appointment to that position. As a detective, Sergeant Luna was assigned to juvenile investigations, where he dealt with child abuse, child predators, and juvenile related crimes on a daily basis.

In January of 2010, Leonard tested and successfully promoted to the rank of sergeant. He was immediately assigned to the Patrol Bureau as a field sergeant. In January of 2013, Sergeant Luna was appointed as the Department's Traffic Bureau commander. There, he assumed the responsibilities of directing the daily traffic enforcement activities of the Department, and took an active role in the California Office of Traffic Safety's Avoid program, a DUI enforcement detail

involving law enforcement agencies from across the region. Anyone close to Leonard knew about his enthusiasm for motorcycles. The appointment to the Traffic Bureau was a highlight for him, as it offered him the opportunity to attend a police motorcycle training course, where he finished at the top of his class.

In addition to his primary assignments, Sergeant Luna also served as a member of the Department's SWAT team for two and a half years, beginning in October of 2007.

At this difficult time, the Hawthorne Police Department is doing everything in its power to comfort and support Sergeant Luna's family and friends. We are supported in this endeavor by our partnering Los Angeles County police and fire agencies, all who have extended their resources to our Department at this difficult time. We are grateful and appreciative for their assistance and support, and ask that the community keep Leonard's family and friends in their thoughts. Funeral services are pending. •

A Letter to the Community

To All the Members of our Community

A video-taped event captured this past weekend, depicting an arrest and subsequent shooting of the arrestee's dog by a Police Officer, has drawn significant notoriety. This Department truly feels in the loss of the Rottweiler dog "Max" and for those impacted by such. We, as a Department, as animal owners ourselves, and the Officer directly involved himself, all relate and empathize in this. This connection is equally rooted in our own canine programs our Department maintains in bolstering public service and outreach. Our own diverse uses range from not only patrol and detection dogs, but one of the only Law Enforcement-hosted "Service" dogs in the country.

In turn, social media responses have not only contained writer opinion but unfortunately some have been direct threats of harm to our employees. The reality is that our current investigation, and the inherent rights afforded to respective parties, prudently govern what we can and cannot publish or expound upon. Information and evidence is continuously being garnered in order to allow us to properly determine

legitimate findings and conduct appropriate actions. Unfortunately, in the midst of this social media response, fallacies are being perpetuated and outright criminal threats are being made. In the public forum of various websites, Department employees have been mis-identified as the officer who shot. This has led to criminal threats of harm directed not only at City employees, but also at similarly-named public citizens who just happen to live and work in our surrounding region. This is intrinsically wrong in every way and unfairly detracts from the others who have professionally communicated with us.

I wish to reassure all that this matter is being addressed in the most appropriate manner demanded and afforded. I ask for all to look no farther than into our own Community for the true reality of our partnerships and efforts that we apply daily in safeguarding our citizens. The Hawthorne Police Department will be accountable to its constituents and to our actions please allow us to fulfill such. We truly sympathize with the feelings and impact suffered by all who have witnessed this incident.

Don Brann Appointed to Lead Inglewood Unified School District

Don Brann, who once led the Wiseburn School District in Hawthorne, was appointed to lead Inglewood Unified School District (IUSD) on June 28 and was expected to begin his duties on Monday, July 1. Brann is the third person to serve as Interim Superintendent since the State takeover last year.

California Professional Employees Representative Christopher Graeber, thought having a new Interim Superintendent

demonstrated the need the District has for direction—but he is hopeful that things can begin to improve. "We think that the State finally got someone who has the proper background and resume to do this," Graeber said. "That is what the State should have done right away—they should have hired a seasoned expert. This is a big school district and this person has lots of experience. He has been all over the county working with districts and the budget is our big problem." •

SBWIB Connects Job Seekers

Comprised of representatives from El Segundo, Manhattan Beach, Carson, Gardena, Inglewood, Lawndale, Redondo Beach, Hermosa Beach and Hawthorne, the South Bay Workforce Investment Board (SBWIB) has been providing employment and training services in the South Bay for years. Through its One-Stop Business and Career Centers, the SBWIB has been able to provide an abundant amount of employment services to the residents of the South Bay, including job skill assessment, career coaching and individualized skill development, among others.

"The way it works is that we are either inundated with people being laid off and we try to meet the needs of these individuals or we have new companies that come in and need to hire new people," SBWIB Executive Director Jan Vogel said. "We do other things too such as afterschool programs like the local teen centers. We try to create a good foundation for those youths so they can be productive in the workforce. We also do mentoring programs and anything to do with jobs and the economy."

Recently, the SBWIB has begun having a stronger presence in of El Segundo where representatives have made themselves available to the public in the West Conference Room at City Hall. The next scheduled outreach dates in El Segundo are scheduled for July 25, August 22, September 26 and October 24 all from 10 a.m. to 2 p.m. In addition, the representatives from the SBWIB will be at the Lawndale Library from 2-5 p.m. every Wednesday.

"We customize the approach and have enough choices and enough different training options that the individuals in those cities can benefit from it," Vogel said. "If you are a dislocated aerospace worker from El Segundo, then you need different kind of services than an individual on public assistance or one that has never worked before. It is a different need, so we try to find out how we can best assist them. The people that are residents in Redondo Beach are looking for something different than Inglewood residents. So we have a One-Stop Center in Redondo Beach that fits more to the Redondo Beach and beach cities needs than those Inglewood where the needs are a bit different."

With a strong emphasis on the local development of resources for potential employees and employers, the SBWIB has found a wide range of methods to reach the residents in the communities it serves. Through the Hawthorne Teen Center, the SBWIB has been able to provide an afterschool setting where kids can further develop academic and social skills. By the end of July, it is expected that Inglewood will open its own teen center thanks to the collaborative efforts of the City and SBWIB.

"The kids in Hawthorne have been grateful for the services there and there have been some Gates Millennium Scholarship awardees [three], so hopefully the success will be replicated in Inglewood," Vogel said. "It is for academic enrichment and also recreational, but we want them to do their homework and what they have to do before they come in and be recreational."

Every year, the Department of Labor negotiates with the State of California to

establish the performance standards. The State in turn will tell the 49 different Workforce Investment Boards what they are expected to do. The SBWIB has the highest performance from every board in the state. A year ago, it received the national award as one of the best in the country.

"The good news is that we are the best in the state. The bad news is that they expect us to keep going until it is impossible," Vogel chuckled. "We are proud of the fact that they expect more from us because we are indeed the highest performing workforce board in the state. We intend to keep achieving as best we can. The formula dollars keep going down every year with the federal budget the way it is, but we try to make do the best we can."

In order to fulfill the training and preparation aspect its goal, the SBWIB has a list of schools and courses on the directory that are available for free to the public and as long as there are funds. "We have more schools on our local directory than any other directory in the state," Vogel said "We screen these schools for competency, we make sure they are fiscally solvent and we demand that there be a 70 percent hiring rate when training is over. We have lots of occupations in this directory and hundreds and hundreds of different courses."

From medical technicians to computer operators to machinists, the SBWIB will train and upgrade basic skills needs in potential employees. "We work with a whole range of people—from people who have never worked to people who have been laid off to people who have not worked for a while," Business Services & Economic Development Manager John Parsons said. "We try to help everyone looking for their next job."

In addition to all the hard work, the SBWIB likes to recognize the efforts of everyone making it possible for every One-Stop-Center to succeed during its October 31 annual awards ceremony that will take place at the Ayres Hotel in Hawthorne. "This is where we provide recognition to those businesses that have helped us all year as well," Vogel said. "We also recognize the service providers that have done an excellent job of providing services to our participants. We also select a handful of participants that we have helped over the last couple of years."

Maintaining strong relationships makes all the difference in accomplishing what the SBWIB sets out to do on a daily basis. "You have to build a certain trust with people in order for them to come to you and that takes a lot of time. In certain communities, they know me well and in other communities they know John Parsons well," Vogel said. "If they are dealing with somebody that they know and trust, then the individuals running certain organizations will work with us. So we try to get involved in many functions."

Vogel added, "When people are depending on you for their livelihood, then we try to make ourselves as available as we can. The people that we hire for the most part think the same way and that is what I look for in somebody. They need to care and have good character. It is hard to test from something like that, but it is important. We need people with the right frame of mind and who want to do the right thing." •

Officer-Involved Shooting Results in Dead Dog, Sparks Public Outcry for Justice

Reactions to the June 30 officer-involved shooting that left a Rottweiler dead in Hawthorne have ranged from cries for justice to anger to the officers being labeled animal killers and even threats of harm to police officers. The shooting occurred in the area at 137th Street and Jefferson Avenue when members of the Hawthorne Police Department responded to a call regarding an armed robbery where a gun was used. As one group of officers entered a property to secure the situation, other officers were responsible for establishing a perimeter.

"During this evolving critical incident and the extraction of suspects from the home, officers containing the location were interfered with by an individual," Detective Bureau Commander and Public Information Officer Lieutenant Scott Swain stated through a press release. "This interference included loud, distracting music [from the individual's vehicle], and his intentional walking within close proximity to armed officers while holding an 80-pound Rottweiler on a leash."

The individual, Leon Rosby, was recorded by other bystanders doing what the statements by the police department indicated. However, at one point he took his dog to his car and put the Rottweiler "Max" in the backseat. Rosby proceeded to walk toward two officers, turned around and put his hand behind his back to peacefully be handcuffed. At that moment Max became agitated and exited the car through a more than halfway closed window, creating a back-and-forth battle between the police, the dog and Rosby. The owner tried to order the dog to sit and the officers attempted to control the situation, but the dog lunged at one officer who avoided the bite and fired his weapon.

"I wish to reassure all that this matter is being addressed in the most appropriate manner demanded and afforded," Hawthorne Police Chief Robert Fager said, through a written statement to the community. "I ask for all to look no farther than into our own community for the true reality of our partnership and efforts that we apply daily

in safeguarding our citizens."

The backlash and public outcry as a result of the incident was instantaneous, as critics took to social media such as Twitter and Facebook to vent their frustration. "Animal killers" and "Justice for Max" were just two of the common catchphrases used by Max sympathizers. However, some residents understood the complexity of the situation and withheld judgment.

"I am kind of torn between both sides," Samantha Perez, Hawthorne resident said. "It is really sad hearing about the dog getting shot, but I feel like it was honestly just a source of protection."

On Tuesday, July 2, the Society for the Prevention of Cruelty to Animals Los Angeles (spcaLA) released a statement asking for an investigation into the "procedures and training protocols" that are required by officers to safely interact when subduing companion animals. "Understandably, the safety of police officers is important. However, with the proper training, these kinds of situations can be diffused or avoided," said Madeline Bernstein, President of spcaLA, in the press release. "This dog did not have to die in such a violent manner. Deadly force should be used only as a last resort. The citizens and animals of our community deserve better."

For Perez the situation was a lose/lose from the beginning, but she is saddened that the dog was killed. "If the cop had not shot the dog, then the story would have been that the dog attacked the officer," Perez said. "There was no way for anyone to win. It was unfortunate, but what are you going to do once you are in that position?"

Chief Fager expressed his condolences at the death of Max and reminded the community that the department has a history of using canines to reach out to the residents in an attempt to build stronger relationships. "The Hawthorne Police Department will be accountable to its constituents and to our actions," Fager said. "Please allow us to fulfill such. We truly sympathize with the feelings and impact suffered by all who have witnessed this incident."•

Holly Park, Tri Park Advance in Junior Baseball

After one out, Yanez singled, stole second and third bases and then scored on a single from Payan.

Don't Get 'Spoofed' by Rogue Callers

When caller ID first arrived on the scene it seemed like a godsend to many people: Now you could easily identify who was on the line and ignore unwanted calls, whether from telemarketers, an ex-boyfriend or an unfriendly collection agency.

But as often happens, unscrupulous individuals soon began manipulating the technology to defraud people by pretending to be someone else. Their scheme is called "caller ID spoofing" and disturbingly, it's perfectly legal in many cases.

Here's how caller ID spoofing works and what precautions you should take to avoid being victimized:

Under the pretext of warning about an urgent situation (breached account, late payment, pending insurance claim, missed jury duty summons, etc.), the spoofer will try to coax you into revealing personal or account information, supposedly to verify their records.

Often these are robocalls, where a recorded voice asks you to stay on the line to speak to a representative or call another number for more information. Do not. If you suspect the call might possibly be genuine, contact the company yourself at the toll-free number found on your card, account statement or the company's website.

For a very low cost, businesses and individuals can use widely available caller ID spoofing software to generate calls that alter the telephone number and/or name which appear on the recipient's caller ID screen.

Police, private investigators and collection agencies have used legal spoofing services for many years. Others who might have a legitimate reason to hide their identity when making a call include domestic violence victims and doctors returning patient calls who don't wish to release their private telephone numbers.

Beyond that, the lines of legality begin to blur. The Truth in Caller ID Act of 2009 prohibits anyone from transmitting misleading or inaccurate caller ID information with the intent to defraud, cause harm or wrongfully obtain anything of value. Violators can be penalized up to \$10,000 for each infraction. Unfortunately, such penalties haven't dissuaded many scammers.

One common scam involves spoofers pretending to represent a bank, government agency, insurer, credit card company or other organization with which you do business. They count on you being reassured after recognizing the company's name on your

Someone possessing such information could use it to gain access to your existing accounts to withdraw or transfer money, raise credit limits or snoop around your recent activity, among other intrusions.

ID thieves also can use your personal information to open new credit accounts (e.g., credit cards, mortgage or car loan), create a new identity or even obtain a job fraudulently. Often, you won't even realize something's wrong until a collection agency -- or the IRS -- starts hounding you for unpaid bills or taxes.

Another common caller ID spoof involves hacking into someone's voice mail account. Many cellphone users never bother to set up passwords on their voice mailboxes. And, since many voicemail systems grant access to callers phoning from their own number, a hacker could easily spoof your number and gain access to your messages.

Bottom line: You wouldn't give your personal information to a stranger on the street. Take the same level of precaution with strangers on the phone -- or online. •

A great lady passed away last week. She was the heart and soul of farmer's markets at Wilson Park and other venues. She set the standards that many, if not all farmers' markets should operate by.

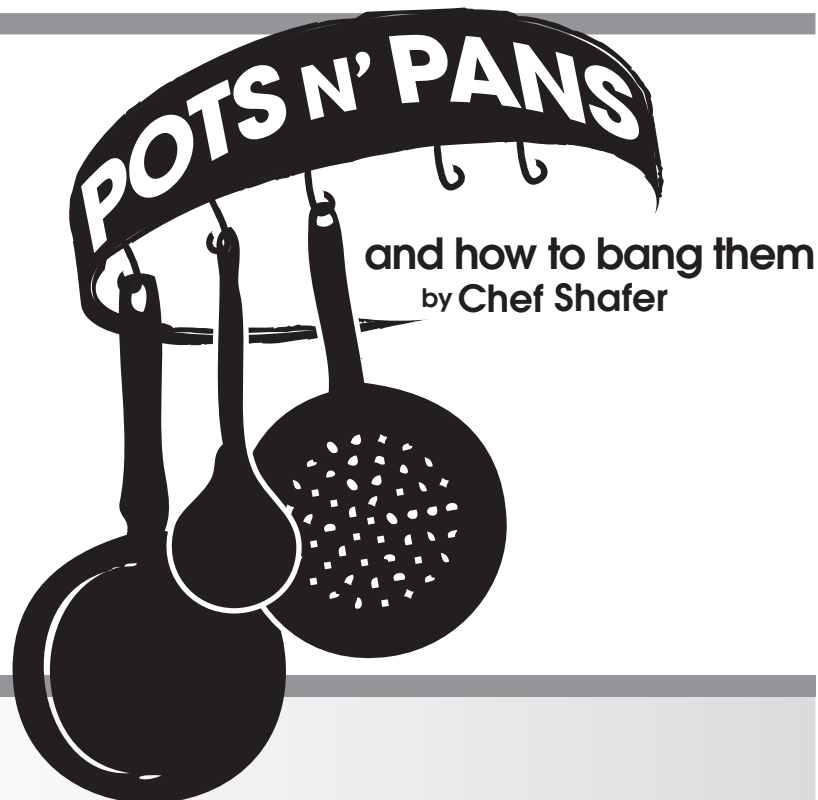
Her name was Mary Lou Wiess. She taught me so much about the market and the season's bounty, and was a fixture in the community.

Mixed Mushroom, Spring Onion and Chardonnay Cream Sauce

- 1/2 cup sliced spring onions or an onion of your choosing
- 2 pounds of mixed mushrooms, sliced
(I use Portobellos, Crimini, Shiitake, and regular white mushrooms)
- 1/4 cup olive oil
- 1/2 cup chardonnay wine
- 1 cup heavy cream
- 2 tablespoons unsalted butter
- Salt and pepper to taste
- 4 fresh basil leaves, coarsely cut up

In a hot large sauté pan, pour olive oil then add the onions. Sauté for about one minute or until onions are translucent.

Add the mushrooms and sauté for another minute or so.

When the mushrooms are soft, add the chardonnay and let it reduce down by half.

Pour in the cream and let the mixture cook for one minute. Continue to stir as it will prevent it from burning or sticking.

Season with salt and pepper, then slowly add the butter while stirring to incorporate butter into the mix. Just before you serve the mix, sprinkle some basil and use the extras to garnish the dish.

The California Assembly's Judiciary Committee passed AB5, the Homeless Bill of Rights, in a 7-2 vote. Unlike current laws and ordinances that tend to criminalize homelessness, AB5 is a significant attempt at helping individuals without shelter rather imposing a punishment. AB5 was authored by Assemblyman Tom Ammiano from San Francisco and it overcame strong opposition through a well-organized grassroots movement of homeless and poor people. AB5 serves a reminder to us that everyone deserves the same protection under law regardless of socio-economic status.

The National Center on Family Homelessness reports that California ranks second worst in the nation in the number of homeless children. It is estimated that 160,000 men, women and children experience homelessness. With so many people living under the homeless label, it is unreasonable to criminalize everyone. Furthermore, how can our legislators justify the prosecution of individuals so down on their luck, circumstances or whatever you want to call it that we simply label them criminals? Granted, there are homeless people who chose to live on the street--and that presents a problem to the rest of the general population. However, that does not mean you become a sub-par human, let alone citizen of this state entitled to equal protection by the law.

Currently criminalization of homelessness comes in the form of laws that make it illegal to sleep, sit or store personal belongings in public spaces, with enforcement against homeless people for violating laws like loitering (which is very selective), jaywalking or open

container ordinances. Furthermore, the removal of homeless people under such circumstances often results in the destruction of their personal property such as medications and personal documents. There are also laws against begging and panhandling, which also restrict groups from sharing food with homeless people in public areas. These laws are enacted to push the homeless population away from one's city, but it does not eliminate the problem.

Some of the measures proposed in the Homeless Bill of Rights include the establishment of hygiene centers such as bathrooms and showers, allowing individuals to rest or sleep in certain public spaces; access to counsel during civil prosecutions; and protecting people who offer food in public places. All of these amenities will cost taxpayers money. Yet, it is costing us money now to prosecute people and families for not having a place to live. Not only is it costing us money, but criminal prosecution is not resolving the homeless issue in any way, shape or form--and neither is prosecution mitigating the nuisances that are associated with the homeless population.

AB5 is not the ultimate solution to a never-ending problem. However, it does decriminalize an issue that should have been humanized many years ago. At the end of the day, these are not 160,000 units or numbers or stats represented in a report. These are 160,000 men, women and children finding it more difficult to get back on their feet because of the tendency for localities to prosecute. Giving such people the amenities necessary to improve their personal existence even in the direst of circumstances will have a more positive effect on their attempt to escape out of homelessness. •

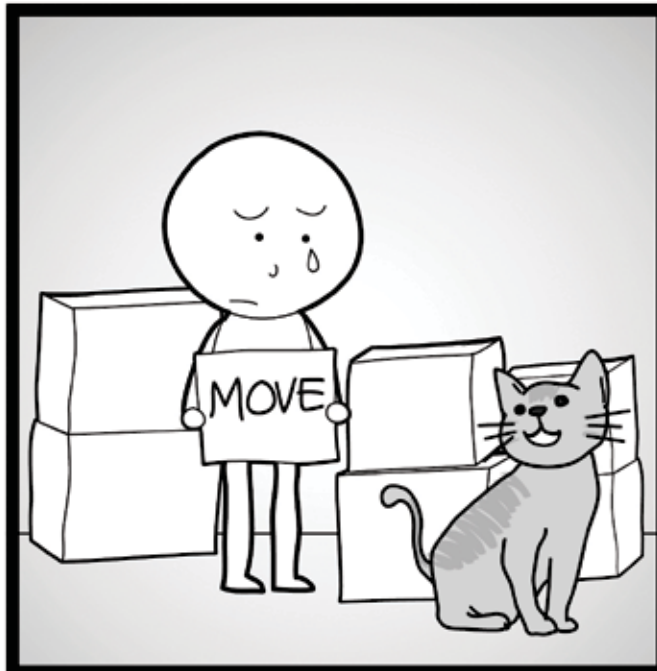
