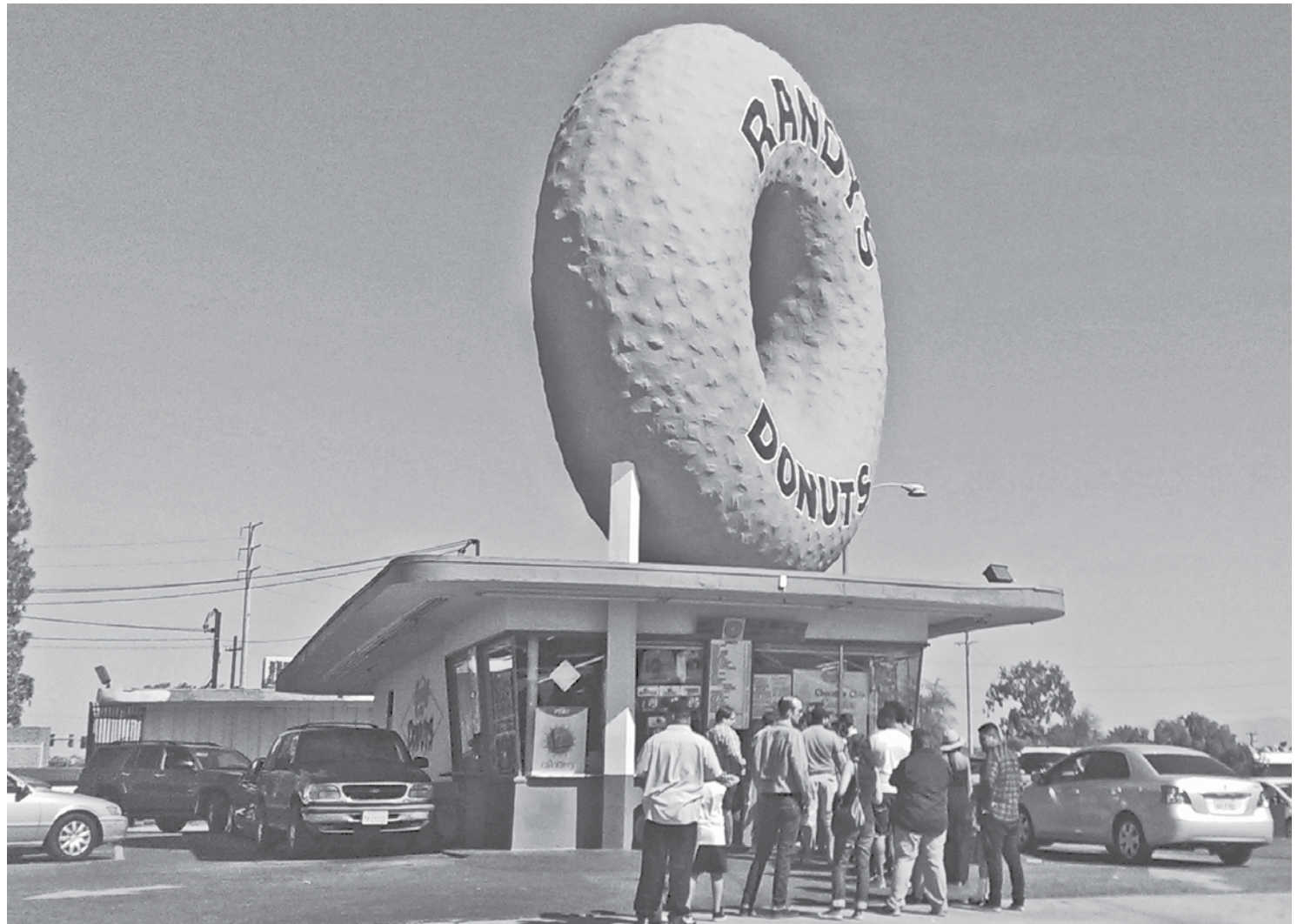

Assemblywoman Burke Hosts Contractor Outreach Fair for LAX Redevelopment

Assemblywoman Autumn Burke hosted a contractor outreach fair at Inglewood City Hall with Hensel Phelps representatives on March 18 in effort to connect with local businesses capable and willing to engage in the United Airlines Terminal 7 Redevelopment Program at LAX.

"We had a fantastic turnout, which was in line with the number of RSVPs we received beforehand," Assemblywoman Burke said. "That volume speaks to the importance of projects like this to our local economy, and to efforts to reach out to local businesses: we have more than enough talent and experience to get the job done, and they are eager to work."

Hensel Phelps, which has been active in California since 1967 and opened its Southern California District Office in 1989, is working to gather the contractors necessary to meet the December 2017 completion deadline. The project is slated to cost \$370 million.

"The United Airlines project is split into several design packages to expedite contracting, which in turn helps compress the overall project duration," Evan Avery of Hensel Phelps said. "Since we build the structural and underground infrastructure work before the interior finish work, those scopes have to be designed and contracted first."

The redevelopment project aims at creating new ticketing lobbies, renovating concourse, gates and hold rooms; it will also include the renovation of the baggage claim system, new security checkpoint, site work such as air side operations area and apron replacement, and the replacement of passenger boarding bridges.

"The timeline for contracting each scope is driven by two things," Avery said. "One, the

status of the design for that scope and; two, the requirements of the project construction schedule."

The buyout schedule for different aspects of the redevelopment project have varying deadlines, but all must be met by this year between April and December. Among the skills being sought out by Hensel Phelps representatives are: demolition and abatement, masonry, patching fireproofing, roofing, doors and hardware, glass and glazing, carpet, ceramic tile flooring and acoustical wall panels.

"But I'm looking forward to working with contractors and businesses at LAX and throughout the region to boost economic opportunities for all in the years to come."

Organizing and planning such an event was a new endeavor for Assemblywoman Burke but it's something she looks forward to continue doing throughout her time as an elected official.

"This is the first time a contractor has reached out to my office since I was sworn-in in December," Assemblywoman Burke said. "But I'm looking forward to working with contractors and businesses at LAX and throughout the region to boost economic opportunities for all in the years to come."

Since Hensel Phelps is responsible for completing a top-quality redevelopment project at the most cost-effective approach, it is entirely their decision what business to contract out with in order to achieve that goal. However, there are conditions that must be met in terms of the labor force involved

with the project.

The Project Labor Agreement at LAX, which applies to Hensel Phelps and all of its subcontractors, requires that a certain percentage of the total employees over the duration of the project be local residents," Avery said. "Hensel Phelps and its subcontractors work closely with the local unions to meet this requirement."

Avery also shared that there are certain requirements for this redevelopment project such as contracting with certain categories of firms related to diverse businesses, which includes women owned, minority owned, veteran owned, small businesses, and a variety of other disadvantaged business enterprises.

"In pursuit of these diverse business goals Hensel Phelps is focusing on following up with the contacts we made at this March 18 event, as well as continuing with our other ongoing outreach efforts to nearby chambers of commerce and various diverse business associations and organizations," Avery said.

Hensel Phelps is on a short timeframe in order to complete the project at LAX and as a result there aren't anymore outreach fairs being planned by Assemblywoman Burke's office. However, the assemblywoman plans to continue engaging with economic growth opportunities.

"I intend to remain robustly engaged in economic development efforts now and in the future," Assemblywoman Burke said. "I'm committed to ensuring that small business owners, especially those in the 62nd District, are included in as many large scale projects like this as possible. By engaging local businesses in government or public-private partnerships of this scope, everyone in our community benefits." •

NOTICE THAT HAWTHORNE CITY COUNCIL WILL CONSIDER ADOPTING ORDINANCE NO. 2086
NOTICE IS HEREBY GIVEN that on April 14, 2015, at 6:00 P.M., the Hawthorne City Council will consider adopting the following ordinance, which will be summarized upon adoption, pursuant to Government Code § 36933(c)(1) as follows:
Ordinance No. 2086, repeals and re-enacts Section 8.20 (Nuisances) of Title VIII (Health and Safety) of the Hawthorne Municipal Code, relating to the establishment of comprehensive property maintenance standards, including the designation of public nuisances, establishing procedures for the abatement of public nuisances, including the abatement of abandoned, wrecked, dismantled and inoperative vehicles and repealing Chapter 8.40 (Property Maintenance).
Abatement of Public Nuisances
Ordinance 2086 provides a comprehensive list of what defines a nuisance and declares as a public nuisance the failure of a property owner to keep their portion of the alley, street or parkway clean of garbage and debris. This provision places responsibility on private property owners in order to protect the public health, safety, and welfare. Code Enforcement staff would judiciously utilize the enforcement tools and remedies in this re-enacted ordinance to address code violation. The City may exercise its administrative, civil/injunctive and criminal remedies, or any one or combination of these remedies, to compel responsible persons to

abate a public nuisance when, in its judgment, such persons have not completed nuisance abatement actions in a timely or proper manner, or when responsible persons have failed to prevent an occurrence or recurrence of a public nuisance.
The proposed ordinance would enable the City to notice, abate, and recover costs associated with removing trash and debris from the public right-of-ways, should a property owner choose not to remove the trash and debris when notified to do so. Procedures for the notice of abatement of both imminent and non-imminent hazards are contained in this proposed ordinance. The intent of the proposed ordinance is to reduce the amount of trash and debris left on the public right-of-ways, effectively improving the safety and cleanliness of the City. The procedure for the City to recover costs of abatement, including code enforcement costs and attorneys' fees is also contained in the proposed ordinance. Recovery of costs includes Special Assessment and recording a nuisance abatement lien on the subject property.
A certified copy of the full text of proposed ordinance No. 2086 has been made available in the City Clerk's Department posted on March 19, 2015 in the office of the city clerk at 4455 West 126th Street, Hawthorne, CA 90250 (310) 349-2915. This ordinance is agenda for adoption on April 14, 2015. City Hall will be closed on April 3rd, 2015.

What You Need To Know To Control This Silent Killer

(BPT) - Most people assume they only need to take their medication when they are sick, meaning when they experience symptoms. But in the case of hypertension, this type of thinking could kill you.

Patients who have hypertension are often completely asymptomatic - that's the reason hypertension is often called the silent killer. The belief that symptoms such as headaches, nose bleeds, nervousness, sweating, difficulty sleeping or facial flushing are signals to take blood pressure medication is a myth.

Nonadherence to hypertension medication is a huge challenge. Research shows that one in three American adults suffer from high blood pressure, but only 47 percent effectively treat their disease to keep blood pressure levels under control.

Higher Risk for Heart Attack, Stroke

Express Scripts' specialist pharmacist Ed Dannemiller recently spoke with a patient who was 40 days late to refill her blood pressure prescription.

"When I asked her about the delay, she said she only takes her medication when she feels stressed or has a headache. The problem with this is that patients with hypertension may feel perfectly fine before suffering a heart attack or stroke," says Dannemiller.

Normal blood pressure is less than 120/80,



but consistent levels above 140/90 require medical attention. Simply keeping a patient's blood pressure under control decreases the risk of heart attack by 25 percent, stroke by 33 percent and heart failure by 50 percent.

But the only way to have a precise measurement is through a blood pressure reading.

Become an Engaged Patient

"I encourage patients to become engaged in their own health and keep track of their

blood pressure readings, which can help prevent unnecessary hospitalizations or ER visits," Dannemiller explains.

For patients with white-coat hypertension - those whose blood pressure rises from stress in the doctor's office - a home blood pressure monitor is a good option.

Dannemiller offers these useful tips for patients monitoring their pressure at home:

- Take blood pressure readings in a seated position with arm at the heart level

- To regulate the monitor, discard the first reading

- Keep a record of your blood pressure levels to bring to your doctor's appointment
- This additional data will help your physician better understand your condition and make better medical decisions to ensure healthier outcomes.

Lifestyle Changes Can Help

In addition to staying adherent to blood pressure medication, regardless of symptoms, the following lifestyle modifications also can improve cardiovascular health:

- Consume a heart-healthy diet rich in fresh fruits and vegetables and low in salt, fat and cholesterol
- Engage in regular aerobic physical activity
- Manage your weight, limit alcohol consumption and do not smoke

Value of Specialized Understanding

"Even with lifestyle modifications, most patients need at least two medications to reach their blood pressure goal," says Dannemiller.

Intervention and education from specialist pharmacists provide an important resource to improve medication adherence. When patients understand the value of their treatment and embrace good cardiovascular health, they bring a little more noise to this silent killer. •
