Lawndale CityTV and the Sportin' Life

The age of digital television became part of the technology world more than 15 years ago. Local programming for communities far and wide is just taken for granted with the plethora of channels from any provider. Citizens look forward to watching City Council meetings, Planning Commission meetings, and getting information on the local Bulletin Board for calendared events. Lawndale residents can watch local programming on Channels 3 and/or 22. Programming is not all necessarily "local" 24 hours a day, seven days a week.

As explained by Tom Strickfaden, a 27-year Lawndale staff member and the Cable Television Department Supervisor, "We have fiber optic cabling and a six-strand bandwidth for broadcasting. We broadcast the Council meetings every two weeks and tape it at the same time so that these are available for replay until the next meeting. We don't yet have live-streaming, but that is up to the City Council to decide.

The City Council has included some dollars for cable television upgrades in the budget that was work shopped a few weeks ago. So, in the future we may see some improvements. Most of our cameras are 20 or more years old and although they are serviceable, they are analog. It would be a welcome upgrade to be totally digital with HD quality across the board.

"Any and all programming that we originate is converted from analog to digital and DVDs are produced for anyone who wants a copy of something specific (Note: any DVD is \$1 each) and we can produce 50 DVDs at a time, so we do have some great equipment," Tom said as he showed off the duplicator.

In fact, all games - Little League, basketball, both league and high school, baseball games, football games, and any event recorded by Lawndale Cable TV has been converted from VHS to DVD going back to 1987. Anyone can get a copy as long as the opponents and a date (even approximate) is part of the request.

Many of the past players in Lawndale or even on teams that opposed a Lawndale team, can use footage to make a recruiting montage for college or for scholarship applications. "My favorite thing is to help out these kids and know that something we filmed helped them get into college with a sports scholarship,"

Strickfaden said.

With a staff of 17 and six announcers for various sports, Strickfaden handles the day-to-day operations. With the help of two primary editors, interviewers, and announcers, all while answering to the appointed Cable Television Commission and the elected City Council quality programming is available. Together, the Council and Commission approve the type of programming not Lawndale-centric.

Sports programming is very popular and comprises at least 49% of the programming. Other programming is acquired through government agencies, universities, and some from other cities, such as Santa Monica and Torrance. "We look for programs that are informative, such as health-related shows, topics that cover air quality, the ports Los Angeles County, and the West Basin Water District, for example," continued the television veteran.

"My favorite thing is to help out these kids and know that something we filmed helped them get into college with a sports scholarship,"

"I guess you could say we are the PBS of local cable," he laughed. "The most important factor for me as the one responsible for the programming is that it is compelling television."

Many of the announcers who work(ed) for Lawndale Cable have gone on to ESPN, local sports in the Los Angeles affiliates of the big three networks (CBS, NBC, ABC) and to Fox Sports West. They groomed for their futures in Lawndale and for local play-by-play announcing all the time. Rufus Washington, Beto Duran, Rashawn Haylock, Jose Bravo are all familiar to Lawndale audiences. Some of them are Emmy-nominated and Emmy-winning television sports announcers, trained up by Strickfaden in Lawndale.

Tom Strickfaden hails from Torrance and is a graduate of Cal State at Dominguez Hills where he earned his degree in Television Programming and Producing. He interviewed his idol, Ozzy Osborne and was (and still is) on a first-name-hug-when-you-see-her basis with Paula Abdul. Many of his past jobs involved

producing, camera work, floor directing or stage managing for television, so his background beneficial to Lawndale Cable.

He is very quick to take no credit and said Lawndale programming on the local channels is effective due to the dedication, highly-trained, and talented staff members he works with each day. "We have stellar camera work and superlative announcing for our games, and the direction is so well-executed, like a band when all the sounds created perfectly form a beautiful melody.

"I do want to acknowledge the ongoing support we receive from the City Council and management. It's the primary reason for any success Lawndale CityTV achieves. Some cities have done away with their media departments, but Lawndale sees the value in communicating with residents. Lawndale CityTV's 29-year history, recent development on social media outlets (YouTube and Twitter), in my opinion," stated Strickfaden, "validate the Council's desire for openness and transparency. Even more importantly, it's a reflection of the Lawndale community... in 29.97 frames per second. I'm so grateful to be part of and serve the Lawndale community. I'm really looking forward to the great opportunities around the corner in the next episode (in High Definition) of Lawndale CityTV."

On June 11 more "STAR" Awards may grace the Lawndale Cable TV offices, adding to those won in 2009, 2010, and 2013 from SCAN (States of CA and Nevada) Chapter of NATOA (National Association of Telecommunications and Advisors). Stay tuned. •

Cyber-Seniors Proves that you Can Teach an Old Dog New Tricks

The thought of teaching technologically challenged senior citizens, many of whom are in their late 80s, how to navigate a computer, let alone the internet, sounds more like a punishment than a reward. Why anyone at that age would willingly subject themselves to such an ominous learning curve makes no sense to most elderly people, but to a special

To engage this group into sticking with the program, a video competition is created to see who can get the most views on YouTube. With the help of their teenage mentors, the seniors set out to make a video based on what is important to them. 93-year-old Marion channels her inner Snoopy Dogg and

Growing up in an era when letters were written by hand, the very thought of sending an email is mind-boggling; What used to take days to receive can now be read in a matter of seconds. Two teenage sisters, Macaulee (16) and Kascha Cassaday (18) developed the Cyber Seniors program from a high school class project. After seeing firsthand how their grandparents were affected by Internet independence, the sisters were inspired to help other elders reconnect with loved ones in their lives.

In the Cyber Seniors program, teenage students sign up to guide the elderly in navigating the web. The comedic moments are organic; 88-year-old Shura is awestruck that she can "chat" with fellow Cyber Senior Ellard, 89, on Facebook. 76-year-old Annette is only concerned with dating websites and sets up a profile right away. Other seniors get confused when they can't access their

makes a rap music video about still having all of her teeth, as she sports a sideways baseball cap and all of her vintage art-deco necklaces. Shura loves to cook, and decides to demonstrate how she makes lunch, which consists of ironing her grilled cheese sandwiches (which actually works)! Other videos are just as funny, which include golf and exercise tips for seniors, how to pick up men, and gardening tricks.

Despite its amateur, low budget "look," *Cyber-Seniors* should be taken seriously as a documentary. It is not all jokes either; there are unexpected emotional moments that affect director Saffron Cassaday, unintentionally pointing out the importance of family and desire for connection. You will fall in love with the men and women and can't help but laugh alongside them as they enter the vast world of technology for the first time. Running at a brisk 74 minutes, *Cyber-Seniors* is a heartwarming story that proves old dogs can learn new tricks, and then brag about it on Facebook.

What Happens if I Put my Data on the Cloud and it Gets Corrupted?

When you use a cloud provider for data storage you should change your disaster recovery plan to incorporate your Cloud vendor. Previously, when our data was stored on a server in our office our disaster recovery plan included backup and restore capability within one physical location. With Cloud vendors we are storing our data in their data centers. In these situations you no longer have complete control of data backup and recovery. Therefore, you should modify your Disaster Recovery Plan to account for these changes. These procedures will be unique to the Cloud vendor so you will need to engage them to understand how you can maintain control in case of a disaster.

In the case of a Cloud Provider going out of business you will need additional steps in place to account for this worst-case scenario. Since each Vendor is unique and they have their own proprietary approach to manage and storing your data you'll need extra protection to protect yourself. In order to restore your

data using their proprietary software you'll need access to their software. This is done through an escrow account, which is an additional expense for you. Once you have the software in an escrow account then you'll need to understand how to access the backup of your data, which is an additional process you will need to account for. When you have the proprietary software and the latest backup in a secured location then you will be protected from a Cloud Vendor going out of business.

Good luck and it's better to plan for the worst-case scenario because if and when it occurs you will be able to mitigate your down time. •

Hoping To Retire In 10, 20 Or 40 Years?

(BPT) - American workers, ages 32 to 64, are \$6.6 trillion short of the amount they need in order to retire comfortably, according to Retirement USA. When it comes to planning ahead and saving money early, time is of the essence. However, 63 percent of American workers have less than \$1,000 saved for retirement, and only 44 percent of workers have even tried to calculate a retirement plan, according to the Employee Benefit Research Institute. This means that fewer than half of working Americans have a set plan for how they'll get by financially after leaving the workplace.

For example, while many workplaces offer savings plans such as 401(k)s and IRAs, withdrawals from pretax retirement savings plans are taxable - even after death. On the flip side, life insurance death benefits may be tax-free and interest and cash generated from

Carl Boenish grew up in Hawthorne and graduated from Hawthorne High School in 1959. He got a job as an electrical engineer with Hughes Aircraft and it looked like he would settle into a comfortable life in sunny So Cal. His ensuing life was anything but ordinary and comfortable. He took a liking to filming using his large 16 mm movie camera. He also took a liking to skydiving. He combined both of these into filming his jumps. His cinematography work included the 1969 John Frankenheimer parachuting film classic *The Gypsy Moths*, starring Burt Lancaster and Gene Hackman, and a *National Geographic Explorer* segment on jumps from El Capitan. From about 1978 on, Carl became the father of the BASE jumping movement. BASE stood for the four different types of high objects that jumpers had to jump off of to be part of the club. B was for Building, A for Antenna, S for Suspension, and E for Earth (such as a cliff). Carl always looked for more spectacular—more dangerous—feats of human flight. Him and his wife Jean broke the BASE jumping Guinness World Record in 1984 on the Norwegian 'Troll Wall' mountain range. Tragically, Carl fell to his death trying a more dangerous jump just a day after their record setting jump. Until recently, Jean lived in Hawthorne and participated in jumping activities. Last Friday, a documentary entitled, *Sunshine Superman* made its premiere showing at the Landmark Theater in West LA. I had the opportunity to attend one of the showings over the weekend. Carl's original footage of his jumps off of El Capitan in Yosemite and many other places captivated the audience.

I don't like looking over the side of a cliff or building. I can't imagine jumping off of one. I would rather just watch people jump. These jumpers deserve to have a "cold one" after jumping from more than 1,000 feet.

St. Mary's Finishes Second in Division IV Finals

St. Mary's Academy's girls' track and field team from Inglewood, like others, was unable to keep up with powerful Oaks Christian High from Westlake Village but the Belles turned in several fine performances to earn them a second place finish in the CIF-Southern Section Division IV Championships last Saturday at Cerritos College.

The Lions ran away with the title with 131 points to 44 for runner-up St. Mary's. Los Angeles Marlborough was third with 39 and Serra of Gardena took fourth at 37. The Belles were led by Alliyah Hale, who won the 300-meter hurdles at 42.91 seconds.

The hurdles, in fact, were a big strength for St. Mary's. Kyra Anderson finished second in the 100 hurdles clocking 14.22, with Jaela Williams of Serra, the Belles' big Del Rey

League track and field rival, in 13.96. Both times were wind aided since the meet was held on a cool and windy day.

St. Mary's had a pair of second place finishes in both the 4x100 and 4x400-meter relays. The Belles' 400 relay squad of Anaiah Brown, Aliyah Hale, Briana Shufford and Keshawna Myles placed second behind Oaks Christian, which had the meet's fastest overall time of 45.75, timing 46.69.

In the 1,600 relay, St. Mary's, that included Hale, Kyra Anderson, Mia Williams and Briana Shufford, also finished second in 3:54.67. The Lions won the race clocking 3:49.4 and the Cavaliers were (3:57.1) were third.

Shufford advanced to Friday's Southern Section Masters (All four divisions combined) Championships at Cerritos College in both relays.

"We're hoping we will do well enough to

make state," Shufford said of the Belles' hopes for the California State Championships on June 5 and 6 at Buchanan High's Memorial Stadium in Clovis.

St. Mary's Anaiah Brown took sixth in the 100-meter dash (12.01) and Shufford (12.15) was eighth. Hale also advanced in the 300 hurdles as did Anderson in the 100 hurdles.

"What we had did real well," St. Mary's head coach Rene Anderson said. "I am satisfied with the way we finished."

For the boys, Lawndale and Inglewood Morningside each had one qualifier. The Cardinals' junior Bryant Perkinson, who won Pioneer League championships in the long jump and triple jump on May 6, qualified for the Division II finals at the triple jump. He finished eighth in the triple jump with a leap of 42 feet, six inches.

The Monarchs' 4x400 team with Darrus Wilson, Jaylin Wright, Aaron Berry and Torry Allen placed ninth in 3:36.34. Neither qualified for the Masters Meet, which begins at 4 p.m. Friday at Cerritos College.

ST. MARY'S GETS ELIMINATED

St. Mary's Academy's softball team from Inglewood was eliminated in the first round of the CIF-Southern Section Division VI playoffs by host Chadwick 16-6 last Thursday in Rolling Hills Estates. The Belles made the playoffs after finishing third, behind champion Long Beach St. Anthony and runner-up Serra, in the Santa Fe League.

HAWTHORNE SOFTBALLERS FALL IN FIRST ROUND

Hawthorne High's softball team began the CIF-Southern Section Division IV playoffs with a 6-0 win at Gabrielino High on May 19 in San Gabriel that gave the Cougars a ticket to the first round at second seed Dos Pueblos in Goleta (north of Santa Barbara) last Thursday.

That's where Hawthorne ran in premiere pitcher Veronika Galoin who threw a six-inning no-hitter with 12 strikeouts and only two walks. The loss ended the Cougars' season at 16-8-1. Hawthorne finished third, behind champion Santa Monica and second place El Segundo, in the Ocean League.

Against Gabrielino, winning pitcher Alyssa Casillas hurled a complete game five-hitter. She struck out five batters. Keying Hawthorne's offense was Fa Leilua who went four-for-four with a home run and two runs batted in.

ANIMO OPENS WITH EASY WIN

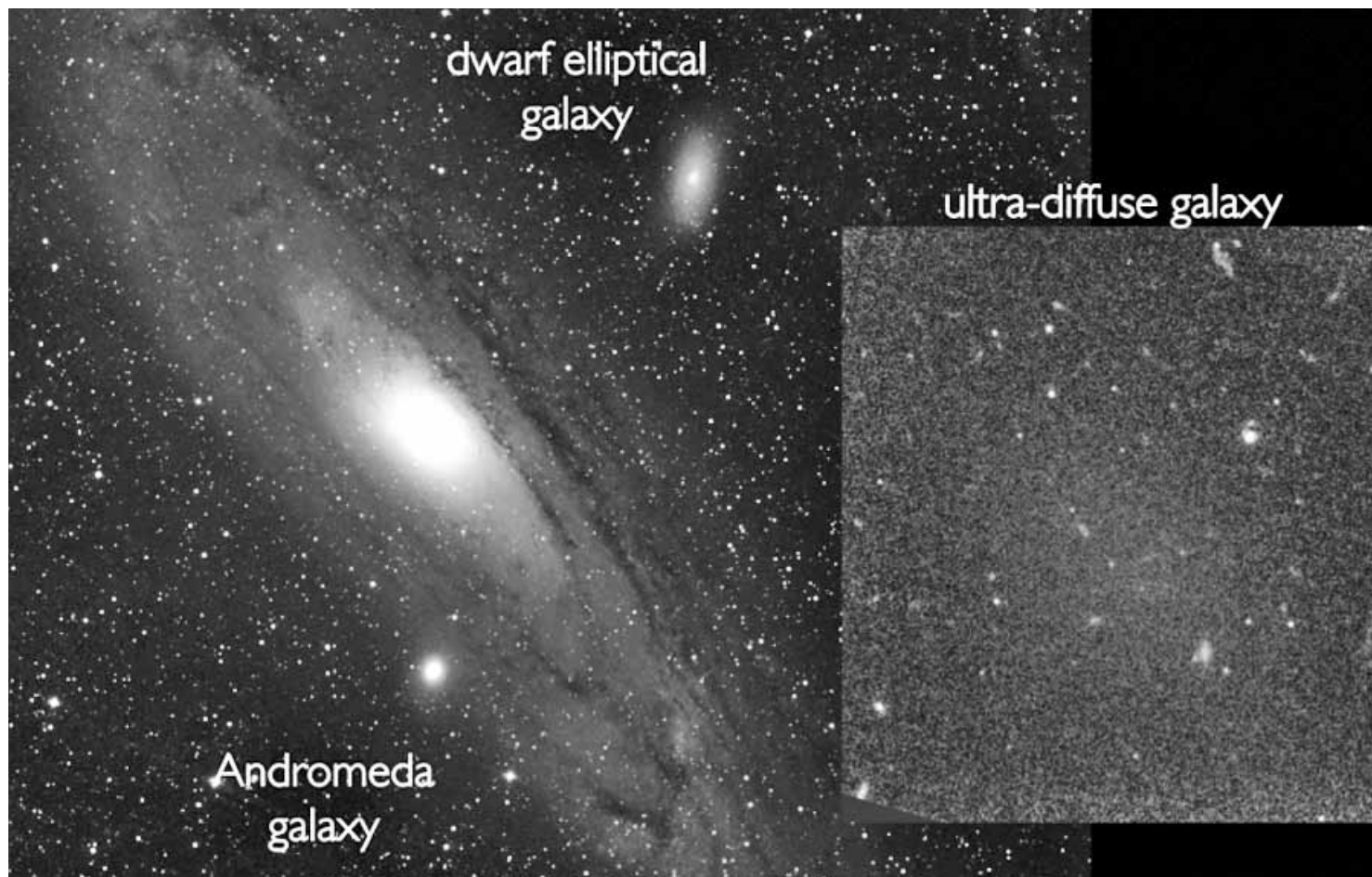

Looking Up

Scientists at Keck Observatory Discover the Fluffiest Galaxies

An international team of researchers led by Pieter van Dokkum of Yale University has used the W. M. Keck Observatory to confirm the existence of the most diffuse class of galaxies known in the universe. These "fluffiest galaxies" are nearly as wide as our own Milky Way galaxy—about 60,000 light-years—yet harbor only one percent as many stars. The findings were recently published in the *Astrophysical Journal Letters*.

"If the Milky Way is a sea of stars, then

these newly discovered galaxies are like wisps of clouds," said van Dokkum. "We are beginning to form some ideas about how they were born and it's remarkable they have survived at all. They are found in a dense, violent region of space filled with dark matter and galaxies whizzing around, so we think they must be cloaked in their own invisible dark matter 'shields' that are protecting them from this intergalactic assault."

The team made the latest discovery by combining results from one of the world's smallest telescopes as well as the largest telescope on Earth. The Dragonfly Telephoto

Array used 14-centimeter state of the art telephoto lens cameras to produce digital images of the very faint, diffuse objects. Keck Observatory's 10-meter Keck I telescope, with its Low Resolution Imaging Spectrograph, then separated the light of one of the objects into colors that diagnose its composition and distance.

Finding the distance was the clinching evidence. The data from Keck Observatory showed the diffuse "blobs" are very large and very far away, about 300 million light-years, rather than small and close by. The blobs can now safely be called Ultra Diffuse Galaxies

(UDGs).

"If there are any aliens living on a planet in an ultra-diffuse galaxy, they would have no band of light across the sky, like our own Milky Way, to tell them they were living in a galaxy. The night sky would be much emptier of stars," said team member Aaron Romanowsky, of San Jose State University.

The UDGs were found in an area of the sky called the Coma cluster, where thousands of galaxies have been drawn together in a mutual gravitational dance. "Our fluffy objects add to the great diversity of galaxies that were previously known, from giant ellipticals that outshine the Milky Way, to ultra compact dwarfs," said University of California, Santa Cruz Professor Jean Brodie.

"The big challenge now is to figure out where these mysterious objects came from," said Roberto Abraham, of the University of Toronto. "Are they 'failed galaxies' that started off well and then ran out of gas? Were they once normal galaxies that got knocked around so much inside the Coma cluster that they puffed up? Or are they bits of galaxies that were pulled off and then got lost in space?" The key next step in understanding UDGs is to pin down exactly how much dark matter they have. Making this measurement will be even more challenging than the latest work.

The W. M. Keck Observatory is located near the summit of Maunakea on the island of Hawaii. Its two, 10-meter optical/infrared telescopes feature a suite of advanced instruments including imagers, multi-object spectrographs, high-resolution spectrographs, integral-field spectrographs and world-leading laser guide star adaptive optics systems.

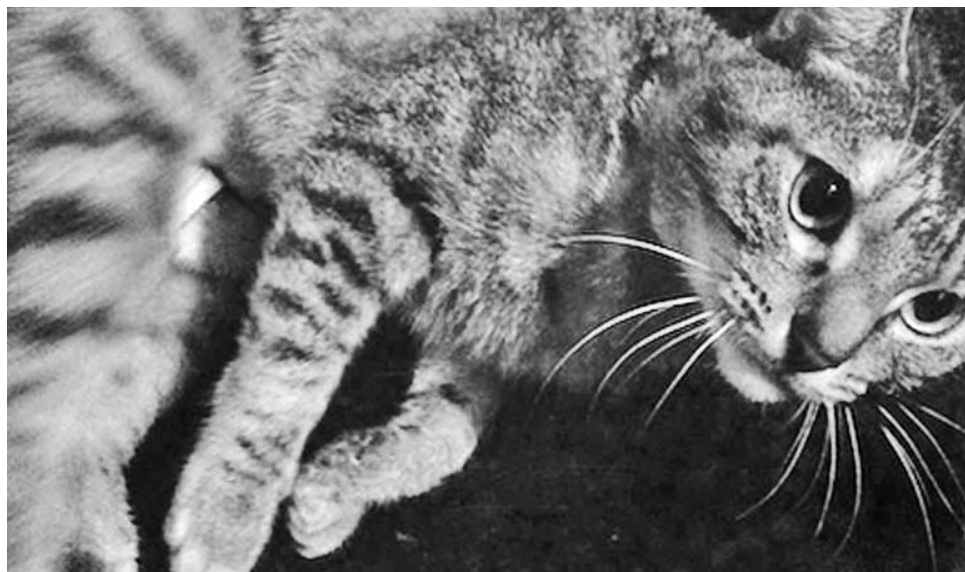

Protect Your Pets from Flea Infestations

April showers bring May flowers, but May showers bring fleas! The combination of humidity and warm temperatures allows fleas to breed quickly and thrive. Fleas are more than a nuisance. Many cats and dogs are allergic to the flea bites and will have severe dermatitis. Fleas can also transmit disease.

In cats, fleas can transmit *Mycoplasma Haemofelis* (formerly called *Hemobartonella* and *Feline Infectious Anemia*). This is a potentially serious disease for all cats but especially in cats already infected with *Feline Leukemia Virus*. The red blood cells become altered and the cat's immune system destroys the cells leading to anemia. Fleas can also transmit the bacteria responsible for *Cat Scratch Disease* (*Bartonella*). Dogs and people can become very ill from this disease. The clinical signs range from weakness and lameness to fevers and meningitis, as well as affecting internal organs.

Fleas transmit *Murine Typhus* to people. This disease is seen frequently in Southern California. *Murine Typhus* is a rickettsial disease caused by a type of bacteria called *Rickettsia Typhi* that is transmitted via fleabites. Fleas carry the bacteria in their feces, and often defecate while biting and feeding on blood. When a person is bitten by a flea and then scratches the bite, the bacteria from the feces can enter the wound and enter the blood stream. People become infected from fleas brought into the home by their pets, or by rats, mice and opossums carrying fleas around the home. Transference of the bacteria

through the eyes, nose, or mouth can also infect people, or inhaling crushed or dried feces of an infected flea.

So how do we prevent these fleas in the first place? The first thing is to use flea prevention year round whether you see them or not. Trying to put out a fire is harder than preventing one. It helps to understand the flea lifecycle and how the modern medicines work.

Fleas are like most insects. They have four life stages: An egg stage, larval or maggot stage, pupa or cocoon stage, and the adult. Only the adult stage lives on the pet and it spends its entire life of about 10 days to three weeks on the animal. During that time the female flea will lay about 50 eggs per day. That's 500 eggs from one flea. The eggs fall off the pet and hatch into the maggot stage. This stage can be as short as nine days. After molting, the maggots form a cocoon.

Once the flea reaches the cocoon stage it's almost impossible to kill. In fact, a flea in its cocoon can remain alive for over a year and withstand heat, cold and drought. The covering of the cocoon is sticky and picks up all kinds of dust and dirt making them difficult

to see. The adult flea hatches from the cocoon when it senses movement, warmth and carbon dioxide. With 70-degree temperatures and 70 percent humidity, a flea can go from an egg to an adult in about 14 days. During the cold weather, the flea eggs and cocoons can take longer to go through their life cycle or may not hatch but they don't die. They can just sit and wait for the perfect weather and the perfect host to walk by.

Treat your pet year round with a professional medicine prescribed by your veterinarian. He

or she will be able to recommend the best type of flea control for your pet's age, breed and health status. Avoid flea shampoo or sprays. These are marginally effective, can irritate skin and are potentially more toxic than newer products. Stay safe and see your veterinarian for more information about fleas.

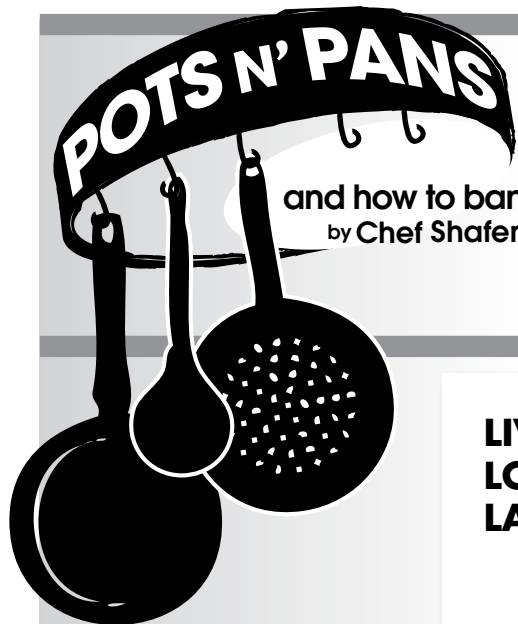

BBQ Tex-Mex

Ingredients

- 5 pounds 1/4 thick sliced beef-top sirloin/hanger/skirt steak
- 10 cloves of garlic chopped
- 3 tablespoons ground coriander
- 1/3 cup paprika
- 1/2 cup orange juice
- 2 tablespoon kosher salt
- 2 tablespoons coarse ground black pepper
- 1/2 cup vegetable oil

Preparation

1. Mix together garlic, coriander, paprika, orange juice, salt, pepper, and oil in a large bowl.
2. Dredge the slice beef into the marinade then into a container for storage. When all the beef is marinated refrigerate till ready to grill.
3. Make sure your grill is very hot before starting. The slices are very thin so you don't need to cook them very long. Just about 30 seconds each side for medium rare. •
