Lawndale City Council Confirms Amended Graffiti Restitution Ordinance

The Lawndale City Council met on Monday, August 3, and approved an amendment to the Municipal Code involving graffiti removal and restitution. After the first reading of the amended ordinance a few phrases were further amended for this requested second reading. The ordinance now includes wording that states the abatement costs will be passed on to the persons perpetrating the graffiti, adding that if a minor is the person accused of the graffiti, restitution will be collected from the parents or guardians, holding all parties severally liable. If it is determined the damage is detrimental to the property, enforcement allows for liens and special collections from the perpetrators or parents and guardians of minors who are responsible for the graffiti. Civil liability penalties will be assessed and restitution can include court costs, attorney's fees, penalties, costs associated with law enforcement identifying and apprehending the perpetrators, repair of the property, and removal of the graffiti.

Working quickly after the recent July 4th holiday the City Council adopted an ordinance amendment, which allows for discharge of Safe and Sane Legal Fireworks on July 4th, beginning at 12 Noon and continuing until 11:59 p.m. on July 4th. Also approved in the consent calendar is the expeditious permitting process for single- and two-family rooftop solar systems, admitting these requests to the front of the queue regardless of submission dates.

The city-owned property at the southwest corner of Hawthorne Boulevard and Manhattan Beach Boulevard is transferred to the Successor Agency of the Redevelopment Agency to allow for that parcel to be developed for businesses that will provide a revenue stream and exponentially add sales tax and business license fees to the city treasury.

The State mandate for the adoption of the County Animal (County Code Title 10), Health (County Code Title 11), and Vehicles

and Traffic Codes (County Code Title 15) appeared on the agenda as a public hearing. One citizen spoke requesting that the dog licenses be increased to match the amount charged by the county, as well as licensing cats. It was explained that the city of Lawndale determines its own costs for dog licenses as part of the Municipal Code and at this time there is no intention to match the cost incurred on the county level. Following the public hearing a motion was made to adopt, and seconded, and passed by a unanimous vote.

The City Council approved a resolution in celebration of the 50th Anniversary of the Voting Rights Act of 1965.

A request from the Association of the Los Angeles County Sheriff's Department (ALAD) was approved in support of the recruiting efforts and hiring of qualified candidates to increase the number of deputies in the Sheriff's Department.

During the Public Safety report on July 20, Captain Steven Sciacca presented a check to the City of Lawndale in the amount of \$2,497.71, representing the value of assets collected by County Sheriff's Deputies in the seizure of illegal narcotic activities. These funds are mandated by the Health and Safety Code to be used only toward law enforcement work within the city.

Three significant reports were given about recent arrests in Lawndale. An individual walking in and out of traffic on Inglewood Avenue near 156th Street, causing traffic issues, was arrested when he was taken out of the street and found to be in possession of narcotic paraphernalia and an illegal knife.

During a business money dispute one of the two arguing individuals pulled out a shotgun, threatening the other with death by that weapon. Deputies arrived on the scene when the disturbance caused citizens to call for law enforcement assistance. The individual brandishing the shotgun was arrested. A felony assault, with a deadly weapon, charge was filed by the District Attorney.

A vehicle in extremely poor condition was stopped by Deputies when the driver made an illegal lane change near 162nd and Hawthorne Boulevard. Occupants of the vehicle gave various stories about who owned the vehicle. With the information from the car's registration it was discovered this was an as-yet-unreported stolen vehicle. All vehicle occupants/suspects were arrested for grand theft auto.

During oral comments, a citizen spoke about his right, under the Bill of Rights, to speak his mind and if his remarks reflect negativity on the city, then the City Council and citizens should use carefully researched information brought to light by caring citizens as a starting point to improve living in Lawndale. Another individual spoke at the citizen's podium about a Rental Property Inspection Program. City Councilman Daniel Reid asked to set up an appointment with that person to discuss this concept further.

The Third Annual Lawndale Blues and Jazz Festival will take place at Jane Addams Park, Saturday, September 26, beginning at 1 p.m. with five Blues artists currently scheduled. Admission is free. Food for purchase at booths will be part of the event.

The meeting was adjourned in memory of Helen Stover, a member of the Senior Citizen's Advisory Committee who passed away recently after residency since 1959. An Open House on Saturday, August 8, at 14920 Arch from 11 a.m. to 2 p.m. will be held by the Stover family.

Also remembered at the close of the meeting was Wyneva Chenault Flores, who died suddenly on Friday, July 24, at her home. Ms. Flores was a consistent volunteer at most city events and attended every City Council meeting, speaking at each one with either an encouraging word or to point out something that needed to be given consideration. No information about services is available.

The next meeting is Monday, August 17, at 6:30 p.m. •

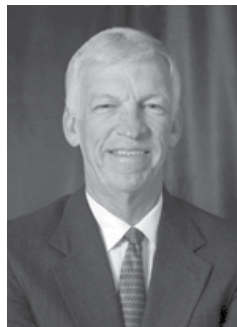

FILING PERIOD CLOSES THIS FRIDAY

Overtime Buzzer Beater Leads Warriors over Hard Work

It was a thrilling overtime game but the Warriors pulled off a buzzer beating 38-35 overtime victory over Hard Work in Hawthorne Parks and Recreation Division IV (age 12-13) play Saturday at the Betty Ainsworth Gymnasium.

The game was tied at 35 after regulation, forcing a two-minute overtime period. As in most of the contest, both defenses did very well to keep the score low. There was no scoring until Tajay Hope heaved a prayer shot that went right into the basket as the Warriors celebrated the win in the very close divisional race.

In the contest that was close throughout, Hope, who scored the Warriors' final seven points, gave the Warriors a 35-32 lead with the basket but it was Hard Work's Daniel Gil that swished a three-pointer with 34 seconds left in regulation that tied the game at 35.

The Warriors had a chance to take the lead as Hope was fouled with eight seconds remaining in regulation. His front end of a one-and-one free throw fell short and the contest went into overtime. In the see-saw battle, Hard Work held an 11-7 lead after the first quarter but the Warriors took a 16-15 edge at halftime. Hard Work led by one at 25-24 after three periods.

The Warriors' balanced scoring attack was led by Hope with seven points, all of them in the final 1:17 of regulation and the overtime period. Michael Harron, Kimani Lavenette and Garry Harris each added six points. Kath Eleby led all scorers with 10 points for Hard Work. Gil and Kevin Eleby chipped in six and five points, in order.

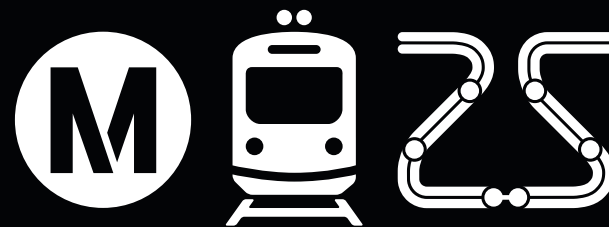

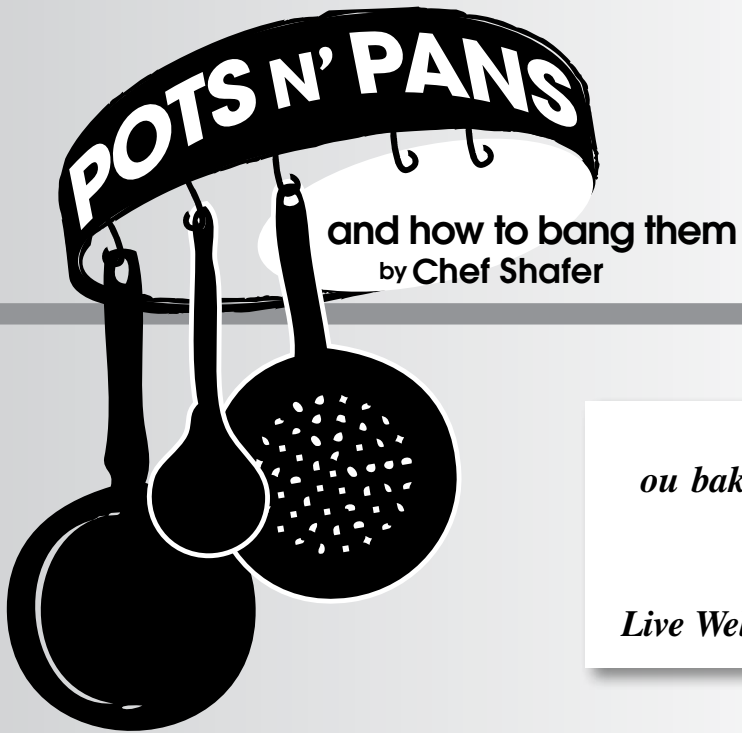

mesmerizing, *The End of the Tour* stands as an early contender for a Best Picture Oscar nomination.

The End of the Tour is based on real-life journalist David Lipsky's critically acclaimed memoir *Although Of Course You End Up Becoming Yourself: A Road Trip with David Foster Wallace*, which chronicles the highs and lows of his 1996 five-day journey with his interviewee-author. Jesse Eisenberg plays Lipsky, himself a novelist with a fascination with Wallace. While working as a reporter for *Rolling Stone* magazine, Lipsky convinces his boss to let him join Wallace on the last leg of his book tour for the post-modern masterwork *Infinite Jest*, scoring a days-long exclusive with the writer dubbed genius.

Lipsky, a fast-talking and socially awkward man, first meets the reserved, introspective Wallace at his home. Subtle humor is sprinkled throughout this first "getting to know you" scene, and it's here where the tone is set for the rest of the film. As the days go by, the bond grows stronger between

Lipsky and Wallace, and what was initially a more formal and awkward Q&A evolves into a free flowing and revealing, conversational interview.

Inevitably, as a journalist who also happens to be a fan, Lipsky gets too close to his mesmerizing subject to stay objective. Yet the breaking of this ethical code is what it takes for Wallace's emotional walls to come down, as he begins to bare his soul to a man he just met. Pretty soon, we, as well as the characters on screen, step back and ask ourselves, who is interviewing who?

It is easy to chart where Wallace's depicted personality breaks through and wins us over. The thoughtful dialogue between both characters is sharp and tactful, one of my favorite lines being "reading you is another way of meeting you," but the minutes-long monologues are where Segel really shines. His honesty and disenchantment with fame is a refreshing perspective on life, and his humility is applaud-worthy. He observes that American life has us programmed to

want to achieve everything, but there is nothing wrong with ultimately wanting to stray from the mainstream and be left alone. This is the inspiring path Wallace is choosing to take, but can't help but let his "Lone Wolf" lifestyle, depression, and loneliness get the best of him.

Segel and Eisenberg's performances are magnetically matched, the intensity of their relationship growing stronger throughout the film. Much credit is due to screenwriter Donald Margulies, who himself is a Pulitzer-Prize winning writer. He tackles *The End of the Tour* with stark realism, highbrow humor, and bittersweet insight. This is evident in the film's final moments, which ends with a single, affecting word.

Director James Ponsoldt's big break into mainstream cinema came in 2013 with the coming-of-age film *The Spectacular Now*. Avoiding many of the stereotypical pitfalls most young-adult stories fall victim to, Ponsoldt captured sensitivity and poignancy that left a lasting impression on audiences.

The Miles Teller-Shailene Woodley-starring film paved the way for this next feature, and it is with this same attention to detail and wistfulness that *The End of the Tour* is greeted.

Meditative and thought provoking, *The End of the Tour* captures the complexity of one man's life through a delicate lens. A neatly wrapped package with standout performances, this is an example of what finely-crafted filmmaking looks and, more importantly, feels like. One thing to note—there is a hidden gem if you stay through the end of the film that delights, just like how I'd imagine David reacting to this surprise if the film was to continue on. It will bring a smile to your face and lead you to tip your hat to the creativity and talent of Ponsoldt in insightfully capturing the essence of a brief yet honest, and almost magical, moment in this reclusive genius's life. *The End of the Tour* is now playing at the Landmark Theatre & the ArcLight Hollywood. •

Stepping Up the Fight Against Identity Theft and Data Hacking

(BPT) - Fueled by the recent epidemic of data breaches, identity theft has become a major concern for millions of Americans. Major companies like Target, Home Depot, eBay, Anthem Blue Cross/Blue Shield and dozens of others have experienced data breaches affecting millions of consumers over the past two years.

Experts have found a strong correlation between being affected by a data breach and the risk of identity fraud. Fully two-thirds of victims of identity fraud in 2014 also received a data breach notification according to Javelin Strategy & Research. Not surprisingly, in February, identity theft was named the top consumer complaint to the Federal Trade Commission (FTC) for the 15th consecutive year. In March, FTC Commissioner Terrell McSweeney affirmed these concerns citing a recent study that found that Americans are "more concerned about ID theft than violent crime, natural disasters or terrorism."

While inaction on data security issues by

policy makers and businesses has exacerbated the problem, there are effective steps consumers can take right now to protect themselves. "Many actions don't require a lot of time or energy but they can go a long way in helping to reduce the risk of identity theft," says John Breyault, vice president of public policy for telecommunications and fraud at the National Consumers League (NCL).

Steps NCL promotes to consumers include:

- Use strong passwords that are different for each website
- Enable two-factor authentication when possible (this is the code sent via text to your mobile phone which you use to log into a website)
- Secure your home wireless router and network
- Don't click on links in emails or download attachments you aren't expecting
- Know what companies store your personal data and limit what you share

"If you have been notified about a data

breach, don't sit by," says Breyault. "Change your passwords, watch out for suspicious email and take advantage of credit monitoring or identity theft protection services if they are offered. Better yet, consider putting a credit freeze on your credit reports with the three major bureaus."

NCL is quick to assert that while there are steps consumers can take individually to safeguard their personal information, more needs to be done at the national level by Washington officials in the fight against hackers who steal information and identities for financial gain.

Advocates are raising the alarm about the increased risk of identity fraud stemming from data breaches. "Businesses are profiting handsomely from the unprecedented amount of consumer data they are now collecting," said John Breyault, vice president of public policy for telecommunications and fraud at the National Consumers League (NCL). "Unfortunately, when they fail to protect that data,

it's consumers who are often the ones harmed when crooks use their information to commit identity theft."

FTC Chairwoman Edith Ramirez told Congress last year that, "Never has the need for legislation been greater. With reports of data breaches on the rise, and with a significant number of Americans suffering from identity theft, Congress needs to act."

Groups like NCL are pushing the federal government to dedicate more resources to combating these kinds of crimes. "Agencies like the Federal Trade Commission should work with businesses that store consumer information to share information and strategies on how to better prevent hackers from breaching their systems," says Breyault. Specifically, NCL has called on the FTC to convene workshops specifically focused on data security. Such events would bring together stakeholders to begin the process of turning the alarming trend of mega-data breach around. •

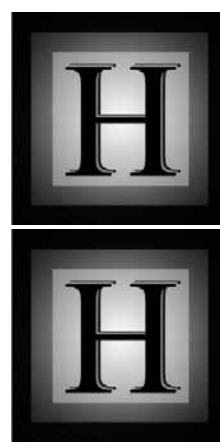
