Lawndale City Council Decides to Join Local Area Storm Water Management Program

The City Council dealt with the issue once again of the consultant contract services for the Storm Water Management Program (SWMP) after making a decision on a consultant at the July 20 Council meeting. Despite the change of consultant from the incumbent (TECS) to a new consultant (CASC), the Los Angeles Regional Water Quality Control Board rejected the individual program presented by the consultant of the city of Lawndale. The city was offered one more opportunity to join the coalition of 84 other cities that comprise the Dominguez Channel Watershed Management Area Group (DC WMA) and contract with Paradigm Environmental, Inc. Incorporating Lawndale into the already prepared program for the DC WMA can be accomplished at a cost of \$94,460. This is necessary to avoid fines and non-compliance judgments against Lawndale for any deficiencies in the storm water discharges that may cause violations of the water quality standards that are permitted to enter the Dominguez Channel.

In addition to joining the coalition contracting with their management consultant for the overall program, the requirement also includes the preparation of the Coordinated Integrated Monitoring Program (CIMP) and incorporating the Lawndale revisions into the final DC WMA CIMP, as well as coordinating efforts with the Los Angeles Bureau of Sanitation. The city must use the services of the Regional Board preparer to assure compliance and Tetra Tech, Inc. requires \$32,200 to complete the work necessary.

The City Council heard the staff report and considered the contract consultant services with Paradigm Environmental, Inc., and the efforts of Tetra Tech, Inc., to incorporate Lawndale requirements into the program, although presented as two separate Administration agenda items as one motion, seconded, and voted upon. The

vote was 4-0, with Mayor Pro-Tem Larry Rudolph absent, to approve the contract with Paradigm Environmental, Inc., for the period of September 9, 2015 to January 31, 2016, in the amount of \$94,460 and to contract Tetra Tech, Inc., for the period of September 9, 2015 to January 31, 2016, in the amount of \$32,200, both expenditures to be appropriated from the General Fund reserves.

In other business, the City Council approved the attendance of Mayor Robert Pullen-Miles, with Councilman Pat Kearney as an alternate, at the League of California

BOE as the designated entity to coordinate payment to the city.

In the Public Safety report citizens are reminded of the return to school of all students to local area school campuses and to be aware of the necessary precautions when driving in a school zone. Drivers should be on high alert for students on bicycles, skateboards, walking, using scooters, and getting out of vehicles as they are being dropped off near schools. Parents are asked to remind their student children to not jaywalk, to not wear headphones while walking, to not be texting and walking, to use sidewalks, and to stop at crosswalks before proceeding to cross the streets. Drivers are asked to comply with all laws to not text and drive, to slow down in school zones and comply with the posted speed limits, and to obey all school bus signals (flashing red lights mean STOP), and give three feet clearance driving next to bicyclists.

Deputies arrested a driver who had previous DUI arrests and was back in a vehicle when he struck several parked vehicles on Hawthorne Boulevard driving while intoxicated. The District Attorney has filed felony identity theft charges against a suspect who was arrested by deputies in Lawndale for trying to use a false identification and trying to cash a check in the name on the false identification, discovering that the suspect was wanted for false identification usage and check cashing of fraudulent checks in other cases.

Citizens are reminded of the Clean-Up Week throughout the city from September 12 to September 20. Large items will be picked up curbside when scheduled by residents, garage sales on the beginning and ending weekend are free, and the Community Clean-up Day, sponsored by Wienerschnitzel, will take place on Saturday, September 19 from 9 a.m. to 1 p.m.

The City Council presented a Proclamation to City Clerk Bernadette Suarez for National Voter Registration Day on September 22, 2015. New voter registration is required every time you change your name, change your address, or change your Party affiliation.

The City Manager was authorized by approved resolution to be the designee and prime point of contact for the State Board of Equalization (BOE) in order for the Utility User's Tax (UUT) for Mobility Usage taxes for prepaid charges revenues (5.5 percent) and 911 charges revenues to be paid to the city through the new State provision of the

Film Review

The Second Mother is a Culturally Crowd-Pleasing Number About Family

The Second Mother is set in Sao Paulo, Brazil (a place where the Grammy-Award winning alt-rock band Arcade Fire is referred to as "The Arcade Fire"). The film (*Que horas ela volta?*) follows the eponymous character Val (Regina Casé), a housekeeper for a considerably wealthy family. It's not an understatement to say her job has become her life, evidenced when her daughter Jéssica

and even intimate in its storytelling.

It must be said, Regina Casé shines in the lead role as Val. She is a graceful presence as an immediately empathetic and cordial character. Val is visibly frustrated by her position – she overthinks how to organize a new coffee table set, is bothered by the family dog, and can't seem to stop Jessica from eating the family's chocolate ice cream. Everybody in *The Second Mother* seems perpetually frustrated and

(Camila Márdila) flies into town, and end up only staying in the house.

The main conflict here is in Val's struggle to identify with a daughter she never quite got to raise. At one point she even relies upon the opinion of the family's son to get a sense of what her own daughter is like.

The Second Mother is a mostly quiet picture. Music is scarce, and camera angles, if not static, move slowly. Scenes within the house are almost claustrophobic due to how these angles repeat themselves throughout, very astutely mirroring the routine of Val's life. Aside from one sequence, set in a high-rise, the surrounding city is never really explored (except for that it rains a lot). But these elements make the film contained, focused,

vicariously argumentative, which feeds what is most interesting and entertaining here: the dynamics and dialogues between characters.

The Second Mother is a film primarily about thickness of bonds, how we concern ourselves with the opinions and approvals of those outside our family, and how they seem to mean more when they are earned. The family's son reaches out to his "second mother" over his first for this reason. But the film is moreover a character study about Val's shortcomings as a first mother herself. That said, while the movie is more dramatic than comedic, it has a natural levity that lends itself to a something deeply felt but also feel-good. *The Second Mother* is now playing in LA at the Laemmle Royal. •

Legal Aid for Elders

Preparing for College? Include Legal Documents and Important Discussions

Unless you have the proper legal documents in place, once your child turns 18, you no longer have access to their health information or academic information and most importantly, you do not have the legal right to make medical decisions on their behalf. Preparing these documents before your child leaves for college is more important than furnishing a dorm room.

Preparing to send a child away to college for the first time is exciting, but there are serious issues to consider. A recent article from *The Atlanta Journal-Constitution*, "How to prepare for kid going off to college" addresses issues concerning healthcare and credit card finances.

Health care: When a child turns 18, you are able to continue to keep him/her on your insurance plan, but they're considered a legal adult under HIPAA as far as disclosing health information. As a parent, you're no longer legally permitted to access their health information when they go off to college and get sick or if they're in a car accident and in the hospital. Because of the HIPAA restrictions, you should have an estate-planning attorney draw up a health-care power of attorney which names a parent or parents as their health-care agent. That way you can speak to healthcare professionals on their behalf if they are incapacitated, and you can obtain their medical information. Have a conversation with your child about the changes that happen when they become an adult and how a health-care power of attorney will protect them. Keep a copy of the document at home and have your son or daughter keep a copy at school. Scan it as

well so you have it in electronic format to email to a physician or to an ER if needed.

Credit cards: Anyone under 21 applying for a credit card must have an independent source of funds to pay the bills, so that's good news for parents. Many college freshmen use credit cards cosigned by parents. Parents should sign up for mobile alerts to monitor their student's expenses, and talk to them about budgeting.

If your child goes on a shopping spree and there are payment issues, your credit is going to take a hit. You can avoid this by paying the bills yourself and having your kid reimburse you for his or her expenses each month. You can also go with a debit card instead of a credit card. When the money is gone, it's gone. Another option is to add your child as an authorized user on your account so that he will have his own card and start to build a credit history. However, you're the one managing the account.

While you're thinking about all of these important issues, you also should take the time to review your estate planning now that your son or daughter is an adult and possibly is no longer living at home. Talk to your estate planning attorney about some of the common changes people consider at this point in the life of a family.

South Wears Down Lawndale

Lawndale High's football team began its season in what was expected to be a good match-up between two of the South Bay's top quarterbacks, the Cardinals' Chris Murray and the Spartans' Gabe Zuniga. Both had good moments but South's depth and experience proved too much for Lawndale in the end as the Spartans prevailed 33-21 last Friday at Lawndale.

The Cardinals jumped on the Spartans quickly as Zach Cooper raced 80 yards for the touchdown and a 7-0 lead. South, though, tied the game when Zuniga completed a drive on a one-yard sneak.

The score remained tied at seven until Lawndale came back to grab a 14-7 lead when Murray tossed a 24-yard touchdown pass to Bryant Perkinson with six seconds left before halftime.

The Spartans, however, came back with Zuniga's second one-yard TD run to get within 14-13. South lined up for the tying point after touchdown but a pair of off side penalties on the Cardinals enabled the Spartans to go ahead with a two-point conversion. Zuniga took just a few steps into the end zone and South led 15-14 with 6:39 remaining in the third quarter.

South, then, turned to junior fullback Cameron Dillon, who proved dominant in the fourth period. He had several good runs in its drive that went from late third quarter to the first part of the final period. It ended with five seconds into the fourth quarter when he gave the Spartans a 21-14 lead on a one-yard run.

Lawndale, though, bounced back after getting good field position at the South 45-yard line with Perkinson's punt return. The Cardinals took 10 plays before Murray raced into the end zone from six yards out and the extra point was good for a 21-21 tie with 5:32 to go in the game.

From there, though, the Cardinals had trouble holding Dillon and Zuniga and they were also hampered with several critical penalties. The Spartans took a 27-21 lead with 3:42 remaining on Zuniga's six-yard

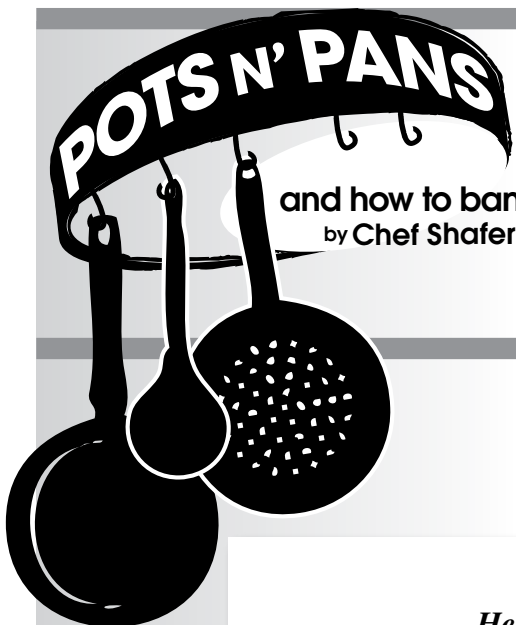
