# **District Eyes Uniform Policy**

Hawthorne School District superintendent Helen Morgan gave a presentation to the School Board on how to proceed with the district's long-sought-after goal of making uniforms the default attire for their schools. During the September 24 meeting, Morgan laid out the possible benefits and costs of implementing a mandatory uniform policy.

Uniforms aren't new to Hawthorne; many of the district's elementary schools have an opt-in policy. However, the rules change with mandatory uniforms. Requiring them means giving parents a six-month notice, so if the district would like to begin requiring uniforms for the 2015-2016 school year, it

only 13.5 percent in the 2003-2004 school year. These policies are intended to lead to a number of benefits, including a sense of belonging, improved attendance, improved academic performance, decreases in bullying, and increases in safety. However, Morgan's research on the subject found some of these claims hard to prove.

"I did some research... and the research was ambiguous at best," said Morgan "For every article I could find that said it had a positive impact I could find an article that said it had no impact. I even found a couple articles that said they had a negative impact, but those were fewer than most."

Perhaps the most important perceived benefit

32 percent of parents in favor at Prairie Vista (the lowest in the district) and 67 percent in favor at Bud Carson (the middle school most in favor of uniforms.) Hawthorne Teachers and Educators president George Amaya questioned whether uniforms would catch on in middle school. "I think it will be a tougher sell at the middle schools," said Amaya.

Morgan responded by saying that the district's middle schools are where they are needed the most. "If we move forward with this, the middle schools are our target," said Morgan. "At the middle school level is when gang attire becomes an issue."

The district would also have to provide istance for lower income families if the uniform policy was made mandatory. Morgan projects that the cost of providing uniform assistance and maintaining a cache of extra uniforms at each school site would be about \$330,000, with additional costs for cleaning, although she also mentioned services like uniform rentals that might impact this estimate. She also would like to see \$120,000 in funding for an employee dedicated to overseeing uniform maintenance. "I think this is a critical piece," said Morgan. "It's critical that we have staff to help this be successful. If we add this to the plate of someone who's plate is already full, this will be the part that falls off." The Board shared Morgan's excitement at bringing uniforms to Hawthorne, although they had many questions. Morgan vowed to continue researching the issue and pin down more the next step more precisely at future meetings. "This is our first conversation," said Morgan. "There needs to be many more conversations, we aren't going to hash it out tonight." •



The district would also be required to allow parents an opportunity to opt out of having their children wear them. In addition, the district wouldn't be able to penalize students for not wearing uniforms, reward students for wearing them, or require parents to have a compelling reason for opting out. Morgan said limiting parents' right to opt out of the policy is "very muddy" and could result in a legal battle with the ACLU.

"In California we would have a harder time doing that," said Morgan. "If we said no to some one who chose to opt out we may have to fight a legal battle and other districts have in the past."

Despite these challenges, according to the National Center for Educational Statistics uniform policies are on the rise nation-wide. In the 2011-2012 school year, 19.3 percent of schools required uniforms, compared with

is better academic performance: however, it was also one of the more dubious claims. "The impact on achievement is almost non-existent," said Morgan. "Even the articles that said there were increases in student achievement, the amount of those increases were very slight, very minor increases."

Not all the results of uniform policies were inconclusive. Morgan's research showed attendance and behavior improved, which could lead to academic improvement as well. She also found the results of uniform policies were magnified in districts similar to Hawthorne.

"There [is] research that shows attendance and improved behavior are an outcome of uniform policies," said Morgan. "Which in my belief is, if you have students at school who are behaving, academic achievement is naturally going to go up."

The district has also held a number of surveys on the topic. At the elementary level, between 80 and 69 percent of parents are in favor of uniforms at each site: however, the middle school results were lower, with only

### **School Meals More Popular at Wiseburn**

The Wiseburn Unified School Board was appetized by a presentation from Janet Lusk, director of dining services at Chartwell, the company that recently took over providing food services on how the new lunch system is working out in the district's schools. During the September 25 meeting, Lusk said that both students and staff are adjusting to the new meals, but thoroughly enjoying them as well.

Chartwell rolled out its lunch services to Wiseburn starting on September 2 and since that time has seen an uptick in students taking prepared lunches at school instead of bringing their own. Anza Elementary had nine percent more students eating school lunch, Burnett Elementary had a 15 percent increase, Cabrillo Elementary had a 21 percent increase and Dana Middle School had over twice as many students eating school lunch with a 59 percent increase.

"It was a lot more than we expected," said Lusk. "We've done 3,000 more meals at Dana in the last three weeks, which is great. The feedback has been incredibly positive. The parents are very happy with the choices, the principals are happy and the kids absolutely love the food."

Board president Roger Banuelos said that

even these increases don't show the true extent of how many more students are eating their lunches. He said that while the 2013 numbers for students receiving school lunches weren't as high as they are now, they were inflated by students taking a lunch and not eating it or only eating part of it. Now Banuelos believes more students find their school lunches delicious to the last bite.

"The numbers are extremely encouraging," said Banuelos. "Even those they were receiving the lunch, they weren't eating them or they weren't consuming all of the lunch."

Lusk said she is still looking to add features that will make meals more enjoyable for students. Since school has started Chartwell already has added a salad bar to Cabrillo. While Lusk said students are excited about the choices it opens up, it does lead to longer lines.

"Of course for the little ones its very exciting for them, but the bargain is that it slows the line down just a tad," said Lusk. "I'm hoping that as they get used to it they will pick it up and be more familiar with it."

Lunch line length has been a concern with the new lunch system. While every student does have time to receive and eat a lunch, the mealtime length has been cutting into students' recreation time. Lusk said that as students become more familiar with the new lunch system wait times should be reduced, but she also counts reducing serving time as an area cafeteria staff can improve.

She is also providing training to cafeteria staff on more effective ordering in order to reduce waste. However, the food waste issue does have another side. Some students have complained about not receiving the meal they ordered, such as having a cold lunch when they requested a hot one. Lusk would like to see schools prepare extra meals for cases where there is overrun, even if it does end up with more wasted food.

"I don't want to encourage waste, but I would rather throw out 20 lunches than have one kid not be able to eat," said Lusk.

While there are still some quirks to work out of the system, Lusk said overall the food service staff has handled the transition to preparing fresh meals very well. "They are doing a really great job," said Lusk. "If you consider heating [moving] from heating frozen meals to now preparing all these meals, they are getting it done. On a whole, I couldn't be more proud of the staff."

One of the factors she believes has made the adjustment easier is that instead of reheating someone else's meal, they are creating their own meals for students. "It's been a super positive experience," said Lusk. "The staff really enjoys the fact that they are now serving the kids meals. They are taking ownership."

While Lusk has shown the Board major improvements to Wiseburn's lunch program, she is still looking for more ways to enhance lunchtime. Her near future plans are to find ways to get even more students to use eat school lunches and serve those lunches more quickly.

"It's going to be speed of service and seeing what we can do to increase participation even more," said Lusk. "I'm really competitive, especially with myself and I'm not happy with 59 percent, I want even more."

On behalf of the Board, Banuelos expressed their gratitude to Lusk and her company for their part in reforming the image of Wiseburn's lunches. "They are all really happy with these meals. They want a hot meal everyday," said Banuelos. "Thank you for all your hard work."•

### Analysts Hope to Wipe Out IUSD Funding Gap by Next Year

With the books now closed on the 2013-14 fiscal year, Inglewood Unified School District has reduced its structural budget deficit to just under \$4.8 million – that's roughly half of the deficit projection from earlier in the year – and remains on track to completely eliminate the funding gap by 2015-16. Considering that Inglewood Unified faced a projected \$17 million structural budget deficit a little over a year ago, this constitutes a roughly 72 percent reduction in the District's structural deficit in just 13 months under the current leadership team.

Increased savings were achieved last fiscal



These regulations are to be implemented upon resolution proclaiming or declaring a local drought emergency and shall remain in effect for the duration of the emergency or until repeal of this ordinance 8.60.022 Water Use Restrictions

a. Stop washing down paved surfaces, including but not limited to sidewalks, driveways, parking lots, tennis courts, or patios, except when it is necessary to alleviate safety or sanitation hazards.

Stop water waste resulting from inefficient landscape irrigation, such as runoff, low head drainage, or overspray, etc. Similarly, stop water flows onto non- targeted areas, such as adiacent property, non-i areas, hardscapes, roadways, or structures. Irrigate residential and com-C. mercial landscape before 10 a m and after 6 p.m. only.

Repair all water leaks within five (5) days of notification by the City of Hawthome unless other arrangements are made with the Code Enforcement Department.

Use recycled or non-potable water for construction purposes when available. 8.60.023 Penalties

Pursuant to Water Code section 377 it is unlawful for any person to violate any provision or to fail to comply with any of the requirements of the Water Conservation Program. Any person who shall violate or fail to comply with any provision or requirement of this chapter shall be guilty of a misdemeanor punishable by up to 30 days in county jail and/or a fine of up to \$500. SECTION 2. If any provision, clause, sentence or paragraph of this Ordinance or the application thereof to any person or circumstance shall be held invalid, such invalidity shall not affect the other provisions of this Ordinance which can be given effect without the invalid provisions or application, and to this end the provision of this Ordinance are declared to be severable. SECTION 3. The City Attorney is authorized to make any non-substantive or clerical changes to this ordinance.

Use a hand-held hose equipped with a positive shut-off nozzle or bucket to water landscaped areas, including trees and shrubs located on residential and commercial properties that are not irrigated by a landscape irrigation system.

Irrigate nursery and commercial grower's products before 10 a.m. and after 6 p.m. only. Watering is permitted at any time with a hand-held hose equipped with a positive shut-off nozzle, a bucket, or when a drip/microirrigation system/equipment is used. Irrigation of nursery propagation beds is permitted at any time. Watering of livestock is permitted at any time.

Use re-circulated water to operate ornamental fountains.

g. Wash vehicles using a bucket and a hand-held hose with positive shut-off nozzle. mobile high pressure/low volume wash system, or at a commercial site that re-circulates (reclaims) water on-site. Avoid washing during hot conditions when additional water is required due to evaporation.




