## Lawndale City Council Discusses A Memorial Wall for Outstanding Citizens

The Lawndale City Council discussed a proposed procedure for creating the Lawndale Memorial Wall of Honor that was originally proposed by Mayor Robert Pullen-Miles as a way to honor, posthumously, any senior citizens who have given volunteer hours over the course of time and deserve recognition of their community service. Staff proposed that the Senior Citizen Advisory Committee (SCAC) be the entity to nominate those two to four persons to be honored each year. Nominations may be submitted by anyone and those on the submission list will be culled by three members of the SCAC and two members of the Lawndale Historical Society. The intent of this Wall of Honor is to give recognition to anyone who has not been recognized by the name being on any city building, school, or park. A plaque for each named honoree will be placed on a wall in the Harold E. Hofmann Lawndale Community Center on the third floor (north side) and will be placed during a modest ceremony either annually or twice per year.

Mayor Pro-Tem Jim Osborne suggested that the nominations not be restricted to senior citizens but also include others who performed exemplary service to the community of Lawndale, regardless of age, but who may have passed on, therefore, qualify for the posthumous honor. Other comments suggested that this honor be devoid of politicization and be based on the merit of the individual and contributions made to Lawndale.

The consent calendar, with all items approved unanimously, included the approval of a feasibility study and design services by Nichols Consulting Engineers for the development of a new Teen Center at 14616 Grevillea Avenue. The funds for this center have been granted by Los Angeles County Supervisor Mark Ridley-Thomas. The further use of Proposition C grant funding for two separate projects to continue on Inglewood Avenue and Prairie Avenue were approved with grants coming from the Los Angeles County Metropolitan Transportation Authority (MTA).

The expansion of the City Manager's duties pertaining to appointing, promoting, disciplining, demoting, or removing employees of the central management team and any Department Heads was approved after a second reading of the ordinance, which will amend the Lawndale Municipal Code as necessary.

Signage at the intersection of Manhattan Beach Boulevard and Hawthorne Boulevard was corrected and the directional views of the street signs identify each true street name.

Based on a recommendation of the Traffic Committee when it was part of the Planning Commission, staff reported on a request from residents of 153rd Place and Condon Avenue intersections for a four-way STOP sign and road painting to be installed. The Traffic Committee originally stated that the addition of red painted curbs on both the north and south sides of Condon Avenue would suffice, but residents urged the STOP sign be presented as an option to the City Council.

The installation of the four-way STOP sign at the intersection of Condon Avenue (north and south) and 153rd Place (east and west) will take place forthwith.

Several speakers during oral comments spoke about voting issues. One suggestion was made to separate Lawndale into districts and elect a member to the City Council from each district. Another suggestion was put forth to not have a separate election for the city's mayor. It was explained that the separation of the mayor's election from those elected to the City Council was instituted following a ballot referendum that citizens voted to be the policy for Lawndale municipal elections.

The LA County Sheriff's Department reported on public safety to say that the shooting on October 29 in the 4200 block of 164th Street was immediately contained to the specific location where the shots were fired; residents were evacuated; backup deputies arrived on the scene in record time; and the armed suspect was wounded by a deputy prior to the arrest of that suspect. The suspect was transported to UCLA Harbor General Hospital and is reportedly in stable condition. The Homicide Bureau is now in charge of the investigation. Citizens are reminded that incidents of this severity are rare in Lawndale and they can rely on the LA County Sheriff's Department and all deputies to be at the ready to mitigate any incidents of this magnitude as expeditiously as possible.

The next meeting of the City Council will be held on Monday, November 17 at 6:30 p.m. •

### Mrs. Chong Goes to Washington

My mother was a warm and loving mom, but she was a banker who could run numbers in her head and tell you where every dime of her household budget went, and she would not suffer fools. If she had read that government had reached two awful milestones, she would have had a seizure. The headlines said that the Federal government had reaped an all-time high of \$3 trillion in tax revenue this year, but our spending was so out of control that our debt had also crossed a new threshold, topping \$18 trillion! \$18 TRILLION!

Once she settled down, she would have concluded that if Democrats win the Senate on November 4th, this nonsense of record tax collection and exploding debt will continue. The only hope would be for Republicans to win and send her to Washington to fix the problem.

Her first step would be to freeze spending: program by program, department by department, freeze it all.

Second, she would have Congress form a bipartisan joint committee, similar to a military base closure committee, to go through the budget, line by line, and identify every program whose cost exceeds its benefits. The Congress as a whole would vote on the committee's recommendations on an up-or-down basis without amendments or debate.

Third, she would consolidate duplicated programs in areas such as poverty and education, passing the budgeted sums to the individual states to use as their local communities require and eliminating the Federal staffing attendant to each program.

Fourth, she would require that, where appropriate, government programs would be evaluated to see if private sector bidding would be more cost effective than performance by the bureaucracy. As a corollary, every private sector contract must be bonded and competitively bid with specific quality, schedules and fixed cost. Any contractor who breaches more than one contract would be barred from bidding on future government contracts.

Fifth, remove every department's procurement authority in order to mitigate the influence of lobbyists and other special interests, leaving Purchasing in the hands of professionals.

Sixth, the Office of Management and Budget should have one function only: to monitor all Federal contracts, with full audit authority.

Seventh, all programs should have a defined sunset provision. Any extension should be treated as a new bill, requiring renewed Congressional debate and Presidential approval.

Eighth, the President should have a line-item veto, but should not have the authority to add funding to any bill.

Mom was also a realist who would not touch the issues of a Balanced Budget Amendment or income tax reform because those are political quagmires that would suck the wind out of all reform proposals, and result in continued political paralysis. Like Mr. Smith who went to Washington, there's an army of smart and principled Moms armed with brooms who have better ideas than politicians. So ink up like a sailor with a heart and Mom tattoo on your shoulder and flash it on Election Day. •

### Voter ID Laws Do More Harm Than Anything

The issue of voter ID laws has floated in the news for years now and much of the rhetoric behind justifying such legislation sounds good but in reality is bad. To date I have not seen one clear-cut example of a state that has such rampant voter fraud that voter that a new voter identification law was needed to maintain the integrity of our democratic process, from the voters' side. However, I keep reading articles about Americans in different states that have been denied the right to vote because of new voter ID laws, even though they are law-abiding citizens who have been going to the polls for years.

The most recent article I came across is from a man named Eric Kennie. Kennie is from Austin, Texas and in his 45 years on this earth he has never lived outside of Austin. Actually, theguardian.com reports that Kennie has never travelled outside of the state, nor has he ever left his native city. Kennie has been an active voter in Texas since he turned 18 but because of the new voter ID law approved by the state's Republican leadership he and an estimated 600,000 legally registered voters will be unable to vote. Under the new law a voter must meet certain photo identification requirements and it has been determined that Kennie fails to do so.

I won't argue against requiring people to provide a legitimate identification card prior to voting. However, if people like Kennie have been voting for years, why are their former forms of identification no longer acceptable? This new law is so absurd

that Kennie's voter registration certificate, which was a valid document to vote, is now considered insufficient in Texas to cast a ballot. Furthermore, such laws make it difficult for young people to vote because students usually don't have state issued identification cards. In order to obtain an ID, one needs a birth certificate but to obtain said document, the petitioner needs a state-issued ID. Seems like a convenient way to keep people from voting.

Every article I read, from several sources, indicates the same thing: law-abiding citizens lose their right to vote with these new laws for no legal reason. Affected by such requirements are usually people who are already disenfranchised: the poor and minorities. Our country already has embarrassingly low voter turn out and with voter ID laws, the ability to vote becomes restricted and will only cause less people to try and become part of the voting process.

There is nothing wrong with setting new standards but to deny a people like Kennie the right to vote without any wrong doing on his behalf is wrong. For anyone who argues that people like Kennie should just abide by the new regulations, you're missing the point. People like Kennie have done nothing wrong to lose the right to vote, so they should not have fix or modify their behavior because some state legislators found a way to eliminate potential against votes. If Texas is so worried about the two registered cases of voter fraud in 20 million votes cast during the past two years, there are better solutions than disenfranchising 600,000 people. •

## Baked Sweet Potatoes with Cranberry Gorgonzola Gremolata

### Ingredients

**Serves 6**

- 6 medium sweet potatoes
- 1/4 cup melted butter
- 1/2 teaspoon salt
- 1/4 cup pure maple syrup
- 1/4 cup minced fresh parsley
- 1 lemon, zested
- 1 clove garlic, minced finely
- 3 tablespoons minced pecans
- 3 tablespoons finely chopped dried cranberries
- 1 scallion, minced
- 2 ounces Stella gorgonzola, crumbled (If you prefer a milder flavor, use 2 ounces crumbled blue cheese instead of gorgonzola)



### Preparation

1. Preheat oven to 450 F. Place sweet potatoes on cookie sheet and bake for 30 minutes. Flip over and return to oven to bake until tender - about 20 minutes. Remove from oven and set aside.
2. When cool enough to do so safely, peel sweet potatoes. Place in a medium skillet over low heat with butter, salt and maple syrup for 5 minutes, basting the potatoes with the butter mixture occasionally. Lightly smash the potatoes until there is an even consistency. Hold over low heat.
3. To make the gremolata: In a small bowl, toss together parsley, lemon zest, garlic, pecans, cranberries and scallion. Gently fold in the cheese.
4. Move sweet potatoes to a serving dish and sprinkle with the gremolata. Serve hot. •

# Looking Up

## Astronomers Observe Stellar Fireball with Unprecedented Clarity

Astronomers have observed the expanding thermonuclear fireball from a "nova" that erupted last year in the constellation Delphinus. The observations produced the first images of a nova during the early fireball stage and revealed how the structure of the ejected material evolves as the gas expands and cools. The results of these observations, carried out by a collaboration of 37 researchers from 17 institutions and led by Georgia State astronomer Gail Schaefer, are published in the current issue of Nature.

A nova occurs following the buildup of a thin layer of hydrogen on the surface of a white dwarf—a highly evolved star with the diameter of the Earth and the mass of the Sun. The hydrogen is provided by a close companion, which is a normal star, in a binary star system where the

two stars orbit about their center of mass.

As shown in the accompanying artist's concept, the normal star sheds a small amount of its mass through a stream onto the white dwarf's surface that gradually builds up a hydrogen "ocean." When that ocean is about 650 feet deep, the enormous surface gravity of the white dwarf produces pressures at the bottom of the hydrogen layer sufficient to trigger thermonuclear fusion—essentially a stellar H-bomb.

In a typical nova, the light from the explosion will significantly exceed the star's normal brightness and the object may suddenly appear to the naked eye in a location not previously noted to have a bright star. Over ensuing weeks, the star slowly fades as the fireball expands, cools and dissipates. Surprisingly, this seeming cataclysm on the white dwarf's surface has no real effect on the star or its companion, and the

flow of material will resume so that the detonation will likely repeat at a future date.

Because these objects are generally very faint until the explosion occurs, they do not appear on classical star maps. Instead, a "new" star suddenly appears where there was none before. The famous 16th-century Danish astronomer Tycho Brahe described this sudden appearance of a star in his 1572 book De Stella Nova, and the Latin "nova" for "new" became attached to this phenomenon.

On August 14, 2013, the Japanese amateur astronomer Koichi Itagaki discovered a "new" star that was promptly named Nova Delphinus 2013. Within 15 hours of the discovery and within 24 hours of the actual explosion, astronomers at Georgia State University's Center for High Angular Resolution Astronomy (CHARA) pointed the telescopes of the CHARA Array, located on the grounds of historic Mount Wilson Observatory

in the San Gabriel Mountains of Southern California, toward Nova Del 2013 in order to image the fireball and measure its size and shape. The size of the nova was measured on a total 27 nights over the course of two months; the first measurement represents the earliest size yet obtained for a nova event. The CHARA facility uses the principles of optical interferometry to combine the light from six telescopes to create images with very high resolution, equivalent to that of a telescope with a diameter of 1,000 feet. This makes it capable of seeing details far smaller in angular extent than traditional telescopes on the ground or in space. It has the power to resolve the size of a U.S. nickel on the top of the Eiffel tower in Paris from the distance of Los Angeles, California. •

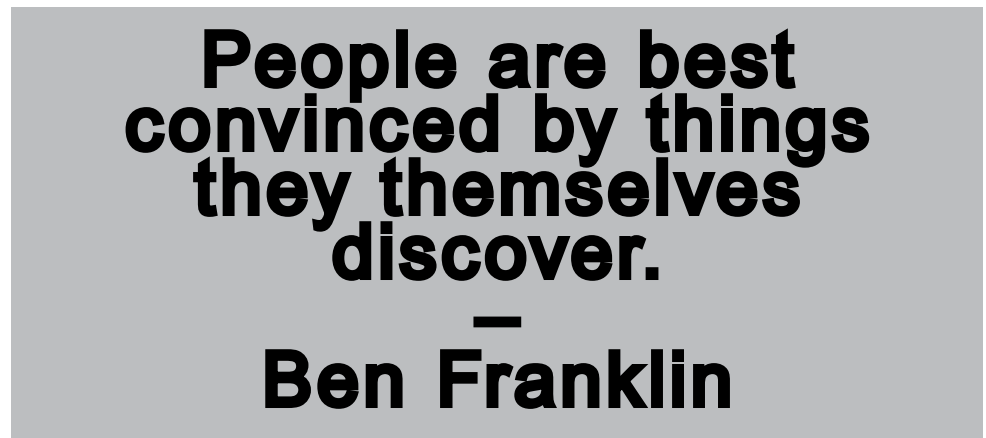

## Lawndale Can't Keep Up With El Segundo

Already having its best league record since the earlier Lawndale High football days of the 1970s, the Cardinals started off with a 3-0 Ocean League record but were heavily challenged at highly regarded El Segundo in the league showdown last Thursday.

It was also to be a matchup between two of the South Bay's top quarterbacks in returning senior all-CIF Southern Section player and Major Division I college prospect Lars Nootbar of the Eagles and Lawndale's upcoming junior Chris Murray.

The veteran Nootbar and company, however, had too much experience and maturity for the Cardinals as El Segundo upped its unbeaten records to 9-0 overall and 4-0 in Ocean play by pulling away for a 35-14 win. The victory enabled the Eagles to clinch, at least, a share of the league title for the second consecutive season. Last year, El Segundo won the Pioneer League crown and made the Southern Section Northwest Division final before losing at Nordhoff 49-21 in Ojai. Currently, the Eagles are ranked second, behind top rated and Pioneer League leader West Torrance (also unbeaten at 9-0 overall and 4-0 in league after defeating cross town rival South Torrance 31-12 last Friday at West), in the Southern Section Western Division.

Lawndale (5-4 overall and 3-1 in league) was in the game at halftime, trailing 21-14, but El Segundo pulled away with two additional touchdowns and shut out the Cardinals in the second half. The Eagles started fast in the third quarter as it went 83 yards on 12 plays that was capped by a 24-yard TD run from senior running back Miguel Wagner-Bagues giving El Segundo a 28-14 advantage.

The Cardinals' first drive of the second half ended unsuccessful after the Eagles' Jack Barone sacked Murray deep in Lawndale territory. That forced the Cards to have to punt from their own end zone, but a bad snap was picked up by Murray who ran 13 yards but it was short of a first down. On top of that, Lawndale was penalized on the play giving El Segundo the ball at the Cardinal 12-yard line. The Eagles needed only two plays to score on an 11-yard run by Taz Tauaese.

Neither team scored in the fourth period but Lawndale attempted to get closer as it reached the red zone (inside the El Segundo 20) twice only to turn the ball over on downs each time.

Wagner-Bagues had a big game for the Eagles. He scored four touchdowns, three of them rushing. He ran for 57 yards on 14 carries. Wagner-Bagues also had a 21-yard TD reception from Nootbar, who completed 10 of 15 passes for 126 yards and one touchdown.

Murray ran for 91 yards on 19 carries and completed eight of 14 passes for 70 yards. He neither scored nor had any account for a touchdown. Running back Austin Manigo, who carried the ball 12 times for 35 yards, scored both Cardinal touchdowns on runs of 16 and eight yards in the first half.

"El Segundo was a little bit more physical than us," Lawndale head coach Rick Mathieson said. "Hopefully we'll learn a lesson. In the playoffs (which Lawndale should make), we'll be playing the likes of West Torrance, Palos Verdes, Redondo, Ventura, Pacifica of Oxnard and Oxnard. We'll have to really step it up."

The Cardinals hope to ensure a spot in their first playoffs in their "Lawndale High Part II (2002-Present) History" when they close Ocean at home against Centinela Valley School District rival Hawthorne Friday at 7 p.m. Overall, Lawndale last made the playoffs in 1980 (the Part I school's last season of 1959-81).

### INGLEWOOD IS ALIVE IN BAY

Inglewood High's football team is suddenly in position of a CIF-Southern Section Western Division playoff spot after rallying for a 40-35 win over Peninsula in a key Bay League game last Thursday at Coleman Stadium. De'Juan Tyson scored the winning touchdown on a 16-yard run for the Sentinels (3-6, 2-2) with eight seconds left in the game. Tyson sparked Inglewood by rushing for 260 yards and three touchdowns. He also had a 37-yard reception that set up his winning score.

Tyson's winning TD came just 34 seconds after the Panthers (3-6, 1-3) took a 35-32 lead on a nine-yard scoring pass from quarterback Daniel Schubert to Andrew Phillips. The Sentinels will look for a shot at the playoffs when they face cross town rival Morningside (4-5, 0-4) Friday at 7 p.m. at Coleman Stadium. The Monarchs lost at Mira Costa 49-19 last Friday.

### DESPITE GOOD EFFORT, LEUZINGER FALLS SHORT

Leuzinger High's football team played a very good North Torrance team tough only to fall short 35-20 in a Pioneer League game last Friday at Leuzinger. The Olympians (3-6, 0-4) were tied at 14 at halftime only to see the Saxons (6-3, 3-1) pull away by outscoring the 21-6 in the second half.

Khalil Miller scored on runs of seven and 11 yards, and Nathaniel Vaughn had a six-yard touchdown run for the Olympians. Leuzinger will seek to close its regular season with a win as it hosts Compton Centennial in an attempt to stay out of the Pioneer cellar Friday at 7 p.m.

### CULVER ROUTS HAWTHORNE

Hawthorne High's football team sought its second Ocean League win for the first time in 10 years but it was dashed by previously winless Culver City 35-10 last Friday at Hawthorne. Paris McDaniel scored the only Cougar touchdown on a 25-yard reception in the fourth quarter. Hawthorne closes at second place Lawndale Friday at 7 p.m. •
